# Boltzm ann entropy and the microcanonical ensemble

#### A bstract

Boltzm ann's entropy is slightly modi ed to make it suitable for discussing phase transitions in nite systems. As an example it is shown that the pendulum undergoes a second order phase transition when passing from a vibrational to a rotating state.

#### 1 Introduction

The Boltzm ann-G ibbs form alism of statistical mechanics is heavily based on the equivalence of ensembles, which for many system sholds in the therm odynamic lim it. It is not adequate to describe the therm odynamic behaviour of small system s. In particular, phase transitions can only occur in the therm odynamic lim it of the canonical ensemble. Recently [1, 2, 3, 4, 5, 6, 7], the use of the microcanonical ensemble has been advocated to describe phase transitions in small system s. The present Letter supports this approach, but argues that one of its premises should be slightly modi ed. Indeed, it is tradition to use Boltzm ann's entropy

with a small but xed energy and with ! (E) the density of states, as the obvious de nition of therm odynam ic entropy of isolated system s. A lternatively (see [3] and the references cited there), the density of states ! (E) in (1) can be replaced by the integrated density of states (E). The proposal of the present Letter is to replace it by a related quantity (E), solution of the non-linear di erential equation

The resulting entropy is denoted S (E)

$$S (E) = k_B \ln ((E))$$
: (3)

A conceptual argument supporting this modication is given below. Practical consequences for macroscopic systems are neglegible. But for small systems the consequences are important.

## 2 Equipartition

According to Boltzmann the equilibrium state of an isolated system is the macrostate that can be realized in the largest number of ways [9]. All accessible states have the same probability. This can be taken as the de nition of the microcanonical ensemble. The notion of entropy enters when two or more isolated system s are compared. The density of states in the combined system is the product of density of states of each of the composing systems. On the other hand, therm odynam ic entropy must be the sum of the entropies of the subsystem s. The standard argum ent is then that entropy necessarily is proportional to the logarithm of the density of states. This results in Boltzmann's entropy. Problem with this reasoning is that the compound system still consists of two unrelated systems, e.g. physically separated by a wall. Rem oval of this wall would a ect entropy. If the wall is not rem oved then the com pound system is in equilibrium, but this is the equilibrium of a microcanonical ensemble constraint to the requirem ent that the di erent subsystem s, labeled with index j, have xed energies E i. Not all possible ways of distributing the total energy  $_{\rm j} {\rm E}_{\rm j}$  over the subsystems are realized. Hence it is not in equilibrium E = in the unconstraint ensemble. The usual way to overcom e this problem is by m eans of equivalence of ensembles. How ever, this works only for m acroscopic system s, if it works at all. Indeed, the essence of the microcanonical approach to phase transitions in nite systems is precisely that the equivalence of ensem bles can break down in presence of phase transitions. W hen this happens then the microcanonical ensemble is the one that decribes nature, not the canonical ensemble. Several conclusions can be drawn from this discussion. In the rst place it shows that the standard argum ent for associating Boltzm ann's entropy with the microcanonical ensemble is not justiled in case of small systems. It also shows that the possibility of phase separation should be taken into account because it modies the accessible part of phase space.

A di erent type of reasoning is now followed. It starts from the assumption that it is possible to compare isolated systems and that it is meaningful to state that they allhave the samemicrocanonical temperature. Note that energy is the control parameter of the microcanonical ensemble, not temperature. Therefore the argument is restricted to simple systems for which energy and temperature are uniquely related. Initially, put all the isolated subsystems in their ground state. Next distribute small amounts of energy dE to the system in such a way that all degrees of freedom of the system are treated in the same manner. To this purpose, introduce an elective number of degrees of freedom  $m_j (E_j)$  which may depend on the energy  $E_j$  of subsystem j. Then the amount of energy received by subsystem j is proportional to  $m_j (E_j)$ . Let us postulate that this procedure of distributing energy over the subsystem skeeps them all at the same tem perature T = T (E). For each of them is then

$$C_{j}(E_{j}) = \frac{dE_{j}}{dT} = C(E) \frac{m_{j}(E_{j})}{m_{k}m_{k}(E_{k})}$$

with C  $(\!E\!$  ) the heat capacity of the total system . The obvious solution of this equation is

$$C_{j}(E_{j}) = k_{B}m(E_{j})$$
: (5)

Integration of  $1=C_{j} (E_{j})$  then gives tem perature T as a function of energy  $E_{j}$ .

#### 3 M odelling heat capacity

Let us next try to relate the e ective number of degrees of freedom m (E) to the density of states ! (E). A suitable de nition is

$$m (E) = 1 + \frac{!^{\circ}(E)^{2}}{!^{\circ}(E)^{2} \cdot ! (E)!^{\circ}(E)};$$

For a system with Hamiltonian H the density of states equals

$$!(E) = d(E H()):$$
 (7)

In case of the harm onic oscillator is  $!^{0}(E) = 0$ , which makes (6) badly de ned. However, if !(E) = AE, with A constant, then m (E) = 1 + follows. Hence, taking the limit = 0 one concludes that for a constant density of states one has m (E) = 1, as expected. This implies  $E = k_{\rm B}T$ , which is the canonical result. In case of the ideal gas is  $!(E) = E^{3n=2}$ . This implies m (E) = 3n=2 and hence  $E = (3n=2)k_{\rm B}T$  which is again the canonical result. O ne concludes that (6) gives physical results in both cases.

Note that one has

m (E) = 1 
$$\frac{(S_B^0 (E))^2}{k_B S_B^0 (E)}$$
: (8)

If the system is macroscopic then the constant 1 in this expression may be om itted, in which case integration can be done easily. The result is that in that case Boltzm ann's entropy is the therm odynam ic entropy, satisfying the therm odynam ic relation

$$\frac{1}{T} = \frac{dS}{dE} :$$

In the general case B oltzm ann's entropy is not the therm odynam ic entropy. The proposal is to replace it by S (E) with (E) chosen in such a way that (9) is satisfied and that the heat capacity C (E) equals  $k_B m$  (E), with m (E) given by (8). This implies that (E) must satisfy

$$\frac{1}{m (E)} = 1 - \frac{(E)^{0} (E)}{(^{0} (E))^{2}} :$$

In combination with (6) this gives (2).

#### 4 D iscussion

Let us investigate som e properties of S (E). A short calculation yields

$$\frac{d^2}{dE^2}S (E) = k_B - \frac{{}^{0}(E)}{(E)} \frac{{}^{2}}{m(E)} (E)$$
(11)

Hence the condition for S (E) to be concave is that m (E) > 0. On the other hand, it is clear from (8) that the condition for Boltzm ann's entropy to be concave is m (E) 1. One concludes that some of the systems that are unstable w.rt. Boltzm ann's entropy are still stable when analysed with S (E). In particular, negative heat capacities, often discussed in the context of nite systems [10, 11, 12, 13, 14, 15], are less likely to be negative when using S (E).

Of practical importance is that (2) can be solved in a system atic manner. Introduce a function

$$f_{\rm B} (E) = k_{\rm B} \frac{d}{dE} \frac{1}{S_{\rm B}^{0} (E)} = 1 - \frac{! (E)!^{(0)} (E)}{!^{(0)} (E)^{2}};$$
(12)

The function f (E) is de ned in a similar way. Then (2) can be written as

$$k_{\rm B} \frac{d}{dE} \frac{1}{S^{0}(E)} = f(E) = \frac{f_{\rm B}(E)}{f_{\rm B}(E) + 1} = \frac{!(E)!^{(0)}(E) \cdot !^{(0)}(E)^{2}}{!(E)!^{(0)}(E) \cdot 2!^{(0)}(E)^{2}};$$
(13)

By integration of f (E) one obtains the inverse of  $S^0$  (E). Inverting and integrating again one obtains S (E).

F inally, note that the two entropies  $S_B$  (E) and S (E) coincide only when the density of states is an exponential function ! (E) = A exp (bE). In that case the e ective number of degrees of freedom is in nite.

### 5 Constant heat capacity

O f interest is the situation where m (E) is constant. E g, if ! (E) = AE , then one has m (E) = 1 = (1 ). This case includes the harm onic oscillator as well as the ideal gas. However, there is a larger class of system s with constant m (E). Note that from (6) follows

$$\frac{! (E)!^{(0)}(E)}{!^{(0)}(E)^{2}} = 1 \frac{1}{m - 1} q;$$
(14)

Solutions of this equation are of the form  $!(E) = A \exp_q(bE)$ , involving the deform ed exponential functions [16, 17]

$$\exp_{q}(x) = 1 + (1 \quad q) x_{+}^{1=(1 \quad q)}$$
(15)

(the notation  $[x]_{\!\!+}=m\,axf0;xg$  is used). The corresponding -entropy (determined up to a constant term which is xed by choosing an arbitrary positive energy  $\,$ ) is

S (E) = 
$$k_{\rm B} m \ln \frac{E E_{\rm g}}{m}$$
: (16)

Here, E  $_{\rm g}$  is the ground state energy of the system . Tem perature T , calculated using (9), satis es

$$k_{\rm B} T = \frac{E E_{\rm g}}{m} :$$
 (17)

O ne concludes that any microcanonical system described by a density of states of the form  $!(E) = A \exp_{\alpha}(bE)$  satis es the equipartition law.

#### 6 The pendulum

An interesting example of a nite system with phase transition is the pendulum with H am iltonian

$$H = \frac{1}{2I}p^2 \qquad {}^{2}I\cos():$$
 (18)

For low energy  ${}^{2}I < E < {}^{2}I$  the motion is oscillatory. At large energy  $E > {}^{2}I$  it rotates in one of the two possible directions. A correct understanding of the therm ostatistics of this model is highly relevant because rotationalm otion of ions and molecules, or part of molecules, occurs frequently in all states of matter. See e.g. [18].

The density of states ! (E) can be written as

$$! (E) = \frac{2^{p} \overline{2}}{2} !_{0} (E = {}^{2}I):$$
(19)

with a constant, inserted for dimensional reasons, and with  $!_0$  (u) given by

$$!_{0}(u) = \frac{1}{2} \int_{1}^{Z_{1}} dx \frac{1}{p \cdot x} \frac{1}{p \cdot 1} \frac{1}{x} \frac{1}{p \cdot 1} \frac{1}{u + (1 + u)x} \quad \text{if} \quad 1 < u < 1;$$

$$= \frac{1}{4} dx \frac{p}{1-x^2} \frac{1}{x+u} \quad \text{if } 1 < u:$$
 (20)

See g.1. Note that a factor 1=2 has been inserted in case u > 1 to take into account that the pendulum is rotating either clockwise or anti-clockwise.

The density of states ! (E) diverges at E =  ${}^{2}I$ . It is log-convex on both intervals  ${}^{2}I < E < {}^{2}I$  and  ${}^{2}I < E$ , rather than log-concave. Hence, Boltzm ann's entropy cannot be used to analyse thism odel. The elective number of degrees of freedom m (E) has the value 1/2 at large values of E, as expected. How ever, it does not start with the value 1 at E =  ${}^{2}I$ , but with m (E)' 0:72. This is due to anharm onicity of the oscillatory motion. The heat capacity C (E) =  $k_{B}m$  (E) has a shape typical for a second order phase transition at E =  ${}^{2}I$ . See g.2.




Figure 1: Density of states  $!_{\,0}\,(\!u\!)$  of the pendulum as a function of energy in reduced units.




Figure 2: Number of degrees of freedom m (u) of the pendulum as a function of energy in reduced units.

### 7 Conclusions

A rgum ents have been given why Boltzm ann's entropy is not suited to discuss phase transitions in small systems and should be slightly modiled. The proposed replacement is given by (3). It involves a function (E), related to the density of states ! (E) and obtained by solving (2). It is based on the notion of elective number of degrees of freedom m (E) and the principle that, if two systems with equalm (E) are heated up in the same manner, then they have at all times the same temperature. Clucial point is relation (6) between m (E) and the density of states ! (E). O mitting the constant term '+ 1' in this expression leads to Boltzm ann's entropy. Hence, if the number of degrees of freedom is m acroscopic then the proposed entropy (3) coincides with Boltzm ann's entropy. But for small system s one can expect in portant dilerences.

To illustrate this point the classical pendulum has been discussed. In the present approach it exhibits a second order phase transition between vibrations and rotations. It cannot be treated using Boltzm ann's entropy because the density of states is piecew ise convex instead of concave. In the approach of [8] it undergoes a rst order transition because heat capacity is negative in a range of energies (this calculation has not been included but can be done straightforw ardly). N egative heat capacities have been discussed atm any places in the literature, in both theoretical and experim ental papers. It is out of scope of the present Letter to reanalyse all those applications. But it is clear that this has to be done.

The main om ission of the present Letter is a discussion of the quantum mechanical microcanonical ensemble. In the quantum case the density of states g(E) counts the number of eigenstates with energy in the range from E to E + , for some xed > 0. It is a highly singular function of energy E. This complicates the calculation of the function (E), and hence, of the modi ed Boltzm ann entropy S (E). The only obvious solution to this problem is to replace the density of states by a continuous function. This is of course only meaningful when the eigenvalues of the H am iltonian are densely spread over some relevant interval of energies. A more fundamental solution is lacking and requires further investigation.
