R obustness of D ecoherence-Free States for C harge Q ubits under Local N on-uniform ity

We analyze the robustness of decoherence—free (DF) subspace and subsystem in charge qubits, when dierence from the collective decoherence measurement condition is large (5%) in the long time period, which is applicable for solid-state qubits using as a quantum memory. We solve master equations of up to four charge qubits and a detector as a quantum point contact (QPC). We show that robustness of DF states is strongly a ected by local non-uniformities. We also discuss the possible two-qubit logical states by exactly solving the master equations.

Although decoherence is the largest obstacle for quantum information processing, a lot of powerful active methods for correcting elects of decoherence have been discovered. As to the passive anti-decoherence protection, decoherence-free (DF) subspace^{2,3} and subsystem are shown to be very useful for collective decoherence environment, in which allqubits suler the same disturbance from the environment. Singlet state is the only DF state for two qubits and there are two independent DF subspace bases for four qubits, e.g.

where $jl001i_{(1234)}=jli_1 \not Di_2 \not Di_3 \not lli_4$ and so on. The DF subsystem starts from three qubits. Experiments have succeeded until four qubits in photon system 5,6 and three qubits in nuclear magnetic resonance (NMR) 7 . Baconet al. also showed that, even if there is a sym metry breaking perturbation from the collective environment, which is parameterized by a coupling strength , the DF subspace is robust in the order of O () when 1.

However, in the case of solid-state qubits, even a single qubit is hard to fabricate and the redundancy regarding the number of qubits would be a critical issue in constructing a large qubit system . First of all, we could not prepare plenty of qubits with mathematically exact size. The sizes of Cooper-pair box of Ref.8 and GaAs quantum dot (QD) where coherent oscillation can be observed are less than hundreds of nm . The requirem ent of a few % uctuation between qubits would result in controllability of a few nm in fabrication. This would be unrealistic until future when fabrication process is greatly advanced. The uctuation of sizes would lead to that of interaction am plitude between qubits and a measurement apparatus, and that of the applied gate bias, in addition to the e ect of random ly distributed background traps 10,11 . Note that even a roughness of the order of 1 A at interfaces a ects current characteristics in advanced LSI technologies as shown in Ref. 12 Thus, the non-uniform ity of solid-state qubits to collective decoherence environment ism uch larger and rather local com pared with that of optical or NMR qubits, and it will be necessary to consider the e ects of second order O (2) or higher sym metrybreaking perturbation.




FIG. 1: Qubits that use double dot charged states are capacitively coupled to a QPC detector.

In this paper, we theoretically describe the e ect of large non-uniform ity (5%) of charge qubit parameters on DF states based on time-dependent density matrix (DM) equations considering the measurement process by detector current. Detection of qubit states induces a backaction on the qubit state resulting in a corrupting of qubit states. Thus, the measurement is an important interaction with the environment for qubits. The charge qubit is a two-level system 13 controlled by gate electrodes 10,14, and constituted from coupled QDs where one excess electron is inserted, assum ing there is one energy level in each QD. The detector discussed here is a quantum point contact (QPC) in the tunneling region depicted in Fig.1. The position of the excess charge a ects the OPC current electrically, resulting in detection of charged state. Experim ents^{15,16} have successfully proved the high sensitivity of QPC detector current $I = G_0 T v_d (G_0 = 2e^2 = h)$ 77 S, T is a transmission coe cient vd is a bias between electrodes) in the tunneling region (T < 1). The QPC current induces shot noise as the basic and unavoidable noise16, and the cause of decoherence treated here. The purpose of this study is to investigate the robustness of many-qubit DF states for local large non-uniform ity and show the possibility of using non-DF states with two-qubit singlet states during the QPC measurement. Two-qubit DM is analytically solved and perfectly analyzed.

between two nearest qubits, originating from capacitive couplings in the QD system 14 . j"i and j#i refer to the two single-qubit states in which the excess charge is localized in the upper and lower dot, respectively. Here $c_{\rm i_L\,s} (c_{\rm i_R\,s}) s = "; \#$ is the annihilation operator of an electron in the $\rm i_L\,th$ (i_R th) level (i_L (i_R) = 1; :::; n) of the left (right) electrode. H int is the (capacitive) interaction between the qubits and the QPC, that induces dephasing between di erent eigenstates of $\rm i_L^2$. Most in portantly, it contains the fact that localized charge near the QPC increases the energy of the system electrostatically, thus a ecting the tunnel coupling between the left and right electrodes:

Note that the case where V_i is independent of the qubit corresponds to collective environm ent, thus the DF states are realized. Hereafter we neglect the spin dependence of V and V_i . both of which also start from O (2) (decoherence rate of j $_{2}^{[4]}i_{(1234)}$ has a similar but more complicated form). The robustness of N 3 qubits changes depends on which qubit includes local uctuation. For example, if the leftm ost qubit of j $_{1}^{[3]}$ i uctuates, $1=_{1[3]}^{(1)}$) 3) (1 $^{-2}$) $^{-2}$, but 1= $^{(1)}_{1\,[3]}$ = 0 when the rightm ost qubit uctuates. In the latter case, there is a symmetry between the leftm ost and middle qubit and we can say that if some symmetry remains, DF states are robust. To see the dependence of spatial arrangem ent of qubits, we also consider j $_{3}^{[4]}i_{(1234)}$ j $_{1}^{[4]}i_{(1423)}$ (hereafter we om it the subscript). j $_{3}^{[4]}$ i is expected to be more susceptible than $j_1^{[4]}i$, because the form er is not a product of two singlet states as j $_{1}^{\left[4\right] }$ i and less sym m etric exchanges of qubit states are possible when qubit parameters uctuate. Thus, the DF states are strongly a ected by the distribution of local non-uniform ities.




FIG. 2: Time-dependent delity of four-qubit DF states (j $_{1}^{[4]}$ i and j $_{3}^{[4]}$ i) three-qubit DF state of j $_{1}^{[3]}$ i, and two-qubit states (singlet, jbi, jbi, and product state $_{1}^{[A]}$ i) under various uctuations: (i) $_{3}$ = (1), $_{3}$ = $_{0}$ and $_{3}^{(\)}$ = (1) (). (ii) $_{2}$ = $_{3}$ = (1), $_{2}$ = $_{3}$ = $_{0}$ and $_{2}^{(\)}$ = $_{3}^{(\)}$ = (1) (). (iii) $_{4}$ = (1), $_{4}$ = $_{0}$ and $_{4}^{(\)}$ = (1) (). (iv) $_{2}$ = (1), $_{2}$ = $_{0}$ and $_{2}^{(\)}$ = (1) (). (iv) is also applied to the two qubits. (a) = 0.01 and = 0.6 (strong measurement), (b) = 0.05 and = 0.2 (weak measurement). = 2 $_{0}$, J_{ij} = 0 $_{i}$ = 0.




FIG. 3: Fidelity of four-qubit DF states at t = 50 $_0$ in the case of (iii) as a function of non-uniform ity. = 2 $_0$, J_{ij} = 0 and = 0.2.

Num erical calculations support these analyses. Here we add uctuations locally to $_{\rm i}$, $_{\rm i}$ and $_{\rm i}$ respectively to various DF states of N $\stackrel{<}{=}$ 4 qubits. In case (i), only 3rd qubit uctuates as $_3$! $_3$ (1), $_3$! $_3$ (1) and $_3!$ $_3$ (1). In case (ii), the 2nd and 3rd qubits uctuate. In case (iii) only 4th qubit uctuates. Fig. 2 (a) shows a time-dependent F (t) in a strong measurement case of = 0.6 of 1% uctuations (= 0.01) and Fig.2 (b) shows that of a weak measurement case of = 0.2 of 5% uctuations (= 0.05), both in degeneracy point = 0 (relaxation decoherence region 10,11). Although Fig. 2 (a) indicates that the four-qubit DF states are fairly robust, Fig. 2 (b) shows that the large uctuation (5%) greatly degrades $j_3^{[4]}$ i in case (iii). If we take $_0$ = 100M Hz, its lifetime (F (t) > 0:75) is about 50 of 500ns, which is much shorter than lowest order estimation of $\begin{pmatrix} 2 & 1 \\ 0 & \end{pmatrix}$ 40 s. This shows that higher sym m etry-breaking perturbation term s cannot be

neglected and there is a case where a product state is m ore preferable than four-qubit DF states. F (t) for j 2 i is in the sam e order of j $_{1}^{\left[4\right] }i_{\text{\textit{r}}}$ which m eans that DF states composed of many entangled states seem fairly robust at the degeneracy point. The three-qubit DF states are fairly robust for larger, and show susceptibilities to m easurem ent strength as the singlet state and other Bell states (Fig 2 (a)). In the case of nite bias (pure dephasing region), the e ect of which appears from $1={}^{(2)}$, F (t) ofj $_{2}^{[4]}$ i and j $_{3}^{[4]}$ i seem more susceptible than the singlet state and the singlet type j $_{1}^{[4]}$ i (Fig.3). The other Bell states and three-qubit DF states are less susceptible than $j_{2}^{[4]}$ i and $j_{3}^{[4]}$ i, which would again be due to the higher order sym m etry-breaking term s. To sum m arize these results, DF states of many qubit (N = 4) are robust for m ost cases but there is a case where even product states m ight be better under large sym m etry-breaking uctuations (> 5%) in the long term.

A nalytical solution for two-qubit case{ The probability that the unexpected non-uniform ities induce sym m etrybreaking e ects become shigher as the number of qubits increases as shown above. Because preparing many solid-state qubits is not easy, the redundancy of coding qubits is a trade-o against the fabrication diculty. Thus, using the singlet state and one of the non-DF states, fai; bb; ccg in two qubit space would sometimes be a realistic solution to construct two logical states \mathfrak{Di}_L and \mathfrak{Jli}_L . Here we investigate which of fai; bb; ccg is appropriate for the second basis in two-qubit space. When we move to four Bell bases under the conditions that the two qubits are identical with no interaction between them $(J_{ij}=0)$ and no bias $_i=0$ (collective environment), Eqs.(3) are divided into the following vegroups:

First, singlet state $_{dd}$ is time-independent (DF state) and $_{bd}(t) = _{D} \frac{_{bd}(0)e}{_{(B+D)^2} \frac{_{16-2}}{16-2}t}$, and $_{ab}(t)$ and $_{bc}(t)$ behave like $e^{_{(B+D)^2} \frac{_{(B+D)^2}}{_{(B+D)^2} \frac{_{16-2}}{16-2}t}$, thus decay rates of $_{ad}(t)$, $_{cd}(t)$, $_{ab}(t)$, and $_{bc}(t)$ depend on whether $4>_{B}$, $_{B+D}$ or $4<_{B}$, $_{B+D}$, respectively. Then we have the eigenvalues of time-dependent matrix equations for f_{aa} ; cc, ac cag in order of B = (4) as 3^B , 4 i 1 $5=3^2$, which shows that the period of qubit oscillation is delayed by the measurement through $^{\mathtt{B}}$ and $^{\mathtt{D}}$. Thus we found that the qubit behavior strongly depends on the relative magnitude of and this is also an important factor in the selection of the possible candidate of the logical basis. In Fig. 2 (b) of = 2 > D 02, F (t) s of joi and jdi are larger than those of jci (and jai). In Ref. 19, we argued the coherent oscillation of the DM without the detector and showed that the DM for joi and jdi are tim e-independent at = 0. This indicates that joi is the candidate in the region, re ecting that joi becomes an unpolarized triplet su ering less degradation from the repulsive Coulomb in-




FIG. 4: Linear entropy S_L and concurrence C plane under the m easurem ent during $0\stackrel{<}{=} t\stackrel{<}{=} 100_0$ for two qubit states jbi and jci (= 0). In weak m easurem ent case of $\stackrel{<}{=} 0.2$, C does not degrade to 0. A lldata start closely to W emer state.

teraction of the detector. On the other hand, in the = 0 case which can be in the \lim it of D ; B , Eq. (3) is easily solved even with a nite bias and $_{CC}$ is found to be a time-independent unpolarized triplet, being the candidate of logical state.

Next, we compare $_{bb}$ and $_{cc}$ in the purity plane, that is a relation between linear entropy and concurrence 20 .

Linear entropy $S_L = 4=3(1 Tr(^2))$ expresses purity of qubits, ranging from 0 (pure state) and 1 (maximallym ixed state). From Eq.(9), $S_L = 4=3[1]$ 2 aa $_{\rm aa})^2$ $2j_{ac}^{2}$], and we have $dS_{L}=dt=(2=3)^{D}$ (_{bb} +(8=3) B j_{ac} \hat{j} . Concurrence C, which is a measure of entanglement, is also given from Eq.(9). If we check the W emer state $_{\rm w}$ joihbj+ (1 $_{\rm w}$)=4 $\hat{\rm I}_2$ $\hat{\rm I}_2$ where $\hat{\rm I}_2$ is 2x2 unit matrix $(1 > w > 0)^{20,21}$, we obtain dC $^{(w)}$ =dS₁. $_{\rm W}$ = 1. Thus both $_{\rm bb}$ and $_{\rm cc}$ coincide with the W erner state at t 0, which shows that the two states are good entangled states, because the W emer state is a mixture of the maximally entangled state²⁰. Figure 4 shows that both bb and cc evolve close to the W emer state. Thus, the two states behave sim ilarly in the purity plane, and are equal candidates.

The noise spectrum S (!) of the QPC without qubits is given by S (!) = e^2 = (white noise) in the present model, thus, the shot noise a ects qubit states in full frequency dom ain. A sta ev et al. experimentally showed that the main causes of the noise in the Josephson qubits are f noise and the background charge noises or 1=f noise, which we do not include. These noises would locally a ect qubits and degrade the robustness of the DF states m ore than discussed here.

In conclusion, we have solved master equations of many qubits and QPC detector, and discuss the robustness of DF states under the large non-uniform ities (5%) during the long time period. Two-qubit non-DF states are shown to be one solution in constructing logical qubits.

To di erentiate the DF states, local measurements are required⁵. In Fig.1, this means that other independent detectors are required or i should be dierent for each qubit as in Ref.¹⁷. However, because the aim of this paper is to see the elect of local non-uniformity, we take the simple setup of Fig.1.
