## Entropy production and Pesin-like identity at the onset of chaos

A sym ptotically entropy of chaotic systems increases linearly and the sensitivity to initial conditions is exponential with time: these two behaviors are related. Such relationship is the analogous of and under specied conditions has been shown to coincide with the Pesin identity. Numerical evidences support the proposal that the statistical formalism can be extended to the edge of chaos by using a specied generalization of the exponential and of the Boltzmann-Gibbs entropy. We extend this picture and a Pesin-like identity to a wide class of deformed entropies and exponentials using the logistic map as a test case. The physical criterion of nite-entropy growth strongly restricts the suitable entropies. The nature and characteristics of this generalization are clarified.

It has been suggested that exponential and power-law sensitivity to initial conditions of chaotic systems could be united through the concept of generalized exponential leading to the de nition of generalized Lyapunov exponents [1]: the sensitivity  $\lim_{\mathbf{x}(0)!} {}_0 \mathbf{x}(t) = \mathbf{x}(0) \text{ grows asymptotically as a generalized exponential gxp(t), where gxp(x) = \exp_q(x) [1 + (1 - q)x^{1-1/q}]; the exponential behavior for the chaotic regime is recovered for q! 1: <math>\lim_{\mathbf{q}} {}_{1} \exp_q(\mathbf{q}) = \exp(t)$ .

The Kolmogorov-Sinai (K-S) entropy is de ned as the tim e-averaged production rate of Shannon entropy over the joint probability for the trajectory to pass through a given sequence of steps in phase space with appropriate coding of the sequence and lim it of the volum e that characterize the steps. The K-S de nition for most system s is not easily am enable to num erical evaluation and not directly equivalent to the usual therm alor statistical entropy. The connection between the K-S entropy production rate and the statistical entropy of fully chaotic system s and, in particular, of the three successive stages in the entropy time evolution is discussed in Ref. [2]. A fter a rst in itial-condition-dependent stage, the entropy grows linearly in the limit of in nitely ne coarse graining: this is the characteristic asym ptotic regim e. The last stage depends on the practical limitation of the coarse graining.

Since this statistical de nition of entropy production rate, where an ensemble of initial conditions connect to a small region is let evolve, appears to be relevant to thermal processes and practically coincides with the K-S entropy in chaotic regimes [2], we use it and call from now one K-S entropy K, even if it is in principle dierent.

The rate of loss of inform ation relevant for the abovementioned systems, which include both full-chaotic and edge-of-chaos cases, should be suitably generalized. In fact at the edge of chaos this picture appears to be recovered with the generalized entropic form proposed by T sallis  $[3]S_q = (1 \quad \bigcup_{i=1}^W p_i^q) = (q \quad 1)$ , which grows linearly for a speci c value of the entropic parameter  $q = q_{sens} = 0.2445$  for the logistic map:  $\lim_{t \to \infty} 1 \cdot \lim_{t \to$ 

K  $_{q}$ , where  $S_{q}$  reduces to  $_{i=1}^{P} p_{i} \log p_{i}$  in the limit q! 1  $p_{i}$  being the fraction of the ensemble found in the i-th cell of linear size L . The same exponent describes the asymptotic power-law sensitivity to initial conditions [4].

Finally, it has been also conjectured that the relationship between the asymptotic entropy-production rate K and the Lyapunov exponent for chaotic systems (Pesinlike identity) can be extended to K  $_{\rm q}$  =  $_{\rm q}$  [1].

Numerical evidences supporting this framework with the entropic form  $S_q$  have been found for the logistic [1] and generalized logistic-like maps [5]. Ref. [6] gives scaling arguments that relate the asymptotic power-law behavior of the sensitivity to the fractal scaling properties of the attractor. Finite-size scaling relates numerically the entropic parameter q to the power-law convergence to the box measure of the attractor from initial conditions uniformly spread over phase space [7, 8]. The linear behavior of the generalized entropy for specic choices of q has been observed for two families of one-dimensional dissipative maps [9].

Renormalization-group methods have been recently used [10, 11] to demonstrate that the asymptotic (large t) behavior of the sensitivity to initial conditions in the logistic and generalized logistic maps is bounded by a special confidence of the exponent could be determined analytically for initial conditions on the attractor. Again for evolution on the attractor the connection between entropy and sensitivity has been studied analytically and numerically, validating a Pesin-like identity for T sallis' entropic form [12].

Sensitivity and entropy production have been studied in one-dimensional dissipative maps using ensemble-averaged initial conditions chosen uniformly over the interval embedding the attractor [13]: the statistical picture, i.e., the relation between sensitivity and entropy exponents and the Pesin-like identity, has been con med even if with a dierent  $q=q_{\rm sens}^{\rm ave}=0.35$  [13]. Indeed the ensemble-averaged initial conditions appear more relevant for the connection between ergodicity and chaos and

for practical experim ental settings. The same analysis has been repeated for two sym plectic standard maps [14].

The main objective of the present work is to demonstrate the more general validity of the above-described picture and, speci cally, of the extended Pesin-like identity and of the physical criterion of nite-entropy production per unit time (linear growth), which strongly selects appropriate entropies and xes their parameters. For this purpose we use the coherent statistical fram ework arising from the following two-parameter family [15, 16, 17, 18, 19, 20] of logarithms

() characterizes the large (sm all) arguw here ment asymptotic behavior; in particular, exp(t) (t)1= for large t. The requirements that the logarithm be an increasing function, therefore invertible, with negative concavity (the related entropy is stable), and that the exponential be normalizable for negative arguments (see Ref. [21] for a discussion of the cri-1 and 0 teria) select 0 < 1 [20]; solutions with negative and are duplicate, since the family (1) possesses the sym m etry \$ . We have studied the entire class of logarithm s and exponentials and will show results for the following four interesting one-parameter cases:

- (1) the original T sallis proposal [3]: = 1 q and = 0:
- (2) the Abe logarithm :  $q_A = 1 = (1 + )$  and = = (1 + ), named after the entropy introduced by Abe [22], which possesses the symmetry  $q_A ! 1 = q_A$ ;
- (3) the K aniadakis logarithm: = = , which shares the same symmetry group of the relativistic momentum transformation and has applications in cosmic-ray and plasmaphysics [23, 24, 25];
- (4) in addition we have considered a sample spanning the entire class (values of ): in this letter we show results for the choice = 2 = 2, which we label logarithm [29].

We study the sensitivity to initial conditions and the entropy production in the logistic map  $x_{i+1}=1$   $x_i^2$ , at the in nite bifurcation point  $_1=1:401155189$ . If the sensitivity follows a deformed exponential (t) =  $\exp(t)$ , analogously to the chaotic regime when (t)  $\exp(t)$ , the corresponding deformed logarithm of should yield a straight line  $\mathbb{E}_g(t) = \mathbb{E}_g(\exp(t)) = t$ .

The sensitivity has been calculated using the exact formula for the logistic map (t) =  $(2)^{t}$   $\sum_{i=0}^{t} j x_i j$  for 1 t 80, and the generalized logarithm  $\log ()$  has been uniform by averaged over the entire interval  $1 < x_0 < 1$  by random by choosing 4 10 initial conditions. The averaging over initial conditions, indicated by h appropriate for a comparison with the entropy production.

Guided by Ref. In fact, the exponent obtained with this procedure has been denoted  $q_{\rm sens}^{\rm av}$  in the case of T sallis' entropy [13] to mark the dierence with the exponent  $q_{\rm sens}$  obtained by choosing an initial condition at the xed point of the map  $x_0=0$  [12].

Table I reports the values of  $_{\rm sens}^{\rm av}$  corresponding to four dierent choices of the logarithm with the shown statistical errors calculated by repeating the tting procedure for sub-samples of the 4  $10^7$  initial conditions; in addition we estimate a systematic error of about 0.004 by tting over dierent ranges of the exponent we ndusing T sallis' formulation  $_{\rm sens}^{\rm av} = 0.644$  0.002 is consistent within the errors with the value quoted in Ref. [13]  $_{\rm sens}^{\rm av} = 1$   $_{\rm sens}^{\rm av}$  0.36. The values of  $_{\rm sens}^{\rm av}$  are within 1%: taking into account the systematic error arising from the inclusion in the global tting of small values of , for which the dierent formulations have not yet reached their common asymptotic behavior (at least at




FIG. 1: Generalized logarithms 16g(), see Eq. (1), of the sensitivity to initial conditions averaged over  $4 \cdot 10^7$  uniform by distributed initial conditions as function of time. From top to bottom: T sallis', , A be's, and K aniadakis' logarithms. The linear rising behavior has been obtained with the asymptotic powers shown in Table I; the corresponding generalized Lyapunov exponents can also be read in Table I.

Figure 1 shows the straight-line behavior of  $\log()$  for all four form ulations when =  $\sup_{\text{sens}}^{\text{av}}$ : the corresponding slopes (generalized Lyapunov exponents) are reported in Table I with their statistical errors; a system atic error of about 0.003 has been estimated by dierent choices of the range of t. While the values of are consistent with a universal exponent independent of the particular deformation, the slope strongly depends on the choice of the logarithm.

the levelof1%), it can be estimated  $_{\text{sens}}^{\text{av}} = 0.650 \quad 0.005$ .

The entropy has been calculated by dividing the interval ( 1;1) in W =  $10^5$  equal-size boxes, putting at the initial time N =  $10^6$  copies of the system with an uniform random distribution within one box, and then letting the system's evolve according to the map. At each time  $p_i\left(t\right)$   $n_i\left(t\right)\!=\!\!N$ , where  $n_i\left(t\right)$  is the number of system's found in the i-th box at time t, the entropy of the ensemble is

where h is an average over  $2^4$  exponential exp (x) whose inverse is indeed the logarithm appearing in Eq. (1) [20]. is A nalogously to the strong chaotic case, where an exponential exp (x) whose inverse is indeed the logarithm appearing in Eq. (1) [20].




FIG. 2: Entropy as function of time, averaged over 2  $10^4$  experiments, each one with an ensemble of  $10^6$  points over a grid of  $10^5$  boxes. The entropies belong to the class of Eq. (2) and are defined with exactly the same exponents and used for the sensitivities; as in Fig. 1, the curves show T sallis', , A be's, and K aniadakis' entropies from top to bottom . Straight lines are guides to the eyes. The resulting rates of growth of entropy K can be read in Table I.

the usual logarithm ( = = 0), and consistently with the conjecture in Ref. [1], the same values and of the sensitivity are used in Eq. (2): Fig. 2 shows that this choice leads to entropies that grow also linearly. We have also veri ed that this linear behavior is lost for values of the exponent dierent from  $_{\text{sens}}^{\text{av}}$ , con ming for the whole class (2) what was already known for the q-logarithm [1, 13].

In Table I we report the rate of growth of several entropies K=S (t)=t; the statistical errors have been again estimated by sub-sampling the experiments. While this rate K depends on the choice of the entropy, the Pesin-like identity holds for each given deformation: K=S

There exists an intuitive explanation of the dependence of the value of K on , i.e., on the choice of the deform a-

tion. If the ensemble at time t is spread approximately uniformly over boxes, while the other (W) boxes are practically empty the entropy is S(t) f bg((t)) [ (t) (t)]=(+), being an elective average number of occupied boxes. Since the exponent is a property of the map, and practically independent of the entropic form, and choosing the rate of growth of T sallis' entropy K<sub>0</sub>, which corresponds to = 0, as reference, the dependence of K on the choice of results:

The rst factor is the asymptotic ( 1) ratio that de-

pends only on and , while the second factor gives the leading nite size correction. The last three lines of Table I compare the asymptotic and corrected theoretical predictions of Eq. (3) with the numerical experiment: this intuitive picture appears to hold with a 10% discrepancy between the asymptotic value and the corrected one which in turns reproduces accurately the experimental results with an elective number of occupied boxes 20. This result is clearly not restricted to the four representative cases explicitly shown.

In sum mary, numerical evidence corroborates and extends T sallis' conjecture that, analogously to strongly chaotic systems, also weak chaotic systems can be described by an appropriate statistical formalism. Such extended formalisms should verify precise requirements (concavity, Lesche stability [26], and nite-entropy production per unit time) to both correctly describe chaotic systems and provide a coherent statistical framework: especially the last criterion restricts the entropic forms to the ones with the correct asymptotic behavior. These results have been exemplied in a speciet wo-parameter class that meets all these requirements: it is the simplest power-law form describing small and large probability behavior and includes T sallis's seminal proposal. More specietally, the logistic map shows

(i) a power-low sensitivity to initial condition with a speci c exponent  $t^{1}$ , where = 0:650 0:005; this sensitivity can be described by deformed exponentials with the same asymptotic behavior (t) =  $\exp(t)$  (see Fig. 1 for exam ples);

(ii) a constant asymptotic entropy production rate (see Fig. 2) for trace-form entropies with a speci c power-behavior  $p^1$  in the limit of small probabilities only when the exponent is the same appearing in the sensitivity;

(iii) the asymptotic exponent is related to parameters of known entropies: for instance = 1 q, where q is the entropic index of T sallis' thermodynamics [3]; =  $1=q_A$  1, where q appears in a generalization of Abe's entropy [22]; = , where is the parameter in K aniadakis' statistics [23, 24, 25];

(iv) a generalized Pesin-like identity holds S = t ! K = for each choice of entropy and corresponding exponential in the class, even if the value of <math>K = depends on the speci c entropy (or choice of ) and it is not characteristic of the map as it is (see Table I for examples);

(v) the ratios between the entropy production rates K (analogous of the K-S entropy) from di erent members of the class of entropies in Eq. (2) can be theoretically understood from the know ledge of the power behavior of the deformed logarithm for large and small values of the argument, Eq. (3), and the predictions are con rmed by numerical experiments (see Table I).

W eakly chaotic systems can be characterized by deformations of statistical mechanics that yield entropic forms

with the appropriate power-law asym ptotic ( $p_i$ ! 0) behavior and a consequent asym ptotic power-law behavior of the corresponding exponential.

We remark that the physical criterion of requiring that the entropy production rate reaches a nite and non-zero asymptotic value has two consequences: (a) it selects a speci c value of the parameter ( is characteristic of the system); (b) strongly restricts the kind of acceptable entropies to the ones that have asymptotic power-law behavior (for instance it excludes Renyi entropy [27, 28]). The reason we ask for a nite non-zero slope is that otherwise we would miss an important characteristic of the system: its asymptotic exponent.

The proper generalization of the Pesin-like identity involves two distinct points: (1) the correspondence between the power-law behavior of the sensitivity for large times and of the proper entropy for small occupation probability (this power-law is independent of the generalization chosen); and (2) the equality of the generalized Lyapunov exponent and the entropy production rate: the numerical value is in this case dependent on the choice of the entropy.
