Enhancement of Coherent Response by Quenched Disorder

We investigate the elects of quenched disorder on the coherent response in a driven system of coupled oscillators. In particular, the interplay between quenched noise and periodic driving is explored, with particular attention to the possibility of resonance. The phase velocity is examined as the response of the system; revealed is the enhancement of the fraction of oscillators locked to the periodic driving, displaying resonance behavior. It is thus concluded that resonance behavior may also be induced by quenched disorder which does not have time-dependent correlations.

In recent years, the stochastic resonance (SR) has drawn much attention, which stands for the phenom ena that the response of a system to a periodic driving force is enhanced by an appropriate am ount of noise rather than suppressed [1, 2, 3]. Those SR phenomena observed in various real system s [4, 5, 6] are known to occur through the cooperative interplay between the noise and the external driving force, and require three ingredients: (i) an energetic activation barrier; (ii) a weak input such as periodic driving; (iii) a random noise [3]. In particular, the SR may be understood in terms of matching of two time scales, the period of the driving force and the inverse of the K ram ers hopping rate associated with the random noise. Note that the noise here usually has tim e-dependent correlations. Namely, the correlation between two noise forces i and i is given by $h_i(t)_i(t^0) = 2T_{ij}$ (t \hat{t}), where T represents the noise strength. Here naturally arises a question how does the SR behavior depends on such characteristics of the noise. In particular, one may ask whether such resonance behavior appears even for the quenched noise without tim edependent correlations.

To resolve this, we consider the system of coupled oscillators described by

where ' i represents the phase of the ith limit-cycle oscillator. The rst term $!_i$ on the right-hand side denotes the intrinsic frequency of the ith oscillator, assum ed to be distributed according to the G aussian distribution g(!) with zero m ean (h! i = 0) and correlations h! i! ji = D ij. Note that correlations between !i's are not time-dependent but quenched in time, in sharp contrast with the usual therm alnoise. The second term on the right-hand side describes the coupling between oscillators, whereas the third term represents the external periodic driving with the driving strength I_i chosen from a certain distribution function f (I). In the absence of the external driving (I_i = 0), Eq. (1) describes the wellknow n K uram oto m odel, where the synchronization phenom ena have been investigated extensively [7]. The scattered intrinsic frequency or quenched noise $!_i$ competes with the coupling strength K in the system : W hen the coupling is strong enough to overcome the scatteredness of intrinsic frequencies, synchronization emerges. Such synchronization behavior m ay be explored by m easuring the order parameter

where nonzero in plies the emergence of synchronization. It is known that the synchronization behavior of the system is characterized by (K K_c) with = 1=2 near the critical coupling strength K_c = 2= g(0) [7]. The K uram oto m odel has been also extended by m eans of introducing a constant in the argum ent of sine coupling [8]. Such extended m odel is also studied in Ref. [9], where frequency locking in the system of Josephson arrays is investigated.

M eanwhile, when the external periodic driving comes into system, the synchronization behavior has been observed to appear periodically [10]. However, the possibility of the resonance phenomena, which may occur via the cooperative interplay between the external driving and the quenched noise, has not been investigated. In this work, we exam ine the linear response of the system, with particular attention to the possibility of the resonance behavior due to the quenched disorder.

We rst investigate analytically the dynam ics of the system governed by Eq. (1). The order parameter de ned in Eq. (2) allow sus to reduce Eq. (1) into a single equation

where is to be determ ined by in posing self-consistency, and indices are suppressed for simplicity. Equation (3) reminds one of the single resistively shunted Josephson junction under combined direct and alternating currents. It is wellknown that such a system can be locked to the external driving, which is characterized by the Shapiro step [11]

with n integer, where '_ (v) is the time-averaged phase velocity. Such mode locking features suggest the ansatz

for the locked phase of the oscillator on the nth step. The external periodic driving in the system also leads us to expect periodic synchronization [10], where the order parameter is decomposed as

Inserting Eqs. (5) and (6) into Eq. (3), we obtain

where $J_{\mathbf{y}_{r}}(\mathbf{x})$ is the 'rth Bessel function and '_0 + $P_{s=1}^{1}$'s s + (n + $P_{s=1}^{1}$ s's) t. The integers 's satisfying s 's = n contribute to the dc component in :

where $\sim \prime_0 + \frac{P_{-1}}{s=1}$'s s and the prime in the sum mation stands for the constraint s's s = n. This gives an estimation of the dc driving strength ! corresponding to the integer locking. The amplitude A_p and phase p of the ac component with frequency p can be determined from the equation

with pintegers '' and 'r satisfying $P_{s=1}^{1} s'_{s}^{*} = p n$ and $S_{s=1}^{1} s'_{s}^{*} = p n$, respectively. When K $_{0}$ is su ciently small compared with the driving am plitude, Eq. (9) with p = 1 yields A_{1} and $_{1}$ to the zeroth order in K $_{0}: A_{1} = I =$ and $_{1} = 0$. It is observed numerically that the dc component $_{0}$ of the order parameter is much larger than higher-order (ac) components [$_{0}$ '(' 1)], which allows the expansion of the locked phase to the zeroth order in K $_{0}$. This gives the (locked) phase of the oscillator on the nth step as

display the locking behavior (v = n), with the higherorder term s of 0 (K $_1$) neglected.

The quenched disorder ! and the driving am plitude I are chosen from the distribution function g(!) and f(I), respectively, which yields the fraction r_n of the oscillators locked to the nth step:

For the G aussian distribution $g(!) = (1 = \frac{p}{2 D})e^{!^2=2D}$ and the delta function one $f(I) = (1=2)[(I J) + (I + I_0)]$, the fraction r_n in Eq. (13) is given by

where erf(x) denotes the error function. To estim ate the behavior of the fraction r_n as the variance D varies, we should know the behavior of the dc component 0 as a function of the variance D. N ote that the self-consistency equation for the order param etergives the behavior of 0 only near the critical point. To obtain $_0$ in the whole range of the disorder strength, we resort to num erical sim ulations and integrate Eq. (1) via Heun'sm ethod [12] with the discrete time step t = 0.01. W hile the equations of motion are integrated for $N_t = 8$ 10⁴ time steps, the data from the rst N $_{\rm t}$ =2 steps are discarded in m easuring quantities of interest. The system size N has been considered up to N = 20000, so that no appreciable size-dependence is observed. The driving amplitude I_0 in the distribution f (I) and the driving frequency have been chosen to be $I_0 = 0.8$ and = 1.0, 1.2, and 1.4,

respectively; the coupling strength K has been set equal to unity for convenience. W e measure the order parameter , and obtain the component $_0$ by taking the time average.




FIG.1: Total fraction $r_1 + r_1$ of the oscillators locked to the rst step (n = 1) versus the disorder strength D for K = 1:0; $I_0 = 0.8$, and = 1:0; 1:2, and 1:4. Inset: dc component $_0$ in the system of size N = 20000 at various driving frequencies.

The dc component $_0$ is shown in the inset of Fig. 1 as a function of the disorder strength D , displaying the m onotonically decreasing behavior. U sing this, we com pute the fraction r $_1$ of the oscillators which are locked to the state since r_1 is most dom inant over other components [r. (' 2)]. Figure 1 displays the total fraction $r_1 + r_1$ for K = 1.0; $I_0 = 0.8$, and = 1.0; 1.2; 1.4versus the disorder strength D . It is found that the fraction rst increases with D, which implies that a larger num ber of oscillators tends to follow the driving force as the quenched disorder becom es stronger. Rem arkably as the disorder is increased further, the fraction reaches the maximum and begins to decrease. For example, the optim ald isorder strength is observed to be D_m 0:17 for = 1:0. Such behavior of the fraction r $_1$ is rem in iscent of the SR, which is known to occur through the cooperative interplay between the external periodic driving force and the random noise. Note that in sharp contrast to the random noise in the conventional SR, the noise in the system governed by Eq. (1) is quenched with no tim e-dependent correlations. Namely, here the quenched disorder enhances the coherent response of the system . It is also shown that as the driving frequency is raised, the fraction r₁ of locked oscillators dim in ishes while the optim al strength D_m shifts to larger values. These tendencies re ect that the oscillators are reluctant to follow the driving which changes too fast, and that the disorder strength D should be enlarged to t the high driving frequency. Another point is that the fraction r_0 of the oscillators locked to the n = 0 step does not exhibit such resonance behavior; it rather displays the monotonic decreasing behavior, which is quite similar to that of the dc com ponent 0 of the phase order param eter. Higher fractions for n 2 also show the resonance behavior, although the magnitude is too small to be clearly discrim inated. We have also investigated the role of coupling on the enhancement of coherent response. As the coupling strength K decreases, such resonance behavior is found to be suppressed.

To con m such resonance behavior, we now perform num erical simulations. We obtain the probability distribution P (v) for the time-averaged phase velocity v under the same conditions as before, varying the disorder strength D. The data are then averaged over 100 independent sets of f!_ig. The inset of F ig. 2 displays the probability distribution for = 1.0 and D = 0.20, where three sharp peaks appear at v = 0 (not fully shown) and

. The two peaks at the driving frequency () manifest that some fraction of the oscillators follow the external driving force, locked to the latter. Note that such peaksmay also appear at higher frequencies n (jnj 2), although they are too small to be manifestly show n.

In the absence of the quenched disorder (D = 0), those peaks at v = do not emerge, and only the delta peak appears at v = 0. As the disorder strength is increased further, on the other hand, peaks show up at the driving frequency, with the height growing. The peak height h₁ at the driving frequency m ay be regarded as a good indicator which describes the response of the system to the external driving.




FIG. 2: Total height $h_1 + h_1$ of the peak at v = in the probability distribution versus the disorder strength D. Inset: probability distribution P (v) of the time-averaged phase velocity v for K = 1:0; $I_0 = 0.3$; = 1:0, and D = 0:20.

We num erically obtain the peak height, subtracting the background noise given by the average of ten data points around the peak. Figure 2 displays the total height $h_1 + h_1$ versus the disorder strength D in the system of size N = 20000, with the driving frequency varied from = 1.0 to = 1.4. We have considered the system size up to N = 40000, where no appreciable sizedependence is observed. The total height is found to rst increase with the disorder strength D and reaches its maximum at a nite value of the disorder, displaying quite a similar feature to the fraction r_1 [see Fig.1]. The enhancem ent of the height indicates that the quenched disorder actually increases the number of the oscillators locked to the external driving. To our know ledge, such enhancem ent induced by the quenched disorder without tim e-dependent correlations has not been addressed before. It is observed in Fig. 2 that the increase of the driving frequency tends to suppress the total height, and to shift the optim all disorder strength to larger values, which may be related with the intrinsic time scale of the system . Note that the conventional SR phenom ena have been known to occur when the K ram ershopping rate and the external driving frequency m atch each other. To see such time scale matching in the quenched-noise-induced resonance, we investigate the relaxation dynam ics of the system, and probe the time evolution of the renorm alized




FIG.3: Inverse relaxation time 1 vs the disorder strength D . The crossing points with the lines 1:0=2 ;1:2=2 , and 1:4=2 yield the values of D $_{\rm m}$ at the corresponding driving frequency.

where $_{eq}$ and (0) represent the equilibrium value and the initial one, respectively. The renorm alized order param eter $^{(t)}$ is thus expected to decay from unity (t = 0) to zero (t ! 1): $^{(t)}$ exp(t=).

Figure 3 shows the inverse relaxation time ¹ versus the disorder strength D for $I_0 = 0.8$ and = 1.0; 1.2, and 1.4. The intrinsic time scale of the system is observed to increase inde nitely as the disorder strength D approaches the critical value D_c beyond which synchronization disappears. The horizontal lines in Fig. 3 describe the time-scale matching conditions at various driving frequencies: the value of D at the crossing point corresponds to D_m at which the enhancement of the response is maxim ized. For example, for = 1.0; 1.2, and 1.4, the crossing points lead to $D_m = 0.19$; 0.21, and 0.22, respectively, which are consistent with the values obtained both analytically and numerically [see Figs. 1 and 2]. We thus conclude that quenched disorder may also enhance the coherent response of the system via the mechanism of the time-scale matching.

In sum m ary, we have explored the e ects of quenched disorder on the coherent response in the driven system of coupled oscillators. We have investigated the interplay between quenched disorder and external periodic driving, with particular attention to the possibility of resonance behavior. The phase velocity is probed as the response of the system; revealed is the enhancem ent of the fraction of the oscillators locked to the external driving, exhibiting resonance behavior. This provides the rst observation of the resonance behavior induced by quenched disorder. In a biological system such as synchronous re ies, different ring frequencies of re iesm ay be regarded as the quenched disorder. O ur results are applicable to expect those di erent ring frequencies (instead of sam e ones) m ay enhance the coherent response of the system.
