H igh-order H arm onic G eneration and D ynam ic Localization in a driven two-level system, a non-perturbative solution using the F loquet-G reen form alism

W e apply the F loquet-G reen operator form alism to the case of a harm onically-driven two-level system. We derive exact expressions for the quasi-energies and the components of the F loquet eigenstates with the use of continued fractions. We study the avoided crossings structure of the quasi-energies as a function of the strength of the driving eld and give an interpretation in terms of resonant multi-photon processes. From the F loquet eigenstates we obtain the time-evolution operator. U sing this operator we study D ynam ic Localization and H igh-order H arm onic G eneration in the non-perturbative regime.

I. IN TRODUCTION

The driven two-level system is a particularly in portant model in physics, since it has proved to be very useful in describing many aspects of the interaction of matter with an electrom agnetic eld. In the eld of atom ic physics, this system was traditionally studied using the Rotating W ave Approximation (RW A)¹, in which the counter-rotating term of the harmonic driving is neglected. This approximation is valid only for amplitudes of the driving eld that are small compared to the energy di erence between the atom ic states most a ected by the driving eld. This was typical for experiments until the 1960's. Presently, technical improvements in laser technology allow experimenters to produce very strong electrom agnetic elds (laser pulses) which can produce interesting non-linear elects in their interaction with matter.

The excitation of a spin 1/2 atom or electron in a magnetic eld interacting with a microwave eld is another example where the strength of the driving eld (RF radiation) can not be assumed to be small.

A lso, due to the progress in lithographic techniques and tunable lasers in the terahertz dom ain, it has become possible to construct semiconductor quantum well structures driven by a strong electrom agnetic eld. In these systems, several interesting results have been obtained, including, coherent suppression of tunneling [also called D ynam ic Localization (DL)]², collapse of m inibands in super-lattices³, absolute negative conductance^{4,5}, photon-assisted tunneling⁶ and AC stark e ect⁷.

The driven two-level system has also been used to describe an atom moving through a Fabry-Perot cavity.⁸ In this system, the strong coupling regime is already accessible both in the microwave and in the visible regime.

In all of the system s m entioned before, where strong elds are involved, the "counter rotating" term in the timedependent part of the H am iltonian does contribute signi cantly. Therefore, di erent theoretical approaches beyond RW A are required. One such m ethod was rst introduced by Autler and Townes⁹. Using F loquet's theorem and continued fractions, they derived a general solution in order to investigate the e ect of a radio frequency eld on the 1-type m icrow ave absorption line of the doublet J = 2! 1 of the m olecules of gaseous OCS.

Later, $Shirley^{10}$ employed F loquet theory to reduce the solution of a periodic time-dependent H am illonian to the problem of diagonalization of a time-independent matrix. This matrix was then used to calculate eigenvalues and transition probabilities for a driven two-level system and also to derive higher order (beyond linear RW A) analytic approximations valid in the case of weak driving. Later approaches to this problem, usually within the context of a spin system in a magnetic and a RF eld, have involved the use of continued fractions^{11,12,13}, although the role played by F loquet theory in those approaches (and in particular the role of the quasi-energy) is not clear.

A di erent kind of analytical expression for the quasi-energy of the system, which does not involve continued fractions was reported by Zhao¹⁴. It makes use of group theoretical arguments for its derivation and involves the evaluation of complicated in nite sums. A part from its intrinsic theoretical value, this solution does not provide a practical way to study this system.

There have been a variety of approaches used to obtain approximate analytic expressions. Most of them have been obtained in the high frequency $\lim it^{15,16,17}$, for ! !₀ or in the strong eld $\lim it^{18,19}$, for v h!. Here ! refers to the frequency of the driving, !₀ is the energy di erence between the two levels of the unperturbed Ham illionian and v is the strength of the driving. One of the most interesting features of a system described by these perturbative solutions is that at some speci c values of the driving eld strength (zeros of the zeroth-order B essel function) D ynam ic Localization (D L) occurs, which in the context of quantum wells means that despite a nonzero tunneling probability between the wells, a system initially prepared in one of the wells will remain in that well inde nitely. A manifestation of D L [also called C oherent D estruction of Tunneling (CD T)] was rst found in a tight binding potential with an applied AC electric eld.²⁰ D L in quantum wells was rst studied by G ro mann elal.²

In a paper by $Ivanov^{21}$ in which H igh-order H arm onic G eneration (HHG) by diatom ic m olecular ions is considered, and then m ore recently in works by Santana et al²² and also D elgado and G om ez L brente²³, analytical expressions in terms of B essel functions were found, valid in the (perturbative) regime where D L occurs. This regime can be characterized by the condition $!_0 = ! 0$ for any v, or $!_0 = ! v = h! 1$. We will say that whenever any of these two conditions is satistical, the system is in the D ynam ic Localization Regime (D LR). When that regime is reached, our results converge to the known B essel-function expressions.

In this work we present a fully developed F loquet-G reen form alism for time periodic systems, which we then use to derive an exact solution for the two level system with harm onic driving. This exact solution is expressed in terms of continued fractions, suitable to the study of the regime where neither the RW A nor any other perturbative approach works. Our aim is to present a whole picture of this system, of its eigenvalues and eigenstates in the di erent regions of its parameter space and to obtain from the general solution a better understanding of the two main features of this system, namely, D ynam ic Localization (D L) and H igh-Order H arm onic G eneration (H H G).

In section II we derive the F loquet-G reen operator form alism and establish a connection between the poles of this operator and the components of the F loquet eigenstates.

In section III we apply this form alism to the specic case of the two-state system with harmonic driving. By making use of continued fractions, we obtain an expression for the quasi-energies. We study the structure of avoidedcrossings in the quasi-energies and interpret them in terms of multi-photon processes. We also derive here the F loquet eigenstates (FES) of the system and study their dependence on the amplitude of the driving eld for di erent values of the two-level energy di erence. The tim e-evolution operator is constructed using the FES.

In section IV, using the above mentioned operator, we study D ynam ic Localization (DL), and in section V we study H igh-order H arm onic G eneration (HHG).

In Section VI we sum marize our ndings and give som e concluding remarks.

II. FLOQUET-GREEN OPERATOR FOR HARMONIC DRIVING

The pioneering work of Shirley¹⁰ and Sam be²⁴ laid down the theoretical foundations for a complete treatment of time-periodic potentials, based on the same mathematical tools already developed for time-independent potentials. Of great importance among these tools is the Green's function, whose de nition and application for time-periodic systems has not been clear until recently. A F loquet-Green function method for the solution of radiative electron scattering in a strong laser eld was introduced by Faisal²⁵. In this work we present a fully developed picture of the F loquet-Green's operator formalism for general time-harm onic H am iltonians that was introduced by the author in a previous work²⁶, and apply it to the case of a two-state system with harm onic driving.

W e start by considering a H am iltonian of the general form :

were H₀ and V are Herm itian operators in the Hilbert space (H) of the system. Because of the periodicity of the Ham iltonian, according to F loquet's theorem, the solutions to Schrodinger's equation $ih \frac{\theta}{\theta t} j$ (t) i = H (x;t) j (t) i are of the form

Inserting this into Schrodinger's equation one arrives at the eigenvalue equation

As pointed out by Sam be^{24} , since Eq.(3) is an eigenvalue equation, it can be solved using the standard techniques developed for time-independent H am illionians, provided we extend the H ilbert space to include the space of time-periodic functions. In this extended space, the time parameter can be treated as another degree of freedom of the system . A similar concept is used in classical mechanics, and gives rise to the concept of a "half" degree of freedom when dealing with time dependent H am illionians.

A suitable basis for this extended Hilbert space (R) is fji ji;::g, where fji;::g is a basis for the Hilbert space H of the system, and we de ne htji \overline{N} e ^{in!t}, with n integer. C learly fji;::g spans the vector space (T of periodic functions, and therefore, R = H T. In this basis, Eq.(3) becomes a matrix eigenvalue equation of in nite dimension with an in nite number of eigenvalues. It is not dicult to proof that if e_i is an eigenvalue, with corresponding eigenvector j^{ei} (t) i, then e_i + m is also an eigenvalue (all quantities are assumed to be in units of h!), with corresponding eigenvector j^{ei+m} (t) = e^{im!t} j^{ei} (t) i. A coordingly, the eigenstate corresponding to eigenvalue e_i + m has the same structure than the eigenstate corresponding to e_i, except that it is displaced by m on the energy axis. Because of this, to nd all the eigenvectors and eigenvalues of the F loquet H am iltonian one needs only to consider $\frac{1}{2}$ e < $\frac{1}{2}$. We will use the letter " to refer to the F loquet eigenvalues restricted to this interval and call them

"quasi-energies". Clearly, any Floquet eigenvalue e_i can be written as $e_i = "_i + p$ for som $e_i = \frac{1}{2}$ " $i < \frac{1}{2}$ and som e integer p. It can be shown that, in general, there are N distinct quasi-energies (except for accidental degeneracies) if the H ibert space H is N dimensional.

This periodic structure in the eigenvalues does not m ean that the "replica" eigenstates have no relevance; they are also valid solutions of Eq. (3) and are essential for completeness in the extended H ilbert space R 27 . They also allow us to understand som e features of the quasi-energies of the system in terms of avoided crossings between "replica" eigenstates.

The Floquet-G reen operator for the Floquet Ham iltonian in Eq. (3), is de ned by the equation²⁶,

where (t) is the -periodic delta function ($=\frac{2}{1}$).

In term s of the complete (in nite) set fj e_1 (t) ig of eigenfunctions of the F loquet-H am iltonian (Eq.4), the solution for Eq.(5) is

From the previous discussion about the eigenvalues and eigenfunctions of the F loquet H am illonian, we can write the F loquet-G reen operator entirely in terms of the eigenfunctions corresponding to values e_i between $\frac{1}{2}$ and $\frac{1}{2}$. We will denote these eigenvalues as ". U sing this, the F loquet-G reen operator can be written as

This last equation shows us the relationship between the residue of the operator G_{p_0} (E) at the pole " + p and the Fourier component $j_p^{"}$ i of the Floquet eigenstate $j_{"}$ (t)i. Notice that $j_{"}$ (t) $i = {}_{p} e^{-ip!t} j_p^{"}$ i. From this we

conclude that, corresponding to each pole at E = " + p of the F bquet-G reen operator $G_{0;0}$ (E) there is an oscillating term of the form $e^{ip!t}$ in the F bquet eigenstate specified by the quasi-energy ".

Let us go back to the task of nding an explicit solution to the F loquet-G reen operator in Eq.(5). Applying $\frac{1}{2} \int_{0}^{\infty} e^{i\pi t^{0}} e^{i\pi t^{0}} e^{i\pi t^{0}} dt'' dt'' dt'' on both sides of this equation, and using Eq.(4) together with the de nitions above we get$

The explicit solution of this equation, in term s of matrix continued fractions follows from 26 . The resulting expression for the operator $G_{0;0}$ (E) is

We now specialize this result for the case of a two state system driven by a classical single frequency potential.

III. HARMONICALLY DRIVEN TWO-LEVEL SYSTEM

In this section we apply the form alism previously presented to the case of a driven two-level system of the form

where H, $\frac{1}{2}_{0}$ and v are given in units of h!. In the context of an electron interacting with an electric eld, the am plitude 2v corresponds to the (static) dipole moment of the electron times the applied electric eld, i.e. $2v = E_0 = h!$, (the factor of two has been introduced for convenience) and the classical electric eld is of the form $E(t) = E_0 \cos(!t)$. In a double quantum -dot realization of this H am iltonian, the non-driven part, $\frac{k_0}{2}_{z}$, describes the tunneling between the states localized on each dot, fjli; 2ig. This tunneling gives rise to a splitting of $h!_0 = \frac{1}{2}(1)!$ between the energy levels $\frac{h!_0}{2}$; $+\frac{h!_0}{2}$, whose corresponding eigenstates we denote by fjai; big, and where $bi = \frac{1}{2}(1)!$, $\frac{1}{2}i$, whose corresponding in Eq.(4) is written in the basis fjai; big. For an atom ic system, $\frac{k_0}{2}_{z}$ describes two bound states of the atom ic (or m olecular) potential, or, in the context of ionizing system s it could also be thought of as describing a bound state and the continuum $\frac{28/29}{2}$. An electron moving in a Fabry-P erot cavity⁸ or a 1/2 spin system with an applied magnetic and microw ave $eld^{11,12,13}$, are also examples of system s where this model has been used.

C ontinued fractions methods have been used before to study this system, specially in the context of spin 1/2 system s in a magnetic and RF eld, starting with the sem in alwork of A utler and Townes⁹. A lso, a previous treatment of this problem where the time dependent G reen's function and continued fractions were used, although without reference to the F loquet form alism can be found in the work by G ush and G ush³⁰. There have been several perturbative approaches to this problem, as it was mentioned before. Here, we will focus on the properties of the exact solution, and in particular we will study its dependence on the strength of the driving eld and the connection with H HG and D L.

To nd the exact solution to this H am iltonian we need to evaluate Eqs. (12,13), for the case $V = v_x$ and $H_0 = \frac{!_0}{2}_z$. It can be checked easily that, given the o-diagonal form of V and the diagonal form of H_0 , the matrices V_e (E) are diagonal. Its diagonal components will be denoted respectively by fv_a (E); v_b (E) g. The dynam ic elective potential V_e (E) is therefore also diagonal and of the form

From Eq.(12), the solution for $G_{0;0}$ (E) is also a diagonal matrix of the form

It can easily be seen from Eq.(17) that this system possesses the symmetry v_a (E) = y(E), which from Eq.(19) gives us g_a (E) = g(E). This means that to nd the two quasi-energies of the system one only has to look for a pole in either g_a (E) or g_b (E) in the range 0.5 E 0.5; the other pole is symmetrically located on the opposite side of the (quasi) energy axis.

A. Poles of $G_{0;0}$ (E) and the quasi-energies of the system

As discussed before, the quasi-energies of the system can be obtained from the poles in $g_a(E)$ and $g_b(E)$. We showed that it is su cient to study the poles in only one of these functions since for any pole in $g_a(E)$ at E = E there is a corresponding pole in $g_b(E)$ at E = E. This implies the existence of two quasi-energies in the system, "; ". The quasi-energy " can be obtained from the solution to $g_b(E)$ ¹ = 0 in the interval 0.5 < E < 0.5. From Eqs. (17),(19), the poles of $g_b(E)$ satisfy the equation,

where = E $\frac{k_0}{2}$. The quasi-energy is obtained as " = $(\frac{k_0}{2} +)$ m od 1.

In Fig. 1 we show one of the quasi-energies of the system, for di erent values of $\frac{1}{2}_0$. These functions are plotted as a function of the driving strength v. We have included the resonant case $\frac{1}{2}_0 = 1$ and several values in the high frequency regime where $\frac{1}{2}_0 < 1$. In the limit when $\frac{1}{2}_0 << \max(1; \frac{1}{2}, \frac{1}{2})$, the function $"(v) = \frac{\frac{1}{2}}{2}J_0$ (4v). This result was rst obtained by Shirley¹⁰. It is precisely in this regime where it was shown^{22,23} that D L appears as a dominant feature. As $\frac{1}{2}_0$ decreases we observe a very quick convergence to the approximate result $"(v) = \frac{\frac{1}{2}}{2}J_0$ (4v). A lready for $\frac{1}{2}_0 = 0.25$, the di erence between the exact result for "(v) and the approximation cannot be observed at the scale of the graph. For $\frac{1}{2}_0 = 0.1$ we plotted both "(v) and "(v) to make the location of the zeros of J_0 (4v) more visible. In Fig. 2 we show the quasi-energy as a function of the driving strength v, for low frequencies, where $\frac{1}{2}$ 1. The resonant case is included for comparison. A loo, the dotted line shows the functions 0.05J_0 (4V) in order to indicate the location of the zeros of this B essel function. A s one increases $\frac{1}{2}$, the amplitude and sharpness of the oscillations around $\mathbf{u} = 0$ increases, the location of the zeros shifts to the left, and the parabola that describes (except in the resonant case) the initial behavior of the curve opens up. For $\frac{1}{2}$ 2 one can get from Eq.(20) that the initial behavior of the quasi-energy is parabolic and has the form

This remains a good approximation for all values of v until (v) $\frac{k_0}{4}$, and provided (v) does not reach the edges of the Brillouin zone (-0.5,0.5) before that. If it does so, then, the quasi-energy experiences an avoided crossing, whose sharpness is proportional to k_0 and decreases with the value of v at which the anti-crossing occurs.

B. A voided crossings

In Fig.3 we can see that the structure of the quasi-energy is determ ined by a regular sequence of avoided crossings which get broader as the strength of the driving eld v is increased (resonant case shown in the gure).

Let us consider the nst avoided crossings, the ones along the line marked "3 ph. res" in Fig. 3. To zero order in v, the eigenvalues and eigenvectors of the F loquet H am iltonian are the state vectors jaiji; jbiji, for any integer n. In this basis, the time-dependent potential can be written as $V = v_x (a + a^y)$. When the elect of one photon processes (in the RWA) is included, one obtains that the new set of eigenstates is fjn; ig, for any integer n, and where jn; $i = \frac{p_1}{2}$ (jaijii jbiji 1i). It's corresponding eigenvalues are $p = \frac{1}{2} + n$ v. This one photon process is in a sense an avoided crossing, with a width that goes to zero as v! 0. One can see that, near v 1, the eigenvalues corresponding to the eigenstates jn; i and jn 2; i would cross if only st order processes where allowed. To second order this degeneracy is not lifted since hn 2; j^2 jn; i = 0. Only when third order processes are included, this degeneracy is lifted, since it is easy to check that hn 2; j^2 jn $i \in 0$. Third order processes are therefore involved in the avoided crossing near v 1.

For the resonant case, after the nst avoided crossing (v 1), for example between the states j; i and j 1;+i, and because of considerable overlap between the 3 photon resonance and the 5 photon resonance, this states do not completely exchange their identities, as it would be the case in a well isolated avoided crossing. An "identity exchange" between F loquet states can clearly be observed for values of $\frac{1}{0}$ and v for which there is a sharp avoided crossing (i.e. $\frac{1}{0} = 3.0$ in Fig.5). In Fig.3, for the resonant case we can see that even though the structure of the eigenstates after the rst avoided crossing is not necessarily of the form jnii, the points where the quasi-energies of these " rst-order" FES cross, come close to the actual location of the avoided crossings. This is an indication that those states are dom inant in the structure of the eigenstates, a fact that can be checked by comparing the actual structure of the FES in Fig. 6, at some amplitude v, with the corresponding " rst order" FES are only one unit of energy further out that the expected value from the simple picture in Fig.3. It is an interesting feature of this system the fact that the FES obtained for small driving amplitudes constitute the "bare bones" structure of the FES and to a good extent they determ ine the avoided crossing structure of the quasi-energies (at least for a larger-than-expected range of driving ekd amplitudes).

This avoided crossings structure, to a certain approximation, can be thought of as mostly due to odd-photon processes between FES. Even more, we will argue that at least for a range of v (0 < v < 4 for the resonant case), the main contribution to the avoided crossings is a three photon process for the rst avoided crossing, 5 photon for the second avoided crossing, and so on (in the resonant case). For any value of $\frac{1}{2}_0$ we not that the number of photons involved in the rst avoided crossing will be the 5 photon resonance (Fig.5); for $\frac{1}{2}_0 = 5$ it will be the 7 photon resonance, etc. In general we can write that, for $\frac{1}{2}_0$ 1 the order of the rst resonance is 2 $\operatorname{Int}\left(\frac{1}{2}\right) + 3$. The avoided crossings picture holds for any $\frac{1}{2}_0$ provided v is not too big; an estimate is $v < 4\frac{1}{2}^2$. Above this, the overlap between di erent photon processes is too big for our simple picture to apply.

In Fig.3. it can be seen that the states that intervene at each avoided crossing are of the form $\frac{1}{2}n + 1$; i and

2n + 1 2m ; + i, form = 1;2;3:... It is easy to check that

This is a good indication that these avoided crossings can be interpreted as multi-photon resonances that involve odd numbers of photons. From Fig. 3, we see that at the avoided crossing A, from the interacting states jl; i and j 1;+i, there should be a three photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and a 1 photon exchange between jaijli and jbij 2i and jbijli. From the exact result for the components of one of the FES shown in Fig. 6 we see that the dom inant components should be jaijli and jbij 2i; this corresponds to a three photon process. Near the avoided crossing B in Fig.3, where v 2, we can see from Fig.5 that the dom inant components are ja; 3i and jb; 2i which corresponds to a 5 photon exchange. For values of t_0 and v for which the avoided crossings are sharper one gets an even clearer picture of those avoided crossing as resulting from the exchange of a speci c odd number of photons between F loquet states.

It is interesting to see how this description of avoided crossings and photon processes is rejected by the structure of the continued fractions in Eq.(20) and how the different terms in it contribute to the features of the quasi-energy as a function of the driving amplitude. From examination of Eq.(20) it is not different to see that for small v, each term of the form + gives a solution near = . To ind accurately the solution of for a particular value of v one does not need to (nor can) include an in nite number of terms in the C F.An important question is therefore, how many terms to include and why? To study this, we inst propose a way to truncate Eq.(20) so that we obtain, in each case, a symmetrical set of solutions. For illustration we will continue focusing on the particular case of resonance ($t_0 = 1$), as it is straight forward to apply the same ideas shown here for other values of t_0 .

In the di erent panels in Fig. 4 we plot the solutions for (v) as obtained from the equation $F_n^+F_n = v^2$ for n = 0;1;2;3 [panels a) through d)], and only for the resonant case $\frac{1}{2}_0 = 1$. We also plot with a dashed line and for comparison, the exact result for (only the two smallest roots are shown). Also, in front of each plot there is an insert with a diagram with lines and arrows. The lines represent each term that has been included in the continued fractions F_n^+ and F_n^- . As we mentioned before, each term of the form + contributes with an eigenvalue curve that originates at =. There are two kinds of term softhat form in the C F.'s of Eq.20): 2n and $+\frac{1}{2}$ (2m + 1). The rst ones contribute, at v = 0, with a solution at = 2n and therefore a pole at $E = E_b^- 2n$. The second kind gives a solution for $= \frac{1}{2}$ (2m + 1) which contributes with a pole at $E = E_b^- \frac{1}{2}_0$ (2m + 1) = E_a^- (2m + 1). To the lines on the left we associate the states $\frac{1}{2};2n + 1i$. We will label this lines as a + 2n + 1, for some n; the lines on the right we associate with the particle- eld states $\frac{1}{2};2n + 1a$ as b + 2n. A sim ilar picture would result from studying the poles of $g_a(E)$.

W hen two such terms in the CF are included, then we see, in the corresponding panel in Fig.4, a pair of solutions, which at v = 0 converge to = 2n and split for v > 0. We know, from previous discussions, that the upper one should correspond to the FES, 2n + 1; $i = j_2 + 1$; $j_3 + 1$; $i = j_2 + 1$; $j_3 + 1$; $i = j_3 + 1$; $j_3 + 1$; $j_$

jbi. This is the main process at work in panels a) and b). In panel c) two new processes enter the picture: As the levels move apart due to the one photon resonance, another resonance (A) can now occur when the levels β ; i and j_1 ; + i mostly due to the transfer of three photons between j_2 ; 3i and j_2 ; 0i. This process appears for the rst time for F_2 when the term j_2 ; 3i is included in the CF. A replica of this three photon resonance occurs also between levels j_1 ; i and j_1 ; + i.

When $j_2; 3i$ and $j_2; 2i$ is included, the second process that becomes available is the verphoton resonance between levels $\beta;$ i and j 1;+i (after this level have interacted with $j_1;+i$ and $j_2;$ i respectively). This resonance becomes more clearly dened in paneld) where more levels are included. Even though, as compared to c), no new resonances appear in d), the inclusion of levels $j_2;$ 3i and $j_2;4i$ contributes to sharpen the resonances already visible in c) and in particular the 5 photon resonance B. This shows that, as mentioned before, there are several odd-photon processes that contribute to a particular avoided crossing. There is how ever, an odd number of photons that seem s to contribute the most and without which, if the corresponding levels are not included, the corresponding avoided crossing does not seem to occur. That speci c number of photons is shown on the top of Fig.3. For v > 4 this pictures begins to falter, and the avoided crossings begin to depend m ore on a higher number of photons than what would be predicted from Fig.3. For v = 5 for example, a better description of the crossing would be for a 15 photon resonant process, not the expected 13. For even higher values of t_0 this picture holds on a bigger range of the driving eld am plitude, namely, for $v \le 4t_0^2$. As mentioned before, one can see that in Fig.5, for $t_0 = 3$, the rst avoided crossing is clearly a 5 photon resonance.

As an empirical rule, which agrees with the above observations, we found that to obtain an accurate result for the quasi-energy up to a value v of the driving potential one needs to use the function F^n (E), with n > Int(2v).

C. Components of the Floquet EigenStates

In the previous subsection we showed how to obtain the diagonal part of the F loquet-G reen operator and discussed its pole structure and their avoided crossings. In this part we study the F loquet eigenstates and the general behavior of them as the am plitude of the driving eld changes. In Appendix A we show that the FES of this system can be written in the form

N is a normalization constant and K(t)f + Z(t)f = 1. In appendix A we also show the explicit form of the components K_{2n} , Z_{2n+1} , in Eq.(61). It can there be seen that all components K_{2n} and Z_{2n-1} are real, and therefore K (0) and Z (0) are also real numbers.

In Fig.6 we show the components of one of the F loquet eigenstates of the system, j "(t)i, for the resonant case, and for eight di erent values of the driving eld amplitude. In the upper gure of each panelwe show the quantities Z_n , K_n (with n odd for Z_n and n even for K_n), and in the lower panels we show the quantities $\ln Z_n$ j $\ln K_n$ j.

A noticeable qualitative di erence between the behavior of Z_{2n-1} and K_{2n} is the fact that for stronger values of v, the form er becom es m ore antisymmetric while the last one becom es m ore symmetrical around n = 0. We will comment shortly about the consequence that this has for the dynamic localization of the system. The fact that the eigenstates of the system have components that are harmonics of the driving eld frequency !, translates, as we will study in the next section, into a (coherent) emission spectrum of the system which contains also m any frequencies that are multiples of the frequency of the driving eld. The possibility of exciting a system at a particular frequency with a strong eld, and producing radiation that includes m any harmonics of the driving frequency (in some cases even hundreds of them) is called H igh H armonic G eneration (HHG) and has been studied in m any experiments.³⁴

existence of a plateau in the spectrum followed by a sharp cut-o where the amplitudes of the harm onics decrease rapidly.^{16,21,28,35,36,37,38}

As one can see directly from Fig. 6 (resonant case), in most of the cases shown, the F loquet eigenstates show a particular structure with two clearly distinguishable regions. The nst region which, in a non-rigorous way we call the "chaotic" one, can be described as corresponding to the F loquet components with $j_1 j^{<} N_e = 2v = 1$ (for v = 1 in the resonant case). The amplitude of these F loquet components depends strongly on n and on v, and there are frequent sign changes. This gives rise to the "plateau" region typical in HHG. The second region, or the "regular" one corresponds to the components with $j_1 j > N_e$, and it is characterized by having amplitudes that decay exponentially with n. A lso, notice that the components K_n and Z_n do not change sign in that region, with K_{2n} > 0, and sg(Z_{2n 1}) = sg(n) in the "regular" region (sg(x) x=jx). For other values of $\frac{1}{20}$, a plateau region was always found whenever $v \ge \frac{1}{k_0}$ (for $\frac{1}{k_0}$ 1), in agreement with a similar expression obtained by K aplar²⁸ in the limit $\frac{1}{k_0} >> 1$. For $\frac{1}{k_0} < 1$, the plateau form s for any $v \ge 1$.

The expression $N_e = 2v$ 1 can be derived in a simple way. First, we look at the conditions to obtain, for n > 0 a perfectly at, triple plateau in the components of the FES. This means that we will assume $K_{n+2} = Z_{n+1} = K_n$ (which gives three consecutive components with the same am plitude), for some n even. This condition can be achieved if, from Eq.(61), v_a^+ ("+ n) = v_b^+ ("+ n + 1) = v. From Eq.(16) we get the condition,

C learly, since in general this 4 equations can not be (nor we care for them to be) satis ed sim ultaneously, we bok for a condition that will produce a simple (possibly) double cusp, both at N_e and N_e . This would describe the location of the two broad peaks that are, in all cases, at the lim it between the "chaotic" and the "regular" region. For obtaining this symmetric at cusp condition we pick the equation that is right in the middle of the set of 4 equations given above. This equation is clearly

with the nice property that the " and the $\frac{1}{20}$ dependence drops out. This is a result that should work well whenever there is a well de ned "plateau" region, that is, for $v = \frac{1}{20} when \frac{1}{20} = 1$, or v = 1 when $\frac{1}{2} < 1$. As can be seen in Fig.6, for $\frac{1}{20} = 1$ and v = 1, this equation seems to describe well the location of the peaks in the spectrum of an eigenstate that separate the plateau from the exponential decay region. For other values of $\frac{1}{20}$ it gives also good agreem ent with the data.

To investigate further the structure of the FES of the system, we use Eq.(24), and evaluate at t = 0,

We now concentrate on the study of the quantities $\cos(v)$; $\sin(v)$; (v), which, as we will see in the next sections, play an important part in the evolution of the system, and correspondingly in the Dynam ical Localization and H arm onic G eneration of the system. In what follows we will study them for three diment values of the parameter t_0 : D riving frequency above resonance, for $t_0 = 0.5$; resonant case for $t_0 = 1$ and driving frequency below resonance, for $t_0 = 2$.

In Figs. 7,8,9, we show the results for $t_0 = 0.5$, $t_0 = 1.0$ and $t_0 = 2.0$ respectively. The upper panels show the dependence of the functions $\cos^2(2 \, (v))$ and $\sin^2(2 \, (v))$, and the lower panel the functions (v) and "(v). As a

function of the driving eld am plitude v, these functions show an oscillatory behavior, which can be better appreciated in the lower panels, where the function (v) is plotted along side with "(v). An interesting feature of this functions is the fact that in general, and to a good approximation, there seems to be a phase shift of =2 between "(v) and (v), which corresponds to a distance of v 0:4 between their maxima. This means that to (alm ost) every maxima of

(v) corresponds a zero of "(v) (the D L points) and vice versa, with the only exceptions occurring at the rst maxim a or the st zero of this functions. Notice also that (v) does not oscillate symmetrically around zero, with the clear consequence that the peaks in the functions $\cos^2(2(y))$ and $\sin^2(2(y))$ have uneven heights, with alternating high and low peaks, although with an overall decrease in height. This alternating pattern of maxim a seem s to be a general feature of the system, which we have found for all the values of $\frac{1}{2}_0$ that we exam ineq. The DL regime, which can be characterized by the parameter $\begin{bmatrix} 0 \\ t_0 \end{bmatrix}$ in $(1;1=\frac{p}{v}) << 1$, has been studied in

several works. In this regime it was found 16,22 that, at t = 0, the eigenstates of the system are of the form

In Figs. 7,8,9, in the low er panel we have plotted with a dash-dot line the function $\frac{1}{2} - \frac{1}{4} H_0$ (4v). As it was expected, since in the DL regime sin <<1, then sin , and (v) ! $d_{\frac{1}{4}}H_0$ (4v). The convergence of (v) to the Struve function is clearly slower for the bigger values of t_0 . It is however rather remarkable that the Struve function seems to approximate well the function (v) much before the DL regime condition is satised (1); for exam ple, for $t_0 = 0.5$, and v = 1, or $t_0 = 1$ and v = 4, which both give = 0.5 < 1 we already see a good agreement between those two functions. One can also see from Fig.7,8,9 that the Struve function correctly gives the height of the maxim a in (v), with the dierence between those two functions being mostly a phase dierence that tends to zero as v! 1. From the asymptotic form of the Struve function in the limit v ! 1 we obtain that, in that limit,

IV. DYNAM IC LOCALIZATION

It is of particular interest to study the situation where the the system's initial state is a superposition of the eigenstates of H₀. In particular, specially in the context of quantum wells, a particularly interesting initial state is one in which the electron is localized in one of the wells. Such an initial state corresponds to $j(0)i = jli = \frac{p_1^2}{2}(jai + jbi)$, or $j(0)i = jli = \frac{p_1^2}{2}(jai - jbi)$. In this case, we are interested in calculating the probability to not the system at that same location after a time t. The solution can be found by applying the transform ation $V = \frac{p_1^2}{2}(z + x)$, which corresponds to the change of basis fjai; jbig ! fjli; j2ig, to the evolution matrix in Eq.(34). The resulting matrix, $U_{12} = V U_{ab}V^{-1}$, can be written as

It is a well-known fact that dynamic localization occurs only at the points where the quasi-energies vanish, i.e. "(v) = 0. At this particular values of driving eld am plitude v, as it can be seen from Eqs.(34) and (35), the dynamics of the system becomes strictly periodic, with period 2 =!, for any initial condition. The points where sin (v) = 0 also produce a periodic evolution of the system (except for an overall time-dependent phase factor), but only for the particular initial conditions j (0)i = jai or j (0)i = jai.

To study the system at the DL points, we will bok at the quantity $ju_{11}(t)f$, which gives the probability (as a function of time), that the system, if localized in a well (e.g. jli) at time t = 0, would remain in that well at a later time t. For "(v) = 0, and from Eqs.(35,39) we get

W e will show in the following gures that the function $\cos(2)$ plays an important role in quantifying how good is the localization of the system at the DL points.

In the lower panels of F igs.7,8,9, we have placed dots on the quasi-energy functions "(v), at di erent values of v. In the upper panel in F igs. 10,11,12 we show, for each one of those points, the corresponding probability $j_{1,1}(t) f$, as given by Eqs. (35), (39). This probability gives the location of the particle, as a function of time, when starting from the initial state jli. In Fig.10 we study the case $t_0 = 0.5$. In this plot one can see that the probability evolves in a manner that is typical of the high frequency regime which has been amply studied in the literature. The function can be described as of the form $\cos("t)$ + sm all time-periodic oscillations. Clearly, at the D L points (A, B, C, D), when " = 0, the probability is exactly periodic (period 2 !) and oscillates between 1 and a value that depends on the driving eld amplitude v and on t_0 . As derived before, in the middle of the driving period, the probability $j_{1,1}f = \cos^2(2 - (v))$.

Given the correspondence between the maxim a of (v) and the zeros of "(v), we can conclude that the minim a of the function $\cos^2(2 - (v))$ tells us the value of the probability $j_{1,1}(t) f$ half way through the driving eld period (t = =!), at the corresponding DL point (with the exception of point A). This value of $j_{1,1}(t) f$ is very in portant because it gives us inform ation about the extend to which the particle is localized when the DL points are reached. A s we can see in the low er panels of F igs. 10,11,12, when the function $j_{1,1}(t) f$ has a local minimum at t = =!, then $\cos^2(2 - (v))$ is close to be the absolute minimum value that $j_{1,1}(t) f$ reaches through out a whole period, $P_1 = m$ in $(j_{1,1}(t) f)$. It is therefore an important number for describing the amount of localization that can be achieved in the system. When the function $j_{1,1}(t) f$ has a local maximum at t = =!, then $\cos^2(2 - (v))$ is still equal to that value but this is not necessarily close to P_1 (specially when we are far from the DL regime). This is the case at points B and D in those gures. Surprisingly, how ever, P_1 , for cases B and D, is given, to a certain approximation, by the value of the function $\cos^2(2 - (v))$ at the minima that corresponds to the next DL point. We do not know why this should be so but it was found to be the case in all the cases that we examined. According to this, the DL points can be grouped in pairs, with (B,C) having a similar amount of localization, given by $\cos^2(2 - (v_c))$; points (D,E) with a localization given by $\cos^2(2 - (v_c))$; that give us directly the amount of localization in the system .

An interesting question to ask, because of practical applications, is whether there is a simple relationship between the amount of localization P_1 , \ddagger_0 and v. In other words, given a particular amount of localization P_1 , and a given \ddagger_0 , what is the required driving eld amplitude for the system to achieve such level of localization? To answer this question in the DL regime (were we expect a high level of localization, $P_1 < 1$), one can use Eq.(30) to derive an approximate relationship between P_1 , \ddagger_0 and v. At the maxima of (v) (Dlpoints), (v) , which gives $P_1 = \cos(2)$ 1 $4^2 = 1$ $\frac{\ddagger_0^2}{8} \frac{t_0^2}{v}$, from which one nally gets

This simple equation, which has been derived assuming v > 1; << 1, already gives good results even for a localization as low as $P_1 = 0.5$, with the accuracy in proving further for higher values of P_1 . For $P_1 = 0.5$ the result is $v = 0.78 \frac{12}{6}$, for $P_1 = 0.9$ one obtains $v = 4 \frac{12}{6}$ and for $P_1 = 0.99$ it gives $v = 40 \frac{12}{6}$.

V. HIGH-ORDER HARMONIC GENERATION

The expected value of the dipole moment of the system can be calculated from the expression

The quantities , ", P (t); Q (t); R (t) depend on v, even though, we do not explicitly indicate so in this notation. We will refer to the initial condition where $j_a j = 1$ or $j_b j = 1$ (and therefore $c_a c_b = 0$), as the "Optical" Initial Condition (O IC); the case $c_a = c_b$ as the "Tunneling" initial condition (T IC) and the case $c_a = ic_b$ as the "C om plex Tunneling" Initial C ondition (C T IN).

From the expectation value of the dipole moment, one can obtain the (coherent) emissions spectrum of the system from the expression jd() $j^2 = \frac{1}{T} \frac{R_{t_0+T}}{t_0} dte^{it} hd(t) i^2$.

Eq.(48) deserves m any comments. Notice that generally, there is low-frequency generation, with frequency 2" for all initial conditions. Only at some particular driving am plitudes this can be prevented. For OIC the low-frequency component can be suppressed only when $\sin(2) = 0$; for TIC only when $\cos(2) = 0$. There is always low-frequency generation at any driving am plitude for CTIC. There is odd-harm onics generation, at frequencies (2n 1)! and due to the term swith R (t). This harm onics are generated except when $\cos(2) = 0$ for OIC and except when $\sin(2) = 0$ for TIC. Interestingly enough, CTIN can not generate odd harm onics. Even harm onics, at frequencies 2n! 2" occur because of the presence of terms ($\sin(2 t)$ or $\cos(2 t)$)Q (t) and ($\sin(2 t)$ or $\cos(2 t)$)P (t), and are generated except when $\sin(2 t) = 0$ for TIC. They are always present for CTIC.

For a general driven H am iltonian that possesses the D ynam ical Symmetry (DS) H (x;t) = H (x;t+ =2) it has been proven⁴¹ that the HHG from a F loquet eigenstate consists of only odd-ham onics. Our H am iltonian, Eq. (14), is certainly of this kind since the quantum operator that corresponds to x is x, and therefore, if x ! x, and t ! t+ =2, the H am iltonian in Eq. (14) remains the same. A coording to this, a good check for our result can be done by replacing in Eq.(48) the initial condition $c_a = \cos$, $q_b = \sin$ which corresponds to the initial state being already a F loquet eigenstate [see Eq.(27)]. A fler doing that, one obtains hd(t)i= = 2R(t), which m eans that this state only generates odd-ham onics, in agreem ent with the dynam ical symmetry arguments developed in the citation above.

As our result (48) shows, in a two-level system it is possible to generate both even and odd harm onics. This has also been found in num erical calculations for a double quantum well⁴². The kind of harm onics present in the spectrum is dependent on the initial condition, the driving amplitude and also the phase of the driving eld. In this work we have chosen a driving force of the form $\cos(!t)$; however, in the most general case of time dependence of the form $\cos(!t)$; however, in the most general case of time dependence of the form $\cos(!t)$; however, in portant role in determining the harm onic content of the spectrum. For the case $\sin(!t)$ see G authey et al³⁶.

It has been argued⁴¹ that in system s that get ionized during the course of the interaction with the eld, only one resonant F bquet state (the one with the longest life-tim e) contributes to the harm onic spectrum and therefore this could explain the absence of even-harm onic generation in m ost experiments. There are several experimental results that involve lasers interacting with solid targets, in which even-harm onics and odd harm onics are generated. Even though ionization takes place, the presence of even harm onics has been attributed to the lack of D S in the H am illionian. For system s where the m ain source of harm onic radiation are bound-bound transitions, it is not clear how to justify the use of only one of the FES in the calculation of the HG of the system. In those kinds of system we will argue in future work that, if the evolution of the system is adiabatic under the e ect of a laser pulse, then again, only odd-harm onics are generated. For non-adiabatic evolution, we expect to see generation of even and odd harm onics and also dependence on the initial phase of the driving. It is interesting to check our results for the tim e dependent dipole m om ent of the system in the DL regime. A swe showed before, in the limit of perfect DL, where v ! 1 or $\frac{1}{2}$ 0, one gets = 0, K (t) become spure real, Z (t) become spure in aginary, and therefore R (t) = Q (t) = P (t) = 0. The result for the dipole m om ent is therefore

with being the phase di erence between c_a and c_b . This is the zeroth-order expression in the rst-order perturbative results obtained by D elgado and G om ez-L brente²³. C learly, in this lim it there is no HG. From this it is clear that in the case of a driven two-level system, DL and HHG are at odds; the greater the localization, the sm aller the HHG. The am plitude of any harm onic component of the emission spectrum of the system (except the low frequency one), as a function of increasing driving eld strength v should initially increase, then plateau (with oscillations) and nally decrease as v is further increased.

Near the DL regime we can obtain some expressions and compare them with the perturbative results obtained in other works^{16,21,23}. For v > 1 and = $\frac{P}{32} \frac{L_0}{F_v}$, we found that the behavior of the functions K (t) and Z (t) is

Here (t) and (t) are periodic functions (even and odd respectively) with am plitude close to one. A swe have shown before, in this regime, the am plitude of the oscillations in the function (v) is also proportional to . A coording to this, and using Eq.(47), we see that in this regime, R (t) / ,Q (t) / ,P (t) / 2 . We now rewrite Eq.(48) in a form that makes evident the magnitude of the di erent term s that contribute to the dipole moment,

From this expression we can see that in the DL regime, O IC generates low frequency and odd-harm onic radiation to second order in and even harm onic generation is forth order in this parameter. For T IC there is strong low frequency generation independent of any of the parameters of the system (provided we are in DL regime); even harm onic generation is second order and odd harm onic generation is forth order in . For C T IC the situation is similar to T IC except that no odd-harm onic radiation is generated at all.

As mentioned before, from the general expression for the dipole moment, since " = "(v) and = (v), with successive points where either (v) or "(v) vanish, there is a lot of variation in the composition (in terms of odd or even harm onics) of the spectrum of this system as a function of the amplitude of the driving eld. The interesting exception being the CTIC where even harm onics are always generated and odd harm onics are never generated.

In Fig.13, 14 and 15 we show the emission spectrum for three distinct initial conditions (O IC, T IC, C T IC) and for two values of the driving eld amplitude. W hat is common to all this plots is the typical prole of harmonic generation that has been found theoretically and experimentally in di erent systems. It consists of a plateau where the amplitudes are of similar magnitude (uctuations are of one to two orders of magnitude typically), followed by a frequency cut-o after which the harmonic amplitudes decay very quickly (exponentially in n!).

From the structure of the FES, like the one shown in Fig. 6, one can see that there is a cut-o in the harm onic components of the eigenstates, which occurs at $N_e = 2v + 1$ (for v + 1). The location of the cut-o in the emission spectrum of the system follows from the location of the cut-o in the eigenstates, since the functions R (t);Q (t);P (t) are second order in the FES components. R (t);Q (t);P (t) therefore have cut-o s at $N_{cut} = 2N_e = 4v + 2$. This is the same cut-o that we expect to see in the emission spectrum of the system.

A swe can see in Fig. 13, 14, 15, this result describes quite well the location of the last peak before the components start to decay exponentially. The linear dependence of N_{cut} on the amplitude of the eld implies that N_{cut} / I, where I is the intensity of the eld. This result is expected for HHG in systems where bound-bound transitions are dominant^{46,47}. For dominant bound-continuum transitions⁴⁸, N_{cut} / I.

In Fig.13 we show the emission spectrum for OIC, and for two di erent values of the driving amplitude. For v = 4.15 (which gives 0), we see, from the rst line of Eq.\$1) that one expects no low frequency component, odd harm onics and no even harm onics. For v = 4.5 (which gives 0), we obtain a strong low frequency component, strong odd-harm onic components and very weak even-harm onics components that are due to the function P (t) only (since at "= 0, sin (2 t) = 0 and therefore Q (t) does not contribute to the spectrum). This is a special case since in general, in this regime, Q (t)'s contribution to jd() j² is two orders of magnitude bigger than the one from P (t).

In Fig. 14 we show the emissions spectrum for TIC for the same values of v as before. In the = 0 case, we can see, from the second line in Eq.(51), that there is a strong low frequency component (= 2"), no odd-harm onics and split even harm onics (= 2n 2"). For the case "= 0 there is a zero frequency component and also odd and even harm onics (not split) of the same m agnitude.

Finally, in Fig. 15 we show the case when the initial condition is CTIC. From the third line in Eq.(51) we see that, for the case = 0 we should get a strong low frequency component and split even harm onics. For " = 0 case there is no static component, only even harm onics (not split).

For the characteristic plateau of HHG to appear, it was show n^{28} that $v = \frac{1}{k_0}$. In this region we have found numerically that $\cos(2) \notin 0$, which means that in the OIC, overall, the odd harmonics are much more stable with respect to changes in the driving amplitude that the even harmonics, which as a whole, do uctuate with v (following the behavior of sin (2)). A sone approaches the DL regime the odd harmonics will dom inate the spectrum for the OIC (which is the initial condition most easily obtained experimentally). It is easy to derive an estimate for the conditions under which odd-harmonics will dom inate over even harmonics in the OIC. For that we take 0:1, so that there is at least one order of magnitude di erence in their contributions to Eq.(49). From = $P = \frac{1}{32} \frac{1}{10}$ one gets the estimate

 $v > 10 k_0^2$:

W hen this condition is satis ed, odd harm onics will clearly dom inate the spectrum in the O IC .

VI. SUMMARY AND CONCLUSIONS

In this work we used a complete F loquet-G reen operator form alism for the analytical solution of a harm onically driven two level system. From this operator we were able to completely solve the system and obtain the quasi-energies and the eigenstates in terms of continued fractions.

We found that the oscillatory behavior of the quasi-energies of the system can be interpreted as due to multiphoton resonances that occur in an increasingly periodic way as the strength of the driving eld is increased. This multi-photon resonances involve an odd number of photons and produce avoided crossings centered at the edges of the energy Brillouin zone " = 0.5. The width and amplitude of them increases with the driving eld amplitude. The structure of the continued fractions from which the quasi-energies can be obtained made it clear that this is the case, since each term in the continued fraction was found to be related to the inclusion of a particular basis state in the calculations, and each avoided crossing studied did only appear when the corresponding term in the continued fraction was included.

We were able to obtain analytical expressions for the components of the F loquet eigenstates and from them we constructed the time-evolution operator of this system. The structure of the eigenstates revealed a characteristic pattern, with a "chaotic" region where the components are sensitive to small changes in v, change sign and have zeros, and a "regular" region where the components depend less sensitively on v, and decay exponentially with the frequency n!. The cut-o frequency that divides the two regions and gives the position of the largest oquet component of the eigenstates is proportional to the driving eld strength v, N_e = 2v 1, a result that is valid for any $\frac{1}{20}$ (provided v > $\frac{1}{20}$).

From the time evolution operator we were able to study the D ynam ic Localization phenom ena which is one of the important features of this H am iltonian. It is known that D L is obtained at values of the driving eld strength for which the quasi-energies vanish. In Q uantum C om putation, this localization mechanism can be of great importance for controlling the state of a q-bit (as realized for example in a solid state devise such as a double quantum well or a Josephson Junction), since the am ount of tunneling of an electron between two adjacent wells can be varied with the intensity of the driving eld. In this work we obtained a correlation between the D L points and the maxim a of the quantity (v) that describes the F loquet eigenstates of the system. A loo, the value of the function $\cos^2 (2 \quad (v))$, at its lowest m inim a, was found to give a good approximation to the degree of localization of the system at the corresponding D L points. These points appear in pairs with sim m ilar degrees of localization corresponding to each pair. W e also found the equation

which, at the DL points, relates the degree of localization P_1 , with the energy level di erence $!_0$, and the am plitude v of the driving eld (all quantities in units of h!). This equation can be used to easily estimate the am ount of localization achievable in this system for a given set of parameters.

For the study of H igh H arm onic G eneration in this system we calculated the expected value of the dipole m om ent which revealed that the emission spectrum, in general, can contain a low frequency component and odd and even harm onics. The particular components and their amplitudes depend strongly on the initial state of the system and on the speci c driving eld amplitude. W e found that there exists an initial condition (C om plex Tunneling) of the driven two-level system for which no odd-harm onics can be generated at any driving eld strength. For each one of the "pure" initial conditions, namely Optical (O IC), Tunneling (T IC) or C om plex Tunneling (C T IC), the driving am plitudes where the (v) = 0 produce either pure even harmonic generation or pure odd harmonic generation, depending on the particular initial condition. For all other driving am plitudes there will be in general generation of both kinds of harmonics (except for CT initial condition). When the initial state is a F loquet eigenstate, we found that only odd-harmonics are generated, a result that is expected from the D ynam ical Symmetry (DS) of the Ham iltonian. In general we can say that the emission spectrum of the driven two-kevel system is sensitive to diment parameters, such as the initial preparation, the am plitude of the driving and its phase (phase dependence will be explored in future work).

For small values of , but still not deep into the DL regime (0:15) we showed the dimension magnitude of the terms that give low frequency, even harmonics and odd harmonics. In the Optical Initial Condition (OIC) we found that odd harmonic generation is stronger, with even harmonics weaker and even nonexistent for particular values of the driving eld amplitude (when (v) = 0). For Tunneling Initial Condition (TIC), even harmonics dom inate, except at the DL points (" = 0), where even and odd harmonics have approximately the same amplitude. For Complex Tunneling Initial Condition (CTIC) no odd harmonics are generated.

W ell inside the DL regime, odd harmonics are almost exclusively generated in the Optical Initial Condition, and even harmonics in both of the Tunneling Initial Conditions. In this regime of high localization, Harmonic generation decreases with decreasing , a situation that clearly places both e ects on opposite sides of the parameter space, although with signi cant overlap between them. In general, for a driven two level system, the strongest HHG should occur for higher values of $\frac{1}{2}_0$ and for driving am plitudes $v < 10\frac{2}{0}$ (for > 0.1). For strong DL, sm aller values of $\frac{1}{2}_0$ and/or bigger values of v are required, $v > 10\frac{2}{0}$ (for < 0.1). Strong HHG in a two-level system is an eminently non-linear, non-perturbative phenom enon.

The driven two-level model has been shown to be useful in understanding the basic features of high-harmonic generation experimentally observed in atom s and molecules, even though obviously the full complexity of the general processes in atom s and molecules can not be accounted for with this model. The model predicts an emission spectrum with a plateau and a cut-o frequency (N_{cut} = 4v 2), whose location depends on the square-root of the intensity of the driving eld (since v / E / 12 I). Such dependence has been found in system s where bound-bound transitions account for most of the HHG 46,49 . For the case of charge-resonant states of odd-charge molecular ions it has also been argued²¹ that this simple two-level model can account for the behavior of these molecules in a strong laser pulse. A square-root dependence of the cut-o frequency with the intensity of the laser eld can be found in several experiments⁴⁵, a fact that is characteristic of a driven two-level system and which might point in the direction of an e ective two-level dynam ics for som e system s²⁸.

HHG and DL are the two mayor features of a driven two-level system with a great range of applications in atom ic and solid state systems where coherent sources of radiation and control of quantum states are sought. Through this work we have established a strong connection between this two phenomena and provided a detailed description and a deeper understanding of this system.




FIG.1: Quasi-energy as a function of driving am plitude (v), for di erent values of $\frac{1}{2} = \frac{1}{2}$ (high frequencies).




FIG.2: Quasi-energy as a function of driving amplitude, for di erent values of \div_0 1 (low frequencies). The functions 0.05J₀ (4v) are plotted with dotted lines for comparison.




FIG. 3: Solutions of Eq. (20) as a function of driving amplitude for the resonant case ($t_0 = 1$). The avoided crossings structure can be accounted for, in an approximate way, by a set of crossings of the eigenvalues corresponding to the rst-order FES indicated on the left of the gure. Avoided crossings A and C are mainly due to a 3 photon resonance between the corresponding FES; B corresponds to a 5 photon process.




FIG. 4: Solutions of truncated versions of Eq. (22): $F_n^+F_n = v^2$, for di erent values of n. In a) n=0; b) n=1; c) n=2; d)n=3. The labels b 2n and a 2m 1 correspond to term s in the CFs in Eq. (23) of the form +2n and $+2m + 1 + \frac{1}{2}$. A smore term s are included new avoided crossings appear. The signs are used to indicate each one of the two solutions that originate at the points = 2n in the y-axis.




FIG. 5: Components of the FES for $t_0 = 3$ and for two diment values of the driving amplitude (v = 12; 1:6). The avoided crossing that occurs near v 1:4 is due to a 5 photon process between two rst-order FES.




FIG.6: Components of the FES for $k_0 = 1$ and for eight di erent values of the driving am plitude. The logarithmic plots show the "plateau" structure of the FES, which gives rise to the well-known plateau studied in HHG. The cut-o location (N_e) follows the approximate rule N_e = 2v 1.




FIG. 7: The upper panel shows the functions $\cos^2((v))$ and $\sin^2((v))$, for $\frac{1}{2} = 0.5$. At t = 0, the FES is given by $j''(0)i = \cos(v)jai + \sin(v)jbi$. The lower panel shows the functions (v) (solid line) and "(v) (dash line). The dash-dot line corresponds to the Struve function $\frac{1}{2}_0 \frac{1}{4}H_0(4v)$. Points A, B, C, D, correspond to the values of v for which DL occurs.




FIG.8: Same as in Fig. 7. Here $t_0 = 1$.




FIG.9: Same as in Figs. 7,8. Here $t_0 = 2$.




FIG.10: The probability to remain in the initial state jli as a function of time (= !t), for 9 di erent values of the driving am plitude and for $k_0 = 0.5$. The lower panels show that the function $\cos^2(2 \text{ (v)})$, at the DL points (A, B, C, D), gives a good approximation to the amount of localization P_1 in this system. $P_1 = \min(j_{11}()^2)$. In the lower left panel the function $\cos^2(2k_0 - \frac{1}{4}H_0(4v))$ is shown with a dash-dot line for comparison.




FIG.11: FIG.11. As in Fig.10 . Here $t_0 = 1$.




FIG.12: As in Figs.10,11. Here $t_0 = 2$.




FIG.13: The emission spectrum of the system, for the "Optical" Initial Condition (OIC) and for two values of the driving amplitude: v = 4.5 corresponds to a DL point and v = 4.15 gives (4.15) = 0. The Fourier components of hd(t) i are connected with a continuous line for better visualization.




FIG.14: Same as in Fig. 13. Here for "Tunneling" initial condition (TIC).




FIG.15: Same as in Fig. 13,14. Here for "Complex Tunneling" Initial Condition (CTIC).
