The N ature of the C ondensate in M ass Transport M odels

We study the phenom enon of real space condensation in the steady state of a class of one dimensional mass transport models. We derive the criterion for the occurrence of a condensation transition and analyse the precise nature of the shape and the size of the condensate in the condensed phase. We nd two distinct condensate regimes: one where the condensate is gaussian distributed and the particle number uctuations scale norm ally as L¹⁼² where L is the system size, and a second regime where the particle number uctuations become a norm alously large and the condensate peak is non-gaussian. We interpret these results within the framework of sum s of random variables.

C ondensation transitions are ubiquitous in nature. For systems in therm alequilibrium, clustering is well understood in terms of the competition between entropy and energy (typically associated with attractive interactions). More exotic are condensations in systems with no interactions, e.g., Bose-Einstein's free (quantum) particles. Less understood are such transitions in non-equilibrium systems, in some of which even the concept of energy is dubious. For example, condensation is known to occur in many mass transport models, de ned only by a set of rules of evolution, with no clear 'attraction' between the masses [1 {6]. The relevance of these models lies in their applicability to a broad variety of phenom ena, e.g., tra c ow [7]force propagation through granular media [9], granular ow [10] and network dynamics [11]. Correspondingly, the condensation transition describes tam m ing in tra c [3], bunching of buses [5], clogging in pipes [5], coalescence of shaken steel balls [10] and condensation of edges in networks [11].

How such transitions arise is especially intriguing for one dimensional (d = 1) systems with local dynamical rules. A well known example is the Zero-Range Process (ZRP) [2,12,13] in which masses hop from site to (the next) site according to some transfer rule. In the steady state, a nite fraction of the total mass bondenses' onto a single site when , the global mass density, is increased beyond a certain critical value: $_{\rm c}$. The system goes from a uid phase, where the mass at each site hovers around

, to a condensed phase, where a uid of density $_{\rm c}$ co-exists with a condensate containing all the <code>bxcess'</code> m ass.

Though condensation in these systems share interesting analogies [3,6] with the traditionalB ose E instein condensation, there are in portant di erences. For example, here condensation occurs in real space and in all dim ensions. M oreover these systems are non-equilibrium in the sense that they are de ned by the dynamics, generally lack a H am iltonian and the stationary state is not speci ed by the usual G ibbs B oltzm ann distribution. There

are two major problems that one faces in the analysis of condensation phenom enon in these systems. First, the stationary state itself often is very di cult to determ ine and secondly, even if it is known such as in ZRP, the analysis of condensation has so far been possible only within a grand canonical enemble (GCE) where one is already in the therm odynam ic (L ! 1) lim it. W hile the GCE approach correctly predicts when a condensation transition can happen and even the value of the critical density c, it fails to provide much insight into the 'condensed' phase (> _c) itself. For that one needs to work in a canonical ensemble with the system size L nite, which has not been possible so far. In this Letter, we show that both of these problem s can be overcom e in a general class of m ass transport m odels recently introduced by us [14]. This allows us to explore the condensed phase in detail revealing rather rich physical behaviors, in particular the existence of two di erent types of condensates.

Our model is de ned as follows: a mass m i resides at each site i of a d = 1 periodic lattice of size L. At each time step, a portion, m_i m_i , chosen from a distribution (m jn), is chipped o to size i + 1. The dynam ics conserves the total mass $M = \prod_{i=1}^{L} m_i = L \cdot T he m odel is$ general enough to include m any previously studied m odels as special cases [14]. Choosing the chipping kernel (m in) appropriately, recovers ZRP, the Asymmetric Random Average Process [15] and the chipping model of [6]. M oreover the model encompasses both discrete and continuous time dynam ics and discrete and continuous mass. In particular, it was shown that the stationary state has a simple, factorised form provided the kernel is (m-jn) / u(m-)v(m m) [14], where u(z)of the form and v(z) are arbitrary non-negative functions. Then the joint distribution of m ass in the steady state is given by

where $f(m) = \frac{R_m}{0} dm u(m)v(m m)$ and the canonical partition function Z (M;L) is just the norm alization

Note that (1) is a product of single-site weights $f(m_i)$ but the -function in (1) implies a xed total mass thus inducing correlations between sites and in general the single-site mass probability distribution $p(m) \in f(m)$.

The dynam ics of the model speci es the functions u(m)and v(m m), which in turn specify the steady state uniquely in terms of weight function f(m). Having determ ined the steady state, one next turns to the issue of condensation. In particular, we ask: (i) when does a condensation transition occur (ii) if condensation occurs, what is the precise nature of the condensate?

The factorization property allows (i) to be addressed rather easily within a GCE framework { a la Bose E instein. The approach implies taking the L ! 1 limit and setting the single-site mass distribution function $p(m) = f(m)e^{-m}$ where is the chemical potential and is chosen to x the density = dm p(m)m. Thus, condensation must occur for $>_{c} = dm f(m)m$ which is the maximum allowed value of within the GCE. Based on previous works on the ZRP related case [4,5], it is easy to show that a condensation transition occurs if the single site weights decay for large m as

A simple example of a chipping kernel which gives such weights is firmished by u(m) = exp(am) and v(mm) = (1+mm) which yield f(m)'m = a for large m. In the following, we stay with the shoice of f(m) in (3) and set, without loss of generality, 0 f(m) dm = 1.

The GCE analysis correctly predicts the criterion for condensation and even the critical density $_{\rm c}$, but provides little insight into the condensed phase itself where $> _{\rm c}$. In this work, we are able to explore the condensed phase by staying within the canonical ensemble and analyzing the mass distribution p(m)

The rest of the letter is devoted to the analysis of p(m) in (4) with f(m) given by (3). We have two parameters and . Our goal is to show how the condensation is manifested by dierent behaviors of p(m) in dierent regions of the () plane giving rise to a rich phase diagram in Fig. 2.

First, consider the Laplace transform of (2):

where $g(s) = {R_1 \atop 0} f(m) e^{-sm} dm$. The main challenge is to invert (5) for a given f(m) and exploit its behavior to analyse p(m). Before proceeding to the general case, let us present a case in which both Z (M;L) and p(m)can be obtained in closed form. We choose f(m) = $2e^{-1-m} m^{-5-2} = {P - \over r}$, for which $g(s) = (1 + 2s^{1-2})e^{-2s^{1-2}}$ and our results below show that c = -g(0) = 2. Now, (5) can be inverted to provide the closed form [16]:




FIG.1. The distribution p(m) vs. m for the exactly solvable case, plotted using M athem atica for L = 100 and = 1 (subcrtical), = $_{c} = 2$ (critical) and = 6 (supercritical). The condensate show s up as an additional bum p near the tail of p(m) in the supercritical case.

where B_{M}_{p} ; $L = LM^{(L+3)=2} e^{L^{2}=M} = p^{p}$, $r = (2L + M)=2^{p}M$ and $H_{k}(r)$ is the H erm ite polynom ial of degree k. Substituting Z (M; L) in (4), we obtain p(m) explicitly and plot the case of L = 100 in Fig. 1. The transition from the subcritical (= 1), through the critical (= 2), to the supercritical (= 6) cases, is clearly seen: the condensate show ing up as an additional, asymmetric bum p for = 6. The explicit solution in this toy example provides us with useful insights into what to expect in the general case.




FIG.2. Schematic phase diagram in the $\{$ plane. The full line represents the critical density $_{\rm c}($)

Before proceeding, let us sum marise here our main results: we refer to Fig. 1 for typical forms of the mass distribution p(m) and Fig. 2 for a schematic phase diagram. In the subcritical regime the system is in a uid phase where the mass distribution decays exponentially with decay length increasing with density. At _c the distribution decays as a power law p(m) m and at > _c the distribution develops an extra piece, representing the condensate, centred around M L_c . By our analysis within the canonical ensemble we show that this piece will have a horm al', gaussian form when > 3. When

< 3, how ever the condensate will have an anom alous, asymmetric form as seen in Fig. 1 for = 6. In the following we supply explicit expressions for these forms.

W e form ally invert (5) using the Brom wich form ula,

where the contour parallels the in aginary axis with its real part, s_0 , to the right of all singularities of the integrand. Since f (m < 0) 0, the integrand is analytic in the right half plane. Therefore, s_0 can assume any non-negative value. M eanwhile, for f given by (3), s = 0 is a branch point singularity. As we shall see, in the subcritical case there exists a saddle point at positive s and s_0 can be chosen to be this saddle point, whereas in the critical and supercritical cases the leading contribution is obtained by wrapping the contour around s = 0.

First we evaluate (7) in the lim $\pm L$! 1 by the saddle point m ethod, assuming $\pm exists$. Let h(s) s + ln g(s). Then the saddle point equation, $h^0(s_0) = 0$, is

leading us to, e.g.,

If < _ (0), then (8) has a solution for $\mathfrak{s} > 0$, the saddle point approximation is valid, no condensation occurs. Substituting (9) in (4) we get, for < _ and m (_)L,p(m)' f(m)e^{s_0m}, recovering the GCE upon identifying the chemical potential = s₀.

W e now focus on the behavior as we approach criticality from the subcritical regim e and consider (8) for sm all and positive $_{\rm c}$, i.e., sm alls. Thus, we just need the sm all s behavior of h (s). For f (m) in (3) with a noninteger, one can expand, quite generally, the Laplace transform g (s) of (3) for sm all s, as

Here n = int[], k is the kth moment of f(m) (which exists for k < n). The second term of (10) is the leading

singular part and it can be shown that b = A (1) Note that 0 = 1 for normalized f, $1 = g^0(0) = c$ $\frac{1}{1}$, which is the width of the distribuand 2 tion f, is nite if > 3. The role of = 3 is now clear. The next-to-leading term is s^2 in one case and s^{-1} in the other, so that the saddle-point solution in (8) is given h $i_{1=(2)}$ by, s_0 ' ($_c$)= ² for > 3 and s_0 ' b(otherwise. Inserting this behavior in the expression (9) qives for > 3, Z (M; L)exp(L($\hat{f}=2^{2}$, pointing to a system with Gaussian distributions and norm al uctuations. In contrast, for 2 < < 3, we will show that anom alous uctuations and non-G aussians appear.

For the supercritical regin e (> $_{c}$), there is no solution to (8) on the positive real axis and more care is needed to nd the asymptotic form of Z (M;L). Our approach is to use the fact that the integral (7) will be dom - inated by s' 0. Thus we can use the small s expansion (10) and develop a scaling analysis by identifying the different scaling regin es and calculating the corresponding scaling form s for Z (M;L) in the large L lim it.

Using (10), one can rewrite (4) as

and M $_{\rm ex}$ ($_{\rm c}$)L is the excess mass. All crucial information about the condensate bum p' is encoded in the asymptotic behavior of W . D efferring the details to a later publication [16], we outline our main results below. A gain, we consider the two cases (> or < 3) separately.

Case-I (> 3): We nd that, for large L, and in the O (L¹⁼²) neighborhood of M_{ex}, the condensate appears in p(m) as a pure G aussian and can be cast in scaling form :

Note that its integral over ${\tt m}$ is 1=L, indicating that the condensation occurs at a single site.

Case-II (2 < < 3): In the neighborhood of the excess mass M $_{\rm ex}$, we d that p(m) has the scaling form :

where V (z) = $\frac{R_{i1}}{i1} \frac{ds}{2i} e^{zs+bs^{-1}}$. Though we have no closed form for V (z), we obtain its asymptotics:

where c_1 , c_2 are constants dependent on $\$. Note that this condensate bum p' is far from being gaussian: it has

a highly asymmetric shape, evidenced by (14, 15). The peak occurs at $m = M_{ex}$ and scales as $L^{=(1)}$. Meanwhile its width is dependent: $L^{1=(1)}$. The area under the bump is 1=L, again implying that the condensate occurs at only one site.

Finally, in both cases I,II the supercritical partition function is given by

Sim ilar results for the critical case = $_{c}$ and = 2;3 (where one obtains logarithm ic corrections) will be published elsewhere [16].

The implication of these results are clear: In the condensed phase, the condensate acts as a reservoir for the critical uid. Thus, the width of the condensate bum p reects the mass uctuation in the critical uid. For > 3we showed that condensate is gaussian distributed with width $L^{1=2}$, so that the masses in the uid uctuate normally. For < 3, however, the width of the condensate and the mass uctuations in the uid are both anom alously large, namely, O ($L^{1=(1)}$). Further in plications concern the dynam ics within the steady state. In system s with symmetry breaking, the 'ip time' [17] is of interest. Here the translational symmetry is broken by the selection of a site to hold the condensate and corresponds to the typical time a condensate exists before dissolving and reform ing on another site. A rough estimate for $s p_{cond}^{1}$ (m), with jm M_{ex}j O(L).For > 3, this im plies ip times growing exponentially with the system size, whereas for < 3, they would diverge more slow ly, as som e power of L.

Our results may be naturally interpreted within the fram ework of sums of random variables. The partition function (2) is proportional to the probability that the sum of L independent random variables mi, each distributed according to f(m) is equal to M. Given for large m , the m $_{\rm i}$ are thus Levy ights f(m) Am and Z (M ;L) is just proportional to the probability distribution of the position of a Levy walker (only taking positive steps) after L steps. Then (16) can be interpreted in term s of the extrem e statistics of a Levy walk. The mean of a sum of L random variables is just $_{1}L$. Thus if $M < L_1$ $M_{\rm c}$ one expects the sum to contain random variables of typical size 0 (1), whereas for M > M $_{\rm c}$ one expects the sum to be dominated by a rare event i.e. L 1 of the variables would be of order $O(_1)$ except for one which would be large and equal $\rm M_{\,c}$. G iven that the distribution of the random to M variables is Am , the probability that this large variable takes the value M M_c is A (M $M_{\rm c}$). This large contribution could be any of the L possible ones, thus the total probability is A L (M $M_{\rm c}$), recovering (16). M oreover, the gaussian $L^{1=2}$ uctuation for > 3 and non-gaussian $L^{1=(1)}$ uctuation for 2 < 3 correspond respectively to the norm al and the anom alous di usion of a Levy process.

To sum marise we have considered a very broad class of mass transport models and derived the condition for condensation. We have presented an analysis within the canonical ensemble that elucidates the nature and structure of the condensate. In particular we have identi ed two distinct condensate regim es where the condensate is norm al and anom alous and derived the scaling distribution for the two types of condensate. Our results rely on the factorisation property of the steady state (1), but we believe the phase scenario of Fig.2 m ay apply in m odels without factorised steady states; it would be of interest to verify this. The underlying dynamics of the model we have studied are one-dimensional however the condition for a factorised state may be generalized to higher dimensions [16] and work is in progress to investigate condensation in such systems. Our results con m that condensation may occur in a wider class of continuous m ass m odels as well as discrete m ass m odels such as the ZRP, as suggested in [18]. It would also be of interest to use this class of models to generalize the phase separation criterion of [8] which is based on the ZRP condensation.
