Quasi-TwoD im ensional D iluted M agnetic Sem iconductor System s

We develop a theory for two-dimensional diluted magnetic sem iconductor systems (e.g. $Ga_{1-x}Mn_xAs$ layers) where the itinerant carriers mediating the ferrom agnetic interaction between the impurity local moments, as well as the local moments them selves, are conned in a two-dimensional layer. The theory includes exact spatial disorder e ects associated with the random local moment positions within a disordered RKKY lattice eld theory description. We predict the ferrom agnetic transition temperature (T_c) as well as the nature of the spontaneous magnetization. The theory includes disorder and nite carrier mean free path e ects as well as the important correction arising from the nite temperature RKKY interaction, noting a strong density dependence of T_c in contrast to the simple virtual crystal approximation.

M any projected applications of diluted m agnetic sem iconductors (DMS), i.e. system s which combine the advantages of a ferrom agnetic material with those of a sem iconductor with the additional exibility of carrierm ediated ferrom agnetism enabling the tuning of the m agnetic properties by applying external gate voltages or optical pulses to control the carrier density, would involve the use of two-dimensional (2D) DMS structures such as quantum wells, multilayers, superlattices, or heterostructures. Such 2D DMS structures are also of intrinsic fundam ental interest since magnetic properties in two dim ensions are expected to be substantially di erent from the three dim ensional (3D) system s [1] that have mostly been theoretically studied in the DMS literature. The 2D DMS systems introduce the possibility of gating, and thereby controlling both electrical and m agnetic properties by tuning the carrier density. In fact, such a carrier density modulation of DMS properties has already been demonstrated [2,3] in gated DMS eld e ect heterostructures. For various future spintronic applications the developm ent of such 2D DMS structures is obviously of great in portance.

In this Letter, we provide the basic theoretical picture underlying 2D DMS ferrom agnetism focusing on the well-studied $Ga_{1 x} M n_x A s, with x$ 0:03 0:08, a system where the ferrom agnetism is well-established to be arising from the alignment (for $T < T_c$ 100K 200K) ofM n localm om ents through the indirect exchange interaction carried by itinerant holes in the G aA s valence (or in purity) band (that are also contributed by the M n atom s which serve the dual purpose of being the impurity local m om ents as well as the dopants). O ur theory is quite general and should apply to other \m etallic" DMS m aterials where the ferrom agnetic interaction between the im purity localm om ents ism ediated by itinerant carriers (electrons or holes). Our theory is a suitable 2D generalization of both the continuum lattice version of the highly successful RKKY mean eld theory (MFT) that has earlier been applied [1] to 3D metallic G $a_{1\ x}$ M $n_{x}As$ systems. One of our important ndings is that the ferrom agnetic

transition (\Curie") temperature for the 2D DMS system s typically tends to be substantially less than the corresponding 3D case with equivalent system parameters. In particular, T_c in the 2D case is found to be com para- T_F) to the Ferm item perature ($T_F = E_F = k_B$, ble (T_c where E_F is the 2D Fermi energy) of the 2D hole system s. This necessitates that the full nite tem perature form for the 2D RKKY interaction be used in calculating DMS magnetic properties, further suppressing $T_{\rm c}\,$ in the system . In fact, this general low ering of the 2D DMS T_c compared with the corresponding 3D case is our central new theoretical result. This in plies that spintronic applications involving 2D DMS heterostructures will be problem atic since the typical T_c (at least for the currently existing DMS materials) is likely to be far below room tem perature (T_c < 100K). A related equally important theoretical nding is that, although the continuum virtual crystalm ean eld approximation much used for 3D $Ga_{1 x} M n_{x} As$ physics [4] would predict that the T_{c} in 2D DMS systems (being proportional to the 2D density of states) is independent of 2D carrier density, there is an intrinsic carrier density dependence of T_c even in the strict 2D system arising from the density and temperature (i.e. $T = T_F$) dependence of the nite-tem perature e ective RKKY interaction.

We speci cally consider the so-called delta-doping schemes for localizing M n dopants, the species responsible for DMS ferrom agnetism, to very narrow layers [3]. It is this situation which we exam ine in this letter, spin-5/2 M n impurities conned to a single plane in GaAs; although the experimental reality may well be one in which a signi cant number of impurities lie o this plane and/or the M n occupy a dierent crystallographic plane, our results are qualitatively correct in these cases as well.




FIG.1. Curie Temperatures plotted versus , the anisotropy parameter. The inset displays $T_{\rm c}$ values for a much smaller range of anisotropies. In both images, the M onte C arlo errors are smaller than the graph symbols. The black line is included only as a guide to the eye in both the main graph as well as the inset.

A lthough the H ohenberg-M erm in-W agner theorem precludes long range order in 2D system swith H eisenberg spins, the theorem applies only for the case in which the coupling between spins is absolutely isotropic. As has been shown both form ally and numerically [5{7], even a sm all amount of an isotropy is su cient to stabilize

long range order at nite tem peratures. W e exam ine the in pact of an isotropy explicitly by studying, the classical an isotropic 2D H eisenberg m odel H = $J_0 = \prod_{hiji} [S_i^x S_j^y +$ $S_{i}^{x}S_{j}^{y}$ + (+ 1) $S_{i}^{z}S_{j}^{z}$], where J_{0} is the ferrom agnetic exchange constant, is the anisotropy param eter, and the spins occupy a 2D square lattice; the sum is over nearestneighbors only. Using a variant of the Wol cluster M onte Carlo technique (with m odi cations appropriate fora nite [8]), we calculate Curie tem peratures by nding the intersection of B inder cum ulants (given by $U = 1 \frac{1}{3}hM fi=hM fi [9]$ for two di erent system sizes (L = 40 and L = 80). The results are shown in Fig. 1, where it is readily evident from the main graph and the inset (depicting T_c for a smaller range of values) that even a sm all am ount of an isotropy yields Curie tem peratures in the vicinity of $J_0 = k_B$, a value in reasonable agreem ent with $T_{\rm c}^{\rm M~F~T}~=~\frac{4}{3}J_0{=}k_{\rm B}$, the corresponding mean eld result for the nearest neighbor 2D Heisenberg m odel. P revious theoretical studies also exam ined ferromagnetism in the 2D DMS context [10,11], without, how ever, considering the Hohenberg-Merm in-Wagner theorem or the an isotropy issue.

We apply the lattice MFT developed previously [12], but we also nd intriguing results in the context of sim – ple continuum W eiss MFT which demonstrate that it is essential to incorporate nite temperature e ects in the e ective carrier-mediated interaction between Mn im purity moments. We assume the 2D hole gas to be con ned in the same plane as the Mn dopants{ it is straightforward to consider [10,11] a spatial separation between the dopants and the holes as well as to consider the quasi-2D con nem ent for the holes. These additional com plications would low $\operatorname{er} T_{\rm c}$ below the strict 2D lim it considered in our model.

Our theory is constructed for two dimensional DMS systems in the metallic lim it with itinerant carriers (we assume the carrier-mediated e ective Mn-Mn indirect exchange interaction to be of the RKKY form). However, including a nite carrier mean free path in our theory allows us to take into account the dependence of the magnetic behavior of our system on the carrier transport properties. In fact, using an exponential cuto in the range of the RKKY function perm its us to treat the long and short-range magnetic interaction regimes simply by varying the cuto parameter 1. In our system, salient param eters include the M n localm om ent concentration (x), the free carrier density (n_c) , and the exponential cuto scale lassociated with the carrier mean free path. The 2D Ferm i tem perature $T_F = \frac{h^2 k_F^2}{2m k_B}$ depends on n_c since the 2D $\,k_F\,$ / $\,n_c^{1=2}$, where $k_F\,$ is the Ferm i wave vector. We take the carrier e ective mass to be $m = 0.4m_{e}$ for all our num erical results. All quantities (T_F;k_F;r, etc.) appearing in our theory refer to 2D param eters.




FIG.2. Temperature dependent 2D RKKY range function ($k_F r; T=T_F$) as a function of $k_F r$ for several temperatures $T=T_F$ = 0.0;0.5, and 1.0 (corresponding to the solid, dashed, and dot dashed lines respectively). Inset (a) also shows ($k_F r; T=T_F$), and inset (b) portrays the elective – nite temperature coupling J_e .

O ure ective H am iltonian describes the M n-M n m agnetic interaction between classical H eisenberg spins S_i on a 2D lattice:

where S_i is the ith M n localm on ent of spin 5=2. In our lattice M FT we assume the M n dopants to lie entirely on the [100] plane of the G aA s zinc-blende crystal lattice, with the impurities occupying the G a sites, which form a square lattice with lattice constant a.

In our Ham iltonian, the carrier mediated RKKY indirect exchange interaction describes the elective magnetic interaction between Mn local moments induced by the free carrier spin polarization. $J_{ij}^{RKKY}(\Gamma) J_0 (k_F r; T=T_F)$, where $(k_F r; T=T_F)$ is the temperature dependent range function which is obtained from the 12 spin susceptibility, and $J_0 = \frac{J_{pd}}{a} = \frac{m}{8[hf^2a^2]}$. Taking $J_{pd} = 0.15$ eV nm³ [13] and square lattice constant a = :4nm, we ind $J_0 = 0.10$ eV; we use this value for J_0 throughout this work.

For T = 0 the 2D RKKY interaction is known exactly [14]:

where $J_n(x)$ are the Bessel functions of the st kind, and N $_{\rm n}$ (x) are Bessel functions of the second kind. The asymptotic form of the RKKY interaction for $k_{\rm F}\,r$ is $J^{RKKY}(r) / J_0 \sin(2k_F r) = r^2$. At nite temperatures (i.e., for $T=T_F \in 0$), it is not possible to obtain the RKKY range function analytically. Thus, we calculate the nite temperature RKKY interaction numerically. In Fig. 2, we show the tem perature dependent range function $(k_F r; T = T_F)$ as a function of $k_F r$ for various T=T_F values. One sees increasingly severe thermaldamping of the RKKY oscillations with increasing $T=T_F$. Inset (a) of Fig. 2 provides a closer view of the RKKY oscillations depicted in the main graph, while inset (b) displays the e ective coupling constant, given by J_{ij}^{RKKY} (r)dr. 0 ne nds, as expected, that J_{kj} J_e = decreases with increasing tem perature due to the dam ping of the range function. Since the magnetic properties of the 2D system are directly dependent on J_e , a nite $T=T_F$ can have an important impact.

In the lattice MFT (where we have in m ind the previously mentioned square lattice with lattice constant a), we calculate the Curie tem perature with [12]

where N_i and r_i are the numbers and distances of the ith nearest neighbors, respectively. The continuum limit, which we exam ine rst, is attained for l;k¹ a, where a is the lattice spacing. We exam ine the large l limit (l $k_{\rm p}^{1}$) and nd that Eq.3 becomes




FIG.3. 2D Curie temperature curves in the continuum MFT for various values of the magnetic in purity density $n_{\rm i}$ (n_{\rm i} = xa 2). Here $T_{\rm c}^{\rm 1}$ is the continuum $T_{\rm c}$ calculated for $T_{\rm F}$ = 1, i.e. the virtual crystal approximation result.

where T_c is the Curie temperature in the continuum lim it, and $g(T_c=T_F)$ depends only on the ratio of T_c to

the Ferm item perature T_F . For T_c T_F , $g(T_c = T_F)$! 1, and the dependence on carrier concentration is lost, and T_c depends only on the impurity concentration x. (For convenience, we identify this temperature as $T_{\rm c} \left(T_{\rm F} ~!~ 1~\right) = \frac{35~{\rm xJ}_{\rm 0}}{6k_{\rm B}}$.) This result, with no de- T_{c}^{1} pendence on n_c, is proportional to the density of states at the Ferm i Level E $_{\rm F}\,$ in two dimensions, and re ects the peculiarity of the 2D density of states being independent of carrier density. (The analogous continuum 3D result, also proportional to the density of states at $E_{\rm F}$, is $T_c / xn_c^{1=3}$, and does depend on the carrier density). For the more general case of nite $T_r = T_F$, one can readily calculate the Curie tem perature self-consistently via num erical means. Fig. 3 shows T_c curves as a function of carrier density for various values of x, the Mn concentration. A salient feature of the curves is a marked dependence on n_c , in contrast to what one nds when the(T = 0) RKKY form ula is used (where there is no dependence at allon n_c). Eventually, the curves saturate as n_c is increased. This is natural, since T_F increases with $n_{c,r}$ and ultimately $T_c = T_F$ approaches zero. This T_F ! 1 lim it of the continuum MFT is the actual virtual approxin ation lim it.




FIG.4. Lattice M FT 2D C urie tem perature curves for various values of x. In the inset, T_c curves are shown for a much greater range of carrier density n_c . In both the main graph and the inset, l=a=5.

Returning to the lattice M FT, which explicitly takes into account the discreteness of the square lattice, we also incorporate the elects of the nite carrier mean free path lby including an exponential cuto in the range of the RKKY interaction. T_c curves are shown in Fig. 4 for several M n dopant concentrations. As in Fig. 3, the Curie temperature increases monotonically in n_c over the experimentally accessible range of carrier densities. However, for considerably higher n_c (i.e. approaching 10^{14} cm²), nonmonotonic behavior is seen in T_c . This is evident in the inset of Fig. 4, where the Curie temperature curves seem to achieve saturation for intermediate carrier densities and ultimately begins to decrease as the




FIG.5. Lattice M FT C unie tem perature curves for various values of n_c plotted as a function of the mean free path l=a. In each case the sam e M n concentration, x = .05, is used.

 T_c is strongly a ected by the nite size of l; in fact, one sees that for each of the carrier concentrations represented in Fig. 5, T_c initially increases sharply with increasing l, eventually saturating for l=a 1. It is $l;k_{r}^{1}$, where informative to examine the regime a one can operate in the continuum limit. where k l 1 and only terms up to fourth order in are shown. The expression for T_c given in Eq. 6 reveals a strong suppression of T_c due to localization e ects; when k_F is small (i.e. in the small n_c limit) the RKKY range function is very extended relative to a and l. As a consequence, most of the RKKY interaction is truncated by the exponential cuto associated with the nite m ean free path l. This truncation e ect is so severe that T_c is very small in comparison with T_F ; to fourth order in there are no corrections to arising from the

niteness of $T_c = T_F$. Note that in the opposite lim it of $k_F = 1$, which rarely applies to DMS system swhich are at best \bad m etals", one can obtain the sim ple form ula $T_c (k_F = 1)$ $T_c = 1$ ($k_F = 1$) $T_c = 1$ by sim ply considering the disorder induced suppression of the 2D density of states.




FIG.6. Concavity curves versus M n concentration x for several carrier densities $n_{\rm c}$ with l=a = 2.0. The inset shows representative examples of the magnetization, M (T). All M (T) curves are calculated for $n_{\rm c}=2.5~10^{11}$ cm 2 .

In addition to T_c , one can also use lattice M FT to calculate the magnetization M (T) [12]. The magnetization behavior is in uenced by the M n in purity concentration as well as the form of the e ective interaction between M n local moments, in principle speci ed by the carrier mean free path 1 and n_c . For convenience, we study M (T=T_c); using the norm alized temperature scale T=T_c allows a system atic comparison of magnetization pro less corresponding to di erent values of the parameters 1, n_c , and x. A n in portant trait of the magnetization pro le is its degree of concavity; concavity in M (T) is a hallm ark of an insulating system, while a convex pro les occur

wellwithin the metallic regime [4]. Linearm agnetization curves correspond to interm ediate in purity densities and m ean free paths. In term g of the m agnetization, the con- 2 M $^{\circ\circ}$ (T)dT, or the dierence cavity is given by in the slopes of M (T). The sign of indicates whether M (T) is convex (negative), concave (positive), or lin-0). The tem peratures t_2 and t_2 are selected ear (if to encom pass an interm ediate tem perature range, neither too close to T_c nor to zero. A signi cant feature of the concavity plots shown in Fig. 6 is weak dependence of the concavity of the magnetization pro les on the carrier density; though the three values of n_c range over two orders of magnitude (10^{10} 10^{12}) cm 2 , the graphs lie very close to one another. One can also see that the param eter range over which the M (T) pro le is concave is much more extensive than predicted by lattice MFT for three dim ensional DMS system s [12]. This is primarily a consequence of the geom etry of the two dim ensional lattice. The inset of Fig. 6 displays representative cases of the magnetization M (T).

In conclusion, we have considered diluted magnetic semiconductors in two dimensions. We nd that long-range ferrom agnetic order can be stabilized by even a small amount of anisotropy invariably present in reality. We have found that, even at the level of continuum MFT, nite temperature e ects in the carrier-mediated e ective interaction between Mn in purity moments introduce a strong dependence on the density of carriers, where naive use of the zero temperature RKKY form ula yields a result independent of n_c . To take into account the discreteness of the strong positional disorder of the 2D DMS system, we have employed a lattice MFT.Our lattice theory also provides a convenient framework for the inclusion of in portant physics such as the nite mean

free path. In general, the 2D DMS $T_{\rm c}$ is strongly suppressed compared with the corresponding 3D DMS $T_{\rm c}$, which is somewhat discouraging for spintronic applications.
