Space-tim e Therm odynam ics of the G lass Transition

We consider the probability distribution for uctuations in dynam ical action and sim ilar quantities related to dynam ic heterogeneity. We argue that the so-called \glass transition" is a manifestation of low action tails in these distributions where the entropy of trajectory space is sub-extensive in time. These low action tails are a consequence of dynam ic heterogeneity and an indication of phase coexistence in trajectory space. The glass transition, where the system falls out of equilibrium, is then an order-disorder phenom enon in space-time occurring at a tem perature $T_{\rm g}$ which is a weak function of measurem ent time. We illustrate our perspective ideas with facilitated lattice models, and note how these ideas apply more generally.

A glass transition, where a super-cooled uid falls out of equilibrium, is irreversible and a consequence of experimental protocols, such as the time scale over which the system is prepared, and the time scale over which its properties are observed (for reviews see [1, 2, 3]). It is thus not a transition in a traditional therm odynam ic sense. Nevertheless, the phenomenon is relatively precipitous, and the therm odynam ic conditions at which it occurs depend only weakly on preparation and measurement times. In this paper, we over an explanation of this behavior in term s of a therm odynam ics of trajectory space.

O ur considerations seem relatively general as they are a direct consequence of dynam ic heterogeneity [4, 5, 6] in glass form ing m aterials. O ur prim ary point is that the order-disorder of glassy dynam ics is revealed by focusing on a probability distribution for an extensive variable m anifesting dynam ic heterogeneity. There are various choices for this variable, depending upon the speci c system under investigation. We have more to say about this later, but to be explicit about what can be learned, m ost of this paper focuses on kinetically constrained m odels [7] and the dynam ical actions of these m odels.

W e show here that due to the em ergence of spatial correlations in the dynam ics, i.e. dynam ic heterogeneity, action distributions have larger low action tails than what would be expected in a hom ogeneous system . These tails indicate a coexistence between space-time regions where motion is plentiful and regions where motion is rare. In the latter the entropy of trajectories is subextensive in time, as previously suggested [8]. The glass transition, where the system falls out of equilibrium at long but nite observation time, is thus a disorder-order transition in space-time. This ordering in trajectory space is not a consequence of any underlying static transition (for therm odynam ic approaches see [9, 10, 11, 12]). Further, it follows from our results here that the exponential tails observed in the aging of soft materials, so-called interm ittency [13, 14, 15] (see also [16, 17, 18]), are a consequence of dynam ic heterogeneity and should be seen in m esoscopic m easurem ents in the equilibrium dynam ics of glass form ers.

M odels and distributions of dynam ical activity.

W e consider two facilitated models of glass form ers to illustrate our ideas: the lattice model of Fredrickson and Andersen (FA) [19] in spatial dimension d = 1, and its dynam ically asymmetric variant, the East model [20]. The FA and East models serve as a caricatures of strong and fragile glass form ers, respectively [21, 22] both cases, there is an energy function $J_{i}n_{i}$, where J > 0 sets the equilibrium temperature scale, ni is either 1 or 0, indicating whether lattice site i is excited or not, and the sum over i extends over lattice sites. The system moves stochastically from one micro-state to another through a sequence of single cellm oves. In the FA m odel, the state of cell i at time slice t + 1, $n_{i:t+1}$, can dier from that at time slice t, n_{it}, only if at least one of two nearest neighbors, i 1; is excited at time t. In the East model the condition is that n_{i+1;t} must be excited. These dynam ic constraints a ect the metric of motion, con ning the space-tim e volum e available for trajectories [23]. This m in ics the e ects of complicated interm olecular potentials in a dense nearly jam m ed m aterial. Excitations in this picture are regions of space-time where molecules are unjammed and exhibit mobility. As such, we refer to n_{it} as the mobility eld. For both models, the dynam ics is tim e-reversal sym m etric and obeys detailed balance. The equilibrium concentration of excitations, $mi = 1 = (1 + e^{J=T})$, is the relevant control param -С eter. The average distance between excitations sets the characteristic lengthscale for relaxation, c^1 , and thus the typical relaxation time, c , where = 3 for the FA m odel and $\ln c = \ln 2$ for the East m odel. See Ref. [7] for details.

The total system under consideration has N_{tot} sites and evolves for t_{tot} time steps, so that the total spacetime volume is N_{tot} t_{tot} . Within it, we consider a subsystem with spatial volume N, and observed time duration t_{obs} ; and use x (t_{obs}) to denote a trajectory in that space-time volume. For the FA and East models, this trajectory speci es the mobility eld p_{t} for 1 i N and 0 t t_{obs} . The probability density functional for x (t_{obs}), denoted by P [x (t_{obs})], de nes an action, E [x (t_{obs})]; nam ely, P [x (t_{obs})] exp (E [x (t_{obs})]). In the FA and East models, E [x (t_{obs})] is a sum over i and t of term s coupling n_{it} to mobility elds at nearby space-




FIG.1: LEFT: Probability distribution of the action P (E) in the FA model at T = 1, subsystem size N = 60 16 ' and $t_{obs} = 320$ 3. Inset show sprobability distribution of num ber of kinks, P (K) (left and top axes), and of num ber of excitations, P (K) (bottom and right axes). R IG HT: P (E) but now for $t_{obs} = 1280$ 12. The straight line indicates the exponential tail exp ($E = t_{obs}$) (regime a, see text). Inset shows coe cient at di erent T from simulation and theory for both the FA and East m odels. Statistical uncertainties from simulations are sm aller than the symbols.




FIG. 2: Trajectories in the FA model corresponding to the regimes (a), (b) and (c) of Fig.1. Unexcited and excited sites are colored white and dark, respectively. Space runs along the vertical direction, and time along the horizontal direction. D ashed lines delim it the measured space-time volume, N $t_{\rm obs}$.

tim e points¹. A s such, its average value will be extensive

in N t_{obs} . This extensivity is a general property for any system with M arkovian dynam ics and short-ranged interparticle forces.

The distribution function for the action is

$$P(E) = h(E E[x(t_{bs})])i = (E)exp(E);$$

where the pointed brackets indicate average over the ensemble of trajectories of length t_{obs} , and (E) =

 $(\!E\!\!;\!N\!\!;\!t_{\!obs})$ is the number of such trajectories with action E. When N is much larger than any dynamically correlated volume in space, and t_{obs} is much larger than any correlated period of time,

will be extensive in the space-time volume N t_{obs} . In this case, the entropy per space-time point, s (E;N; t_{obs}),

Here, x_t $E[x(t)] = E(x_t j x_t t) +$ $fn_{it}g$ denotes a conguration at time t, (x_0) is the distribution of initial conditions and $E(x_{t+t}x_t)$ $\ln p(\mathbf{x}_{t+t}, \mathbf{x}_t)$ with $p(x_{t+t}, x_t)$ the probability for an elementary microscopic move in time t. In a Monte Carlo simulation, for example, t = 1=N and the move is an attempted spin-ip. The explicit form of the operator $E(x_{t+t}, y_t)$ is given in [8]. The corresponding contribution to the action is $E(x_{t+}, t, x_t) =$ $\ln t + T^{1} (1 n_{i}) \ln N$ (the last term is added to remove trivial ln N dependences, also present in standard MC).

will be intensive. Similarly, and for the same reasons, the mean square uctuation, $(N;t_{bs}) = hE^2i$ hEi^2 , is extensive for large enough N t_{obs}. The onset of this extensivity with respect to t_{obs} can be viewed as an order-disorder phenom enon, as we will discuss shortly.

The distribution function for the action can be obtained from simulation by running trajectories and creating a histogram for the logarithm of the probabilities for taking steps in the trajectory. Far into the wings of the distribution, satisfactory statistics is obtained with transition path sampling [25]. This methodology allows us to carry out um brella sam pling [26] applied to trajectory space². Figure 1 illustrates the P (E)'s we have obtained in this way for the FA and East models. W hile the bulk of the distributions is Gaussian, for values of the action su ciently smaller than hEi they display exponential tails. Sim ilar distributions are found for other measures of dynamic activity, such as the number of transitions or kinks in a space-time vol $i_{i,t} [n_{i,t} (1 n_{i,t+t}) + (1 n_{i,t}) n_{i,t+t}], or$ ume, K =the total num ber of excitations M = _{i:t} n_{i;t}. This is shown in the inset to Fig. 1 (left).

D ynam ic heterogeneity and susceptibility. Figure 2 m akes vivid the fact that the exponential tails in these distributions are manifestations of dynamic heterogeneity. The extended bubble or stripe in trajectory (a) illustrates a volum e of space-tim e that is absent of excitations. Because it extends throughout the pictured time frame, the statistical weight for this excitation void is dom inated by the probability to observe this void at the initial time t = 0. A sexcitations at a given time slice are uncorrelated, this probability is Poissonian, exp (cL), where L is the width of the stripe. In the presence of a bubble occupying a space-time volume L tobs, the net action is E tobs (N L)", where " is the average action per unit space-time. In this regime, the probability density for the action is then exp $[cL(E)] / exp(cE=t_{obs}")$. This proportionality explains why the slope of the exponential tail scales linearly with inverse time. The speci c value of that slope is determined from evaluating the action density. Perform ing the requisite average of the action gives " hEi=Nt_{obs} f(c) c ln c, for sm all 2c for the FA m odel, and f (c) c, where f (c) c for

the East model. Hence, to the degree that this picture is correct, the slope $=t_{obs}$ in Fig.1 should coincide with = c=". The inset to Fig.1 (right) shows that this relationship holds to a good approximation. Thus, the exponential tail in P (E) manifests structures in space-time that depend upon initial conditions over a time frame t_{obs} . It also follows that the entropy for trajectories with action that falls in the exponential tails is non-extensive in time t_{obs} .




FIG. 3: LEFT: Action susceptibility per unit length and time, =N t_{obs} , as a function of observation time t_{obs} for constant temperature T, in the FA model. Inset shows scaled susceptibility, $(t_{obs}^{1}) = [\lim_{t_{obs}! 1} (t_{obs}^{1})]$ as a function of $t_{obs} = .R$ IG HT: Action susceptibility per unit length and time, =N t_{obs} , but now as a function of T at constant t_{obs} . Inset shows free energies of trajectories, $\ln P$ (E), for observation time $t_{obs} = 3200$ at di erent tem peratures. System sizes are N = 16c¹. For $t_{obs} = 3200$, T 0:44. Statistical uncertainties from simulations are smaller than the symbols.

The tails in P (E) are statistically negligible when $t_{\rm obs}$ is large compared to the relaxation time , but they are dom inant when $t_{\rm obs}$. The latter regime is where the mean square uctuation or susceptibility, (N; $t_{\rm bs}$), is non-linear in time. Figure 3 (left) shows the growth of this quantity with respect to $t_{\rm obs}$. The susceptibility per unit space-time increases with increasing $t_{\rm obs}$ because increasing time allows for increased uctuations. W ith the onset of decorrelation, when $t_{\rm obs}$ > , the susceptibility ity becomes a constant. This plateau or constant value increases with decreasing T because uctuations become m ore prevalent as c decreases. Indeed, the FA and E astm odels approach dynam ic criticality as c ! 0 [27].

W hile the plateau value of (N; tobs) = N tobs increases with decreasing T or c, the time for the onset to extensivity also increases. As a result, if t_{obs} is kept xed and T is varied, (N;tobs) will have a maximum. This behavior is illustrated in Fig. 3 (right). The extrem um will approach a singularity in the lim it of criticality, $t_{obs} \mid 1$; c! 0. For tobs xed and nite, the extrem um is located at a nite tem perature, T, namely, (T) tobs, where (T) denotes the equilibrium relaxation time at the tem perature T. A coordingly, T is a glass transition tem perature. In particular, below this temperature, the system cannot equilibrate on time scales as short as tobs. In other words, with observation times no longer than this, the system will have fallen out of equilibrium . For the Arrhenius FA model, In (T) _ 1=T, so that T in this case varies logarithm ically with observation time tobs. For the super-Arrhenius East model, \ln (T) / $1=T^2$, T is even more weakly dependent upon observation time, going as $1= \ln t_{obs}$. It is due to this weak dependence on observation time that the glass transition is very nearly a material property, being con ned to a narrow range of tem peratures.

Similar behaviors are expected for distributions of analogous quantities in continuous force Rsystem s. 0 ne such quantity is tobs dtexp fik Q = $[r(t+t) r_i(t)]g$, where j2 V 0 r_i (t) refers to the position of the jth particle at time t, and the sum includes all those particles j that are in volumeV at time 0. The wave-vector k and time lag t_r while m icroscopic, should be such that variation in Q is due to di usion of particles, not sim ply vibrational motion. In the past, studies of dynam ic heterogeneity have considered the susceptibility for dQ =dtobs, regarding the time lag t as a variable that can be large [27, 28]. The e ect of this variability and the di erentiation is to focus

² A trajectory of the total system is accepted if the action of the subsystem computed from that trajectory lies between E_1 and E_2 . A new trajectory is created from the accepted trajectory by in plem enting shooting and shifting moves [25]. The new trajectory is accepted if the action of the subsystem again lies between E_1 and E_2 , and rejected otherwise. The ensemble of trajectories created by repeating this process m any times provides the distribution function for the action for the subsystem when that action is between E_1 and E_2 . Y et another part of the distribution is created by performing the sam pling again, this time for subsystem actions in a di erent range, say between E_3 and E_4 . Eventually, the distribution is mapped out over the entire range of interest by splicing together m any of these partial distributions.




FIG.4: Free energies of trajectories, F_b (E), for di erent values of the param eter b. The curve for b = 1 is that of F ig.1 (left), with T = 1, N = 16c¹, $t_{obs} = 320$. The curves with b = 1:001; 1:002; 1:003 are obtained by adding (b 1) to the b = 1 curve. Triangles show the free energy com puted by simulation at b = 1:001 using transition path sam pling combined with free energy perturbation theory.

on an object that is not extensive in t_{obs} , thus obscuring order-disorder in space-time.

N ot all variables extensive in space and time are useful. This situation is familiar in standard phase transition theory. Phase transitions are recognized only through physically motivated choices of variables that are then shown to reject the transition. For example, consider Langevin dynamics, $\mathbf{x}(t) = \mathbf{f}[\mathbf{x}(t)] + \sim (t)$, where $\mathbf{\tilde{x}}(t)$ is

a Gaussian random force. In this case, the contribution to the action for a transition in in nitesimal time dt ! 0 is, up to a constant, $\ln p[x(t + dt) \dot{x}(t)] =$ dtfx-(t) f[x (t)]g²=4T, which is distributed as $\frac{dt}{4T} \sim^2$ independently of the forces f. The net action for a trajectory is simply the accumulation of these in nitesimal steps, and will be therefore distributed in a trivialm anner. It is insensitive to the phenom enon we are after. The action for non-linear functions or functionals of the Langevin x (t), how ever, need not be trivial [29]. For variables that manifest dynamic heterogeneity, in particular, a meaningful observable can be constructed out of the probabilty for nite (not in nitesimal) steps: P [x (t+ t) jx (t)] = p[x(t+dt)jx(t)] p[x(t+ t)jx(t+ dx_{t+ dt}dx_{t+ 2dt} t dt)], where t is an appropriate coarse-graining time. The integrals over interm ediate states make the action for nite moves, $E[x(t + t)\dot{x}(t)]$ $\ln P [x(t + t) \dot{x}(t)], de$ pendent on the actual forces f, and the distribution for this action will be system dependent. The case of determ inistic dynam ics is sim ilar in that the m icroscopic action is always vanishing, and a coarse-grained action is needed to reveal interesting behaviour. W hether or not this coarse-graining is practical, other variables, such as Q, are clearly useful and practical.

O rder-disorder in space-time. Above T , the system is equilibrated and disordered with respect to order parameters like E or K or Q. Below T , the system is ordered with respect to these quantities, and the order m anifests dependence upon initial conditions. In view of the anom abus behavior of $(N;t_{\rm obs};T)$ near T = T, this dependence can be manipulated in a fashion familiar in the context of equilibrium phase transitions. To

this end, it is useful to de ne b $(ln = lE and a corresponding free energy <math>F_b(E)$ ln (E) + bE =

 $\ln P~(E)$ + (b ~1)E. The parameter b is to trajectory space what reciprocal temperature is to state space. In particular, an extremum in ~(T) corresponds with a rapid change in hEi with respect to T, which in turn implies a bistable free energy, $F_{\rm b}~(E)$, near b = 1 and T = T .

F ig.4 illustrates this behavior. C oexistence takes place at b = b > 1, the precise value depending upon T and t_{obs} . The free energy for b > 1 can be computed from path sampling with a form of therm odynamic perturbation theory [26], running trajectories as before (i.e., with b = 1) and averaging the functional exp ($bE[x(t_{obs})]$). In the case illustrated, b = 1.003, very close to the physical value b = 1. The basin at low action coincides with the exponential tail and thus correlation with initial conditions throughout the observed time fram e.

For an equilibrium system, b = 1. In this case, there will be a true dynamical singularity for t_{obs} ! 1 only at T = 0. In particular, from the exponential tails of P (E), we know that $b = 1 + = t_{obs}$, so that b! 1 when c ! 0 with $t_{obs} = !$ nite. An interesting question is whether it is possible to de ne a dynam ical protocol, perhaps through some form of external driving, which would allow one to tune b from b = 1 to b = b, and thus observe this dynam ical transition at T > 0.
