## Superradiant scattering from a hydrodynam ic vortex

## Abstract

We show that sound waves scattered from a hydrodynamic vortex may be amplied. Such superradiant scattering follows from the physical analogy between spinning black holes and hydrodynamic vortices. However a sonic horizon analogous to the black hole event horizon does not exist unless the vortex possesses a central drain, which is challenging to produce experimentally. In the astrophysical domain, superradiance can occur even in the absence of an event horizon: we show that in the hydrodynamic analogue, a drain is not required and a vortex scatters sound superradiantly. Possible experimental realization in dilute gas Bose-E instein condensates is discussed.

Hawking's prediction of radiation from black holes is one of the most surprising outcomes of the quest to unify quantum mechanics and general relativity [1]. It is problem atic that such an important theoretical prediction has no immediate prospect of direct experimental investigation. Consequently, Unruh's observation of an analogy between wave scattering from black holes, and sound wave scattering from sonic horizons in uids, has intrigued both the astrophysical and condensed matter communities [2, 3, 4, 5].

The generation and detection of the sonic analogue of Hawking radiation faces m any di culties, and a detailed experimental scheme has yet to be presented. Consequently, we propose the initial investigation of the simpler, but closely related, superradiant amplication of scattered waves by an ergoregion [6]. Quantum mechanically, Hawking radiation and superradiance m ay be regarded as spontaneous and stimulated radiation counterparts. However, stimulated radiation is easier to observe because of its much greater strength, and because of the control provided by the stimulating pulse. Furthermore, an analogue ergoregion is realized by a vortex, which is experimentally simpler to achieve than a horizon. This superradiance is related to the Zeldovich-Starobinsky elect, which has been discussed in the context of super uid helium by Volovik [7]. We provide quantitative details and numerical simulations to argue that this superradiance might be observed in dilute gas Bose-Einstein condensates (BECs) [8, 9, 10, 11].

A coording to general relativity, rotating black holes have an ergoregion: a region in which no physical object can remain at rest with respect to an inertial observer at in nity. Low frequency waves are scattered from the ergoregion with increased amplitude; that is superradiantly [12]. In uids, regions where the uid speed exceeds the speed of sound are analogue ergoregions [4]. A draining vortex with a central sink m ay also possess an analogue event horizon, and hence is an analogue of a rotating black hole. B asak and M ajum dar [13] showed that sonic superradiance occurs for a draining vortex, but assumed that the density of the uid, and the speed of sound, were constant.

For a BEC a sink m ight be realized by outcoupling the condensate to form an atom laser beam [14]. However there are di culties with strong outcoupling [15], and it will be simpler to create a vortex without a sink, for example by stirring with laser beams [16] or m agnetic elds [17]. Then the simpler velocity function makes it feasible to consider the variable density pro les which are unavoidably associated with vortices in BECs.

The wave equation for sound waves, that is linear perturbations of the velocity potential

of a barotropic, inviscid, irrotational uid, may be written [2, 4]

where the coe cients g are functions of the unperturbed uid density and velocity, and g is their inverse determ inant. This has the same form as the K lein-G ordon equation for a massless scalar eld in curved spacetime with metric g [18]. Provided the quantized uid has suitable commutation relations, the analogy extends to the quantum eld [19].

A llthis suggests the possibility of using uid ows to m in ic general relativistic spacetime m etrics. The analogy requires the length scales of the problem to be large enough that the atom icity of the uid can be neglected. In BECs, furtherm ore, the hydrodynam ic equation (1) is an approximation neglecting the \quantum pressure" term [20]. This is valid when any spatial variations in the BEC occur over length scales longer than the healing length of the condensate [21]. In our case, this must be smaller than both the sound wavelength and the spatial scale of the vortex.

Let the unperturbed uid's speed of sound be c, velocity be  $\mathbf{v}$ , and density be . In cylindrical polar coordinates a vortex centred on the origin, with  $v_r = v_z = 0$ , has wave equation coe cients

and  $g = {}^4r^2 = c^2$ . For irrotational ow, v = =r, for some constant . The density and speed of sound depend only on the radial coordinate r, and approach asymptotic values  $_1$  and  $c_1$  for r! 1.

We consider cylindrical wave solutions to the wave equation (1) of the form  $(t;r;;z) = (t;r)e^{im}$ , with angular wavenum ber m. A ssum ing that the square of the speed of sound is proportional to the density, as is the case for a BEC [20], the density may be eliminated from the wave equation, which then becomes

For single frequency waves of the form  $(t;r) = r^{1=2} G(r) e^{i!t}$ , and de ning a \tortoise

where we have introduced an elective potential  $V_e$  to emphasise the similarity to the time-independent Schrodinger equation.

In order to analyse superradiance we consider the two limiting cases where the tortoise coordinate r approaches 1. For r large, r r, and eliminating all terms except those of highest order in r yields the asymptotic form

where A and B are constant amplitudes of incoming and outgoing waves respectively.

The analysis of the other limit, where r ! 1, requires that the density prole of the vortex be specified. In order to present analytical calculations we use the density prole

This is similar to the charge l = 1 vortex density pro le for a BEC [20], but with the scale length given by the free parameter , rather than by the healing length . In the Thom as Ferm i lim it of dom inant atom interactions, the length scale for a charge l vortex, with angularm on entum 1- perparticle, is 1 [22]. A librough a vortex with l > 1 is unstable to decay into l single charge vortices, it may be stabilised by a pinning optical potential [23]. Since the density pro le Eq.(8) was chosen primarily for analytical convenience, we do not expect it to be exactly achievable experimentally, although something close to it should be. For example, the dipole potential generated by far detuned light has been used to engineer density pro les in BEC's [24]. The other free parameter is the radius of the zero density core  $r_0$ , which m ight also be engineered by applied potentials. Since we have assumed that the square of the speed of sound is proportional to the density,  $e^2 = 1$ , and the tortoise coordinate is

This is an Euler-type equation and has solutions of the form G(r) = jr j, where

The general solution to the asymptotic form of the wave equation is then

where C and D are constants. According to Eq.(12), is either real or purely in aginary. For in aginary this asymptotic solution is oscillatory and may be written in the form

By making jr j the argument of a logarithm we have anticipated that r will be made dimensionless. This last form allows us to identify the two linearly independent solutions as outgoing and ingoing waves, with am plitudes C and D, respectively. Note that in this asymptotic limit r < 0 and hence ln jr j increases with decreasing r. Note also, that it is the sign of the group velocity, not of the phase velocity, which determ ines the identi cation of outgoing and ingoing waves [25], and the sign of the group velocity is independent of the sign of .

Let the W ronskians (of the solution and its complex conjugate) corresponding to the asymptotic solutions Eqs. (7, 14) be denoted W (1) and W (1). Then

Following Vilenkin [25], consider a solution to the wave equation for G (r) representing a wave originating at r = +1 and having the asymptotic form s, for in aginary ,

Then by Abel's Theorem, the W ronskian of this solution is constant, since there is no rst derivative term in the dimensial equation for G (r), Eq. (4). Thus, setting A = 1 and B = R in Eq. (15), and C = 0 and D = T in Eq. (16), and equating W (1) = W (1),

In particular, if is negative, and T  $\in$  0, then  $\Re$  j> 1, and superradiance occurs, since then, in the asymptotic region far from the vortex, the amplitude of the rejected wave exceeds that of the incident wave. This superradiance inequality < 0 expands to ! < m = $r_0^2$ , which requires m > 0, so that the cylindrical waves propagate in the same direction as the vortex ow.

In contrast to the draining vortex exam ined by B asak and M a jum dar [13] and the rotating black hole [25], here there are two independent necessary conditions for superradiance: must be purely imaginary and must be negative. Combining these conditions gives a frequency-independent condition for superradiance. For since ! 0, then  $m = r_0^2$ , and superradiance requires, 0  $m = r_0^2$ , and therefore  $2 m^2 = r_0^4$ . If is to be in aginary, we must have  $1 < 8 r_0^2 = c_1^2$ , and since m > 0, the frequency-independent necessary condition for superradiance is  $m > c_1 r_0^2 = (2 r_0^2)$ .

For a charge 1 vortex in a BEC we can substitute expressions [20] for the vortex velocity constant =  $l \sim = m_{atom}$ , where  $m_{atom}$  is the mass of an atom, and for  $c_1$  in terms of the healing length ,  $c_1 = \sim = \begin{pmatrix} p \\ 2 \\ m_{atom} \end{pmatrix}$ , to obtain  $> r_0^2 = (4 \ lm)$ . This is always possible to full, at least in principle, since the healing length is given by = (8 na)  $^{1-2}$ , where n is the atom ic number density and a is the s-wave scattering length, and both n and a are under experimental control.

To determ ine the magnitude of the superradiant amplication, we numerically solved the wave equation (3) using the XMDS package [26]. We used an initial Gaussian wavepacket of the form (0;r) = A(r), with frequency  $!_0$ . Specifically,

W e found that superradiance occured for a wide range of parameters, as long as the relevant inequalities were fullled. Fig. 1 shows a particularly strong and clean example of the scattering of an m = 1 wavepacket. Comparing the Fourier components of the real parts of the incident and rejected wavepackets in the asymptotic region, we found that the dominant Fourier power in the rejected wavepacket is approximately doubled.

The parameters are given in the caption, and are representative of conditions for a trapped dilute gas BEC. They are made dimensionless, indicated by a tilde, by measuring distance

and time in units of  $r_0$  and  $!_0^{-1}$  respectively. For example, choosing  $r_0 = 1 \text{ m}$  and  $!_0^{-1} = 10^3 \text{ s}$ , the parameters of Fig. 1 correspond to  $c_1 = 10^3 \text{ m s}^{-1}$  and = 20 m. For the case of a Rb<sup>87</sup> BEC,  $m_{\text{atom}} = 1.4 \quad 10^{-25} \text{ kg}$ , and the asymptotic healing length  $\sim 0.5$ , and  $\sim = 2 \text{ corresponds}$  to a vortex charge of about l = 3. Note that the real part of the wave is plotted against the modil editortoise coordinate  $r = r 2 \sim^2 = (r + 1)$ . This magniles the scale as  $r ! r_0 (r ! - 1)$ , while limiting the lower bound of r to  $1 = 2 \sim^2 = .$  The ergoregion boundary, or static limit, is at r = 8 or r = 92.

The local healing length determ ines the validity of the hydrodynam ic approximation, and is larger than the asymptotic value by the factor  $p_{-1} = (r)$ . Because of this the BEC interpretation fails for Fig. 1(b). However, we have found a tradeo between the strength of the superradiance and the validity of the BEC hydrodynam ic approximation. With increasing m, ~, and sound wavelength, rejection occurs at larger values of r, and hence for smaller local healing lengths, while the superradiance decreases in strength. We denother rejection point to be at the maximum of the elective potential Eq. (5). Compared to the case of Fig. 1, a transmitted wavelength comparable to the local healing length at the reection point, accompanied by a 70% reduction in superradiance power, occurs for an initial wavelength an order of magnitude longer, and ~ a factor of ve larger.

Num erical simulations of BEC s under the proposed experimental conditions, and without the hydrodynamic approximation, could explore the elect of its breakdown as the wavelength of the transmitted wave decreases due to its inward propagation. This is related to the \trans-P landkian" problem of Hawking radiation [27].

In sum m ary, our analytical and num erical work has shown superradiant sound scattering from hydrodynam ic vortices. We have also argued for its experimental realization in dilute gas Bose-E instein condensates. This might provide a useful step towards the ultimate goal of observing the sonic analogue of H awking radiation.
