U sing m uon spin rotation, well-de ned bulk 100% m agnetic phases in N $a_x C \otimes c_2$ are revealed. A novel magnetic phase is detected for x = 0.85 with the highest transition temperature ever observed for x 0.75. This stresses the diversity of x 0.75 m agnetic phases and the link between m agnetic and structural degrees of freedom. For the charge-ordered x = 0.50 com pound, a cascade of transitions is observed below 85 K. From a detailed analysis of our data, we conclude that the ordered m om ent varies continuously with temperature and suggest that the two secondary transitions at 48 K and 29 K correspond to a moderate reorientation of antiferrom agnetically coupled m om ents.

B eyond their long-known ionic mobility which opened the route to industrial applications, cobaltates recently received considerable attention after the discovery of high therm oelectric power in m etallic N $a_{0:7}$ C cO₂ [1] and superconductivity, m aybe unconventional, in the hydrated N $a_{0:35}$ C cO₂ com pound [2]. In addition, a very rich phase diagram [3], still to be explored in detail, seem s to involve m any and possibly com peting parameters such as doping, charge order, m agnetism, frustration and strong electronic correlations. This spans over most of topical problem s in condensed matter, m ore speci cally in the

eld of correlated system s. W hether one param eter has a leading role over others is a central issue for understanding the fundam entals of physics in Na-cobaltates.

Cobaltates are layered compounds, like high- T_c cuprates. Magnetic and conducting properties set in CoO_2 layers, issued from edge sharing CoO_6 octahedra stacked along the c-axis and separated by Na⁺ partially

led layers. In a naive model, the increase of Na^{\dagger} content leads to a conversion of the form alcharge of C o from 4^{\dagger} (low -spin, S = 1=2) to 3^{\dagger} (S = 0) -hence a depleted antiferrom agnetic frustrated quantum triangular latticeand/or to electron doping occuring in a S = 1=2 background, which per se are interesting problem s.

Experim entally, both m etallic and m agnetic characters can be found for various x but, at variance with high- T_c 's, N a⁺ and C o^{3+ =4+} charge-orderings m ight set in for well de ned compositions as shown by recent electronic di raction [4], cristallographic [5] and NM R studies [6].

M agnetic states have been reported for long for x 0:75. A commensurate spin density wave (C-SDW) was detected below 22 K in minority volume fraction in a nominal x = 0.75 sample [7]. Given the reported c-axis parameter is rather typical of the non-magnetic x = 0.70 phase [6], the invoked magnetic inhom ogeneity might rather relate to the multiphasing of the investigated com -

pound. Furtherm ore, on the basis of a second nom inally x = 0.90 sam ple where an incommensurate (IC)SDW 25-50% fraction order sets in below 20 K, a dome-shaped continuous phase diagram was proposed, in a Hubbard approach which links magnetism to doping [8]. Bulk C-SDW was reported to occur below 20 K [9], only in one x = 0.82 (2) single crystal, with a SR signature di erent from the previous sam ples. Sorting out the actual in pact of doping on magnetism of the CoO₂ planes clearly calls for a more re-ned study.

The importance of the structure m ight be well illustrated in the peculiar x = 0.50 case. A well de ned com – m ensurate superstructure has been observed [4] where Na⁺ /vacancies and Co³⁺ /Co⁴⁺ arrange in order to m inim ize both Na-Na and Na-Co Coulomb repulsion. A m agnetic state was recently reported below 50 K [10] and a m etal-insulator transition sets in around 30 K [3]. In addition a susceptibility anomaly is observed around 90 K [3], which origin is still not known.

In this Letter, we present a study of 100% m agnetic phases, detected through SR. The structures of all investigated sam ples were checked by room -T X -ray Rietveld re nements. For x 0:75, we isolate two pure magnetic phases, including a novel one for x = 0.85. We clearly demonstrate the absence of phase separation, stress the underlying role of the structure, hence the com plexity of the magnetic, likely non-continuous phase diagram. For x = 0.50, we clearly establish, for the rst time, that 3 m agnetic transitions occur below 85 K.

All samples were prepared by solid state reaction of Co_3O_4 and Na_2CO_3 . They were further annealed in air for twice 12 hrs and quenched with interm ediate grinding, then annealed in owing oxygen for 24 hrs at 600 C. The x = 0.50 composition was reached by immerging and stirring for 4 days the starting x = 0.70 m aterial in a sodium hypochlorite solution. Hexagonal parameters




FIG.1: ZF asymmetries (lines are for ts) and FT at 5K for x = 0.75 and 0.85 (PSI).C incles on FT are for tted frequencies The asymmetry of the high frequency line is accounted for by 2 frequencies (i.e. 2 ⁺ sites) for x = 0.75.

a = 2.81511(3) A and c = 11.1314(2) A were measuredwith a P nm m orthorhom bic superstructure (a 3;2a;c). Na sites, at the vertical either of a Co site (Na1) or of the center of a C o triangle (N a2) have an equal occupancy of 0.25, in agreement with the nominal composition. The x = 0.75 sample displays an hexagonal P 6₃/m m c lattice with a = 2:84175(4) A, c = 10:8087(2) A, typical of the H2 phase of ref. [5] and exhibits only a few very weak (incommensurate) additional di raction peaks for 25 < 2 < 40. Structural re nem ents lead to site occupancies 0.22(1) for Na1 and 0.52(1) for Na2, close to the nom inalcontent 0.75. Thism aterial decom poses spontaneously in air leading to the x = 0.70 typical di raction pattern (c 10:892(4) A). Finally, x = 0:85 m aterialexhibits a monoclinic distortion with a 10.766(2) A c-lattice constant (projected on the hexagonal cell).

The SR experiments were performed at the ISIS (EMU) and PSI (GPS) facilities [11]. In the case of magnetic order, spontaneous oscillations of the muon polarization are detected without any applied eld (ZF setup) through the asymmetry of the positron emission due to the ⁺ desintegration. The frequency (ies) correspond to the internal eld (s) (H_{int}) at the muon (s) site (s) and, in the case of sim plem agnetic phases, track the variation of the order parameter (i.e. the local static moment). High statistics counts allowed to reveal clearly all the oscillating frequencies for each detected magnetic phase.

We rst give a brief account for the x 0.75 sam ples which display a textbook SR signature of a phase transition to an ordered m agnetic state. In Fig. 1, for x = 0.75and 0.85 sam ples, we report both ZF asymmetry and




FIG.2: Left, closed symbols: T - variation of the 4 ZF frequencies used in the ts. $(T T_{\rm o})^{0.28}$ lines emphasize the scaling of all their variations. The widths are sm aller or of the order of the point sizes. Right, open circles: wTF asymmetry

Fourier transforms (FT) which give the distribution of H_{int} over all ⁺ sites. The FTs are quite well peaked clearly indicating a simple magnetic order in view of the number of ⁺ sites expected (see x = 0.5 discussion). A coordingly, SR signals and their T-evolution are best described by damped cosine functions (see ref. [7, 9] for details), the weight of which can be xed at low T values.

In Fig. 2, we plot the weak transverse eld (wTF) asymmetry which monitors the non-magnetic fraction, found to be less than 10% in both samples. The sharpness of the decrease of the wTF signal allows us to extract transition temperatures, $T_o = 20.8$ (5) and 27 (1) K, for x = 0:75 and 0.85. For each sample, the frequencies (Fig. 2) scale with each other on the whole T-range and decrease sm oothly when T increases to vanish at T_o , sim – ply re ecting the variation of the order parameter of a unique magnetic phase probed at 4 di erent $^+$ sites.

For x = 0.75, the frequencies and T_o values are similar to that of minority 20% phases reported in [7]. On the contrary, to our know ledge, for x = 0.85, the frequencies are di erent from existing ones and the transition tem – perature is much higher than any reported to date for x = 0.75. This points at a novel m agnetic phase, com – m ensurate, as suggested above, which is worth noticing for such non-peculiar value of x as 0.85.




FIG. 3: Left panel: ZF asym m etnies for x = 0.5 at various typical T (PSI). Lines are ts, see text. The evident change of the oscillations shape is relected in the Fourier transforms (right panel). There, circles mark tted frequencies.




FIG.4: T-plot of the x = 0.5 ZF frequencies (the line is a guide to the eye). Bars stand for the FW HM of the various spectral lines. The errors in the ts are sm aller than the data points. C losed (open) symbols are for PSI (ISIS) data taken on di erent batches. Vertical arrows indicate the kinks of the magnetic susceptibility (see inset). Vertical dotted lines separate the various regimes.

We now focus on the x = 0.50 composition. In Fig. 3, we display for various T both asymmetries versus time and their FT.M agnetic order is evident through spontaneous oscillations of the ZF SR signals below 85(1) K, which corresponds to the high T kink in SQUID data (inset, Fig. 4). Unlike previous cases where the shape of the asymmetry remains similar for all T in the frozen regime, we nd, for the rst time, that three distinct magnetic regions exist for x = 0.50 [12]. Depending on the T range, 2 or 3 frequencies were used to t the SR data, lead-

ing to a more complex T-dependence of the frequencies (Fig. 4) than in Fig. 2. Two extra-transitions are singled out at lower T, namely at 29 (1) and 48.0 (5) K.

At base temperature (5 K), three frequencies can be distinguished on the FT in the range 1.3-1.9 M Hz. Surprisingly, upon increasing the temperature, only the high frequency line is kept, whereas the remaining spectrum progressively spreads downwards continuously to even reach zero frequency around 29 K. Correlatively, the widths of the two lowest frequency signals noticeably increase from T = 5 K to nally overlap for T. 28 K. Between 30 and 48 K, the FT spectrum is mainly peaked at two frequencies, one fairly low (< 0.5 M Hz) and one in the continuity of the high frequency cuto . The FT spectrum changes abruptly around 48 K and three frequency peaks are again evident between 50 and 85 K.

If the highest-frequency still roughly m in ics the variation expected for an order param eter, the variation of the other frequencies do not scale with this one and have an unconventional non-m onotonic variation in the T > 48 K phase. The form er certainly corresponds to a + dom inantly coupled to a single magnetic site while the latter are issued from severalm om ents and are likely sensitive to the relative orientation of m om ents. In this respect, the continuity of the highest frequency indicates that there is no sudden change of the m om ent at 48 and 29 K . On the contrary, the marked change at 48 K for the others reveals a lock-in of the magnetic structure below 48 K -and down to 29 K-which is con med by the kink observed in SQUID data at 48 K.wIF measurements (not displayed) indicate that the magnetic fraction in our sam ples is 90% for all T < 85 K, and therefore underlines the bulk character at all T. Finally, the changes observed for all ⁺ frequencies at these speci c T either through in exions or discontinuities clearly establish that we deal, in each dom ain, with a single cristallographic phase and

no phase separation occurs.

In order to further discuss our data, we now address the issue of the $^+$ location. Possible sites, m in in izing the $^+$ electrostatic energy are either a N a^+ vacancy or a site located 1 A away from an 0^2 , form ing a 0- bond. The rstone can be discarded since (i) nearby N a^+ would repel the $^+$ from this position (ii) the G aussian damping in the paramagnetic state, originating from N a and C o nuclear dipoles, is m uch too sm all to m atch with this site location only ($_{\rm calc}=0.28\,(1)$ instead of 0.17 s 1) and (iii) in the case of partial occupancy, a m uch lower frequency than observed at 5 K should be found at a N a vacant site in comparison with that at 0^2 site (ratio 1.5), as already advocated in [7, 9] for x 0.75.

For x = 0.50, Co are known to form alternating chains in a given plane [4]. Every 2 chains, N a alternate above and below each Co, hence the Co valence in such a chain is expected to be uniform and weaker than for the next Co, also uniform, chain. In the following, we make the sim ple assumption that cobalt is either in the Co³⁺ or Co⁴⁺ state [13] and consider an ideal undistorted orthorhom bic structure. We arbitrarily consider ⁺ bound




FIG.5: Charge order suggested in ref.4. B ig circles are for $C \circ^{4+3+}$ and squares are for N a above the C o plane. O xygens (sm all circles) form a triangular network shifted from the C o one above and below (not represented) the C o planes.

to oxygens located above the Co plane. Inequivalent charge/m agnetic con guration surrounding oxygens can be sorted by considering Co triangles next to the ⁺ site altogether with the occupancy of nn Na⁺ sites (g.5). Three inequivalent O² are found, consistent with the num ber of frequencies observed at 5 K and above 49 K. Two have 2 nn m agnetic Co⁴⁺ and have either a nn Na1 or a nn Na2, respectively labeled (2a) and (2b) [14]. The third site (1) has a single nn Co⁴⁺ and 2 nn Co³⁺ with one Na1 and one Na2 lled nearby sites.

A s already argued above, ⁺ with 1 m agnetic nn C o⁴⁺ (site 1) can be safely assigned to the highest frequency signal. A ⁺ coupled to two nn C o⁴⁺ will sense pronounced changes of internal elds and m ay also experience quite weak elds. O ur data constrains severely the orientation of the m om ents, since, rst, H_{int} is observed to be weaker for sites (2) than for sites (1) for all T and second, the ratio varies sizeably with T to reach 1/5 value between 29 and 48 K. To illustrate this point, one can notice that H_{int} (2) cancels only for two antiferrom agnetic C o⁴⁺ m om ents, lying perpendicular to the

 $Co^{4+} - Co^{4+} - + plane$ (hence perpendicular to the chain). We rst perform ed calculations of the dipolar eld induced on the 2 types of sites by a chain of Co^{4+} , assum ing an AF coupling. The e ect of m om ents beyond 2^{nd} nn was found negligible. We further checked that the drawn conclusions still hold without sensible changes for a 3D m agnetic stacking either ferro or antiferrom agnetic of such AF chains. Our major notings are (i) the moments lie close to AF order (ii) their direction is within 20 perpendicular to the plane 0 (2)-nn C o⁴⁺ chain; (iii) sites (2) frequencies are fairly sensitive to a small m isalignm ent of neighborm om ents or to a change of the direction of the AF ordered m om ents, e.g. 10-20 is enough to explain the variations observed in Fig. 4. Note that the moment direction should alternate along c-axis since oxygen triangles are inverted for two next Coplanes.

For this structure, since site (1) is coupled dom inantly to a single C o, the highest frequency at 5 K can be used to extract a value for the C o⁴⁺ m om ent of the order of $0.3(1)_{\rm B}$. Such a weak value could be explained by a strong zero point quantum reduction due to the possible 1D character of the C o⁴⁺ chain. A Iternatively, a com - m ensurate spin density wave description in the fram e-work of band m agnetism -the system is m etallic above 29 K - could be a natural explanation of this value.

The values of the frequencies are found to be only little a ected by a change in the $^+$ position as compared to the e ect of moments m isalignement. Therefore, the changes around 29 K cannot be merely explained by a slight structural change or a charge re-ordering which would a ect the $^+$ site. We infer that a magnetic com – ponent is also associated with this transition, smoother than the 48 K one. The increase of the resistivity observed in [3], rather modest in comparison with usual m etal-insulator transitions, clearly shows that electronic and magnetic properties have a common origin, likely structural.

The origin of these multiple transitions is not obvious at the present stage. We can clearly rule out a scenario where an IC-SDW would switch to a C-SDW since the frequencies are already quite well peaked at the upper transition. Whether the problem can be tackled through a purely ionic model where anisotropy and charge localization could induce the secondary transitions or whether a C-SDW ordermight be in uenced by these parameters open new avenues to the debate on this peculiar x = 0.5com position.

In summary, we clearly show the existence of bulk phase transitions in high quality pow dered sam ples with well identi ed structures. This truly underlines the im portance of magnetism in cobaltates, in a large range of Na doping. For x = 0.5, we give a convincing evidence that three m agnetic transitions occur with an AF order building up at 85 K and m om ents rearrangem ents at lower T (48 and 29 K). For 0:75 x 0:85, one can now isolate three close magnetic phases, with a C-SDW ground state, including the x = 0.82 of [9] [15]. The increase of T_0 from 21 K for the hexagonal x = 0:75 to 27 K for the monoclinic x = 0.85 phase is quite surprising since the number of magnetic Co is expected to decrease. W hether Co-Co couplings di er because of structural changes, or som e charge ordering locks-in a di erent magnetic order de nitely calls for further investigations of stable structures in the range x = 0.75 1 as well as a clear identi cation of magnetic Co sites with respect to the Na order. Rather than a continuous phase diagram induced by charge doping only, the scattering of the $T_{o}s$ rather point at a tight link between structures and m agnetic order. Disentangling how charge order/disorder and doping im pact on the physical properties versus Na content is now a crucial issue for cobaltates which apparently com bine the physics of m anganates and high-T $_{\rm c}$ cuprates.
