GeneralDynamics of Topology and Tra c on W eighted TechnologicalN etworks

For m ost technical networks, the interplay of dynam ics, tra c and topology is assumed crucial to their evolution. In this paper, we propose a tracedriven evolution model of weighted technological networks. By introducing a general strength-coupling mechanism under which the trac and topology mutually interact, the model gives power-law distributions of degree, weight and strength, as con rm ed in many real networks. Particularly, depending on a parameter W that controls the total weight grow th of the system, the nontrivial clustering coe cient C, degree assortativity coe cient r and degree-strength correlation are all in consistence with empirical evidences.

The past few years have witnessed a great devotion of physicists to understand and characterize the underlying mechanisms of complex networks including the Internet [1], the WWW [2], the scientic collaboration networks (SCN) [3, 4] and world-wide airport networks (WAN) [5, 6]. So far, researches on networks have mainly focused on unweighted graphs. Barabasiand A lbert have proposed a well-known model (BA model) that introduces the degree preferential attachm ent m echanism to m in ic unweighted growing networks [7]. Most recently, the availability of m one com plete em pirical data has allow ed scientists to consider the variation of the weights of links that re ect the physical characteristics of m any real networks. Obviously, there is a need for a modelling approach to complex networks that goes beyond the purely topological point of view. A lain Barrat, et al. presented a model (BBV model) that integrates the topology and weight dynam ical evolution to study the growth of weighted networks [8]. Their model yields scale-free properties of the degree, weight and strength distributions, controlled by an introduced parameter How ever, its weight dynam ical evolution is triggered only by newly added vertices, resulting in few satisfying interpretions to the collaboration networks or the airport system s. In fact, the dynam ics and properties of social and technological networks are quite di erent and should be addressed individually. It is well-known that networks are not only specied by their topology but also by the dynamics of weight (e.g. information ow) taking place along the links. For instance, the heterogeneity in the intensity of connections may be very important in understanding technological system s. The am ount of traf-

c characterizing the connections of communication systems or large transport infrastructure is fundam ental for a full description of these networks [9]. Take the WAN for example: each given edge weight w_{ij} (trac) is the number of available seats on direct ight connections be-

tween the airports i and j. W eighted networks are often described by an adjacency matrix wij which represents the weight on the edge connecting vertices i and j, with i; j = 1; :::; N, where N is the size of the network. We will only consider undirected graphs, where the weights are symmetric ($w_{ij} = w_{ji}$). As con in ed by measurements, complex networks often exhibit a scale-free degree distribution P (k) s k with 2 3 [5, 6]. The weight distribution P (w) that any given edge has weight w is another signi cant characterization of weighted networks, and it is found to be heavy tailed, spanning several orders of m agnitude [10]. A natural generalization of connectivity in the case of weighted networks is the $_{\rm j2}$ $_{\rm (i)}$ w $_{\rm ij}$, where the vertex strength described as $s_i =$ sum runs over the set (i) of neighbors of node i. The strength of a vertex integrates the inform ation about its connectivity and the weights of its links. For instance, the strength in WAN provides the actual tra c going through a vertex and is obvious measure of the size and im portance of each airport. Em pirical evidence indicates that in most cases the strength distribution has a fat tail [6], sim ilar to the power law of degree distribution. Highly correlated with the degree, the strength usually displays scale-free property s s k [11, 12].

The previous models of complex networks always incorporate the (degree or strength) preferential attachment mechanism, which may result in scale-free properties. E scentially, this mechanism just describes interactions between the new ly-added node and the old ones. A ctually, such interactions also exist between old nodes. Perhaps, the most reasonable and simplest way to express such interactions is by the product form of related vertex strengths, i.e. the pairwise interaction between vertices i and j is proportional to $s_i s_j$ (strength coupling form). Let's review BA model: a new vertex n is added with medges that are random ly attached to an existing vertex i according to the degree preferential probability, which can be written in the product form of degrees

Analogously, in BBV networks one can rewrite the strength preferential probability:

W e argue that such interactions (actually driven by trafc) exist between old vertices in the same way, and will considerably a ect the ows between them: First, new edges should be allowed to add between old nodes; second, the pre-existing trac ows along the links will be updated with the growth of networks. Indeed, physical interaction of nodes plays a crucial role in determ ining the network topology during its dynam ical evolution. O ur above perspectives have been partly inspired by the work of D orogovtsev and M endes (DM) [13] who proposed a class of undirected and unweighted m odels where new edges are added between old sites (internal edges) and existing edges can be rem oved (edge rem oval).

In the letter, we present a model for weighted technological networks that considers the topological evolution under the general trac-driven interactions of vertices. It can m in ic the reinforcement of internal connections and the evolution of m any infrastructure networks. The diversity of scale-free characteristics, nontrivial clustering coe cient, assortativity coe cient and strength-degree correlation that have been empirically observed can be well explained by our microscopic mechanisms. Moreover, in contrast with previous models where weights are assigned statically [14, 15] or rearranged locally (BBV model), we allow the ows to be widely updated.

The model starts from an initial con guration of N $_0$ vertices connected by links with assigned weight w $_0$. The model is de ned on two coupled mechanisms: the topological growth and the strengths' dynamics:

(i)Strengths' D ynam ics. From the beginning of the evolution, all the possible (existing or not) connections at each time step are supposed to update their weights according to the strength-coupling mechanism :

integrates the strength coupling of vertices i and j, and determ ines the increment probability of weight w_{ij} (if i and j are unconnected, w_{ij} = 0). The total weight of the edges in statistical sense is modiled by the amount $< _{i < j} w_{ij} > = W$, which is assumed constant for sim – plicity. This parameter relects the growing speed of the network's total trached; for instance, the increasing rate of total information ow in a communication system. The always growing trached that W p_{ij} is very likely to exceed one if the initial number of nodes N₀ is small. When W p_{ij} exceeds one, it is automatically assumed to be one. This treatment of W p_{ij} will probably




FIG. 1: Illustration of the evolution dynamics. A new node n_{p} connects to a node i with probability proportional to $s_{i} = {}_{j} s_{j}$. The thickness of nodes and links respectively represents the magnitude of strength and weight. New connections (dashed) can be built between pre-existing nodes and the bilateral links represent the trac growing process along links under the general mechanism of strength couplings.

a ect the initial network evolution, while it is not significant for discussing the statistical measures, as they are alm ost independent of initial states.

(ii) Topological G rowth. At the same time step, a new vertex n is then added with m edges that are random ly attached to an existing vertex i according to the strength preferential probability n!i (Eq. (2)). The weight of each new edge is also xed to w_0 . In fact, the strength preferential attachem nt is essentially the same with the m echanism tra c-driven interactions we have argued.

The network provides the substrate on which num erous dynam ical processes occur. In previous models, trafc was often assumed just as an appendix to the network structure. A ctually, tra c and the underlying topology arem utually correlated and it is very in portant to de ne appropriate quantities and m easures capable of capturing how all these ingredients participate in the form ation of com plex networks [9]. Technology networks provide large empirical database that simultaneously captures the topology and the dynam ics taking place on it. For Internet, the information trac between routers (nodes) can be represented by the corresponding edge weight. The total tra c that each router deals with can be denoted by the node strength, which also represents the in portance of given router. The increasing information ow as an internal dem and always spurs the expansion oftechnological networks. Speci cally, the largest contribution to the growth is given by the emergence of links between already existing nodes. This clearly points out that the Internet growth is strongly driven by the need of a redundancy wiring and an increasing need of available bandwidth for data transmission [12]. On one end, new ly-built links (between existing routers) are supposed

to preferentially connect high strength routers, because otherwise, it would lead to the unnecessary trac congestion along indirect paths that connect those high strength nodes. Naturally, trac along existing links between high strength routers, in general, increases faster than that between low strength routers. All the points are rejected in our strength-coupling mechanism. On the other end, new routers preferentially connect to routers with larger bandwidth and tra chandling capabilities (the strength driven attachment). Those phenomena also exist in airport system, power grid, and railroad network; and they could be explained by the trac-driven mechanism of our model. For power grid and railroad network, the cost by distance has a distinct e ect to their topological properties. Their degree distributions, for example, are not scale-free. In a word, topology and trac interact with each other in networks under general interactions of vertices driven by the internal increasing trac dem and.

The model time is measured with respect to the number of nodes added to the graph, i.e. $t = N = N_0$, and the natural time scale of the model dynam ics is the network size N. In response to the dem and of increasing trac, the system must expand. With a certain size, one technological network assumably has a certain ability to handle certain trac load. Therefore, it could be reasonable to suppose that the total weight on the networks increases synchronously by the natural time scale. That is why we assume W as a constant. This assumption also bring us the convenience of analytical discussion. U sing the continuous approximation, we can treat k, w, s and the time t as continuous variables [1, 7]. Then Eq. (3) indicates:

The strength s_i of vertex i can increase either if a newadded node connects to i by the topological growth dynam ics or any possible (exsiting or not) connections to i are updated by the strengths' dynam ics:

where the last expressions recovered by noticing that $_{i}s_{i}(t) = 2(m + W)t$. From Eq. (6), one can analytically obtain the power-law distribution of strength (P (s) s) with the exponent [7, 8]: = 2 + m = (m + 2W). Obviously, when W = 0 the model is topologically equivalent to the BA network and the value = 3 is recovered. For larger values of W, the distribution is gradually broader with ! 2 when W ! 1.

W e perform ed num erical sim ulations of networks generated by choosing di erent values of W and xing N₀ = 3, m = 3 and w₀ = 1. W e have checked that the scalefree properties of our m odel networks are almost independent of the initial conditions. Num erical sim ulations are consistent w ith our theoretical predictions, verifying again the reliability of our present results. Fig. 2 (a) gives the probability distribution P (s) s , which is in good agreem ent with the theoretical predictions. W e also report the average strength s_i of vertices with degree k_i , which displays a nontrivial power-law behaviors k as con m ed by empirical m easurem ent. U nlike BBV networks (where = 1), the exponent here varies with




FIG.2: (a) Probability distribution P (s). D ata are consistent with a power-law behaviors . In the inset we give the value of obtained by data tting (lled circles), together with the analytical expression = 2 + m = (m + 2W) (line). The data are averaged over 20 networks of size N = 5000. (b) Strength s_i versus k_i for di erent W (log-log scale). Linear data tting gives slope 1.04, 1.17, 1.25 and 1.30 (from bottom to top), dem onstrating the correlation of s k.




FIG.3: (a) Probability distribution of the degrees P (k) k . (b) Probability distribution of the weights P (w) w T he data are averaged over 20 networks of size N = 5000.

the parameter W in a nontrivial way as shown in Fig. 2 (b). Moreover, the major di erence between our model and DM network is rejected in the strength-degree correlation graph. Though DM model allows the emergence of internal edges, it could not mimic the reinforcement of pre-existing connections in that it is unweighted. The nontrivials k correlation demonstrates the signicant part of weight increment along existing edges, and thus implies that our model is reasonable in the light of trac ow. More importantly, one could check the scale-free property of degree distribution (P (k) k)




FIG. 4: (a) Clustering coe cient C depending on the parameter W. In the inset, we report the evolution of clustering coe cient (or C versus N) which converges soon. (b) D egree-degree correlation r depending on W. In the inset, we report its evolution which converges soon.

by combining s k with P (s) s . Considering P (k)dk = P (s)ds, the exponent is easily calculated: = (1) + 1. The scale-free properties of weight and degree obtained from simulations are presented in Fig. 3 (a) (b). Finally, it is worth remarking that for the BA networks, the clustering coe cient is nearly zero, far from the practical nets that exhibit a variety of sm allworld properties. In the present m odel, how ever, clustering coe cient C is found to be a function of W (Fig. 4 (a)), also supported by empirical data of a broad range.

In the social networks, connections between people m ay be assortative by language or by race. M ixing can also be disassortative, i.e. vertices in the network preferentially form connections to others unlike them . N ewm an proposed some simple measures for these types of m ixing, which we call assortativity coe cients [16]. In the case of m ixing by vertex degree, a rem arkable pattern

em erges. A lm ost all the social networks studied show positive assortativity coe cients while all others, including technological and biological networks, show negative coe cients. It is not clear if this is a universal property; the origin of this di erence is not understood either. In our views, it represents a feature that should be addressed in each network individually. We argue that the adaptive evolution of topology in response to the increasing tracis them a pr cause of disassortativem ixing of technological networks. Using the formula de ned in Ref. [16] (Eq. (26)), we calculate the degree assortativity coe cient (or degree-degree correlation) r of the graphs generated by our model. Simulations given in the Fig. 4 (b) are supported by em piricalm easurem ents [16]. The restriction of our model to technological networks is for that there are few empirical data for statistical analysis on \weighted" biological networks, where m any interacting mechanisms are far from present know ledge either. But hopefully, our model may be very bene cial for future understanding or characterizing biological networks and social ones, as it generates m any topological properties observed in those real networks. Due to its apparent sim plicity and the variety of controllable results, we believe that some of its extensions will probably help address the other two classes of networks.

In conclusion, the universal interactions of nodes and internal tra c dem and of the system will determ ine the topology evolution of technological network. This general tra c-driven m echanism provides a wide variety of scale-free behaviors, clustering coe cient and nontrivial correlations, depending on the param eterW that governs the total weight grow th. A ll the results are supported by em pirical data. Therefore, our present m odel for all practical purposes will dem onstrate its applications in future weighted network research.
