D oping dependence of density response and bond-stretching phonons in cuprates

A bstract

We explain the anomalous doping dependence of zone boundary (;0) and (;) bond-stretching phonons in La₂ SrCuO₄ in the range 0 < 0.35.0 ur calculations are based on a theory for the density response of doped Mott-Hubbard insulators.

The relevance of electron-phonon interaction for high- $T_{\rm c}$ superconductivity has been controversially discussed over the years. Certainly a clear signature of the interplay of charge carriers and phonons is the strong dependence of breathing and bond-stretching phonon modes as function of doping as evidenced in neutron scattering data. This was rst observed in LaSrCuO and YBCO [1,2], yet appears meanwhile as a generic feature of all high- $T_{\rm c}$ superconductors.

The theoretical study of phonon renorm alization in strongly correlated high- $T_{\rm c}$ superconductors requires a calculation of the density response for a doped M ott-H ubbard insulator (M H I). Such a theory has been developed for the t-J m odel based on a description of correlated electrons in the fram ework of the slave boson approach [3], as well as within the complementary slave ferm ion method [4], with results in favorable agreement with exact diagonalization studies [5].

In this contribution we report the doping dependence for La_2 Sr CuO $_4$ in the range 0 < < 0.35 of the zone-boundary (;) breathing phonon and of the highly anom alous (;0) bond-stretching mode, i.e., calculated by means of the slave boson approach [3].

The phonon data presented include theoretical results for optim aldoping, = 0:15, published earlier [6].




Fig. 1. D isplacements of 0 ions (a) for $q=(\ ;\)$ and (b) for the (;0) half-breathing mode.

The phonon modes under discussion couple directly to the density of holes $n_i^h=h_i^+\,h_i$ since the associated O—ion displacem ents lead to a modulation of the Zhang-Rice singlet energy. This is also the reason why the renorm alization of these phonons can be treated in the fram ework of the t-J model. The change of the Zhang-Rice energy E $_{\rm Z\,R}=8t_{\rm pd}^2=-$ with respect to the oxygen displacements u^i , =-x;y, of the four O—neighbors at R $_i$ + $^{\rm O}$ around the Cu—hole at R $_i$ yields the linear electron—phonon coupling [6]

W eassume that the resonance integral obeys the H arrison relation t_{pd} / r_0^{7-2} , where r_0 is the Cu-O distance, and obtain $g=7E_{ZR}=4r_0$, i.e., g=2eV/A. The lattice part of the H am iltonian is determined by the force




Fig. 2. Dynam ic charge structure factor N (q;!) (norm alized by the density of holes) at m om entum q=(;0) for di erent doping concentrations .(a) On the large energy scale revealing the scaling of the edge of the spinon particle hole continuum 4(J+t) and of the polaron peak (J+t).(b) N (q;!) at low energy and doping dependence of the spectral function of the q=(;0) bond stretching phonon.

constant K $\,$ 25eV /A 2 for the longitudinalO -m otion. D ue to the structure of H $_{\rm e}$ $_{\rm ph}$ the bond stretching m odes couple directly to the density response function (q;!). We have studied the renormalization of the phonon G reen's function

where $!_{\,q;0}$ is the bare phonon frequency, i.e.m easured in the undoped parent compound ($!_{\,q;0}$ 80 and 90 meV for (;0) and (;), respectively [1]). The coupling function $_{\,q}=\frac{4g^2}{K}\,(\sin^2q_{\!_{K}}\!=\!2+\sin^2q_{\!_{V}}\!=\!2)$ vanishes at the point and becomes maximal at the zone edges. Based on the parameters of the pd-model we estimate for the dimensionless coupling constant $=\hat{g}^2\!=\!ztK$ 0:07 0:12.

The central quantity controlling the phonon propagator, Eq.(2), is of course the density response function $(q;!) = h \ n^h \ n^h i_{q!}$ of the doped M ott-H ubbard insulator, whose momentum and frequency dependence was studied in Ref.[3]. Figure 2(a) shows the doping dependence of the associated density uctuation spectrum N $(q;!) = \frac{1}{2} \ ^{00}(q;!) = \ \text{for} \ q = (\ ;0)$. At $q = (\ ;0)$ them ain structure of N (q;!) lies at high energy

3t and is strongly broadened due to the scattering of holes by spin excitations. The underlying polaronic mechanism leads at the same time to a peak in N (q;!) at low energy (J + t) w ith 0:3, which can be attributed to the coherent motion of the polarons, i.e., holes dressed by spin excitations moving coherently on the energy scale dictated by the spin degrees of freedom . This polaron peak, whose energy scales with , is the origin of the anom alous behavior of the (;0) bondstretching phonon. Interestingly this polaron structure is absent near (;) [5,3], hence no anom alous behavior is expected for the breathing phonon. The origin of the anom alous behavior of the density response of the doped M H I near (;0) can be traced back to a strong




Fig. 3. Predicted doping dependence on the basis of the t-J m odel for (;) breathing and (;0) bond-stretching phonon energies in La $_2$ Sr CuO $_4$. Param eters as for Fig.2: t = 0:4 eV, J=t = 0:3, and dimensionless electron phonon coupling constant = g^2 =ztK ' 0:06.

(;0) \$ (0;) scattering m ediated by spin-excitations with m omentum transfer close to (;). An additional feature seen in Fig.2(a) is the spinon particle-hole continuum which at (;0) extends up to 4 (J + t).

As (q;!) is proportional to the hole density, phonons are renorm alized basically linearly with , yet due to the polaron structure at low energy along the (;0) direction, the (;0) phonon reveals an anomalous energy shift and damping. The strong doping dependence of this e ect, shown in Fig 2 (b) and Fig 3, is due to the shift / (J+ t) of the polaron peak position in N (q;!) and its crossing of the bond-stretching phonon energy. Our results in ply in particular that the large damping of the (;0) optical phonon near optimal doping disappears at larger doping concentrations, where the two phonon modes (;0) and (;) behave similar.

In conclusion, the anom alous renorm alization and damping ofbond stretching phonons is a manifestation of the strongly correlated motion of holes in cuprates, thus the study of these phonons provides a subtle test of the low-energy density response in cuprates at nite momentum transfer.
