D ephasing by a nonstationary classical interm ittent noise

We consider a new phenom enological model for a 1=f classical interm ittent noise and study its e ects on the dephasing of a two-level system . W ithin this model, the evolution of the relative phase between the j i states is described as a continuous time random walk (CTRW). U sing renewal theory, we nd exact expressions for the dephasing factor and identify the physically relevant various regimes in terms of the coupling to the noise. In particular, we point out the consequences of the non-stationarity and pronounced non-G aussian features of this noise, including som e new anom alous and aging dephasing scenarii.

I. IN TRODUCTION

Recent experimental progress in the study of solidstate quantum bits (Josephson qubits)¹ has stressed the in portance of low-frequency noise in the dephasing or decoherence of these two-level system $s^{2,3,4}$. It now appears that the coupling to low -frequency noise is them ain limitation in obtaining long lived phase coherent states of qubits necessary for quantum computation. How ever, a complete understanding of the microscopic origin of 1=f noise in solid state physics is not available yet⁵ and therefore, theoretical studies of the dephasing by such a noise are based on phenom enologicalm odels. In the spinboson model, the environm ent of the qubit is modeled by a set of harm onic oscillators, with an adequate frequency spectrum 6,7. A nother com m only used m odel for a low frequency noise consists in considering the contributions from many independent bistable uctuators^{8,9}. In the sem i-classical lim it, the noise from each uctuator is approxim ated by a telegraph noise of characteristic switching rate . For a broad distribution 1= of switching rates , a 1=f spectrum is recovered when sum ming contributions of all uctuators. Such a model is based on observations of telegraph like uctuations in nano-scale devices^{10,11}, but a precise characterization and justi cation of the broad distribution of switching rates is still lacking although the localization of these uctuators^{12,13} as well as their collective or individual nature¹⁴ have been investigated for a long time.

In this paper, we consider a new phenomenological model for the classical low-frequency noise. This model can be viewed as the intermittent limit of the sum of telegraphic signals. In this limit, the duration of each plateau of the telegraphic signal is assumed to be much shorter than the waiting time between plateaus¹⁰. A 1=f power spectrum for the intermittent noise is then recovered for a distribution of waiting times behaving as

² for large times. Because the average waiting time is in nite, no time scale characterizes the evolution of the noise which is nonstationary. The purpose of this article is to study the e ects of such a low-frequency interm ittent noise on the dephasing of a two-level system in order to identify possible signatures of interm ittence.

As we will show, in this model the relative phase between the states of the qubit performs a continuous time random $walk^{15,16}$ (CTRW) as time goes on. Such a CTRW was considered in the context of 1=f current noise by Tunaley¹⁷, extending the previous work of M ontroll and Scher on electronic transport¹⁸. However, in the present paper it is the integral of noise, and not the noise itself, which performs a CTRW . Moreover to our know ledge, the precise consequences of CTRW s nonstationarity on dephasing have not been studied. On the other hand aging CTRW were previously considered in the context of trap models in glassy materials¹⁹ and in the study of uorescence of single nanocrystals^{20,21}. Technically, the dephasing factor that we will consider corresponds to the average Fourier transform of the positional correlation function of the random walk. Some of the asymptotic behaviors of this correlation function were already obtained in ref.19. However, in the present paper we will extend these results to all possible regimes and we will present all of these results in a uni ed fram ework. The use of renewal theory²² greatly enlightens the origin of non stationarity and enables us to interpret som e features of the dephasing scenarii.

This paper is organized as follows : in section II, we present our model for the noise and de ne the quantity of interest, i.e the dephasing factor of a two-level system coupled to this noise. In section III, the exact expression for the single Laplace transform of the dephasing factor will be derived and, from this result, the physically relevant weak and strong coupling regimes are identi ed. M oreover, we clarify the origin of non-stationarity and show the relation of our problem to renew altheory. For completeness and pedagogy, the e ects of standard anom alous di usion of the phase and of random ness of waiting times on dephasing are compared showing the in portance of interm ittence in the non-stationarity properties of the dephasing scenarii. In sections IV and V, we present a com plete study of the behavior of the dephasing factor respectively for a noise with a vanishing average amplitude (symmetric noise) and with a nite average one (asymmetric noise). The general discussion of the results is postponed to section VI.

II. THE MODEL

A. Pure dephasing by an interm ittent noise

In this paper, we consider a quantum bit de ned as a two-level system with controllable energy di erence $h!_0$ and tunneling amplitude between the two states j i and j+ i (eigenstates of _z). The e ect of the environ-m ent on this two-level system will be accounted for by a uctuating shift hX of the energy di erence $h!_0$. Thus the H am iltonian describing this model is written as

In this paper, we will mainly focus on the case of pure dephasing (= 0). However, as explained below in section IIC, our discussion will also apply to other operating points (ϵ 0), including the special points where a careful choice of control parameters considerably lower the qubit sensitivity to low frequency noise³.

Here, we will focus on the elects of a low-frequency classical noise on the qubit. The noise is represented by a classical stochastic function corresponding to the uctuations of the noise in a given sample. W ithin this statistical approach, we focus on the statistical properties (e.g. the average) of physical quantities associated with the qubit such as the so-called (average) dephasing factor. A swe shall see now, its meaning can be understood by considering a typical Ram sey (interference) experiment on the qubit²⁴.

In such an experiment, the qubit is prepared at initial time t_p in a superposition of the eigenstates of z, e.g $j + i = (j!i + j!i)^{2}$. Note that throughout this paper, t = 0 will correspond to the origin of time for the noise (e.g the time at which the sample reached the experiment's temperature). At some later time $t_p + exp > t_p$, we consider the projection of the evolved qubit state on j'i. In them ean time, the state has evolved under H am iltonian (1) (= 0) and both states j"i and j!i have accumulated a random relative phase (t_p ; exp) de ned by

For a given accumulated phase = $(t_p; e_{xp})$, the quantum probability P; $_{e_{xp}}$ (J'i) to nd the qubit in state j+ i at time t_p + $_{e_{xp}}$ is given by

Note that in a given sample, P ; $_{exp}$ (j+ i) oscillates between 0 and 1 as a function of $_{exp}$ (although possibly nonperiodically). The experimental determ ination of the probability for noting the qubit in the j+ i state at time $t_p + t$ usually requires m any experimental runs of same duration $_{exp}$. The phase uctuations between diment

runs induce an attenuation of the amplitudes of these oscillations (analogously to destructive interference e ects in optics). Using B ayes theorem, the corresponding statistical frequency to nd the qubit in state j + i after a duration $_{\rm exp}$ is given by the probability

In this expression, the decay rate of these oscillations is encoded in the dephasing factor D $_{\rm t_p}$ ($_{\rm exp})$ de ned as

In this formula (and only here), the overline denotes an average over all possible congurations of noise X (t) during the experiment.

Note that in deriving eq.(4), statistical independence of the phases between di erent runs has been assum ed. This is not necessarily true for successive runs in a given sample as correlations of the noise might lead to a dependence of the distribution of the phase $(t_p; e_{xp})$ on the starting date t_p of the run. Hence throughout this paper, for self-consistency, we will keep track of this e ect through a possible t_p dependence of the dephasing factor D t_p (exp). Its possible in plications will be discussed together with our results in section V I.

B. A model for classical interm ittent noise

In several experimental situations, the low-frequency noise acting on the qubit is supposed to be due to contributions from background charges in the substrate^{8,9}. When the dephasing is dominated by the low-frequency uctuators, a sem i-classical approach, in which the noise is modeled by a classical edd, appears su cient ^{8,9,25}. In this case, the noise is described by a D utta-H om m odel²⁶. In its simplest form, the potential X (t) is written as the sum of the contributions of many telegraphic signals, each with a characteristic switching rate between the up and down states (see gure 1a). For switching rates distributed according to an algebraic distribution p() ' 1= , the power spectrum of the corresponding noise has a 1=f low-frequency behavior.

In this paper, motivated by several noise signatures^{11,13}, we will focus on the intermittent limit for such a Dutta-Hom model, and propose a phenomenological spike eld to study its e ects on qubit dephasing. By intermittence, we mean for the case of the telegraphic noise that the switching rate + from the up to the down states is much larger than the switching rate from the down to the up states (or vice-versa). In this limit, the total noise reduces to a collection of well de ned events, separated by waiting times $_{i}$ (see gure 1b). If considered on times much larger than the typical duration $_{0}$ of these events (or at frequencies




FIG.1: Representation of a low-frequency noise as a sum of contributions from telegraphic signals (a). In this rst case, the switching rates for the up $(\ _{+}\)$ and down $(\ _{-}\)$ states are comparable, and a 1=f spectrum is recovered for a distribution of switching rates 1=. The interm ittent lim it (b) corresponds to the lim it where the noise stays in the down states m ost of the time ($_{+}\)$. In this paper, we will approximate this interm ittent noise by a spike eld. For this interm ittent noise, a 1=f spectrum in plies a non stationarity whose consequences on dephasing are studied in this paper.

sm aller than $1=_0$, we can approximate this noise by a spike eld consisting of a succession of delta functions of weight x_i corresponding to the integral over time of the corresponding events of the interm ittent eld (Fig.1b).




FIG. 2: Representation of the random spike eld used to model the interm ittent low-frequency noise in this work. This noise is described by the distributions of the phase pulses x_i and of the waiting time intervals $_i$ between the spikes.

M ore precisely, denoting by t = 0 the origin of time, and by $_i$ the successive waiting times between the spikes (or events), we know that the nth spike occurs at time $t_n = \sum_{i=1,n \ i}$. The value of the stochastic interm ittent classical noise X (t) (see Fig. 2) is then

In the following, we will consider the dephasing produced by this spike eld. We expect any short time details like the specic shape of the real pulses to be irrelevant in the lim it of typical dephasing time long com – pared to $_0$. W ithin this approximation, a noise signal is fully characterized by the collection of waiting times $_{\rm i}$ and pulse amplitudes $x_{\rm i}$ that occur as time goes on. We will assume these two quantities to be independent from each other, and completely uncorrelated in time. We will then characterize such a noise solely by two independent probability distributions () and p(x) for the $_{\rm i}$ and $x_{\rm i}$ respectively.

The distribution of pulse amplitudes p(x) will be assum ed to have at least its two rst moments nite, and denoted in the following by

W e w ill consider separately the case of zero average (sym – m etric noise) and of non-zero average (asym m etric noise) since the latter induces speci c features of the dephasing factor, discussed in section V.

W e w ill consider algebraic distribution of waiting times (), parametrized by a single parameter :

As we will show in section IID, a 1=f power spectrum for this interm ittent spike eld follows naturally from such a choice for (). As we shall see in this paper, the above algebraic distribution of waiting times allows to correctly capture the essential features of the dephasing scenarii generated by an interm ittent noise. The rst and second m om ents of are nite respectively for > 1and > 2 and are given by

Let us note that the above de ned pulse noise contains two independent potential sources of dephasing: The random ness of the pulse weights and the random ness the waiting times. Their respective e ects will be compared in section III.

C. Decoherence at optim alpoints

Before turning to the detailed study of pure dephasing (= 0 in (1)), let us mention that our discussion can be easily extended to the study of dephasing in the presence of a transverse coupling in (1), in particular at the so-called optim al points. They correspond to congurations where the uctuations of the elective qubit level splitting are only quadratic in the noise am plitude. The qubit can be operated at these optim al points by a careful choice of the control parameters $!_0$ and of the qubit and then, the in uence of low frequency noise can be reduced considerably³. For the Ham iltonian considered in the present work (1) such an optim al point is reached for transverse coupling to the noise (! $_0 = 0$ and \neq 0). In this case and assuming the amplitude of the noise to be small compared to the control param eter , the e ective qubit level splitting is given by $^{2} + X (t)^{2}$ + X (t)²=(2). Hence, the dephasing e ect of a linear transverse noise can be accounted for using an elective quadratic longitudinal noise. The corresponding dephasing factor is then given by (5) and (2) with the replacement X $\, ! \,$ X $^2=$ (2).

In addition, the transverse noise at an optimal point induces transitions between the eigenstates of the qubit, i.e. it leads to relaxation. The Ferm iG olden Rule relaxation rate _r, which is used for estimating the relaxation contribution to dephasing, involves the power spectrum of the noise at the resonance frequency of the qubit¹. The total dephasing rate is obtained by sum m ing the contribution of relaxation given by _r=2 and the contribution of pure dephasing due to the above elective longitudinal noise.

In general the statistics of X and X 2 are very di erent and a special treatment is needed to derive the dephasing factor at optim al points⁶. However, for the noise considered in the present work, the elective quadratically coupled longitudinal noise can be viewed as en elective linearly coupled noise of the same type but with renormalized parameters. The renormalized distribution of the spike intensities is now given by (x 0):

where $_0$ is a m icroscopic time scale needed to regularize the square of delta functions. Therefore, our results for the longitudinal noise presented in section IIA can also be used to describe the e ect of a transverse noise.

D. Spectral properties of the interm ittent noise

1. One and two point correlation functions

To make contact with other descriptions of lowfrequency noise, we will determ ine the behavior of the two time correlation function of our noise, or equivalently of its spectral density. However, as we will see, this spectral density is far from enough to characterize the statistics of the noise for small , in particular due to its non stationarity. We will consider for sim plicity the case of a non zero average $h = \overline{x}$.

a. Time dependent average Let us consider the average of the noise am plitude X (t). In our case, it reduces to two independent averages: over the am plitudes x_i of the spikes and over the waiting times $_i$ between them. Noting that X (t) vanishes except if a spike occurs at time t, we can express its average in terms of the average density S (t) of pulses at time t also called the sprinkling time distribution in ref. 27:

U sing the expressions (A 4), (A 10) for S (t) (see appendix A), we obtain for the average of X $\,$:

Hence the non-stationarity of the noise manifests itself already in the time dependence of this single time average. W hile it is only a subleading algebraic correction for 1 < < 2, this time dependence becomes dominant for 0 < < 1.

b. Two time function Following the same lines of reasoning, we can derive the expression of the two time correlation functions (with t > 0):

The rst factor S (t_p) corresponds to the probability that a spike occurs at time t_p , while the second factor S (t) reads the probability of having a pulse at time $t_p + t$, knowing that there was one at t_p . This rejects the reinitialization of the noise once a spike has occurred at time t_p . From (11,13), we obtain the connected two points functions:

2. 1=f noise spectrum

W e will de ne the spectral density of the noise as the Fourier transform of the connected two points functions restricted to t > 0 :

The correlation function C (t_p;t) generically depends on both times t_p and t_p + t thus showing that in generalX is not a stationary process. However, to extract the low – frequency behavior of S_X (t_p;!), it appears su cient to consider the quasi stationary regime t_j t_p which corresponds to experiment durations much smaller than the age of the noise. In this regime, the connected correlation function (14) reduces for t > 0 to

The associated e ective power spectrum is dened for frequencies ! large compared to $1=t_p$ and reads:

where L [S] denotes the Laplace transform of S (t). Note that in this quasi-stationary regime, the nonstationarity of the noisem anifests itself only through the t_p dependent am plitude S (t_p). Using explicit expressions for L [S] (see appendix A), we obtain the elective power spectra:

for the interm ediate class 1 < < 2. The common 1=! dependence of the spectral density is recovered in the limit ! 1. More precisely, the Laplace transform of S for = 1, obtained in appendix A, gives a logarithm ic correction to a 1=! e ective power spectrum :

Let us stress nally that this e ective power spectrum, although useful to com pare our approach with other noise models, is not su cient to characterize the statistical properties of the spike eld noise relevant for dephasing. As we shall see in this paper, it does not account precisely for the non-stationarity of the dephasing factor. B esides this, non G aussian properties of the noise have strong e ects on the dephasing factor in m any regimes.




FIG.3: A con guration of the noise X ($t_p+~$) in ourm odel (as a function of) between $t_p=10^5_{-0}$ and $t_p+~=111\,10^5_{-0}$. In this gure, h=0 and the waiting times are distributed with an algebraic distribution P ($_i$) ' $_i^{-211}$. The bottom part of the gure shows the corresponding continuous time random walk of the accumulated phase of the TLS between t_p and $t_p+~$.

III. DEPHASING, CONTINUOUS TIME RANDOM WALK OF THE PHASE AND RENEWAL THEORY

A. Continuous time random walk of the phase

Having de ned our model for the interm ittent noise eld X (t), we will now study its e ects on the dephasing of the two-level system, characterized by the dephasing factor (5). Note that a priori this dephasing has several origins: the random ness of the pulses am plitudes x_i , and the random ness of the waiting times $_i$. These two dephasing sources are assumed to be independent from each other in this work. For clarity and pedagogical reasons, we rst start by considering the e ect of random ness of the pulse am plitudes before turning to the the e ect of waiting time random ness.

1. Dephasing by random phase pulses : the random walk of the phase

Here, we assume that all waiting times are equal $i = t_i \quad t_i = -$. In this case, the phase $(t_p;t)$ accumulated between t_p and $t_p + t$ performs a usual random walk characterized by the distribution p(x) of phase pulses : at the dates $t_n = n \sim$, $(t_p;t)$ is increased by a random value x_i . In the limit jxj 1, the phase slow ly di uses and dephasing is achieved only after a large number of pulses $n = t_n = -$. Then, the distribution of the phase $(t_p;t_n)$ can be well approximated by a Gaussian distribution (apart from some irrelevant tails) and the dephasing factor is easily computed. It decays exponen-

tially with characteristic time $=\frac{2^2}{g^2 h^2}$.

Note that this di usive regime can also be studied when the distribution p(x) lacks a nite second or even rst moment. An anom alous di usion of the phase is expected²⁹. Let us assume that $x_i = h + i$ i where the probability distribution of i has zero average and belongs to the attraction bassin of the stable law L . characterized by the exponent 0 < < 2 of the algebraic tails for large values of i and the asymmetry parameter j j 1. Then, according to the generalized central lim it theorem , the accumulated phase after n pulses is $n = nh + n^{1=}$ where is distributed according to L ; . Consequently, in the di usive limit (n 1), the dephasing factor is the product of the hom ogenous phase $e^{iht=\sim}$ by the characteristic function of L , evaluated for k' g(t= \sim)¹⁼. For < 2 and \neq 1, this leads to:

where C is a num erical constant which can be absorbed in a rescaling of . Thus, in this case, the decay is still exponential and stationary although non G aussian features of the noise lead to an anom alous dependance of the dephasing time on the coupling constant that characterizes the scale of the uctuations of phase pulses²⁸.

2. Dephasing by random waiting times and continuous time random walk

Let us now turn to the situation where the phase pulses happen at random times. In this case, the accumulated relative phase $(t_p;)$ (see eq.(2)) does not perform a random walk as increases, but rather a continuous tim e random walk^{15,16} (CTRW) on the unit circle. In other words, after some random waiting time $_{i}$, (t_p;) is incremented by a random value x_i (see gure 3). Thus, on a technical level, the dephasing properties of the two level system are now related to som e correlation function of the corresponding CTRW . The corresponding dephasing factor can dier from results obtained in the previous section due to the additional source of dephasing given by the random ness of waiting times. To illustrate this point, let us consider the case where all phase pulses have the sam e intensity p(x) = (x h). The accumulated phase after N events is exactly N h. Thus, dephasing com es only from the random ness of the num ber N [tp;tp + t] of events occurring between t_p and t_p + t and the phase di usion is governed by the probability distribution for N $[t_p; t_p + t]$. The time needed to obtain N eventspis the sum over the N rst waiting times after $t_p: t_N = \int_{j=1}^{N} dt_p = 0$, all is are distributed according to the same probability distribution and therefore, in the lim it of large N, the generalized central lim it theorem ²⁹ can be used (the case $t_0 \in 0$ will be discussed below). It provides the lim it law for t_N at large N which in turn determ ines the probability law for the number of events. According to this theorem, three classes must be considered depending on whether the moments (9) are nite:

- The case > 2 where both h i and h²i are nite. In this case, the probability distribution for the number of events is gaussian with a vanishing relative uncertainty.
- 2. The case 1 < < 2 where the average of is nite but the second m om ent diverges.
- 3. The case < 1 where all m om ents diverge.

The usual model for telegraphic noise assumes a Poissonian distribution for the number of events in a given time interval and corresponds to () = e . We will refer it as the Poissonian case and it belongs to the > 2 class.

Note that non trivial behavior is expected in the last two cases where has in nite rst or second moments. In particular, for < 1, as () does not have any average, no time scale characterizes the evolution of the noise and, as we will see, nonstationarity follows. This case deserves a special attention as we showed that a 1=f spectrum is found precisely for ! 1. Before turning to the general form alexpressions for the dephasing factor, we will focus on the origin of this nonstationarity.

3. Origin of the non-stationarity in CTRW : the rst waiting time distribution.

W ithin our model, the waiting times between successive pulses are chosen independently according to the distribution . Consequently, all the t_p dependence of $(t_p;t)$ will come from the choice of $_1$ de ned as the waiting time between t_p and the rst spike that follows t_p (see gure 4). Indeed, at time $t_p + _1$, the CTRW




FIG .4: Interm ittent noise between $t_{\rm p}$ and $t_{\rm p}$ + t

starts anew: $_2$ is chosen without any correlation to the history of the CTRW . Hence given the probability distribution of $_1$, we can forget about the history of the CTRW of the phase and describe its behavior starting at t_p . This remark is at the core of the use of renewal theory. In the following, the probability distribution of $_1$ will be denoted by $_{t_p}$ and a priori, it may depend on t_p . In fact, as we shall see later, its behavior can be quite counter-intuitive.

First of all, note that a given $_1$ can be obtained from m any di erent noise con gurations that di er from the

time of the last event occurring before t_p . Separating noise con gurations (starting at t = 0) that have their rst spike at time $t_p + 1$ from the others leads to an integral equation that determ ines t_p in terms of (S is determ ined from through an integral equation (A1)):

The integral in the r.h.s. comes from noise con gurations that have a spike between 0 and t_p . Equation (22) is the starting point for deriving analytic results about t_p in appendix B and C using Laplace transform techniques. Before computing exactly the dephasing factor, let us show some of the counter-intuitive properties of t_p (1). In particular from (22), we can derive the following expression for the average of 1 valid for > 2:

This rst term corresponds to the case of regularly spaced pulses averaged over the origin of times. The second term is the contribution of uctuations. This result means that irregularities in the event spacings increase the average waiting time of the rst event following tp. The r.h.s. of (23) does not depend on t_p , as expected from the stationarity of the CTRW for > 2 after a short transient regime at small t_p . On the other hand, for < 2, eq. (23) is expected to break down since h² i diverges. This divergence signals that in some noise con gurations 1 can become of the order of tp and, as a consequence, the average properties of the CTRW $after t_p$, depend on this age of the noise. Indeed, we can show from (22) that $h_1 i_{t_n}$ scales with the age as t_n^2 . Note that in the diusion regime, many phase pulses are necessary to dephase the qubit. Therefore, we expect that, in this regime, the aging e ect on t_n (1) only brings weak corrections to the dephasing scenario as will be con med below by exact com putations. However, we shall see in the following that the t_p dependence of t_o for 1 has much more spectacular consequences on the dephasing factor than in the 1 < < 2.

W e will now show that, know ing the Laplace transform of $_{t_p}$, an explicit expression for the Laplace transform of the average dephasing factor can be obtained.

B. Exact dephasing via renewal theory

1. Dephasing factor

A m ong all noise con gurations that are to be taken into account, some of them (possibly very few) do not have any event between t_p and $t_p + t$. Their totalweight is given by $_0$ (t_p ;t) which is

All other histories have at least one event between t_p and t_p + t. Let us assume that it happens at t_p + $\ \ \, w$ here

lies between 0 and t. Then after this event, the noise starts anew. The jump itself contributes by e^{ix} to the dephasing factor and the rest of the noise con guration contributes by D₀ (t) (i.e. $t_{\rm p} = 0$ in eq.(5)). The probability that the rst event after $t_{\rm p}$ happens at time $t_{\rm p} + t_{\rm p}$ is nothing but $t_{\rm p}$ (). Hence the contributions to D $t_{\rm p}$ (t) from all possible noise con gurations take the form of the follow ing renew al equation:

Note that the Laplace transform of this expression is very simple:

where f = 1 e^{ix} . Specializing $t_p = 0$, one gets an expression for D_0 (t) that contains $_0$ (0;t). Since $_0$ (0;t) = t_1^{-1} ()d an explicit expression for the Laplace transform of D_0 can be found:

Plugging expression (27) into equation (26) gives:

This exact expression will be extensively used to derive both analytic expressions and num erical plots by Laplace inversion. Before proceeding along, let us express L $[D_{t_p}]$ in term s of the density of events. It is then convenient to de ne S_{t_p} (t) = S (t_p + t) (see appendix A). From the expressions in this appendix of L $[S_{t_p}]$ and L [S] in term s of L [] and L [t_p], we obtain

Equation (28) and (29) enable analytical estimates of the dephasing factor in various limiting regimes. Equation (29) is useful in the limit of small coupling (i.e. f ! 0) whereas eq. (28) will be useful in the opposite limit of a wide distribution of spikes' heights (i.e. f ! 1).

2. W eak and strong coupling regimes

In the limit of very strong coupling (f = 1), the phase spreading of a single spike is su cient to dephase the qubit. In this case, eq.(25) immediately leads to D $_{t_p}$ (t) = $_0$ (t_p;t). This means that the whole average is dominated by the rare noise con gurations that do not evolve during the experiment. A swe shall see later, this leads to a strong t_p dependence of D $_{t_p}$ (t) for < 2.

At much lower couplings (jf j 1), it is not a priori clear whether the renewal equation for D $_{t_p}$ (t) induces a strong dependence of D $_{t_p}$ (t) on t_p . Pushing the above analysis forward amounts to compare the time dependence of the two terms in the rhs. of the renewal equation (25). As we will see now, it will provide a better understanding of the physics underlying the dephasing scenario.

Let us rst assume that $_{0}$ (t_p;t) decays much faster than D₀(t). Since $_{t_p}$ () = $(0, t_p;)$, it also decays much faster than D₀. Consequently, we can approxim ate $_{t_p}$ ()D₀(t) by $_{t_p}$ ()D₀(t) in Eq.(25). Then, after a short initial decay due to both D₀(t) and $_{0}$ (t_p;t), D $_{t_p}$ (t) decays as D₀(t). Consequently, the dephasing time does not depend on t_p. For instance, we expect this situation to occur at weak coupling when the average waiting time h is nite since the probability that no event occurs between t_p and t_p + t vanishes quite fast when t increases. Note that in the lim it of vanishing coupling, the spreading of the phase can become much slower than the decay of $_{0}$ (t_p;t) and thus our starting point hypothesis is valid.

The opposite case where the decay of D $_0$ (t) is much faster than the decay of $_0$ (t_p;t) can be discussed more conveniently by integrating the renew all equation (25) by parts. Considering again g 1 we get:

Approximating $_0$ (t_p;t)) $_0$ (t_p;t) in this equation yields D t_p (t) = D $_0$ (t) + $_0$ (t_p;t) (1 D $_0$ (t)). As a consequence, once D $_0$ (t) has decayed, the dephasing factor is almost equal to $_0$ (t_p;t). This is the same behavior than in the very strong coupling regime f = 1, although here, we assumed jf j 1. This regime is expected to occur when the decaying time scales of D $_0$ (t) and of $_0$ (t_p;t) are comparable. This is obviously the case at very strong coupling but, surprisingly, as we shall see now it can also be obtained for jf j 1!

First of all, the above discussion shows that such a regime can only happen if the average waiting time is in nite, i.e. for < 1. In this case, $_0$ (t_p;t) can be evaluated analytically (see eq. (D1)): it is shown to be independent of $_0$ and to exhibit aging behavior (i.e. to depend only on t=t_p). Therefore, the decaying time scale of $_0$ (t_p;t) scales as t_p. C om paring this time scale with the dephasing time scale for jfj 1, leads to a t_p dependent cross-over coupling constant f_c (t_p). In the case of aging $_0$, the crossover coupling decays to lower and lower values by increasing t_p.

For $jf j > f_c(t_p)$, the dephasing factor behaves as $_0(t_p;t)$ and the dephasing time saturates as a function of f. Such a saturation of the dephasing time as a function of the am plitude of the noise has already been discussed for a Poissonian uctuator^{9,25}. In this case $_0(t_p;t) = _0(0;t) = e^{t=h i} decays very fast, on a time scale h i. The cross-over between weak and strong coupling regime happens precisely at the point where the$

dephasing time assuming weak coupling h i=g² is of the same order as this decay time, i.e. for g 1. Note that in this case, as expected from our discussion, the crossover scale is independent of the age of the noise t_p. We expect this reasoning to break down in ourmodel because of the broad distribution of waiting times (< 2). Understanding the various dephasing scenarii and computing the t_p dependence of the crossover coupling in our case requires the computation of $_0$ (t_p;t) and of D $_0$ (t). These quantitative results will be presented in forthcoming sections.

To sum marize the above discussion, we have argued that the dephasing time is bounded by the typical decay time of both $_0$ (t_p;t) and D $_0$ (t). This suggests to distinquish between two regimes: on one hand, a weak coupling regime for which D_0 (t) decays much slower than $_0$ (t_p;t) and for which the dephasing time - in that case just the decay time of D₀ (t) - is not sensitive to t_0 . On the other hand, a strong coupling regime for which D $_{\rm 0}$ (t) decays faster than $_0$ (t_p;t). In that case, the dephasing time is given by the decay time of $_0$ (t_p;t) and thus possibly t_pdependent. A s the above discussion show s, the cross-over between these two regimes may happen for a possibly to dependent cross-over coupling $f_c(t_p)$ 1. Note that in the strong coupling regime, the dephasing time becomes independent of the amplitude of the noise whereas in the weak coupling regime, it is expected to depend on the am plitude and to diverge in the vanishing coupling lim it.

IV. DEPHASING IN THE SYMMETRIC MODELS

In this section we present our results for the situation of a symmetric distribution of the spikes, p(x) = p(x). Under this assumption the average random accumulated phase vanishes, i.e. f and consequently $D_{t_p}(t)$ are real. For g 1, f may be expanded in moments of p(x), f \hat{g} 1 where g measures the typical scale of the uctuations of the spikes.

A. Dephasing at $t_p = 0$

Before discussing the decoherence factor for arbitrary preparation time t_p , it is useful to investigate the case $t_p = 0$. Rewriting the Laplace transform of D₀ (t) (27) as

suggests to introduce a scale $\ _{\rm g}$ related to the strength of the coupling:

Note that g vanishes with the coupling g. Investigating the behavior of D $_0$ for t $_0$ requires evaluating

the Laplace transform for s₀ 1. In this regime, the Laplace transform L []=(1 L []) can be approximated by 1=(1 L []). Within this approximation, we shall now derive explicit expressions for L D_0] which can be Laplace inverted explicitly. This leads to expressions for D₀(t) valid at t₀ for the di erent classes of .

In the case of nite average waiting time (> 1), we can expand L[] 1 shito nd the leading contribution to D_0 (t) for h i $_{\rm g}$ t < 1. This gives:

with the dephasing time = $_{g}^{1}$ = h i=f (see eq. (32)). Note that this expression is exact only for () = $\frac{1}{h} e^{-h}$. At nite non integer , taking into account the uctuations of the waiting times requires keeping all terms in 1 L[] up to the rst non integer power (s b) . For 1 < 2, we get algebraic subleading corrections to (33): log (D $_{0}$ (t)) ' $_{g}$ t fc() (t= $_{0}$)² , where c() = (1)=(2). These corrections being weak forg 1, the dephasing time remains equal to $_{g}^{1}$ = h i=g² in this regime.

For < 1, the rst term in the expansion of 1 L [] is proportional to $(_0s)$. Therefore, plugging in (1 L [])=L []' (1)(s_0) and performing the inverse Laplace transform of (31) gives:

where E (z) = $\frac{P_{1}}{n=0} \frac{z^{n}}{(1+n)}$ denotes the M ittag-Le er function³⁰. For values of close to one and z < 1 this function can be approximated by a simple exponential, whereas for 0 it is similar to an algebraic function E (z) (1 + z)¹. For large values of the argument (jzj 1) and jarg(z)j< (1 = 2), we obtain³⁰ E (z) (z (1))¹. This change of behavior from an exponential to an algebraic behavior was interpreted in ref. 32 as a G ri th e ect.

C om puting long time behavior (gt 1) of the dephasing factor can be done by expanding (31) as follows:

For $_{g}t$ 1 (s $_{g}$) we can safely replace L[] 1 in the denominator. The inverse Laplace transform can then be done easily and reads for $_{g}t$ 1:

For < 1, (36) is nothing but the asymptotic behavior of (34) for $_{\rm g}$ t 1. Note that forg 1, $_{\rm g}$ ¹ is of the order of $_0$ and the decay is algebraic at all times t> $_0$, given by (36). For 1 < < 2 and g 1, only at large times ($_{\rm g}$ t ln (l=f)), when the qubit has almost completely dephased, the decay crosses over to the power law (36).

B. In uence of a nite preparation time t_p

W e will now discuss in detail the t_p -dependence of the dephasing scenario and of the crossover coupling strength g_c for the di erent classes of . Sim ple analytical expressions for D t_p (t) can be derived in the weak (g g_c) and strong (g g_c) coupling regimes.

1. In nite uctuations of the waiting times: 1 < < 2

For $1 < \langle 2, \text{ the decay of } D_0(t)$ is accurately described by (33) and (36). On the other hand, $_0(t_p;t)$ exhibits an explicit dependence on the age of the noise (see appendix D):

for t_p 0. We will arbitrarily de ne the typical time scale of the decay of any function as the time at which its modulus reaches a xed value 0 < < 1 (= 1=e in all the gures of this paper). The cross-over between a weak and strong coupling regime is de ned as the value of g where the typical decay times of D₀ (t) and 0 (t_p ;t) coincide (see section IIIB 2). In the present case, the cross-over coupling gets a weak t_p dependence:

$$(g_{c}(t_{p}))^{2} ' \frac{1}{1} + \frac{0}{t_{p}} : (38)$$

Note that g_c is a decreasing function of t_p since increasing t_p slows down the decay of $_0$ ($t_p;t$) (remember that the average time of the $\,$ rst occurring spike after t_p increases as t_p^2). But since the average waiting time is nite, g_c has a non zero lower bound. Note also that the t_p- dependence of g_c is only visible for values of $\,$ close to one and disappears as $\,$ increases to higher values. This can be seen on the numerical results depicted on $\,g.\,6:\,g_c\,(t_p)$ is the crossover coupling where the dephasing time start to saturate as a function of $g.\,$

In the case of very strong coupling (g $g_c(t_p)$), the decay of D $t_p(t)$ coincides with $_0(t_p;t)$ and is thus algebraic at all times (see g. 5). On the other hand, at weak coupling (g g_c), the dephasing factor D $t_p(t)$ follows D $_0(t)$ up to times of the order of the dephasing time, i.e. it decays exponentially: D $t_p(t) = \exp((t=))$, where $= \frac{1}{g} = \frac{1}{g} g^2$. In this weak coupling regime, the dephasing is thus described accurately using a second cum ulant expansion. However, for times large com pared to the dephasing time, t $^>$ ln ($=_0$), higher cumulants contribute and the decay goes over to a much slow er power law. If $t_p <$ the asymptotic decay of D $t_p(t)$ continues to follow D $_0(t)$ behavior given in (36) whereas, in the opposite case $t_p >$ it is given by $_0(t_p;t)$ (37).




FIG. 5: Dephasing factor D_{tp} (t) in the symmetric model obtained by numericalLaplace inversion for = 1:1 and t_p = 10^5 and various values of g. At small couplings, the decay is exponential. But at longer times t and for strong coupling the decay is algebraic.




FIG. 6: Dephasing time in the symmetric model as a function of g for = 1:1, = 1:8 and for various values of t_p . At strong coupling the dephasing time exhibits t_p -dependence, which disappears as increases to higher values. Note that the critical coupling g_c has a weak t_p -dependence for close to one.

2. In nite average waiting time: 0 < < 1

For 0 < < 1 the in uence of a nite preparation time t_p becomes even more drastic, due to the absence of a characteristic time scale in the waiting time distribution. In this case $_0$ (t_p ;t) only depends on the ratio t=t_p (aging behavior):

where $_{2}F_{1}$ denotes a hypergeom etric function³¹. Consequently, the typical decay time of $_{0}$ (t_p;t) is proportional to t_p. On the other hand, D₀ (t) is given by (34) and its decay time thus scales as $= _{g}^{1} / _{0} = f^{1=} _{0} = g^{2=}$ in the limit g 1. As a consequence, the crossover cou-




FIG.7: Dephasing time in the symmetric model as a function of g for < 1 and for various values of t_p . At strong coupling the dephasing time exhibits a t_p -dependence, which disappears as increases to higher values. Note the explicit t_p -dependence of the critical coupling g_c .

pling strength g_c exhibits a strong t_p dependence:

$$g_{c}(t_{p}) = () \frac{0}{t_{p}} = 1;$$
 (40)

where () is a function of that can be obtained by inversion of (39) and (34). As in the case 1 < < 2, g_c is a decreasing function of t_p : the range of the strong coupling regime increases with the age of the noise. How ever, contrarily to the case 1 < < 2, g_c has no lower bound, i.e. it decays to zero as we increase t_p . Consequently, any qubit surrounded by a noise with 0 < < 1 will eventually end up in the strong coupling regime. This can be seen on results depicted on gure 7.

At strong coupling (g > $g_c(t_p))$, $D_{t_p}(t)$ is given by $_0$ (t_p;t) and therefore is only a function of t=t_p. In this regime, the dephasing time is proportional to t_p, as show n on g. 8. The initial decay of coherence is quite fast since, for t t_p , $_0$ (t_p ;t) 1 A () (t=t)[⊥] with A() = sin() = [(1)])]. Consequently, for close to one D_{to} (t) decays substantially for times short com pared to the preparation time $t_{\rm p}$. For t $^>~t_{\rm p}$, the decay slows down considerably and goes over to a power law $_{0}$ (t_p;t) / (t_p=t) .

At weak coupling (g < $g_c(t_p)$), the decay of D $_{t_p}(t)$ is accurately described by (34). For close to 1 and $_{g}t < 1$, the M ittag-Le er function can be approximated by a exponential decay D $_{t_p}(t) = \exp[(g_t)]$, whereas for 0 < 1 and $_{g}t < 1$, the decay is rather algebraic, D $_{t_p}(t) = [1 + (g_t)]^{-1}$. In any case, the typical decay time scales as $= g^{-1} / g^{-2e}$. As for 1 < 2, this dephasing time can be recovered using a second cumulant expansion of the phase. O byiously, for larger times, t >

, higher cum ulants contribute and the decay goes over to a power law , D $_{t_0}$ (t) / ($_0$ =t) , as shown in F ig (8).




FIG.8: Dephasing factor D $_{\rm tp}$ (t) in the symmetric model obtained by numericalLaplace inversion for $\,=\,0.8,\,t_{\rm p}=10^5$ and various values of g. For weak coupling, g < g_c ($_{\rm p}$), the decay is exponential for t < $\,$. For times t $^>$ at weak coupling and for strong coupling the decay is algebraic.

3. On the marginal case: = 1

Finally, in the marginal case = 1 corresponding to 1=f noise, the above analysis is con med qualitatively. We mainly nd logarithm ic corrections to the above results, leading to behaviors intermediate between the classes < 1 and 1 < < 2. The crossover coupling g_c in this case turns out to be

$$g_{c}(t_{p}) = \frac{0}{t_{p}} \ln (t_{p} = 0)$$
 ; (41)

showing a strong dependence on the preparation time $t_{\rm p}$. As in the case ~< 1, it decays to zero for $t_{\rm p}$! 1 .

C om puting D₀(t) requires to invert (31). This cannot be done exactly because of the complicated form of L[]' 1 s₀ jin (s₀) j for s₀ 1. However, D₀(t) may be estimated considering ln (s₀) as a constant and replacing s by 1=t in its argument. This leads to:

 for $t < \frac{0}{f} \ln f$; (42)

Hence, for weak coupling, D $_{t_p}$ (t) decays due to the contribution of D $_0$ (t) on a characteristic time scale ' ($_0$ =f) jln f j. A gain, for times large compared to the dephasing time, the decay slows down considerably and goes over to a power law (36), D $_{t_o}$ (t) / t 1 .

At strong coupling $(g > g_c(t_p))$, $D_{t_p}(t)$ follows $_0(t_p;t)$, which reads in the present case:

$$_{0}$$
 (t_p;t) ' $\frac{1}{\ln(1 + t_{p} = 0)} \ln 1 + \frac{t_{p}}{0 + t}$: (43)

Consequently, the dephasing time exhibits a strong dependence on the preparation time t_p . However, since

 $_{0}$ (tp;t) is not a function of t=tp the dephasing time does not scale linearly with tp (as for < 1) but has a weaker tp dependence which depends on the parameter used to de ne (D $_{t_{0}}$ () =).

V. DEPHASING IN THE ASYMMETRIC MODELS

In this section, we consider asymmetric distributions p(x) of the pulse amplitudes with a non-vanishing average $h = \overline{x}$. This obviously corresponds to the generic case for our intermittent noise, but it also appears naturally in the context of decoherence at optim algorithms discussed in section IIC.

Similar expansions of the exact expression (28) can be performed to derive the detailed decay of D $_{t_{n}}$ (t) in the case of a nite mean value of the noise, $\overline{x} \in 0$. Nevertheless, analytic expressions are much harder to obtain since in this case f = 1 e^{ix} is complex. Therefore, in this section, we will mainly derive scaling laws of , the critical coupling gc and present num erical com putations of D_{to} (t) in various regimes. Note that at strong coupling, the dephasing is due to single events of the noise, i.e. D $_{t_{o}}$ (t) ' $_0$ (t_p;t). As a consequence, dephasing only depends on (), not on the details of p(x). In this regime, the results reduce to those previously derived for the symmetric case (h = \overline{x} = 0) in the strong coupling regime. Dierences with respect to the symmetric case only arise in the weak coupling regime on which we shall focus in the following.

Before proceeding along, let us recall the notations (7) for the m om ents of p(x): $h = \overline{x}$ and $g^2 = \overline{x^2}$. At weak coupling, f m ay be expanded in m om ents of p(x): f

 $ih + g^2 = 2 + \dots$ As expected for h g^2 , the nite m ean value does not modify the results of the previous section, i.e. the dom inant dephasing is the same as in the h = 0 case (sym m etric noise). How ever, as h gets of the same order as g^2 the decay of D $_{t_o}$ (t) and the scaling are modied. Understanding precisely the possibly of nonlinear e ect of a small bias on the dephasing factor is related to the uctuation/dissipation issue in CTRW and is out of the scope of the present paper. Therefore we shall now focus on the case of huge asym metry where g². In this lim iting regime, the pulse dispersion can h be forgotten and h is the only coupling parameter. Note that in this specic variant of the asymmetric model, $t_{\rm t}$ (t) is proportional to the num ber of events N [$t_{\rm p}$; $t_{\rm p}$ + t] that occur between t_p and t_p + t and therefore, the dephasing factor as a function of h is the characteristic function of the probability distribution for N $[t_p; t_p + t]$. Contrarily to the case of Poissonian telegraph noise^{8,9} where a nite mean value of the noise just adds a global phase to D_{t_n} (t), we will see that strong uctuations in the occurrence tim es of the spikes induce dephasing even for a xed value of the phase pulses.

A. The 0 < < 1 class

In the 0 < < 1 case, we can use the same method as for the derivation of (34) to nd the scaling law of as a function of the coupling strength. The dephasing factor in the weak coupling regime decays as D_{to} (t) = \pm (iz)jwhere z' h(t= $_0$) = (1) and E denotes the M ittag-Le er function previously used. Using the series expansion that de nes E , it can be shown easily that \pm (iz)jonly depends on z^2 . As a consequence, the dephasing time in the weak coupling regime scales as




FIG. 9: Dephasing time in the asymmetric model as a function of the coupling g for a huge asymmetry h g^2 , and di erent values of < 1. At weak coupling, h < h $_{\rm c}$ (t $_{\rm p}$), the dephasing time scales as / 1=h^{1=}, whereas it becomes proportional to t $_{\rm p}$ for h > h $_{\rm c}$ (t $_{\rm p}$). Note the t $_{\rm p}$ -dependence of the critical coupling h $_{\rm c}$, visualized for = 0:4.

 $/_0 = h^{1=}$, as shown in Fig. 9.

The cross-over between weak and strong coupling regime is obtained by comparing this time scale with the typical decay time of $_0$ (t_p;t), which is proportional to t_p for 0 < < 1. Therefore the critical coupling strength scales as $h_{\rm c}$ / $t_{\rm p}$.




FIG.10: Decay of D $_{t_p}$ (t) in the asymmetric model for = 0.8, t_p = 10³ $_0$ and dimensional dimension of the coupling strength h. Here h_c (10³ $_0$) ' 10 $^{2:4}$

Fig. 10 shows D $_{t_o}$ (t) for = 0:8 and di erent values of the coupling strength from the weak coupling regime to slightly above h_c. The initial decay, up to the dephasing time, follows the previous exponential decay. At larger times the decay crosses over to a power law, $D_{t_{n}}$ (t) / 1=t , as in the symmetric case. Between these two asymptotic behaviors, beatings may occur, due to interferences between di erent noise histories, as already seen in other m odels²⁵. How ever, in this reference, oscillations appear in the strong coupling regime. They arise from interferences between noise histories associated with di erent initial conditions. Such a strong initial condition dependence is expected at strong coupling for a Poissonian uctuator. In our case, oscillations are also present at $t_p = 0$ in the di usion regime and therefore cannot be explained by an initial condition dependence. Nevertheless they are still associated with an interference e ect between noise histories.

To illustrate this point, let us mention that for D₀(t), a numerical investigation shows that in the situation considered here (h g^2), these oscillations are only present for > 1=2. M ore precisely, the probability distribution for the accumulated phase ₀(t) can be com - puted analytically in the di usion regime. In this lim it $_0$ (t) = hN [0;t] can be viewed as a positive real number. For 0 < < 1, its probability distribution is highly non G aussian and given by

< 1=2, it decays monotonically whereas for > 1=2, it grows towards a maximum before decreasing rapidely for large values. This maximum can be viewed as a precursor of the maximum expected for 1 < < 2 close the average value ht=h i of the phase (for 1 < < 2, P_{0,t} is a truncated Levy distribution whereas for 2 it is G aussian). It is precisely this local maximum that leads to oscillations in the modulus of the dephasing factor.

Note that these oscillations m ight be related to the G ri th e ect mentioned in ref. 32.

B. The interm ediate class 1 < < 2

In the interm ediate case of diverging variance, 1 < < 2, it is even harder to nd scaling laws analytically. Numerically, one nds that the decay time of D_{tp} (t) in the weak coupling regime scales as $/_0=h$. This leads to a critical coupling h_c (t_p) equal to the rhs of (38). At weak coupling, the decay roughly follows an exponential exp(t=) up to time softhe order of . At larger times it crosses over to a power law, D_{tp} (t) / 1=t . Again, at intermediate times and in the weak coupling regime B D_{tp} (t) shows a transcient regime. Note also that the cross-over between the weak and strong coupling regimes happens in a much larger (-dependent) range of the coupling strength than in the symmetric case.

VI. DISCUSSION AND CONCLUSION

To conclude, we have proposed a new model for an interm ittent classical noise with a 1=f power spectrum . W ithin this model, the noise consists in a succession of pulses, separated by random waiting times. We have shown within this context that the interm ittence associated with the 1=f characteristics implies a nonstationarity of the noise. Non-stationarity e ects are present in some of the regimes of the dephasing of a two level system coupled to this noise as summarized on tables I and II for the symmetric model. In particular, in the strong coupling regime, the dephasing factor decays algebraically in time, with a characteristic time of decay (dephasing time) depending on the age t_p of the noise. On the other hand, in the weak coupling regime an initial exponential decay of this dephasing factor is found. How ever, for low frequency noises and contrarily to the usual behavior, this exponential is stretched and the dephasing time shows an anom alous dependence on the coupling to the noise. A fter this initial decay, the dephasing factor decays algebraically. An important observation is that the critical coupling strength separating the weak and strong coupling regimes does depend on the age of the noise when it is non-stationary. More precisely, it decays to zero with the age, such that any qubit coupled to a non-stationary noise will eventually fall in the strong coupling regime.

One should be careful that the dephasing factor that we studied is de ned as a con guration average, or ensem ble average over the noise (see eq. (5)). In the usual experim ental protocols, inform ation on the quantum statistics of the qubit is collected in a given sample in successive runs. This corresponds to a time average in a given con guration. These two averages do not coincide in general for non-stationary or aging phenom ena. Indeed, the non-stationarity of the 1=f noise that we considered is closely related to the weak ergodicity breaking found in sim ilar trap m odels for glassy m aterials³³. Thus one should be careful in interpreting the non-stationary dephasing factor that we found in some regimes. We nevertheless hope that the questions raised by our results m ight lead to som e possible experim ental setup to better characterize the low frequency noise in m esoscopic solids.

APPENDIX A: USEFUL RESULTS ON THE SPRINKLING TIME DISTRIBUTION
