# The projection of a nonlocal mechanical system onto the irreversible generalized Langevin equation, II: Numerical simulations

The inversible generalized Langevin equation (iG LE) contains a nonstationary friction kernel that in certain lim its reduces to the G LE with space-dependent friction. For more general forms of the friction kernel, the iG LE was previously shown to be the projection of a mechanical system with a time-dependent H am iltonian. [R. Hernandez, J. Chem. Phys. 110, 7701 (1999)] In the present work, the corresponding open H am iltonian system is further explored. Numerical simulations of this mechanical system illustrate that the time dependence of the observed total energy and the correlations of the solvent force are in precise agreement with the projected iG LE.

### I. IN TRODUCTION

Several models for stochastic motion involve the Langevin and generalized Langevin equation (GLE) in so far as the environment is assumed to be in a steady-state equilibrium throughout the dynamical event, vis-a-vis the linear responding bath is stationary and obeys a uctuationtheorem .1,2,3,4,5,6,7,8,9,10,11,12,13,14,15 dissipation In recent work,<sup>16,17,18,19,20</sup> it was suggested that in many instances, the environm ent is not stationary, and as such a nonstationary version of the GLE would be desirable. In principle, it is easy to write a nonstationary GLE as

where F (t) (  $r_q V(q(t))$ ) is the external force, v (= q) is the velocity, q is the mass-weighted position, (t) is the random force due to a solvent, and  $(t;t^0)$  represents the nonstationary response of the solvent. To completely specify this system of equations, a closure connecting the random force to the friction kernel is needed. The

uctuation-dissipation relation (FDR) provides such a closure for the GLE.<sup>7</sup> An obvious generalization of the FDR for nonstationary friction kernels is the requirement,

Unfortunately, such a construction will not necessarily be satis ed for an arbitrary nonstationary friction kernel, nor will it necessarily be associated with the dynam ics of a larger mechanical system.

The GLE m odelw ith space-dependent friction (xGLE) developed by Lindenberg and cow orkers,<sup>21,22</sup> and Cameli and N itzan<sup>23</sup> does exhibit the structure of Eq. (1) and as such is an example of nonstationary stochastic dynamics. In recent work,<sup>16,17,18,19,20</sup> a generalization of this m odel was developed which includes arbitrary nonstationary changes in the strength of the friction, but like the xGLE m odel does not include changes

in the response time. As such it is not quite the ultimately desired nonstationary GLE. A voiding redundancy in the term \generalized GLE," the new form alism has been labeled the irreversible generalized Langevin equation (iGLE), thereby emphasizing the irreversibility visa-vis nonstationarity in the response of the quasi-equilibrium environment. But this \irreversibility" may not persist at long times, and therefore D rozdov and Tucker chose to call such an equation of motion them ultiple time-scale generalized Langevin equation (MTSGLE) in their application of the iGLE to study local density enhancements in supercritical uids<sup>24</sup>

In this paper, the iG LE model is rst sum marized in Sec. II, explicitly indicating the lim it in which positiondependent friction may be recovered. In earlier work,<sup>20</sup> (Paper I) it was shown that the iG LE may be obtained as a projection of an open Ham iltonian system, in analogy with the sim ilar construction for the G LE.<sup>5,25,26,27,28</sup> In Sec. II, the connections between the projection of the Ham iltonian of Paper I onto a chosen dynam ical variable and that obtained by the xG LE are further illustrated, and the possibly troubling nonlocal term it contains is also further explored. The results of several num erical simulations of the Ham iltonian system are presented in Sec. III in order to illustrate the e ect of the nonlocal term on the dynam ics, and to verify that the constructed random force does obey the FDR.

#### II. THE IGLE AND SPACE-DEPENDENT FRICTION

### A. Stochastic Dynam ics

The iG LE m ay be written as

where g(t) characterizes the irreversibility in the equilibrium environment, and there exists a FDR between the G aussian random force  $_0$  (t) and the stationary friction kernel  $_0$  (t t<sup>0</sup>). Through the identities,

the iG LE is a construction of the nonstationary Eq. (1). O ne possible interpretation of the role of g(t) in the iG LE is that it corresponds to the strength of the environm ental response as the reactive system traverses the environm ent through an a priori speci ed trajectory, call it y(t). A ssum ing that one also knows the eld f(y), which is the strength of the environm ental friction over this con-

guration space, then the irreversibility m ay be written as,

In the case that the chosen coordinate is itself the con guration space over which the friction varies | i.e., y = x | the GLE with space dependent friction of C arm eli and N itzan is form ally recovered.<sup>23</sup>

But the iGLE is more general than the xGLE because it allows for a variety of \inversible" time-dependent environments. For example, in the W iGLE model,<sup>19</sup> each particle | labeled by n | is in an environment induced by the average of the properties of itself and w neighbors,

where  $S_{w,n}$  is the set of w neighbors. In the lim it that  $w \ ! \ 0$ , the chosen coordinate is dissipated only by a function of its position, which is precisely the lim it of space-dependent friction. In the lim it that  $w \ ! \ 1$ , the chosen coordinate is instead dissipated by a macroscopic average of the motion of all the reacting systems in the sample. The contribution of a particular particle to this average is in nitesimally small, and hence the friction contains no space-dependent friction. In between these lim its, there is a balance between self-dissipation due to a space-dependent friction term, and heterogeneous dissipation due to the average of the motion of the w neighbors.

#### B. M echanical System s

In recent work, a Hamiltonian has been obtained whose projection is the iGLE when g(t) depends exclusively on time | i.e., it includes neither explicit space-dependence nor the W iGLE dependence.<sup>20</sup> This so-called

and the time dependence in q(t) is explicitly included in the de nition of the  $V_2[q();t]$  functional for clarity. Ignoring the  $V_2$  term and identifying g as in Eq. (4), this H am iltonian is similar to the xG LE H am iltonian for space-dependent friction. This result is not surprising in the sense that the iG LE has a similar generalized structure. However, the xG LE H am iltonian gives rise to an additional dependence on q whereas the iG LE H am iltonian gives rise to an additional dependence on time t. The projections are thus analogous but not exactly the same.

#### C. Equation of M otion

The nonlocality in the  $V_2[q();t]$  term does present some di culties which are worth considering. In the absence of this term, the extrem ization of the action readily leads to the usual H am ilton's equations. In general, the presence of the  $V_2$  term contributes to the time evolution of the momentum, p, by what of the functional derivative,

where the contribution to the action due to  $V_2$  may be written as




FIG.1: The square of the irreversible change in the environment  $g(t)^2$  is shown here as a function of time for the three cases exam ined in this study.

and T is the arbitrary naltime to which the action is evaluated. A simple calculation readily leads to

The rst time in the RHS precisely cancels the contribution due to the nonstationarity in the friction kernel. However, the remaining second term depends on the arbitrary naltime T. It's presence can't be physically correct because it leads to dierent dynamics depending on the choice of T. In the limit that T is near | though greater | than t, this term vanishes, how ever. This suggests that an additional approximation ignoring the second term, thereby eliminating the transient e ects from a term that depends arbitrarily on T, is warranted. (And this is consistent with the C arm eliand N itzan derivation, in that they too need to rem ove transient terms.) W ithin this approximation, the projection in Ref. 20, then leads to the iG LE.

Thus the projection of the iG LE H am iltonian leading to the iG LE with a purely time-dependent friction is analogous (& complementary) to the C armeli & N itzan projection to a G LE with space-dependent friction. The construction of such a H am iltonian for an iG LE with arbitrary nonstationary friction, as manifested in W iG LE, is still an open problem. In the next section, the dynam - ics of the iG LE H am iltonian is explored through num erical simulations in order to observe the degree of energy conservation | as it is a ected by  $V_2 |$  and the correlation of the constructed forces.

#### III. NUMERICAL RESULTS

In this section, num erical simulations of the H am iltonian equivalent of the iGLE are presented. It is shown that the inclusion of the non-local term,  $V_2$  [q();t],




FIG.2: The average correlation of the random forces on the tagged particle h (t) ( $t^0$ )i as a function of time t (solid line) for the GLE case with coupling constants calculated as in Eqn.tuckercrazy. The dashed line represents the friction kernel as calculated in Eqn.eq:freq.

known to be small in the quasi-equilibrium regime is actually necessary generally. That is, throughout this work, the value of  $V_2[q();t]$  is non-zero during the increase in system coupling. The latter is specified through the function g(t) chosen to satisfy

as illustrated in Fig. 1, or equivalently as

#### A. Coupling Constants

The values of the coupling constants in Eqn.6a can be obtained from the reverse cosine transform of Eqn.13,

is used to approximate  $_{0}e^{t=}$ . The coupling constants  $c_{i}$  in Eqn. 6a are readily obtained on a discrete (and nite) grid of N nontrivial frequencies,  $!_{i}$  i!  $_{c}$ , by equating the spectral densities of the exponential friction to that of discretization. The smallest frequency  $!_{c}$  1=M ) can be characterized in terms of the characteristic integer M which e ectively sets the longest time

scale that can be measured before false recurrences appear due to the discretization. The coe cients can be written (as, for example, also obtained by Topaler and  $M akrr^{29}$ ) as

 $1=(\mathbb{N} \cdot |_{c})$  represents the shortest time scale of interest. This connection between the continuum stationary friction kernel and the discrete number of frequencies and coupling strengths (Eq. 13) is exact in the continuum limit (N ! 1). However, M must also be large enough so as to ensure the decay in correlations between the bath m odes; typically M 4. Simulations of the GLE (with constant friction) were performed to con m a suitable number of bath particles for which convergence of the relationship in Eqn. 13 was observed. It was found that as few as 20 harm onic bath modes can yield acceptable convergence of the velocity correlation function of the chosen coordinate because its decay is much faster than the recurrence time in the bath modes. Nonetheless, to ensure that there are enough modes to approximately satisfy the continuum lim it at the longest and shortest tim es of interest while also limiting the requisite com puting power, the number of harm onic bath modes, N, used in the present work have been taken to be 200.

A lthough the coupling constants have been calculated as per Eq. 14 in the simulations of the mechanical projection of the iG LE presented in this work, it is bene cial to exam ine some other choices of the coupling constants,  $c_i$ . The main question is how to best equate the continuum (left hand side) and discrete (right hand side) representations of Eqn. 13 in the frequency domain. One alternative method is that of Tucker and cow orkers,<sup>30</sup> in which the coupling constants are obtained, not by integrating the spectral function over an in nite domain as above, but over a domain bounded by the longest time scale  $1=!_c^0$ . The resulting coe cients,

are associated with a corresponding discrete frequency  $!_i$  i! $_c^\circ$  as before, but the sm allest frequency is rede ned as  $!_c^\circ = - (p)$  for some characteristic integer p. The use of the coupling constants of Eq. 15 in the Ham iltonian representation of the GLE yields a very good m atch between the friction kernel as specified by Eqn. 13 and the correlation function for the random forces on the tagged particle as shown in Fig. 2. Unfortunately, the system still retains a long-time periodicity associated with the mode described by the largest inverse frequency. In an attempt to sidestep this issue, the chosen frequencies in the domain could be chosen incommensurably by choosing a frequency random ly within each window,  $I_i$  (fi  $1g!_c; i!_c$ ]. Given a random sequence of frequencies f!  ${}_{i}^{R}$  g in which ! ${}_{i}^{R} \ge I_i$  for each i, the coefficients

can then be re-evaluated leading to the result,

This choice of coe cients was also tested on the GLE but it led to sim ilar results for the correlation function of the projected (random) forces (t), both in terms of the accuracy and in reproducing the long-time periodicity. It was therefore determ ined that the results for the GLE (and thereby the iGLE) are not highly sensitive to the limiting form of the coupling constants so long as the choice satis es the appropriate friction kernel, while the random choice of frequencies did not remove the false long-time periodicity in the autocorrelation of the force (t).

This discussion, though som ewhat pedantic, does o er a critical warning: any numerically measured behavior in the chosen particle that is correlated for times longer than the period of the false long-time periodicity in the discrete representation is suspect to error. This, in turn, places an upper bound on the slowest time scale | viz.tg in Eq.11| that can be imposed on the nonstationary behavior of the bath coupling for a given choice of discrete oscillators in the Ham iltonian representation. In the simulations that follow, this bound is, indeed satised.

#### B. The Free Particle

The num erical equivalence between the iGLE and the Ham iltonian system of Eq. 6 can be illustrated using the same model of the nonequilibirium change in the environm ent originally investigated in the context of the phenom enologicaliG LE.<sup>16</sup> To this end, num erical results are presented for the Hamiltonian system of a tagged free particle (V (q) = 0) bilinearly coupled to a bath of 200 harm onic modes whose smallest characteristic bath frequency is  $!_c = 1 = (M)$  where M = 4. Individual bath frequencies are taken at discrete values,  $!_i = (i \quad 1=2)!_c$ , and coe cients as per Eq. 14. All other parameters have identical values to those used in the num erical integration studies of the iGLE in Ref. 16 with the exception that 100,000 trajectories were used in this study, which is a 10-fold increase. In sum mary, all simulations share the following set of parameters:  $N = 100;000; k_B T =$  $2:0; _{0} = 10:0; = 0:5; _{q} = 0:2; t = 1x10^{4} (t)$ and  $t = 1 \times 10^{3}$  (t < 8): The time dependent friction is modulated through the switching function g(t) as shown in Fig. 1. Each individual trajectory is rst equilibrated from t = 20 to ensure that the observed dynam ics are in uenced only by the irreversible change in the friction and not the dynam ics of equilibration. The system is propagated using the velocity-Verlet m ethod with




FIG.3: The mean square velocity  $hv^2$  (t) i is displayed for each of the cases as a function of time t and case I, II or III with the non-local term  $V_2$  [q();t] set equal to zero.

sm aller tim esteps during the regim e of friction increase than for the constant friction regim es. $^{31}$ 

In order to determ ine whether or not the  $V_2[q();t]$  term is negligible, simulations were rst performed with  $V_2[q();t] = 0$ . For all three cases of the change in friction, the non-local  $V_2[q();t]$  term was found to be non-negligible as can be seen in Fig. 3 by the fact that the system does not obey equipartition of energy during times near t = 0. The larger the friction increase, the larger the deviation from equipartition. This can be seen in Fig. 3 as the largest deviations are seen for case I where the switching function g(t) increases from 0 to 10. The friction increases along a similar range and the average square velocity  $hv(t)^2$  i peaks at near 8000 around t = 0.




FIG.4: The mean square velocity  $hv^2$  (t) is displayed for each of the cases as a function of time t and case I, II or III with the non-local term  $V_2[q();t]$  explicitly considered.

However, upon introducing the nontrivial terms,  $V_2[q();t]$  and its derivative (Eq. 6c), within the Ham iltonian equations of motion, equipartition for the system is preserved, as shown in Fig. 4. The  $V_2[q();t]$  term is therefore not negligible in the extreme test cases exammined in this work in which all the interesting time scales 1=0,  $t_g$ , and are comparable. Explicit integration of  $V_2[q();t]$  is computationally expensive. This expense can be reduced when the stationary friction kernelhas an exponetial form. In this case, the derivative,  $\frac{\theta - V_2[q();t]}{\theta t}$ , can be calculated using the auxiliary variable z, where

The value of  $\frac{(l V_2[q();t])}{(lt)}$  can then be obtained at each timestep,

A llofthe results shown in this paper have been calculated using the integration of the auxiliary variable z because

it is consequently form ally equivalent to the explicit integration of Eq. 6c while requiring fewer computing cycles.

As can be seen from Fig. 4, all three test cases lead to the same level of uctuations in the long time regime even though they begin from di erent initial states. In the limit of an in nite number of trajectories, all cases would exhibit no uctuations, but these uctuations due to nite size e ects are indicative of the system dynam ics. For example, in case I the particle obeys equipartition perfectly for the early regime, because its motion is ballistic, whereas the early time dynamics for cases II and III clearly show the in uence of coupling to the harm onic bath particles. It can be seen from the plot of the average square velocity that the system conserves energy in these calculations when the  $V_2[q();t]$  term is incluced. Unfortunately the addttional test for the conservation of energy cannot be com puted directly in these cases because  $V_2[q();t]$  depends on the function q(t)which cannot be known a priori.

The construction of the iGLE also requires that the correlation function of the random forces satis es a nonstationary extension of the FDR,

with respect to the explicit forces  $\ \ (t)$  on the tagged particle seen in a microscopic system ,




FIG. 5: The nonstationary friction kernel  $(t;t^0)$  in case I at several di erent times t (-4.0 thick solid line, -0.5 solid line, 0.0 dashed line, 1.0 long dashed line and 4.0 dot dashed line) as a function of the previous times t t<sup>0</sup>. The friction kernel is norm alized by the value (t;t) for illustrative and comparative purposes.




FIG. 6: The nonstationary friction kernel  $(t;t^0)$  in case II at several di erent times t (-4.0 thick solid line, -0.5 solid line, 0.0 dashed line, 1.0 long dashed line and 4.0 dot dashed line) as a function of the previous times t t<sup>0</sup>. The friction kernel is norm alized by the value (t;t) for illustrative and comparative purposes.




FIG.7: The nonstationary friction kernel  $(t;t^0)$  in case III at several di erent times t (-4.0 thick solid line, -0.5 solid line, 0.0 dashed line, 1.0 long dashed line and 4.0 dot dashed line) as a function of the previous times t t<sup>0</sup>. The friction kernel is norm alized by the value (t;t) for illustrative and comparative purposes.

That the mechanical system satis es this relationship is illustrated in Fig. 5, Fig. 6 and Fig. 7 for cases I, II and II respectively. The integral can be simplified using an auxiliary variable  $z_2$  akin to the method for replacing  $V_2[q();t]$  with z. The auxiliary variable satis es,

The explicit expression for the forces on the tagged particle can then be obtained at each timestep by substitution,

The autocorrelation function of the force due to the bath | viz., the random force in the projected variables | obey the FDR for all cases and times. It should be emphasized that this remarkable agreement would not have been found if the nonlocal term were om itted.




FIG. 8: The autocorrelation function of the velocity of the free tagged particle,  $hv(t)v(t^0)i$ , is displayed for each of the three cases of the change in friction at initial times t= (-4.0 thick solid line, -0.5 solid line, 0.0 dashed line, 1.0 long dashed line and 4.0 dot dashed line). The panels indicate cases I,II and III from top to bottom.

The velocity autocorrelation functions for the tagged free particle are shown in Fig. 8. The dynam ics of the chosen coordinate changes in the sam emanner as for the studies on the num erical integration of the iGLE. The curves match the previous results exactly with the exception that the t = 0 and t = 0.5 were m islabeled in Ref. 16. The long time (t = 4.0) autocorrelation functions

are all the same indicating that all cases reach the same equilibrium as would be expected. In case I, the early time (t= -4.0) autocorrelation function is a straight line since the particle is in the ballistic regime. All curves start at approximately 2.0 for t  $t^0 = 0$  since the system satis es equipartition.

## C. The Particle in a H arm onic Potential

The same simulations were run for a tagged particle in a harm onic well characterized by a frequency ! = 1. The results are essentially all the same with the following exceptions: The system with tagged particle in a har-




FIG. 9: The autocorrelation function of the velocity of the ham onic tagged particle,  $hv(t)v(t^0)i$ , is displayed for each of the three cases of the change in friction at initial times t= (-4.0 thick solid line, -0.5 solid line, 0.0 dashed line, 1.0 long dashed line and 4.0 dot dashed line). The panels indicate cases I,II and III from top to bottom .

m onic well is less sensitive to the increase in friction and can be simulated accurately with larger timesteps than the free particle case due to the conning elect of the harmonic well. Similarly, the system does not yield such large spikes in the average square velocity for simulations with  $V_2[q();t] = 0$ , although the explicit calculation of that term is still a necessity for accurate results. C learly the early time dynamics will dier between the free particle and harmonic particle cases as can be seen from the velocity autocorrelation functions for the harmonic tagged particle case in Fig. 9. Interestingly though, this is only the case for case I. In cases II and III the dynam – ics are essentially identical to the free particle case. This is due to the fact that the initial friction and thus the coupling is so strong (10.0 for case I and 50.0 for case II) that the tagged particle potential has an insigni cant contribution to the energy as compared to the contribution from the interaction with the bath.

# IV. CONCLUDING REMARKS

The equivalence of the stochastic iG LE and the determ inistic Ham iltonian system has been demonstrated by num erical integration of the equations of motion corresponding to the Ham iltonian in Eqn. 6a. The Ham iltonian system with 200 bath particles has been shown to exhibit equivalent dynam ics as that seen in num erical integration of the iG LE. This is expected to be the case in the in nitely large bath size regime. The equivalence is contingent upon the explicit evaluation of the non-local dissipative term which is non-zero for all the cases of interest in this study. A lthough the free particle and harm onic oscillator cases do not contain a reactant/product boundary, they should be su cient to verify the general agreem ent between the iGLE and the mechanical oscillator system. The determ inistic mechanical system serves as further evidence that the stochastic equation of motion is not purely a ction (e.g., phenom enological), but rather is equivalent to a physical system with an explicit energy function or Ham iltonian.
