Deconstruction of the K ondo E ect near the AFM -Q uantum Critical Point

The problem of a spin-1/2 m agnetic in purity near an antiferrom agnetic transition of the host lattice is shown to transform to a multichannel problem. A variety of xed points is discovered asymptotically near the AFM -critical point. Among these is a new variety of stable xed point of a multichannel K ondo problem which does not require channel isotropy. At this point K ondo screening disappears but coupling to spin- uctuations remains. Besides its intrinsic interest, the problem is an essential ingredient in the problem of quantum critical points in heavy-fermions.

Theories of quantum critical phenomena involving ferm ions rely on extensions of the theory of classical critical phenomena to quantum problem s by integrating out the ferm ions in favor of low energy bosonic uctuations [1, 2]. Several experimental results on heavy-ferm ion quantum critical points (Q C P's) are in disagreement with such theories [3, 4]. Some valiant e orts to address the problem are being made by using an extended dynamicalmean eld theory [5]. As an interesting problem in itself as well as to gain insight to the di cult problem of the lattice, we present here a system atic theory for a single impurity in a host with a diverging antiferrom agnetic (AFM) correlation length. We show below that this necessarily leads to a multi-channel problem with a variety of rem arkable properties.

The S = 1=2 localized m om ent is coupled to the host itinerant electrons, which are near an AFM instability due to electron-electron interactions, by the H am iltonian (J=2)(2) $d^{R} d^{d}k(2) d^{R} d^{d}k^{0} y_{k^{0}}$ S where k^{Y} ($_{k^{0}}$) is the creation (annihilation) operator for the itinerant electron with m om entum k (k^{0}), and S is the localized spin. D ue to the interactions am ong the host electrons, the bare K ondo vertices J are renorm alized. For a Ferm i liquid such vertex corrections lead only to a num erical renorm alization. H ow ever, qualitatively new e ects can arise due to such renorm alizations in the vicinity of a QCP in the host itinerant electrons. This problem has been solved for the case of a ferrorm agnetic instability of the itinerant electrons [6, 7]. The problem of the AFM instability is both physically and technically quite di erent.




FIG.1: Exchange interaction between the host electrons and the localized spin in the low energy e ective action. The rst line gives the complete interaction; the subsequent lines show rst few terms of the series that is sum med in each vertex in the rst line. represents the dynamical spin susceptibility of the host electrons.

In order to perform a renorm alization group (RG) procedure, we rst derive the low-energy e ective action in which the momenta of the itinerant electrons are restricted within a narrow region near the Ferm i surface, $\mathbf{J}'_k \mathbf{j} \quad W \quad (\mathbf{''}_k \text{ is the energy of the host electrons rela$ $tive to the Ferm i level). Denote _k (<math>\mathbf{y}_k$) as _< (\mathbf{y}_k) for $\mathbf{J}'_k \mathbf{j} \quad W \quad \text{otherw ise } > (\mathbf{y}_k)$, then the Ham iltonian can be expressed as H [; \mathbf{y}] = H [_<; \mathbf{y}_k] + H [_>; \mathbf{y}_k] + H 0 [<; \mathbf{y}_k ; >; \mathbf{y}_k]. E lim inating the modes for $\mathbf{J}'_k \mathbf{j} > W$ in a path-integral form ulation, we obtain the e ective action as $A_{eff} = A_{eff}^{(0)} + A_{eff}^{(cc)} + A_{eff}^{(cf)} + \dots A_{eff}^{(0)}$ describes the free parts of the e ective action, $A_{eff}^{(cc)}$ is the mutual-interaction term among the spins of the host it inerant electrons and $A_{eff}^{(cf)}$ corresponds to the e ective interaction between the host electrons and the localized spin which is represented by Fig.1:

Fig.1 presents Feynm an diagram s for $A_{eff}^{(cf)}$ in which solid and broken lines are associated with the host electron and the local m on ent respectively. The exchange couplings in $A_{eff}^{(cf)}$ has two parts: the rst term j in Fig.1 is irreducible with respect to the propagator D_{k,k^0} (!) describing the AFM spin uctuations of the host electrons, while the second part is reducible. The division into the two parts is such that g starts out as J while j starts out as O (J²), as explained through the rst few term s of the series for j, and g in the gure. g is the coupling of the spin- uctuations to the local m on ents which are always




FIG. 2: Perturbative corrections to (a) the self-energy of the local moment represented in terms of pseudo ferm ions, (b) the vertex j, and (c) the vertex g describing the coupling of the local moment to the magnetic uctuations.

coupled through electron-electron interaction vertices to the ferm ions. The vertices g, and are also irreducible with respect to the propagator $D_{k;k^0}$. = I $^>$ (k;k⁰) where I is the bare interaction among the spins of the host electrons and $^>$ (k;k⁰) is the one-interaction irreducible vertex part in the spin channel for H [>; y]. $D_{k;k^0}(!)$ is related to the dynam ical spin susceptibility $^>_{k;k^0}(!)$ of the host described by H [>; y] as

Note that even in the limit of W ! O near the QCP, $^{>}$ is not singular (while $^{>}$ is). So, we can safely neglect the dependence of on the cuto as well as the momenta, after D_{k,k} is extracted.

In the lim it that the energy cuto W ! 0, the momenta k and k^0 are restricted to be on the Ferm i surface S_F . If k is represented by its projection onto S_F denoted by K and the energy shell it belongs to " = "k, we can approximate $D_{k,k^0}(!) D_{k,k^0}(0) D$ (K; K⁰) as

where (W) is the inverse magnetic correlation length, N $_0$ is the density of states, A is a constant of the order of 1. The retardation of the interactions is properly included through a cut-o which appears through

(W) / W z , where z is the dynam ical exponent. This procedure has been explicitly justi ed in R ef.[7] where it occurs in the same context.

N ow, consider the unitary transform ation which diagonalizes D (K;K⁰) on the Ferm i surface S_F . A ssuming that the impurity sits in a site with the full point group symmetry of the lattice, the symmetry operations R of a point group G (say, C_{4v} for the d = 2 square symmetry) may be used such that it is enough to not eigenvalues of D (K;K⁰) with K restricted to an irreducible portion of the B rillouin zone, (a triangle determined by the vertices (0;0), (;0), and (;) for C_{4v} . In the whole space of the Ferm i surface, the number of degeneracies d₁ is equal to d . This general result is always true but more interesting is the generic case in which the AFM vectors Q, (assum ed commensurate [8]) connects points on the Ferm i-surface ("hot-spots" in 2-d but "hot-lines" in 3-d). In that case the problem acquires larger degeneracies.

Eq.(4) has the form of a multi-channel K ondo H am iltonian with the number of channel d_l for each l, but the interactions depend explicitly on W through .

The RG equations for Eq.(4) are now derived for any given D₁(). Fig2 presents perturbative corrections up to the third order of j and g in the successive elimination ofm odes for W⁰ < "_k W.De nea crossoverparameter W₁ rW₀; r is the distance from the QCP. For the present case of z = 2, $=_0 = \frac{1}{W} = \frac{W_0}{0}$ for W $\geq \frac{W_1}{1}$, i.e. the "quasi-classical" regime while $=_0 = \frac{1}{r}$ for W < W₁, i.e. the quantum regime. $_0$ is a constant of the order of 1. In this paper we present results only for the "quasi-classical" regime . It is also useful to introduce

(d=dt) ln $2 \left[\frac{1}{1} d_1 D_1^2 \right]$ with t = ln (W $_0$ =W). Because the imaginary part of the local spin susceptibility for the host electrons scales as Im $_{loc}(!) = 2 \left[\frac{1}{1} d_1 D_1^2 \right]$! W !, determ ines the power law of $_{loc}()$ for the long-time lim it ! 1 as $_{loc}() = 1 = 2 \left[\frac{1}{2} \right]$. Note that = (4 d)=2 for W > W $_1$, (while = 0 for W < W $_1$ as for Ferm i liquids.)

It is convenient to write the RG equations in terms of $t = \ln (_{0} =)^{2}$ and to rescale g and $D_{1} asg = g$ $_{1}d_{1}D_{1}^{2}$ and $D_{1} = D_{p} = \frac{1}{_{1}d_{1}D_{R}^{2}}$. From the de nition of , it follows that $_{1}d_{1}D_{1}^{2} = K_{,K^{0}}D(K;K^{0})^{2} / 1 = {}^{2}$.

In order to solve Eqs.(5), we must rst nd D_1 () from Eq.(3). We have done this for 2-d as well as 3-d analytically for ! 0 and checked it num erically for a range of . Fig.3 shows dependence of D_1 on obtained from num erical solutions of Eq.(3) in a 2d square lattice with circular Fermiline at half lling (the Fermiradius is 2). In this case the Ferm i surface has 8 "hot-spots", which are four pairs of points connected by the AFM wave-vector Q . In the case of C_{4v} , there exist ve irreducible representations in which d = 1 for $= A_1, A_2$, B_1 , and B_2 while d = 2 for $= E \cdot W e$ nd quite clearly that the absolute values of eight eigenvalues approach each other and A_1 , B_2 , and E (A_2 , B_1 , and E) states bunch up to constitute four-fold degenerate states with a positive (negative) value of D_1 in the limit of ! 0. From the inset it can be checked that the results are con $d_1 D_1^2 / 1 = 2$, i.e., = 1, so that $D_1 j$ sistent with diverge as 1= for all l.

The above realization of sym m etry higher than that of the underlying lattice near the QCP can be understood from a general point of view; the 2-d example is explained here. Consider a Ferm illine with N_h = 2n_h equivalent hot spots, divided into n_h pairs with one m ember of the pair connected to the other by Q. Let K_h¹ and K_h² be the vectors of two hot spots of one such pair, i.e., K_h¹ = K_h² + Q, and e_h¹ and e_h² be the unit vectors tangent to the Ferm i line at these two hot spots. If we write K = K_h + pe_h and K⁰ = K_h + p⁰e_h in which = 1 and = 2 or vice-versa near these hot spots, then the singular parts of D (K; K⁰) can be approxim ated by


where \cos_h is given by $e_h^1 p \stackrel{2}{\underline{\beta}}$. Substituting Eq.(6) into Eq.(3), and dividing it by $\frac{1}{1}d_1D_1^2 / 1$, the eigenvalues of D₁() in the limit of ! 0 can be obtained by solving the following equation:

where is 1 for = otherwise 0. If we diagonalize D(x;y) with respect to the indices and , we necessarily nd two eigenvalues of equal magnitude and opposite

sign. For N_h = 8 as in Fig.3, the hot spots are connected by the operations of C_{4v} which is the symmetry of the underlying lattice. For a special case of N_h = 4, e.g. the circular Ferm i line with the Ferm i radius \mathcal{D} j=2, the hot spots are connected by the operations of C_4 the num ber of which is 4. The num ber of degeneracies is then half of the num ber of the symmetry operations in the group of the hot spots.

Eqs.(7) and (8) suggest that for $_{\rm h}$! 0, all D₁() ! 0 as ! 0 in 2d. We have explicitly found that the num erical results are consistent with this conjecture. In this case, as we explain below, the problem eventually acquires in nite degeneracy.

The situation is actually simpler in 3d, where it follows from Eq.(3) that $\mathfrak{P}_1()$ jare less singular than ! jln j as ! $p_0 p for any 1$, while is 1=2, so that $\mathfrak{P}_1() j = \mathfrak{P}_1() = \frac{1}{2} d_1 D_1^2$ ¹⁼² jln j i.e., $D_1()$ are zero for all lin the lim it ! 0.

W ith this know ledge of $D_1()$, we return to the RG Eqs.(5) to study the xed points. It is straightforward to prove that $D_1()$ approach constants as $! 0 (dD_1=dt ! 0 \text{ as t } ! 1)$, as may also be seen in Fig.3. Therefore, it is su cient to analyze with $= D_1(0)$. There are two possibilities for the xed points of Eq.(5b). (i) g g = 0. Then, it follows from Eqs.(5) that the usual multichannel problem is realized. Due to the small channel anisotropy this is always unstable towards the single channel Ferm i-liquid xed point. On the other hand, a new class of singular or non-Fermi liquid (NFL) xed points is obtained for (ii) ${}_1 d_1 N_0^2 f_1^2 =$. Then the xed-point values of g, f_1 are solutions of the follow ing equations;

Of these NFL xed points, one in which all of $_1$ are 1 can be shown to be linearly stable. For d = 2, this stable xed point exists only when the Ferm i line is almost tangent at the hot spots to the boundary of the magnetic Brillouin zone, i.e. h! 0 (otherwise there is no solution of Eqs.(9) with $_1 = 1$ for all 1). For d = 3, this xed-point solution is always found.

W hen h ! 0 for d = 2, and d = 3, a study of the solution of Eqs.(5) reveals that the RG ow of g and j_1 is toward the single channel Ferm i-liquid xed point (i) only for large initial coupling $N_0 J >> 1$, i.e. for initial $g < < j_1$; the K ondo tem perature is so high that AFM correlations do not determ ine the xed point. For the interesting weak-coupling case N $_0$ J << 1, i.e. for initial $g >> j_1$, the RG ow is sucked into the stable one of the new class of NFL xed points (ii), i.e., the xed point of the degenerate multichannelK ondo problem with a nite g, as described below, is realized at the QCP.

For h = 0.05 with 8 hot spots in 2d, an explicit calculation of the stable xed point shows that $N_0 g j =$ 0.9205 and that $N_0 j_1 = 0.06731, 0.03895, 0.02927, :::,$ in order of size. At each value there are exactly four degenerate states in response to the enhanced degeneracy of $D_1(0)$. Thus a multiple degenerate four-channel xed point with a nite g is realized for both signs of coupling to the localized spin.

In the limit of $_{\rm h}$! 0, in 2d, i.e. the Ferm i surface tangent to the magnetic B rillouin zone, max $[\mathcal{D}_1(0)]! = 0$ with $d_1 D_1 (0)^2 = 1$. In this case, expansion of Eqs.(9) with respect to $D_1(0)$ leads us to

As shown above, for d = 3, max $[p_1()_1]! 0$ as ! 0 with $d_1D_1()^2 = 1$. Then the exotic stable xed point given by Eq.(10) always exists. So, the xed point boks like the multichannel xed point at which the number of channels is in nity.

It is important to note that channel anisotropy is irrelevant at these stable xed points for $d = \frac{2}{r^2}$ as well as d = 3. This can be proved by noting that $_1d_1N_0^2f_1^2$ and $dD_1 = dt! 0$ as t! 1. Then Eqs.(5) leads to $df_1 f_1 = f_1 f_1 (2N_0 f_1)$ =2) < 0 ast ! 1when $D_1(0) = D_{1^0}(0)$ for $1 \le 1^0$.

The other xed points given by Eqs.(9) are unstable. In the case of max $[D_1(0)_{j}]! 0$, N $_{0}^{2}g^{2} = (1)$ n = 4), $N_{0}j_{1} = = 2$ for 1 = 1, $N_{0}j_{1} = 0$ for 1 = 1, where n_+ is the number of channels for which $_1 = 1$. Since $n_{+}=4$) must be positive or zero, there exist four

(eight) unstable xed points in two (three) dimensions where = 1 (= 1=2). If is assumed to be small, these may be related to the unstable xed points of a multichannel version of the Bose-Ferm i K ondo m odel in the -expansion [9].

The di erence of the results from those for the Bose-Ferm iK ondo m odel [5, 9] are instructive. In the present work, the bosons or spin-uctuations enter the theory only as interm ediate states and not in external vertices, see Figs.1 and 2. This is the consistent formulation of the problem because the uctuations arise in the rst place due to the electron-electron interaction vertex . In Refs. [5, 9], is in plicitly included in part of the problem in de ning the uctuations but neglected in the other part, the conversion of the uctuations back to ferm ions.

The correlation functions near the xed point for W >W₁ as well as the detailed properties when approaching the xed point from $W < W_1$ will be presented in a longer paper. At this point we can only say that Eq.(10): $f_1 ! 0$ suggests a decoupling of the local moment from the conduction electrons, while a nite g at the xed point suggests that the moment responds to the AFM correlations of the host. This is what may be expected if the K ondo e ect is deconstructed such that the local m om ent is at least partially recovered and the recovered m om ent participates in the AFM correlations [10]. The in nite degeneracy at the xed point suggests that the ground state has nite entropy. This degeneracy may also be understood as the prelude to the participation of the moment in the in nite range spin-wave correlations below the AFM transition. This in nite channel xed point m ay be thought of as the analog for staggered m agnetization correlations of what happens for growing FM correlations [6], where a droplet of size 1 around the impu-^(d 1) [11]. How ever rity leads to num ber of channels / this analogy is only suggestive both because of the special condition of "hot-spots" or "hot-lines" required to get such a xed point as well as the very special second property, on f_1^2 , noted after Eq.(10) at the xed point.
