Ferm i-like behavior of weakly vibrated granular m atter

Abstract

Vertical movement of zirconia-yttria stabilized 2 mm balls is measured by a laser facility at the surface of a vibrated 3D granular matter under gravity. Realizations z(t) are measured from the top of the container by tuning the uidized gap with a 1D measurement window in the direction of the gravity. The statistics obeys a Fermi-like con gurational approach which is tested by the relation between the dispersions in amplitude and velocity. We introduce a generalized equipartition law to characterize the ensemble of particles which cannot be described in terms of a Brownian motion. The relation between global granular temperature and the external excitation frequency is established.

A vibrated granularm edium (GM) exhibits a wealth of intriguing physical properties [1, 2, 3, 4, 5]. Since energy is constantly being added to the system a nonequilibrium steady state (s.s.) is reached [6]. In [7] we have studied the spectrum properties of vibrated GM under gravity, and shown that in the weakly excited regime the dynam – ics of the uidized particles cannot be described as simple B rownian particles, this fact leads us to the conclusion that in order to describe the cooperative dissipative dynam ics of the GM particles, it must be done in terms of generalized Langevin particles [8, 9].




FIG.1: D istance m easurem ent (am plitude realizations z(t)) corresponding to 13 layer GM (h = 21 mm) with 1:99m m Z_xO_2 Y₂O₃ balls in a glass container of 30m m diameter. Set up for (a) the single particle m easurem ent and (b) the laser light barrier experiment.

Recently Hayakawa and Hong [10] introduced the approach of therm odynamics of a weakly excited granular matter, in particular vibrated GM by mapping the nonequilibrium system with a \Ferm ion like" theory. Our experimental conditions allow us to consider a N particles system of n-rows in a cylindrical container as a 1D degenerate Ferm i system . Two experiments based on a laser were set up to investigate the occupation dynam ics at the uidized gap of the n-rows GM. The rst one considers a realization z (t) of one particle from the top of the container by tuning the uidized gap with a 1D window in the gravity direction, see Fig.1 (a). It is clear that these realizations mainly correspond to macroscopic Ferm i-like particles (m Fp) from near the \Ferm i level". The second one concerns the measurement after a long integration time of the mass pro lew hich corresponds to the Ferm i-like pro le, see Fig.1 (b). By focusing on the con gurational properties of an excluded volum e theory, the s.s. mass pro le can be understood in term s of a congurational maximum principle assumption. Excluded volume interactions of the GM do not allow two grains to occupy the sam e state (gravitational energy), thus the i[≒N i!(number of congurations is W =N_i)!]. ()d = N; we get exp(N mgD =) = 1 + exp(). Therefore the zero-point \chemical potential" is $_0$ = mgD N = ; where N = is the number of balls in an elementary column of diameter D. From these considerations it is trivial to see that without vibration the centre ofmass (cm.) is characterized by $z_{cm.} = _0=2mg$ h=2. For vibrated GM the Lagrange parameter is a non-trivial function of the velocity uctuations. Before going ahead, let us denote ()/N as the cum ulative probability that the energy will be occupied in an idealGM layer at the nonequilibrium s.s. characterized by the global temperature 1 .

From () it is possible to calculate the cm. expansion as a function of , the mean energy per particle, its square dispersion ², etc. M any questions concerning the GM layer system are still open, in fact the stochastic motion of the uidized particles is not entirely known [11]. For example it is in portant to test that the spectrum of the realization S_z (f) does not behave as B row nian particles ($1=f^2$), but it has a more complex behavior, 1=f,

related to a cooperative dynam ics [7, 9]. Thus an exhaustive analysis of the realizations z (t) of these m acroscopic Ferm i-like particles should be m ade. We have m easured z (t) and we calculate the Lagrange parameter to show its complex relation to the kinetic energy.

Am plitude dispersion vs. the velocity dispersion

A sinusoidal vibration is driven by a vibration plate on the GM bed (with intensity = $A ! ^{2} = g$, where A is the am plitude, g is the acceleration of gravity, and $! = 2 f_{e}$ the frequency of the plate). The vibration apparatus is set up by an electrom agnetic shaker (T IRAV IB 5212) which allows [12] for feedback through a piezoelectric accelerom eter the control of f_e and in the range of 40g respectively. The control bop 10-7000H z, and 2 is completed by an Oscillator Lab-works SC121 and a TIRA 19/z amplier of 1kw. The n-rows GM bed set up were Z_rO₂ Y_2O_3 balls with D = 1:99mm and m = 26:8 0:1mgr, into a glass container of 30 mm of diam eter with steel bottom, see Fig.1(a). The experiments were carried out in a chamber at latm of air with 5:8 0.2gr/m³ of water vapor. The absolute hum idity was controlled by using a peltier condenser and a control loop through a therm o-hygrom eter. The hum idity is of m a pr relevance in order to control the particle-particle and particle-wall contact forces [7, 12, 13]. Under such hum idity controlled conditions, no surface convection or convection rolls were observed in the GM, nor rotational m ovem ent of the bed with respect to the container, which is typical for a content of water vapor > 10gr/m^3 .

The z(t) of one particle was followed in a window of 12mm with a laser device by using a triangulation method, see Fig.1 (a). A laser em itter with a spot of 70 m and a linear im age sensor (CCD-like array) enables a high speed measurement with 100 sec sampling. The linear in age sensing m ethod m easures the peak position values for the light spots and suppresses the perturbation of secondary peaks, which makes possible a resolution of 1 m. The shaker and the laser displacem ent sensor were placed on vibration-isolated tables to isolate them from the external vibrations, and the displacem ent sensor from the experiment vibrations. The z(t) is a measure of the variations of the distance (di erence) between the particle and the sensor around the surface of the GM bed (uidized gap). The measured z(t) without excitation reveals a white noise < 10 m. Then our set-up e ective resolution is no higher than 10 m. We have shown [7] that depending on the external excitation the z(t) can show from quasinon-erratic parabolas, for the movem ent under gravity, to realizations of larger rugosity.

The registers of z (t) were taken with a 9354C Le C roy O scilloscope of 500M Hz. The velocity V (t) = dz/dt of the m Fp was calculated numerically for t = $\frac{100 \text{ sec from } z(t)}{100 \text{ sec from } z(t)}$ registers.




FIG.2: (a) $_{z}$ vs. $_{v}^{2}$, and the corresponding trings by using vs. $_{v}^{2}$ solved from (6), or from (8) in the LT approximation. The excitation frequency was from 60 180Hz. (b) Lagrange parameter vs. $_{z}$.

fz(t);V (t)g. In Fig.2(a) we report $_z$ against $_V^2$ for xed = 10;20 and several f_e from 60-180H z for GM beds of h = 21m m and 12m m.

For weakly excited GM the displacement of the uidized particles, in the gap, can be studied from the prole (). In fact a nonequilibrium s.s. density P (= m gz), characterizing the motion of the uidized m Fp, is sustained by the input of energy from the plate colliding periodically with the GM bed; i.e., a current of particles near $_0$ | which is proportional to a gradient of () | will be balanced by the random input of m ass coming from the periodic m ovem ent of the plate. It is clear that P () will be a narrow density around $_0$; so we characterize the m ovem ent of the m Fp at the Ferm i-like sea by

At the nonequilibrium s.s. the dispersion $_z$ can be calculated from P (= m gz), but a rather simple and analytical expression for a characteristic length scale z can be obtained by solving from the following consideration

where q is a \cum ulant" parameter. If P () were G aussian the value q = 1 = e w ould give the exact dispersion = +. We have tested that our conclusions are not changed for values q 1 = e. Using () in the expression for P () we get for the characteristic scale

where $A = e^{\circ}$, then by putting $q = 1 = e^{\circ}$ in (3) it gives the amplitude dispersion z = -m g as a function of :Now the task is to determ ine as a function of the kinetic energy of the m Fp in the uidized gap.

If collisions were elastic, in a 1D ideal gas the equipartition theorem says that total kinetic energy per particle is related to the Lagrange parameter by m $_{\rm V}^2 = 2 = 1 = 2$: O ur conjecture for a weakly excited GM is to generalize the equipartition law to

where m = m accounts for inelastic factors, and N/N is a relative factor that counts the therm odynam ically \active" mFp in the uidized gap. In fact, a granular gas since its non-G aussian velocity distribution reveals an inelastic gas heated in a non-uniform way, with the expected high energy tail e ^{constantV 3=2}.

The factor N/N can be calculated from

Note that in the high temperature limit $_0$ 1 and for the elastic case = 1 we recover the equipartition theorem. This situation is just what we have found experimentally for one steel ball in a narrow glass cylinder [7]. In that experiment, when we compared the relation $_z$ vs. $_v^2$, we reduced the dissipation during the vibration and assured that there is no rotation of the ball during its movement z (t), then from energetic considerations: mg $_z = \frac{1}{2}m_v^2$, predicting a line with slope 1=2g. The opposite situation is in the limit $_0$ 1; in this case we arrive at the Low Temperature (LT) scaling.

D ue to the fact that dissipation and degrees of freedom are functions of the external param eters, we expect that the analysis of the complex behavior of vibrated GM will be enlightened from the study of $z = z \frac{2}{v}$: Thus an important point would be to test experimentally our theoretical predictions. Noting that z = z = -mg it is simple to see that at LT (3) gives

Thus we got an explicit LT formula $z = z \frac{2}{v}$ as a function of the dissipative parameter , which in fact is a function of the external parameters and f_e. In Fig.2(a) we report the measurement of z against $\frac{2}{v}$ for two experimental studies of a GM bed with h = 21and h = 12 mm at = 10 and = 20 respectively, forseveral f_e from 60-180Hz. In that gure we also show the twith our theoretical prediction (resolved per least squares) showing a very good agreem ent for 0:0009 and 0.0064 (= 10 and = 20 respectively). In Fig.2(b) we show the corresponding against $_z$, where the f g data set were calculated from the f $_{\rm V}$ g experim ental data set for the two experim ental studies, using (7). By considering the mass of the Z_rO_2 Y_2O_3 ball and 1 = e, we represent in F ig 2 (b) the log-log plot of the q equation (8), show ing an excellent agreem ent between the experimental data and our theory. The two experimentaldata sets are on the same curve due to the fact that we use for the two experiments the same Z_rO_2 Y₂O₃ balls. Note that if all stochastic realizations could be understood in term s of a B row nian oscillating m ovem ent around ₀, the P (z) would correspond to exp z²C

¹ proportional to the tem perwith C a constant and ature. Then we would have obtained $_{\rm z}$ / $^{1=2}$ which is not the case reported experim entally in Fig 2 (b). Here we point out that in order to describe the spectrum of the uidized particles we should use a non-Markovian description [7]. Unfortunately we still do not have a tim edependent statistical description for the m Fp. G lobal tem perature against the external excitation. Eq.(7) is the LT approximation of our generalized equipartition theorem for a GM experiment out of equilibrium . Now we would like to nd a relation between the Lagrange param eter and the external param eters characterizing the input of energy. The maximum kinetic energy, per particle, transferred by the oscillating plate must be proportional to the e ective m assm and the dim ension less velocity $A! / \frac{r}{gd}$, on the other hand the maximum potential energy related to the uidized gap is proportional to the variation of the cm. at the global tem perature 1 . Thus we get the relation




FIG.3: C om parison of the two experiments for a G M bed of h = 21m m under an acceleration = 10. (a) the Lagrange parameter (f_e) by measuring the realizations z (t) from the top of the container. (b) pro le (z)/N integrated from the laser light barrier during 3h corresponding to = 4:4 0.2 J¹ for f_e = 100H z, and = 10:5 0.5 J¹ for f_e = 125H z.

U sing the relation $A ! = g/2 f_e$ we can transform (11) in terms of the variables that we have xed in our experiment. From these considerations it is trivial to see that for a given intensity and increasing frequency $f_e ! 1$ the \temperature"! 0, (i.e.; $\frac{2}{z}$! 0 and z_{cm} ! h=2). In Fig.3 (a) we present the behavior of the global temperature as a function of the excitation frequency, showing an agreement with our theoretical prediction. In

Fig.3(a) a least squares thing is also shown giving a slope of 0.06 J¹s, while (11) gives 0.09 J¹s. The dispersion in Fig.3(a) is mainly introduced by the numerical calculation of dz=dt. The nonequilibrium s.s. Ferm i-like pro le. We have remarked that the pro le

()/N gives the probability that the energy will be occupied in an idealGM layer at the nonequilibrium s.s. characterized by the global temperature 1 . Note that (= m gz)/N decreases monotonically with z from 1 to

0. In fact we can write ()/N as a cum ulative probability ()/N = 1 $_0$ (°) d°, and interpret the density () as associated to the uidized gap. We write the s.s. mass pro leas

To measure the pro le (12) we have im plemented a second experiment on a GM bed (h = 21mm) with a laser light barrier of 10mm wide, Fig.1 (b). The voltage signal from the position sensitive detector runs from 0 to 10V, which means a vertical window from 10mm to 0mm.We take m easurem ents every 3s during 3h, where the norm alized frequency count integrated from such a register is equal to the occupation number /N for z ₀=m q /N for z < $_0$ =m g. At a xed f_e and for and to 1 = 10 two registers were obtained for $f_e = 100$ Hz and $f_e = 125H z$, which were integrated and norm alized to get the corresponding prole (z)=N. In Fig.3(b) we show the pro le and our theoretical prediction (12). From this data we obtain the values = 4:4 0.2 J¹ for $f_e = 100 H z$, and $= 10.5 0.5 J^1$ for $f_e = 125 H z$, that we compare with the results of the rst experiment Fig.3(a). Not only the agreem ent is good, but also this procedure allows a self-consistent test.

D iscussion. In Fig.2 (a) we show the amplitude dispersion $_z$ against the velocity squared dispersion $_v^2$ of the realizations z (t). For weak amplitude the slope $_v^2$ $_z$ shows a linear behavior and the departure from a linear behavior is a clear evidence of the complex behavior of the GM bed. This indicates that for this regime it is necessary to introduce a description in terms of our theory.

The corresponding global tem perature $(k_B)^1$ for a undized gap to occur happens to be at T = 92 0.5 10^{15} K, which means $f_e = 130$ Hz for = 10, see the transition in Fig.3(a). Feitosa et al. measure for a dilute granular gas a range of tem peratures of the order of T 500PK (Peta Kelvin, see Fig.5 of Ref. 5]). This range is higher than our measurements, however it is in agreem ent with them since our corresponds to a weakly uidized GM.From [7] we know that the movement of the mFp when the uidized gap appears can be approximated by a Brownian motion, but this description changes to a more complex stochastic behavior by decreasing f_{e} (for xed) when the tem perature reaches Т 15PK. This global tem perature should be understood, indeed, as equivalent to an order param eter of the stochastic process in the energy con guration. We remark that around the uidization transition where the stochastic dynamics start to apply dz/dt occurs with larger rugosity. Then a proper description in term sofdifferentiable realizations z(t) is well de ned in the weakly excited region (T > 9PK) where the dynam ics start to be non-M arkovian. For lowertern peratures (T < 9PK) despite of the larger rugosity of realizations z (t); the calculation of $\frac{2}{v}$ from a time-window of 2 second makes it reliable. This num erical calculation only introduces, for such range, a larger dispersion of the data in the curve of Fig2(b), but again in good agreem ent with the equation (8).
