Quantum States of Neutrons in Magnetic Thin Films

We have studied experimentally and theoretically the interaction of polarized neutrons with magnetic thin Im s and magnetic multilayers. In particular, we have analyzed the behavior of the critical edges for total external rejection in both cases. For a single Im we have observed experimentally and theoretically a simple behavior: the critical edges remain is xed and the intensity varies according to the angle between the polarization axis and the magnetization vector inside the Im. For the multilayer case we indicate the critical edges for spin up and spin down polarized neutrons move towards each other as a function of the angle between the magnetization vectors in adjacent ferromagnetic Im s. A lthough the results for multilayers and single thick layers appear to be diment, in fact the same spinor method explains both results. An interpretation of the critical edges behavior for the multilyers as a superposition of ferrom agnetic and anti erom agnetic states is given.

IN TRODUCTION

Neutron re ectivity goes back to 1946 when it was rst used by Fermi and Zinn for the determination of coherent scattering lengths [1]. Subsequently inserting a polarizer and analyzer to produce a polarized neutron beam, Hughes and Burgy started to perform polarized neutron experiments as early as 1951 [2]. It was foreseen by the authors of this work that beam s of com pletely polarized neutrons will be useful in the study of magnetic and nuclear properties. The next major achievement of Polarized Neutron Re ectometry (PNR) was the prediction of spin- ip re ectivity by Ignatovich (1978) [3] and the pioneering experim ents on m agnetic surfaces by Felcher (1981) [4]. While specular PNR is widely recognized as a powerful tool for the investigation of magnetization pro les in magnetic heterostructures [5], the description of o -specular scattering from magnetic domains is still under development [8]. In spite of these in portant developm ents there is still a confusion concerning the quantum states of neutrons in a magnetic sample. Here we show unam biguously that the neutron has to be treated as a spin 1/2 particle [6, 7] in each hom ogeneous m agnetic layer. This is at variance with the conventional description of neutron re ectivity, which often considers the neutron magnetic potential as a classical dot product [9, 10, 11, 12].

Neutrons interact with a magnetic thin $\,$ lm via the Ferm i nuclear potential and via the magnetic induction. Thus, the neutron - lm interaction ham iltonian includes both contributions: V = $V_n + V_m$ = (\sim^2 =2m)4 N b B, where m is the neutron mass, N is the particle density of the material, b is the coherent scattering length, j j is the magnetic moment of the neutron, and β j is the magnetic induction of the $\,$ lm . Unconventionally, how -

ever, neutron re ectivity treats the dot product between the magnetic induction and neutron magnetic moment classically: $V_m = B = j j \beta j \cos()$, where is the angle between the incoming neutron polarization direction and the direction of the magnetization inside the lm. W riting the magnetic potential as a classical dot product implies that the neutron energies in the magnetic layer have a continuous distribution from -j j \beta j to + j j \beta j. This predicts that the critical angle for total re ection depends on the angle between the direction of polarization and the direction of the magnetic eld inside the layer:

where is the glancing angle to the surface, is the wavelength of the neutrons, and Q_c is the critical scattering vector. There are experimental data [11, 13] on magnetic multilayers which apparently con rm this behavior. Therefore, the classical representation appears to provide a convenient and transparent way to describe the experimental observations [9, 10, 11, 12].

From the Stem-Gerlach experiment we know that there are only two eigen states for the spin 1/2 particles in a magnetic eld. Therefore, the eigen wave number of a neutron in a magnetic thin Im has two proper values. A fler solving the Schrödinger equation one obtains two eigen wave numbers for neutrons in a magnetic Im: $k^2 = \frac{2m}{r^2} (N_n j jB)$. They correspond to two possible states of spin orientation: one for the case, when the spin is parallel to the magnetic induction, and the other one for the antiparallel orientation. It follows that there are only two possible energies and consequently only two values for the index of refraction corresponding to the spin-up and spin-down states of the neutrons. Therefore,

QM predicts that there are only two critical angles for the total re ection: one corresponding to the R^+ and one to the R^- re ectivity

O byiously there is a contradiction between the quantum m echanical prediction (Eq2) and the prediction based on the classical representation of the m agnetic potential (Eq.1): quantum m echanics predicts that the spin states of the neutron is determ ined by the m agnetic induction in the sample, whereas classical representation of the m agnetic potential, supported by experiments on m agnetic multilayers, assert that the spin states of the neutrons is xed by the incident polarization axis.

Here we describe an experiment which provides direct and unam biguous evidence for the spin states of neutrons in magnetic media. The goal is to nd a system where the angle between the neutron polarization and direction of the magnetization inside of the lm can be xed and controlled. Then we measure the R⁺ and R re ectivities and determ ine whether the position of the critical edges changes as a function of the angle, or whether the critical edges stay xed, and only intensity redistributes between relections R^+ and R^- with change of . The easiest way to control the angle is to rotate the magnetic lm and therefore the magnetization direction with respect to the neutron spin polarization, which remains xed in space outside of the sample. This requires that the lm should have a high rem anentm agnetization. A dditionally, the Im thickness should exceed the average neutron penetration depth [15]. The last requirement is essential in order to avoid neutron tunnelling e ects which will hinder the precise determ ination of the criticaledges.

SAM PLE CHARACTERIZATION BY MOKE AND PNR




FIG.1: Bottom: hysteresis loop of the polycrystalline Fe/Si sam ple m easured by MOKE.Top: the behavior of the rem anent m agnetization as a function of the rotation angle extracted from hysteresis loops.

To ful 11 the aforem entioned requirem ents, we have chosen a 100 nm thick polycrystalline Fe lm deposited by rf-sputtering on a Si substrate. The thickness of the Fe lm s was about 4 times larger than the average penetration depth 1= $2m V_N = 2$. The Fe lm was covered with thin Co and CoO layers, the latter one protecting the Fe lm from oxidation. For sample characterization at room temperature we rst recorded hysteresis loops with the magneto-optical Kerre ect (MOKE). A series of hysteresis loops were taken with the eld parallel to the Im plane but with dierent azim uth angles of the sample. A typical hysteresis loop is shown in Fig. 1. The coercive eld is about 20 0 e and the rem anence is high. A plot of the ratio between the rem anent m agnetization and saturation magnetization M $_{\rm rem}$ =M $_{\rm sat}$ versus the rotation angle about the sample norm al is shown in




FIG.2: (Color online). Top: Polarized neutron re ectivity curves R^+ (solid black circles) and R (open black circles) of the Fe/Si sample. The black line is the simulated R^+ reectivity and the red (light gray) line is the simulated R re ectivity. The applied magnetic eld was 2000 O e. In the inset, the magnetic pro le obtained from tting the data is shown. Bottom : Experimental (open black sym bols) and simulated (black line) spin asymmetry ($(R^+ R^-)=(R^+ + R^-)$) are plotted for the same sample in saturation. All lines in the top and bottom panels are ts to the data points using the GMM (for more details see text). The abscissa is the wave vector transfer: Q = 4 sin ()=.

Fig.1.W e conclude that the system has no macroscopic anisotropy and the remanent magnetization is 97.5% of the saturation magnetization.

Neutron re ectivity experiments were performed using the angle dispersive neutron re ectometer ADAM installed at the Institut Laue-Langevin, Grenoble, which operates at a xed wavelength of 4.41 A. The R⁺ and R re ectivities and the spin asymmetry $(R^+ - R^-)/(R^+ + R^-)$ in a saturation eld of 2000 Oe are plotted in the top and bottom panel, respectively, of Fig. 2. The solid lines are to the data points using the PolarF it code based on the general matrix method (GMM) [7]. The t and sample parameters are listed in Table I. In order to obtain a high con dence of the t parameters, all re ectivities were ttted together and with the same parameter set. In general it is useful to t rst the spin asymmetry, for which geometrical and normalization parameters drop out.

TABLE I: Param eters of the Fe/Sisam ple obtained by tting to the R⁺ an R data shown in Fig 2. d is the layer thickness, is the rm s roughness, SLD is the scattering length density, and B is the magnetic induction in the ferrom agnetic lm s.

From Table I and the magnetic characterization (Fig.1) we conclude that the sample fulls the requirements as concerns thickness, anisotropy, and remanence as required for our experiment.




FIG. 3: (Color online). Experimental (symbols) and simulated (lines) re ectivity curves (R^+ and R^-) from Fe(1000 A)/Si sample. The abscissa is the wave-vector transfer. The two sets of R^+ (solid black symbols) and R^- (open black symbols) re ectivity curves were measured for four di erent angles between the neutron polarization along B₀ and the direction of the magnetic induction (B) which lies in the sample plane. The guiding eld is B₀ 10 0 e. The blue (thick dark gray) lines are the simulated R^+ re ectivities and the red (thin light gray) lines are the simulated R^- re ectivities. In the right side the experimental geometry is shown. The gure shows that the critical edges Q_{+}^{+} and Q_{-}° are not sensitive to the angle.

ROTATION EXPERIMENT

The rotation experiment was performed as follows: the Fe layer was magnetized parallel to the neutron polarization direction and then the magnet was removed. A small guiding eld (H_c) is still present at the sample position in order to maintain the neutron polarization. Subsequently a series of R^+ and R^- re ectivities, shown in Fig. 3, were measured for several in-plane rotation angles of the sample. We observe two characteristics of the

re ectivities: (1) the critical edges are xed and independent of the in-plane rotation angle (see Eq. 2), and (2) the R intensity continuously increases at the expense of the R^+ intensity as a function of the angle. Using the parameters obtained from the t to the saturation data (see Table I) and using the rotation angle as set during the experiment, we have simulated [14] the re ectivities using the GM M approach [7] which transparently predicts the behavior of the critical edges described by Eq.2. The simulated curves are plotted together with the experimental data in Fig.3. There are no free parameters for these simulations, providing an excellent description of the experimental results. The xed critical edges Q_+^c and Q^c can easily be interpreted in the context of the neutron spin states in homogenous magnetic media as discussed in the introduction.

EXPERIMENTAL DETERMINATION OF MAGNETIZATION ORIENTATION

The sensitivity to the in-plane rotation angle of the magnetization is seen very clearly seen in the rejected intensities R^+ and R_- plotted in Fig. 3. It has been shown theoretically [16] that, for a single magnetic layer, the normalized spin asymmetry (nSA()) is directly related to the angle through the following expression:

$$nSA() = \frac{SA()}{SA(0)} = \cos()$$




FIG.4: (Cobronline). Solid black sym bols: The experimental normalized spin asymmetries (nSA () = SA ()=(SA (0))), plotted as a function of the wave-vector transfer Q.Lines: The three lines are the cosines of the corresponding angles set during the experiment. From top: cosine of 48 (thin gray (red) line), 68 (thick gray (blue) line), and 88 (thin black line), respectively. The angles are the experimental rotation angles

Now, we use our experim ental data shown in Fig. 3 to con m the validity of this equation. In Fig. 4 is shown the experim ental norm alized spin asymmetry and the cosine of the experim ental angles. The agreem ent between the experim ental norm alized spin asymmetry (symbols) and the cosine of the angles (lines) set during the experim ent is excellent over the whole wave vector transfer range. It follows that the magnetization orientation of a single magnetic layer with respect to the neutron polarization outside the layer can be easily extracted experimentally using Eq. 3. For more complicated systems a numerical tting is still necessary. The nSA is an important measure of hysteresis loops. It was shown in Ref. [16] that nSA can be written, generally, as: $nSA = M_{ii} = M_{sat}$ for both, magnetization reversal via coherent rotation and via dom ain wall movem ent. This implies that nSA reproduces the hysteresis loops as measured by SQUID or MOKE. Here we con m the validity of the nSA for determ ining the magnetization reversal via coherent rotation. W e m ention that this equation is valid for samples which contain a single magnetic layer. Comparing MOKE or SQUID hysteresis loops with nSA is a very useful tool for the evaluation of magnetic domain state and/or a reduced magnetization within the layer.

M U LT ILAYERS

O urnext topic is to investigate the neutron spin states in multilayers with noncollinear magnetization of adjacent layers. We simulated the re ectivity prole of a $[Fe(60A)/Cr(8A)]_{40}/Si$ superlattice, with thicknesses of the Fe and Cr layers which are typical for many real superlattices [13]. For the simulation we used the freeware code PolarSim [14] based on GMM for the calcula-

used during the experiment shown in Fig.3. The experimental normalized spin asymmetries are assembled from the R^+ and R^- rectivities shown in Fig 3. This gure shows that the equation nSA () = cos() is valid over the whole Q range for a single magnetic layer. It can be used to extract the angle directly from the experimental rectivities.

tion of the relection and transmission coe cient together with a full quantum mechanical description of the spin states [7]. In the simulation the choice of a Si substrate has the advantage that it does not obscure the critical edge of the (-) neutron state. In the top panel of F ig. 5 we show simulations of R⁺ and R re ectivities for three angles between the magnetization vectors of adjacent Fe Im s: = 0 (or ferrom agnetic alignment); = 100; and = 170 (close to antiferrom agnetic alignment). Our focus is on the behavior of the critical scattering vector for total re ection. We observe that for = 0 the (+) and (-) critical scattering vectors are well separated and that they contain inform ation about the saturation m agnetization. W hen the value increases, the critical edges approach each other. For an angle = 180 (not shown here) there is no di erence between the R+ and R-re ectivities. The main result from this simulation is the observation that the separation of the critical edges is a continuous function of the angle between the inplane adjacent m agnetization vectors. The critical edge positions satisfy the following relation:

$$\frac{4 \sin(c_{c})}{m} = Q_{c} = \frac{r}{\frac{2m}{c^{2}}} (V_{n}^{eff} j jB_{s} j \infty s(=2));$$

where V_n^{eff} is an elective nuclear potential. C learly, for this geometry the angles and =2 coincide if the neutron polarization is parallel to the average eld (B₁ + B₂)=2, where B₁ and B₂ are the magnetic eld inductions of adjacent layers. Therefore, numerically, the eqs. 1 and 3 are alm ost identical. However, there is a fundamental di erence: similarly to the single layer, the angle does not in unce the position of critical edges, whereas the

angle is solely responsible for the continuous shift.




FIG.5: (Coloronline). Top: Simulation of polarized neutron re ectivities \mathbb{R}^+ (dashed lines, shifting from right to left), R (solid lines, shifting from left to right)] for a Fe/Crmultilayer as a function of coupling angle () between the magnetization vectors of adjacent Fe layers. Bottom: Simulations of \mathbb{R}^+ (solid lines, shifting from top down) and R (dashed lines, shifting from bottom up) as a function of rotation angle for = 90

To shed more light on how the and angles a ect the critical edges for polarized neutron re ectivity at the multilayers we simulated numerically the rotation experiment performed on the single layer. For a xed coupling angle of = 90, as it can be achieved also experimentally via biquadratic exchange coupling, the re ectivities R^+ and R are plotted as a function of the angle. Here the

angle is the angle between the incoming neutron polarization and the direction of the average magnetization vector of two adjacent ferrom agnetic layers. The results are shown in the bottom panel of Fig. 5. We observe a sim ilar behavior of the critical edges and intensities as for the single layer. W hile the positions of the critical scattering vectors Q_{+}^{c} and Q_{-}^{c} remain xed for a constant coupling angle, the R intensity increases on the expense of the R⁺ intensity with increasing angle. With this simulations we lift the contradiction stated in the introduction by showing that Eq.1 is a particular case of Eq. 4, which, in turn, is in agreement with the QM description of the neutron spin states in magnetic media Eq. 2. The di erent behaviors of the critical edges for the case of a single hom ogeneous ferrom agnetic layer and for a multilayer with alternating directions of the layer m agnetization vectors now becom es obvious: in the multilayer the neutrons are a ected by an average magnetic potential which depends on the relative orientation of the m agnetic induction in the individual layers. How ever, in both cases, single Im as well as multilayer, the magnetic potential of the individual layers $(V_m = j j B_s)$ enters the algorithm for calculating the re ectivities.

It should be noted that the dependence of Q_{+}^{c} and Q^{c} on the angle in a multilayer is a general property of the periodic potential with di erent eld orientation and m agnitude. It is natural to expect that such a sam ple is a noncollinear ferrim agnet with ferrom agnetic eld B_f = (B₁ + B₂)=2,

$$B_{f} = \frac{1}{2}B_{1} + B_{2} = B \cos(=2);$$

and with antiferrom agnetic eld $B_{af} = (B_1 \quad B_2)=2$,

$$B_{af} = \frac{1}{3}B_1 \quad B_2 = B \sin(=2)$$
: (6)

Then, the critical edges can be expected to be given by Eq.4.

To further stress the origin of the elective nuclear potential V_n^{eff} term in Eq. 4., let us consider the critical edge for non-polarized neutrons when scattered at a Fe(x

A)/Cr(y A))] multilayer. Naively, we may expect that the critical edge to be given by the Ferm i interaction potential of Fe as it is higher than the potential of Cr. This is, how ever, not the case. For a nite thickness x of the Fe layer and zero thick Cr layer, indeed the critical edge is equal to the critical edge of a single thick Fe layer. V ice versa, for zero thickness of Fe layer and nite thickness y for the Cr layer the critical edge is given by the Ferm i potential of Cr. How ever, when both layers have nite thicknesses the critical edge of the multilayer w ill vary from the value for pure Fe to the value for pure Cr. Therefore, the critical edge for non-polarized neutrons reected from a multilayer not only depends on the Ferm i potential of the two separate layers, but also on their individual thicknesses.

CONCLUSIONS

In sum m ary, we have analyzed the behavior of the criticalscattering vectors Q_{+}^{c} and Q_{-}^{c} for total external rection of a polarized neutron beam for the case of hom ogeneous ferrom agnetic Im s and for antiferrom agnetically coupled multilayers. For a single lm we have observed experimentally and shown theoretically that the critical edges do not change as a function of the angle between the neutron polarization and the direction of the magnetic spins inside the lm. They ful llthe relation Eq.2: $\frac{2m}{2}$ (V_n $j j \beta_s j$, which directly rejects the Q spin states of the neutron beam in magnetic thin lms. For multilayers we found that the critical edges for total external re ection m ove tow ards each other as a function of the coupling angle. Their position is well reproduced $\frac{2m}{r^2}$ (V_n^{eff} j j β_s jcos(=2)). by the Eq.4: Q_c = The cos(=2) dependence is not related to the neutron spin states in the magnetic media, but it is the result of the presence of a ferrom agnetic eld direction along the average eld in the noncollinear ferrin agnetic. By choosing a xed coupling angle between the magnetization vectors of adjacent layers and rotating the sample, the critical edges behave again in accordance with the neutron spin states in hom ogeneous magnetic media. Practically, the coupling angle in non-collinear superlattices can be inferred directly from the experim ental data through the separation of the critical edges. For a single layer the orientation of the magnetization can be extracted experim entally from the spin asymmetry.
