GENERALIZING THE PLANCK DISTRIBUTION

A long the lines of nonextensive statistical mechanics, based on the entropy $S_q = k (1 i_1 p_1^q) = (q-1) (S_1 = k i_1 p_1 \ln p_1)$, and Beck-Cohen superstatistics, we heuristically generalize P lanck's statistical law for the black-body radiation. The procedure is based on the discussion of the di-erential equation $dy = dx = a_1 y (a_q a_1) y^q$ (with y(0) = 1), whose q = 2 particular case leads to the celebrated law, as originally shown by P lanck him self in his O ctober 1900 paper. A lthough the present generalization is mathematically simple and elegant, we have unfortunately no physical application of it at the present moment. It opens nevertheless the door to a type of approach that might be of some interest in more complex, possibly out-of-equilibrium, phenomena.

We normally obtain the statistical mechanical equilibrium distribution by optim izing, under appropriate constraints, an entropic functional, namely the Boltzmann-Gibbs (BG) entropy $S_{BG} = k_i^- p_i \ln p_i$. The success and elegance of this variational method are unquestioned. But at least one more possibility exists, namely through dierential equations. Such a path is virtually never followed. Indeed, such an approach might seem quite bizarre at rst sight. But we should by no means overlook that it has at least one distinguished predecessor: Planck's law for the black-body radiation. Indeed, P lanck published two papers on the subject in 1900. The rst one in October, the second one in December 1. The bases of both of them were considered at the time as totally heuristic ones, although kind of dierent in nature. The second paper might be considered as a primitive form of what has now become the standard approach to statistical mechanics, based on the optim ization of an entropy functional, the connection with Bose-E instein statistics, and, ultim ately, with the Boltzm ann-Gibbs therm altheory for a quantum harm onic oscillator². The st paper³, however, is totally based on sin ple arguments regarding an ordinary di erential equation. It is along this line that the present paper 2

is constructed.

If $S_{B,G}$ is extrem ized under appropriate constraints, we obtain the fam ous BG weight $p(E) = p(0)e^{-E}$. This distribution can be seen as the solution of the differential equation dp=dE = p. Since m ore than one decade, a lot of e ort is being dedicated to the study of the so called \(\)\nonextensive statistical mechanics", based on the generalized entropy $S_q = k(1 \quad _i p_i^q) = (q \quad 1) \ (S_1 = S_{BG})^4$ (for a review, see 5). The extrem ization of this entropy under appropriate constraints yields $p(E) = p(0)e_q^{-E}$, where $e_q^x = [1 + (1 \quad q)x]^{1=(1 \quad q)} \ (e_1^x = e^x)$. This distribution, which has been shown to emerge in many natural and articial systems 5 , can be seen as the solution of the differential equation $d[p=p(0)] = dE = [p=p(0)]^q$. As a next step, we may consider even more complex systems, namely those which exhibit, for increasing E, a crossover from nonextensive to BG statistics. Such appears to be the case of cosmic rays 6 . Such situations can be handled with a differential equation which uniferential equation which uniferential equations to one set as follows:

Excepting for the fact that here q m ay be noninteger, this dierential equation is a particular case of Bernoulli's dierential equation. Its solution is given by

which precisely exhibits the desired crossover for q>1 and $0<_1<<_q$. Indeed, for $(q-1)_1E<<1$ we have that p=p(0) $-e_q^{-qE}$, whereas, for $(q-1)_1E>>1$, we have p/e $^{-1E}$.

In the lim it $_{\rm q}$ = $_{\rm 1}$! 1 and p(0) $_{\rm 1}$ = $_{\rm q}$! C, where C is a constant, Eq. (2) becomes

which, for q = 2, becomes

$$p(E) = \frac{C}{e^{-1}E}$$

If we multiply this statistical weight by the photon density of states g (E) / E 2 and by the energy E , we have the celebrated frequency spectral density

where we have identified $_1$! $1=k_B$ T and E! h. It is in this precise sense that Eq. (3) (hence Eq. (2)) can be seen as a generalization of Planck statistics.

For q > 1, Eq. (3) can be written as




Figure 1. Degeneracy d(n;q) as function of q(n=0;1;2;3); q=2 corresponds to Planck law.

(x) being the G am m a function. W e m ay now follow P lanck's path in his D ecem ber 1900 paper, where he introduced the discretization of energy that eventually led to the formulation of quantum mechanics. Consistently, we may interpret E_n as a discretized energy and d(n;q) as its degeneracy. We see that, 8q>1, the spectrum is made of equidistant levels, like that of the quantum one-dimensional harmonic oscillator. The situation is de nitively dierent in what concerns the degeneracy (see Fig. 1). Only for q=2 we have the remarkable property d(n;2)=1 (8n), which recovers the harmonic oscillator problem.

At this point, let us em phasize that any therm ostatistical weight (that of thermal equilibrium for instance) rejects the microscopic dynamics of the system. This

fact was addressed by E instein in 1910 7 , and was recently revisited by several authors (see 8 , for instance). It was shown also, on quite general grounds, in 9 . In the same vein, a dynamical theory of weakly coupled harmonic oscillators system was recently used for deducing the functional relation between energy variance and mean energy that was conjectured by E instein in connection with Planck's formula, thus exhibiting that it is a consequence of pure dynamics 10 . It is within this dynamical interpretation that Beck and Cohen introduced their superstatistics 11 . Indeed, nonequilibrium systems might exhibit spatio-temporal uctuations of intensive quantities, e.g., the temperature. They assumed then that the inverse temperature might itself be a stochastic variable, such that the generalized distribution of energy is expressed as

where the distribution f() satis es $\frac{R_1}{0}$ d f() = 1: The elective statistical mechanics of such systems depends on the statistical properties of the uctuations of the tem perature and similar intensive quantities. Naturally, if there are no uctuations of intensive quantities at all, the system must obey BG distribution (i.e., f() = $(1=k_BT)$). They also showed that, if f() is the -distribution (see also 12), one obtains the q-exponential weight of nonextensive statistical mechanics. Moreover, for small variance of the uctuations, the nonextensive statistical distribution is once again reobtained. See 13 for an entropic functional which, extremized under appropriate constraints, recovers the distribution of superstatistics.

We straightforwardly obtain, through Laplace transform, that the superstatistical distribution f () corresponding to the p (E)=p (0) given by Eq. (2) is



where h:::i $R_1 \atop 0$ d f()(:::). The notation q_{cc} (BC stands for Beck-Cohen) has been introduced to avoid confusion with the present q. 0 nly when f() equals the -distribution we have $q_{cc} = q$. Using Eq. (10) and integrating we obtain

Replacing (12) into (11) we obtain




Figure 2. Functions $\frac{p(E)}{p(0)}$ (left) and f() (right) for h i = 1. (a) Boltzm ann-G ibbs distribution h $\frac{p(E)}{p(0)} = e^{-E}$; f() = (1); (b) q = $q_{B,C} = 1.8$ distribution $\frac{h}{p(0)} = \frac{q}{0.8} = \frac{(1.25)}{(0.75)} = \frac{1}{(1+0.8E)^{1.25}}$; f() = $\frac{0.25}{0.8^{1.25} (1.25)} e^{-1.25}$; (c) $(q;q_{B,C}) = (2;3=2)$ distribution $\frac{p(E)}{p(0)} = \frac{(2 \ln 2)^{-1}}{2e^{E-2}}$; f() = $\frac{1}{2}$ [($\frac{1}{2}$) + $\frac{1}{2}$ (1) + $\frac{1}{4}$ ($\frac{3}{2}$) + :::]; (d) $(q;q_{B,C}) = (3=2;5=4)$ distribution $\frac{p(E)}{p(0)} = \frac{[4(1-\ln 2)]^{-1}}{(2e^{E-4}-1)^2}$; f() = $\frac{1}{4}$ [($\frac{1}{2}$) + ($\frac{3}{4}$) + $\frac{3}{4}$ (1) + :::]. In the cases (a,c,d), what is represented is not f() strictly speaking, but rather the weights of the D irac delta's.

Finally, we may rewrite distribution (2) as follows:

Observe that, for all q, if q_{cc} ! 1 we obtain the BG distribution. In addition, we see that generically assumes discrete values in f(). If we focus on the limit of continuous values for , we must have (using Eq. (10)) (n + 1) (n) = $_{1}$ (q 1) ! 0, and this is obtained (see Eq. (13)) when h i ! 0 (i.e., high

tem perature) or q_{ac} ! q (i.e., q-statistics) . In Fig. 2 we present typical examples of pairs p(E)=p(0); f().

Sum marizing, we obtained the distribution corresponding to the di erential equation (1), expected to characterize a class of physical stationary states where a crossover occurs between nonextensive and BG statistics. This led us to a possible generalization of P lanck law. We obtained also the Beck-C ohen superstatistical distribution f() associated with such type of crossovers between statistics. A long similar lines, it is possible to study crossovers between q and q^0 statistics, with eventual applications in turbulence and other complex phenomena.

In his \Ueber eine Verbesserung der W ien'schen Spectralgleichung" 19 October 1900 paper, Planck writes the following equations: $d^2S=dU^2==[U(+U](S)]$ and U being the entropy and internal energy respectively; and are constants), and dS=dU=1=T (T being Kelvin's absolute temperature). Replacing the latter into the former leads to $dU=d(1=T)=(=)U+(1=)U^2$. From this dierential equation, he eventually obtains his famous law, namely $E=C^5=(e^{C^2-T})$ (being the wavelength; C and c are constants). If, as usually done now adays, we express this spectral density in terms of the frequency $(E)=(E)^2$ 0 being a constant).
