A long the lines of nonextensive statistical m echanics, based on the entropy $S_{q}=k(1$ $\left.{ }_{i} p_{i}^{q}\right)=\left(\begin{array}{ll}q & 1)\left(S_{1}=\right. \\ k & \left.{ }_{i} p_{i} \ln p_{i}\right) \text {, and } B e c k-C \text { ohen superstatistics, we heuristically } . ~\end{array}\right.$ generalize $P$ lanck's statistical law for the black-body radiation. T he procedure is based on the discussion of the di erentialequation $d y=d x=a_{1} y \quad\left(a_{q} \quad a_{1}\right) y^{q}(w i t h y(0)=1)$, whose $q=2$ particular case leads to the celebrated law, as originally shown by P lanck him self in his O ctober 1900 paper. A lthough the present generalization ism athem atically sim ple and elegant, we have unfortunately no physical application of it at the present m om ent. It opens nevertheless the door to a type of approach that $m$ ight be of som $e$ interest in $m$ ore com plex, possibly out-of-equilibrium, phenom ena.

We norm ally obtain the statistical mechanical equilibrium distribution by optim izing, under appropriate constraints, an entropic functional, nam ely the B oltzm ann-G ibbs (BG) entropy $S_{B G}=k{ }_{i} p_{i} \ln p_{i}$. The success and elegance of this variationalm ethod are unquestioned. But at least one $m$ ore possibility exists, nam ely through di erential equations. Such a path is virtually never followed. Indeed, such an approach $m$ ight seem quite bizarre at rst sight. But we should by no $m$ eans overlook that it has at least one distinguished predecessor: P lanck' s law for the black-body radiation. Indeed, $P$ lanck published tw o papers on the sub ject in 1900. The rst one in O ctober, the second one in D ecem ber ${ }^{1 / 1}$. The bases of both of them were considered at the tim e as totally heuristic ones, although kind ofdi erent in nature. T he second paperm ight be considered as a prim itive form of what has now becom e the standard approach to statisticalm echanics, based on the optim ization of an entropy functional, the connection with B ose F instein statistics, and, ultim, ately, w ith the Bollam ann-G ibbs them al theory for a quantum harm onic oscillator ${ }^{n}$. The rst paper ${ }^{13}$, how ever, is totally based on sim ple argum ents regarding an ordinary di erentialequation. It is along this line that the present paper
is constructed.
If $S_{B} G$ is extrem ized under appropriate constraints, we obtain the fam ous BG w eight $p(E)=p(0) e^{E}$. This distribution can be seen as the solution of the differential equation $d p=d E=p$. Since m ore than one decade, a lot of e ort is being dedicated to the study of the so called $\backslash$ nonextensive statisticalmechanics", based on the generalized entropy $S_{q}=k\left(\begin{array}{ll}1 & \left.{ }_{i} p_{i}^{q}\right)=\left(\begin{array}{ll}q & 1\end{array}\right)\left(S_{1}=S_{B G}\right) ~(f o r ~ a ~ r e-~\end{array}\right.$ view, see ${ }^{51} \mathbf{5}^{1}$. T The extrem ization of this entropy under appropriate constraints yields $\mathrm{p}(\mathrm{E})=\mathrm{p}(0) \mathrm{e}_{\mathrm{q}}{ }^{\mathrm{E}}$, where $\left.\mathrm{e}_{\mathrm{q}}^{\mathrm{x}} \quad[1+(1 \mathrm{q}) \mathrm{x}]^{1=(1} \mathrm{q}\right) \quad\left(\mathrm{e}_{1}^{\mathrm{x}}=\mathrm{e}^{\mathrm{x}}\right)$. This distribution, which has been shown to em erge in many natural and arti cial system $\mathrm{S}^{5} \mathbf{5}$, can be seen as the solution of the di erential equation $d[p=p(0)]=d E=[p=p(0)]^{q}$. A s a next step, wem ay consider even $m$ ore com plex system $s$, nam ely those which exhibit, for increasing $E$, a crossover from nonextensive to BG statistics. Such appears to be the case of cosm ic rays ${ }^{6 \prime \prime}$. Such situations can be handled w ith a di erential equation which uni es the previous tw o ones, as follow s:

Excepting for the fact that here $q \mathrm{~m}$ ay be noninteger, this di erential equation is a particular case of B emoulli' s di erential equation. Its solution is given by

which precisely exhibits the desired crossover for $q>1$ and $0<1 \ll \quad$. Indeed, for ( $q$ 1) ${ }_{1} E \ll 1$ we have that $p=p(0) \quad e_{q}{ }^{q E}$, whereas, for $\left(\begin{array}{ll}q & 1\end{array}\right){ }_{1} E \gg 1$, we have $\mathrm{p} / \mathrm{e}{ }^{\mathrm{E}} \mathrm{E}$.

In the $\lim$ it $q=1$ ! 1 and $p(0)_{1}=_{q}$ ! C , where C is a constant, Eq. (2) becom es

If we m ultiply this statisticalw eight by the photon density of states $g(E) / E E^{2}$ and by the energy $E$, we have the celebrated frequency spectral density

where we have identi ed $1!1=k_{B} T$ and $E!h$. It is in this precise sense that Eq. (3) (hence Eq. (2)) can be seen as a generalization of P lanck statistics.

For $q>1$, Eq. (3) can be w ritten as

( x ) being the G am m a function. W em ay now follow P lanck' spath in his $D$ ecem ber 1900 paper, where he introduced the discretization of energy that eventually led to the form ulation of quantum $m$ echanics. Consistently, we $m$ ay interpret $E_{n}$ as a discretized energy and $d(n ; q)$ as its degeneracy. W e see that, $8 q>1$, the spectrum is $m$ ade of equidistant levels, like that of the quantum one-dim ensional harm onic oscillator. The situation is de nitively di erent in what concems the degeneracy (see $F$ ig. 1). Only for $q=2$ we have the rem arkable property $d(n ; 2)=1(8 n)$, which recovers the harm onic oscillator problem.

At this point, let us em phasize that any them ostatistical weight (that of ther$m$ alequilibrium for instance) re ects the $m$ icroscopic dynam ics of the system. This
fact w as addressed by E instein in $1910{ }^{\Gamma^{\prime}} \bar{l}^{\prime}$, and w as recently revisited by several authors (see '8', for instance). It was show $n$ also, on quite general grounds, in ' ${ }^{9} 1$ '. In the sam e vein, a dynam ical theory of weakly coupled harm onic oscillators system w as recently used for deducing the functional relation betw een energy variance and $m$ ean energy that was con jectured by Einstein in connection with P lanck' s for$m$ ula, thus exhibiting that it is a consequence ofpure dynam ics dynam ical interpretation that Beck and C ohen introduced their superstatistics ${ }^{1111}$. Indeed, nonequilibrium system sm ight exhibit spatio-tem poral uctuations of intensive quantities, e.g., the tem perature. T hey assum ed then that the inverse tem perature $m$ ight itself be a stochastic variable, such that the generalized distribution of energy is expressed as

where the distribution $f()$ satis es $R_{0} d f()=1$ :The e ective statisticalmechanics of such system $s$ depends on the statistical properties of the uctuations of the tem perature and sim ilar intensive quantities. Naturally, if there are no uctuations of intensive quantities at all, the system $m$ ust obey BG distribution (i.e., $f()_{-}=\left(1=k_{B} T\right)$. They also showed that, if $f()$ is the distribution (see also $\left.{ }^{12}-2\right)$, one obtains the q-exponentialw eight of nonextensive statisticalm echan ics. $M$ oreover, for sm all variance of the , uctuations, the nonextensive statistical distribution is once again reobtained. Seel ${ }^{113}$ for an entropic functionalw hich, extrem ized under appropriate constraints, recovers the distribution of superstatistics.

W e straightforw ardly obtain, through Laplace transform, that the superstatistical distribution $f()$ corresponding to the $p(E)=p(0)$ given by Eq. (2) is

where h:::i $\quad R_{1} d f()(:::)$. The notation $q_{c} \quad$ (BC stands for Beck-C ohen) has been introduced to avoid confusion with the present q. Only when $f()$ equals the -distribution we have $q_{\mathrm{B}}=$ q. U sing Eq. (10) and integrating we obtain

In the cases $(a, c, d)$, what is represented is not $f($ ) strictly speaking, but rather the w eights of the $D$ irac delta's.

It is w orthy rem arking that, for alladm issible $f()$, we can w rite the asym ptotic expression $p(E)=p(0)=$ he $E_{i} \quad e^{h i E\left(1+\frac{{ }^{2} E^{2}}{2}\right)}$, where $\quad P \overline{h{ }^{2} i \quad h i^{2}}=$ $\left(q_{\mathrm{b}} \quad 1\right) \mathrm{h}$ i! 0 .

F inally, we m ay rew rite distribution (2) as follow s:

O bserve that, for all $q$, if $q_{c}$ ! 1 we obtain the BG distribution. In addition, we see that generically assum es discrete values in $f()$. If we focus on the lim it of continuous values for , wem ust have (using Eq. (10)) (n + 1) (n) = 1 (q 1) ! 0, and this is obtained (see Eq. (13)) when h i ! 0 (i.e., high
tem perature) or $q_{c}$ ! q (i.e., q-statistics). In $F$ ig. 2 we present typical exam ples of pairs $p(E)=p(0) ; f()$.

Sum $m$ arizing, we obtained the distribution corresponding to the di erential equation (1), expected to characterize a class of physical stationary states where a crossover occurs betw een nonextensive and BG statistics. This led us to a possible generalization of l lanck law. W e obtained also the Beck-C ohen superstatistical distribution $f()$ associated with such type of crossovers betw een statistics. A long sim ilar lines, it is possible to study crossovers between $q$ and $q^{0}$ statistics, with eventual applications in turbulence and other com plex phenom ena.

In his \U eber eine Verbesserung der W ien'schen Spectralgleichung" 190 ctober 1900 paper, $P$ lanck w rites the follow ing equations: $\mathrm{d}^{2} \mathrm{~S}=\mathrm{dU}^{2}==[\mathrm{U}(+\mathrm{U}]$ ( $S$ and $U$ being the entropy and intemal energy respectively; and are constants), and $d S=d U=1=T$ ( $T$ being Kelvin's absolute tem perature). Replacing the latter into the form er leads to $\mathrm{dU}=\mathrm{d}(1=\mathrm{T})=(=) \mathrm{U}+(1=) \mathrm{U}^{2}$. From this di erential equation, he eventually obtains his fam ous law, nam ely $E=C \quad{ }^{5}=\left(e^{c=T} \quad\right.$ 1) ( being the wavelength; C and $c$ are constants). If, as usually done now adays, we express this spectral density in term sof the frequency / $1=$, we obtain the fam iliar expression, proportional to ${ }^{3}=\left(e^{c^{0}}=T \quad\right.$ 1) ( $c^{0}>0$ being a constant).
