The inhom ogeneous evolution of subgraphs and cycles in com plex networks

Subgraphs and cycles are often used to characterize the local properties of com plex networks. Here we show that the subgraph structure of real networks is highly time dependent: as the network grows, the density of some subgraphs remains unchanged, while the density of others increase at a rate that is determined by the network's degree distribution and clustering properties. This inhom ogeneous evolution process, supported by direct measurements on several real networks, leads to system atic shifts in the overall subgraph spectrum and to an inevitable overrepresentation of some subgraphs and cycles.

Subgraphs, representing a subset of connected vertices in a graph, provide in portant inform ation about the structure of m any real networks. For exam ple, in cellular regulatory networks feed-forward bops play a key role in processing regulatory inform ation [1], while in protein interaction networks highly connected subgraphs represent evolutionary conserved groups of proteins [2]. In a sim ilar vain, cycles, a special class of subgraphs, offer evidence for autonom ous behavior in ecosystem s [3], cyclical exchanges give stability to social structures [4], and cycles contribute to reader orientation in hypertext [5]. Finally, understanding the nature and frequency of cycles is in portant for uncovering the equilibrium properties of various network m odels [6].

M otivated by these practical and theoretical questions, recently a series of statistical tools have been introduced to evaluate the abundance of subgraphs [1, 2, 7] and cycles [8, 9, 10, 11], o ering a better description of a network's local organization. Yet, most of these m ethods were designed to capture the subgraph structure of a speci c snapshot of a network, characterizing static graphs. Most real networks, however, are the result of a growth process, and continue to evolve in time [12]. W hile growth offen leaves some of the network's global features unchanged, it does alter its local, subgraph based structure, potentially modifying everything from subgraph densities to cycle abundance. Yet, the currently available statisticalm ethods cannot anticipate or describe such potential changes.

In this paper we show that during grow th the subgraph structure of com plex networks undergoes a system atic reorganization. We nd that the evolution of the relative subgraph and cycle abundance can be predicted from the degree distribution P (k) and the degree dependent average clustering coe cient C (k). The results indicate that the subgraph com position of com plex networks changes in a very inhom ogeneous m anner: while the density of m any subgraphs is independent of the network size, they coexist with a class of subgraphs whose density increases




FIG. 1: Examples of subgraphs and cycles with a central vertex. The subgraph shown in (a) has n = 5 vertices and n + t = 5 edges, where t = 1 represents the num ber of edges connecting the neighbors of the central vertex (em pty circle) together. In (b) we show a subgraph with t = 3 edges am ong the neighbors, such that the central vertex and its neighbors form a cycle of length h = 5, highlighted by the dotted circle

at a subgraph dependent rate as the network expands. Therefore in the therm odynam ic lim it a few subgraphs will be highly overrepresented [1], a prediction that is supported by direct m easurements on a number of real networks for which time resolved network topologies are available. This noting questions our ability to characterize networks based on the subgraph abundance obtained from a single topological snapshot. We show that a com – bined understanding of network evolution and subgraph abundance o ers a more com plete picture.

Subgraphs: W e consider subgraphs with n vertices and 1 + t edges, whose central vertex has links to n 1 n neighbors, which in turn have t links among them selves (Fig. 1a). The total number of n-node subgraphs that can pass by a node with degree k is ${k \atop n \ 1}$. Each of these n-node subgraphs can have at most $n_p = (n \ 1) (n \ 2)=2$ edges between the n 1 neighbors of the central node. The probability that there is an edge between two neighbors of a degree k vertex is given by the clustering coefcient C (k). Therefore, the probability to obtain t connected pairs and n_p t disconnected pairs is given by the binom ial distribution of n_p trials with probability C (k). The expected number of (n;t) subgraphs in the network is obtained after averaging over the degree distribution, resulting in

where $k_{m ax}$ is the maximum degree and the geometric factor g_{nt} takes into account that the same subgraph can have more than one central vertex. For instance, a triangle will be counted three times since each vertex is connected to the others, therefore $g_{31} = 1=3$. For networks where P (k) k and C (k) k , where and are the degree distribution and clustering hierarchy exponents, in the therm odynam ic lim it $k_{m ax}$! 1 Eq. (1) predicts the existence of two subgraph classes [7]

Therefore, for the Type I subgraphs the $N_{nt}=N$ density increases with increasing network size, and Nnt=N is independent of N for Type II subgraphs. In the following we provide direct evidence for the two subgraph types in several real networks for which varying network sizes are available: co-authorship network of mathematical publications [13], the autonom ous system representation of the Internet [14, 15], and the semantic web of English synonym s [16]. In each of these networks the maximum degree increases as k_{m ax} N . We estimated from the scaling of the degree distribution m om ents with the graph size, $hk^n i N^{(n+1)}$, with n = 2;3;4. Furthermore, we nd that C_0 from $C(k) = C_0 k$ also depends $N_{\rm P}$, where can be estion the network size as C_0 mated using $C_0 = \frac{1}{k_2} C(k) = \frac{1}{k_2} k_2$, giving a better estimate than a direct t of C (k). The exponents characterizing each network are sum marized in Table. I.




FIG.2: Number of (n = 5,t) subgraphs for the co-authorship (a), Internet (b), sem antic (c) networks and the determ inistic m odel (d) as a function oft. D i erent symbols correspond to di erent snapshots of the networks evolution, from early stage (circles) to interm ediate (squares) and current (i.e. largest) (triangles). N_{nt} depends strongly on t (spanning several orders of m agnitude) m aking di cult to observe the N dependence. Thus we norm alized all the quantities (N_{5t}, C₀ and N) to the rst year available. The arrows correspond to the phase boundary 5 t = 0, with Type I and II subgraphs to the left and right of the arrow, respectively. In the insets show the system size dependence we plot log N_{5t} vs log N for di erent values of t.

In Fig. 2 we show the density of all ve vertex subgraphs (n = 5) as a function of t. For the Internet and Language networks C₀ increases with N, therefore the subgraph's density increases with the network size for all subgraphs. This consequence of the non-stationarity of

the clustering coe cient is subtrated by norm alizing N $_{nt}$ by C₀^t. For the co-authorship graph with = 0 (Table I), only Type I subgraphs are observed, as predicted by (2). In contrast, for the Internet and sem antic networks > 0, therefore the overrepresented Type I phase is expected to end approximately at the phase boundary predicted by (2). Indeed, left to the arrow denoting t phase boundary we continue to observe a the n system atic increase in N_{5t}=N C^t₀, as expected for Type I subgraphs. In contrast, beyond the phase boundary the subgraph densities obtained for dierent network sizes are independent of N, collapsing into a single curve.


W e com pared our predictions with direct counts in a grow ing determ inistic network model [17] as well, characterized by a degree exponent $= 1 + \ln 3 = \ln 2$ 2:6 and a degree dependent clustering coe cient C (k) = C $_0$ k , with $C_0 = 2$ and = 1. In Fig. 2d we show the number of (n = 5, t) subgraphs for di erent values of t and graph sizes. The arrow indicating the predicted phase transition point n t = 0 clearly separates the Type I from the Type II subgraphs, a num erical nding that is supported by exact calculations as well. Note that only one Type $\Pi n = 5$ subgraph is present in the determ inistic network, due to its particular evolution rule.

Cycles: The form alism developed above can be generalized to predict cycle abundance as well. Consider the set of centrally connected cycles shown in Fig. 1b. If the central vertex has degree k, we can form $\begin{pmatrix} k \\ h \end{pmatrix}$ di erent groups of h vertices, h 1 selected from its k neighbors and the central vertex. Each ordering of the h 1 selected neighbors corresponds to a di erent cycle, therefore we multiply with half of the number of their permutations 1)! (assuming that 123 is the same as 321). Finally, (h to obtain the number of h-cycles we multiply the result with the probability of having h 2 edges between consecutive neighbors, C $(k)^{h-2}$, and sum over the degree distribution P (k), nding

where g_h is again a geometric factor correcting multiple counting of the same cycle. Note that (3) represents a lower bound for the total num ber of h-cycles, which also include cycles without a central vertex. Depending on the values of h, and the sum in (3) may converge or diverge in the lim it k_{max} ! 1 . When it converges, the density of h-cycles is independent of N (Type II), otherwise it growswith N (Type I). Since in preferential attachm ent m odels without clustering the density of hcycles decreases with increasing N [18], we conclude that clustering is the essential feature that gives rise to the observed high h-cycle num ber in such real networks like the Internet [8]. To further characterize the cycle spectrum, we need distinguish two di erent cases, 0 < < 1and 1.

< 1: In the k_{m ax} ! 1 lim it the cycle density 0 < follow s

2)=(1). Therefore, large cycles (h > where $h_c = ($ h_c) are abundant, their density growing with the network size N. As ! 1 the threshold h_c ! 1, therefore the range of h for which the density is size independent expands signi cantly.

D irect calculations using (3) show that N $_{\rm h}$ exhibits a maximum at some intermediate value of h (see Fig. 3a, already reported for the determ inistic model [10]. The maximum represents a nite size e ect, as the characteristic cycle length h , corresponding to the m axim um of N $_{\rm h}$, scales as h k_{max} (Fig. 3b). Yet, next we show that this behavior is not generic, but depends on the value of .

1: For all > 2 only Type II subgraphs are expected (N_h=N C_0^{h-2}), as suggested by the divergence of h_c in the ! 1 lim it. If $C_0 > 1$ the num berofh-cycles continues to exhibit a maximum and the characteristic cycle length h scales as h $k_{m ax}$. If $C_0 < 1$, how ever, the num ber of h-cycles decrease with h, although a sm all localm in in a is seen for sm all cycles. M ore im portant, in this case N $_{\rm h}$ =N is independent of the network size (see Fig. 3c), in contrast with the size dependence observed earlier (Fig. 3a and [10]). Thus, for networks with > 1or = 1 and $C_0 < 1$ the cycle spectrum is stationary, independent of the stage of the growth process in which we inspect the network.

Our predictions for the cycle abundance are based on centrally connected cycles, in which a central vertex is connected to all vertices of the cycle (Fig. 1b). In the following we show that our predictions capture the scal-




FIG.4: Density of all (open sym bols) and centrally connected (lled sym bols) cycles with h = 3 (circles), 4 (squares) and 5 (diam ond) cycles as a function of the graph size. The continuous lines corresponds with our predictions (Tab. I).

ing of all h-cycles as well, not only those that are centrally connected. For this in Fig. 4 we plot the number of h = 3;4;5 cycles (i.e. all cycles as well as those that are centrally connected) as a function of the graph size for the studied real and model networks, together with our predictions (continuous line). First we note that in m any cases (h = 3 and 4) the full cycle density and the density of the centrally connected cycles overlap. In the few cases (h = 5) where there are system atic di erences between the two densities the N-dependence of the two quantities is the same, indicating that our calculations correctly predict the scaling of all cycles.

For the co-authorship and Internet graphs < 1 and $h_c < 3$, therefore the h = 3;4;5 cycles are predicted to be in the Type I regime $(h > h_c)$. In this case $N_h = N$ N^h , where $_h = (h - 2) + (1 -)(h - h_c)$. For the language graph = 1, therefore $_h = (h - 2)$. For the determ inistic model a direct count of the h-cycles reveals that they are of Type II, i.e. their density is independent of N [10], in agreement with our predictions for 1. These predictions are shown as continuous lines in Fig. 4, indicating a good agreement with the realm easurements.

O ur results o er evidence of a quite com plex subgraph dynam ics. As the network grows, the density of the Type II subgraphs remains unchanged, being independent of the system size. In contrast, the density of the Type I subgraphs increases in an inhom ogeneous fashion. Indeed, each (n,t) subgraph has its own grow th exponent $_{nt}$, which m eans that their density increases in a di erentiated manner: the density of some Type I subgraphs will grow faster than the density of the other Type I subgraphs. Thus, inspecting the system at several time intervals one expects signi cant shifts in subgraphs densities. As a group, with increasing network size the Type I graphs will signi cantly outnum ber the constant density Type II graphs. Therefore the inspection of the graph density at a given m om ent will o er us valuable, but limited inform ation about the overall local structure of a complex network. However, P (k) and the C (k) functions allow us to predict with high precision the future shifts in subgraph densities, indicating that a precise know ledge of the global network characteristics is needed to fully understand the local structure of the network at any m om ent. These results will eventually force us reevaluate a number of concepts, ranging from the potential characterization of com plex networks based on their subgraph spectrum to our understanding of the im pact of subgraphs on processes taking place on com – plex networks [19, 20].
