# M ulti-channel scattering and Feshbach resonances: E ective theory, phenom enology, and m any-body e ects

A low energy e ective theory based on a m icroscopic multi-channel description of the atom -atom interaction is derived for the scattering of alkali atoms in di erent hyper ne states. This theory describes all scattering properties, including medium e ects, in terms of the singlet and triplet scattering lengths and the range of the atom -atom potential and provides a link between a m icroscopic description of Feshbach scattering and m ore phenom enological approaches. It perm its the calculation of medium e ects on the resonance coming from the occupation of closed channel states. The examination of such e ects are demonstrated to be of particular relevance to an experimentally important Feshbach resonance for  $^{40}$ K atoms. We analyze a recent retherm alization rate experiment on  $^{40}$ K and demonstrate that a measurement of the tem perature dependence of this rate can determ ine the magnetic moment of the Feshbach molecule. Finally, the energy dependence of the Feshbach interaction is shown to introduce a negative e ective range inversely proportional to the width of the resonance. Since our theory is based on a m icroscopic multi-channel picture, it allows the explicit calculation of corrections to commonly used approximations such as the neglect of the

### I. IN TRODUCTION

The use of Feshbach resonances to vary the interactions between atoms obeying Ferm i statistics has become a matter of interest in the eld of ultracold trapped atoms [1]. One reason is that these systems perm it the experimental exploration of potentially strongly correlated Ferm i systems in which the magnitude of the scattering length a is larger than the interparticle separation. The study of such strongly interacting Ferm i systems is relevant to several elds including condensed matter and nuclear physics and astrophysics.

It is therefore in portant to understand in some detail the physics of atom s interacting via a Feshbach resonance. Theoretical studies of the two-body physics of Feshbach resonances are typically perform ed in the context of vacuum multi-channel scattering theory using a m icroscopic model of the atom -atom interaction [2]. On the other hand, studies of low energy many-body properties often require the use of e ective theories with a simpli ed form of the atom -atom interaction in order to make calculations tractable. A precise link between such e ective theories and m icroscopic multi-channelm odels is therefore crucial in order to incorporate the correct twobody physics in many-body calculations. In the atom ic gas com m unity, e ective theories are of two types. In one, the presence of closed channels is simply neglected, and only the resultant (resonant) scattering length is used as an input param eter. This approximation is adequate for the calculation of certain m any-body properties close to broad resonances where the wave function of the Feshbach molecule is dominated by atom pairs in the open channel [3]. In the other, the presence of a two-body

bound state in the closed channel (which leads to the resonance) is put in by hand in the form of a point boson [4, 5]. The parameters appearing in such theories are then the magnetic moment of the Feshbach molecule and the molecule atom coupling.

The treatment of the bound state in the closed channels as a point boson is, however, incorrect in principle since it is really a composite two-body object. The m ain purpose of the present paper is therefore to develop a system atic, improved low energy e ective theory for the multi-channel scattering of alkali atom s in which the presence of a closed channel molecular Feshbach state is not put in by hand as a point boson but rather en erges naturally as a composite object consisting of two interacting ferm ionic atom s. We will show that such a theory perm its tractable calculations of low energy many-body properties including medium e ects due to the occupation of states in the closed channels. The examination of such e ects will be demonstrated to be of particular in portance for the experim entally well-studied resonance of 40K atoms. It will be dem onstrated that our approach can be reduced to the well-known Bose-Ferm i model when the two-ferm ion nature of the bare molecule in the closed channel can be ignored. This theory can be form ulated in two equivalent ways: One uses the microscopic param eters describing the atom -atom interaction as input; the other takes physical param eters describing the low energy scattering as input including the position and width of the resonance and the magnetic moment of the Feshbach molecule (including the e ects of dressing by the open channel). This provides an appealing link between the microscopic parameters often used in two-body multi-channel calculations and the physical

param eters used in low energy e ective m any-body theories. W e will use this e ective theory to analyze recent retherm alization experim ents on <sup>40</sup>K atom s and propose that further experim ental study of retherm alization rates at higher tem peratures can provide a determ ination of the m agnetic m om ent of the Feshbach m olecule. F inally, the energy dependent Feshbach interaction w ill be shown to introduce an e ective range inversely proportional to the width of the resonance. This e ective range can be neglected (and universal behavior close to resonance expected) only in the case of broad resonances.

Note that we set h = 1 throughout the paper.

## II. LOW ENERGY EFFECTIVE THEORY

In this section, we develop a low energy e ective theory for the scattering of alkali atom s in di erent hyper ne states. Consider a gas of alkali atom s in a given m agnetic

eld B along the z-direction. Incoming and outgoing scattering channels are characterized by the eigenstates of the single particle hyper ne Ham iltonian

where A is the hyper ne constant, C = 2  $_{\rm B}$  B , D =

 $_{n}$  B = I with  $_{n}$  the nuclear spin m agnetic m om ent, and S and I are the electron and nuclear spin operators respectively. We denote the single particle eigenstates of the hyper ne H am iltonian for a given B - eld as j i with  $\hat{H_{spin}} j i = j i$ . The eigenstates can be labeled by their total spin, F = S + I, F = I  $\frac{1}{2}$ , and its z-projection, m<sub>F</sub> = I  $\frac{1}{2}$ ; :::I +  $\frac{1}{2}$ , e.g., j i f; m<sub>F</sub> i. The main contribution to the atom -atom interaction driving the scattering process is the electrostatic central potential

where  $V_s(r)$  and  $V_t(r)$  are the singlet and triplet potentials and  $S_1$  and  $S_2$  are the spins of the valence electrons of the two alkali atoms [6]. We ignore here the small magnetostatic and magnetic dipole-dipole interactions between atoms. The potential (2) induces transitions among two-particle states with the same total z-projection of F. The properly anti-symmetrized two-particle state with the lowest energy constitutes the open channel joi =  $j_{1}$ ; 2i. The states of higher energies which can be coupled to joi by the potential (2) form a set of closed channels  $jc^{(n)}i = j_{3}^{(n)}; \frac{4}{4}$  i. The threshold energies for the closed channels are then  $E_{th}^{(n)}(B) = \frac{4}{4}$ .

eld B through H spin.

As a practical illustration of our approach, we consider in the following the s-wave Feshbach resonance in a cold  $^{40}$ K gas at B<sub>0</sub> ' 201:6 G, which has frequently been studied experimentally, e.g., Refs. [7, 8]. The open channel for this resonance has atom s in the states  $\frac{9}{2}$ ;  $\frac{9}{2}$  i and

 $\frac{1}{2}$ ;  $\frac{7}{2}$ i. The only other state in the ground-state m anifold to which the open channel can couple through the dom inant electrostatic potential has atom s in the states  $\frac{19}{J_2}$ ;  $\frac{9}{2}$  i and  $\frac{17}{J_2}$ ;  $\frac{7}{2}$  i. Thus,  $\dot{p}i = \frac{19}{J_2} = \frac{9}{2}$ ;  $\frac{9}{2}$ ;  $\frac{7}{2}$  i, and the only closed channel is  $jci = \frac{9}{J_2} = \frac{9}{2}; \frac{7}{2} = \frac{7}{2}i$ . Note that the open and closed channels have the state  $\frac{1}{2}$ ;  $\frac{9}{2}$  i in com m on. Thus, we can im m ediately conclude that any initial occupation of the state  $\frac{j^2}{2}$ ;  $\frac{9}{2}$  i will have direct e ects on the closed channel Feshbach state. Such e ects cannot be described by the usualBose-Ferm im odels which treat the Feshbach molecule as a point Boson. It was dem onstrated in Ref. [10] using a schematic mean eld theory that these e ects can be important for BCS-BEC crossover physics. Here, we will dem onstrate that the occupation of the closed channel state can have signi cante ects on scattering properties using an e ective theory based on a microscopic description of the atom -atom interaction. The threshold energy for this resonance is given by

W ith the values of A = 1:37  $1^{\circ}$  K, C = 1:3410  ${}^{4}$  B=G K, and D = 1:19  $10^{8}$  B=G K from Ref. [6], we can Taylor expand around B<sub>0</sub> = 201:6G to obtain

which is approximately linear in B  $B_0$  for elds near the resonance.

W eem phasize that our eetive theory is not limited to two-channel problem s. It is readily generalized to more than two channels if appropriate for other atom ic resonances.

The total H am iltonian describing a system of particles in the scattering states joi and joi interacting via V (r) is

where  $\stackrel{Y}{q}(K) = [a_{K}^{Y}_{e^{2}+q^{-}4} a_{K^{2}-q^{-}3}^{Y}; a_{K^{2}-q^{-}2}^{Y}, a_{K^{2}-q^{-}1}^{Y}]$ describes the creation of an atom ic pair in the closed and open channels with center of mass momentum K and relative momentum q. Here,  $_{;k} = + k^{2}=2m$ with m the mass of the atom s, and V is the volume of the system. The interaction matrix elements of V (r) in (2) between the di erent scattering channels are denoted  $V_{ij}(q^{0};q)$  with i;j = o;c. They depend on B through the B -dependence of the states joi and jci.

The scattering process is described by the scattering matrix,  $T_{ij}$  (!;K;q<sup>0</sup>;q), which depends on the center-ofmass frequency and momentum (!;K) and the relative m om enta q and  $q^0$  in the incom ing and outgoing channels respectively. The scattering matrix obeys in the ladder approximation the Lippmann-Schwinger equation

where the propagator for two atom s in the open channel is

is the propagator for a pair of atom s in the closed channel. Here f is the Ferm idistribution function appropriate for the hyper ne state j i. N ote that (6) is a matrix equation both in the relative momenta  $(q^0;q)$  and in the channels (i;j).

### A. E ective interaction

We now de ne an e ective interaction U appropriate for calculating the low energy scattering properties of the system. This is done by considering the Lippm ann-Schwinger equation in vacuum for ! = 0 and ignoring the hyper ne splitting of the atom ic levels

where  $G^{vac}(q) = (i \quad \hat{q}=m)^{-1}$  is the vacuum pair propagator ignoring the hyper ne splitting. When the scattering is dom inated by the presence of a single Feshbach state in a closed channel, the e ective interaction m ediated by the closed channel state is rank one separable: Its Fourier transform can be expressed in terms of the product of the Fourier transform sh  $_k j\hat{V} j_m i$ , where  $j_m i$ is the m olecular state and  $j_k i$  is a plane wave state of the two atom s [9]. For the low energies relevant for dilute atom ic gases, the typical wavelength  $q^{-1}$  of the open channel scattering atom s is such that  $qr_c = 1$  where  $r_c$ is the characteristic length scale of hr  $j\hat{V} j_m i$ . For these long wavelengths, the solution of (9) can be written from (2) as

where  $a_s$  and  $a_t$  are the scattering lengths for the singlet  $V_s$  (r) and triplet  $V_t$  (r) potentials, respectively. Cut-o e ects of the potential (for  $r_c > 0$ ) are contained in the

form factor g(q) ! 0 for  $qr_c$  ! 1 . The atom -atom potential is thus characterized by the three parameters:  $a_s$ ,  $a_t$ , and (in plicitly)  $r_c$  . U sing (10), one can readily calculate the low energy e ective interaction matrix elements hijJ jji for the scattering channels jii. Note that these matrix elements depend on B through the B -dependence of the eigenstates of (1). For  $^{40}$ K, a simple calculation expressing the hyper ne states jP=2; 9=2i, jP=2; 7=2i, and jT=2; 7=2i in term softhe eigenstates of the electron and nuclear spin for a given B - eld yields

where  $c_7 = \frac{p}{(2x + 7)^2} \frac{p}{81 + 28x + 4x^2} = 32$  and  $c_9 = (2x + 7)^2 = 32$  with x = (C + D) = Aincorporate the B dependence of the elective interaction.

W ith (10) [or (11) for  ${}^{40}$ K ], we have obtained a low energy e ective interaction. Since U is a solution to the scattering problem in vacuum, it includes the in uence of the non-resonant coupling to high momentum states in both open and closed channels.

#### B. Scattering m atrix

We can now use U as an elective low energy interaction for the exact solution of the scattering problem. The resonant scattering matrix can be expressed in terms of U using (6) and (9) with the result that

where  $G_{\circ}(!;K;q) = G_{\circ}(!;K;q) \quad G^{vac}(q)$  and  $G_{\circ}(!;K;q;B) = G_{\circ}(!;K;q;B) \quad G^{vac}(q)$ . The pair propagators  $G_{\circ}$  and  $G_{\circ}$  provide corrections to the scattering matrix arising from the hyper ne level structure which leads to the presence of a Feshbach resonance and corrections due to the presence of a medium in both channels. Note that since the e ective interaction U includes the coupling to high energy states, our theory as de ned in (12) is properly renorm alized in the sense that it yields nite results even for  $r_{\rm E} = 0$  corresponding to a -function interaction.

W ith U given by (10), we can readily solve (12) to obtain the scattering matrix in the open channel

The integrals in (14)–(15) can performed straightforwardly in the vacuum case for a zero range ( $r_c = 0$ ) potential with the result that  $\overset{vac}{_{o}}(!;K) = im^{3=2^{D}} \frac{1}{!} = (4) + 0$  ( $m \stackrel{!}{_{e}} r_c$ ) where  $! = ! K^2 = (4m)$  is the energy in the center of mass frame. Similarly,  $\overset{vac}{_{c}}(!;K;B) = \overset{vac}{_{o}}[! E_{th}(B);K] + 0$  ( $m \stackrel{E}{_{e}} t_{r}r_c$ ).

### C. Feshbach resonance

Consider now the case when a Feshbach resonance is present at  $B = B_0$ . For elds close to  $B_0$ , it is standard to parameterize the zero energy vacuum scattering matrix as

where  $a_{bg}$  is the (non-resonant) background scattering length and B the width of the resonance. We see from (13) that the zero energy (! = 0) scattering matrix in a vacuum is

since  $_{o}^{vac}$  (! = 0) = 0. A comparison of (16) with (17) allows us to express the phenomenological low energy scattering parameters  $a_{bg}$ , B, and B<sub>0</sub> in terms of the microscopic parameters  $a_s$ ,  $a_t$  and  $r_c$  which characterize the atom -atom interaction. The resonant part of the scattering coming from the coupling between the open and closed channels is clearly given by the second term in (17), which depends on the B eld through U and

for the width of the resonance. W ith (10), (13), (18), (19), and (20), we have nally arrived at our low energy  $(kr_c \quad 1)$  e ective theory. Equation (13) gives the full low energy/m om entum dependent multi-channel scattering matrix as a function of the parameters  $a_s$  and  $a_t$  (and  $r_c$ ) through U in (10). M edium e ects due to the occupation states in both open and closed channels are

included explicitly included through  $_{\rm o}$  and  $_{\rm c}.$  Furthermore, (18), (19), and (20) express the physical parameters  $a_{\rm bg}$ , B $_0$ , and B describing zero energy scattering in vacuum in terms of  $a_{\rm s}$  and  $a_{\rm t}$  and  $r_{\rm c}$ . A lternatively, these equations can be used to  $x a_{\rm s}$  and  $a_{\rm t}$  and  $r_{\rm c}$  from experimental data.

We emphasize that our theory is nite and well de ned even for  $r_c = 0$  (i.e., g(q) = 1). The form factors g(q) have been retained in order to describe nite range effects. These can important since the hyper ne splitting energy  $E_{\rm th}$  can be comparable to  $h^2 = (m r_c^2)$ .

# III. MAGNETIC MOMENT OF THE FESHBACH MOLECULE

In the spirit of Landau Ferm i theory, it is offen convenient to express the full energy- and momentum dependent multi-channel scattering matrix in terms of physical observables only. To do this, it is necessary to introduce one more parameter: the magnetic moment of the Feshbach molecule in a vacuum. The energy of the molecule in a vacuum is determined by the poles of the full pair propagator in the closed channel:




FIG.1: The full (dressed) molecule given by (21) is indicated by the double wavy lines whereas the bare molecule in the closed channel, excluding coupling to the open channel, is given by the single wavy line. Ferm ions are indicated by straight lines, and the intrachannel couplings  $U_{\rm oc}$  and  $U_{\rm cc}$  are indicated by dashed lines. The coupling  $U_{\rm oc}$  between the open and closed channels is indicated by

The rst term,  $D_{\text{bare}}^{1} = \frac{\text{vac}^{1}}{c} U_{\text{cc}}$ , describes the propagation of a pair of atoms interacting in the closed channel only (i.e., the \bare" m olecule) while the nal term describes the coupling to the open channel (\dressing"). The m olecule propagator is illustrated diagram m atically in Fig. 1. To obtain an expression for the m agnetic m oment of the m olecule for elds close to B<sub>0</sub>, we expand (21) about B = B<sub>0</sub> and  $\frac{1}{2} = 0$  to obtain

where we have used  $T_{bg} B_{bare} @! c^{vac 1} = U_{oc}^{2}$  following from (20,24) and explicitly separated the threshold  $\frac{P}{!}$  term in  $_{o}$  by writing

The term  $_{\rm o}$  contains the corrections to the pair propagator in the open channel coming from the nite range (r<sub>c</sub>  $\in$  0) of the potential. Equation (23)-(25) provides a clear physical interpretation of the various contributions to the magnetic moment of the molecule. Equation (24) gives the magnetic moment of the bare molecule when the interaction with atom pairs in the open channel is ignored. It consists of a contribution from the magnetic moment di erence between the open and closed channels,  $\varrho_{\rm B} \, {\rm E}_{\rm th}$  and a contribution from the magnetic eld dependence of the interaction matrix elements in the closed channel. For the  $^{40}$ K resonance discussed above, we have from (4)  $\varrho_{\rm B} \, {\rm E}_{\rm th} = 1.78$   $_{\rm B}$ . The second term in (24) can be estim ated as

The factor z given by (25) gives the renormalization of the magnetic moment due to coupling of the molecule to high momentum atom pairs in the open channel (excluding the threshold e ect given explicitly by the  $\overline{!}$ -term). This renormalization was rst included systematically in a low energy e ective theory in Ref. [5] where it was argued that it can, in general, be signi cant. To see this, we use a simple cut-o form factor  $g(q) = (r_{p}^{-1} - q)$  in (14) to calculate  $_0$  as

where 1 u is the atom ic m ass unit. For the Feshbach resonance of <sup>40</sup>K considered in this paper, B O (10G) 0 (100A) (see next section). It then follows and a<sub>bg</sub> from (27) that the renorm alization of the magnetic mom ent of the m olecule due to the coupling to high m om entum atom pairs in the open channel can be signi cant (i.e. z < 1) if  $r_c > 10A$ . Likewise, the renorm alization can be signi cant for the very broad resonance for<sup>6</sup>Liat 300G and  $a_{bq}$ B ' 830G with B O (1000A) [12]. However, for the narrow  $^{6}$ Li resonance at B $_{0}$  ' 543G and B = 0:23 G studied in Ref. [11], (27) indicates that the renorm alization of the magnetic moment away from threshold described by z can be ignored, i.e. z ' 1.

Having introduced the magnetic moment of the molecule, we can now express the full frequency- and momentum -dependent scattering matrix in a medium in terms of the physical parameters  $a_{bg}$ ,  $B_0$ , B, and . To do this, we rewrite the open-open channel scattering matrix given by (13) in the form




FIG. 2: The open-open channel scattering matrix split into scattering in the open channel only (rst line) and scattering via the closed channel (second line) as given by (28).

The rst term describes the scattering via the open channel interaction only, and the second term describes scattering via the closed channel. The in-medium molecule propagator D is given by (21) with the replacement vac ! . This splitting of the scattering into open channel and closed channel processes is illustrated diagram matically in Fig. 2. Comparison with (21) reveals that the second term in (28) describes the presence of the Feshbach molecule (including medium elects) leading to the resonance. Note that both terms in (28) contribute to the background scattering given by (19). Indeed, a Taylor expansion around ! = 0 and B = B<sub>0</sub> and comparison with the vacuum expression for the scattering matrix (16) yields

in (29) describes e ects com ing from the fact that the Feshbach state is a composite two-ferm ion object including medium e ects in the closed channel.

W ith (29), we have expressed the full scattering matrix in terms of the physical parameters  $a_{bg}$ ,  $B_0$ ,  $B_1$ , and . These, in turn, can be calculated from  $a_s$  and  $a_t$  with the aid of (18)–(20) and (23). Thus, (29) and (13) are two formulations of the same result, the former expresses the in-medium scattering matrix in terms of the microscopic parameters characterizing the atom – atom interaction; the latter provides a formulation valid close to the resonance in terms of the physical observables characterizing the resonance. Our elective theory thus provides a link between these descriptions.

#### IV. MEDIUM EFFECTS

We now consider the shift of the resonance position due to the presence of a medium. To do this, we rewrite (29) as

We see clearly that the term  $T_{bg}$  B  $_{o}^{inf}$  in the denominator describes the e ects of the presence of atom s in the open channel whereas h (!) describes the e ects of the presence of atom s in the closed channel.

We rst calculate medium e ects due to the presence of open channel atom s. We see from (14) that medium e ects in the open channel shift  $_{\rm o}$  by

for K = 0 and ! = 0 where  $k_{\rm F}$  is the Ferm im omentum for both open channel hyper ne states (we have assumed equal population) and  $k_{\rm B}$  T  $k_{\rm F}^2$ =2m. The resulting shift B in the position of the center of mass K = 0 resonance from its vacuum position B<sub>0</sub> is then readily determined from (31)

Taking a density of  $n = 2 10^{12}$  cm<sup>-3</sup>,  $a_{bg} = 290a_0$ , and B = 8G relevant for the  ${}^{40}$ K resonance considered here, (33) yields B = 0.61G for the shift of the position of the resonance due to the occupation of states in the open channel. O f course, in a typical radio-frequency (RF) experiment which probes the scattering of pairs of atom s within the Ferm i sea with varying center of m ass m om enta K [12], it is necessary to average (14) and (31) appropriately over m om enta in order to obtain the average m edium shift of the resonance position.

The e ects due to the population of the closed channel states can likewise be calculated from h(!). The medium shift of h(!) is obtained from (30) and (15) as

where  $n_c$  is the density of closed channel atom s and E<sub>th</sub> (3  $^2n_c$ )<sup>2=3</sup>=2m by assumption. The shift of the resonance position due to the occupation of closed channel states follows from (31) as

For the  ${}^{40}$ K resonance, an assumed total density of n =  $2 \quad 10^{12}$  cm  ${}^{3}$  corresponds to  $n_c = 10^{12}$  cm  ${}^{3}$  since the open and the closed channels share one hyper ne state. U sing E<sub>th</sub> = 0.084K from (4) and assuming <sub>bare</sub> <sub>B</sub> yields B =  $1.7 \quad 10^6$  G for the shift of the position of the resonance due to the occupation of states in the closed channel. The shift B is very small because E<sub>th</sub> <sub>F</sub> for this resonance where <sub>F</sub> is the Fermi energy.

The medium e ects are treated within the ladder approximation in the present paper. Close to resonance when interaction e ects are strong, it is not obvious that this approximation is adequate. However, the good agreement between the single channel therm odynamic calculations based on the ladder approximation and M onte C arb results indicate that the ladder approximation includes the most important physics, even close to resonance [13].

# V. COMPARISON W ITH BOSE FERM I EFFECTIVE THEORIES

A comparison with other recent low energy e ective theories for atom ic Feshbach resonances is now in order. M ost of these theories are based on a Bose-Ferm im odel where the presence of the Feshbach molecule is put in by hand as a point boson [4, 5]. In the present approach, on the other hand, the Feshbach molecule emerges dynam ically and is treated correctly as a composite twoferm ion object consisting of atom pairs in both the open and the closed channels. This allows for the description of e ects com ing from the two-ferm ion nature of the molecule through  $_{\rm c}$  in (13) or the term h(!) in (29)-(30). The sim plerBoseFerm itheory, which describes the Feshbach state as a point boson whose propagator has linear ! -dependence, is recovered only when h(!) = 0. Furtherm ore, the present theory provides expressions for all low energy scattering and bound state properties, including medium e ects in both open and closed channels, through the param eters  $a_s$ ,  $a_t$ , and  $r_C$  characterizing the atom -atom interaction and thus provides a nice link between am icroscopic (coupled-channels) description of the scattering and m ore phenom enological descriptions. This includes a physically clear picture of the various contributions to the magnetic moment of the Feshbach molecule. Once  $a_s$ ,  $a_t$ , and  $r_c$  are xed, our approach a ords a system atic description of Feshbach resonances in all the relevant channels.

### VI. RETHERMALIZATION RATE

Finally, we analyze a recent experiment on the Feshbach resonance at B<sub>0</sub> ' 201:6 G for <sup>40</sup>K atom s in the hyper ne states  $\mathcal{P}=2$ ; 9=2i and  $\mathcal{P}=2$ ; 7=2i. In refs. [7, 8], the elastic collision rate for <sup>40</sup>K atom swasm easured near this Feshbach resonance using the following retherm alization technique: The gas was \heated" preferentially in one spatial direction, and the relaxation tow and equilibrium with a uniform temperature in all directions was then followed in the time evolution of the rm scloud radii. The retherm alization rate was then extracted from an exponential t of the aspect ratio as a function of time.

A variational expression for the relaxation time of tem - perature an isotropies can be given [6] as

where  $f_0$  is the equilibrium distribution function for  $\mathcal{P}=2$ ; 9=2i and  $\mathcal{P}=2$ ; 7=2i atom s and where we treat the trap potential  $V_{\text{trap}}$  (r) using the Thom as Ferm i approximation with a spatially dependent chemical potential (r) =  $V_{\text{trap}}$  (r). The populations of  $\mathcal{P}=2$ ; 9=2i and  $\mathcal{P}=2$ ; 7=2i atom s are assumed to be equal. The deviation function appropriate for therm all an isotropy is

where d =d is the on-shell (! =  $p^2=2m + p_1^2=2m$ ) di erential cross section and is the solid angle for the direction of the relative outgoing momentum  $p_r^0 = (p^0 \quad p_1^0)=2$  with respect to the relative incoming momentum  $p_r = (p \quad p_1)=2$  [6]. The calculation of the integrals in (36) proceeds as in Ref. [14]. In the classical limit, these integrals can be evaluated analytically yielding

The factor of  $x^7$  in (41) comes from the weight function  $_{\rm T}$  appropriate for temperature relaxation. Note that (40) di ers from the averaged cross section arising from the collision relaxation time. The latter results from a therm all average of the cross section weighted with the relative velocity only, which corresponds to the factor  $x^3$  in (41).

We now use  $= m^2 J_{T_{oo}} \hat{J}^2 = 4$  with  $T_{oo}$  given by (29) to analyze the experimental data. In Refs. [7, 8], the experiments are performed at temperatures T  $2T_F$  and densities n  $10^{12}$  cm  $^3$ . We can therefore use the classical results (40) and (41). Likewise,  $T_{oo}$  in (29) can be approximated by the vacuum on-shell scattering matrix




FIG. 3: Fit to the experimental rethermalization cross section [8] with (41)-(42) for two values of the molecule magnetic moment at T = 4:4 K. The t parameters are given in (43) for = 0:118  $_{\rm B}$  and (44) for = 1:78  $_{\rm B}$ .

where q is the relative momentum of the two scattering atoms. At present, know ledge of the experimental value of the magnetic moment of the Feshbach molecule is limited. We therefore consider two cases of a large and a small value of . We take =  $0_{\rm B} E_{\rm th} = 1.78_{\rm B}$  from (4) as a large value and =  $0_{\rm C} = 0.118_{\rm B}$  from Ref. [5] as a small value. U sing (41)-(42), we can now analyze the experimental results [7, 8]. For the two values of

above, we tune the parameters B and  $a_{bg}$  keeping the resonance position xed at  $B_0 = 201.6 \text{ G}$ . The results of our ts are presented in Fig. 3. For  $= 0.118_B$  we nd

In Ref. [3], the authors give the tted values of the singlet and triplet scattering lengths as  $a_s = 104.8 a_0$  and  $a_t = 174 a_0$ . Substituting these values in (19), we nd  $a_{bg}$  '  $170 a_0$ , which is close to the value  $164 a_0$  reported in Ref. [15]. This value di ers som ewhat from ours ( $a_{bg}$  '  $290a_0$ ). The reason for this discrepancy can be the experim ental uncertainty in determ ining the num – ber of atom s trapped, and/or the fact that the authors in Ref. [3] use a di erent therm al averaging procedure than that given by (41) [16].

The t parameters (43)-(44) do not depend strongly on the value of the molecule magnetic moment at the tem perature T = 4:4 K. This is because В k<sub>B</sub> T for both values of :  $B = k_B = 55 \text{ K}$  for = 1:78 <sub>B</sub>. In  $B = k_B = 980$  K for 0:118 <sub>B</sub> and fact, the overall shape of the retherm alization curve as a function of B  $B_0$  (e.g. the position of the resonance and the magnitude of the maximum) becomes sensitive to only when




FIG.4: The retherm alization cross section (41) with (42) for two values of the molecule magnetic moment and the tem peratures T = 8 K and 20 K.The t parameters are given in (43) for = 0:118  $_{\rm B}$  and (44) for = 1:78  $_{\rm B}$ .

To illustrate this, we show in Fig. 4 the cross section (41) evaluated for tem peratures T = 8 K and T = 20 K and for the two values of above. We see a clear di erence in the shape of the curve depending on the tem perature.

The magnitude of the minimum of the rethermalization rate located at B  $B_0$  B (for  $k_B T$ 

B) is how ever sensitive to the tem perature even for  $k_B T$  B. This can easily be understood as follows. If one ignores the  $q^2$ =m term in (42), the cross section is identically zero for B  $B_0 = B$  for all q leading to a vanishing retherm alization rate. But from




FIG.5: The position B B  $_0 = B_{m in}$  and m agnitude h  $_{m in}i$  of the m inim al value of the retherm alization cross section as a function of the m olecule m agnetic m oment for T = 4:4 K, T = 8 K, and T = 20 K.

 $q^2 = m$  $k_B T$  is follows from (42) that the minimum of the retherm alization rate at B  $B_0$ B scales as B. Thus, the minimum  $k_B T =$ B for k<sub>B</sub> T of the rethern alization rate is sensitive to the tem perature or the value of the molecule magnetic moment even B. To illustrate this, we plot in Fig. 5 for k\_B T the position  $B_{m in} = B$   $B_0$  and the magnitude  $h_{m in}$  i of the minim al value of the retherm alization cross section as a function of the molecule magnetic moment for

T = 4:4 K, T = 8 K, and T = 20 K. We see that the position of the minimum does not depend on when  $k_B T$  B whereas the magnitude of the minimum value of the retherm alization rate does.

The tem perature dependence of the retherm alization rate could be used to determ ine the magnetic moment of the Feshbach molecule: One can measure this magnetic m om ent by tting the m easured retherm alization cross section as a function of temperature using the theory described above. A scan of tem peratures from k<sub>B</sub> T B to k<sub>B</sub> T B is likely to yield a fairly B, the Feshbach accurate value of .Fork<sub>B</sub>T resonance gives rise to a sharp maximum and minimum in the retherm alization scattering cross section whereas B, the retherm alization cross section is for k<sub>B</sub> T a much sm oother function of the B eld. Furtherm ore, if one is able to measure the magnitude of the minimum retherm alization rate which is sensitive to the tem perature for all T, the size of the magnetic moment can even be determined for  $k_{\rm B}$  T в.

## VII. EFFECTIVE RANGE

We now demonstrate that the energy-dependent, Feshbach-mediated interaction introduces a new length scale: the elective range  $r_{\rm e}$ . The elective range expansion for the vacuum scattering matrix is given by [17]

where  $a = a_{bg} \begin{bmatrix} 1 & B = (B & B_0) \end{bmatrix}$  is the resonant scattering length. This expansion can be obtained from (42) in the lim if  $\beta = B_0 j$  B with the elective range given as

The  $q^2 = m$  term in (42) coming from the momentum dependence of the Feshbach molecule energy can therefore introduces a new length scale: An elective range given by (47). Equation (47) was also derived in Ref. [18] in the context of a Bose-Ferm im odel.

Note that the e ective range given by (47) is negative as a direct consequence of the energy dependence of the multi-channel interaction. In a recent paper, nite range e ects on the physics of cold atom ic gases in the BEC-BCS crossover regime was exam ined using a single channel model [19]. The atom -atom potential used in Ref. [19] has a positive e ective range and thus does not provide a correct description of nite range e ects for resonant multi-channel atom -atom scattering. Sim ilarly, the e ective range of the single channel interaction used in a recent M onte-C arlo study also has r 0 [20]. In general, it is often di cult and som et in es in possible to obtain a negative e ective range in single channelm odels of resonant scattering. This feature em erges naturally in multi-channelm odels.

It is common to neglect the e ective range term by adopting a simple approximate form of the unitarized scattering matrix

This approximation leads to the idea of universality. When jaj! 1, the only remaining length scale in the problem is the interparticle spacing, and the properties of the gas should therefore be independent of the microscopic details of the atom -atom interaction. The physics of interacting gases in the universal lim it has been exam – ined by a number of authors [20, 21, 22, 23]. How ever, we have now demonstrated explicitly that there is an additional length scale in the problem given by (47). This length scale can be neglected only when calculating properties with a typical wave length q for which  $qr_e$  1; the therm odynam ic properties of the gas are independent of  $r_e$  only when

where  $r_{12}$  is the average interparticle spacing. For low temperatures where q  $k_{\rm F}$ , using (47), this condition can be written as

The simple unitarized form for the scattering given by (48) therefore holds only for broad resonances as de ned by (50). In particular, one can expect universal behavior only for such broad resonances [18].

For the Feshbach resonance for  $^{40}$ K at B  $_0$  ' 201:6G, 10G and  $a_{gq}$ 290a, as explained we nd B  $_{\rm B}$  and  $_{\rm F} = 10^{-6} {\rm K}$ , this yields above. A ssum ing  $_{\rm F}$  =k<sub>F</sub> a<sub>bg</sub> and one would expect the gas to ex-B hibit universal behavior close to resonance. This is also true for the very broad resonance for  $^{6}$ Liat B ' 830G 300G.However, for the narrow <sup>6</sup>Liresonance with B at  $B_0$  ' 543G, B = 0.23G, and  $a_{bg}$ 80a [11], we nd  $3k_{\!F}\,a_{bg~B}$  B for  $_F$  = 10  $^6K$  . One can therefore F not expect the e ective range to be an irrelevant length scale for this narrow resonance.

### VIII. CONCLUSIONS

A low energy e ective theory for the in-medium scattering of alkali atom s was obtained using a microscopic multi-channel description of the atom -atom interaction. Expressions for all scattering properties in term s of a few parameters characterizing the atom -atom potential were derived thereby providing a link between a microscopic multi-channel description of Feshbach resonances and more phenomenological approaches. The presence of a Feshbach resonance emerged naturally from the theory as a two-particle bound state, and the energy dependence of the Feshbach-mediated interaction was shown to introduce a negative e ective range inversely proportional to the width of the resonance. Furtherm ore, m edium e ects arising from the occupation of both open and closed channel states were calculated. The theory was shown to allow the explicit calculation of corrections to commonly used approximations such as the neglect of the e ective range and the treatment of the Feshbach molecule as a point boson. We also analyzed a recent retherm alization experiment on <sup>40</sup>K atom s and

showed that measurement of the rethermalization rate as a function of temperature would permit the determ ination of the magnetic moment of the Feshbach molecule.
