## Nature of perturbation theory in spin glasses

The high-order behavior of the perturbation expansion in the cubic replica eld theory of spin glasses in the param agnetic phase has been investigated. The study starts with the zero-dimensional version of the replica eld theory and this is shown to be equivalent to the problem of nding nite size corrections in a modil ed spherical spin glass near the critical tem perature. We nd that the high-order behavior of the perturbation series is described, to leading order, by coe cients of alternating signs (suggesting that the cubic eld theory is well-de ned) but that there are also subdom inant terms with a complicated dependence of their sign on the order. Our results are then extended to the d-dimensional eld theory and in particular used to determ ine the high-order behavior of the terms in the expansion of the critical exponents in a power series in = 6 d. We have also corrected errors in the existing expansions at third order.

#### I. IN TRODUCTION

The theory of spin glasses in nite dimensional system s has traditionally been approached by the loop expansion around Parisi's mean-eld replica symmetry breaking solution [1]. However, the picture of spin glasses which emerges from this perturbative approach is quite dierent to the one arising in droplet theory [2]. The motivation for the present paper was to investigate the possibility that perturbation theory in spin glasses might fail for some reason (for example, non-perturbative terms like \droplets" might dom inate their free energy, at least in the low-temperature phase). We have started the programme with a study of the nature of the perturbation expansion in the high-temperature or param agnetic phase, and postpone to another paper the discussion of the low-temperature phase.

In general the nature of perturbation expansions in disordered system is far from trivial. This is in contrast to the perturbation theory in pure systems, where, for example, the Borel sum m ability of the series leads to an accurate evaluation of critical exponents [3]. In the study of the perturbation expansion for disordered ferrom agnets, Bray et al. [4] found that even in zero dimensions, the high-order behavior of the perturbation expansion was surprisingly rich. The high-order expansion coe cients are sum s of two kinds of term s: one type has an unusual cosine-like oscillation with increasing periodicity and the second type has a simple alternation in sign which dom inates for smalldisorder. This unusual behavior has been further studied in Refs. [5], [6], with the nal conclusion that the series is still sum m able, but that the sim ple Borelprocedure needs to be modi ed to deal successfully with long series. We shall nd that the perturbation expansion for spin glasses has remarkably similar features to those of the disordered ferrom agnet.

0 ur investigation of the nature of the perturbation expansions in the high-tem perature phase of spin glasses starts by boking at the perturbation expansion of the zero-dimensional spin glass problem (which will be referred to as the \toy" problem). The zero-dimensional eld theory is the key to the analysis of the d-dimensional

eld theory as the extension to the d-dimensional eld theory and critical exponents is a relatively straightforward extension of the toy problem [7]. A part from being simple integrals, the zero-dimensional toy eld theory has the advantage of allowing an analysis without replicas. In this paper this is achieved by mapping the problem to that of critical nite-size scaling in a modi ed version of the spherical spin glass [8] and this mapping allowed us to nd the high-order behavior without the use of replicas. However, to obtain the high-order behavior of the perturbation expansion for the d-dimensional eld theory requires the use of replicas and we found that this needed the use of a non-trivial replica sym m etry breaking scheme in the toy model in order to get results consistent with our mapping to the spherical model. Our chief result is that the perturbation theory is well-de ned and the dom inant high-order terms in the perturbation expansion have coe cients of alternating signs. However, the perturbation series of the zero-dim ensional spin glass eld theory is not Borel sum mable in a straightforward way due to the presence of subdom inant term s.

The paper is organized as follows. In the next section, we consider the cubic replica eld theory of spin glasses and obtain the rst few expansion coe cients of the zero-dimensional toy problem by explicitly evaluating the Feynm an diagram s. In Sec. III, we show the equivalence of the zero-dimensional eld theory and the critical nite-size scaling of the modil ed sphericalm odel. Using this mapping we obtain the high order behavior of the perturbation expansion for the toy problem in Sec. IV. In Sec. V, we consider the toy problem using replicas. This is generalized to the problem of the high order terms in the expansion in Sec.VI. We conclude with a discussion in Sec.VII.

#### II. REPLICA FIELD THEORY OF SPIN GLASSES

The replica eld theory of spin glasses, (see Ref. [9] for a review), starts from the Ham iltonian density

A susual the eld components q ( 🗧 and q = q) take all real values, and the indices such as take the values 1;2;3;:::;n. In the lim it when n goes to zero, such a eld theory is thought to capture the physics of nite dimensional spin glasses. The quartic term s work as stabilizing term s, but for d < 6 are irrelevant variables which we shall drop. One question which we shall ask is whether the resulting cubic eld theory is well-de ned in the limit n ! 0. It is possible this approach may not be valid as cubic theories have H am iltonians which are not bounded below [7]. However, there are examples of eld theories existing where unphysical limits, such as the number of eld components n is taken to zero, which saves these apparently unphysical theories [7, 10]. This seems also to be the case for spin glasses as our work shows that the coe cients in the perturbation expansion in walternate in sign, which is an indication that the eld theory remains well-de ned in the limit when n goes to zero.

The partition function of the zero-dimensional spin glass eld theory is given by


The perturbation expansion is well-de ned irrespective of whether the integral of Eq. (2) actually exists. The perturbation expansion in w yields a series

where we take  $g^2 = w^2 = (=2)^3$  as the expansion parameter of the problem. The use of =2 instead of is for later convenience. The series expansion of the corresponding free energy is given by

A lthough this zero-dimensional theory is nothing but a multiple integral, it is not an easy task to calculate the expansion coe cients A  $_{\rm K}$  or B  $_{\rm K}$  directly by expanding




FIG. 2: Feynm an diagram s to 0  $(g^8)$  contributing to the renorm alized vertex with their corresponding contributions.

the exponential in (2), because of the complicated structure of the internal summations. In fact, even using a symbolic manipulation program on a computer, we nd it very di cult to get the expansion coe cients higher order than the rst couple of terms. Fortunately, in the study of a cubic eld theory sim ilar to ours { the percolation problem [11] { di erent types of the internal contractions occurring in the theory were classi ed diagram m atically, and all the relevant diagram swere given up to O (g<sup>8</sup>). To this order there are ve di erent internal contraction types. (See the diagram s denoted by , , , and in Figs. 1 and 2.) These were translated into the spin glass problem in Ref. [12]. In Figs. 1 and 2, all the diagram s to this order contributing to the renorm alized propagator and vertex are listed along with their contributions. Note that, in the zero-dimensional eld theory, each contribution is just given by the product of these contraction factors.

The expansion coe cient B  $_{\rm K}$  of the free energy can be obtained by noting that (0, F)=0 w is just the renormalized three-point function, which can be written in terms of the renormalized propagator and vertex. Collecting the contribution from each diagram and using the results of the internal contractions, we calculate the perturbation expansion coe cient B  $_{\rm K}$  up to four-loop order  $(0 (g^8))$ . We nd that  $B_{\rm K} = \frac{1}{6}n (n-1) (n-2) f_{\rm K} = 8^{\rm K}$ , where  $f_1 = 1=2$ ,  $f_2 = n-2$ ,  $f_3 = 4n^2 - 31n=2+44=3$  and  $f_4 = 22n^3 - 123n^2 + 229n - 148$ . Therefore, the free energy for the toy spin glass problem,  $\lim_{n \to \infty} n! \circ F = n$ , is given by a power series in  $g^2$  with coe cients of alternating signs up to 0 ( $g^8$ ).

In the course of investigation, we have discovered errors in two (and in Figs. 1 and 2) of the ve types of contraction reported in Ref. [12]. The correct results we obtain are =  $n^3 - 9n^2 + 54n - 104$  and =  $5n^2 - 14n$ ,

while the results in Ref. [12] were =  $n^3 3n^2 + 38n 94$ and =  $5n^2 2n 12$ . The latter can easily be shown to be incompatible with the simple n = 3 case. These corrections will change the O (<sup>3</sup>) terms in the critical exponents in d = 6 dimensions. From the explicit expressions for the critical exponents and obtained in Ref. [11], we calculate the correct form of the expansion to third order to be

The corrected series for  $\ ^1$  2+ shows an oscillation in signs in contrast to the one in Ref. [12] where the O ( $\ ^3$ ) term was positive.

#### III. MAPPING OF THE TOY PROBLEM ONTO A MODIFIED SPHERICAL MODEL

As mentioned in the Introduction, we study the zerodimensional eld theory by mapping it onto a modied version of the spherical spin glass model. The Ham iltonian of the spherical model is

with the spherical constraint  ${}^{i}_{i}S_{i}^{2} = N$  among the N spins. Unlike the conventional spherical spin glass model [8], we take  $J_{ii} \notin 0$  in addition to the in nite-ranged

interactions  $J_{\rm ij}$  =  $J_{\rm ji}$  (i f j). They are chosen from G aussian distributions

The presence of the diagonal interaction does not make any di erence in the N ! 1 limit. In the following, however, we consider nite size corrections in this model. The partition function can be written as

where = 1=T is the inverse tem perature and the chem icalpotentials was introduced to represent the delta function (N  $_{i}S_{i}^{2}$ ).

In order to make a connection to the replica eld theory (2), we replicate the partition function n times and average over the Gaussian bond distribution. We then take the usual H ubbard-Stratopovich\_p(HS) transform ations on the factor exp[( $^2=4N$ ); ( $_iS_iS_i$ )<sup>2</sup>] to get the spins on the same site, where the Greek indices denote the replica components. In order to do that, we need to introduce the diagonal q and o -diagonal q ( $\epsilon$ ) elds for the corresponding factors. We have

W e can then integrate over the spin variables to obtain the replicated partition function as integrals over the HS elds, q and q and over the replicated chem ical potential z :

where tr is taken with respect to the replica index.

In the large-N limit, these integrals can be evaluated by the steepest descent method. For  $T > T_c$  1, the saddle points are at q = 0,  $q = {}^2$  and  $z = + {}^1$ . This is the well-known result [8] from the N ! 1 analysis of the spherical spin glass. We investigate the nite-size corrections in the limit T !  $T_c = 1$  by considering the uctuations around these saddles. Writing  $q = {}^2 + y$  and  $z = 1 + {}^2 + ix$ , we have

where  $C = \exp((nN = 2)(1 + 2 = 2))$ . If we expand the logarithm in powers of the elds, we not that the quadratic terms in the diagonal elds x and y inside the exponential are given by

D iagonalizing this quadratic form, we nd two eigenvalues with nonvanishing negative real parts at  $T = T_c$ , which implies that the diagonal elds are hard modes near  $T_c$  and can be integrated away without encountering divergences. Therefore the critical behavior is described by the o -diagonal partition function, which can be written as

where the quartic and higher order terms in q all have coe cients proportional to N . A key point of this discussion is to note that, in the lim it where t  $(T T_c)=T_c$ ! 0 and N ! 1, the quartic and higher order term s can be neglected if we keep N  $t_p^3$  <u>nite</u>. This can be easily seen by rescaling q ! q = N tin (15). In fact we can show that the o -diagonal partition function in this lim it is exactly the same as the zero-dimensional cubic eld theory de ned in (2) and (3) after identifying the expansion param eter as  $g^2 = 1 = (N t^3)$  and  $= T^2 = 1 = t(2 + t) ! 2t$ ast! 0. We have  $Z_{\circ}$  (N; )!  $Z\left(\frac{1}{N+3}\right)$  as N! 1, t! 0 and N t<sup>3</sup>! nite. A similar observation was made for the critical nite size corrections of the Sherrington-K inkpatrick m odel in R ef. [13]. (In this paper, the series for the free energy of the toy model was given to order g<sup>4</sup>).




FIG. 3: The integration contour C<sub>sp</sub> used in Eq. (16). The lled circles represent the eigenvalues J schematically. The largest and the second largest eigenvalues are denoted by  $J_1$ and  $J_2$ , respectively.

# IV. HIGH-ORDER BEHAVIOR OF THE EXPANSION COEFFICIENTS:TOY PROBLEM

#### A. Leading-order behavior

Having established the equivalence of the modi ed spherical spin glass model to the cubic replica eld theory, we can analyze the toy problem (2) without using the replicas. Integrating over the spin variables in (9), we obtain

where J denotes the eigenvalue of the m atrix  $J_{ij}$ . Note that the contour  $C_{sp}$  of integration lies to the right of the largest eigenvalue  $J_1$ . (See Fig. 3.)

For large N , the integral is dom instead by the saddle point determ ined by

In the lim it N ! 1, one can evaluate the sum on the right hand side using the W igner sem icircle law for the eigenvalue density (J) [8]. Here we are interested in the nite N corrections, in particular, the lim it where N ! 1 and t ! 0 with N t<sup>3</sup> held xed. In this case, one has to nd a solution z of (17) for given bond realization  $J_{ij}$ , then calculate the free energy T ln Z sp from (16), which has to be averaged over the bonds. This is an extrem ely di cult task to carry out analytically. Instead here we make a self-consistent approximation where we assume




FIG.4: (a) The disorder distribution responsible for the dominant high-order behavior. The largest eigenvalue  $J_1$  is far away from the saddle point that the contour passes through. The rest of the eigenvalues (the shaded region) are approxim ated as a continuum distribution. (b) The disorder distribution for the sub-dom inant high-order behavior. The separation between the eigenvalues  $J_1$  and  $J_2$  is large so that the eigenvalues sm aller than  $J_2$  can be approximated as a continuum.

the saddle point is located well away (in the sense to be speci ed below) from the largest eigenvalue  $J_1$ . Since the eigenvalues can be regarded as one-dimensional electric charges interacting logarithm ically [14, 15], an analogy to the multipole expansion in electrostatics suggests that we can treat the eigenvalues less than  $J_1$  as a continuous distribution given by the sem icircle law. That is to take

In the limit of N  $\,!\,$  1 , t = (  $^1$   $\,$   $J_1=2)\,(2=J_1)\,$  ! 0 (T<sub>c</sub> =  $J_1=2$ ), and nite  $\,$  N  $^{1=3}$ t, we nd that the distance of the saddle point from  $J_1$  is scaled as z  $\,$   $J_1$  O (N  $^{2=3}$ ). In terms of  $\,$  N  $^{2=3}$  (z  $\,$   $J_1$ )(2=J\_1), the saddle point equation (17) reduces to  $\,$ =  $\,$  1= in this approximation. As will be shown below, the high-order behavior of the perturbation expansion is described by the small g^2 (or large ) behavior of the partition function. The distance of the saddle point from the largest eigenvalue (m easured in terms of ) will be large for large

and therefore the approxim ation can be justiled for determ ining the high-order coel cients of the perturbation expansion. (See Fig. 4 (a).)

W ithin this approximation, the sum in (16) consists of

the term involving  $J_1$  and

where the prime indicates the largest eigenvalue is excluded from the sum. By changing the integration variable to in (16) and taking the large-N lim it, we obtain

where  $f_0 = J_1=2+(1=2) \ln (J_1=4)+1=4+t^3=6$  and the contour C starts from j j=1 with arg() = =4 and extends to j j=1 with arg() = =4. We can evaluate the above integral explicitly as

where A i is the A iry function. We note that the above expression is valid for both  $T > T_{\rm c}$  ( > 0) and  $T < T_{\rm c}$  (< 0). Since the argument of the A iry function is an even function of , we obtain, in the large-N lim it, A i( $^2$ =4) exp[ j j=12)=2 j j using the asymptotic behavior of the A iry function. Therefore, above  $T_{\rm c}$ , the leading contribution to the free energy density, N $^1$  ln  $Z_{\rm sp}$ , in the large-N lim it is just  $f_0$ . On the other hand, below  $T_{\rm c}$ , it is given by  $f_0$  t $^3$ =6.0 ne can explicitly check that these quantities coincide with the free energy densities given in Ref. [8] for the spherical model when T approaches  $T_{\rm c}$  from above and below .

We now consider the nite size corrections above  ${\rm T_c}$  . To do this we introduce  ${\rm Z_1}$  by writing (20) as

Note that the square root in the denom inator of (22) comes from the Gaussian uctuations around the large-N saddle point. The nite size corrections relevant to the zero-dimensional cubic eld theory comes from  $Z_1$ , since we can show that  $Z_1 = Z_1 (g^2)$  is a function of the expansion parameter  $g^2 = {}^3$  only. It is given by




FIG. 5: The rotated contours used in Eq. (23) for (a)  $\arg(g^2) =$  and (b)  $\arg(g^2) =$ . The insets show how these contours must be deform ed to pass through the saddle points u = 0 and u = 1 (led circles).

where  $u = g^{2=3}$ . A lthough  $Z_1$  ( $g^2$ ) can be evaluated analytically as in (21), we calculate the high-order expansion  $\infty$  e cients of  $Z_1$  by an indirect m ethod, where the self-consistency of our approximation is more apparent. (Remember that we are striving to get the behavior of the high-order  $\infty$  e cients exactly; our approximation of the

distribution of the eigenvalues as a continuum described by the sem icircle law does not give the correct low -order coe cients in the expansion of the free energy). From the integral representation (23), we can analytically continue  $Z_1$  (g<sup>2</sup>) to any complex g<sup>2</sup> by rotating the contour appropriately. We nd that  $Z_1$  has a branch cut along the  $g^2$  < 0 axis. The imaginary part of  $Z_1$  is discontinuous crossing this axis. For small igf, we can evaluate the discontinuity by the steepest descent method. For arg  $(g^2) =$ , the contour C is rotated by =3 as shown in Fig. 5. Am ong the two saddle points u = 0 and u = 1 that C can pass through, the latter produces a real quantity which is the same for arg  $(g^2) =$ ,while the form er is responsible for the discontinuous in aginary part




FIG.6: The integration contour in the  $g^2$  space used to determine the expansion coe cients a  $_{\rm K}\,$  in Eq. (25). The integral reduces to the one along the branch cut on the  $g^2 < 0$  axis as the contribution from the circle vanishes when the radius gets large.

This can be used to extract the coe cients A  $_{\rm K}\,$  of the perturbation expansion. We follow the standard procedure [16, 17] by writing a dispersion relation for Z $_1\,(g^2)\,$  for  $g^2\,>\,0$  in terms of an integral over a contour that runs around the cut in the negative  $g^2\,$  axis. (See Fig. 6.) Therefore, the coe cients a  $_{\rm K}\,$  lim  $_{n\,!\,0}\,A_{\rm K}$  =n of the perturbation expansion in the toy spin glass eld theory is given by

For large K , this integral is dominated by the saddle point  $g^2 = 1 = (6K)$ . This implies that the information on Im  $\rm Z_1~(g^2)$  for small  $g^2$  can be used to obtain  $\rm A_K~$  for large K , which justi es the present approximation. We nally obtain

The coe cients with alternating signs are consistent with the low -order behavior obtained in Sec. II.

#### B. Subdom inant behavior

There can be other contributions to the free energy from di erent disorder distributions. For example, when the eigenvalues are distributed in such a way that the saddle point is not very far from the largest eigenvalue, the above approximation breaks down. In this case, we expect a di erent behavior of the free energy. To handle this, we again make an approximation which can be justied self-consistently. We consider a disorder distribution where the second largest eigenvalue  $J_2$  is well separated from  $J_1$  such that the spectrum below  $J_2$  can be described by the sem icircle law. (See Fig. 4 (b).) This assumption

is justi ed in the following analysis. We approximate

where the double-primed sum excludes = 1 and 2. This sum can be evaluated as in (19) with  $J_2$  replacing  $J_1$ . W e make the same series of integration variable changes leading to (20) and (23) (using N<sup>2=3</sup> (z  $J_2$ ) (2= $J_2$ ) and  $T_c = J_2=2$  in this case), and take the large-N limit. W e obtain  $Z_{sp}$  ' e<sup>N fo</sup>Z<sub>2</sub> where  $f_0$  is the same as before with  $J_1$  replaced by  $J_2$  and

with the eigenvalue spacing N  $^{2=3}$  (J<sub>1</sub> J<sub>2</sub>) (2=J<sub>2</sub>). (Recall g  $^2$  =  $^3$ .)

The contribution from this arrangement of disorder to the free energy, which we denote by  $F_{\rm sub}$ , is obtained by averaging  $\ln Z_2$  over the distribution p() of the eigenvalue spacing . Among the subdom inant contributions to the high-order behavior, we focus on those from possible zeros of  $Z_2$ . By explicitly evaluating the contour integral (29) numerically for given g, we nd that there exists a complex conjugate pair of zeros,  $_0$  and  $_0$  in the complex- plane. To make analytic progress

on the contribution from these zeros, we look at the uctuation around the saddle point u = 1. By writing  $u = \frac{1}{p} \frac{1}{q=2} \mathscr{E}_2$  (g<sup>2</sup>; ), where

with  $v = (1 g^{4=3}) = (2g)$ . Note that v is assumed to be of O (1), which means O (g<sup>4=3</sup>). This is consistent with the present approximation where the separation of eigenvalues is very large. W riting

The zeros of  $\mathscr{B}_2$  come from the in nitely many zeros of the modi ed Bessel function K  $\frac{1}{4}$  [5, 6]. We can arrange them as complex conjugate pairs,  $v_m$  and  $v_m$ , m = 0;1;2;:::, given approximately for large m by

Am ong the in nitely many zeros, we focus only on the pair  $v_0$  and  $v_0$  closest to the origin as our num erical evaluation of zeros of (29) is consistent with  $_0 = (1 \quad 2gv_0)=g^{4=3}$  for small g. The other zeros probably give only subdom inant contributions com pared to the rst ones.




FIG. 7: The deformed contour in  $g^2$  space that leads to Eq. (35). The branch points  $g_0^2$  and  ${g_0}^2$  correspond to the zeros of the logarithm .

The subdom inant contribution to the expansion coefficient denoted by  $\mathbf{e}_K$  can be calculated as

The integral over  $g^2$  is done by deforming the contour such that it runs along a circle of radius R and around the branch cuts associated with the zeros,  $g_0^2$  and  ${g_0}^2$  of  $\hat{\mathcal{F}}_2$  for xed . (See Fig. 7.) The integral along the circle vanishes as R ! 1 and we have

The eigenvalue spacing distribution is known [15] to take the form  $p() \exp(((^2=16)(=D)^2))$  for large when them ean eigenvalue spacing is D. From the num erical results in Ref. [18] on the eigenvalue spacing distribution of real symmetric matrices, we can calculate the mean spacing near the edge of the spectrum as D ' 2:30. The integral over in (35) can be done using the steepest descent method for large K. The saddle point for the rst term in (35) is given by

where =  $^2$ =(12D  $^2$ ) ' 0:155. Note that the large-K behavior corresponds to small g and large with g  $^{4=3}$ , which m eans that these results are entirely in the regime of the present approximation. Inserting these into (35) we nally obtain

where  $a = \frac{3+4}{4}$  / 4:05,  $b = 3 \frac{3+8}{8} \operatorname{Re}(v_0)$  / 3:15 and  $c = 3^{3=8}$  Im (v<sub>0</sub>) ' 3:38. Compared with (26), this is a subdom inant contribution containing only a fractional power of K !. The coe cients do not alternate in sign as in (26) but oscillate with a cosine function with an increasing periodicity. The situation is similar to that in the zero-dim ensional disordered ferrom agnets [4, 5, 6], where this type of oscillation also occurs in the subdom inant term s. W e expect that as in the case of disordered ferrom agnets the subdom inant term sm ake the resum m ation of the series non-trivial such that a straightforward Borelsum m ation is spoiled. However, it seems likely that the series could be resum m ed in other ways and anyway, the evidence from Ref. [4] suggests that the straightforward Pade-Borelm ethod works well for short series even in the presence of subdom inant term s.

There are obviously other types of bond distribution which could give rise to subdom inant contributions to the high-order behavior of the perturbation series besides the one studied in this subsection. We suspect that the type studied here provides the largest of these contributions but we have no proof of this.

#### V. REPLICA APPROACH TO HIGH ORDER BEHAVIOR IN THE TOY PROBLEM

W hile the mapping of the toy integral, Eq. (2), to the spherical model has enabled us to obtain direct estimates for the high-order terms of its perturbative expansion, in order to obtain high-order estimates for the ddimensional eld theory and hence for critical exponents we have to discover how to obtain the same high-order estimates directly from the integral in the replica variables q . Once this has been done the extension to eld theory is relatively straightforw ard and is carried out in the next Section. Unfortunately the direct replica approach is neither obvious nor rigorous. W ithout the results obtained from the mapping to the sphericalm odelwewould have had no con dence in the replica procedure which we were forced to use.

It is useful to rst exam ine the integral for the special case of n = 3 when the integrals can be done explicitly and exist if w is pure in aginary. This case was analyzed in Ref. [7]. Here we follow the same analysis to clarify some points which will be in portant in the case of general n. For n = 3, we have after setting = 1 for simplicity

with the modied Bessel function I (x). For pure imaginary coupling w =  $iw_{p}^{0} w^{0}$  real, f =  $(=3)J_{1=6}$  ( $w^{0}R^{3}=6^{-3}$ )J<sub>1=6</sub> ( $w^{0}R^{3}=6^{-3}$ ) with the ordinary Bessel function J (x). We can easily see that the integral in (39) is well-de ned and real in this case.

W hen analytically continued to real coupling w,  $Z_3$  develops an in aginary part which is discontinuous crossing the branch cut along the real w axis. For sm all values of coupling, one can calculate the discontinuity using the steepest descent method on the integral in (39). Since the main contribution to the imaginary part comes from the saddle point R = O (1=w), we rst study the asymptotic behavior of f when jw R<sup>3</sup> j is very large, which is

The above expansion is valid for 0 arg (w) , or for  $\arg(w^2)$  2. For  $\arg(w) = 0$ , only the rst ex-0 ponential in (41) is important and the integral in (39) is dom instead by the saddle points  $R_1 = 0$  and  $R_2 = \frac{7}{3} = w$ . The steepest descent direction at R<sub>2</sub> is perpendicular to the real-R axis along which the integral generates the im aginary part. W e can deform the contour in (39) such that it starts from R<sub>1</sub> along the positive real-R axis toward  $R_2$  and makes an upward turn at  $R_2$ . (Examples of sim ilar deform ations are in Ref. [19].) We note that, since we only pass a half of the steepest descent path of  $R_2$  in this way, the Gaussian integral coming from the uctuation around R<sub>2</sub> produces a half of the total uctuation contribution. Keeping this in m ind, we evaluate the integral to obtain  $\text{Im } \mathbb{Z}_3$  (w) = exp( $\frac{1}{2w^2}$ ) for  $\arg(w) = 0.$  For  $\arg(w) =$ , the saddle points  $\operatorname{are}^{n} R_{1}^{0} = 0$ and  $R_2^0 =$ 3=w and the continuation of the contour used for arg (w) = 0 to this case is the one which makes

where the positive and negative signs correspond to  $\arg(w^2) = 0$  and  $\arg(w^2) = 2$ , respectively. This exponentially small in aginary contribution to the partition function at the physical coupling can be used to determ ine the large order behavior of the perturbation expansion, but at the same time its presence indicates that the cubic eld theory for n = 3 is ill-de ned and requires stabilizing quartic terms for its existence.

W e now study the case of generaln. For sm allvalues of the expansion parameter,  $w^2 = (=2)^3$ , we can evaluate the integrals in Eq. (2) using the steepest descent method. Saddle points are found by solving

The trivial solution of this equation q = 0 is the starting point of the perturbative expansion. Non-perturbative terms arise from its non-trivial solution. The set of saddles which we study are q = q, when both and lie in the interval between 1 and r, where and  $q = = (r \ 2)w$ . This can be described schem atically as

C learly other types of saddle exist besides this. We rst focus on this class of saddles, which we call scheme I. The H am iltonian density for this saddle is given by

There are more solutions to Eq. (43) with the same H am iltonian (45), which can be obtained by switching the signs of some of q . One can take, for example,  $q_1 = q$  for  $\notin 1$ , and q = q for ;  $\notin 1$ . Since one can pick any other subscript than 1, the number of such solutions is r. One can also switch the signs of two di erent sets such as  $q_1 = q_2 = q$  for  $\notin 1;2$  and keep all the other elements q = q. The number of such solutions is r(r 1)=2. Sim ilarly, one can switch the signs of 3;4;:::;r 1 di erent sets of q . However, we can show that the solutions obtained by switching the signs of k di erent sets for k = 1;2;:::;r 1. Therefore, the total number S (r) of the solutions with the H am iltonian (45) is

We need to include the G aussian uctuations around these saddles. The matrix of the second derivatives has six distinct eigenvalues: a \breather" mode with eigenvalue which is non-degenerate, one other negative eigenvalue,  $=(r \ 2)$  which is  $(n \ r)$ -fold degenerate, and eigenvalues  $2 = (r \ 2)$ ,  $(r \ 1)$ -fold degenerate,  $r = (r \ 2)$ ,  $(r(r \ 3)=2)$ -fold degenerate,  $(2r \ 3) = (r \ 2)$ ,  $(r \ 1)(n \ r)$ -fold degenerate, and ,  $(n \ r)(n \ r \ 1)=2$ fold degenerate. Setting = 1 for sim plicity and collecting the contributions from the saddle points to G aussian order, we obtain



where the rst term corresponds to the usual perturbation expansion in w. The sum over r starts at 3 since in Eq.(43) the index must dier from both and . The factor<sup>n</sup>C<sub>r</sub> denotes the num ber of ways of introducing r non-zero blocks. Collecting the contributions from the saddles in this way, instead of deform ing a contour in a multidim ensional complex space, determ ines the partition function up to an overall factor. The analysis of the n = 3 case suggests that there is an overall factor of 1=2coming from the fact that, for the nontrivial saddles, only a half of the Gaussian integrals contribute com pared to the perturbative one. Indeed, for n = 3, one can explicitly check that the non-perturbative part of (47) reduces to Eq. (42). The negative eigenvalues are responsible for the factor  $(1)^{(n + 1)=2}$ , which generates the imaginary part in Z.

For nite n, the saddles in the scheme I correspond to the partition function which is well de ned except for realw resulting in a branch cut on the positive  $w^2$  axis. The discontinuity of the imaginary part across the cut is exponentially small exp  $(n(n 1)=(12(n 2)^2w^2))$ . (The imaginary part of (47) is dominated by the r = nterm, since the H am iltonian (45) decreases m onotonically as r increases.) If the cubic spin glass eld theory is wellde ned for real coupling w , we expect that the  $\operatorname{cut} m$  oves to the negative w<sup>2</sup> axis as we take the n ! 0 lim it and that there is an exponentially sm all discontinuity across the negative  $w^2$  axis. The migration of the cut as the analytic continuation of n ! 0 is taken is exactly what happens in the percolation problem [7]. In that case, the Ham iltonian H<sub>s</sub> for the saddles depends explicitly on n such that it changes sign as n ! 0. In the present case,  $H_{s}$  in (45) is independent of n, and there is no way of producing an exponentially sm all discontinuity across the

negative  $w^2$  axis from these saddles. Therefore, we conclude that the saddles in the scheme I are not su cient to describe the partition function in the n ! 0 lim it.

This observation leads us to consider another type of solution of Eq. (43), which we call scheme  $\Pi$ . It is inspired by the replica symmetry breaking scheme used by two of us [20] to describe the free energy uctuations. Instead of taking all q nonzero for ; = 1;2:::r as in the previous scheme, we set q = q only when and belong to the m blocks of size r=m on the diagonal of the r r m atrix as



The key point of the construction of these saddles is that we let m ! 1 before n ! 0. For nite m, this scheme is just a generalization of the scheme I which produces only subleading term s. For m ! 1, however, the H am iltonian becomes

which has the opposite sign to the one in the scheme I. This can now describe the partition function where the cut lies on the imaginary w axis. The solution to (43) is  $q = = (r=m \quad 2)w ! = 2w \text{ as m } ! 1$ .

The matrix of the second derivatives necessary to include the Gaussian uctuations around the saddles, has two distinct positive eigenvalues, =2 and , which are, respectively, r (n r)-fold and (n r) (n r 1)=2-fold degenerate. There exist a null eigenvalue, r (r 3)=2-fold degenerate, and one negative eigenvalue , r-fold degenerate. This negative eigenvalue is responsible for the factor ( )  $\frac{1}{2}$  which generates the imaginary part for odd values of r. The total num ber of solutions that can be obtained by switching the sign of q is  $[S(r=m)]^n ! 2^{r=2}$ asm! 1. (This limit exists if we assume r=m is even.) From (49), we can see that the saddles with sm allest r dom inate for pure in aginary w. Therefore, the leading contribution to the imaginary part of (50) should come from the rst i.e. r = 1 term as we can see no reason why it should be excluded in this kind of replica symmetry breaking scheme. Thus

We nally obtain the discontinuity of the imaginary part of the partition function (2) in the lim it n ! 0 across the cut on the imaginary w (w<sup>2</sup> < 0) axis as

W e cannot obtain the precise prefactor to the exponential term because we have neglected the contributions of the m assless eigenvalue. In principle, this soft m ode could be integrated out by identifying the underlying sym m etries associated with the saddle point. This does not seem obvious to us. However, its contribution is subdom inant to that from the exponential and we shall ignore its contribution.

The discontinuity in the imaginary part of the partition function can be used to extract the coe cients A  $_{\rm K}$  of the perturbation expansion. To do that we write the above result in term s of the expansion parameter  $g^2$ . Recalling = 2t, we can write the right hand side of Eq. (51) as exp(1=6g<sup>2</sup>) for arg(g<sup>2</sup>) = . This is the same as Eq. (24) up to the undeterm ined prefactor. Therefore we obtain exactly the same high-order behavior as in (25)

W ithout the spherical model mapping one would have had reservations about the likely correctness of the replica procedure used.

### VI. HIGH ORDER TERMS OF THE EXPANSION

The starting point for obtaining the large order form of the expansion is the H am iltonian of Eq. (1) but without the quartic term s:

O ur treatm ent closely follows that of M cK ane [7]. The saddle points which are the analogue of Eq. (43) of the toy replica calculation are the instantons which satisfy the equation

For evaluating the high-order coe cients in the expansion we can set = 0 and look for a solution of the form  $q = w^{-1} d_{-c}(r)$  in d = 6 dimensions. Such a solution, which decouples replica indices from the spatial dependence r, exists if

There are spherically symmetric solutions of Eq. (56):

where the parameter releases the dilatation invariance of Eq. (56). We shall take for d the replica symmetry broken solution of scheme II. Then the energy of the instanton is

U sing the result that

the energy of the instanton is

$$E = \frac{1152^{-3}}{5} \frac{1}{48w^2} = \frac{3}{40g_R^2}$$

where  $g_R^2 = K_6 w^2$  and  $K_6 = S_6 = (2)^6$  and  $S_6 = {}^3$  is the surface area of a six dimensional sphere of unit radius.

The leading term s in the large order behavior of the expansion are obtained by replacing  $g_R^2$  by its xed point value, which to lowest order is =2 [12] and by the usual saddle-point arguments the coe cient of  $^K$  for large K for any critical exponent goes like

The next most dom inant term is a factor of the form K  $^{\rm b}$ . The value of b depends on the critical exponent being studied and is beyond the scope of this paper. To determ ine its value a treatment is needed of the massless modes which arise in the Gaussian uctuations around the instanton solution.

Inspection of the rst three terms in the expansion for and  $^1$  2 + show that these terms are not growing anything like as rapidly as predicted at large K. It is perhaps not surprising, therefore, that a P ade-B orel analysis of the series does not yield good num erical values for the critical exponents in three dimensions.

#### VII. DISCUSSION

In sum m ary we have studied the nature of the perturbation expansion of the zero-dimensional cubic replica eld theory of spin glasses. By mapping this to the problem of critical nite-size corrections in a modied spherical spin glasses, we have determ ined the high-order behavior of the perturbation expansion coe cients. To the leading order, the coe cients alternate in sign, but there is a subleading contribution where the terms in the perturbation series show a cosine-like oscillation. In practice, the e ects of these sub-dom inant terms will be sm all, making a simple Pade-Borel resum mation of the series useful, as was found to be the case in a similar situation for the disordered ferrom agnet [4].

N on-perturbative term s are also present in spin glasses. These are G ri ths singularities and arise from regions where the values of the couplings  $J_{ij}$  produce a sm aller am ount of frustration and hence a locally enhanced transition temperature. A discussion of their form has been given in Ref. [21]. Sim ilar singularities exist for disordered ferrom agnets and it is widely believed that their e ects are very sm all. To our know ledge no quantitative discussion of these singularities has been m ade for spin glasses and their study remains to be done. (The toy problem, because it is zero-dimensional, is free of G rift the singularities).

The expansion for the critical exponents gives disappointing results as regards applications to real spin glasses. This is not just due to the fact that = 3 in three dim ensions as in R ef. [11] good results were obtained for the exponents of the percolation problem in three dim ensions from an expansion with the same num ber of terms. W e do not understand the origin of this problem.

However, to our m ind, the m ost signi cant rem aining problem is what motivated this entire study. N am ely, does perturbation theory (i.e. the loop expansion) work well in the spin glass phase or does the existence of \droplets" in nite dimensional spin glasses indicate that it fails com pletely? Our work does indicate though that perturbation theory is useful in the high-tem perature phase.
