# Nature of Phase Transitions in a Generalized Complex j f M odel

W e em ploy M onte C arlo sin ulations to study a generalized three-dimensional complex j f theory of G inzburg-Landau form and compare our numerical results with a recent quasi-analytical meaneld type approximation, which predicts rst-order phase transitions in parts of the phase diagram. A swe have shown earlier, this approximation does not apply to the standard formulation of the model. This motivated us to introduce a generalized H am iltonian with an additional fugacity term controlling implicitly the vortex density. W ith this modi cation we nd that the complex j j<sup>4</sup> theory can, in fact, be tuned to undergo strong rst-order phase transitions. The standard model is con rm ed to exhibit continuous transitions which can be characterized by X Y m odel exponents, as expected by universality arguments. A few remarks on the two-dimensional case are also made.

## I. IN TRODUCTION

Since long the G inzburg-Landau m odel has been considered as paradigm for studying critical phenomena using eld-theoretic techniques.<sup>1</sup> Perturbative calculations of critical exponents and am plitude ratios of the Ising (n = 1), XY (n = 2), Heisenberg (n = 3)and other 0 (n) spin models relied heavily on this eldtheoretic form ulation.<sup>2</sup> E ven though the spin m odels contain only directional uctuations, while for n-component Ginzburg-Landau elds with n 2 directional and size uctuations seem to be equally important, the two descriptions are completely equivalent, as is expected through the concept of universality and has been proved explicitly for super uids with n = 2, where the spin m odel reduces to an XY m odel.<sup>3</sup> Therefore it appeared as a surprise when, on the basis of an approximate variational approach to the two-component Ginzburg-Landau model, Curty and  $\operatorname{Beck}^4$  recently predicted for certain parameter ranges the possibility of rst-order phase transitions induced by phase uctuations. In several papers<sup>5,6,7,8,9</sup> this quasi-analytical<sup>10</sup> prediction was tested by M onte C arlo simulations and, as the m ain result, apparently con m ed num erically. If true, these ndings would have an enorm ous in pact on the theoreticaldescription of m any related system s such as super uid helium, superconductors, certain liquid crystals and possibly even the electrow eak standard m odel of elem entary particle physics.<sup>11,12</sup>

In view of these potential important implications for a broad variety of di erent elds we perform ed independent M onte C arlo simulations of the standard G inzburg-Landau m odel in two and three dimensions in order to test whether the claim of phase- uctuation induced rstorder transitions is a real e ect or not.<sup>13</sup> Our results clearly support the prevailing opinion that the nature of the transition is of second order. In turn this im plies, of course, that the variational approximation employed in R ef. 4 is less reliable than originally thought in view of the apparent num erical con rm ations. In order to shed som e light on the num erical results of R efs. 5,6,7,8,9, we generalized the standard model by adding a fugacity term which in plicitly controls the vortex density of the model. The purpose of this paper is to present for this generalized G inzburg-Landau model results on its phase structure as obtained from extensive M onte C arb simulations. Employing nite-size scaling analyses we nd numerical evidence that, by tuning the extra fugacity parameter, it is indeed possible to drive the system into a region with rst-order phase transitions.

The layout of the rem ainder of this paper is organized as follows. In Sec. II we rst recall the standard model, and then discuss its generalization and the observables used to map out the phase diagram. Next we describe the employed simulation techniques in Sec. III. The results of our simulations are presented in Sec. IV, where we rst discuss the three-dimensional case in some detail and then add a few brief comments on the two-dimensional model to complete the physical picture. Finally, in Sec.V we conclude with a summary of our main indings.

### II. MODEL AND OBSERVABLES

The standard complex or two-component G inzburg-Landau theory is de ned by the H am iltonian  $\frac{7}{2}$

where  $(\mathbf{r}) = \sum_{x} (\mathbf{r}) + i_{y} (\mathbf{r}) = j_{z} (\mathbf{r}) \dot{\mathbf{e}}^{i_{z}(\mathbf{r})}$  is a complex eld, and , b and are temperature independent coe cients derived from a microscopic model. In order to carry out M onte C arb simulations we put the model (1) on a d-dimensional hypercubic lattice with spacing a. A dopting the <u>potation</u> of R ef. 4, we introduce scaled <u>vari-</u> ables  $\tilde{\phantom{r}} = \tilde{\phantom{r}} (j_{j} + b)$  and  $\mathbf{u} = \mathbf{r} = ,$  where  $\tilde{\phantom{r}} = \tilde{\phantom{r}} = j_{j} j$ is the mean-eld correlation length at zero temperature. This leads to the norm alized lattice H am iltonian

where denotes the unit vectors along the d coordinate axes,  $N = L^d$  is the total number of sites, and an unim – portant constant term has been removed. The param – eter  $\nabla_0$  m erely sets the tem perature scale and can thus be absorbed in the de nition of the reduced tem perature  $T = T = \nabla_0$ .

A fier these rescalings, and om itting the tilde on , , and T for notational simplicity in the rest of the paper, the partition function Z considered in the simulations is then given by

and D D D Re D Im stands short for integrating over all possible complex eld con gurations.

In Ref. 13 we have show n, that the disagreem ent m entioned above is caused by an incorrect sam pling of the Jacobian which emerges from the complex m easure in (4) when transforming the eld representation to polar coordinates,  $n = R_n (\cos(n); \sin(n))$ . When updating in the simulations the modulus  $R_n = j_n j$  and the angle n, one has to rewrite the measure of the partition function (4) as

W hile m athem atically indeed trivial (and of course properly taken into account in Ref. 4), this fact m ay easily be overlooked when coding the update proposals for the modulus and angle in a Monte Carlo simulation program. While for the angles it is correct to use update proposals of the form n ! n + with (where is chosen such as to assure an optim al acceptance ratio), the similar procedure for the modulus,  $R_n ! R_n + R$ R, would be incorrect since this igwith R R nores the R<sub>n</sub> factor com ing from the Jacobian. In fact, if we purposely ignore the Jacobian and simulate them odel (6) (erroneously) without the R-factor, then we obtain a com pletely di erent behavior than in the correct case, cf. e.g.Fig.2 below. As already mentioned above these results reproduce<sup>14</sup> those in Refs. 5 and 9, and from this data one would indeed conclude evidence for a rst-order phase transition when is small. With the correct measure, on the other hand, we have checked that no rstorder signal shows up down to = 0.01.

To treat the measure in Eq. (6) properly one can either use the identity  $R_n dR_n = dR_n^2 = 2$  and update the squared moduli  $R_n^2 = j_n f$  according to a uniform measure (where the update proposal  $R_n^2$  !  $R_n^2$  + with

is correct), or one can introduce an effective H am iltonian,

with 1 and work directly with a uniform measure for  $R_n$ . The incorrect om ission of the R-factor in (6) is equivalent to setting = 0. It is well know  $n^{11}$  that the nodes  $R_n = 0$  correspond to core regions of vortices in the dual form ulation of the model. The Jacobian factor R (or equivalently the term ln R<sub>n</sub> in H<sub>e</sub>) tends to suppress eld con gurations with many nodes  $R_n = 0$ . If the R-factor is om itted, the number of nodes and hence vortices is relatively enhanced. It is thus at least qualitatively plausible that in this case a discontinuous, rst-order \freezing transition" from a vortex dom inated phase can occur, as is suggested by a sim ilar mechanism for the XY model<sup>11,15,16</sup> and defect-models ofmelting<sup>17,18</sup>.

In the lim it of a large parameter , it is easy to read o from Eq. (5) that the modulus of the eld is squeezed onto unity and once hence expects that irrespectively of the value of the XY model lim it is approached with its well-known continuous phase transition in three dimensions (3D) at  $T_c$ 22 respectively Kosterlitz-Thouless (KT) transition in two dimensions (2D) at  $T_{KT}$ 0:9. W hile for the standard m odel with = 1, this behavior should qualitatively persist for all values of , from the num erical results discussed above one expects that for = 0 the order of the transition turns rst-order below a certain (tricritical) -value. The purpose of this paper is to elucidate this behavior further by studying the phase diagram in the --plane, i.e., by considering an interpolating model with varying continuously between 0 and 1.

To be precise we always worked with the proper functional measure in Eq. (6) and replaced the standard Ham iltonian H by

where we have introduced the parameter = 1, such that = 0 (= 1) corresponds to the standard model and = 1 (= 0) to the previously studied modied model with its rst-order phase transition for small enough.

In order to m ap out the phase diagram in the - -respectively - -plane, we have measured in our simulations to be described in detail in the next section among other quantities the energy density e = hH i=N , the specic cheat persite  $c_v$  = (hH  $^2$ i hH i²)=N , and in particular

the mean-square amplitude

which will serve as the most relevant quantity for com parison with previous work  $^{4,5,6,7,8,9}$ . For further com parison and in order to determ ine the critical tem perature, the helicity modulus,

was also computed. Notice that the helicity modulus

is a direct measure of the phase correlations in the direction of . Because of cubic symmetry all directions are equivalent, and we always quote the average =  $(1=d)^{d}_{=1}^{d}$ . In the in nite-volume limit, is zero above  $T_c$  and di erent from zero below  $T_c$ . We also have measured the vortex density v (of vortex points in 2D and vortex lines in 3D). The standard procedure to calculate the vorticity on each plaquette is by considering the quantity

where \_\_;;::; \_4 are the phases at the corners of a plaquette labeled, say, according to the right-hand rule, and [ ]\_2 stands for modulo 2 : [ ]\_2 = + 2 n, with n an integer such that + 2 n 2 ( ; ], hence  $m = n_{12} + n_{23} + n_{34} + n_{41}$ . If  $m \notin 0$ , there exists a vortex which is assigned to the object dual to the given plaquette (a site in 2D and a link in 3D). Hence, in two dimensions, m, the dual of m, is assigned to the center of the original plaquette. In three dimensions, the topological point charges are replaced by (oriented) line elements ]\_2 which combine to form closed networks (\vortex loops"). The vortex \charges" m or \_ilcan take three values: 0; 1 (the values 2 have a negligible probability). The quantities

serve as a measure of the vortex density. We further analyzed the Binder cum ulant,




FIG. 1: Mean-square amplitude of the standard threedimensional complex G inzburg-Landau model with = 1 and = 0.25 on a  $10^3$  cubic lattice.

is the magnetization per lattice site of a given con guration.

### III. SIM ULATION TECHNIQUES

Let us now turn to the description of the M onte C arb update procedures used by us. To be on safe grounds, we started with the most straightforward (but most ine cient) algorithm known since the early days of M onte Carlo simulations: The standard Metropolis algorithm<sup>19</sup>. Here the complex eld n is decomposed into its Cartesian components,  $n = x_{in} + i_{y_{in}}$ . For each lattice site a random update proposal for the two components is made, e.g.  $x_{;n} ! x_{;n} + x_{;n} w$  ith  $x_{;n} 2 [;]$ , and in the standard fashion accepted or rejected according to the energy change  $H_{\text{qen}}$ . The parameter is usually chosen such as to give an acceptance rate of about 50%, but other choices are perm issible and m ay even result in a better perform ance of the algorithm (in terms of autocorrelation times). All this is standard<sup>20</sup> and guarantees in a straightforw ard m anner that the com plex measure D D in the partition function (4) is treated properly.

The well-known drawback of this algorithm is its critical slowing down (large autocorrelation times) in the vicinity of a continuous phase transition<sup>20</sup>, leading to large statistical errors for a xed computer budget. To in prove the accuracy of our data we therefore employed the single-cluster algorithm <sup>21</sup> to update the direction of the eld<sup>22</sup>, similar to simulations of the X Y spin m odel<sup>23</sup>. The modulus of is updated again with a M etropolis algorithm. Here some care is necessary to treat the measure in (4) properly (see above comments). Per measurement we performed one sweep with the M etropolis algorithm and n single-cluster updates. For all simulations in two and three dimensions the number of cluster updates was chosen such that nh<sup>C</sup> ji L<sup>d</sup> N, where hjC ji is the average cluster size. Since hjC ji scales with system size as the susceptibility, =  $N h^{2}i' L^{=}$ , and = = 2 = 7=4 at the Kosterlitz-Thouless transition in 2D and = = 22 in 3D , n was chosen /  $L^{1=4}$ in 2D and / L in 3D. In the 2D case most of the sim ulations were performed for L = 10;20, and 40, and in 3D we usually studied the lattice sizes L = 10;15;20, and 30. For each simulation point we therm alized with 500 to 1000 sweeps and averaged the measurements over 10000 sweeps. In the cases of strong rst-order phase transitions we employed a variant of the multicanonical scheme<sup>24</sup> where the histogram of the mean modulus is attened instead that of the energy. All error bars are com puted with the Jackknife m ethod<sup>25</sup>. In the following we only show the more extensive and accurate data set of the cluster simulations, but we tested in many representative cases that the M etropolis simulations coincide within error bars, for an example see Fig. 1.

#### IV. RESULTS

#### A. Three dim ensions




FIG.2: Mean-square amplitude hj $\hat{f}$ i, helicity modulus and vortex-line density hvi of the three-dimensional generalized complex G inzburg-Landau model on a 15<sup>3</sup> cubic lattice for dierent values of the parameter = 0.25;:::;3:0 for the case = 0 (left) and the standard formulation with = 1 (right).




FIG. 3: Top: H istogram of the mean modulus j j on a logarithm ic scale for a  $4^3$  cubic lattice, = 0 and = 0.25, reweighted to the temperature  $T_0$  0.0572 where the two peaks are of equal height. Bottom : H istogram for the same quantity and lattice size at T = 1:1 close to the second-order phase transition for = 1 and = 0.25.




FIG. 4: Transition lines in the -T-plane for = 0 and = 1. The thick line for = 0 indicates rst-order phase transitions while all other transitions are continuous.

In the rst set of simulations we concentrated on the two most characteristic cases = 0 and = 1 and perform ed tem perature scans on a 15<sup>3</sup> lattice for various values of the parameter . Our results for the mean-square am plitude, the helicity m odulus and the vortex-line density are compared for the two cases in Fig. 2. In the plots for = 0 on the left side, we see that all three quantities exhibit quite pronounced jumps for small values, which is a clear indication that in this regime the phase transition is of rst order. At = 0.25, for example, we observe already on very small lattices a clear double-peak structure for the distributions of the energy and m ean-square am plitude as well as the m ean m odulus  $\frac{1}{j} = \frac{1}{N} \prod_{n=1}^{r} j_n$  jwhich is depicted in Fig. 3. Notice that already for the extrem ely sm all lattice size of  $4^3$ the minimum between the two peaks is suppressed by more than 20 orders of magnitude. This is an unam biguous indication for two coexisting phases and thus clearly implies that the model undergoes a rst-order phase transition in the small -regime for = 0. Due to the pronounced m etastability these simulations had to be perform ed with a variant of the multicanonical schem e24 where, instead of attening the energy histogram, extra weight factors for the mean modulus were introduced. W ith this simulation technique we overcome the diculty of sam pling the extrem ely rare events between the two peaks of the canonical distribution. A closer look at the = 0 plots shows that the crossover from secondto rst-order transitions happens around t 2:5. For the standard model with = 1, on the other hand, we observe for all -values a sm ooth behavior, suggesting that the XY model like continuous transition persists also for small -values. This is clearly supported by a single-peak structure of all distributions just m entioned,

for the case of the m ean m odulus see F ig. 3. This supports the prevailing opinion that the standard complex  $j \int_{-1}^{4} m$  odel always undergoes a second-order phase transition. In fact, we have checked that down to = 0.01 no signal of a rst-order transition can be detected for the standard m odel parameterized by = 1. The resulting transition lines in the -T-plane for = 0 and = 1 are sketched in Fig.4, with the thick line for = 0 indicating the approximate regime of rst-order phase transitions.




FIG.5: Energy density e, m ean-square amplitude hj  $\hat{f}$  i, helicity m odulus  $30^3$  cubic lattices for = 0.25 and = 0 (left) respectively = 1 (right).

Next we concentrated on the small regime and performed a rough nite-size scaling (FSS) analysis for = 0.25 on m oderately large  $10^3$ ,  $15^3$ ,  $20^3$ , and  $30^3$  lattices. In Fig.5 we compare results for the energy, mean-square amplitude (9), helicity modulus (10) and vortex-line density (13) for = 0 and = 1. A part from the transition region where a strong size dependence is of course expected, we notice only a small dependence on the variation of the lattice size. On the basis of these results, we do not expect a signi cant change of the qualitative behavior form uch larger lattices and hence used sim ilar m oderate lattice sizes for most of our further investigations.




FIG.6: Top: H istogram of the mean modulus j j for = 0 and = 1.5 on a logarithm ic scale for various lattice sizes ranging from L = 4 (top curve) to L = 16 (bottom curve), reweighted to temperatures where the two peaks are of equal height. Bottom : FSS extrapolation for L 6 of the interface tension  $F_{L}^{s}$ , yielding the in nite-volume limit  $F^{s} = 0.271(5)$ .

To exemplify the big di erences between the models with = 0 and = 1, we choose in the following the case = 1:5, where we shall characterize for both values the phase transitions in som e detail. Let us start with the non-standard case = 0, where the rst-order phase transition around T 0:36 is also pronounced but much less strong than for = 0.25. Still, in order to get su ciently accurate equilibrium results, the simulations for lattices of size L = 4;6;8;10;12;14;15, and 16 had to be perform ed again with our modulus variant of the multicanonicalmethod. As can be inspected in the histogram plots for the mean modulus shown in Fig. 6, the frequency of the rare events between the two peaks in the canonical ensemble for a 163 lattice is about 50 orders of magnitude smaller than for con gurations contributing to the two peaks.

In order to characterize the transition m ore quantitatively we estimated the interface tension  $^{26}\mbox{,}$

where  $P_L^{m ax}$  is the value of the two peaks and  $P_L^{m in}$  denotes the minimum in between. Here we have assumed that for each lattice size the temperature was chosen such that the two peaks are of equal height which can be achieved by histogram reweighting. The thus dened temperatures approach the in nite-volume transition temperature as  $1=L^d$ , and for the nalestimate of  $F^s = \lim_{L \le 1} F_L^s$ , we performed a traccording to<sup>27</sup>

As is shown in Fig. 6, the nite-lattice estimates  $F_L^s$  are clearly nonzero. The in nite-volum e extrapolation (17) tends to increase with system size and yields a comparably large interface tension of  $F^s = 0.271$  (5).

Let us now turn to the second generic case, = 1, where the model de nitely exhibits for = 1:5 a second-order phase transition around 1=T 0:8. To con m the expected critical exponents of the O (2) or XY model universality class, we simulated here close to criticality som ewhat larger lattices of size L = 4;8;12;16;20;24;32;40, and 48 and perform ed a standard FSS analysis. From short runs we rst estim ated the location of the phase transition to be at  $_0 = 0.7795$  c. In the long runs at  $_0$  we recorded the time series of the energy density e = E = N, the magnetization ~, the mean modulus j j and the mean-square amplitude<sup>28</sup> j f, as well as the helicity modulus and the vorticity v. After an initial equilibration time we took about 1000000 measurements for each lattice size. Applying the reweighting technique




FIG.7: Least-square ts for = 1 and = 1.5 on a log-log scale, using the FSS ansatz df ()=d /  $L^{1=}$  at the maxim a locations. The ts using the data for L 8 lead to an overall critical exponent 1= = 1:493 (7) or = 0:670 (3).

rst determined the maxima of the susceptibility, we 0= N (h~<sup>2</sup>i hj·ji<sup>2</sup>), of dhj·ji=d, and of the logarithm ic derivatives dlnhj-ji=d and dlnh-2i=d. The locations of these maxim a provide us with four sequences of pseudotransition points  $m_{ax}$  (L) for which the scaling variable  $_{\rm c}$ )L<sup>1=</sup> should be constant. Using this  $x = (m_{ax}(L))$ fact we then have several possibilities to extract the critical exponent from (linear) least-squares ts of the FSS ansatz  $dU_L = d = L^{1=} f_0(x)$  or  $dlnhj \neq fi = d = L^{1=} f_p(x)$ to the data at the various  $m_{ax}$  (L) sequences. The quality of our data and the ts starting at  $L_{m in} = 8$ , with goodness-of-t parameters Q = 0.85 0.90, can be inspected in Fig. 7. All resulting exponent estimates and consequently also their weighted average,

are in perfect agreement with recent high-precision M onte Carlo estimates for the XY model universality class.<sup>22,29</sup> N ote that hyperscaling implies =  $2 \quad 3 = 0.010$  (9), which also favorably compares with recent

spacelab experiments on the lambda transition in liquid helium  $\mathbf{.}^{30}$ 

A ssum ing thus 1 = 1.493 we can improve our estimate for  $_{\rm c}$  from linear least-squares ts to the scaling behavior of the various  $_{\rm m\,ax}$  sequences. The combined estimate from the four sequences is  $_{\rm c} = 0.780\,08\,(4)$ . To extract the critical exponent ratio = we can now use the scaling relation for the susceptibility = N h<sup>-2</sup>i' a + bL = at  $_{\rm c}$ . For L 16 we obtain from a FSS t with Q = 0.70 the estimate of

where we also take into account the uncertainty in our estimate of c; this error is estimated by repeating the tat c c d and indicated by the number in square brackets. Here we nd a slight dependence of this value on the low er bound of the trange [Lmin;48], i.e., one would have to include larger lattices for a high-precision estimate of the critical exponent ratio = , but this was not our objective here. Still, these results are in good agreement with recent high-precision estimates in the literature<sup>22,29</sup> and clearly con m the expected second-order nature of the phase transition in the standard com plex j f m odel, governed by X Y m odel critical exponents.

A similar set of simulations at = 0.25 for lattice sizes L = 4;8;12;14;16;20;24;28;32, and 40 gave the exponent estimates 1= = 1:498(9), = 0:668(4) and = = 1:918(71)[8] (at  $_{\rm c}$  = 0:9284(4)), which are less accurate but again compatible with the XY model universality class. At any rate these results de nitely rule out the possibility of a rst-order phase transition in the standard model at small -values. When going to even smaller -values, the FSS analysis is more and more severely ham pered by the vicinity of the G aussian xed point which induces strong crossover scaling e ects. Since consequently very large system sizes would be required to see the true, asymptotic (XY model like) critical behavior we have not further pursued our attempts

and vortex-line density v on  $10^3\,\text{;}15^3\,\text{;}20^3$  and

in this direction. Here we only add the remark that for

= 0:01 the energy and magnetization distributions exhibit a clear single-peak structure for all considered lattice sizes up to L = 20, showing that in the standard model with = 1 a phase- uctuation induced rst-order phase transition is very unlikely even for very small values.

W e also checked the critical behavior along the line of second-order transitions for = 0. Speci cally, at = 5, i.e., su ciently far away from the crossover to rst-order transitions at  $_{\rm t}$  2:5, we obtained from FSS ts to data for lattices of size L = 4;8;12;16;20;24;28;32, and 40 the exponent estimates 1 = 1:489(7), = 0:671(3) and = 1:913(82)[13] (at  $_{\rm c} = 0:97253(4)$ ). As expected by symmetry arguments, also these results for the second-order regime of the = 0 variant of the model are in accord with the XY m odel universality class.

In a second set of simulations we explored the twodimensional - parameter space of the generalized Ginzburg-Landau model in the orthogonal direction by




FIG.8: Log-log plot of the FSS of the susceptibility for = 1 and = 1:5 at = 0:78008  $_{\rm c}$ . The line shows the three-parameter ta+bL = , yielding for L 16 the estimate = = 1:962(12).




FIG.9: The dependence of the mean-square amplitude hj  $\dot{f}$ i as a function of temperature on a  $15^3$  lattice for = 0.25.

performing simulations at xed varying values and = 0 to 1. For most -values we concentrated on from the crossover region between st-and second-order transitions when varying . For two selected values, = 0.25and = 1:5, we studied the dependence more system atically by simulating all values from = 0 to 1 in steps of 0:1. In addition we perform ed two further runs in the crossover regime at = 0:85 and 0:95 for = 0:25 as well asat = 0.15 and = 0.25 for = 1.5. In Fig. 9 we show the resulting mean-square amplitudes for all simulated values of at = 0.25 as a function of the tem perature, indicating again that for small the transitions are rstorder like while for closer to unity the expected secondorder transitions emerge. From Fig. 9 we read o that for = 0.25 the crossover between the two types of phase transitions happens around t = 0.25 0.8, and the




FIG. 10: Phase diagram in the -T-plane of the threedimensional generalized complex G inzburg-Landau model for = 0.25 and = 1.5. The transitions along the thick line for < t are of rst order, and the transitions for > t are of second order. The points labeled t at the intersection of these two regimes are tricritical points.

analogous analysis for = 1.5 yields t (= 1.5) 0.2. The resulting transition lines for these two -values are plotted in Fig. 10, where the thick lines indicate again rst-order phase transitions.




FIG.11: Phase structure in the --plane of the generalized complex G inzburg-Landau model in three dimensions, separating regions with rst- and second-order phase transitions, respectively, when the temperature is varied. All continuous transitions fall into the universality class of the XY model which is approached for all -values in the limit ! 1.

Finally, by combining all numerical evidences collected so far with additional data not described here in detail, we not the phase structure in the --plane depicted in Fig.11. All points in the lower left corner for small and small exhibit temperature driven rst-order phase transition when the temperature is varied, while all points in the upper right corner display a continuous transition of the XY model type. This means in particular that for the standard model parameterized by = 1 this is always true. Quantitatively the XY model is reached for all -values in the limiting case ! 1.

## B. Twodim ensions




FIG.12: Energy density e, m ean-square amplitude hj $\hat{f}$ i, helicity m odulus and vortex density v of the two-dimensional m odel on  $10^2$ ; $20^2$  and  $40^2$  square lattices for = 1 and = 0 (left) respectively = 1 (right). The straight line in the plots indicate the universal KT jump = (2= )T at T = T<sub>c</sub>, which clearly is only compatible with the data for the standard m odel with = 1.

We conclude the paper with a few very brief remarks on the two-dimensional generalized model where the Kosterlitz-Thouless nature of the standard XY model transition would require more care for a precise study. Here we only report results of some runs at = 1 for  $10^2$ ,  $20^2$ , and  $40^2$  square lattices. As the main result, we nd that the standard observables e, hj  $f_i$ , and v exhibit qualitatively the same pattern as in three dimensions. This is demonstrated in Fig. 12 where again the two cases = 0 and = 1 are compared. For = 0, the data are indicative of a rst-order transition around T 02, while the behavior of the standard model with

= 1 is consistent with the expected K osterlitz-T houless transition around T 0.4. Note in particular that (only) the data for = 1 are compatible with the expected universal jump of the helicity modulus at  $T_c$ , = (2=)T, indicated by the straight line in the corresponding plots. A careful investigation of the rst-order transitions in the generalized model with = 0 will be reported elsew here.

### V. SUMMARY

The possibility of a phase- uctuation induced rstorder phase transition in the standard three-dimensional G inzburg-Landau model as suggested by approximate variational calculations<sup>4</sup> cannot be con rm ed by our numerical simulations down to very small values of the parameter . Our results suggest, how ever, that a generalized G inzburg-Landau model can be tuned to undergo rst-order transitions by a mechanism similar to that discussed in Rpef. 15 when varying the parameter of an additional  $\ln R_n$  term in the generalized H amiltonian

(8). As in Ref. 15 this can be understood by a duality argument. For 0 < 1 the extra term reduces the ratio of core energies of vortex lines of vorticity two versus those of vorticity one, and this leads to the same type of transition as observed in defect melting of crystals.

The phase transitions of the standard m odel as well as the continuous transitions of the generalized m odel are con m ed to be governed by the critical exponents of the XY m odelor O (2) universality class, as expected by general sym m etry argum ents. For the generalized m odel it would be interesting to analyze in m ore detail the tricritical points separating the regions with rst- and secondorder phase transitions. Such a study, how ever, is quite a challenging project and hence left for the future.

Exploratory simulations of the two-dimensional case,

where the standard model exhibits Kosterlitz-Thouless transitions, indicate that a similar mechanism can drive the transition of the generalized model to rst order also there.
