#### Abstract

W e investigate the ground-state structure of the bilayer quantum H all system at the lling factor $=2 . \mathrm{M}$ aking an exact analysis of the ground state in the $S U$ (4)-invariant lim it, we include allother interactions as sm allperturbation. W e carry out analytic calculations and construct phase diagram s for non zero values of the Zeem an, tunneling and bias interactions. In particular we exam ine carefully how the phase transition occurs by applying the bias voltage and inducing a density im balance between the two layens. W e com pare our theoretical result w th the experim ental data due to Saw ada et al. based on the phase diagram in the $0-0$ plane, where 0 and 0 are the totalelectron density and the density di erence betw een the tw o layers, respectively.


## I. INTRODUCTION

A rich physics has em erged from the layer degree, $\boldsymbol{o f}_{1}$ freedom in the bilayer quantum $H$ all ( $\mathrm{Q} H$ ) system ${ }^{\mathrm{L}_{2}} \mathbf{2} \mathbf{2}$. An electron carries the $S U$ (2) pseudospin index assigned to the front and back layers. The spin and the pseudospin are equal partners. There arises a unique phase at the ling factor $=1$. It is the spin-ferrom agnet and pseudospin-ferrom agnet phase, where various intralayer aqd interlayer coherent phenom ena have been observed $d^{\frac{1}{2}, \frac{1}{2}}$. On the other hand, according to the onebody picture we expect to have two phases at $=2$ depending on the relative strength betw een the Zeem an gap $z$ and the tunneling gap SAS. O ne is the spinferrom agnet and pseudospin-singlet phase (abridged as the spin phase ${ }^{13^{1}}$ ) for $z^{>}$SAs; the other is the spinsinglet and pseudospin-ferrom agnet phase (abridged as the ppin phasa ${ }^{(311}$ ) for $z<S A S$. Betw een these two phases, driven by interlayer correlations, a novel canted antiferrom agnetic phase has been predicted to em erga $4^{4, v_{1}^{1} 5^{1}}$.

The rst experim ental indication of a phase transition at $=2$ was revealed by inelastic light scattering spectroscopy-. An unam biguous evidence was subsequently obtained through $m$ agneto-transport $m$ easurem ent $\frac{1}{1}^{\frac{1}{1}}$, where the im portance ofm aking density im balance betw een the tw o layers is em phasized to study phase transitions. There is an attem ptiq to interpret the datal ${ }^{17}$ based on num erical analyses. H ow ever, the physical picture is not yet clear enough due to the lack of analytic understanding. For instance, it is yet to be explored how the density im balance is induced as a function of the bias voltage $V_{b i a s}$. The density im balance is $m$ ade as soon as $V_{b \text { bias }} 0$ at $=1$, but this is not sp, simple at
$=2$. Furtherm ore, the exact diagonalization' of a few electron system has shown that the boundary betw een the spin and canted phases is practically unm odi ed but the boundary betw een the canted and ppin phases is considerably modi ed from the $m$ ean- eld result. There is so far no theoretical explanation of these behaviors. T he aim ofthis paper is to understand the ground-state structure of the $=2$ bilayer QH system m ore in details based on perturbation theory.

W e investigate physics taking place in the low est Lan-
dau level (LLL). Since each Landau site can accom modate four electrons w ith the spin and pseudospin degrees of freedom, the underlying group structure is enlarged to SU (4). W e start w ith the SU (4)-invariant lim it of the bilayer system, where the ground state is determ ined by solving the eigenvalue equation. W e then include SU (4)noninvariant term s perturbatively. T he ground-state energy is calculated analytically in the rst order of perturbation. Then we exam ine carefully how the phase transition occurs as the density im balance is $m$ ade betw een the two layers. W e are particularly interested in the phase diagram in the 0 - 0 plane, where 0 and 0 denotes the totalelectron density and the im balance param eter (the norm alized density di erence betw een the tw o layers), respectively. This is because phase transition points have experim entally ${ }^{\frac{1}{1}}$ been observed $m$ ost clearly in such a plane. We also present the phase diagram in the the $0^{-}$SAs plane, which w illbe usefulto analyze experim entaldata obtained in sam plesw ith di erent SAs but all other param eters unchanged.

In Section II we review the $\ddagger$ andau-site $H$ am iltonian goveming bilayer Q H system $\mathbf{1}^{10}$. In Section III we solve the eigenvalue equation for the ground state in the SU (4)invariant lim it. In so doing we identify the physical variables w th in 15 generators of the group SU (4). W e show that there are 9 independent physical variables, am ong which 8 variables describe real $G$ oldstone $m$ odes on the SU (4)-invariant ground state. We then calculate the ground-state energy of the full system in the rst order of perturbation. In Section IV we verify the existence of the spin phase, the canted phase and the ppin phase in the presence of the bias voltage. The ground state is obtained in an analytic form in each phase. In particular the spin com ponent $S_{z}$ and the im balance param eter 0 are calculated as functions of the bias voltage for typical sam ple param eters. In Section V we present phase diagram $s$ in the $S A S S^{-}$z plane, in the $0^{-} 0$ plane and in the $0^{-}$sAs plane. In Section VI we show that the spin phase is not m odi ed but the ppin phase is considerably m odi ed by higher order perturbations. Thus, the spincanted phase bopundary is an exact result, as is consistent $w$ th the resultal obtained from the exact diagonalization of a few -electron system. In Section V II we interpret the
experim ental data ${ }^{F_{1}^{\prime}}$ based on the phase diagram in the $0^{-}$o plane. Section V III is devoted to discussions.

## II. LANDAU-SITE HAM ILTON IA N

Electrons in a plane perform cyclotron motion under strong magnetic eld $B_{\text {? }}$ and create Landau levels. In Q H systems the electron position is speci ed solely by the guiding center $X=(X ; Y)$ sub ject to the noncom $m$ utative relation, $[X ; Y]=i_{B}^{Z}, w$ ith the $m$ agnetic length $\rangle_{B}=P \underset{\sim=e B \text { ? }}{ }$. It follow $S$ from this relation that each electron occupies an area $2 \sum_{B}^{2}$ labelled by the Landau-site index. The total num ber of Landaus sites is $N=S=2 \quad{ }_{B}^{2}=N=$, where $N$ and $S$ are the total electron num ber and the area of the system, respectively. E lectrons behave as if they were on lattice sites, am ong which C oulom b interactions operate.

In the bilayer system an electron carries 4 di erent polarizations associated w the ordinary spin (";\#) and two layers ( $£$, b). These four polarizations can be incorporated in the isospin index $=\mathrm{f}^{\prime \prime}, \mathrm{f} \mathrm{\#}, \mathrm{~b} ", \mathrm{bH}$. In this notation the second quantized electron eld in the low est Landau level (LLL) appear as

$w$ here hx in $i$ is the oneboody wave function for the Landau site $\mathrm{m}^{n} \mathrm{i}$ in the LLL $w$ ith $m$ labeling the angular $m$ om entum. The operators $c(m)$ and $c^{y}(n)$ satisfy the standard anticom $m$ utation relations.

The electron eld has four com ponents, and the bilayer system possesses the underlying algebra SU (4). It has the subalgebra $S U_{s p}$ in (2) $S U_{p p}$ in (2). W e denote the 3 generators of the spin $S U$ (2) algebra by ${ }_{a}^{s p i n}$, and those of the pseudospin SU (2) generators by ${ }_{a}^{p p}$ in . There are rem aining 9 generators in SU (4), which are given by ${ }_{a}^{s p}$ in ${ }_{b}^{p p}$ in . Their properties are sum $m$ arized as

where $S_{a}$ describes the total spin, $2 P_{z} m$ easures the electron-density di erence between the two layers. The operator $R_{a b}$ transform $S$ as a spin under $S U_{\text {spin }}$ (2) and as a pseudospin under $S U_{\text {ppin }}$ (2).

The total H am iltonian consists of the C oulom b, Zeem an, tunneling and bias term s . T he C oulom b interaction is decom posed into the SU (4)-invariant and SU (4)noninvariant term s ,

 $T$ his is in sharp contrast to the $=1$ case, where the $m$ agnitude of the $S U$ (4) isospin, $S^{2}+P^{2}+R^{2}=3=4$, is xed kinem atically.
Though there are 12 real param eters in the antisym $m$ etric $m$ atrix $g$, one of them is unphysical for representing the overall phase, and another is xed by the norm alization condition (3, 3, ). Then one variable is xed by the condition $(\overline{3} \cdot \overline{1} \overline{4})$ on the ground state ji. As we shall see soon [see ( 3 (32 20$)$ ] and prove in A ppendix ' ${ }^{\prime}$ ', there exists another unphysical variable which decouples on the ground state jgi. H ence the param eter space characterizing the SU (4)-invariant ground state ji contains 8 real independent variables. They are the 4 com plex Goldstone $m$ odes associated $w$ th a spontaneous breakdow $n$ of the $S U$ (4) sym $m$ etry in the $S U$ (4)-invariant lim it. The num ber, of the G oldstone m odes agrees w ith our previous result $1^{112} n^{2 \prime}$ obtained based on an e ective theory w the the use of com posite bosons.

We now include the SU (4)-noninvariant interactions as $s m$ all perturbation. The rst order perturbation is to diagonalize the full H am iltonian H w ithin this subspace. Equivalently, the ground state is determ ined by $m$ inim izing the energy

> V. PHASE D IAGRAMS

The phase diagram can be studied based on analytic form ulas given in the previous section. We rst present the phase diagram in the $\mathrm{SAS}^{-}$z plane for typicalvalues of, bias to com pare our result w th the standard ones ${ }^{18} n^{13}$. It is observed that the ppin-canted phase boundary is m odi ed considerably by higher oder quantum corrections.

In draw ing the phase diagram in the $\mathrm{SAS}^{-}$z plane we need to $x$ the layer separation $d$. Follow ing the standard literature ${ }^{\text {b }} \mathrm{n}^{1}-3$, , we have exam ined the case $d=$ B and presented the phase diagram in F IG $\bar{N}$. O ur results agree qualifatively $w$ ith results obtained num erically by $B$ rey et $a l^{181}$ and M acD onald et all ${ }^{131}$ for im balanced congurations.
O ur analytic form ulas reveal som e new features not reported in literature. W e have found som e peculiar behaviors for the ppin-canted boundary as in F IG $\overline{1} 4$, which occurs for $2 "_{D}<3 "_{X}$, or d. 0:75 ${ }_{B}$. W hen the bias voltage is increased, a sm all ppin region appears in the vicinity of the origin at

w ith di erent d to realize, e.g., $\mathrm{d}=\mathrm{B}$, but this is im possible. It is $m$ ore interesting to see experim entally $y^{1 / 1}$ how the phase transition occurs by controlling the total density 0 and also the imbalance param eter 0 in a single sample with xed values of d and SAs. H ere we wish to describe new aspects of the phase diagram from this point of view.

W e start w ith the spin phase in the balanced con guration $w$ ith bias $=0$. ( $T$ he spin phase realizes provided the electron density is $m$ ore than a certain criticalvalue.) W hen the bias voltage is applied ( bias 0) the param eter becom es nonzero according to ( $5 . \frac{1}{2}$ ). H ow ever, no charge imbalance is induced betw een the two layers $(0=0)$ as far as $=0$. A charge im balance occurs only above a_certain critical value ${\underset{b}{\text { sc }}}_{\text {bias }}$ of the bias voltage as in F IG $\underset{\sim}{11}$, which is given by solving ( 5

To com pare the experim ental data ${ }^{11114}$ it is $m$ ore convenient to present the phase diagram in the $0-0$ plane F IG $\left[\frac{1}{6}\right]$, which is constructed by using the relation betw een the bias voltage and the im balance param eter im plied by $(5,3)$ and (5.4).

It is also useful to study the phase diagram in the $0^{-}$ SAS plane, since it is not di cult to prepare sam ples w ith di erent sas w th allother param eters unchanged

## VI. HIGHER ORDER CORRECTIONS

W e have explored the ground-state structure in the rst order of perturbation theory. O ur H am iltonian consists of the SU (4)-invariant term $\mathrm{H}_{\mathrm{C}}^{+}$and the $\mathrm{SU}(4)-$ noninvariant term $\mathrm{H}_{\text {non }}=\mathrm{H}_{\mathrm{C}}+\mathrm{H}_{\mathrm{zpz}} \cdot \mathrm{W}$ e are interested in the regim e where $\mathrm{H}_{\mathrm{f}}^{+} \quad \mathrm{H}_{\text {non }}$. H ence we have diagonalized $H_{C}^{+}$as in ( $3 . l_{0}^{-} .4_{3}^{\prime}$ ) and treat $H_{\text {non }}$ perturbatively. $T$ he eigenstates are degenerate $w$ th respect to $H_{C}^{+}$, consisting of 6 states at each Landau site. The degeneracy is rem oved by the SU (4)-noninvariant term $s H_{\text {non }}$. We $m$ ay construct 6 states $\dot{j}_{i} i$ satisfying

W e have constructed the phase boundaries betw een the spin phase, the canted phase and the pp,in phase. H ere we recall the exact-diagonalization resultit of a few -electron system show ing that the boundary betw een the spin and canted phases is practically unm odi ed but the boundary betw een the canted and ppin phases is considerably modi ed from the $m$ ean- eld result $\mathbb{E} I G-1 / 2]$. In order to explain this we discuss e ects due to higher order perturbations.

W e start w ith the spin phase. It is im portant that the fully spin polarized state $(4.9)$ is an exact eigenstate of the total H am iltonian H.This follow s from

It is practically im possible to carry out the second order perturbation since alm ost no eigenstates of the unperturbed H am iltonian $\mathrm{H}_{\mathrm{C}}^{+}$are known. W em ake a variational analysis. W e decom pose the total H am iltonian H into two pieces, $\mathrm{H}_{0}$ and $\mathrm{H}_{1}$, where $\mathrm{H}_{0}$ is the m axim al part of H one of whose eigenstates is $\mathrm{j}_{\mathrm{pp}} \mathrm{in}$ i. We do not give their explicit form s here since they are very com plicated. W e obtain

VII. EXPERIMENTALSTATUS

B ased on our theoretical results we w ish to interpret the experim entaldata due to Saw ada et el $l^{7} \underline{1}_{1}^{14}-$ y ielding an unam biguous evidence for phase transitions. They have presented the activation-energy data for $0 \mathbb{F}$ IG $\left.\overline{8}_{1}^{1}(a)\right]$ and the plateau-w idth data for $0 \mathbb{E} I G\left[{ }_{1}^{-1}(b)\right]$. In th is section we set $0=n \quad 10^{11}=\mathrm{am}^{2}$, and use n to represent the total density.

The calculation is straightforw ard though quite tedious. To perform various integrals explicitly we approxim ate (2.5) as

T he correction is larger for larger layer separation $d$, and it is largest at the balanced point $(0=0)$.

It is not easy to derive higher order corrections for the canted phase, since $\dot{9}_{c a n t} i$ is not an eigenstate of any sim ple H am iltonian and furtherm ore it is a com plicated state involving 5 states as in (4.7). Though we are unable to determ ine the im proved ppin-canted phase boundary, we $m$ ay $m$ ake som e argum ents how it is $m$ odi ed. For sim plicity we study the balanced point. W e have show $n$ that the w ould-be phase transition point is SP SA given by $(4 . \overline{1} \overline{6})$ in the ignorance of the canted phase: $W$ e exam ine how this point is $m$ odi ed by equating $\overline{2}(6,4)$ and $1(6.12)$. Nam ely, from $\mathrm{E}_{\mathrm{g}}^{\text {spin }}=\mathrm{E}_{\mathrm{var}}^{\mathrm{ppin}}$ we nd

It is observed that this is m uch sm aller than the rst order perturbation result $\mathbb{E}$ IG $\bar{Z} \overline{1}]$. Since the spin-canted boundary (4.17) is not modi ed we expect that the canted phase is shrunk considerably. T hese features are precisely what are found in the exact diagonalization of a few electron system ${ }^{\text {P1 }}$ E IG

W e see a phase transition point $(0 ; \mathrm{n})=(0 ; 0 ; 9)$ from the activation-energy data $\mathbb{F} I G[(a)]$, for which $d_{=}{ }_{B}=1.23$ in the sample $w$ ith $d=233^{-1} m$. We give the phase diagram in $\mathrm{SAS}^{-}$z plane, upon which we plot the data point $\mathbb{E}$ IG ${ }^{[19} 1 \mathbf{l} 1$. On one hand, the point is al$m$ ost on the spin-canted boundary. Furtherm ore, though the spin-canted boundary is exact, it is obtained in the ideal tw o-dim ensional system and it will be modi ed in actual sam ples w ith nite quantum wells. T hen it is reasonable that the point is slightly o the theoretical estim ation. On the other hand, as we have argued, the ppin-canted phase boundary is considerably modi ed so that the canted phase occupies a tiny dom ain in the phase
 act diagonalization result ${ }^{51} \mathrm{w}$ ith the data directly since it is available only at $V_{\text {bias }}=0$ and $d={ }_{B}=1$. Since the phase diagram for $d_{=}=1: 23$ is sim ilar to the one for $d^{\prime}{ }_{B}=1$, it would be allow ed to extrapolate the exact diagonalization data from $\mathrm{d}_{\mathrm{C}}{ }_{\mathrm{B}}=1$. W e have plotted it on the same gure as indicated by the dotted curve E IG $\left.{ }_{[10}^{-9}\right]$. Then the point is also near to the ppin-canted phase boundary. It is hard to decide on which phase boundary this point exists from this phase diagram.

W e answer this problem based on the phase diagram in the $0^{-} 0$ plane $\mathbb{E}$ IG ${ }^{\prime}$ ' $]$ ]. We focus on the horizontal line at $\mathrm{n}=0: 9$. T his corresponds to the curve indexed by $n=0: 9$ in the plateau-w idth data $\mathbb{F}$ IG $\overline{\left.0_{1}^{\prime}(b)\right] . ~ T h e ~}$ curve takes a maxim um at $0=0$ and a minim um at $0^{\prime} 0: 2$ as the density imbalance is m ade. It is reasonable to identify the region $0>0.2 \mathrm{w}$ ith the ppin phase. Then the region $0<0<0.2 \mathrm{~m}$ ust be the canted phase. $N$ ote that the spin phase is realized only at $0=0$. W e conclude that the point $(0 ; n)=(0 ; 2 ; 0: 9)$ represents the ppin-canted phase transition point and that the point $(0 ; n)=(0 ; 0: 9)$ found in the activation-energy data represents the spin-canted phase transition $\mathbb{F}$ IG $\left.{ }_{\text {, }}^{6} / 1\right]$. $T$ his interpretation is consistent $w$ ith the fact that no indication of phase transion is found for $0: 9<\mathrm{n}<1: 6$ in the sam e data $\mathbb{E}$ IG $\left.{ }_{1}^{1}(a)\right]$.

W e continue to exam ine the plateau-w idth data for the sam ple w ith various density n $\mathbb{F}$ IG $\bar{d}(\mathrm{~d})$ ]. T he data $w$ ith $\mathrm{n}=1: 4$ and $\mathrm{n}=1: 2$ show sim ilar behavions as the one w th $\mathrm{n}=0: 9 . \mathrm{N}$ am ely, they possess the m inim um points to be identi ed w ith the ppin-canted phase transitions around the imbalance param eter $0^{\prime} 0: 3$. It is observed that the ppin-canted transition point 0 decreases as $n$ decreases. It is not clear from the data when the ppincanted phase transition disappears as $n$ decreases. H ow -
ever, it seem s that the entire region belongs to the ppin phase at $\mathrm{n}=0: 6$. Let us tentatively regard the critical point exists near the point $n=0: 6$. In this way we have speculated the real ppin-canted boundary in the phase diagram in the $0-0$ plane $\mathbb{E}$ IG $\left[\begin{array}{l}{[1]}\end{array}\right]$ and in the $0^{-}$SAS plane E IG

## V III. D ISCU SS IO N S

There are three phases, i.e., the spin phase, the canted phase and the ppin phase at ${ }_{\ldots}=2 . T$ he ground state is the fully spin polarized state (4.9) in the spin phase, while it is the fully pseudospin polarized state ( $4.111_{1}$ ) in the ppin phase. In the canted phase, how ever, it is not sim ply $m$ ade of a certain combination of these two states, as postulated in a phenom enologicalbosonic spin m odel ${ }^{15}$ but $m$ ade of $m$ ore states in a very com plicated way. We have constructed the ground states explicitly in the rst order of perturbation.

The phase diagram has been studied num erically w ithin the Hantree Fock approxim ation in the standard literatura $a^{4,5 v^{5}} \mathrm{~L}^{4} \mathrm{n}^{13}$. In this paperw e have presented analytic form ulas for it based on perturbation theory. O ur results in the rst order approxim ation reproduce precisely the H artree $F$ ock variationalresult ${ }^{13}$, at the zero bias voltage, and agree qua, itatively w ith num ericalresults for nonzero bias voltages 8,112 . W e have also argued how the phase diagram is modi ed by higher order quantum corrections. W e have shown that the spin-canted phased boundary is not modi ed but the ppin-canted phase boundary is considerably modi ed. It is necessary to develop a reliable theory including higher order quantum corrections to determ ine the accurate ppin-canted boundary in various phase diagram s.

O ur new contribution is the phase diagram sin the $0^{-}$ 0 plane as well as in the bias 0 plane. W e have analyzed the relation between the im balance param eter 0 and the bias voltage $V_{b i a s}$. At $=1$ the density im balance occurs as soon as the bias voltage becom es nonzero. H ow ever, this is not the case at $=2$ as in FIG ${ }^{1} 1$, where bias $=\mathrm{eV}_{\mathrm{b} \text { ias. }}$. As far as $\mathrm{V}_{\mathrm{b} \text { ias }}<\mathrm{V}_{\text {bias }}^{\text {sc }}$ the density im balance is not induced and the system is still in the spin phase. A charge im balance occurs only above a certain critical value $\mathrm{V}_{\mathrm{b} \text { ias }}^{\text {sc }}$ of the bias voltage, where the system is driven into the canted phase. A s the bias voltage increases above a second critical value $\mathrm{V}_{\mathrm{b} \text { ias }}^{\mathrm{pc}}$, the system tums into the ppin phase. Taking these facts into account we have constructed the phase diagram in the 0 - o plane as well as in the bias- o plane. These phase diagram s w illbe usefulto identify the three phases experim entally by using a single sam ple. W e have also presented the phase diagram in the $0^{-}$sAs plane. It will be useful to identify the three phases experim entally by using severalsam plesw th di erent sAs but allother param eters unchanged.

W e have interpreted experim entaldata due to Saw ada et all $l_{1}^{T_{1}} n^{4}$. W e adm it that our analysis is far from satis-
factory. This is m ainly because of the lack of quali ed data. Recall that the prim ary concem of these experi$m$ ents were to reveal the existence of the interlayer coherent phase at $=2$, which is identi ed w ith the ppin phase in the present term inology. In passing detailed experim ents w ith several sam ples are urged to be perform ed in order to establish the ground-state structure in the $=2$ bilayer QH system.
