Energy Flow Puzzle of Soliton Ratchets

We study the mechanism of directed energy transport for soliton ratchets. The energy ow appears due to the progressive motion of a soliton (kink) which is an energy carrier. However, the energy current formed by internal system deform ations (the total eld momentum) is zero. We solve the underlying puzzle by showing that the energy ow is realized via an inhom ogeneous energy exchange between the system and the external ac driving. Internal kink modes are unambiguously shown to be crucial for that transport process to take place. We also discuss elects of spatial discretization and combination of ac and dc external drivings.

A transport mechanism of potential relevance in various areas of physics, chem istry and biology is based on the ratchet e ect [1], i.e. the generation of directed currents by zero-m ean external perturbations. It is based on the breaking of relevant space-tim e sym m etries of the underlying system evolution equations [2]. A paradigmatic model corresponds to a classical particle moving in a spatially periodic potential under the in uence of zero-m ean uctuations [1], where the energy current is directly connected with the mean particle momentum and the corresponding kinetic energy of the particle. For spatially extended system s, e.g. an annular Josephson junction, which is described by a partial di erential equation (PDE), the ratchet phenom enon manifests as a unidirectional motion of a collective kink excitation (soliton) [3, 4, 5, 6, 7, 8]. Here the unambiguous ab initio de nition of a current m ay becom e a m uch m ore com plicated task, because the kink excites otherm odes in the system during its motion, which may contribute to an energy current as well.

A well-known model in the eld of soliton ratchets is the driven-damped sine-Gordon equation [9], which is also used for modelling the abovem entioned annular Josephson junction [8]:

where E (t) is a zero-mean time-periodic driving force, E (t+T) = E (t), $_{0}^{R_{T}}$ E (t)dt = 0. We impose the kinkbearing periodic boundary condition:

where Q = 2 m is the topological charge with integer $m = 1;2; \dots, and L$ is the system size.

Let us consider the easiest case m = 1, i.e. the presence of one kink in the system Q = 2. The kink velocity V is de ned e.g. as [4, 5]:

In the case of a soliton ratchet the m ean value of V (t) will be nonzero. Since the kink carries som e energy, one expects a m ean nonzero energy current as well. Recently it has been proposed to observe this directed energy transport using the de nition of the internal energy current J^{I} and its density j^{I} [5]:

 J^{I} is also known as the total momentum of the system [9, 10, 11].

Choosing either Eq.(3) or Eq.(4), the symmetry analysis provides identical necessary conditions for the appearance of a ratchet e ect [5]. If the ac driving E (t) possesses a shift symmetry,

then the combined symmetry transformation

leaves the equation (1) invariant and changes the sign of V and J^{I} . Consequently, if Eq.(1) allows for only one attractor solution, both quantities will have average value zero. V iolating (5) we loose the symmetry (6) and may expect nonzero values for the mean values of V and J^{I} . This can be done e.g. by the choice [5, 6, 8]:

The soliton ratchet e ect has been observed in terms of the mean soliton velocity V both numerically β , 4, 5] and experimentally in an annular Josephson junction [8]. However, by dimentiating Eq.(4) and using Eq.(1) together with the boundary condition (2) it follows that [10, 12]:

Thus, for any ac driving force E (t) with zero mean the time-averaged value of the total momentum, $J^{I} = \lim_{t \to 0} J^{I} (J^{I}) d$, is zero. Suppose that a kink moves with some non-zero mean velocity V. The kink carries also some non-zero energy. Hence the progressive kink motion should lead to the appearance of an energy ux in the system. Thus the system supports a non-zero averaged energy ow and a vanishing averaged intermal energy current (total system momentum). We will solve the puzzle in this Letter.

The PDE (1) corresponds to the energy density

Using Eq.(1) we obtain:

The last two terms describe energy bosses through dissipation and the energy exchange between the system and external driving E (t). However they also contain a derivative j_x^E of an additional current density, as we will show below. A central result of this work is that these terms describe a new exchange energy current J^E (t). This exchange current corresponds to an additional energy transm ission channel provided by a spatially inhom ogenous energy exchange between the system, the external ac driving and the dissipation. Thus, the com plete current balance equation for the full current J reads:

W e consider a large system size, i.e. L L_k , where L_k is the kink localization length. Far from the kink center the eld is oscillating in time while being hom ogeneous in space. We also assume that the kink travels only over distances L_p L during one period of the ac driving. Because of the external ac force the eld evolution is uniquely locked to the driver (as it was the case for all previous considerations [3, 4, 5, 6, 8], i.e. assuming that the system allows only for one attractor). Thus we observe a moving localized excitation (kink) which propagates on a background form ed by a spatially hom ogenous groundstate. It is convenient to separate ' (x;t) into a localized kink part, ' ^k (x;t), where $'^{k}$ (x ! 0;t) = 0; $'^{k}$ (x ! L;t) = 2 , and a background (vacuum) part ' " (t) which depends only on time [10]:

The vacuum part alone must satisfy Eq.(1). Because it is also a solution of the system in the absence of a kink when Q = 0, it can not contribute to any energy transport [5].

On the attractor the dynamics of the system (1) is given by

where T = 2 =! and V is the averaged kink velocity, V = hV (t) i_T = $\frac{1}{T} \begin{pmatrix} R_T \\ 0 \end{pmatrix} V$ (t)dt. Note that all integral system characteristics, such as the total energy of the system, the kink velocity, and energy currents from Eq.(11) are periodic functions of time with the period T.

Let us compute the full energy current J produced by a moving kink. We use the periodicity of the total system energy W (t) = $\frac{R_L}{0}$ (x;t)dx in time. The amount of energy carried through a point x between time t and t+T is equal to:

Here we assume that at x = 0 we have a hom ogenous vacuum state during the full cycle of the ac driving, thus there is no energy current through this point. Due to the presence of ac driving the system is not time hom ogeneous and $4 \le x;t$ in Eq.(14) depends on t. W ith (2),(13) it follows $4 \le x;t + T$) = $4 \le x \le VT;t$) and $4 \le (x + L;t) = 4 \le (x;t)$ and

U sing Eqs.(2), (13) and the multiplicative integration rule [13] we obtain from (14), (15):

with h:::i = $1=T_{0}^{R_{T}}$:::dt. The quantity being averaged in the rhs of (16) is the di erence between the energy of system with and without a kink, or simply the kink energy W^k = W_Q (t) W₀ (t), so that the mean total current, Eq.(16) generated by the moving kink reads

It follows that the total energy current has the same symmetry properties as the kink velocity (3). This result proves the initial intuitive guess that a moving kink indeed generates a non-zero energy current in the system.

Because for any ac driving E (t) with zero mean the averaged internal current J^{I} is equal to zero, we arrive at the following energy current balance:

In order to obtain an expression for the exchange current density, we use (10) and (15) and arrive at




FIG.1: The dependence of the mean exchange current J^E on for = 0.2 (solid line) and = 0.05 (dashed line). Circles correspond to the num erical results for J^{total} . O ther parameters: $E_1 = E_2 = 0.2$, ! = 0.1, Q = 2, L = 500.

E vidently the exchange current J^E has the same symmetry as V, J and J^I .

W e solved the equation (1) num erically [14] in order to test the current balance (18). A crucial parameter is the mesh size h used for the spatial discretization of the equation (1). For any nite value of h the internal current J^{I} is nonzero, as also obtained in [5]. However it scales according to J^I h² for h 0:1 and vanishes in the continuum lim it h ! 0 in full accord with (18). We chose h = 0.1 here, for which the values of J and J^{E} are determ ined with an error of less than 3%, while J^I=J 0.003 (for h = 0.32 used in [5] the latter ratio increases to 0.02 for = 0.2 and 0.18 for = 0:05).The results of num erical calculations of J, Eq.(16), and J^E, Eq. (21), are shown in Fig.1. We obtain very good agreement with (18). Note that L = 500, L_k 10 and Lp 30. A coording to the collective coordinate theories [6, 7] a nonzero average kink velocity implies the excitation of internal shape modes on the kink. Thus the appearance of a nonzero exchange current is another manifestation of the excitation of internalkink modes for the case of the considered soliton ratchet.




FIG.2: Space-time evolution of the soliton ratchet for = 0.2 and other parameters as in Fig.1. (a) Contour plot of the function (x;t), Eq. (20). (b) Contour plot of the energy density (9).

In Fig2(a) we plot the space-time evolution of the function (x;t) as de ned in (20), which describes the energy exchange between the eld', the external ac drive E (t) and the friction term. The energy is exchanged and transported in a cyclic way: rst the kink absorbs energy in its rare tail, then it releases energy in its front, then it absorbs energy in its front and nally releases energy in the rare tail. In Fig2(b) we plot the space-time evolution of the energy density (x;t) (9). The excitation of internal shape m odes on the kink is clearly observed – the kink ism uch m ore compressed when m oving opposite to its average propagation direction as compared to the times when it m oves in the same direction.

It is very instructive to apply our approach based on the generalized current balance equation (11) to the wellstudied case of a constant force, E = const [9]. Due to the time hom ogeneity of the system '(x;t) = '(); =

x Vt. Still we deal with the motion of a spatially localized kink with a nite extension. The internal current J^{I} can be evaluated using Eq.(8):

Sim ilarly the exchange current density can be obtained as




FIG.3: The densities of the scaled internal current, $0.02j^{\rm I}$ (x) (thin line), and the exchange current, $j^{\rm E}$ (x) (bold line), for the constant force case E = 0.2. The other parameters are Q = 2, L = 500 and = 0.2.

Due to the time hom ogeneity the kink energy W $_{\rm k}$ is now independent on time, and the total current can be com puted using (17). We plot the current densities in Fig.3. The internal current density is single peaked, with the peak position corresponding to the position of the kink center. The exchange current density $j^E \in 0$, which may com e as a surprise, since in this case the kink m oves without exciting internal shape modes. Yet the kink is a spatially extended object, and it is this property which leads to a nonzero exchange current density. W e also com puted the kink velocity, the kink energy, the total current and the total internal and exchange currents for the case E = 0.2 and = 0.2, L = 670 and h = 0.045. The kink velocity V = 0:6201, the kink energy $W_k = 10:0813$ and thus the total current J = 6251. The internal current $J^{I} = 6.282$, which is o the exact result $J^{I} =$ 2 (22) by an error = 0.001. The total exchange current is obtained as $J^{E} = 0.0321$. The current balance equation

(11) is satis ed within the same small error , which is an order of m agnitude sm aller than the computed value for J^E. Together with a series of further tests, including the analysis of the dependence of the results on L and h, we conclude that the exchange current is nonzero for a constant eld E. It follows from the mism atch between the total current $J = VW_k$ and the internal current J^{I} . Since no internalmodes are excited on the kink in this case, the appearance of an exchange current (or its density) is simply linked to the nite spatial extent of the kink, and the corresponding spatially (and thus tem porally as well) inhom ogeneous energy exchange between the eld' and the external eld E and the friction term, sim ilar to the soliton ratchet. Notably the exchange current for a constant eld E will vanish in the Ham iltonian $\lim it E = 0$ and also in the overdam ped $\lim it$ 1.

Let us com bine both cases from above, i.e. both a constant and an ac components of the driving E.A careful tuning of the parameters leads to an exact cancellation of both force components and V = 0. At that point J = 0(17). At the same time, according to Eq. (22), the internal current is $J^{I} = Q E^{stop} =$ where E^{stop} is the dc component of E. This implies an exact balance between the two currents,

It is also possible to have a situation where the sign of the total momentum of the system J^{I} , Eq.(4), is opposite to the sign of the kink velocity V, and the internal current is pumping energy against the kink motion.

W e solved the soliton ratchet puzzle of nonvanishing kink velocities and vanishing total m om entum (see also [15] and [11]). W e identi ed a new energy pathway which is entirely m ediated by the spatial and tem poral inhom ogeneity of the system m ediated by the ac driving and the spatial extension of the kink. M ore precisely, internal kink m odes are crucial in order to sustain this energy exchange current for the soliton ratchet. The reason for the appearance of this new exchange current is provided by the nite spatial extent of the kink. Even for the case of a constant external edd, the exchange current is found to be nonzero.

D iscretizing space will additionally change the ratio between the various currents. For the ac driving case of a soliton ratchet, corrections to the internal current invalidate (8) so that J^{I} also contributes to the total energy ow [5] even for a zero m ean drive. W hile our results are im portant for the general case of spatially extended elds coupled to external driving elds or sim ply other degrees of freedom, they also apply directly to the soliton ratchet in an annular Josephson junction [8].
