## Quantum theory of spectral di usion induced electron spin decoherence

A quantum cluster expansion method is developed for the problem of localized electron spin decoherence due to dipolar uctuations of lattice nuclear spins. At the lowest order it provides a microscopic explanation for the Lorentzian di usion of Hahn echoes without resorting to any phenom enological M arkovian assumption. O ur num erical results show remarkable agreement with recent electron spin echo experiments in phosphorus doped silicon.

It was realized a long time ago that spectral di usion due to the dipolar uctuations of nuclear spins offen dom inates the coherence decay in electron spin echo experiments [1, 2]. The recent advent of spin-based quantum computation in sem iconductor nanostructures revived the interest in spectral di usion, which is expected to be the dom inant channel for low -tem perature spin decoherence in several spin-based quantum computer architectures  $[\beta]$ . In spectral di usion, the electron spin Zeem an frequency di uses in time due to the noise produced by the nuclear spin bath. Dipolar uctuations in the nuclear spins give rise to a tem porally random e ective magnetic eld at the localized electron spin, leading to irreversible decoherence (i.e. a T2-process). All available theories to date are based on classical stochastic modeling of the nuclear eld, a Markovian theoretical fram ework which is inevitably phenom enological since it requires an arbitrary choice for the spectrum of nuclear

uctuations. Such a classical M arkovian m odeling is arguably incom patible with the strict requirem ents of spin coherence and control in a quantum information device. In addition, recent rapid experimental progress in single spin m easurements [4], which in the near future promise sensitive m easurements of quantum e ects in spin resonance, also warrant a quantum theory of spectral di usion. Here we propose a quantum theoretical framework for spectral di usion which is non-stochastic and fully m icroscopic. In addition, our theory produces an accurate quantitative prediction for the initial decoherence, which is the m ost im portant regime for quantum com putation. To the best of our know ledge, ours is the rst quantum theory for electron spin spectral di usion.

Spectral di usion is not a limiting decoherence process for silicon or germanium based quantum computer proposals because these can, in principle, be fabricated free of nuclear spins using isotopic puri cation. Unfortunately this is not true for the important class of materials based on III-V compounds, where spectral di usion has been shown to play a major role [3, 5]. There is as yet no experimental measurement of localized spin decoherence (echo decay) in III-V materials, but such experimental results are anticipated in the near future.

Our theory reveals that the inclusion of quantum corrections to nuclear spin uctuation increases the degree of decoherence, as is best evidenced from our explanation of the existing factor of three discrepancy between the Markovian stochastic theory [5] and experimental data [6, 7, 8] of spin echo decay in phosphorus doped silicon. Our method allows a fully microscopic explanation for the observed time dependence of Hahn echo decay due to a nuclear spin environment. It was pointed out a long tim e ago [2, 7] that the observed tim e dependence of these echoes are well tted to the expression  $exp(^2)$  (here is half of the time lag between the initial signal and an echo), a behavior which can be derived phenom enologically by assuming Lorentzian Brownian motion for the electron spin Zeem an frequency [2, 9]. In our method this behavior arises naturally from the collective quantum evolution of the dipolar coupled nuclei, without any phenom enological assumption on the dynamics of the environm ent responsible for decoherence. A proper description of coupled spin dynamics is rather di cult due to the absence of W ick's theorem for spin degrees of freedom. In that regard, variations of our method may prove rather useful, since environm ental spin baths are ubiquitous in any device exploiting the coherent properties of quantum spin system s.

The free evolution H am iltonian for the spectral di usion problem is given by [5]

Here S denotes the electron spin operator which couples to the nuclear spin  $I_n$  located at the lattice site  $R_n$ . The nuclear spins are coupled to the electron through the hyper ne constant  $A_n$ . We have truncated Eq. (4) since the non-secular hyper ne coupling can be neglected at m oderate magnetic elds (B > 0:1 Tesla for the SiP case). This interaction leads to interesting e ects at B = 0 [10], but at the moderate magnetic elds required for spin resonance m easurem ents it only contributes a sm all visibility decay [11]. Each nuclear spin is coupled to all others via the dipolar interaction Eq. (5), which is again truncated in the range of m oderate B elds (For further details we refer to R ef. [5]). The Hahn echo experiment consists in preparing the electron spin in the initial state  $\dot{y}_e i = (J'i + i \#i) = 2$ , and then allowing free evolution for time . A -pulse (here described by the Pauli operator x;e) is then applied to the electron spin, and after free evolution for one more interval an echo is observed, which provides a direct m easurem ent of single spin coherence (i.e.  $T_2$  or  $T_M$  in the usual notation).

W e will now derive an exact expression for the H ahn echo decay due to Eq. (1). The density m atrix (for electron and nuclear spins) describing H ahn echo is given by

Here  $_0$  is taken to be a therm all state for the nuclear spins,

where  $H_n = H_{Zn} + H_B$  and M is its partition function (M  $2^N$  for T nK [5], where N is the number of nuclear spins). The spin echo envelope is then given by

A n explicit expression for Eq. (9) can be obtained by noting that the electron and nuclear spin Zeem an energies commute with the total Ham iltonian, and  $_{x,e}$  anticom – mutes with  $S_z$ . A fler a few manipulations we get

are evolution operators under the e ective H am iltonians

which describe dipolar evolution under the e ect of an electron spin up  $(H_+)$  or down  $(H_-)$ . The trace in Eq. (10) is taken over nuclear spin states only.

In the high temperature limit ( $k_B T = IB$ ) we can expand Eq. (10) in powers of to get

De ning the parameter

we obtain the rst ve coe cients  $\mathbb{D}_{21}$  as a power series of  $c_{nm}$  and  $b_{nm}$ . For example, the rst two coe cients become explicitly D  $_2$  = 0, D  $_4$  = 4  $_{n < m} c_{nm}^2 \, b_{nm}^4$ . Truncating Eq. (13) gives physical results only for extrem ely short unless most nuclear pairs satisfy the condition  $c_{nm}$  1. Nevertheless most physical problem s are characterized by several  $c_{nm}$  1, making evident the need for an alternative expansion. Thus the expansion, while being form ally exact, is not practical for coherence calculation except for extrem ely short .

In the  $c_{nm}$  1 regime, non-degenerate perturbation theory is applicable to Eq. (12). We introduce a bookkeeping parameter such that  $H = H_0$   $H^0$ . Here the unperturbed Ham iltonian  $H_0 = \frac{1}{2} \prod_n A_n I_{nz}$  is diagonal in the nuclear spin z-basis, while  $H^0 = \frac{1}{2}H_B$  is the dipolar interaction rescaled to have the same magnitude as  $H_0$ . A convenient choice for an order of magnitude estimate of  $1=j_{nm}j$  is to use the minimum possible value of  $b_{nm} = A_n$   $A_m$  jbetween nearest neighbors:

M ax  $(b_{nm})=M$  ax  $(A_n)$  10<sup>3</sup> for SiP.Below we introduce a cluster expansion that can be related to powers of in this perturbation approach when  $c_{nm}$  1.

Let D be a subset of the nuclei in the problem . Let  $v_D$  () be the solution of  $v_E$  () [Eq.(10)] when only including the nuclei in D. We recursively dene the contribution from subset D as  $v_D$  () minus contributions from any proper subset of D,

For the empty set, we de ne  $v_{i}^{0}() = v_{i}() = 1$ . Consider a subset contribution written in the form of the non-degenerate perturbation expansion. A sum ing M ax ( $b_{hm}$ ) 1, we can show by the speci c properties of H<sup>0</sup> that a cluster of size k is composed of terms that are O (<sup>k</sup>) or higher. In other words, we can write the following expansion,

where the second sum mation is over all possible nuclear subsets of size k (containing k distinct nuclear sites). We note that a subset of size 1 gives no contribution. The O ( $^{k_0+1}$ ) error in Eq. (16) is m isleading because the number of terms of a given order of may be large compared to . The nature of this problem , as well as a solution, becomes apparent when we use a nearest neighbor approximation. W ith this approximation, we ignore the interaction between distant nuclei (i.e. pairs of nuclei for which  $b_{\rm hm}$  is below some threshold) and divide our nuclear subsets into connected \clusters." A subset contribution is then the product of its cluster contributions.

Consider all possible contributing subsets of size k. We can categorize these subsets by the number of clusters they contain. To estim ate the number of subsets of size k with 1 clusters, consider building the subset random ly. First select l nuclei at random for each of the l clusters. The remaining k l nuclei are chosen random ly from the neighbors of any previously chosen nuclei. Let L be the average number of \nearest neighbors" for each nucleus. The probability that a nucleus will bridge two clusters that were meant to be separate is at most 0  $rac{\mathrm{kL}}{\mathrm{N}}$  . So the probability that any of the k nuclei will bridge two clusters is at most 0 1 1  $\frac{kL}{N}^k$  ! 0  $\frac{k^2L}{N}$  . Therefore, as long as  $k^2$ N=L, we can accurately estim ate the num ber of subsets in this manner of choosing nuclei at random . Under this condition, the number of subsets of size k with 1 clusters will scale roughly (without dividing out permutations) as 0 (N  $^{1}L^{k}$  ), growing exponentially with N as we increase the num ber of clusters. C lusters of size one give no contribution; therefore, assuming k N = L and NL, the possible contributing subsets of size k are dom inated by those containing all pairs (and a single triplet if k is odd) which maxim izes the number of contained clusters. If k = 21is even, then the number of contributing subsets of size N = L, largely composed of l pairs, is  $O = \frac{(N L)^2}{2^2 U}$ . k Therefore, our subset expansion [Eq. (16)] error grows  $\sqrt[]{N=L}$  as O  $\frac{(^{2}NL=2)^{l_{0}}}{l_{0}!}$ . This is with  $k_0 = 2l_0$ problem atic because <sup>2</sup>N L is not necessarily sm all. Noting, however, that most contributing subsets are com posed entirely of pairs (except the one triplet of odd-sized subsets), we can approximate the solution up to order N =L by adding all possible products of pair conk<sub>0</sub> tributions as obtained by distributing the product in the follow ing,

which gives the lowest order of our cluster expansion. The correction O  $\frac{\binom{2}{N}L=2)^{l_0}}{l_0!}$  is in nitesimal provided  $l_0 = k_0=2$   $p \frac{p}{N=L}$   $^2N$  L, or  $1=(N L^3)^{1=4}$ . For N  $10^4$  and L 10, we get 0:02 as the condition for disconnected pairs to dom inate spectral di usion de-

cay. The O (L) in Eq. (17) represents the error incurred by not considering clusters larger than pairs (including what is required for odd subsets) and can be thought of as the contribution you get by adding a neighbor to one of the distributed pairs. Not all of the term s obtained by distributing Eq. (17) will contain pairs that are disconnected from each other. However, using the same argument we used to estimate numbers of contributing subsets,  $1 < k_0=2$  random pairs will most likely be disconnected when  $k_0$  N = L. These extraneous terms are therefore negligible at each order below  $k_0$ .

For a cluster of two nuclear spins (D = fn;m g) exact evaluation of  $v_D$  () using Eq. (10) in the high tem perature lim it leads to

with  $c_{nm}$  de ned in Eq. (14). Using Eq. (17) and the condition M ax  $(b_{nm})$  1 we write the nalexpression for the lowest order cluster expansion as

Note that including clusters of three adds a correction O(L) to the decay.

We have presented two theories. Both require M ax  $(b_{nm})^{\perp}$ ; how ever, in problem swe've considered, the decay time is well within this limit. We argued the expansion  $\mathbb{E}q.(13)$ ] converges for  $c_{nm}$ 1 while the cluster expansion [Eq.(17)] for c<sub>nm</sub> 1. The cluster expansion becom es non-perturbative through the use of the exact solution Eq. (18). In fact, in the same way that cluster size was related to m in im um orders of in the perturbation expansion, we can also relate cluster size to m in im um orders of in the -expansion. For example, by taking 1 in Eq. (18) we recover Eq. (13) to low est order, Cnm show ing that this exact solution interpolates between the two regimes at low est order. For physical problem swhere a wide range of parameters cnm coexist, exact evaluation of larger clusters provides a novel system atic approxim ation to the problem of spectral di usion.

W e use Eqs. (20) and (18) to perform explicit calculations of electron spin echo decay of phosphorus in purities in silicon [5, 6, 7]. In this case the parameter  $A_n$  is given by the hyper ne shift of a nuclear spin positioned a vector  $R_n$  from the donor center,

We used  $_{\rm S}$  = 1:76  $10^7$  (sG)  $^1$  and  $_{\rm I}$  = 5:31  $10^3$  (sG)  $^1$ . Here (R<sub>n</sub>) is the Kohn-Luttinger wave function of a phosphorus donor impurity in silicon, as




FIG.1: Hahn echo decay  $v_E$  (;) of a phosphorus donor electron spin in silicon. (a) Theory (solid lines) and experiment is shown for several orientation angles of the magnetic eld with respect to the crystal lattice, ranging from the [100] to the [110] direction (= 0;10;20;:::;90). (b) Here we plot  $\ln v_E$  (;) +  $\ln v_E$  (; = 0), allowing for the rem oval of any decoherence mechanism which is independent of . The qualitative and quantitative agreement between theory and experiment is rem arkable, in contrast to the stochastic approach (dashed).

described in Ref. [5]. The central <sup>31</sup>P nuclear spin does not contribute to spectral di usion because its hyper ne energy is signi cantly larger than any of its neighbors, suppressing the spin ips by energy conservation. Dipolar coupling is given by

It contains an important anisotropy with respect to the angle  $_{nm}$  form ed between the applied magnetic eld and the bond vector linking the two spins (R  $_{nm}$ ). This property leads to a strong dependence of spin echo decay when the sam ple is rotated with respect to the applied B eld direction. Fig. 1 shows experimental data when the sam – ple is rotated from the [100] to the [110] direction. Here the cluster approximation is expected to be appropriate for 1 5 m s. Finally, in a natural sam ple of silicon only a small fraction f = 4:67% of lattice sites have non-zero nuclear spin (these are the spin-1=2<sup>29</sup>Si isotopes). A veraging Eq. (17) we get

O ur numerical calculations of H ahn echo decay for several magnetic eld orientation angles are shown on F ig. 1(a). We also show experimental data taken for bulk natural silicon with phosphorus doping concentration equal to  $2 10^5 ext{ cm}^3$  [8]. The high concentration

of phosphorus donors leads to an additional decoherence channel arising from the direct spin-spin coupling between the electron spins that contribute to the echo. This contribution can be shown to add a multiplicative factor exp ( =1 m s) to Eq. (23) [12]. Because this contribution is independent of the orientation angle, we can factor it out by subtracting the = 0 contribution from the logarithm of the experimental data taken at angle . The result is shown on Fig. 1(b) (log-log scale). Our theory seems to explain the time dependence of the echo quite well. To check convergence of our cluster expansion we have gone to the next order. Including clusters of three amounts to a contribution of 0:1%, in agreement with 10<sup>3</sup>. We have also veri ed that our estimate of fL our cluster expansion results agree quantitatively with Eq. (13) for small when excluding nuclei close to the center of the electron wave function where cnm 1.This result is to be compared with the recent stochastic theory developed by two of us [5] (Dashed line in Fig. 1 (b) shows the stochastic calculation for = 60). Although the stochastic theory yields correct order of m agnitude for the coherence times, it fails qualitatively in explaining the time dependence. The present method is able to incorporate all these features within a fully microscopic fram ew ork.

An important issue in the context of quantum information is the behavior of spin coherence at the shortest tim e scales. The experim ental data in Fig. 1 reveals several oscillating features which are not explained by our current m ethod. These are echo m odulations arising from the anisotropic hyper ne coupling om itted in Eq. (1) [7]. This e ect can be substantially reduced by going to higher magnetic elds (In a quantum computer В 9 Tesla will probably be required in order to avoid loss of delity due to echo m odulation [13]). On the other hand, spectraldi usion is essentially independent of magnetic eld even to extrem ely high values (B 10 Tesla). Nevertheless this e ect is expected to be absent in III-V m aterials [14], hence our theory allows the study of spin coherence at tim e scales of great in portance for quantum information purposes but currently inaccessible experim entally.

In conclusion, we describe a new quantum approach for the problem of localized electron spin decoherence due to the uctuation of dipolar coupled nuclear spins. In contrast to form er theories, our method requires no ad hoc stochastic assumption on the complex dynamics of the environm ent responsible for decoherence. Hence it provides an important example where direct integration of the environm ental equations of motion provides a system – atic understanding of the loss of coherence which needs to be controlled for quantum information applications. After the completion of the review process of our

m anuscript, a preprint by W ang Yao, Ren-Bao Liu, and L.J.Sham [15] appeared exactly reproducing our lowest order theoretical result by a completely di erent technique which treats excitations of nuclear paircorrelations as quasi-particles that are non-interacting for

M ax  $(b_{hm})^{-1}$ . This independent agreem ent dem onstrates the validity of our cluster expansion technique.
