# On the higher order corrections to the Fokker-P lanck equation

#### Abstract

$T$ he $R$ ayleigh $m$ odel of nonlinear $B$ row $n i a n ~ m o t i o n ~ i s ~ r e v i s i t e d ~ i n ~ w h i c h ~ t h e ~ h e a v y ~ p a r t i c l e ~ o f m ~ a s s ~$ $M$ interacts $w$ ith ideal gas molecules of $m$ ass $m \quad M$ via instantaneous collisions. U sing the van $K$ am pen $m$ ethod of expansion of the $m$ aster equation, non-linear corrections to the Fokker-P lanck equation are obtained up to sixth order in the $s m$ all param eter $=\overline{\mathrm{m}=\mathrm{M}}$, im proving earlier results. The role and origin of non-G aussian statistics of the random force in the corresponding Langevin equation are also discussed.

## I. IN TRODUCTION

There has been renewed discussion recently of the $R$ ayleigh $m$ odel of nonlinear $B$ rownian $m$ otion, stim $u-$ lated prim arily by ndings of new qualitative e ects govemed by nonlinear stochastic processes such as recti cation of uctuations [1-4], stochastic resonance In the $R$ ayleigh $m$ odel the heavy $B$ rownian particle of $m$ ass $M$ is im $m$ ensed in an idealgas ofm olecules ofm ass $m \quad M$ and interacts w ith them through instantaneous elastic collisions. T he gas is assum ed to be so rare ed that collisions of its m olecules $w$ ith the particle do not a ect the distribution of incident molecules, and also re-collisions can be nfglected. In lowest order in the sm all param eter $=\overline{\mathrm{m}=\mathrm{M}}$, the velocity distribution function $f(V ; t)$ of the particle satis es the second order FokkerP lanck equation which can be obtained by the conventionalm ethod, i.e. truncating the $K$ ram ers $M$ oyal expansion of the $m$ aster equation to the nst two term $s$ and evaluating coe cients integrating the corresponding Langevin equation $\left[\begin{array}{l}6 \\ 1\end{array}, 171\right]$. T his procedure is consistent if the random force in the Langevin equation can be treated as white (w ith negligible correlation tim e) and G aussian. H ow ever these two assum ptions m ay be justi ed strictly speaking only in the ultim ate lim it ! 0. For nite , the $K$ ram ers $M$ oyal expansion has generally an in nite num ber ofnon-zero term $s$, and $m$ ore carefiulanalysis is needed to study e ects of higher order in ${ }^{[ }[\mathbf{k}]$. In this case, as was rst shown by van $K$ ampen, the differential equations for the distribution function do not have the form of the second order FokkerP lanck equation but rather involve derivatives of order higher than tw o $\left.\bar{p}_{0}^{1}, 191\right]$. A though these higher order equations are linear in the distribution function, they are som etim es referred to as nonlinear Fokker-P lanck equations because the corresponding Langevin equations involve nonlinear corrections of higher orders in to the linear dam ping force. T hese corrections $m$ ay lead to interesting physical consequences, such as additionalterm $s$ in the uctuation spectrum and modi cation of decay rate coe cients ${ }_{1}^{[-[7]}$. A lso, going beyond the low est order is often necessary to account for delicate uctuation-induced phenom ena such as directional drift in the absence of system atic forces.

If the tem peratures on the left and right sides of the $R$ ayleigh particle are di erent, the particle undergoes directionalm ovem ent even when the pressure on both sides is the sam e [2-4]. T he system atic average velocity of the particle can be calculated as a perturbative solution of the Langevin equation w ith nonlinear corrections to the dam ping force [3]-1]. A trematively, one can use the corresponding nonlinear Fokker-P lanck equation or an equivalent set of equations for the $m$ om ents [ $\left[\frac{1}{1}\right]$.

To derive a di erential equation for the distribution fiunction $f(V ; t)$ to desirable order in , one has to extract an explicit -dependence in the $K$ ram ens M oyalexpansion, transform ing it into the expansion in pow ers of , often referred to as the van $K$ am pen expansion (VKE). T hem ethod essentially relies on an assum ption of certain scaling properties of transition rates in the $m$ aster equation. For the R ayleigh m odel an explicit expression for the transition rates is available and all coe cients in the VKE can be found analytically. N ote that another popular exactly solvable m odel of B row nian m otion, nam ely that of a particle coupled to a bath of ham onic oscillators, is degenerate in the sense that all nonlinear corrections vanish identically.

T he $R$ ayleigh $m$ odelm ay be generalized in $m$ any ways to study e ects of asym m etry of the surrounding bath [24], possibility of non-canonical distributions [10], niterange interaction [11], strong non-equilibrium uctuations [12], etc. To analyze these generalizations it w ould be of help to com pare their predictions w th the results of the originalm odel. In doing that we have found that the VKE for the R ayleigh m odel often appeared in the literature in form $s$ which are either not quite accurate or incom plete, and lead to nonlinear Fokker-P lanck equations w ith serious defects. For instance, these equations $m$ ay have a non-G aussian stationary solution even when the $M$ axw ellian distribution is an exact solution of the original $m$ aster equation. $V$ iolation of the equilibrium condition can lead to large errors, such as an exponentially overestim ated activation ux in the barrier cross-
 the $M$ axw ellian distribution $m$ ust satisfy each term of the VKE for the R ayleigh particle separately. W hile the equation of order ${ }^{4}$ derived in [801] has the $M$ axw ellian
stationary solution, the equations obtained later by other authors do not always posses this virtue [14, '15] The extraction of explicit dependence on for the Rayleigh m odel is slightly m ore com plicated com paring w th other applications of the van $K$ am pen $m$ ethod and requires som e care. O ne purpose of this paper is to give an accurate derivation of the equations for the velocity distribution of the Rayleigh particle up to order ${ }^{6}$. These equations have the $M$ axw ellian stationary solution and preserve positivity of the distribution function when deviations from equilibrium are sm all. A nother purpose is to discuss som e subtle points relevant to the derivation, such
as the origin and consequences of non-G aussian statistics of the random force in the corresponding Langevin equation, which has not been clearly articulated in the literature so far. A though the assum ption of $G$ aussian random force w as criticized in the literature $[\bar{T}]$, it is still w idely applied to derive the second order Fokker $P$ lanck equation, often without proper justi cation. In the last section we discuss w hy the random force is approxim ately G aussian in low est order in , while corrections of higher orders $m$ ay be essentially non-G aussian. This fact has im portant im plications which go far beyond the speci c m odel considered here.

## II. KRAMERS-MOYALANDVANKAMPENEXPANSIONS

The conventional starting point in the derivation of the Fokker-P lanck equation, as well as equations of higher order, is the $m$ aster equation for the velocity distribution function $f(V ; t)$

It is convenient to express the transition rates $W \quad\left(V_{1}!V_{2}\right)$ as a function of the initial state $V_{1}$ and the transition length $V=V_{2} \quad V_{1}$, that is $W\left(V_{1}!V_{2}\right)=W\left(V_{1} j V\right)$. Then the $m$ aster equation takes a m ore suggestive form

If the random force exerted on the particle by the bath $m$ olecules is white and Gaussian, one can show that only two rst term s survive in the $K$ ram ers $M$ oyal expansion, which therefore tums into the second order Fokker-P lanck equation. This can be proved using another equivalent representation for $a_{n}$,

 usually unknown. On the other hand the average $(V(t+) V(t))^{p}$, appearing in $\left.\mathbf{V}_{\mathbf{\sigma}}^{\boldsymbol{\sigma}}\right)$, can be readily found integrating the Langevin equation

$T$ his approxim ation corresponds to a coarse-grained description with a time resolution o much shorter than the characteristic tim efor the relaxation of the particle's velocity $v$ and $m u c h$ longer than the correlation tim $e$ for the
 tim e dependence of $A(V(t))$, but not of the random force which evolves signi cantly with the integration range
 For a white and G aussian random force only two rst term s survive in the $K$ ram ers $M$ oyalexpansion,

$T$ he result that in the $K$ ram ers $-M$ oyalexpansion only tw o rst term $s$ do not van ish relies entirely on the assum ptions that the random force in the Langevin equation is $G$ aussian white noise. The above approach does not involve any param eters controlling applicability of this assum ption, and the range of validity of the Fokker $P$ lanck equation is di cult to analyze. This di culty does not arise in situations when transition rates in the $m$ aster equation are know $n$ explicitly. In this case one can nd a directly from Eq. (IT) w thout appealing to the Langevin equation and therefore $w$ thout $m$ aking any assum ption about statistical properties of the random foroe. $U$ sing this $m$ ethod one nds that the condition $a_{n}=0 ; n>2$ does not hold invariably, and the $K$ ram ers $M$ oyalexpansion contains in general in nite num ber of term $s$. N evertheless, it is still possible to get for $f(V ; t)$ a di erential equation of nite order analyzing dependence of coe cients $a_{n}$ on the $s m$ all param eter and neglecting term sofhigher order in . The K ram ers M oyal expansion in the form ( $\overline{4}_{1} \mathbf{i}$ ) is not appropriate for such a perturbation analysis because the dependence on is im plicit in ( $\underline{4}_{1}^{\prime}$ ). A ssum ing that transition rates have certain scaling properties w ith respect to, van $K$ am pen modi ed the $K$ ram ers $\mathcal{M}$ oyalexpansion transform ing it into the form of the expansion in powers of . K eeping term s up to order
${ }^{n}$ in this expansion, one obtains for $f(V ; t)$ the di erential equation of order $n$.

## III. VAN KAMPEN EXPANSION FOR THERAYLEIGH PARTICLE

For the one-dim ensional $R$ ayleigh $m$ odel the transition rate has the form $[\underline{17}]$

Second, the expansion (1-d) involves dependence on the velocity the particle $V$ which is obviously a function of . If we restrict ourselves to $s m$ all-range uctuations about the equilibrium state, it $m$ ay be reasonably expected from fhe equipartition theorem that the ratio of the particle's typical velocity to that of surrounding $m$ olecules is of order $\overline{\mathrm{m}=\mathrm{M}}$. T his leads to the second scaling assum ption

where ${ }_{n}{ }^{(p)}$ is $p$-th derivative of $n(V)$ at $V=0$. Physically this expansion re ects the fact that the heavy particle is $m u c h$ slower than surrounding light $m$ olecules. The rst term $w$ ith $p=0$ corresponds to the particle which does not $m$ ove at all (approxim ation of the in nitely heavy particle, ! 0), while the next term successively take into account the nite inertia of the particle.

Substitution of the above expansions for ${ }^{2 n}$ and $n$ in (19인) gives nally the desirable van $K$ am pen expansion in powers of

$T$ his form of the VKE is slightly di erent from that one usually nds in the literature and has the advantage that the dependence on is entirely contained in the product $n+p_{n}()$, whereas the coe cients ${ }_{n}^{(p)}$ are -independent.

$T$ hese form ulas are valid not only for the originalR ayleigh $m$ odel, but also for asym $m$ etric $m$ odels [2-4] when properties of the bath on the left and on the right of the particle are di erent. O fcourse, the explicit form of the coe cients ${ }_{n}^{(p)}$ are di erent for di erent $m$ odels. In $w$ hat follow $s w e$ restrict ourselves to the sym $m$ etric problem when the transition

IV. FOKKERPLANCK AND H IGHER ORDEREQUATIONS
$T$ he results of the previous section allow to $w$ rite the van $K$ am pen expansion for the $R$ ayleigh $m$ odel in the explicit form up to order ${ }^{6}$. Truncation of (2-1) to term sof order ${ }^{2}$ leads to the second order FokkerP lanck equation

It was shown recently that the equation ( $3 Z_{1}^{\prime}$ ), rst derived by $R$ ayleigh, can be recovered $w$ ith in a $m$ ore general approach expressing coe cients in the -expansion in term $s$ of correlation functions for the random force and then taking the $M$ arkovian lim it [1] $\left.\overline{1}_{1}^{1}\right]$.

This equation appeared previously in an incom plete form in $\left[4^{1}\right] m$ issing the term ${ }_{5}^{(1)} \frac{e^{5}}{d x^{5}} x$ in $D_{6}$.

O ne can show $\left[\bar{T}_{1} \bar{\eta}_{1}\right]$ that the stationary solution of the $m$ aster equation with transition rates in the form (13) is the $M$ axw ellian distribution which for the scaled velocity $\mathrm{x}={ }^{1} \mathrm{~V}$ has the form $\mathrm{f}_{\mathrm{s}}(\mathrm{x})=\mathrm{C} \exp \quad \frac{1}{2} \mathrm{x}{ }^{2}$. This distribution does not depend on and therefore must satisfy each term in the expansion (2d) separately,

O ne can immediately check that the above expressions for $D_{2}, D_{4}$, and $D_{6}$ do satisfy this condition.

Eqs. (3G) or (3d) can be solved using an appropriate perturbation technique, how ever it is often easier to handle the equations for the m om ents $h x^{n}$ i $\left.\left.\bar{T}_{1}, 11\right]_{1}^{1}\right]$.

It is know $n$ that approxim ationsof the $m$ asterequation by a di erential equation involving derivatives of order higher than two m_ay lead to solutions w hich are not pos-
 equation ([3], preserves positivity off is because the right hand side of the equation, and therefore the tim e derivative $f_{t}$, are alw ays positive at the points where $f(x ; t)$ as a function of $x$ has $m$ inim a. As a result, the $m$ inim a becom e less deep with time, the initially positive solution rem ains positive for all tim es. This is not true in general for Eqs. ( 3 (3G) and (3) ${ }^{2}$ ) involving $x$-derivatives of order higher than two. These derivatives can be of any sign at extrem e points, which in principle $m$ ay result
in negative $f_{t}$ at $m$ inim um points. H ow ever, since the term $s$ w ith higher order derivatives are of higher order in , one $m$ ay expect that for su ciently smooth initial distributions the sign of the right sides of $E$ qs. ( 3 G) and ( 3 ) is determ ined by the term $w$ ith $f_{\mathrm{xx}_{\mathrm{r}} .}$ For $\mathrm{ex}^{2}-$ am ple, the only term $s$ in the right side of Eq.(3G) which can be negative at $m$ inim um points are those involving ${ }^{4} \quad{ }^{3=2} \mathrm{xf}_{\mathrm{xxx}}$ and ${ }^{4} \quad{ }^{5=2} \mathrm{f}_{\mathrm{xxxx}}$. T They are sm aller than the term ${ }^{2}{ }^{3=2} \mathrm{f}_{\mathrm{xx}}$, which gives the positive contribution, by the factors of order ${ }^{2}\left(x=x_{c}\right)$ and ${ }^{2}\left(x_{\text {th }}=x_{C}\right)^{2}$, respectively. H ere $x_{c}$ is the characteristic length of the distribution $f(x ; t)$ for a given $t$, and $x_{t h}$ is the scaled
them al velocity of the particle, $x_{\text {th }}=\quad{ }_{1} \frac{k_{B} T=M}{}$. $R$ ecall that the expansion $m$ ethod we used im plies that the system is close to equilibrium and that $x \quad x_{\text {th }} \quad{ }^{0}$. U nder this condition the term $w$ th $f_{x x}$ dom inates and determ ines the sign of the right hand side of Eq. (3-1) at $m$ inim um points, which guarantees preservation of the positivity of the solution.

The expansion $m$ ethod $m$ ay be im plem ented also for non-equilibrium uctuations'[12] but in that case the possibility to introduce a stochastic variable $x$, which would be of order one for all relevant tim es, is less obvious and has to be justi ed a posteriori.

## V . D ISC U SSIO N

If the white random force $F$ ( t ) in the Langevin equation $V(t)=A(V)+F(t)$ is also assum ed to be a G aussian process, then the conventional procedure outlined in Section 2 leads invariably to the second order Fokker$P$ lanck equation (1 $1 \overline{2}_{1}$ ), no $m$ atter whether the dam ping force A (V) is linear or not. On the other hand, the van $K$ am pen $m$ ethod, which does not require any assum ptions about statistics of the random foroe, leads to the second order equation only to the lowest order in the expansion param eter, when the dam ping force is linear $A(V)=V$. In higher orders in , when the dam ping force A ( V ) involves nonlinear corrections $A(V)={ }_{1} V \quad{ }_{3} V^{3} \quad$ (where ${ }^{2}$ ), theVKE leads to equations w th $V$ derivatives of order higher than two. Thismeans that the approxim ation of a $G$ aussian random force is legitim ate to lowest order in but not to higher orders. It is therefore inconsistent to take into account nonlinear corrections to the linear dam ping force $A(V)=V$, and at the sam $e$ tim e to assum e that the random force is $G$ aussian. Failure to appreciate this point $m$ ay lead to $w$ rong conclusions. For exam ple, for the $R$ ay leigh $m$ odel the $M$ axw ell distribution is a correct stationary solution to any order in . O n the other hand the assum ption of a G aussian random force would lead to the FokkerP lanck equation (121) which for nonlinear $A(V)$ has a non $-M$ axw ellian stationary solution.
$T$ he $G$ aussian property of the random force is usually expected to hold intenpreting the force as a result ofm any uncorrelated collisions, and appealing to the the central lim it theorem. H ow ever, one has to keep in $m$ ind that a decom position of the total force exerted on the particle into a regular dam ping and \random" parts is a purely $m$ athem atical procedure, which in general can be perform ed w th an appropriate pro jection operator technique. The random force $F(t)$, obtained in this w ay generally can not be interpreted as a superposition ofm any \physical" forces. M oreover, it is not even a dynam i-
cal variable: its evolution in tim e is not govemed by the N ew tonian propagator $\exp (\mathrm{tL})$ w ith the Liouville operator L, but by a m ore com plicated \pro jected" propagator. O ne can get som e insight in properties of the random force expanding it in powers of which has the form [ill

where $S(t)$ is a non $-N$ ew tonian propagator the explicit form of which is not im portant for our purpose here. The rst term $F_{0}(t)$ in the expansion (42) is a dynam ical variable and has a well de ned physical meaning: it is a force exerted on the particle xed in space (the lim it of in nitely heavy particle). C onventional qualitative reasoning to justify the Gaussian property is quite applicable for this term. M oreover, for a large B rownian particle, interacting sim ultaneously $w$ ith $m$ any bath $m$ olecules, the $G$ aussian property of $F_{0}(t)$ can be proved analytically [1]. To low est order in the random force is just $F_{0}(t)$ and therefore is $G$ aussian. On the other hand, there is no reason to expect that the same argum ent should work for the \unphysical forces" represented in (42") by term s of higher orders in involving the non N ew tonian propagator. These term s in general are not $G$ aussian. In a future publication we shallexplicitly evaluate correlation functions hF $\left(t_{1}\right) F\left(t_{2}\right) \quad k F(t$ for an exactly, solvable $m$ odel $w$ th parabolic interaction suggested in [1] [1]. This would allow to construct the expansion sim ilar to the VKE but expressing coe cients in term $s$ of correlation functions for the random force rather than transition rates $W$. In low est order in it was done in $\left[\overline{l n}_{1}^{1}\right]$ recovering in the $M$ arkovian lim it the Fokker $P$ lanck equation ( $344^{\prime}$ ).
