### The Quantum Compass M odelon the Square Lattice

U sing exact diagonalizations, G reen's function M onte C arb simulations and high-order perturbation theory, we study the low-energy properties of the two-dimensional spin-1/2 com pass m odel on the square lattice de ned by the H am iltonian H =  $\begin{bmatrix} J_x & x & x & r + e_x \\ r & x & r & r + e_x \end{bmatrix}$ . When  $J_x \notin J_z$ , we show that, on clusters of dimension L L, the low-energy spectrum consists of  $2^L$  states which collapse onto each other exponentially fast with L, a conclusion that remains true arbitrarily close to  $J_x = J_z$ . At that point, we show that an even larger number of states collapse exponentially fast with L onto the ground state, and we present numerical evidence that this number is precisely  $2 \quad 2^L$ . We also extend the symmetry analysis of the model to arbitrary spins and show that the two-fold degeneracy of all eigenstates remains true for arbitrary half-integer spins but does not apply to integer spins, in which cases eigenstates are generically non degenerate, a result com med by exact diagonalizations in the spin-1 case. Im plications for M ott insulators and Josephson junction arrays are brie y discussed.

#### I. IN TRODUCTION

Building on the deep understanding of the Heisenberg and otherm odels ofm agnetism , it is a very com m on practice to describe discrete degrees of freedom as pseudospins, with the hope to gain insight from the form of the resulting magnetic model. A well-known example of considerable current interest shows up in the context of M ott insulators with orbital degeneracy: In an octahedral environment, the degeneracy of the d electrons is only partially lifted, and the remaining orbital degree of freedom is often described as a spin-1/2 or 1 for  $e_{\alpha}$  and  $t_{2q}$  electrons, respectively [1, 2]. However, the situation is in general less simple that one m ight hope. Indeed, as already em phasized by Kugeland Khom skii, the symmetry of pseudo-spin H am iltonians is in generalm uch low er than SU (2), and there are cases where the properties of the resulting model are poorly understood. This is in particular the case of models where the anisotropy of the coupling in spin space is related to the orientation of the bond in real space. The simplest version of such a model on the square lattice is de ned by the Ham iltonian

where  $_{\rm r}$  are the x and z components of a pseudo-spin operator. By analogy with the dipolar coupling between compass needles, this model has been called the compass model by Kugel and Khom skii [2]. Realistic models of orbital degeneracy are usually more complicated in several respects. In particular, the spins and pseudo-spins are usually coupled. Pure orbital models can be of direct relevance though if the spins order ferrom agnetically, as recently argued by M ostovoy and Khom skii in the context of N aN iO<sub>2</sub> [3]. The precise symmetry is also usually more complicated than the simple case of this Ham iltonian, but we will nevertheless concentrate on that model, considering it as a m inim alm odel rather than a realistic one.

Interestingly, such m odels have appeared in other contexts as well. F irst, even in M ott insulators without orbital degeneracy, extra degrees of freedom can appear if the system is frustrated and, for instance, consists of spin-1/2 coupled triangles, like in the trim erized kagom e lattice, in which case the chirality that keeps track of the extra degeneracy of each triangle plays a role sim ilar to that of orbitals [4]. In a magnetic eld, this m odel has been predicted to exhibit a magnetization plateau at 1/3 [5], and the low energy properties inside the plateau can be described by a kind of com pass m odel [6].

M ore recently, the model of Eq. (1) with anisotropic couplings along the x and z directions has been proposed by D oucot and collaborators in the context of Josephson junction arrays [7].

Despite its deceptive simplicity, the model of Eq. (1)is a form idable challenge, in many respect comparable to very frustrated magnets. To see this, let us follow Ref. [8] and consider the classical version of the model, in which spins are considered as classical vectors. In that case, as shown by Nussinov et al., the ground state is highly degenerate, as in very frustrated m agnets. First of all, all ferrom agnetic states are degenerate, regardless of the relative orientation of the spins with respect to the lattice, as can be easily checked from Eq. (1). In addition, from any ferrom agnetic state, one can construct other states by ipping all spins of a z colum n with respect to an x m irror, or equivalently by ipping all spins of an x line with respect to a z m irror. Since all these operations can be performed simultaneously and in any order, they generate a discrete degeneracy of order 2<sup>L</sup>.

The e ects of them al uctuations on the classical modelhave been convincingly identied by analytical and

num erical approaches. Nussinov et al. have shown that an order by disorder mechanism is expected to lift the rotational degeneracy and to select states in which the spins point along the x or z axis, leading to a nem atic ground state since lines or colum ns of spins are still free to ip. U sing extensive M onte C arlo simulations, M ishra et al. have shown that the two possible orientations along x or z lead to an elective Ising order parameter, and that the m odel undergoes a nite tem perature phase transition of the Ising type [9].

On the other hand, the understanding of the spin-1/2 version of the model is still prelim inary. Most of the results have been obtained by D oucot et al. [7] in their analysis of a generalized version of the model of Eq. (1) de ned by the H am iltonian

in which the couplings along the x and z directions can take di erent values. U sing elegant sym m etry argum ents, D oucot et al. have show n that all eigenstates must be at least two-fold degenerate. They have also shown that in the strongly asymmetric case  $(J_x=J_z)$ 1 or  $J_z = J_x$ 1), the  $2^{L}$  states that evolve adiabatically from the 2<sup>L</sup> ground states of the decoupled Ising chain case  $(J_x = 0 \text{ or } J_z = 0)$  should collapse onto each other. This perturbative argum ent does not apply close to  $J_x = J_z$ though, and whether this remains true in the isotropic case could not be decided. Note that this is an important issue in the context of quantum bits in which they cam e accross this model since the presence of a gap would help to protect the q-bits. M ore recently, Nussinov and Fradkin [10] have shown that these models are dual to models of p + ip superconducting arrays, and have discussed general properties of order param eters and phase transitions.

In this paper, we concentrate on the zero-tem perature properties of the quantum version of the model. We start by a sem i-classical analysis of the model of Eq. (1) and show that, as in m any frustrated m agnets, quantum uctuations essentially have the same e ect as therm al uctuations regarding the lifting of classical degeneracy (section II). We then turn to an extensive analysis of the model of Eq. (2) in the spin-1/2 case. As we shall see, there is nom inus sign problem in the Green's function im plem entation of quantum M onte Carlo, which allows one to study the ground state properties of very large clusters, i.e., up to 17 17. C om bined with the large num ber of sym m etries, hence of di erent sym m etry sectors that can be studied independently, this allowed us to reach de nite conclusions regarding the low energy spectrum, conclusions that agree with high order perturbation theory. These results are presented in section III. Finally, the symmetry analysis of Doucot et al. is extended to larger spins in section IV, with the conclusion that integer and half-integer spins behave once m ore quite di erently. Som e in plications of the present results are discussed in the last section of the paper.

### II. SEM I-CLASSICAL COM PASS MODEL

In order to have a rst insight into the properties of the quantum version of the com pass model, we have perform ed a spin-wave analysis in the symmetric case dened by Eq. (1). In that respect, it is useful to emphasize that, as noticed in Refs. [8, 9], the degeneracy is partly accidental and partly due to symmetry. Indeed, in addition to the lattice translational sym metries, this model has two types of discrete sym m etries: (i) The  $Q_i$  transformation which ips the z component of all the spins of the column  $r_x = i_i$  and the  $P_i$  transform ations which ip the x component of all spins of the line  $r_z = j$ . Note that the transform ations  $Q_i$  (resp.  $P_i$ ) could be seen as rotations of all the spins of the column (resp. line) about the  $e_x$  axis (resp.  $e_z$ ) by an angle . (ii) The simultaneous rotation  $R_v(\frac{1}{2})$  of all spins and of the lattice about an  $e_y$  axis by an angle  $\frac{1}{2}$ . Starting from any state, these symmetries generate new states with exactly the same classical energy and the degeneracy associated to these symmetries cannot be lifted by thermal uctuations [9]. However, the ground state also has an accidental degeneracy: All ferrom agnetic states are degenerate regardless of the angle between the spins and the lattice. This degeneracy is not related to a sym m etry since the m odel is not rotationally invariant. A coordingly, it has been found that the therm al uctuations partially lift this degeneracy via an order-by-disorder mechanism, favouring the  $2^{\circ}$  ground states with all spins parallel to  $e_x$  or  $e_z$ and implying a directional ordering of the spins. These favoured states are the uniform state with all spins in the direction ex and all the states obtained by applying the symmetries  $R_y(\frac{1}{2})$ ,  $P_j$  and  $Q_i$ . So, as anticipated, only the accidental degeneracy is lifted by them al uctuations.

The same idea applies to quantum uctuations. Starting from an arbitrary ground state, one can bring it back into a ferrom agnetic ground state applying only symmetry operations. But applying symmetry operations does not change the form of the Ham iltonian. The uctuations around both states will thus have exactly the same form. Then it is su cient to do the spin-wave expansion around the uniform classical ground states  $S_r = S \cos_0 e_x + S \sin_0 e_z$ . To linear order in 1=S, the energy can be brought into the form




FIG.1: G round-state energy of the ferrom agnetic states dened by  $S_r = S(_0) = S \cos_0 e_x + S \sin_0 e_z$  including zeropoint energy as a function of the angle  $_0 \cdot E_{cl} = JN S^2$  is the classical ground-state energy.

with  $!_q(_0) = 4JS \frac{P}{1 \cos^2 0 \cos k_x} \sin^2 0 \cos k_z$ , and the resulting ground-state energy is plotted in Fig.1. As in the classical case with them all uctuations, the gure clearly shows that the angles  $_0 = 0; \frac{1}{2}; ; \frac{3}{2}$  are selected by quantum uctuations since they m inimize the energy. Applying the symmetries  $Q_i, P_j$  and  $R_y(\frac{1}{2})$  to these states gives  $2 \frac{2}{2}$  equivalent favoured states, corresponding to  $2^L$  states parallel to  $e_x$  and  $2^L$  states parallel to  $e_z$ . So, as in the classical case, there is a directional

ordering of the ground state.

As ism any frustrated m agnets like the  $J_1$   $J_2$  m odelon the square lattice for  $J_2=J_1=1=2$ , this calculation is not fully consistent since the correction to the m agnetization diverges [11]. In the present case, the divergence comes from a line of zero energy along the  $k_x = 0$  direction when  $_0 = 0$ ; and along the  $k_z = 0$  direction when  $_0 = \frac{1}{2}; \frac{3}{2}$ . We have pushed the expansion to next order in 1/S and checked that a self-consistent m ean- eld decoupling of the 4-boson term s suppresses the divergence. At this approximation, the spectrum becomes gapped, which does not violate any general theorem since the m odel does not possess rotational symmetry, and long-range order is preserved even for spin-1/2.

In the anisotropic case  $(J_x \in J_z)$ , discrete rotational symmetry of the H am iltonian as well as continuous rotational symmetry of the ground state are lost, leading to only the 2<sup>L</sup> ground states with rows of parallel spins along the x axis for  $J_x > J_z$  and columns of parallel spins along the z axis for  $J_x < J_z$ . Since these 2<sup>L</sup> classical ground states are related by symmetries of the H am iltonian, quantum uctuations cannot lift this degeneracy.

### III. QUANTUM COMPASSMODEL:SPIN-1/2

In this section, we turn to the spin-1/2 case for which we write the H am iltonian

where  $r_r^x$  and  $r_r^z$  are Paulim atrices acting on the spin at site r. In the following, we will use the parametrization of the exchange integrals  $J_x = J \cos and J_z = J \sin w$  ith 2  $[0; \frac{1}{2}]$ , and we will study the model on N-site square clusters of dimension L L.

Taking all sym m etries into account, exact diagonalizations could be perform ed up to L = 5. As we shall see, this is not su cient to draw conclusions regarding the degeneracy of the ground state in the therm odynam ic lim it close to  $J_x = J_z$ . How ever, this model has the very interesting property that all non-diagonal matrix elements are negative. This has allowed us to im plement the G reen's function M onte C arlo algorithm [12], which gives access to the ground-state energy in a given symmetry sector, and to reach clusters up to L = 17. Besides, one can choose quantum numbers so that all relevant low energy states are ground states of a given symmetry sector. To see how this works, let us look more closely at the sym – m etries of the model.

In addition to the lattice translation symmetries, the Ham iltonian (4) has another type of discrete symmetries. The rst one corresponds to the operators  $Q_i = \int_{j}^{x} \frac{i_{jj}}{i_{jj}}$ , which are the products of the r on one column ( $r_x = i$ ). These operations correspond to a rotation by an angle about the  $e_x$  axis of all the spins of a given column:  $Q_i \int_{ijj}^{y_{ij}} Q_i = \int_{ijj}^{y_{ij}} and Q_i \int_{ijj}^{z} Q_i = \int_{ijj}^{z} which are the products of the operators <math>P_j = \int_{ijj}^{z} which are the products of the operators <math>P_j = \int_{ijj}^{z} which are the products of the operators <math>P_j = \int_{ijj}^{z} which are the products of the <math>r_r$  on one line ( $r_z = j$ ), and which correspond to a rotation by an angle about the  $e_z$  axis of all the spins of a given line:  $P_j \int_{ijj}^{z} P_j = \int_{ijj}^{z} which are the products of the isotropic lim if <math>J_x = J_z$ , there is one more discrete symmetry: the global rotation  $R_y(\frac{1}{2})$  of all spins and lattice about the  $e_y$  axis by an angle  $\frac{1}{2}$ .

As emphasized by Doucot et al, the Pi's commute with each other, as well as the  $Q_i$ 's, but  $[Q_i; P_j] \in 0$ 8 i; j. Thishastworm arkable consequences: First of all, all eigenstates must be two-fold degenerate. Besides, we can choose either the P<sub>i</sub>'s or the Q<sub>i</sub>'s to de ne sym m etry sectors in which the Ham iltonian can be independently diagonalized. Since  $P_{j}^{2} = 1$  and  $P_{j}^{Y} = P_{j}$ , the eigenvalues of  $P_i$  are  $p_i =$ 1, the sam e being true for the Qi's. Thus the Hamiltonian can be diagonalized in the symmetry sectors characterized by the set  $(p_1;$ \_\_)**,;p**i= 1, or alternatively in the sectors de ned by the eigenvalues of  $Q_i$  and characterized by the set  $(q_i;$ \_\_)**,;q\_\_** = 1. To see how this works, let us start from the trivial case  $J_x = 0$ . The model then consists of a set of decoupled Ising columns with eigenstates  $jn i = jn_{1,1}i$ jm1;2i

The classi cation according to the Q<sub>i</sub>'s is quite di erent. First, note that the states fjm ig are not eigenstates of Q<sub>i</sub>. However, if we denote by j "i<sub>i</sub> (resp. j #i<sub>i</sub>) the ground state of column i with all the spins up (resp. down), then one can de ne two new ground states by  $j + i_i = \frac{1}{p-2} (j - i_i + j + i_i)$  and  $j + \frac{1}{2} = \frac{1}{p-2} (j - i_i - j + i_i)$ .

These new states are eignestates of Q  $_{\rm i}$  with eigenvalues

1 respectively. So q can be either 1 or +1 for each column independently, and the ground state manifold has one member in each of the  $2^{L}$  sectors  $(q_1; L),;q_1 = 1$ .

The case  $J_z$  = 0 is connected to the case  $J_x$  = 0 by the rotation sym metry  $R_y\left(\frac{1}{2}\right)$ . Since  $R_y\left(\frac{1}{2}\right) \ ^1P_jR_y\left(\frac{1}{2}\right) =$  (  $1^{j_L}Q_L$   $_j$  and  $R_y\left(\frac{1}{2}\right) \ ^1Q_iR_y\left(\frac{1}{2}\right) = P_i$ , the sym metry sectors are interchanged. So the ground state is made up of  $2^L$  states in each  $2^L$  sectors (p\_1; \_\_\_\_) p ( 1; ; 1).

So, as announced earlier, to determ ine the structure of the low-energy spectrum when going away from  $J_x = 0$  or  $J_z = 0$ , it is always possible to choose the quantum num bers so that each state is the ground state of a given sym m etry sector.

## A. Exact diagonalization




FIG.2: Energy of the low-lying states versus anisotropy parameter for 4 4 and 5 5 lattices obtained by exact diagonalization ( $J_x = J \cos 3J_z = J \sin 3$ ).

The spectrum of the Ham iltonian (4) versus the asym metry parameter has been determined for L = 2;3;4and 5 using exact diagonalization. Fig. 2 presents the low energy levels for L = 4 and L = 5. As expected, when  $J_x; J_z \in 0$ , the ground state is two-fold degenerate  $_{\rm L} = p + 1$  and the with one state in the sector  $p_1 =$ other in the sector  $p_1 =$  $_{L} = p 1. For 0 < J_{z} < J_{x}$ , the  $2^{L}$  -fold degeneracy of the ground state at = 0 (i.e.,  $J_z = 0$ ) is lifted by the  $J_z$  term of the H am iltonian. The low est of these states is in the sector  $p_1 =$  $_{\rm L} = p \ 1$ and the highest in the sector  $p_i =$ (1). The gap between these two states is denoted by (). As we will see in the following, () goes to zero for all in the therm odynam ic lim it.




FIG.3:G ap  $_{\rm 2}$  (see text) as a function of the num ber of sites N .

In the symmetric case ( =  $\frac{1}{4}$ , i.e.,  $J_x = J_z$ ), the adiabatic continuation of the degenerate ground states of the  $J_x = 0$  and  $J_z = 0$  cases generates only 2 Ź 2 states, and not 2  $2^{-}$  as one m ight naively expect from the sem i-classical case. The reason is that the low est pair of state is common to the two fam ilies of states coming from  $J_x = 0$  and  $J_z = 0$ , while all other states cross at  $J_x = J_z$  (see Fig. 2). This does not mean how ever that the low energy sector has only 2  $2^{-2}$ 2 states for very large system s. In fact, another pair of states is decreasing quite fast toward the ground state as a function of the size. Since these states correspond to the st two-fold degenerate excited state of the sectors  $p_1 =$ L = pl $_{L}=p$  1, one can keep track of their and  $p_1 =$ energy for all sizes. The gap between the ground state and these states, denoted by  $_2$ , is plotted in Fig. 3 as a function of 1=N. These results are indeed consistent with a vanishing of this gap in the therm odynam ic lim it [13].

### B. Perturbation theory

B efore discussing the results obtained for large clusters with G reen's function quantum M onte Carlo, let us see

what perturbation theory predicts regarding the scaling of the gap in the lim it J  $_z$  J $_x$ . To this purpose, the H am iltonian is written as

where  $H_0 = \int_x^P \int_x^x \int_x^x e_x$  and  $V = \int_z^P \int_x^z \int_x^z e_x$ . Since each term of V ips a pair of spins on neighboring chains, it is necessary to apply the perturbation at least L times on an L L lattice to ip all spins of a pair of neighboring chains and reach another ground state. So the gap is expected to scale as  $=J_x = a (bJ_z = J_x)^L$ . One can be more precise though and determ ine the constants a and b from high order perturbation theory. To rst signi cant order in  $J_z = J_x$ , the gap is given by the gap between lower and higher eigenvalues of the elective H am iltonian

Next, we note that, in terms of the pseudo-spin  $_{j}^{z} = _{1;j}^{z} _{L;j}^{z}$ , the operator  $_{j}^{z} _{1;j}^{z} _{1;j+1}^{z} _{L;j+1}^{z} _{L;j+1}^{z}$  is

nothing but the H am iltonian of the one-dimensional Ising model. So, the gap between the lowest and highest eigenvalues is  $\max_{\min} = 2L$  when L is even and  $\max_{\max} \min = 2(L - 1)$  when L is odd. Finally, if we dene P (L) by




FIG.4:  $\log$ -linear plot of LP (L) versus the linear lattice size L. The squares are the results obtained num erically, and the dotted line is an exponential t.

The dom inant behaviour of P (L) has been determ ined numerically (see Fig. 4). It turns out that LP (L) ' exp(0.754L 0.694), which leads to:

It has the correct  $(J_z=J_x)^L$  behavior which corresponds to the exact result for the two-line system [7]. So, when  $(J_z=J_x)$  1, this approximation predicts ! 0 in the therm odynamic limit. Moreover, since 0:531  $(J_z=J_x) < 1$ even for  $J_z=J_x = 1$ , it seems likely that this scaling will remain true up to the symmetric limit  $J_x = J_z$ . As we shall see, this is con med by the Green's function M onte C arbo results.

### C. Green's function M onte Carlo

If the Ham iltonian of a model has only non-povitive o -diagonalmatrix elements, which is the case here, the G reen's function M onte C arlo m ethod [12] allows one to calculate the ground-state energy of a given symmetry sector by using a stochastic approach. The algorithm we have used is the implementation with a xed number of w alkers described in detail by C alandra and Sorella [12], and the guiding function is given by:

where  $\mathbf{F}_x \mathbf{i}$  is the ferror agnetic state in x direction such that  ${}_r^x \mathbf{F}_x \mathbf{i} = \mathbf{F}_x \mathbf{i} \, 8r$ . The parameters  $v_{r,r^0}$  were determ ined in order to m inim ize the energy of the guiding function. The ground state energy has been determ ined in each sector ( $p_1$ ;  ${}_L$ ) peparately, which corresponds to the energy of the rst  $2^L$  states of the full H ilbert space (the states coming from the limit  $J_z = 0$  ground state in Fig.2), and gives access to the gap ().




FIG . 5: G round-state energy E  $_{\rm 0}$  versus the number of sites N for various values of the asymmetry parameter ~ .

Let us rst discuss the scaling of the energy per site as a function of the system size. As can be seen in Fig.5, the energy per site is strongly size dependent up to a certain size (8 8 for  $J_x = J_z$ ), and is very little size dependent for larger clusters. This indicates that strong nite-size e ects are to be expected, especially close to the sym – m etric point, justifying the use of quantum M onte C arbo to get inform ation on large clusters.




FIG.6: G ap versus linear lattice size L for various values of the asymmetry parameter . For L = 2;3;4;5 the results were obtained from exact diagonalization.




FIG.7: versus  $J_z\!=\!\!J_x$ , where  $\;$  is the gap scaling constant  $^L$ . The symbols are the results obtained with G reen's function M onte C arlo and the dotted line is tted to these values.

Fig. 6 shows a log-linear plot of the gap versus the linear lattice size L for various values of the asymmetry parameter . Perturbation theory predicts that the scaling of is given by a power law =J  $_x$  / <sup>L</sup>, with '  $0.531J_z=J_x$ . To check this prediction, we have tted the results of Fig. 6 with a straight line for each value of , keeping only sizes beyond which the scaling is approximately linear. The values of deduced from this t are plotted in Fig. 7 as a function of  $J_z=J_x$ . Remarkably, the relation between and  $J_z=J_x$  is quite linear up to  $J_x = J_z$ , which seems to justify the perturbation theory in this limit. Moreover, a t gives '  $0.55J_z=J_x$ ,

in good agreem ent with the perturbation theory prediction '  $0.531J_z=J_x$ . In fact, for small  $J_z=J_x$ , even the prefactor and the even-odd e ect predicted by the perturbation theory agree with the results of Fig. 6. All these results lead us to the conclusion that the gap indeed follows a power law =J<sup>L</sup>,with < 1 when J<sub>x</sub>, implying that ! 0 in the therm odynam ic  $J_z$  $\lim it$ . Thus the 2<sup>L</sup> states coming from the  $\lim it = 0$  $(J_z = 0)$  ground state collapse in the therm odynam ic  $\lim it$ , as long as  $J_z$  $J_{\!x}$  . Using the rotation symmetry  $R_y(\frac{1}{2})$ , the same result holds true for the 2<sup>L</sup> states coming from the limit =  $\frac{1}{2}$  (i.e.,  $J_x = 0$ ) ground state, as long as  $J_z$  $J_{x}$ . The conclusion is that there are  $2^{L}$ states collapsing exponentially fast onto each other when

 $J_x \in J_z$ , and at least a 2  $2^{L}$  2 when (i.e.,  $J_x = J_z$ ). As we argued above, the actual num ber is very probably actually equal to 2  $2^{L}$ , in agreem ent with the sem iclassical analysis.

# IV. GENERAL SPIN

The sym metry arguments used for spin-1/2 can be easily extended to arbitrary spins. Let us consider the system with N spins S on a L L lattice described by the com pass model H am iltonian

It is straightforward to check that the generalizations of the P  $_{\rm j}$  and Q  $_{\rm i}$  de ned by

for integer spins and by

for half-integer spins commute with the Hamiltonian. However, it is easy to check that the commutator  $[Q_{i};P_{j}]$  vanishes for integer spins, whereas it does not vanish for half-integer spins (fQ\_{i};P\_{j}g = 0). Indeed, the only terms in the product which do not trivialy commute are those on the site (i; j). So we just have to show that  $[e^{i S_{i,j}^{x}}; e^{i S_{i,j}^{z}}] = 0$  for integer spins and fe<sup> $i S_{i,j}^{x}$ </sup>;  $e^{i S_{i,j}^{z}} = 0$  for half-integer spins. The operatore  $i S_{i,j}^{z} = R_{z}$  () corresponds to the spin rotation by an angle about the z axis acting at site (i; j). Applying this rotation to  $e^{i S_{i,j}^{x}}$  gives

But for integer spins,  $e^{i S_{i,j}^z} = e^{i S_{i,j}^z}$ , while for halfinteger spins,  $e^{i S_{i,j}^z} = e^{i S_{i,j}^z}$ , which term inates the proof. This has two important consequences. First of all, in D oucot et al.'s argum ent, the fact that  $[D_i; P_j] \in 0$  was crucial to show that each state was two-fold degenerate. We thus expect that for all integer spins, the eigenstates are generically non-degenerate. B esides, for integer spins, since all  $Q_i$ 's com m ute with all  $P_j$ 's, one can use all these sym m etries sim ultaneously, leading to  $2^{\rm 2L}\,$  di erent sym – m etry sectors.




FIG.8: Spectrum versus asymmetry parameter for linear lattice sizes L = 2 and L = 3 obtained by exact diagonalization.  $J_x = J \cos and J_z = J \sin a$ .

W e have checked these predictions for S = 1 with exact diagonalizations of clusters of size L = 2 and L = 3 (see Fig. 8). Indeed, the ground state is non-degenerate

for all  $J_x; J_z \in 0$ , and it is in the only symmetry sector  $p_1 =$  $_{L} = = p q_{1} =$  $_{\rm L} = = q (1)^{\prime}$  connecting the ground states in the lim its  $J_x = 0$  and  $J_z = 0$ . The  $J_z = 0$  (resp.  $J_x = 0$ ) ground state  $2^{L}$  -fold degeneracy is partially lifted by the  $J_z$  (resp.  $J_x$ ) term of the Ham iltonian, creating a gap As in the spin-1/2 m odel, thegap between the ground state and the st excited state which has the sam e degeneracy and is in the sam e sym metry sector as the ground state is denoted by 2. The gaps and  $_2$  are sm aller for L = 3 than for L = 2, and one can conjecture that these gaps go to zero in the thermodynamic limit. In this case, the ground state would have the same degeneracy as for spin-1/2. A de nite conclusion would clearly require to study larger clusters though.

## V. CONCLUSION

Using a variety of approaches, we have obtained a coherent picture of the zero-tem perature properties of the quantum compass model. On a nite cluster, we have con med that all eigenstates of the spin-1/2 model are at least two-fold degenerate, a result that we have extended to arbitrary half-integer spins, while they are not necessarily degenerate for integer spins. However, the degeneracy that remains when therm alor sem i-classical quantum uctuations are introduced, namely the possibility to ip the spins along lines or columns, is still present as a manifold of states which collapse exponentially fast onto the ground state upon increasing the size of the lattice. This was already known to be the case for the asymmetric case not too close to  $J_x = J_z$ . Thanks to extensive quantum M onte Carlo simulations, we have shown that this remains true up to the symmetric case  $J_x = J_z$ , and that the the number of these states (2<sup>L</sup>) when  $J_x \in J_z$ , 2  $2^{L}$  when  $J_x = J_z$ ) agrees with the degeneracy predicted by the sem i-classical analysis.

Physically, this has two consequences. Regarding orbital uctuations in M ott insulators, in which case the symmetric version of the model seems more appropriate, the present results con rm the absence of true orbital long-range order for quantum spins in the therm odynamic limit even at zero temperature. Nevertheless,

as in the case of therm al uctuations for classical spins, the possibility to choose between the x and z directions should still lead to a nite-tem perature Ising transition.

Regarding Josephson junction arrays, one of the inportant issues is to ensure that the two-fold degenerate ground state is well protected by a gap to all excited states. As noticed by Doucot et al., this requires to work with not too large systems if a family of states collapse onto the ground state in the therm odynamic lim it, as they already showed to be the case for  $J_x = J_z$ . Their results suggested however that there might be a quantum phase transition to a gapped phase around  $J_x = J_z$  in which the gap to all excited states would remain nite even in the therm odynamic lim it. This possibility is clearly ruled out by the present results.
