Can Frustration Preserve a Quasi-Two-D im ensional Spin Fluid?

Abstract

U sing spin-wave theory, we show that geom etric frustration fails to preserve a two-dimensional spin uid. Even though frustration can remove the interlayer coupling in the ground-state of a classical antiferrom agnet, spin layers innevitably develop a quantum -m echanical coupling via the m echanism of \order from disorder". We show how the order from disorder coupling m echanism can be viewed as a result of m agnon pair tunneling, a process closely analogous to pair tunneling in the Josephson e ect. In the spin system, the Josephson coupling m anifests itself as a biquadratic spin coupling between layers, and for quantum spins, these coupling terms are as large as the in-plane coupling. An alternative m echanism for decoupling spin layers occurs in classical XY m odels in which decoupled "sliding phases" of spin uid can form in certain nely tuned conditions. Unfortunately, these nely tuned situations appear equally susceptible to the strong-coupling e ects of quantum tunneling, forcing us to conclude that in general, geom etric frustration cannot preserve a two-dim ensional spin uid.

I. IN TRODUCTION

This study is motivated by recent theories of heavy electron systems tuned to an antiferrom agnetic quantum critical point^{1,2} which propose that the formation of magnetically decoupled layers of spins plays a central role in the departure from Fermi liquid behavior. A wide variety of heavy electron materials develop logarithmically divergent speci c heat coe cients and quasi-linear resistivities in the vicinity of quantum critical points^{1,2,4,8,16,17,18,19,20,21,22,23,24,25,26,27}. Several theories explaining these unusual properties have been proposed^{1,2,4,5,6,7,8,18,20,26}. The standard model for these quantum phase transitions, proposed by Hertz and Moriya, involves a soft, antiferrom agnetic mode coupled to a Fermi surface. Hertz-Moriya SDW theory can account for the logarithmically divergent speci c heat coe cients and quasi-linear resistivities^{1,3}, but only if the spin uctuations are quasi-two-dimensional. An alternative local quantum critical description, based on the extended dynamical mean eld theory, also requires a quasi-two-dimensional spin ufil. E ach of these theories can only account for the anom alies of quantum critical heavy electron materials if the spin uctuations of these systems are quasi-two-dimensional^{1,4,5,6,7,8}.




FIG.1: Lattice Structure.

The hypothesis that heavy electrons involve decoupled layers of spins motivates a search for a mechanism that might preserve quasi-two-dimensionality in a diverse set of heavy ferm ion materials. One such frequently cited mechanism is geometric frustration^{1,4}. Here, the idea is that frustration, naturally induced by the structure of the crystal, decouples layers of spins within the material^{1,4} (see Fig. 1). In this paper, using the Heisenberg antiferrom agnet as a simple example to explore this line of reasoning, we show with the help of spin-wave theory that in general, zero-point uctuations of the spin overcom e the frustration and generate a strong interlayer coupling via the mechanism of \order from disorder" ^{9,10}.

To illustrate the main points of our argument, consider two separate layers of H eisenberg spins. At T = 0 each layer is antiferrom agnetically ordered, and spin waves run along the layers. Now consider the e ect of a small frustrated interlayer coupling. In a system of classical spins, the layers remain decoupled in the classical ground state, and their spins may be rotated independently. The long-wavelength spin waves continue to run along the layers, and the spin uid is quasi-two-dimensional at long wavelengths.

In the quantum -m echanical picture, even a sm all interlayer coupling enables m agnons




FIG. 2: Contrasting (a) Josephson tunneling between paired superconductors and (b) m agnon tunneling between antiferrom agnets, viewed within a resonating valence bond (RVB) picture.

to virtually tunnel between layers. An antiferrom agnet can be regarded as a long-range RVB state¹¹, so individual magnon transfer is energetically unfavorable, and the transfer of magnons between the layers tends to occur in pairs, as in Josephson tunneling (see Fig. 2). Interlayer magnon pair tunneling is ubiquitous in three-dimensional spin systems, frustrated and unfrustrated alike. So unless the interlayer coupling constant is set exactly to zero, magnons travel between the layers, producing a coupling closely analogous to Josephson coupling of superconducting layers. Such a coupling is an alternative way of viewing the phenom enon of \order from disorder^{19,10}, whereby the free energy of zero-point or therm al

uctuations depends on the relative orientation of the classical magnetization.

If we use the analogy between superconductors and antiferrom agnets, then spin rotations of an antiferrom agnet m ap onto gauge transform ations of the electron phase in a superconductor. In a superconducting tunnel junction, the Josephson energy is determined by the product of the order parameters in the two layers, i.e.

where t_2 is the tunneling matrix element, the superconducting gap energy and $_1$ (1= 1;2) represents an electron eld in lead one and two. By analogy, in a corresponding \spin

junction", the coupling energy is determined by the product of the spin-pair amplitudes. Suppose for simplicity that the system is an easy-plane XY magnet, then

where S_{li} represents the spin raising, or low ering operator at site i in plane l, parallel to the local magnetization. The factor 2 arises because the spin-pair carries a phase which is twice the angular displacement of the magnetization (S_{+} S_{x} + iS_{y} Se^{i}). In other words,

so the interlayer coupling induced by spin tunneling is expected to be biquadratic in the relative angle between the spins. Clearly, this is a much oversimpli ed argument. We need to take account of the O (3), rather than the U (1) symmetry of a Heisenberg system. Nevertheless, this simple argument captures the spirit of the coupling between spin layers, as we shall now see in a more detailed calculation.

II. SPIN-WAVE SPECTRUM FOR DECOUPLED LAYERS

Consider a Heisenberg model with nearest-neighbor antiferrom agnetic interaction in its ground state de ned on the body-centered tetragonal lattice. This choice of model is motivated by the structure of $C eP d_2 S i_2$, one of the compounds for which the idea of quasi-twodimensionality was originally proposed⁴. In this lattice structure (Fig. 1), square lattices stack with a shift of $(\frac{a}{2}, \frac{a}{2})$ between adjacent layers (a is the lattice constant within the layer). For simplicity, the distance between the layers is also a. The spins of the nearest neighbors in each layer are anti-parallel. In the classical ground state the spins in di erent layers are decoupled and may assume any relative alignment.

For simplicity, let us consider just two adjacent layers, the argument being easily generalized to an in nite number of layers. The Hamiltonian is then

where H $^{(T)}$ and H $^{(B)}$ are the H am iltonians for the top and bottom layers, and V is the interlayer coupling.

Here $S_i^{(B)}$ ($S_i^{(T)}$) is the spin variable de ned at the site i in the bottom (top) layer. The vector denotes a displacement to the nearest neighbor sites within the plane, = (a;0) or (0;a). = (a=2;a=2) de nes a shift between layers. Since the coupling between layers is small (J^2 J^k), we may treat this model using perturbation theory where the ratio of coupling constants $J^2 = J^k$ is taken as a small parameter.

For our purposes, it is su cient to consider a simple case with the spins lying in the

planes of the 2-dimensional lattice. At sites i = (la; m a) and $i + = (la + \frac{1}{2}a; m a + \frac{1}{2}a)$ the spins are

where X and Y are mutually perpendicular directions in the plane, l and m are integers.

Following a standard procedure 12,13 , we use the Holstein-Primako approximation for the spin operators to determ ine the spin-wave spectrum. The single-layer Ham iltonian H $^{()}$ becomes

III. MAGNON PAIR TUNNELING BETW EEN THE LAYERS

Now we express the perturbation V in (4) in terms of a_q^{+} , $a_q^{()}$ as

where $_{q} = (A_{q}^{?} \sinh 2u_{q} + B_{q}^{?} \cosh 2u_{q})$ describes the amplitude form agnon pair tunneling, and $V_{ph} = S_{q}^{P} (A_{q}^{?} \cosh 2u_{q} + B_{q}^{?} \sinh 2u_{q}) (b_{q}^{+(T)} b_{q}^{(B)} + b_{q}^{+(B)} b_{q}^{(T)})$ describes single m agnon tunneling between layers.

It is straightforward to see that the particle-hole terms do not a left the ground-state energy, for V_{ph} if $S \ge 0$, where if $S \ge$ denotes the ground state wave-function of the system. The second order correction to the ground state energy E_0 is then

To understand the nature of coupling between the layers (dipolar or quadrupolar), let us retrive the dependence of $~E_0^{~(2)}$ on the angle ~ .

The interlayer coupling is indeed quadrupolar in nature, as foreseen earlier. Moreover, there is no small parameter, and for small S, when $J^2 = J^k$, this coupling is not weak.

IV. DISCUSSION

In the above calculation, we considered an ordered Heisenberg antiferrom agnet at zero tem perature. In practice, provided the spin-spin correlation length is large com pared with the lattice constant a, a, a biquadratic interlayer coupling will still develop. Moreover, at nite tem peratures, therm all uctuations will produce further interlayer coupling. Both therm all and quantum interlayer coupling processes are manifestations of \order from disorder". The main di erence between the therm all and quantum coupling processes lies in the replacement of the magnon occupation numbers with a Bose-Einstein distribution function, and in general both the sign and the angular dependences of the two couplings are expected to be the sam e⁹. In general, geom etrical frustration is an extrem ely fragile mechanism for decoupling spin layers and will always be overcom e by quantum and therm all

uctuations. Our work was motivated by heavy electron systems. These are much more complex systems than insulating antiferrom agnets, but if our mechanism for the formation of two-dimensional spin uid is to be frustration, it is dicult to see how similar interlayer coupling e ects might be avoided. We are led to conclude that for the hypothesis of the reduced dimensionality of the spin uid in heavy fermion materials to hold, a completely di erent decoupling mechanism must be at work.

In the special case of XY m agnetism there is, in fact, one such alternative m echanism, related to "sliding phases". Some heavy ferm ion systems, such as Y bR h_2 S i_2 , are XY-like, m ost others, such as C eC u_6 , are Ising-like. It is, therefore, instructive to consider whether the sliding phase m echanism m ight be generalized to H eisenberg or Ising spin systems to provide an escape from the uctuation coupling that we have discussed.

The existence of a "sliding phase" in weakly coupled stacks of two-dimensional (2D) XY models was predicted by O'Hem, Lubensky and Toner¹⁴. In addition to Josephson interlayer couplings, these authors included higher-order gradient couplings between the layers. In the absence of Josephson couplings, these gradient couplings preserve the decoupled nature of the spin layers, only modifying the power-law exponents of the 2D correlation functions, $hS_iS_ji = r$. As the tem perature is raised, Josephson interlayer couplings become irrelevant above a particular "decoupling tem perature" T_d . O ne can always select interlayer gradient couplings to satisfy $T_d < T_{KT}$ and produce a stable sliding phase in the tem perature window $T_d < T < T_{KT}$.

To see this in a little more detail, consider the continuous version of the H am iltonian of two layers of X Y models, $H = H_0 + V$, where H_0 is a sum of independent layer H am iltonians and V is the usual Josephson-type interlayer coupling

At low tem perature, when the interlayer coupling J^2 is zero, the average of the intralayer spin-spin correlation function with respect to H₀ is

where $= T=2 J^k$, L is the sample width and b is a short-distance cuto in the XY plane. The average of Josephson interlayer coupling V scales as hV $i_0 L^2$, so Josephson couplings become irrelevant at $T_d = 4 J^k$. At temperatures above the K osterlitz-T houless transition temperature $T_{KT} = J^k=2$, therm ally excited vortices destroy the quasi-long-range order and drive the system to disorder. In this simple example, it happens that $T_d > T_{KT}$, which does not permit a sliding phase. However, higher-order gradient interlayer couplings between the layers, when added to this model, suppress T_d below T_{KT} , producing a stable sliding phase for $T_d < T < T_{KT}$. So can the sliding phase concept be generalized to H eisenberg spin systems? A sliding phase develops in the XY m odel because power-law spin correlations introduce an anom alous scaling dimension, but unfortunately, a mite temperature H eisenberg m odel has no phases with power-law correlations¹⁵. In general, biquadratic interlayer couplings will always remain relevant in H eisenberg m odels. In the quantum -m echanical picture, as soon as a frustrated interlayer coupling is introduced, the order-from -disorder phenom enon^{9,10} generates a coupling S $J^{2} = J^{k}$ between the layers:

where = $S^2 a^2 J^k$. This coupling gives us a length scale l_0 determ ined from $(l_0)^2 = \frac{p}{a} \overline{S} J^k = J^2$. Once the spin correlation length $a \exp(2 \ J^k S^2 = T)$ within a layer grows to become larger than l_0 , i.e. $l_0 < a \exp(2 \ J^k S^2 = T)$, a 3D-ordering phase transition occurs. An estimate of the 3D-ordering transition temperature is then T_c 2 $J^k S^2 = \ln \left(\begin{array}{c} S J^k = J^2 \end{array} \right)$. The answer is essentially identical in the classical picture, for here, therm all uctuations generate an entropic interlayer coupling $\max(S J^2 = J^k; TS^2)$, so at high enough temperatures, for large S, $T J^2 = J^{k2}$, l_0 $S a J^k = J^2$. A classical estimate of the 3D-ordering temperature is $T_c = 2 \ J^k S^2 = \ln(J^k = J^2)$.

A nother interesting question is whether XY models perm it sliding phases at T = 0. The decoupling tem perature, as found by 0 'H em, Lubensky and Toner¹⁴, is

O ne sees no obvious mechanism of suppressing T_d to zero. A 2D sliding phase is equivalent to a 3D nite temperature sliding phase, so the existence of a sliding phase in the XY model at zero temperature would mean a power-law phase in 3D XY model. Since no power-law phase exists in 3D XY-like systems, sliding phases at T = 0 are extremely unlikely. In conclusion, the sliding phase scenario also fails to provide a valid general mechanism for decoupling layers in Ising-like and Heisenberg-like systems.

Let us return m om entarily to consider the implications of these conclusions for the m ore complex case of heavy electron m aterials. It is clear from our discussion that simple m odels of frustration do not provide a viable m echanism for decoupling spin layers. One of the obvious distinctions between an insulating and a m etallic antiferrom agnet is the presence of dissipation which acts on the spin uctuations. The interlayer coupling we considered here relies on short-wavelength spin uctuations, and these are the ones that are most heavily damped in a metal. Our exclusion of such e ects does hold open a small possibility that order-from -disorder e ects might be substantially weaker in a metallic antiferrom agnet. However, if we are to take this route, then we can certainly no longer appeal to the analogy of the insulating antiferrom agnet while discussing a possible mechanism for decoupling spin layers.
