E ect of Long-R ange Interaction on the Critical Behavior of Three-D im ensional D isordered Systems

A eld-theoretical description of the behavior of a disordered Ising system with long-range interaction is presented. The description is performed in the two-loop approximation in three dimensions using the Pade-Borel resummation technique. The renormalization group equations are analyzed, and the xed points determining the critical behavior of the system are found. It is shown that the e ect of frozen structural defects on a system with long-range interaction may cause a change in its critical behavior or smearing of the phase transition.

The e ect of long-range interaction, which at long distances is described by the power law r^D , was studied analytically in terms of the expansion [13] and numerically by the M onte Carlo method [46] for two-and one-dimensional systems. It was found that the e ect of long-range interaction on the critical behavior of Ising systems is considerable for < 2. The study [7] carried out for a three-dimensional space in the two-loop approximation conmed the prediction of the "expansion for a homogeneous system with long-range interaction.

A coording to the results of [8, 9], the introduction of frozen in purities into a system leads to a change in its critical behavior. In this connection, it is of interest to determ ine the e ect of frozen structural defects on the critical behavior of a system with long-range interaction.

This paper describes the critical behavior of a three-dimensional disordered system a long-range interaction for dierent values of the parameter .

The Hamiltonian of a system with long-range interaction has the form

where S_q denotes the uctuations of the order parameter, D is the space dimension, $_0$ $^{\dagger}\! T$ $T_c \, ^{\dagger}\! J$ T_c is the critical temperature, u_0 is a positive constant, and $_q$ is the random eld of impurities of the random temperature type.

The critical behavior strongly depends on the parameter , which determ ines the rate of interaction decrease with distance. A coording to [1], the elect of long-range interaction on the system behavior is considerable for 0 < 2, while, for 2, the critical behavior is equivalent to that of a system with short-range interaction. Therefore, only the case of 0 < 2 is considered below .

For a low impurity concentration, the distribution of the random $\;$ eld $\;$ $_{\rm q}$ can be considered as G aussian and described by the function

where A is the normalization factor and $_{0}$ is a positive constant proportional to the concentration of frozen structural defects.

Applying the replica procedure for averaging over random elds caused by the frozen structural defects, we obtain the elective Hamiltonian of the system

The properties of the initial system can be obtained in the lim it of the number of replicas (transforms) m! 0.

Applying the standard renormalization group procedure based on the Feynman diagram technique [10] with the propagator $G(K) = 1 = (+ \frac{1}{2}Kf)$, we arrive at the expressions for the functions u, , and t, which de-

As a result, we obtain the following expressions for the functions , , and t:

Such a redeterm ination makes sense for D = 2. In this case, J_0 , J_1 and G are divergent functions. Introducing the cuto parameter and considering the ratios $J=J_0^2$ and $G = J_0^2$ we obtain nite expressions in the lim it

The values of the integrals were determ ined num erically. For the case a D=2, a sequence of the values of $J_1=J_0^2$ and $G=J_0^2$ was constructed for dierent approximated to in nity.

The critical behavior is completely determined by the stable xed points of the renormalization group transform ation. These points can be found by equating the -functions to zero:

The critical exponent characterizing the growth of the correlation radius in the vicinity of the critical point $(R_c \ T_c j)$ is obtained from the relation

The Fisher exponent describing the behavior of the correlation function in the vicinity of the critical point in the wave-vector space ((G $\,$ $\,$ $k^{2^{+}}\,$)) is determined from the scaling function \cdot : = 2 + \cdot (v_1 ; v_2). The values of other critical exponents can be determined from the scaling relations.

It is well known that the perturbation series expansions are asymptotic, and the interaction vertices of the order parameter uctuations in the uctuation region are su ciently large, so that Eqs. (7) applies. Therefore, to extract the desired physical inform ation from the expressions derived above, the PadBorelm ethod generalized to the many-parameter case was used. The corresponding direct and inverse Borel transform ations have the form

For the analytic continuation of the Borel transform of a function, a series expansion in powers of the auxiliary variable is introduced:

and the [L/M] Pade approximation is applied to this series at the point = 1. This approach was proposed and tested in [11] for describing the critical behavior of systems characterized by several interaction vertices of the order parameter uctuations. The property (revealed in

[11-14]) that the system retains its symmetry when using the Pade approximants in the variable is essential in the description of multivertex models.

The table shows the stable xed points of the renormalization group transform ation and the eigenvalues of the stability matrix at a xed point for the parameter values 1.5 < 1.90 ne can see that stable xed points exist in the physical region $(v_1; v_2 > 0)$ only when the long-range interaction parameter is a 1.8. The cal-

culations showed that, for any < 1.3, the stable points of a three-dim ensional impurity system are characterized by a negative value of the vertex.

The calculation of the critical exponents provided the following values:

Thus, for a three-dimensional Ising system with long-range interaction, the introduction of frozen structural defects leads to a change in its critical behavior if the long-range interaction parameter is 1.8 and to smearing the phase transition if the parameter is < 1.8.
