The arboreal gas and the supersphere sigm a model

A bstract

We discuss the relationship between the phase diagram of the Q = 0 state Potts model, the arboreal gas model, and the supersphere sigm a model $S^{0;2} = O SP (1=2)=O SP (0=2)$. We identify the Potts antiferrom agnetic critical point with the critical point of the arboreal gas (at negative tree fugacity), and with a critical point of the sigm a model. We show that the corresponding conform altheory on the square lattice has a non-linearly realized O SP (2=2) = SL (1=2) sym m etry, and involves non-com pact degrees of freedom, with a continuous spectrum of critical exponents. The role of global topological properties in the sigm a model transition is discussed in term s of a generalized arboreal gas model.

1 Introduction

The question of possible xed points and RG ows in 1 + 1 theories with supergroup symmetries plays a major role in the supersymmetric approach to phase transitions in non-interacting disordered systems (such as the transition between plateaux in the integer Quantum Hall or spin Quantum Hall e ects). A lthough some similarity with what happens in systems with ordinary group symmetries is expected, it has also become clear over the last few years that more com plicated scenarios are at work. Am ong the features that play a key role in these scenarios are the facts that supergroup symmetries are not protected by the Merm in-W agner theorem and can be spontaneously broken in two dimensions; that the lack of unitarity allows non Kac-Moody

(logarithm ic) conform al eld theories with supergroup symmetry; etc. Recent references in this area are [1, 2, 3, 4, 5].

A system atic program to investigate these questions would be to tackle the continuum limit of spin chains with supergroup symmetries, either with compact or non-compact representations, with or without integrability. This turns out to be quite hard (for some recent work in this direction, see Refs. [6, 5]), as profoundly new features appear, on top of, and maybe related to, technical di culties, already in the rst steps of this program.

We discuss in this paper one of the simplest possible examples of a supergroup theory one may imagine, the supersphere sigm a modelOSP (1=2)=OSP (0=2). This model is deeply related to the arboreal gas model (see Fig. 1), and the Q ! 0 limit of the Potts model on the square lattice, and through these relations, can be studied in considerable detail. In particular, the relation with the Potts model provides a phase diagram for the sigm a model, a con mation that the perturbative results are identical with those of the O (n); n = 1 sigm a model, and the identication of a' critical point of the sigm a model with the antiferrom agnetic transition in the Potts model, as well as the transition in the arboreal gas model. Surprisingly, the associated critical theory turns out to be of a type seldom if ever encountered before in lattice models: with c = 1, it involves a non-compact boson as well as a symplectic ferm ion, and is related to a theory with a larger, OSP (2=2), symmetry.

The paper is organized as follows. In section 2, we review the relationship between the Q = 0 Potts model, the arboreal gas model, and the sigm a model. A short version of the results presented there has appeared in Ref. [7]. Related results have also appeared in Ref. [8]. Sections 3 and 4 discuss the continuum limit of the model at the antiferrom agnetic critical point using Bethe ansatz equations as well as techniques from conformal eld theory. In section 5 we prove the remarkable identity between the Bethe equations for the Q = 0 antiferro Potts model and the integrable osp(2=2) spin chain in the fundam ental representation. U sing general results about the phase diagram s of orthosym plectic chains provides independent con mation of our continuum limit identi cation. Some conclusions are gathered in section 6 while the appendix discusses a few technical aspects of Bethe ansatz for the sl(2=1) = osp(2=2) algebra.

This paper is not only a step up the program of understanding statistical mechanics models with supergroup symmetries: rst, the results will prove extremely useful in the analysis of the antiferrom agnetic Potts model for Q generic, which we will discuss elsewhere [9]; second, the

arboreal gas is a model of great interest from the point of view of transitions in gases of hard' objects at negative fugacity; nally, the relationship between the arboreal gas and the sigm a model provides a way to investigate fundam ental questions like the role of global topological properties in sigm a models in their broken symmetry phase in a particularly simple context.

2 The Q = 0 Potts model and the sigm a model

The Potts model at Q = 0 can only be well de ned through the cluster expansion and a proper limiting procedure [10]. This requires generally to approach coupling K = 0 along lines e^{K} $1 = \frac{Q}{a}$, in which case the partition function as Q ! 0 can be rewritten as the partition function of an arboreal gas [7, 8]

where N (F_p) is the number of ways of covering the lattice with p non-overlapping trees (a forest), such that each site belong to one and only one tree.

The proof of this statem ent is straightforward. W rite the partition function as

where G are subgraphs of the lattice m ade of B bonds and Clclusters (connected components), S is the total number of sites, Cy the number of cycles on the clusters. We have used Euler's relation (valid in the plane or on an annulus, a geometry we will consider below), S = B + Cl Cy. In the last equation Q 0, e^{K} 1 $\frac{Q}{a}$. As Q ! 0, only graphs without cycles survive, giving the result (1) after a renorm alization of Z. This is true irrespective of the lattice.

On the square lattice, the usual critical Potts model corresponds to approaching Q = 0 along the selfdual curve e^{K} $1 = \frac{p}{Q}$ [11], i.e., by taking a ! 0, in which case one keeps a single spanning tree. The geometrical properties are then described in terms of a symplectic ferm ion theory [12, 13, 14].

Similarly, on the triangular lattice the selfdual curve reads $(e^{K} 1)^{3} + 3(e^{K} 1)^{2} = Q$ [15], which, for Q ! 0 and K > 0, becomes $e^{K} 1^{P} Q = 3$, whence a ! 0 and the equivalence with a spanning tree follows once again. These two lattices thus strongly suggest that the usual critical behaviour is universal, and governed by sym plectic ferm ions.

The case a > 0 corresponds to a massive region in the Potts model phase diagram, and therefore the arboreal gas is massive. The case a < 0 negative is more interesting. While the model is still massive for jajbig enough, on the square lattice and for a < a = 0, the model is massless, and ow s to the sym plectic ferm ion theory again. The special value a = 4 is critical, and corresponds to the limit Q = 0 of the critical antiferrom agnetic Potts model on the square lattice [17, 10].

On the triangular lattice there is strong num erical evidence for a massless regime when a < a = 0, again characterized by a low to the symplectic ferm ion theory [8]. However, since a = 5:705 = 0:006 is only known num erically, it appears to be discult to detect whether there

is distinct critical behaviour exactly at a , and what is the exact nature of the transition to the massive regime a < a [8].

It turns out that, on any planar graph, the arboreal gas can be expressed in terms of an interacting symplectic ferm ion theory [7]. This comes from the remarkable identity

Here, each lattice site i carries a pair of ferm ions $_1$ (i) and $_2$ (i), d $_1$ d $_2$ is shorthand for the m easure of integration over every site, and M is the discrete Laplacian with m atrix elements m $_{ij}$. Thus, for if j, m $_{ij}$ equals m inus the number of edges connecting i and j, and m $_{ii}$ equals the number of neighbours of site i (excluding i itself, if the graph contains a loop). We have introduced the two objects

where we recall S is the total number of sites on the lattice, and the sum in Q_2 is taken over pairs of neighbouring sites. This ferm ionic reform ulation is interesting for several reasons, in particular because it allows one to derive quick conclusions on the phase diagram of the arboreal gas. One observes rst that the action in Eq. (3) exhibits a non-linearly realized OSP (1=2) symmetry. Indeed, let us introduce on each vertex an auxiliary eld (i) subject to the constraint that 2 (i) + 2a ${}_1$ (i) ${}_2$ (i) = 1. Solving for gives two solutions, of which we chose = 1 a ${}_1$ ${}_2$, that is the body' (part m ade of c-numbers) of positive (which we denote by b() > 0). Using the basic rule that $({}^2 + 2a {}_1 {}_2 {}_1) = \frac{1}{2}$ (+ a ${}_1 {}_2 {}_1$), together with $\frac{1}{2} = e^{a {}_1 {}_2}$, one can entirely eliminate the aQ₁ term in the action and write the functional integral as

We now introduce the vector $u = (; _1; _2)$ with the scalar product $u(i) = u(j) = (i) (j) + a_1(i)_2(j) + a_1(j)_2(i)$. By explicitly writing down the discrete Laplacian terms and regrouping a bit, one nds that the action can be rewritten as

The additional four-ferm ions term have disappeared from the action, which exhibits global OSP(1=2) symmetry (the group of transform ations leaving the scalar product invariant). The generating function in fact looks exactly like the one of a discretized sigm a model on the target manifold OSP(1=2)=OSP(0=2) UOSP(1=2)=SU(2)!

A lthough the parameter a appears in our de nition of the scalar product, it can always be absorbed in a rescaling of the ferm ions, and thus

where $_1$; $_2$ are 'small' ferm ionic deformation parameters, and a; b; c are small bosonic parameters. In terms of the ferm ion variables, the symmetry is thus realized non-linearly:

We now take the continuum limit by introducing slowly varying fermionic elds $_1(x;y)$ and $_2(x;y)$. The euclidean action reads after some simplemanipulations (Boltzmann weight e^S)

with coupling g = 2a. Note that no lattice spacing (say, a_0) appears in this action as the a_0^2 from the expansion of the elds is compensated by the $1=a_0^2$ from the transformation of the discrete sum over lattice sites into an integral.

We now go back to the issue of the sign of the eld . There are of course two solutions to the equation $^2 + 2_{12} = 1$. While we have focused on $= 1_{12}$, the other choice $= 1 + _{12}$ is also possible. It is therefore more correct to say we have mapped the Q ! 0 Potts model or the arboreal gas model onto a hem i-supersphere sign a model: the correspondence with the sign a model holds exactly at the perturbative level, but breaks non-perturbatively. This is not expected to a ect the physics in the broken symmetry phase where the eld is slow ly varying, and does not jump between the two solutions. The physics in this phase follows from the RG equation at one loop:




Figure 2: Phase diagram of the supersphere sign a model from the Q state Potts model on the square lattice.

with n = 1 = 1 2 for OSP (1=2) and g positive (i.e., a negative). We see that g ows to 0 in the IR for small enough initial values, the theory remains massless, and the symmetry is spontaneously broken.¹ This is in complete agreement with the phase diagram of the Pottsmodel in the limit Q $0, e^{K}$ 1 $\frac{Q}{a}$ (see Fig. 2). For the sigma model, the ow pattern holds until g hits a critical value, beyond which the model is massive in the IR again. On the square lattice on the other hand, the massless phase of the Pottsmodel ends up with the antiferrom agnetic transition point, and thus it is tempting to speculate that the universality class of the critical sigma model. But thism ight be a ected by the di erence between the hem i-supersphere and the full one (the elect of global topological properties of manifolds on the critical points of sigma models does not seem to be completely understood in general. See [16] for a recent review.)

W hile the situation is not so fam iliar in two dimensions where most e ort has been devoted to models based on unitary compact groups where the Merm in-Wagner-Coleman theorem prevents spontaneous symmetry breaking, it is well known in higher dimensions. There, one typically

tackles exponents at the critical point in the O (N) model with $(^{2})^{2}$ coupling by studying the broken symmetry phase, i.e., the non-linear sigma model, in d = 2 + , calculating the function in this phase, and identifying the critical point with the rst zero of the function. The perturbative series thus obtained are only sensitive to the local structure of the group manifold, while the restoration of symmetry involves global properties.

To discuss things further, we consider the geom etrical interpretation of the full sigm a model. It is slightly more convenient to start from the non-scaled fermions, and consider the equivalent of Eq. (6) with the constraint b() > 0 removed. To each site i we assign an Ising variable i = 1 which distinguishes between the two solutions (i.e., b() > 0 and b() < 0). One not easily

where we have de ned $\sim_i = \int_{j \in i} m_{ij} j$. For the region of broken symmetry, a is negative, and thus the existence of domain walls with i j = 1 extremely unfavorable for small jaj. If we think of the i's as Ising variables (essentially the c-num ber parts of the eld), we have a ferrom agnetic Ising model coupled to the arboreal gas. A full geometrical interpretation is easily obtained by going over the steps of [7]. The terms again give an arboreal gas, but now each tree gets a more complicated weight

so now trees getting near or across dom ain walls have their weight modi ed.

As the lattice coupling is modied, a rst sight analysis would say that generically in such a model, one will observe two transitions: an Ising transition where only the dynamics of the $_{\rm i}$ variables becomes critical, and an arboreal gas transition, where only the dynamics of the trees becomes critical. These transitions will occur for dierent values of a. Hence the critical point of the arboreal gas, i.e., the hem isphere lattice sigm a model, will coincide in general with the

critical point of the coupled system [Ising m odel+ arborealgas], i.e., the full lattice sign a m odel.² Only an extraordinary coincidence could m ake the Ising and arboreal transitions m erge, resulting in a higher order phase transition, and a situation where the critical points of the hem i-sphere and full sign a m odel are di erent, the latter being of higher order, and less stable.

This whole analysis may have to be taken with a grain of salt however. In particular, the arboreal gas is a model whose weights are extremely non-local, and the modi cation brought by coupling to the Ising variables might have strange consequences. Also, it is after all not clear how much of the conventional wisdom derived from models with positive Boltzmann weights will extend to models such as ours, where the physics is determined by balance of positive and negative contributions in addition to the usual energy/entropy balance. At this stage, numerical study seems the best way to clarify the situation.

3 Bethe equations at the antiferrom agnetic point

The special value a = 4 identied above corresponds more precisely to the end point Q ! 0 of the antiferrom agnetic critical line, which was identied by Baxter [17] as

(here K₁;K₂ are the usual horizontal and vertical couplings). While the Potts model on the square lattice is not solvable for arbitrary couplings, it does become solvable on the line (15). The Bethe ansatz equations were written in the original paper by Baxter, and read

where N is the width of the cylinder in the transferm atrix (measured in terms of the Potts spins), the are the usual spectral parameters determining the Bethe wave function, and we have parameterized $P \overline{Q} = 2 \cos$, 2 0; $_{\overline{2}}$. As discussed in details in [9] for the case Q generic, the physics of the isotropic model $K_1 = K_2$ can be studied more conveniently by considering a strongly anisotropic limit and the associated quantum ham iltonian for a chain of 2N spins 1=2. The energy (in the relativistic scale) is then given by

We expect that the ground state is obtained by lling up the lines $\text{Im} = \frac{1}{2}$ and $\text{Im} = \frac{1}{2}$. If we restrict to solutions of the type $\frac{i}{2}$ + and $\frac{i}{2}$ + , a system of two equations for the real parts and can then we written. It can also be extended to string con gurations centered on either line.

²This is if the Ising transition has not yet occurred when the arboreal degrees of freedom become critical. The converse m ight happen, with the Ising variables becom ing critical rst, but this seems quite unlikely, as it would lead to the universality class of the supersphere sigm a model being a simple Ising theory. Notice that at small negative a the Ising model is in the ordered phase, and the weight per unit length of a domain wall is e^{2-a} 1. As jajincreases, this weight increases until at the critical value a = -4 it reaches $e^{-1+2} = 0.606$. W ithout coupling to the arboreal gas, the Ising model meanwhile would order when the weight per unit length of a domain wall is $\frac{1+2}{1+2} = 0.414$. So the Ising transition must be signi cantly ham pered by the trees.

We now focus on the limit $\frac{1}{2}$. We set $=\frac{1}{2}$ + , and scale the spectral parameters with . The resulting system of equations reads (we use the same notations for the rescaled spectral parameters)

4 Critical properties at the antiferrom agnetic point

4.1 First aspects

We now observe that setting = gives Bethe equations similar to the antiferrom agnetic XXX chain, while there is an additional factor of 2 in the de nition of the energy. The sector symmetric in and roots will lead to twice the central charge and critical exponents of the XXX chain, which are the ones of a free boson with coupling constant g = 1, or an SU (2) W ZW model at level one (a similar feature was encountered in [5]. This is more than a coincidence, as will be discussed below).

This is not to say that all the excitations are of this type. Doubling the spectrum of the X X Z chain of course creates many gaps in the conform all towers, which have to be led with other types of excitations in our system. But at least, we can derive quickly some results from this subset of the spectrum, which is now under control.

For the electric part of the spectrum , we then get the follow ing result

The charge e can be interpreted as giving a special weight w to non-contractible boops. Following the detailed m appings of the Potts m odel on contours and vertex m odels, one nds w = 2 cos e. Since non-contractible boops com e in pairs, we have e de ned m odulo an integer. The Q ! 0 state Potts m odel itself corresponds to $e = e_0 = \frac{1}{2}$, for which c = -1, while the e ective central charge is $c_e = 2$.

M agnetic gaps read sim ilarly

Here m is the spin of the equivalent XXX chain. Since one solution of the equivalent XXX system corresponds to a pair of solutions of our system, $m = \frac{N}{2}$ [number of pairs of solutions] and $m = \frac{S^2}{2}$, where S^2 is the spin in our initial system. Therefore

where S^{z} is an integer since we have an even number of spins.

One can see here that parity e ects will likely occur. If N is even, since we must also have an even number of upturned spins to make up pairs of Bethe roots in the folding of the equations,

the result strictly speaking will only apply to S^z even, including the ground state. Numerical study shows that in fact it holds for S^z odd as well. If N is odd on the other hand, since we must also have an even number of upturned spins to make up pairs of Bethe roots in the \folding" of the equations, the result strictly speaking will only apply to S^z odd. Numerically, we have observed indeed that for S^z even, including the ground state $S^z = 0$, results for N odd obey a di erent pattern. This will be discussed later, and we restrict for now to N even.

The electric charges in the S^z = 0 sector of the equivalent XXX chain are, for the untwisted case, integer, and give rise to the following gaps = 2 $\frac{e^2}{4g} = \frac{e^2}{2}$. Combining all the excitations, we thus get exponents from a single free boson at $g = \frac{1}{2}$, viz., $_{em} = \frac{1}{2}$ e $\frac{S^z}{2}^2$, where e; S^z are integers. ³ This is intuitively satisfactory, as one expects the \arrows degrees of freedom " in the model to be described by a free boson in general. This free boson of course contributes only c = 1 to the total central charge, so to get c = 2 we need to invoke the presence of another theory with c = 1.

To proceed, we consider the dynam ics of the hole excitations over the ground state where the two lines $Im = \frac{1}{2}$ are lied. We introduce the functions (notations are the same as in [18])

Now in ordinary models such as those with sl(n) symmetry, it is well known how to obtain analytically the spectrum of exponents by careful analysis of nite size scaling e ects. The exponents are expressed as quadratic forms based on the matrix Z and its inverse [19, 20]. We

shall assume a bit naively that the same essentially is true here as well. All the elements of Z diverge in the limit x = 0, but if we keep x sm all, Z reads

The symmetric part of the spectrum $n_1 = n_2 = n$ and $d_1 = d_2 = d$ gives $h + h = (n)^2 + d^2$. We have checked numerically that this formula extends to the case n half odd integer, so the total XXX part of the spectrum reads $h + h = e^2 + \frac{m^2}{4}$, e;m integers, or $h = \frac{1}{8} (m + 2e)^2$ and $h = \frac{1}{8} (m - 2e)^2$. This corresponds to a free boson at the coupling g = 1=2, i.e., symplectic ferm ions. It is useful to introduce now the determ inants of the Laplacian on a torus with di erent types of boundary conditions, Det $_{ab}$; the subindices denote the boundary conditions (P = periodic, A = antiperiodic, or F = free), with b referring to the space direction (of length N) and a to the imaginary time direction (of length M, with m odular parameter $q = e^{-2 M - N}$) [21]:

C om bined with this sym plectic ferm ion part, we have an in nite degeneracy associated with the modes $d_1 = d_2$. P resumably, this leads to a continuous spectrum of exponents on top of the sym plectic ferm ion ones. Since on the other hand we know that the theory has c = 1 ($c_e = 2$) while the sym plectic ferm ion part identi ed so far has c = 2 ($c_e = 1$), it is very tem pting at this stage to propose that the missing part of the spectrum consists simply in a non-com pact boson. We now give a more direct argument for this.

4.2 Lessons from free boundary conditions and modular transform ations

The partition function of the Q = 0 Potts model on an annulus with free boundary conditions can be obtained in two steps, both based on previous works. The rst step consists is expressing it as an alternate sum over generating functions of levels for type II representations of U_tsl(2) (where $\stackrel{P}{Q} = t + t^{-1}$, and we use the notation t for the quantum deform ation parameter to avoid confusion with q) [22] in the associated six-vertex or XXZ model (not to be confused with the XXX model which appears through its Bethe equations earlier in this paper as a subsector of the Potts model. The latter has t = 1 while the form er has t = i). The second step consists in identifying the generating function K_j of levels for the type II representations. This step is not rigorous, and based on our understanding of the model at special points $= \frac{1}{n}$, n > 2, together with arguments of continuity in [10]. To make a long story short, one ends up with the following results.

The expression of K $_{i}$ as Q ! 0 is

where $P(q) = {Q \atop 1} (1 q^n)$, and j is an integer (spin) label, j = 0;1;2:::. The astute reader might wonder why this expression does not satisfy for instance $K_0 = K_1 + K_2 = K_3:::= 0$ which would naively result from the quantum group symmetry that mixes all spin 0 and spin 1 representations [22]. The reason is that the eigenvalues of the transfer matrix all go to zero as Q = 0, and this transfer matrix cannot be rescaled in such a way that its elements remain all nite as Q = 0. A lternatively, in a ham iltonian formulation, the ground state energy of the relativistic ham iltonian goes to 1 in the lim it Q = 0. In that lim it, the K_j 's are obtained after an additional renormalization, and do not have to satisfy the quantum group induced coincidences any longer.

A little algebra shows that the generating function of levels (partition function in the conform al language) of the XXZ or six-vertex m odel on the annulus is

It corresponds to the partition function of sym plectic ferm ions on an annulus with antiperiodic boundary conditions in the time direction, det (A_F) , and is as well a character of the c = 2 rational logarithm ic theory [23]. The object Z_{PF}^{vertex} written as $Z_{PF}^{\text{vertex}} = Z_{PF}^{\text{vertex}} = \frac{1}{2}$ det (A_F) is an thus be interpreted as arising from a theory made of sym plectic ferm ions and a non-compact boson, with partition function $\frac{1}{2}$.

The presence of the non-compact boson can be ascertained through a modular transform ation. Writing $\mathbb{Z}_{PF}^{\text{vertex}} = 2\frac{2}{(q)}$, we see that modular transform ations in the usual Q = 0 critical Potts model do close, since

The corresponding object in the usual critical Potts model (\mathbb{Z}_{PF}) would vanish identically. As before, $\mathbb{Z}_{PF}^{arboreal}$ can be interpreted as the partition function of sym plectic ferm ions (here, ferm ions periodic on the annulus, and the zero mode subtracted) times the contribution from a non-com pact boson, $\frac{1}{2}$.

We thus see that the study of the model with free boundary conditions greatly strengthens the claim that the continuum limit of the model is made up of a symplectic ferm ion theory and a non-compact boson. This of course agrees with c = 1, $c_e = 2$. Let us discuss this identication further.

4.3 The continuum lim it of the Q = 0 antiferrom agnetic critical Potts model

The action corresponding to this continuum limit reads (Boltzm ann weight e $^{\rm S}$)

with the boson being non-compact. Now recall that the scaling limit of the arboreal gas, or the Q = 0 Potts model in the Berker-Kadano phase, was idential with the OSP (1=2) supersphere sigm a model, whose action reads exactly like Eq. (41) with the additional constraint that $^2 + 2_{12} = 1$. To all appearances therefore, the critical point of the arboreal gas simply corresponds to a free OSP (1=2) eld theory, where the constraint has been forgotten, and the symmetry is realized linearly. This interpretation requires some further discussion. The sigm a model in the massless Berker-Kadano (spontaneously broken symmetry) phase has action

with g a negative quantity. It thus boks as if the natural action for the theory without constraint should be Eq. (41) with a negative sign. W hile this has no importance for the fermions (the

sign for them can be switched by a trivial relabeling) it is not so at all for the boson. While the model $S = + (0)^2$ is well de ned, the model with $S = (0)^2$ is naively rather ill de ned! It is possible to argue how ever, that since the theory is not compactiled, this sign does not really matter.

Start with the 'proper' free uncompacti ed boson, with action (we put num erical constants explicitly now)

and thus propagator h (z;z) (0) i = $\frac{1}{4}$ h $\dot{z}\dot{f}$. The fact that is not compactified allows all powers of as elds, and hence by summation, all complex exponentials. However, since only normalizable states appear in the partition function (see [24, 25] for further discussion on this point), only in aginary exponentials will show up there. This is compatible with the result of the functional integration

Hence in a transferm atrix study of such a model, we would see essentially a continuous spectrum above the central charge c = 1. Note how the presence of operators with arbitrarily negative dimension does not make the theory unstable, nor does it a ect the ground state in the transferm atrix calculations.

If we adm it that the \full operator content" is built out of elds $e^{(a+ib)}$ and derivatives, then a change of variables ! i should leave it invariant. This means that full operator content can be built as well out of $e^{(a+ib)}$ and derivatives, where now has a propagator with the wrong sign, h (z;z) (0)i = $\frac{1}{4}$ ln $\frac{1}{2}$ ². Normalizable states now correspond to real exponentials, and their contribution to the partition function gives exactly the same result as Eq. (44), which can therefore be considered as the partition function for the theory with action

In other words, we de ne the functional integral in the case of Eq. (45) by analytic continuation, and since the set of allowed elds is invariant under this continuation, the partition function is the same in both cases.

The fact that the critical point of the supersphere sign a model appears to be the free theory is a bit surprising. One would have expected instead the OSP (1=2) symmetry to be restored in a non-trivial way, and the model maybe to coincide with the critical O (n = 1) model of N ienhuis [26], discussed more thoroughly as an OSP (1=2) model in Ref. [3]. The latter model how ever has central charge $c = \frac{3}{5}$, and de nitely is very dimensioners the one we obtain. This dimension model. It might also be that some of the simplications in the denition of the solvable O (n) critical model in [26] (such as the denition of the Boltzmann weight) a ect the physics in an unexpected way when n is negative, with, as a result, less universality than expected.

5 Relation with OSP (2=2) theories

5.1 osp(2=2) integrable spin chain.

We now notice that the Bethe equations bear a strange sim ilarity with equations written for a chain with sl(2=1) symmetry. In particular, if we took a chain with alternating 3;3 representations

(N of either type), the equations would read, in the appropriate grading [27, 5],

M ore generally, the Bethe equations for alternating representations build with n-supersymm etric tensors and the conjugate would look like Eq. (46), but with the factor 2 replaced by 2n on the left-hand side (source term s). Our equations seem to correspond to taking \quarter spin" representations (in sl(2) inspired conventions, where the fundam ental has spin 1=2). This in fact has a meaning, thanks to the work [28] where it was shown that the Bethe equations for a chain built with the four-dimensional typical representation (and L sites) read

where b is the ferm ionic D ynkin number (denoted by b_2 in [28]). The fundam ental of sl(2=1) corresponds to b = 1, a degenerate case. The case b = 0 m eanwhile corresponds to the fundam ental representation of osp(2=2). Energy terms in this case can also be read from [28] and exactly m atch the term in the Q = 0 Potts m odel case (after a rescaling of the Bethe parameters in [28]). We thus conclude that the Bethe equations and energy for the Q = 0 antiferrom agnetic Potts spin chain are identical with those for the integrable spin chain with osp(2=2) symmetry built on the four-dimensional fundam ental representation [b = 0; j = 1=2].

Note that the length of the osp(2=2) system in these equations, denoted L in the Bethe equations, coincides with N, where the number of spin 1=2 representations in the spin chain is 2N. Hence the size of the H ilbert spaces on which the two systems are acting are identical, and equal to $2^{2N} = 4^{N}$. Since the Bethe equations also coincide, this is a very strong indication that the spectra of the two systems are identical, even though one has to be careful with such statem ents, as Bethe spectra are not always com plete in the superalgebra case.⁵

5.2 Continuum lim it of the osp(2=2) integrable spin chain.

Now, as argued in [31], the integrable model based on the four-dimensional fundamental representation of osp(2=2) sits inside the Goldstone phase of this model, and goes to the supersphere sigm a model OSP (2=2)=OSP (1=2) in the scaling limit. The latter model can be described [30] by the following action. Parameterize the S^{1;2} supersphere as

where is compactified, +2. The integrable chain corresponds to spontaneously broken symmetry, with the theory being free in the UV and massless in the IR, corresponding to a negative coupling constant g. Critical properties are described by the g! 0 lim it of Eq. (49). A rescaling and relabeling brings Eq. (49) into the form

with now $+\frac{p^2}{yj}$. As g ! 0, we thus obtain a symplectic ferm ion and a non-compact boson, with the wrong sign of the metric. This is exactly the low energy theory we had identified earlier for the Q = 0 antiferrom agnetic Potts model, thus con iming our picture.

Note that the presence of a continuous spectrum in this osp(2=2) version of the problem has a physical origin in the fact that the symmetry is spontaneously broken, and thus correlation functions of order parameters have no algebraic decay (though have logarithmic behaviour). This feature was veried numerically in [31] where it was found that the scaling dimensions of p leg polymer operators extracted through transferm atrix calculations vanish inside the entire G oldstone phase indeed.

As a nal note we rem ark that the Bethe equations for the osp(2=2) chain have been most offen [32, 33] written in a di erent grading from the one we used. It is also interesting to compare the analysis of the low energy physics from the more standard point of view.

The usual Bethe equations are written as

These equations show that the chain has a relativistic limit (a feature peculiar to the value b = 0 of the fundam ental representation [18]). Moreover, the density equations coincide with those for the Q ! 0 antiferrom agnetic Pottsm odel discussed above: even though we have started from two di erent gradings, we end up with identical physical equations, a very strong indication that our approach is consistent [34] (note in particular that the quantum num bers of the excitations, being expressed naturally in terms of com plexes and real holes, have di erent expressions in terms of the bare quantum num bers) and the results correct.

To nish the analysis of the osp(2=2) system, the most useful quantity one can consider is the equivalent spin' de ned by forming the combination m b $3S^{z}$. The four states of the fundamental representation b = 0; $S^{z} = 1=2$; $S^{z} = 0$; b = 1=2 correspond respectively to the values m = 3=2; 1=2; 1=2; 3=2. On the other hand, according to the detailed lattice model derivation of the Bethe ansatz equations [33, 32],

The spectrum is expressed in terms of sum s and di erences of n_c^h and n_r , where the subscripts c;r indicate complexes and real particles respectively. One has

We thus see that it is possible to change the value of the pseudospin m without changing $n_c^h + n_r$, i.e., by exciting only the at part of the spectrum. In other words, in the geometrical interpretation, the gaps for p leg operators are all expected to vanish. This result agrees with predictions based on the G oldstone analysis of the OSP (2=2) loop model, as well as numerical calculations [31], and we take the consistency of the di erent approaches as a justication of our use of the dressed charge form alism in these problem s.

5.3 Explicit m apping between the two models

Even though we have found that the Bethe equations for the two models are identical, we do not exactly know how to map them onto each other. Clearly, one must combine pairs of neighbouring spin 1=2 representations of the vertex model to make up four-dimensional representations of the osp (2=2) algebra, but we are not sure how to implement this. Part of the di culty comes from the highly singular nature of the Potts transferm atrix as Q ! 0.




Figure 3: Indecom posable representation $1=2^{2}$ for t = i.

It is interesting to notice however that as t ! i, the tensor product of two fundam ental representations of $U_t sl(2)$, which decomposes as the sum of a one and a three dimensional representations like for t = 1 when t is generic, becomes indecomposable, and has the structure shown in Fig. 3, where $ju_1i = e^{i} = 4j + i + e^{i} = 4j + i = 4j + i$




Figure 4: M apping between forests and self-intersecting loops. This solid (resp. dashed) lines represent the lattice L (resp. the dual lattice L^{D}). All edges of L^{D} penetrating the boundary of L are understood to jpin at a unique dual site situated on the in nite, exterior face of L. Thick solid lines depict the forest (here with four component trees); thick dashed lines depict the (unique) dual tree. The grey (red online) solid line is a self-intersecting loop on the surrounding lattice (see text). It bounces o occupied edges (thick linestyle) on L and on L^{D} , and self-intersects whenever a pair of intersecting direct and dual edges are both non-occupied.

at t = i, together with the lim its $\lim_{t!} \frac{(S_{t+t})^2}{t+t^2}$, one obtains the four-dimensional representation of osp(2=2). This suggests a mechanism by which the symmetry of the lattice model must be enhanced at the critical point. One can in fact show by brute force that by concatenating pairs of spins 1=2 into four degrees of freedom and carefully taking the Q ! 0 lim it of the Boltzm ann weights of the heterogeneous 6-vertex model equivalent to the critical antiferrom agnetic Q state Potts model, the R matrix of the osp(2=2) integrable vertex model in the fundamental (b = 0; j = 1=2) representation is indeed obtained. This will be discussed elsewhere.

Note of course that the osp (2=2) integrable model can be reform ulated as a bop model. In fact the whole G oldstone phase has been argued to be realized physically by taking a model made of a single dense bop where crossings are allowed. This can be obtained (and studied num erically) for instance by taking the usual [35] covering of the surrounding lattice of the square lattice with a single self avoiding loop, and then allowing self-crossings.

It is well known that in the case where self-crossings are not allowed, the loop the hull of a spanning tree, hence giving rise to the well-known close relationship between the critical theory of dense polymers and that of spanning trees, both being related to sym plectic ferm ions [12, 13]. This relationship can to some extent be generalized to the arboreal gas and the loop with self-

crossings (see Fig. 4). Indeed, draw on the lattice L a spanning forest. D raw on the dual lattice L^{D} (which in particular contains a single site outside L) a spanning tree. The resulting contour on the surrounding lattice is a single loop with a number of self-intersections equal to the number of trees on L plus one! So we have a sort of correspondence between a self-crossing loop and an arboreal gas, i.e., between a system with osp(2=2) symmetry and the Q ! 0 antiferrom agnetic Potts model. However, this is not a very satisfactory correspondence. In particular, because the tree on the dual lattice plays a crucial role in determining the loop con guration, there is no one to one correspondence between loop and forest. A lso, giving a negative fugacity to trees corresponds to a negative weight for self-crossings of the loop, while the existence of the G oldstone phase was argued in [31] for positive weights only.

6 Conclusion

The most interesting conclusion is probably the emergence of a non-compact boson in the continuum limit of the critical antiferrom agnetic Potts model at Q = 0. A lthough it is di cult to demonstrate the existence of such a non-compact object based on any single analysis, the convergence of Bethe ansatz calculations, num erical calculations, and symmetry considerations, leaves very little doubt that the conclusion is correct. This is, to our know ledge (together with our earlier work on Goldstone phases [31], which as we saw is intimately related), the rst time that a non-compact object appears in the continuum limit of a lattice model with a nite number of degrees of freedom (but 'unphysical' Boltzm ann weights). In a subsequent work, we will see that this feature extends to the antiferrom agnetic Potts model away from Q = 0 [9].

We have also seen how this non-compact boson is part of a free OSP (1=2) theory, which appears here as a critical point of the super (hem i-)sphere sigm a model. The main question that remains unanswered in this study of the physics of models with supergroup symmetry is what happens to the other' (Nienhuis) critical O (n = 1) model [26], and how this is related with a possible di erence between the critical points in the hem i and full supersphere sigm a models. We hope to get back to these questions soon.

To nish, we can clarify several remaining points. The rst is the issue of what happens when the size of the lattice system N is odd. As will be discussed in details for the general antiferrom agnetic Potts model in [9], the spectrum in that case does not show any signs of non-compactness because the bosonic eld appears to be twisted (and thus its properties independent of any compactic cation radius). By OSP (1=2) symmetry, the fermionic eld is also twisted, so the elective central charge in this sector is

in agreem ent with num erical calculations [8, 9].

The second point is that numerical [B] as well as analytical arguments [9] suggest that the critical point is, in the Potts model point of view, approached from the Berker-Kadano phase (the broken symmetry phase) with a singularity in the free energy of the form

$$f/(a a) \ln(a a)$$
 as a "a: (59)

(We recall that a = 4 for the square lattice.) Using hyperscaling, this corresponds to a perturbation of the critical point by a eld of vanishing dimension. There are of course plenty of

such elds in the non-compact boson theory. We speculate that the scaling lim it near and below a could be described by the simple Landau-G inzburg theory

$$S = d^{2}x (0)^{2} + 20 10 (0)^{2} + (0)^{2}$$

for which the logarithm in f [see Eq. (59)] follows as well.

The last point concerns the physical interpretation of our results. This of course has to be taken with a bit of care, as our model involves negative Boltzm ann weights. But the image we have is that in the region a < a = 0, the partition function is dom instead by con gurations where a single in nite tree covers a nite fraction of the lattice this fraction is unity as a ! 0, and remains nite in the whole phase a < a < 0, the rest of the lattice being covered by trees of nite size. Tree exponents are the same as in the limit a ! 0, as can be checked num erically in Table 1. In particular, the fact that the one-tree exponent remains equal to zero guarantees that there is an in nite tree, and that its fractal dimension is equal to two. At a = a, we have coexistence of two phases, one with an in nite tree of nite density, the other with only nite trees. As a = a is crossed, the derivative of the free energy with respect to a is discontinuous [8], in plying that the average num ber of trees per lattice site, and thus the average size of nite trees, experiences a discontinuity. In the phase a < a (like in the phase a > 0), there are only nite trees, of typical linear size given by the nite correlation length. The point a = a is actually a rst-order critical point, that is a point where a rst and second order phase transition coincide [8]. At such a point, som e correlations still decay algebraically, while som e of the therm odynam ic properties have discontinuities. The latter translate into operators of vanishing dimensions, for which we expect an in nite multiplicity. The simplest formalism to encompass this multiplicity

is a non-com pact boson, in agreem ent with what was found previously.

We conclude with a side remark. The fermionic representation of the arboreal gas model, instead of being used to argue for the presence of an OSP (1=2) sym metry, can be used to get yet another representation, this time in terms of a loop model. For this, go back to the initial path integral (3) written in terms of fermions $_1$; $_2$ only

Simply expand the exponent, and contract the ferm ions. This is like the standard high tem perature expansion for the Nienhuis O (n) model. It gives rise to a sum over non-intersecting loops, with weight 2 per loop (like in the O (n = 2) model), plus non-overlapping monomers with weight 4 + a, and dimers (which can be considered as degenerate length-two loops) with weight

a. The critical point a = 4 m eans m onom ers disappear, dim ers have weight 4. We are not sure why this model should be critical note the dim ers seem to encourage swelling of the loops, instead of self attraction as one would expect to get to a tricritical point and this direction certainly deserves further study. Note that a critical point with c = 1 has been identied in a modiled version of the 0 (n = 2) model in Ref. [36].

A Bethe equations

The standard integrable model based on the sl(2=1) = osp(2=2) superalgebra is the Perk Schultz model. It uses the fundamental representation of dimension 3, and leads to the Bethe ansatz equations (for a review see [37])

A lgebraically, these equations correspond to treating the fundam ental representation of sl(2=1) as a non-typical ferm ionic representation with parameters [b; j] = [1=2;1=2], of dimension 3 instead of 4. One could as well consider a model based on higher spin representations [b; j] = [j; j]obtained by taking the fully supersymmetric component in the product of n = 2j fundam ental representations. The equations would read as Eq. (62) but on the left-hand side the factor 2 would be replaced by 2n.

M ore generally, for the four-dim ensional typical representations [b; j = 1=2], the Bethe equations generalizing Eq. (62) read [38, 39, 40]

In particular, the case b = 0 is similar to Eq. (62) but on the left-hand side the factor 2 is replaced by 1 corresponding roughly to taking a 'quarter spin'. The second type of Bethe ansatz for the Perk Schultz model is obtained when associating the fundam ental representation to the bosonic root of the distinguished Dynkin diagram instead. One obtains then the so called Sutherland's equations

F inally, it is also possible to write a Bethe ansatz based on the alternative D ynkin diagram, where both roots are ferm ionic

In this ansatz, equations for a m ix of the fundam ental and its conjugate are particularly elegant [27]:

As for the model based on the four-dimensional representation, its equations are given in the text as Eq. (47) and correspond once again to taking a 'quarter spin'.
