## A simple beam model for the shear failure of interfaces

W e propose a novelm odel for the shear failure of a glued interface between two solid blocks. W e m odel the interface as an array of elastic beam s which experience stretching and bending under shear load and break if the two deform ation m odes exceed random ly distributed breaking thresholds. The two breaking m odes can be independent or combined in the form of a von M ises type breaking criterion. A ssum ing global load sharing following the beam breaking, we obtain analytically the m acroscopic constitutive behavior of the system and describe the m icroscopic process of the progressive failure of the interface. W e work out an e cient simulation technique which allows for the study of large system s. The lim iting case of very localized interaction of surface elements is explored by computer simulations.

#### I. IN TRODUCTION

Solid blocks are often joined together by welding or glueing of the interfaces which are expected to sustain various types of external bads. When an elastic interface is subjected to an increasing load applied uniform ly in the perpendicular direction, in the early stage of the failure process cracks nucleate random ly along the interface. Due to the heterogeneous microscopic properties of the glue, these cracks can remain stable under increasing load, which results in a progressive dam age of the interface. This gradual softening process is followed by the localization of dam age which leads then to the global failure of the interface and separation of the two solid blocks.

Interfacial failure plays a crucial role in ber reinforced composites, which are constructed by embedding bers in a matrix material [1]. Composites are often used as structural components since they have very good mass speci c properties, i.e. they provide high strength with a relatively low mass, preserving this property even under extrem e conditions. The mechanical perform ance of composites is mainly determined by the characteristic quantities of the constituents (ber and matrix), and by the fabrication process which controls the material's m icrostructure, the form ation of dam age prior to applications, and the properties of the ber-m atrix interface. In many cases the reinforcement is a unidirectional arrangement of long bers resulting in highly anisotropic mechanical properties, i.e. in the direction of the ber axis the composite exhibits high strength and fracture toughness since the load is mainly carried by bers, how ever, in the perpendicular direction the load bearing capacity is provided solely by the matrix material. Hence the dom inant failure mechanism of unidirectional com posites perpendicular to the bers' direction is shear.

Failure here occurs mainly due to the debonding of the berm atrix interface.

Since disordered properties of the glue play a crucial role in the failure of interfaces, most of the theoretical studies in this eld rely on discrete models [2, 3] which are able to capture heterogeneities and can account for the complicated interaction of nucleated cracks. The progressive failure of glued interfaces under a uniform load perpendicular to the interface has recently been studied by means of ber bundle models [4, 5, 6, 7, 8, 9, 10, 11]. Several aspects of the failure process have been revealed such as the macroscopic constitutive behavior, the distribution of avalanches of simultaneously failing glue and the structure of failed glue regions [12]. Considering a hierarchical scheme for the load redistribution following ber failure, a cascading mechanism was proposed for the softening interface in Ref. [13, 14]. The roughness of the crack front propagating between two rigid plates due to an opening load was studied in the fram ework of the fuse m odel. The m icrocrack nucleation ahead the m ain crack and the structure of the dam aged zone were analyzed in detail [15]. The shear failure of an interface between two rigid blocks has very recently been investigated by discretizing the interface in terms of springs. It was shown that shear failure of the interface occurs as a rst order phase transition [16].

In the present paper we study the shear failure of the glued interface connecting two solid blocks in the fram ework of a novel type of model. In our model the interface is discretized in terms of elastic beam swhich can be elongated and bent when exposed to shear load. B reaking of a beam is caused by two breaking modes, i.e. stretching and bending, characterized by random ly distributed threshold values. The two breaking modes can be either independent or combined in terms of a von M ises type breaking criterion [17]. A ssum ing long range interaction am ong the beam s, we obtained the full analytic solution of the model for the m acroscopic response of the interface, and for the m icroscopic process of failure. We show that the presence of two breaking modes low ers the crit-

ical stress and strain of the material without changing the statistics of bursts of simultaneously failing elements with respect to the case of a single breaking mode. The coupling of breaking modes results in further reduction of the strength of the interface. We demonstrate that varying the relative importance of the two breaking modes the macroscopic response of the interface can be tuned over a broad range. The limiting case of very localized interaction of beams is also considered. We determ ine the constitutive behavior and the distribution of avalanches of breaking beams for the case when beam s interact solely with their nearest and next-nearest neighbors in a square lattice. An elective simulation technique is worked out which makes it possible to study system s of large size.

## II. PROPERTIES OF THE MODEL




FIG.1: (a) Shearing of a single beam between two rigid plates. Since the distance 1 between the plates is kept constant, the beam experiences stretching and bending deform ation, with longitudinalt and shear f forces. (b) Shearing of an array of beam s, with the corresponding forces. In the case shown, one beam is broken.

In our model we represent the glued interface of two solid blocks as an ensemble of parallel beam s connecting the two surfaces. First, we derive an analytical description of a single beam of quadratic cross section clamped at both ends and sheared by an external force f, see Fig. 1(a). The shearing is exerted in such a way that the distance l between the two clamping planes is kept constant. Consequently, the beam experiences not only a torque m, but also a norm all force t due to the elongation l, which is characterized by the longitudinal strain = 1.

W e derive the form of the de ection curve of the beam, as well as the magnitude of the tension force. It is necessary to introduce some approximations, so the model can be incorporated into the simulation code in a sensible way. Following the procedure outlined e.g. in [18], we solve the di erential equation for the beam de ection (z) under the in uence of the lateral force f and a given stretching force t. We then solve self-consistently fort(f), with the bing the result of the longitudinal elongation.

The governing di erential equation for the bending situation depicted in Fig.1(a) can be cast in the form

Here, E denotes the modulus of elasticity, and I is the moment of inertia for bending of the beam. For a beam of rectangular cross-section, we have  $I = d^4=12$ , where d is the side length. Let us brie y motivate this ansatz by stating that the second derivative <sup>(0)</sup>(z) is proportional to the torque on the beam, so consequently it needs to vanish at the beam half-length l=2. A coordingly, the third derivative <sup>(00)</sup>(z) is proportional to the shearing force exerted on the beam, hence, it constitutes a term of the balance equation, Eq. (1). The rst derivative term with

 $^{0}(z)$  denotes the projection of the tension force t. Due to the clamping, the dejection and its inst derivative must vanish at the end z = 0. The formula for the bending moment m is

The solution (z) for vanishing t can be obtained as [19]

from which we can calculate the elongation

where  $S = d^2$  is the beam cross-section area. The rst order solution for t(f) reads as

From a computational point of view, a formulation of bending and stretching in term softhe longitudinal strain is more suitable than using the lateral force f. For that,

we only need to replace m (f) by m ( ), which yields

Using as an independent variable enables us to make comparisons to the simple case of ber bundle models [4, 5, 7, 8, 20, 21] where the elements can have solely stretching deformation. In the model we represent the interface as an ensemble of parallel beam s connecting the surface of two rigid blocks (see Fig. 1 (b)). The beam s are assum ed to have identical geom etrical extensions (length l and side length d) and linearly elastic behavior characterized by the Young m odulus E . In order to capture the failure of the interface in the model, the beams are assum ed to break when their deform ation exceeds a certain threshold value. As it has been shown above, under shear loading of the interface beam s su er stretching and bending deform ation resulting in two modes of breaking. The two breaking modes can be considered to be independent or combined in the form of a von M ises type breaking criterion. The strength of beam s is characterized by the two threshold values of stretching  $_1$  and bending  $_2$  a beam can withstand. The breaking thresholds are assumed to be random ly distributed variables of the pint probability distribution (PDF)  $p(_1;_2)$ . The random ness of the breaking thresholds is supposed to represent the disorder of the interface material.

After breaking of a beam the excess load has to be redistributed over the remaining intact elements. Coupling to the rigid plates ensures that all the beam s have the same deform ation giving rise to global load sharing, i.e. the load is equally shared by all the elements, stress concentration in the vicinity of failed beam s cannot occur. If one of the interfaces has a certain com pliance, the load redistribution following breaking of beam s becomes localized. This case has recently been studied for the external load in posed perpendicular to the interface [16].

In the present study we are mainly interested in the m acroscopic response of the interface under shear loading and the process of progressive failure of interface elem ents. The global load sharing of beam senables us to obtain closed analytic results for the constitutive behavior of the system for both independent and coupled breaking m odes. W e exam ine by com puter simulations the statistics of simultaneously failing elements. The limiting case of the very localized interaction of interface elements is explored by com puter sim ulations.

#### III. CONSTITUTIVE BEHAVIOR

A ssum ing global load sharing for the redistribution of load after the failure of beam s, the most im portant characteristic quantities of the interface can be obtained in closed analytic form .

B reaking of the beam is caused by two breaking modes, i.e. stretching and bending which can be either independent or coupled by an empirical breaking criterion.

a beam breaks if either the longitudinal stress t or the bending moment m exceeds the corresponding breaking threshold. Since the longitudinal stress t and the bending moment m acting on a beam can easily be expressed as functions of the longitudinal deformation , the breaking conditions can be form ulated in a transparent way in terms of . To describe the relative importance of the breaking modes, we assign to each beam two breaking thresholds  $\frac{1}{1}$ ;  $\frac{1}{2}$ , i = 1; ...; N, where N denotes the number of beam s. The threshold values  $_1$  and 2 are random ly distributed according to a joint probability density function  $p(_1; _2)$  between lower and upper bounds  $\frac{m}{1}$  in;  $\frac{m}{1}$  and  $\frac{m}{2}$  in;  $\frac{m}{2}$  ax, respectively. The density function needs to obey the norm alization condition

#### A. OR breaking rule

First, we provide a general form ulation of the failure of a bundle of beam s. We allow for two independent breaking modes of a beam that are functions f and g of the longitudinal deformation . Later on this case will be called the OR breaking rule. A single beam breaks if either its stretching or bending deform ation exceed the respective breaking threshold  $_1$  or  $_2$ , i.e. failure occurs if

where Eqs. (11,12) describe the stretching and bending breaking modes, respectively. The functions f() and g() are called failure functions, for which the only restriction is that they be monotonic functions of . For our specic case of elastic beams the failure functions can be determ ined from Eqs. (6,8) as

where a is a constant and the value of the Young modulus E is set to 1.




FIG. 2: Plane of breaking thresholds (1; 2). The point of intersection of f() and g() determines the fraction of remaining beam s.

In the plane of breaking thresholds each point  $(_1;_2)$ represents a beam. For each value of those beam swhich survived the externally in posed deform ation are situated  $1^{max}$  and g()  $2^{max}$ <sup>m ax</sup>, as in the area f()  $_1$ it is illustrated in Fig. 2. Hence, the fraction of intact beam s N intact=N at a given value of can be obtained by integrating the density function over the shaded area in Fig.2

D ue to the global load sharing, deform ation and stress of the beam s are the same everywhere along the interface. Consequently, the macroscopic elastic behavior of the system can be obtained by multiplying the load of a single beam,  $^{(1)} = (E = 1 \text{ is taken})$ , by the fraction of intact elements Eq. (14)

A sum ing that the breaking thresholds, characterizing the relative importance of the two breaking modes, are independently distributed, the joint PDF can be factorized as

This is the general form ula for the constitutive behavior of a beam bundle with two breaking modes applying the OR criterion. In the constitutive equation 1  $P_1(f())$ and 1  $P_2(g())$  are the fraction of those beams whose threshold value for bending and stretching is larger than g() and f(), respectively. It follows from the structure of Eq. (18) that the existence of two breaking modes leads to a reduction of the strength of the material, both the critical stress and strain take sm aller values com pared to the case of a single breaking m ode applied in simple ber bundle m odels [4, 5, 6, 7, 8, 9, 10, 11].

Considering the special case of two uniform distributions for the breaking thresholds in the intervals  $\begin{bmatrix} m & in \\ 1 & 1 \end{bmatrix}$  and  $\begin{bmatrix} m & in \\ 2 & 1 \end{bmatrix}$ , respectively, we can derive the speci c form of Eq. (18) by noting that

M ore speci cally, if the distributions have equal boundaries [0;1], and substituting the failure functions f and g from Eq. (13), the constitutive equation takes the form

### B. Von M ises type breaking rule

We now address the more complicated case that the two breaking modes are coupled by a von M ises type breaking criterion: a single beam breaks if its strain ful lls the condition [17]




FIG. 3: Intact beam s in the plane of the failure thresholds  $_1$ ;  $_2$  for a given strain , if breaking is determined by the von M ises criterion. The values a and b are de ned as the intersections between the curve of the breaking condition Eq. (22) and the maximum values  $\prod_{i=1}^{max} ; \prod_{i=2}^{max}$ , respectively. The shaded region labeled A denotes the intact beam s; the shaded region B represents the additionally failing beam s that would be intact in the case of the OR-criterion.

This algebraic condition can be geom etrically represented as it is illustrated in Fig. 3. In the plane of the failure thresholds  $_1$ ;  $_2$ , the beam s that survive a bad are bounded by the maximum values  $_1^{\max}$ ;  $_2^{\max}$  and the hyperbola de ned by Eq. (22). Calculating the intersection points a and b de ned in Fig. 3, which are found to be

### IV. COMPUTER SIMULATIONS

W e would like to enphasize that assuming independence of the breaking thresholds the joint distribution factorizes  $p(_1; _2) = p_1(_1) \quad p(_2)$ , but the integrals in Eq. (26) over the two variables cannot be performed independently. Still, the integral in Eq. (26) can be evaluated analytically for a broad class of disorder distributions. As an example, we again consider two hom ogeneous distributions Eq. (19) over the interval [0;1] along with the failure functions Eq. (13). Setting the Young modulus and the parameter E = 1 = a, the integrals yield

Even for the simplest case of uniform ly distributed breaking thresholds, the constitutive equation takes a rather complex form. It is important to note that the coupling of the two breaking modes gives rise to a higher amount of broken beam s compared to the OR criterion. In Fig. 3 the beam s which break due to the coupling of the two breaking modes fall in the area labeled by B.





FIG. 4: Constitutive behavior of a bundle of beam s with two breaking modes in a strain-controlled simulation of N = 4  $10^{\circ}$ beam s, under the OR (dashed line), von M ises type (solid line), and a pure stretching breaking criterion (dotted line). The random failure thresholds for the breaking modes of each beam are sampled from uniform distribution between [0;1]. The points marked with `', `+' and `' denote the respective theoretical results, Eqs. (21, 27), and = (1) for the pure stretching case. The constants E and a are set to unity here.

In order to determ ine the behavior of the system for complicated disorder distributions and explore them icroscopic failure process of the sheared interface, it is necessary to work out a computer simulation technique. In the model we consider an ensemble of N beam sarranged on a square lattice. Two breaking thresholds  $\frac{1}{1}$ ;  $\frac{1}{2}$  are assigned to each beam i (i = 1;::;N) of the bundle from the joint probability distribution p(1; 2). For the OR breaking rule, the failure of a beam is caused either by stretching or bending depending on which one of the conditions Eqs. (11,12) is fullled at a lower value of the external bad. This way an elective breaking threshold  $\frac{1}{6}$  can be de ned for the beam s as

where f<sup>1</sup> and g<sup>1</sup> denote the inverse of f;g, respectively. A beam ibreaks during the bading process of the interface when the bad on it exceeds its e ective breaking threshold  $\frac{i}{c}$ . For the case of the von M ises type breaking criterion Eq. (22), the e ective breaking threshold  $\frac{i}{c}$  of beam i can be obtained as the solution of the algebraic equation




FIG. 5: The beams that break due to mode g fall in the shaded region. The labels a and b m ark the abscissae of the intersection points of the curve  $g^1(_2) = f^1(_1)$  with the lines  $_2 = \frac{m}{2}^{in}$  and  $_2 = \frac{m}{2}^{ax}$ , respectively.

A lthough for the speci c case of the functions f;g given by Eqs. (11,12) the above equation can be converted to a 4th order polynom ial and solved analytically, this solution turns out to be in practical, especially since the num erical evaluation of the solution is too slow. We therefore solve Eq. (29) num erically by m eans of a m odi ed N ew ton root nding scheme, where we m ake use of the fact that the solution has the low er bound 0.

In the case of global load sharing, the load and deform ation of beams is everywhere the same along the interface, which in plies that beam s break in the increasing order of their e ective breaking thresholds. In the simulation, after determining  $\frac{i}{c}$  for each beam, they are sorted in increasing order. Quasi-static loading of the beam bundle is perform ed by increasing the external load to break only a single element. Due to the subsequent load redistribution on the intact beam s, the failure of a beam may trigger an avalanche of breaking beams. This process has to be iterated until the avalanche stops, or it leads to catastrophic failure at the critical stress and strain. Under strain controlled loading conditions, how ever, the load of the beam s is always determ ined by their deformation so that there is no load redistribution and avalanche activity.

In Fig. 4 the analytic results of Sec. III on the constitutive behavior Eqs. (21, 27) are compared to the corresponding results of computer simulations. As a reference, we also plotted the constitutive behavior of a bundle of bers where the bers fail solely due to simple stretching [4, 5, 6, 7, 8, 9, 10, 11]. It can be seen in the gure that the simulation results are in perfect agreement with the analytical predictions. It is in portant to note that the presence of two breaking modes substantially reduces the critical stress  $_{\rm c}$  and strain  $_{\rm c}$  ( and value of the maximum of the constitutive curves) with respect to the case when failure of elements occurs solely under stretching. Since one of the failure functions g() is non-linear, the shape of the constitutive curve () also changes, especially in the post-peak regime. The coupling of the two breaking modes in the form of the von M ises criterion gives rise to further reduction of the strength of the interface.

# V. PROGRESSIVE FAILURE OF THE IN TERFACE

D uring the quasi-static loading process of an interface, avalanches of sim ultaneously failing beam s occur. Inside an avalanche, how ever, the beam s can break under di erent breaking m odes when the OR criterion is considered, or the breaking can be dom inated by one of the breaking m odes in the coupled case of the von M ises type criterion. Hence, it is an important question how the fraction of beam s breaking due to a speci c breaking m ode (stretching or bending) varies during the course of loading of the interface.




FIG.7: Constitutive behavior for di erent values of the shape param eter m<sub>1</sub> of stretching. Strain controlled simulation of N = 90000 beam s with failure due to the OR-criterion, xing the param eters  $_1 = _2 = 1:0$  and m<sub>2</sub> = 2. Inset: total fraction of beam s broken under mode g during the course of loading.

For the OR criterion, those beam s break, for instance, under bending, i.e. under mode g de ned by Eq. (12), whose e ective breaking threshold  $\frac{i}{c}$  is determined by  $g^{1}(\frac{i}{2})$  in Eq. (28) so that the inequality holds

In the plane of breaking thresholds f<sub>1</sub>; <sub>2</sub>g the region of beam swhich full the above condition is indicated by shading in Fig. 5. The fraction of beam sB<sub>g</sub>() breaking under mode g up to the macroscopically in posed deformation can be obtained by integrating the probability distribution p(<sub>1</sub>; <sub>2</sub>) over the shaded area in Fig. 5. Taking into account the fact that the intersection points a;b de ned in Fig. 5 may in general lie outside the rectangle  $\binom{m \ in}{1}$ ;  $\binom{m \ ax}{2}$ ;  $\binom{m \ in}{2}$ ) and adjusting the integral lim its accordingly, we arrive at the following form ula for the fraction of bers breaking under mode g as a function of the deform ation

It should be noted that the second integral vanishes unless  $b < \frac{m}{1}^{ax}$ . The total fraction of beam sbreaking under m ode g during the entire course of the bading can be obtained by substituting =  $m^{ax}$  in the above form ulas, where  $m^{ax}$  denotes the deform at the breaking of the last beam.

In order to study the e ect of the disorder distribution  $p(_1; _2)$  of beam s on the relative importance of the two breaking modes and on the progressive failure of the interface, we considered independently distributed breaking thresholds \_1; \_2 both with a W eibull distribution

where index b can take values 1 and 2. The exponents  $m_1;m_2$  determ ine the am ount of disorder in the system for stretching and bending, respectively, i.e. the width of the distributions Eq. (32), while the values of  $_1;_2$  set the average strength of beam s for the two breaking modes. C om puter simulations were performed in the framework of global load sharing by setting equal values for the shape parameters  $m_1 = m_2$  and xing the value of  $_1 = 1$  of the stretching mode, while varying  $_2$  of the bending mode.

The total fraction of beam s breaking by stretching and bending using the OR breaking rule is presented in Fig. 6. Increasing  $_2$  of the bending mode, the beam s become more resistant against bending so that the stretching m ode starts to dom inate the breaking of beam s, which is indicated by the increasing fraction of stretching failure in the gure. In the limiting case of  $_2 >> _1$  the beam s solely break under stretching. Decreasing  $_2$  has the opposite e ect, m ore and m ore beam s fail due to bending, while the fraction of beams breaking by the stretching m ode tends to zero. It is interesting to note that varying the relative in portance of the two failure modes gives also rise to a change of the macroscopic constitutive behavior of the system . Fig. 6 illustrates that shifting the strength distributions of beams the functional form of the constitutive behavior remains the same, however, the value of the critical stress and strain vary in a relatively broad range.

The same analysis can also be performed by xing the values  $_1$  and  $_2$  and changing the relative width of the




FIG.8: Fraction of bers broken by the stretching mode as a function of fordi erent values of the corresponding shape parameter  $m_1$ . Strain controlled simulation with failure due to the OR-criterion, N = 90000, 1 = 2 = 1.0,  $m_2 = 9$ .

two distributions by varying one of the W eibull shape param eters m. We nd it convenient to shift m<sub>1</sub>, the shape param eter of the stretching mode instead of m<sub>2</sub>. It can be observed in Fig. 7 that for this choice of the scale param eters , the value of the critical strain hardly changes, how ever the critical stress nearly doubles as com pared to Fig. 6.

A lthough the e ect on the nal fraction of beam s broken by each m ode, see inset of Fig. 7, is not as pronounced as for shifting , we should also consider the fraction of bers broken up to a value of during the bading process (Fig. 8). It should be noted that the end points of the respective curves in Fig. 8 are just the nal fraction num bers in Fig. 7, but the curves show a strong spread for interm ediate values of . This dem onstrates that changing the am ount of disorder in the breaking thresholds strongly in uences the process of dam aging of the interface.

W e apply the m ethods outlined in the previous paragraphs to the von M ises case. Obviously, Eq. (22) does not allow for a strict separation of the two m odes. How – ever, the breaking of a beam at a certain value  $_{\rm c}$  is dom – inated by stretching if




FIG.9: Constitutive behavior for di erent values of the bending scale parameter  $_2$ . Strain controlled simulation with the von M ises criterion, N = 90000,  $_1 = 1.0$ , m $_1 = m_2 = 2$ . The inset presents the fraction of beam s whose failure was dominated by the stretching or bending m ode.

W ith the previous prescriptions for the failure functions Eqs. (13), we again nd a massive in uence on the constitutive behavior and the nal number of broken beam s, see Fig. 9. The inset of Fig. 9 dem onstrates that a crossover between stretching and bending preponderance occurs also in the von M ises case.

## VI. AVALANCHE STATISTICS

The stress controlled bading of the glued interface is accompanied by avalanches of simultaneously failing elements. The avalanche activity can be characterized by the distribution D () of burst sizes de ned as the number of beam breakings triggered by the failure of a single beam. In the framework of simple ber bundle models, it has been shown analytically that global load sharing gives rise to a power law distribution of avalanche sizes for a very broad class of disorder distributions of m aterials strength [6, 22]

with an universal exponent = 5=2.




FIG.10: A valanche size distribution D () for pure stretching of a ber bundle, and the two beam breaking conditions for system sizes N = 16 1<sup>(h)</sup>, averaged over 100 nuns. A t with the best result D / <sup>2:56</sup> over almost four decades is provided. The inset shows the dependency of the largest avalanche <sub>1</sub> on the system size for the three cases. Again, no di erence is found.

In the previous sections we have shown that in our model the interplay of the two breaking modes results in a complex failure mechanism on the microscopic level, which is strongly a ected by the distributions of the breaking thresholds. In order to investigate the bursts of breaking beam s we perform ed stress controlled simulations on large system s ( $N = 10^4 :::16 = 10$ ) with both the OR and von M ises type breaking criterion. In Figure 10 the simulation results are compared to the avalanche size distribution of a simple ber bundle model where failure occurs solely due to stretching [6, 7, 8, 9, 22]. In all the cases the avalanche size distributions can be t-ted by a power law over three orders of magnitude. The

best t exponent of = 2.56 0.08 was derived from the system of size N = 16 10 beam s, with an average taken over 100 samples. The size of the largest avalanche in the inset of Fig. 10 proved to be proportional to the system size. It can be concluded that the beam model belongs to the same universality class as the ber bundle model [6, 7, 8, 9, 22].

### VII. LOCAL LOAD SHARING




FIG.11: Snapshot of a LLS system at the last stable con guration. The color coding represents the load per beam, with broken beams carrying a vanishing load. The system size is L = 100.

During the failure of interfaces, stress localization is known to occur in the vicinity of failed regions, which results in correlated growth and coalescence of cracks. In our model this e ect can be captured by localized interaction of the interface elements, which naturally occurs when the two solid blocks are not perfectly rigid [12]. For simplicity, in our model solely the extremal case of very localized interactions is considered, i.e. after breaking of a beam in the square lattice, the load is redistributed equally on its nearest and next-nearest intact neighbors. This localized load sharing (LLS) results in growing failed regions (cracks) with high stress concentration along their perimeter [7, 12, 23]. Figure 11 shows the last stable con guration of a beam lattice preceding global failure, which was obtained using the OR criterion for beam breaking. Due to the stress concentration around cracks, the onset of a catastrophic avalanche occurs at lower external loads making the macroscopic response of the interface m ore brittle com pared to the case of global load sharing [7, 12, 23].

As for global load sharing, we shift the relative in portance of the two breaking modes by changing their




FIG.12: Constitutive curves in the LLS case, shifting  $_2$  and keeping the parameters  $_1 = 1.0$  and  $m_1 = m_2 = 2$  xed. Stress controlled simulation of N = 10000 bers averaged over 300 runs.

threshold distributions, and record the in uence on micro- and macroscopic system properties. We consider here the OR-criterion, and use two W eibull distributions with parameters  $_1$ ;  $_2$  and m $_1$ ;  $m_2$ , where the indices 1 and 2 denote the stretching and bending mode, respectively. Varying  $_2$  for a xed  $_1$ , we nd a considerable in uence on the constitutive properties, as Fig. 12 illustrates.

W e investigated also the distribution of avalanche sizes




FIG. 13: Distribution of avalanche sizes for LLS for three values of  $_2$ , with  $_1 = 1$  and  $m_1 = m_2 = 2$  xed. Simulations were performed using the OR criterion for a bundle of 10000 beams averaged over 300 runs.

for LLS, Fig. 13, where we vary the scale parameter  $_2$  of the bending mode g. We nd merely a shifting to di erent am plitudes, but no considerable e ect on the shape of the distribution function, which is similar to the one reported in [7]. In comparison to the GLS case, we should note that large avalanches cannot occur, and the functional form of the curves can be approximated by a power law with an exponent higher than for GLS in agreem ent with R efs. [6, 22, 23].

# VIII. CONCLUDING REMARKS

Fiber bundle models have been applied to describe various aspects of the failure of heterogeneous interfaces. However, bers can sustain solely elongation, and hence cannot account for m ore com plex deform ation states of interface elements, which naturally occurs under shear loading. We constructed a novel type of model for the shear failure of the glued interface of two solid blocks. In the model the interface is discretized in terms of elastic beam swhich experience stretching and bending deform ation under shear. B reaking of a beam can be caused by both deformations resulting in two failure modes. The mechanical strength of beam elements is characterized by the two threshold values of stretching and bending the beam can withstand. The beams are assumed to have identical elastic properties, the heterogeneous microstructure is represented by the disorder distribution of the breaking thresholds. In the model we assume that the two solid blocks are perfectly rigid which results in a

global load redistribution over the intact beam s following the breaking events.

W e presented a detailed study of the m acroscopic response and the progressive dam aging of the interface under quasistatic loading. Making use of the global load sharing of intact beam s, we obtained the analytic solution of the model for the constitutive behavior and the amount of dam age during the course of loading. In order to explore the microscopic process of dam aging we worked out an e cient simulation technique which enables us to study large system s. W e dem onstrated that the disorder distribution and the relative in portance of the two failure modes have a substantial e ect on both the microscopic dam age process and the m acroscopic constitutive behavior of the interface. Varying its parameters, the model provides a broad spectrum of material behaviors. Simulations showed that the failure of the interface proceeds in bursts of simultaneously breaking beam s. The distribution of burst sizes follows power law behavior with an exponent equal to the one of simple ber bundles. Under stress controlled loading conditions, the m acroscopic failure of the interface occurs analogously to phase transitions, where our beam model proved to be in the same universality class as the equal load sharing ber bundle model [7, 21, 24]. We showed that the localized interaction of beams leads to a more brittle behavior of the interface, which im plies a more abrupt transition at the critical load.

Beam models have been successfully applied to study the fracture of cohesive frictional materials where cracks usually form along the grain-grain interface. Beam elements proved to give a satisfactory description of the interfacial failure of grains and the emerging micro- and macro-behavior of materials [25]. Our beam model presented here provides a more realistic description of the interface of macroscopic solid bodies than the simple ber bundle model and is applicable to more complex bading situations. Experiments on the shear failure of glued interfaces are rather limited, especially on the microscopic mechanism of the progressive damage, which hinders the direct comparison of our theoretical results to experimental ndings. Our work in this direction is in progress.
