Scattering function for a self-avoiding polymer chain

An explicit expression is derived for the scattering function of a self-avoiding polym er chain in a d-dim ensional space. The e ect of strength of segment interactions on the shape of the scattering function and the radius of gyration of the chain is studied num erically. Good agreement is dem onstrated between experimental data on dilute solutions of several polymers and results of num erical simulation.

I. IN TRODUCTION

This paper is concerned with the scattering function (form factor) of a self-repellent polymer chain. The effect of excluded-volum e interactions between segments on the characteristic size of a \real" chain has attracted substantial attention from the beginning of the 1950s [1, 2, 3]. A though a noticeable progress has been reached in this area (the results of investigation are summarized in monographs [4, 5, 6, 7, 8]), the e ect of selfavoiding interactions on the statistics of m acrom olecules has remained a subject of debate in the past decade, see [9, 10, 11, 12, 13, 14, 15, 16, 17], to mention a few. This fact m ay be ascribed to the importance of excludedvolum e interactions for the description of such phenom ena as (i) protein folding and denaturation [10, 15], (ii) unzipping of DNA [17], (iii) mechanical response of individual m acrom olecules [13], and (iv) transport of chains through narrow pores [16]. A correct account for selfrepellent interactions (i) provides a consistent description of the e ect of m olecular weight on intrinsic viscosity of dilute polymer solutions [18], (ii) leads to an adequate characterization of tim e-dependent shear stresses [11, 14] and transport coe cients in polymer uids [12], (iii) predicts reinforcem ent of interfaces between incom patible solvents by random copolymers [9], etc.

The in uence of self-avoiding interactions on the scattering intensity of a chain in light, X-ray, and neutron scattering experiments has been investigated in [19, 20, 21, 22, 23, 24, 25, 26], where phenomenological equations have been developed for the structure function based on simplied theoretical models and results of M onte C arlo simulation. A lthough these relations improve our knowledge of the statistics of self-avoiding chains, their applicability remains questionable for the lack of direct comparison of their predictions with those grounded on an exact expression for the form factor. The objective of this study is to derive analytical form ulas for the scattering function of a self-avoiding chain in a d-dimensional space and its radius of gyration and to analyze the in uence of strength of excluded-volum e interactions on these quantities.

Two approaches are conventionally employed to model a self-repellent exible chain. According to the rst, a chain is treated as a set of freely-jointed rigid segments linked in sequel, whereas self-avoiding interactions do not perm it each pair of segments to occupy the same place [1]. This model implies that the distribution function of end-to-end vectors for the chain coincides with that for a self-avoiding random walk on a lattice [27, 28]. A lthough the latter function is unknown, it is believed that the leading term in the expression for the distribution function of a long chain is described by a stretched exponential function multiplied by a polynom ial of the end-to-end distance [29, 30].

The other approach (the Edwards m odel [31]) treats an arbitrary con guration of a chain as a curve with a Ham iltonian ascribed to it. The Ham iltonian equals the sum of the conventional H am iltonian for a G aussian chain and the excluded-volume functional, where the energy of segment interactions is approximated by the deltafunction. This method does not exclude intersections between segments, but assumes their number to be reduced (compared to that for a Gaussian chain) in some proportion to the strength of self-repellent interactions. The distribution function of end-to-end vectors for a selfavoiding chain is determined by the conventional path integral (G reen's function), and the scattering function (form factor) is given by the classical form ula [32], where averaging is performed with the help of the G reen function.

D espite an apparent sim plicity of the Edwards model, no exact formulas have yet been derived within this approach for the radial distribution function and the form factor. This may be explained by the fact that the H am iltonian containing the excluded-volum e functional becomes non-quadratic, and the path integral cannot be computed by using conventional approaches [33]. Am ong non-rigorous techniques proposed for the treatment of this problem, it is worth mentioning perturbative [3, 34, 35, 36] and renorm alization-group [37, 38, 39] methods.

The purpose of the present paper is to derive an exact formula for the form factor of a self-avoiding chain in a d-dimensional space based of the Edwards model with a slight modi cation of the excluded-volum e functional. This modi cation is caused by the observation that the average (over con gurations) value of the EdwardsHamiltonian, aswellasallmomentsofthe number of segment intersections become in nite at d > 1. The divergence rejects an increase in the number of intersections between di erent segments of the chain when the distance between them (measured along the curve that describes an arbitrary con guration) approaches zero. Based on a similarity between con gurations of a Gaussian chain and trajectories of a standard Brownian motion, the latterm ay be explained by the well-known properties of the local time of intersection for a d-dimensional Brownian path [40].

We concentrate on the derivation of an explicit expression for the scattering function. The interest to this quantity is explained by the fact that a num ber of experim ental data on sm all-angle X -ray and neutron scattering by m acrom olecules is available, which allow the strength of excluded-volum e interactions to be found by tting observations. An analytical formula for the distribution function of end-to-end vectors will be developed in a subsequent paper. The exposition is organized as follows. The average number of self-intersections for a exible chain is calculated in Section 2. The Edwardsm odelw ith a regularized Ham iltonian is introduced in Section 3. A series expansion for the scattering function is developed in Section 4. Borel's sum m ation of the series is perform ed in Section 5, where a closed-form expression is derived for the Laplace transform of this function. Explicit expressions for the scattering function of a self-repellent chain are obtained in Section 6 for the one-dimensional case and in Section 7 for the three-dimensional case. Two asymptotic approaches are suggested for the simplication of the form factor for a self-avoiding chain. The approximate expressions are tested in Section 8, where results of num erical simulation are compared with experin ental data. Som e concluding rem arks are form ulated in Section 9.

II. THE LOCALTIME OF SELF-INTERSECTIONS

We consider a standard Gaussian chain in a ddimensional space. One end of the chain is xed at the origin, and the other end is located at a point with radius vector Q. An arbitrary con guration of the chain is described by a curver() with 2 [0;L], where L stands for the contour length. The Ham iltonian of the chain reads

where b_0 denotes the length of a statistical segm ent, k_B is Boltzm ann's constant, and T $\,$ is the absolute tem perature.

Fixing a segment of the chain labeled by t 2 (0;L], we consider intersections of this segment with other segments labeled by 2 (q_1s_2), where 0 $q_1 < s_2 < t$. The number of intersections (the local time of intersection) is defined as

is the D irac function, the dot stands for inner product, and integration is performed over all vectors k. The delta-function in Eq. (2) counts the \number" of intersections between the segments labeled by t and , and the integral describes the sum these \numbers" over various segments belonging to the interval ($q; s_2$). The pre-factor b_0 is introduced to make the right-hand side of Eq. (2) dimensionless. The dependence of on the end-to-end vector Q is suppressed.

A lthough Eq. (2) is widely used, it should be treated with caution for this form ula has an unam biguous meaning when the average (over con gurations) number of self-intersections h $(s_1;s_2;t)i_0$ is nite for any point t and an arbitrary interval $(s_1;s_2)$. This is not the case, how ever, because all moments of the function $(s_1;s_2;t)$ diverge as s_2 ! t. This fact appears to be natural, for all con gurations are taken into account in the calculation of the average value of , including those curves r() that \oscillate" (and intersect them selves) with high frequencies.

Several approaches were developed to avoid the divergence of the integral in Eq. (2). The simplest method [41] consists in (i) replacement of the delta-function in Eq. (2) with another delta-function that $\mbox{measures}$ " the number of intersections $\mbox{shifted}$ " to some vector a, (ii) determination of the average number of intersections, and (iii) calculation of its limit (if it exists) as a ! 0. This technique allows the rst moment of the number of intersections to be found, but does not permit the entire set of moments to be determined analytically.

The renorm alization group approach was applied to the analysis of intersections of B rownian motion in [42, 43, 44]. An appropriate renorm alization (both multiplicative and additive) allows (i) explicit expressions for the rst twomoments of to be derived, and (ii) convergence of the \renorm alized" process $(s_1; s_2; t)$ [treated as a function oft for a given interval $(s_1; s_2)$] to a B row nian motion with known characteristics to be proved. A lthough these methods seem rather promising, their interpretation in terms of physical parameters of a chain remains unclear.

To avoid complications of the renorm alization-group approach, we regularize the number of intersections by ascribing to each intersection between segments labeled by and the weight that (i) approaches zero when the dimension when the vanishes, and (ii) reaches its ultimeter value of unity when the value

As the regularizing function (t) may be chosen from a set of functions satisfying the conditions (0) = 0 and $\lim_{t \ge 1} (t) = 1$, Eq. (4) provides an additional degree of freedom in the design of models for self-avoiding chains. In what follows, we set

where L_0 is the characteristic length of internal inhomogeneity. Roughly speaking, Eqs. (4) and (5) treat intersections between segments located [along the curve r()] at distances exceeding L_0 with the same (unit) weight and disregard intersections between segments located [along this curve] closer than the characteristic length L_0 .

To nd the average number of self-intersections, we replace the delta-function in Eq. (4) with its Fourier transform (3), and average the obtained relation over all conguration of a chain with an end-to-end vector Q,

E quation (10) shows that the average num ber of intersections between a segment labeled by t and segments belonging to the interval $(s_1; s_2)$ approaches in nity when s_2 ! t and d > 1, if a regularization function (t) is not used.

Setting $s_1 = 0$ and $s_2 = t$ in Eq. (4), we not the regularized number of intersections between a segment labeled by t and all segments labeled by t. Sum mation of these numbers over t 2 (0; L] provides us (after division by L) with the number of self-intersections per unit length

III. THE EDWARDSMODEL

A coording to the E dw ardsm odel [31], the H am iltonian H of a self-avoiding chain equals the sum of the H am iltonian of a standard G aussian chain H $_0$ and a quantity proportional to the number of self-intersections per unit length . Equations (1), (4) and (11) in ply that




FIG.1: The dimensionless ratio versus the dimensionless strength of segment interactions . Solid line: exact solution. Circles: linear approximation.

The function (93) is determined by three parameters: (i) the mean-square root end-to-end distance of an appropriate G aussian chain b, (ii) the dimensionless strength of segment interactions , and (iii) the dimensionless length of a chain . The pre-factor G is found from normalization condition (20).

Equation (99) provides an explicit expression for the radius of gyration of a self-repellent chain in the limit of small strengths of segment interactions (1) for an arbitrary dimensionless parameter .

B. A sym ptotic expression for the scattering function

O ur aim now is to derive a form ula for the scattering function at strong self-repellent interactions with v ! 1 under the assumption that ! O and the product v in Eq. (91) remains nite,

C om parison of Eqs. (72) and (101) in plies that in the lim it (100), the scattering function for a self-repellent chain in a three-dimensional space coincides (after the natural replacement $\frac{1}{6}q^2$! $\frac{1}{2}q^2$) with that for a self-avoiding chain in an one-dimensional space. Based on this sim ilarity and using Eq. (75), we arrive at the closed-form expression for the scattering function

that extends the D ebye form ula for a standard G aussian chain to self-avoiding chains. It follows from Eqs. (23) and (102) that the radius of gyration of a self-repellent chain in a three-dimensional space is given by Eq. (78), and its dependence on strength of self-avoiding interactions is presented in Figure 1.




FIG.2: The Guinier plots of the scattering function S for a standard Gaussian chain (= 0.0) and for self-repellent chains with various strengths of excluded-volume interactions.




FIG.3: The scattering intensity I versus the amplitude of scattering vector q. Sym bols: experim ental data on a PDM S blend [48] at volum e fractions of H-PDM S 0.06 (un lled circles), 0.26 (lled circles), and 0.52 (asterisks). Solid lines: results of num erical simulation.




FIG.4: The scattering intensity I versus the amplitude of scattering vector q. Large symbols: experimental data on solutions of PS/PBLG [49] in dioxane (un lled circles) and dioxane/TFA mixture (lled circles). Solid lines: results of numerical simulation. Small circles: approximation by the D ebay function with b = 1372 nm.

VIII. RESULTS OF NUMERICAL SIMULATION

To perform num erical simulation, we return to presentation (101) of the scattering function and write




FIG. 5: The scattering intensity I versus the amplitude of scattering vector q. Symbols: experimental data on a PDM E/PEM S blend at the temperatures T = 100, 200 and 250 C, from top to bottom, respectively [50]. Solid lines: results of numerical simulation with = 0.84.




FIG. 6: The scattering intensity I versus the amplitude of scattering vector q. Symbols: experimental data on a PDME/PEMS blend at the temperatures T = 150,200 and 300 C, from top to bottom, respectively [50]. Solid lines: results of numerical simulation with = 0.67.

W e sum num erically series (103) for several values of and present the dependence S (q) in Figure 2 (the G uinier plot). G iven an amplitude of the scattering vector q, an increase in strength of self-repellent interactions results in a pronounced decrease in the scattering intensity. W ith the growth of , the graph of the scattering function attens at relatively sm all values of q and it becomes m ore close to the graph of the G iunier function. The latter




FIG. 7: The m ean-square-root end-to-end distance for an equivalent G aussian chain b versus tem perature T. Sym bols: treatm ent of observations on PDM S/PEM S blends. Solid lines: approxim ation of the experim ental data by Eq. (104).

function is believed to adequately describe the scattering intensity of chains with strong excluded-volum e interactions [47].

We proceed with matching observations [sm all angle neutron scattering (SANS)] on poly (dimethylsibxane) (PDMS) blend 5HC/11DC with various volume fractions of hydrogenated PDMS (H-PDMS) reported in [48]. A description of the experimental procedure is given in [48]. A sum ing the scattering intensity I (q) to be proportional to the scattering function S (q), I = K S, where K is an optical constant [32], we approximate the experimental data depicted in Figure 3 by using three adjustable parameters: b, and K. The best-t quantities b and are determined by the steepest-descent method, and K is found by the least-squares algorithm. Figure 3 demonstrates an excellent quality of matching the observations with varying in the interval between 2.3 and 4.3.

To compare the accuracy of thing experimental data by Eq. (103) and by the D ebye function (46), we approxin ate observations (SANS) on poly (styrene-d₈)-b-poly (benzylL-glutam ate) (PS/PBLG) reported in [49]. The scattering intensity I is plotted versus the amplitude of scattering vector q in Figure 4 for solutions of PS/PBLG in dioxane and m ixture of dioxane and tri uoroacetic acid (TFA) with 20 wt. % of TFA. For a detailed description of the experim ental procedure, see [49], where it is dem onstrated that the presence of TFA in the solution results in transition from the rod-coil architecture of the diblock polymer to coil-coil topology of macrom olecules. Figure 4 shows that the best-t parameter vanishes for the coil-coil system, and Eq. (103) is reduced to the Debye function. For the rod-coil architecture of the diblock polymer, equals 3.1 (approximately), which means that the e ect of excluded-volum e interactions between rods is substantial. The Debye t of the observations on solution of PS/PBLG in dioxane is rather poor com pared

with the approximation by Eq. (103), and the best-t value of b found when self-avoiding interactions are disregarded appears to be too large.

To study the e ect of tem perature T and m ass-average molecular weight M $_{\rm w}$ on the material constants in Eq. (103), we approximate observations (SANS) on solutions of symmetric blends of poly (dimethylsiloxane) and poly (ethylm ethylsiloxane) (PEMS) in toluene. A detailed description of polymers and the experimental procedure is given in [50]. The experimental data and the results of num erical simulation are presented in Figures 5 and 6 for two blends at tem peratures ranged from 100 to 300 C. To reduce the number of adjustable param efor each blend by matching observations ters, we nd at the lowest temperature and use this quantity without changes to approxim ate the scattering intensity m easured at other tem peratures (thism eans that b is the only adjustable parameter in the tting procedure). Figures 5 and 6 dem onstrate good agreem ent between the observations and the results of num erical analysis (in contrast with the model used in the original work [50] that contains the same number of adjustable constants, but shows rather poor quality of matching the experimental data). The parameter equals 0.84 for the blend with low molecular weight and 0.67 for that with high M $_{\rm w}$.

The mean-square-root end-to-end distance for an equivalent G aussian chain b determ ined by thing these data is depicted in F igure 7 together with its approxim ation by the A menius-type dependence

where the coe cients $_0$ and $_1$ are found by the leastsquare technique. Form ula (104) is employed as a phenom enological relation that describes the e ect of tem – perature on the segment length $b_0 = b^2=L$. Figure 7 reveals that (i) the number of statistical segments increases with molecular weight, and (ii) given M_w, the K uhn length decreases with temperature (the growth of T is tantam ount to an increase in the intensity of therm al uctuations, which, in turn, in plies that the characteristic length of correlations between m onom ers dim in ishes).

IX. CONCLUSIONS

Introducing regularizing function in the form (5), we have derived explicit expressions for the scattering function S (q) of a self-avoiding chain in a d-dimensional space. Analytical relations are developed for the form factor and the radius of gyration of a self-repellent chain in the one-dimensional and three-dimensional cases. Results of numerical simulation demonstrate that the conventional linear approximation for the radius of gyration (weak excluded-volume interactions between segments) ensures an acceptable agreement with the exact solution when the dimensionless strength of interactions is less than unity. Fitting of experimental data (sm allangle neutron scattering) on several polymer solutions reveals that the values of the dimensionless strength of self-repellent interactions exceeds the ultimate value at which this approximation is reliable.

A novel approximation for the scattering function is proposed (high strength of segment interactions v ! 1 and large characteristic length of internal inhom ogeneity $L_0=L$! 1). In the limit (100), the scattering function for a self-repellent chain in a three-dimensional space

is similar to that for a self-avoiding chain in an onedimensional space. Equation (102) deduced in this approximation provides a simple generalization of the Debye formula (46) for the form factor of a standard G aussian chain. C om parison of numerical results with observations reveals that Eq. (103) adequately matches experimental data, and its material parameters are a ected by external conditions in a physically plausible way.
