# Scattering function for a self-avoiding polym er chain

#### Abstract

A $n \operatorname{explicit}$ expression is derived for the scattering function of a self-avoiding polym er chain in a d-dim ensional space. The e ect of strength of segm ent interactions on the shape of the scattering function and the radius of gyration of the chain is studied num erically. G ood agreem ent is dem onstrated betw een experim ental data on dilute solutions of several polym ers and results of num erical sim ulation.

## I. INTRODUCTION

This paper is concemed w th the scattering function (form factor) of a self-repellent polym er chain. T he effect of excluded-volum e interactions betw een segm ents on the characteristic size of a \real" chain has attracted substantial attention from the beginning of the 1950s

A correct account for selfrepellent interactions (i) provides a consistent description of the e ect ofm olecular w eight on intrinsic viscosIty of dilute polym er solutions [1] ${ }^{\text {d }}$, (ii) leads to an adequate characterization of tim e-dependent shear stresses [11 1, , $\left.1 \underline{1}_{1}^{\prime}\right]$ and transport coe cients in polym er uids [in 2$]^{\prime \prime}$ (iii) predicts rein forcem ent of interfaces betw een incom patible solvents by random copolym ers [9] $]$, etc.

The in uence of self-avoiding interactions on the scattering intensity of a chain in light, X -ray, and neutron scattering experim ents has been investigated in
 equations have been developed for the structure function based on simpli ed theoretical $m$ odels and results of $M$ onte Carlo simulation. A though these relations im prove our know ledge of the statistics of self-avoiding chains, their applicability rem ains questionable for the lack of direct com parison of their predictions w ith those grounded on an exact expression for the form factor. The ob jective of this study is to derive analytical form ulas for the scattering function of a self-avoiding chain in a

[^0]d-dim ensional space and its radius of gyration and to analyze the in uence of strength of excluded-volum e interactions on these quantities.

T w o approaches are conventionally em ployed to model a self-repellent exible chain. A ccording to the rst, a chain is treated as a set of freely-jointed rigid segm ents linked in sequel, whereas self-avoiding interactions do not perm it each pair of segm ents to occupy the sam e place [11]. This $m$ odel im plies that the distribution function of end-to-end vectors for the chain coincides $w$ ith that for a self-avoiding random walk on a lattice [271, 281]. A though the latter function is unknown, it is believed that the leading term in the expression for the distribution function of a long chain is described by a stretched exponentialfunction multiplied by a polynom ialofthe end-to-end


The other approach (the Edw ards model [ $\left.\mathrm{B}_{2}^{1} \overline{1}^{1}\right]$ ) treats an arbitrary con guration of a chain as a curve with a H am iltonian ascribed to it. The H am iltonian equals the sum of the conventionalH am iltonian fora $G$ aussian chain and the excluded-volum e functional, where the energy of segm ent interactions is approxim ated by the deltafunction. This $m$ ethod does not exclude intersections betw een segm ents, but assum es their num ber to be reduced (com pared to that for a Gaussian chain) in som e proportion to the strength of self-repellent interactions. The distribution function ofend-to-end vectors for a selfavoiding chain is determ ined by the conventional path integral (G reen's function), and the scattering_function (form factor) is given by the classical form ula [32], where averaging is perform ed w th the help of the $G$ reen function.

D espite an apparent sim plicity of the Edw ards m odel, no exact formulas have yet been derived within this approach for the radial distribution function and the form factor. This $m$ ay be explained by the fact that the Ham iltonian containing the excluded-volume functionalbecom es non-quadratic, and the path integral can-
 A $m$ ong non-rigorous techniques proposed for the treat$m$ ent of this problem, it is worth $m$ entioning perturoa-
 $m$ ethods.

The purpose of the present paper is to derive an exact form ula for the form factor of a self-avoiding chain in a d-dim ensional space based of the Edwards model $w$ ith a slight $m$ odi cation of the exchuded-volum efunctional. This m odi cation is caused by the observation that the average (over con gurations) value of the Edwards H am iltonian, as well as allm om ents of the num ber of segm ent intersections becom $e$ in nite at $d>1$. The divergence re ects an increase in the num ber of intersections betw een di erent segm ents of the chain when the distance betw een them ( $m$ easured along the curve that describes an arbitrary con guration) approaches zero. B ased on a sim ilarity betw een con gurations of a G aussian chain and trajectories of a standard B row nian motion, the latterm ay be explained by the w ell-know n properties of the localtim e of intersection for a d-dim ensional B row nian path [ 4 Qu'].

W e concentrate on the derivation of an explicit expression for the scattering function. T he interest to this quantity is explained by the fact that a num ber of experi$m$ entaldata on sm all-angle $X$-ray and neutron scattering by $m$ acrom olecules is available, which allow the strength of excluded-volume interactions to be found by tting observations. A $n$ analytical form ula for the distribution function ofend-to-end vectors w ill.be developed in a subsequent paper. The exposition is organized as follow s. The average number of self-intersections for a exible chain is calculated in Section 2. TheEdw ardsm odelw ith a regularized H am iltonian is introduced in Section 3. A series expansion for the scattering function is developed in Section 4. B orel's sum $m$ ation of the series is perform ed in Section 5, where a closed-form expression is derived for the Laplace transform of this function. Explicit expressions for the scattering function of a self-repellent chain are obtained in Section 6 for the one-dim ensional case and in Section 7 for the three-dim ensional case. Two asym ptotic approaches are suggested for the sim pli cation of the form factor for a self-avoiding chain. The approxim ate expressions are tested in Section 8, where results of num erical sim ulation are com pared w th experim ental data. Som e concluding rem arks are form ulated in Section 9.

## II. THE LOCALTIMEOF <br> SELF-INTERSECTIONS

We consider a standard Gaussian chain in a ddim ensional space. O ne end of the chain is xed at the origin, and the other end is located at a point w ith radius vector $Q$. An arbitrary con guration of the chain is described by a curve $r($ ) w th $2[0 ; L]$, where $L$ stands for the contour length. T he H am iltonian of the chain reads

where $b_{0}$ denotes the length of a statistical segm ent, $k_{B}$ is Boltzm ann's constant, and $T$ is the absolute tem perature.

Fixing a segm ent of the chain labeled by t $2(0 ; \mathrm{L}]$, we consider intersections of this segm ent $w$ th other seg$m$ ents labeled by $2\left(s_{1} ; s_{2}\right)$, where $0 \quad \mathrm{~s}<\mathrm{s}_{2}<\mathrm{t}$. $T$ he num ber of intersections (the local tim e of intersection) is de ned as

is the D irac function, the dot stands for inner product, and integration is perform ed over all vectors $k$. The delta-fiunction in Eq. (2) counts the \num ber" of intersections betw een the segm ents labeled by $t$ and , and the integraldescribes the sum these \num bers" over various segm ents belonging to the interval $\left(\mathrm{s} ; \mathrm{s}_{2}\right)$. The pre-factor $b_{0}$ is introduced to m ake the right-hand side of Eq. (2즈) dim ensionless. The dependence of on the end-to-end vector $Q$ is suppressed.

A thhough Eq. (2) is w idely used, it should be treated $w$ th caution for this form ula has an unam biguous m eaning when the average (over con gurations) num ber of self-intersections $h\left(s_{1} ; s_{2} ; t\right) i_{9}$ is nite for any point $t$ and an anbitrary interval $\left(\mathrm{s}_{1} ; \mathrm{s}_{2}\right)$. T his is not the case, how ever, because allm om ents of the function ( $s_{1} ; s_{2} ; t$ ) diverge as $s_{2}$ ! $t$. $T$ his fact appears to be natural, for all con gurations are taken into account in the calculation of the average value of , including those curves $r()$ that loscillate" (and intersect them selves) w ith high frequencies.

Several approaches w ere developed to avoid the divergence of the integral in Eq. (2, $\left.\bar{Z}_{\text {I }}\right)$. The simplest $m$ ethod [411] consists in (i) replacem ent of the delta-fiunction in Eq. (2, $)$ w ith another delta-function that $\backslash m$ easures" the num ber of intersections \shifted" to som e vector a, (ii) determ ination of the average num ber of intersections, and (iii) calculation of its lim it (if it exists) as a! 0.This technique allow s the rst $m$ om ent of the num ber of intersections to be found, but does not perm it the entire set of $m$ om ents to be determ ined analytically.

The renorm alization group approach was applied to the analysis of intersections of $B$ rownian $m$ otion in
 tiplicative and additive) allow s (i) explicit expressions for the rst twom om ents of to be derived, and (ii) convergence of the \renorm alized" process ( $\mathrm{s}_{1} ; \mathrm{s}_{2} ; \mathrm{t}$ ) treated as a fiunction oft for a given interval $\left(s_{1} ; s_{2}\right)$ ] to a $B$ row $n-$ ian m otion $w$ ith know $n$ characteristics to be proved. A $1-$ though these $m$ ethods seem rather prom ising, their interpretation in term s of physical param eters of a chain rem ains unclear.

To avoid com plications of the renorm alization-group approach, we regularize the num ber of intersections by
ascribing to each intersection betw een segm ents labeled by and tsom eweight that (i) approaches zero when the di erencet vanishes, and (ii) reaches its ultim ate value of unity when the \distance" betw een these points along the curve r( ) becom es relatively large. Thism eans that we replace de nition $(\underline{2})$ ) w ith

As the regularizing function $(t) m$ ay be chosen from a set of functions satisfying_the conditions ( 0 ) = 0 and $\lim _{t!} 1 \quad$ ( t$)=1, \mathrm{Eq}$. ${ }_{(1)}^{(4)}$ provides an additional degree of freedom in the design of $m$ odels for self-avoiding chains. In what follow S, we set

where $L_{0}$ is the characteristic length of intemal inhom ogeneity. Roughly speaking, Eqs. (4) and ( $\mathbf{S}_{1}^{\prime \prime}$ ) treat intersections betw een segm ents located [along the curve $r()]$ at distances exceeding $L_{0} w$ ith the same (unit) w eight and disregard intersections betw een segm ents 10 cated [along this curve] closer than the characteristic length $\mathrm{L}_{0}$.

To nd the average num ber of self-intersections, we replace the delta-fiunction in Eq. ( $\bar{U}^{4}$ ) $w$ ith its Fourier transform $\overline{(3)})$, and average the obtained relation over all con guration of a chain $w$ th an end-to-end vector $Q$,

## III．THE EDWARDS M ODEL

A ccording to the E dw ardsm odel［ $\left.{ }^{3} 11_{1}^{1}\right]$ ，the H am iltonian $H$ of a self－avoiding chain equals the sum of the $H$ am il－ tonian of a standard G aussian chain $H_{0}$ and a quantity proportional to the num ber of self－intersections per unit

Linear approxim ation (7) ensures a correct tofthe dependence $\mathrm{R}_{\mathrm{g}}(\mathrm{)}$ at relatively sm all strengths ( < 1), but overly estim ates the radius of gyration at higher values of .

W e sum num erically series ( $(1031)$ for several values of and present the dependence $S(q)$ in $F$ igure 2 (the $G$ uinier plot ). G iven an am plitude of the scattering vector q , an increase in strength ofself-repellent interactions results in a pronounced decrease in the scattering intensity. W ith the grow th of , the graph of the scattering function attens at relatively $s m$ all values of $q$ and it becom es $m$ ore close to the graph of the Giunier function. The latter

function is believed to adequately describe the scattering intensity of chains w ith strong exchuded-volum e interactions [47]

W e proceed w ith $m$ atching observations [sm all angle neutron scattering (SANS)] on poly (dim ethylsiloxane) (PDM S) blend $5 \mathrm{HC} / 11 \mathrm{D}$ C w ith various volum e fractions of hydrogenated PDMS (H PDMS) reported in [ $4 \overline{1} \bar{q}_{1}^{\prime}$ ]. A description of the experim entalprocedure is given in [481]. A ssum ing the scattering intensity $I(q)$ to be proportional to the scattering function $S(q), I=K S$, where $K$ is an optical constant [ 3 3i], we approxim ate the experim ental data depicted in $F$ igure 3 by using three adjustable param eters: b , and K . T he best- t quantities b and are determ ined by the steepest-descent $m$ ethod, and $K$ is found by the least-squares algorithm . F igure 3 dem onstrates an excellent quality ofm atching the observations w ith varying in the intervalbetw een 2.3 and 4.3 .

To compare the accuracy of tting experim ental data by Eq. (103') and by the D ebye fiunction (4-1), we approxim ate observations (SA N S) on poly (styrene-d 8 ) -b-poly (benzyl L-glutam ate) (P S/PBLG) reported in [4\%]. The scattering intensity $I$ is plotted versus the am plitude of scattering vector $q$ in $F$ igure 4 for solutions of $\operatorname{S/PB}$ LG in dioxane and $m$ ixture ofdioxane and tri uoroacetic acid (TFA) w th 20 wt. \% of TFA. For a detailed description of the experim ental procedure, see [4d], where it is dem onstrated that the presence of TFA in the solution results in transition from the rod-coil architecture of the diblock polym er to coil-coil topology ofm acrom olecules. $F$ igure 4 show s that the best- tparam eter vanishes for the coil-coil system, and Eq. (103i) is reduced to the D ebye function. For the rod-coil architecture of the diblock polym er, equals 3.1 (approxim ately), which $m$ eans that the e ect of exchuded-volum e interactions betw een rods is substantial. The Debye $t$ of the observations on solution of PS/PBLG in dioxane is rather poor com pared
$w$ ith the approxim ation by Eq. (103), and the best- $t$ value of $b$ found when self-avoiding interactions are disregarded appears to be too large.

To study the ect oftem perature $T$ and $m$ ass-average molecular weight $\mathrm{M}_{\mathrm{w}}$ on the m aterial constants in Eq. ( 10 tions of sym $m$ etric blends of poly (dim ethylsiloxane) and poly (ethylm ethylsiloxane) (PEM S) in toluene. A detailed description of polym ers and the experim entalprocedure is given in $\left[{ }_{5}^{2} 0_{1}^{\prime}\right]$. The experim ental data and the results of num erical sim ulation are presented in $F$ igures 5 and 6 for two blends at tem peratures ranged from 100 to 300 C . To reduce the num ber of adjustable param eters, we nd for each blend by $m$ atching observations at the lowest tem perature and use this quantity $w$ thout changes to approxim ate the scattering intensity $m$ easured at other tem peratures (thism eans that b is the only adjustable param eter in the tting procedure). Figures 5 and 6 dem onstrate good agreem ent betw een the observations and the results of num erical analysis (in contrast w ith the m odel used in the original work [ $\mathrm{H}_{2}^{\prime}$ I' that contains the sam e num ber of adjustable constants, but show s rather poor quality of $m$ atching the experim ental data). The param eter equals 0.84 for the blend w ith low m olecular weight and 0.67 for that with high $\mathrm{M}_{\mathrm{w}}$.

The $m$ ean-square-root end-to-end distance for an equivalent $G$ aussian chain $b$ determ ined by tting these data is depicted in $F$ igure 7 together $w$ ith its approxim ation by the A rrhenius-type dependence

where the coe cients 0 and 1 are found by the leastsquare technique. Form ula ( 10 nom enological relation that describes the e ect of tem perature on the segm ent length $\mathrm{b}_{0}=\mathrm{b}^{2}=\mathrm{L}$. Figure 7 reveals that (i) the num ber of statistical segm ents increases $w$ ith $m$ olecular weight, and (ii) given $M_{w}$, the $K$ uhn length decreases $w$ ith tem perature (the grow th of $T$ is tantam ount to an increase in the intensity of therm al uctuations, which, in tum, im plies that the characteristic length of correlations betw een $m$ onom ers dim in ishes).

## IX . CONCLUSION S

Introducing regularizing function in the form $\overline{(\overline{( }+\boldsymbol{T})}$, we have derived explicit expressions for the scattering function $S(q)$ of a self-avoiding chain in a d-dim ensional space. A nalytical relations are developed for the form factor and the radius of gyration of a self-repellent chain in the one-dim ensional and three-dim ensional cases. Results of num erical sim ulation dem onstrate that the conventional linear approxim ation for the radius of gyration (w eak excluded-volum e interactions betw een segm ents) ensures an acceptable agreem ent with the exact solution when the dim ensionless strength of interactions is less than unity. Fitting of experim ental data (sm allangle neutron scattering) on several polym er solutions
reveals that the values of the dim ensionless strength of self-repellent interactions exceeds the ultim ate value at which this approxim ation is reliable.

A novel approxim ation for the scattering function is proposed (high strength of segm ent interactions v! 1 and large characteristic length of intemal inhom ogeneity $L_{0}=L!1$ ). In the lim it ( $10-1$ ), the scattering function for a self-repellent chain in ${ }^{-1}$ three-dim ensionalspace
is sim ilar to that for a self-avoiding chain in an onedim ensional space. Equation (102) deduced in this approxim ation provides a sim ple generalization of the $D e-$ bye form ula (4G) for the form factor of a standard $G$ aussian chain. C om parison of num erical results $w$ ith observations reveals that Eq. (103) adequately m atches experim entaldata, and its m aterialparam eters are a ected by extemal conditions in a physically plausible way.
