On the e ective one-component description of highly asymmetric hard-sphere binary uid mixtures

The phase diagram of a binary uid m ixture of highly asymmetric additive hard spheres is investigated. Dem ixing is analyzed from the exact low-density expansions of the therm odynamic properties of the mixture and compared with the uid-uid separation based on the elective one-component description. Dierences in the results obtained from both approaches, which have been claimed to be equivalent, are pointed out and their possible origin is discussed. It is argued that to deal with these dierences new theoretical approximations should be devised.

It is well known that, due to the widely dierent time and length scales involved, it is a very dicult task to describe a soft matter complex uid composed of mesoscopic (colloidal) particles and m icroscopic (sm all) particles, i.e. a colloidal suspension. Therefore people have struggled for years trying to devise strategies that may render a tractable description. On the theoretical side, a rather successful and often employed approach in the colloids literature is that of coarse graining. In this technique the idea is to integrate out the irrelevant degrees of freedom (the small particles) to end up with a onecomponent system of colloidal particles described by effective interactions [1]. One of the most celebrated e ective interactions results from the depletion mechanism rst described by Asakura and Oosawa [2]. Suppose that two colloidal hard spheres are imm ersed in an ideal uid of small hard spheres. When the separation of the surfaces of two large spheres is less than the diameter of the small ones, the depletion of the latter from the gap between the colloids leads to an unbalanced osmotic pressure which, in turn, results in an e ective attraction between the two large spheres. Although the Asakura-O osawa depletion pair potential is concerned only with the lim it of extreme dilution, the theory of the depletion m echanism has recently been reexam ined by also including the interactions between the small spheres [3, 4]. In several of the recent studies the depletion mechanism has been invoked as the possible driving force for dem ixing, i.e. a phase transition whereby a binary uid mixture of hard spheres separates into two uid phases of dierent composition.

The aim of this paper is to shed some more light on the usefulness or limitations of the depletion pair potential picture, i.e. the consideration of an elective one-component uid of large spheres with elective pair interactions for describing the phase behavior of a binary uid mixture of highly asymmetric additive hard spheres [5]. Such an issue has recently been addressed by simulations [6, 7, 8, 9] but the analysis unfortunately provides no denitive answer due to limitations in the presently available simulation algorithms.




FIG. 1: C ritical total packing fraction  $\,^{\circ}_{\,^{\circ}}$  as a function of the critical reduced pressure  $p_c$ , where  $p_c$   $p_d^{-3}$ ,  $p_d^{-3}$ , with  $p_d^{-3}$  = 1=k<sub>B</sub> T, with  $p_d^{-3}$  with  $p_d^{-3}$  = 0.01 ann's constant, and T the absolute temperature, as obtained from the exact low-density expansions for three values of the diam eter ratio . Successive points (from left to right) indicate the addition of a new exact virial coefcient, starting with the second. Lines have been drawn to guide the eye. Dash-dotted line and triangles:  $p_d^{-3}$ 0.05; dashed line and squares:  $p_d^{-3}$ 0.1; solid line and circles:  $p_d^{-3}$ 0.2.

Recently [10] we have analyzed the demixing transition of a binary uid m ixture of  $N = N_1 + N_2$  additive hard spheres of diam eters  $_1$  and  $_2$  ( $_1$  >  $_2$ ). For a xed diam eter ratio =  $_2$ =  $_1$ , the therm odynam ic properties of the mixture were described in terms of the num ber density = N = V, with V the volum e, the partial number fraction of the big spheres  $x = N_1 = N$ , and the total packing fraction =  $_1$  +  $_2$ , where  $_1$  =  $_{1}^{3}$  (1 x)  $^{3}$ =6 are the packing fractions of the large and the small spheres. Demixing was studied by starting from the exact low-density expansions of the therm odynam ic properties, using as input analytical expressions [11, 12] and num erical computations [13, 14, 15, 16, 17, 18] for the virial coe cients so far reported in the literature (up to the sixth). For all the size asymmetries considered we found that, by successively incorporating in the density expansions a new exact virial coe cient, the critical consolute point moves to higher values of the pressure and of the total packing fraction as shown in Fig. 1. It is also seen in this gure that the rate of convergence is slow and so de nittive conclusions on the location of the critical consolute point cannot yet be reached with the available data on virial coe cients. We have also compared these ndings with the uid-uid separation resulting from di erent em pirical proposals for the equation of state [19, 20, 21], that attempt to reproduce the virial behavior and/or to comply with consistency conditions of the contact values of the radial distribution functions. We have realized that for historical reasons all these \rescaled" equations of state yield the exact second and third virial coe cients but inherit the singularity of the Percus-Yevick theory. We have shown that this apparently innocuous singularity arbitrarily introduces, as com pared to the exact low-density expansion of the pressure, additional dependencies on x through the fourth, fth, and so on virial coe cients. Such dependencies make the location of the critical consolute point to vary enorm ously from one equation of state to another, so that the predictions stemming from each of them are indeed unreliable.

The dem ixing transition of a binary m ixture of additive




FIG. 2: B inodals of asymmetric binary uid mixtures of additive hard spheres in the ( $_{1}-_{2}$ ) plane as obtained from the exact low-density expansions (continuous lines) for the same values of the diameter ratio as considered in Fig. 1. Filled circles indicate the critical consolute points. The dashed lines are the results of Ref. 5. The inset in the lower pannel is the curve for = 0.05 in a magni ed scale.

hard spheres may be analyzed using dierent therm odynam ic planes. In order to compare to well docum ented results in the e ective one-component uid, we rst considerthe (1 2) plane. In Fig. 2 we present the binodals resulting from the exact low-density expansions up to the sixth virial coe cient for two size asymmetries, namely = 0.2 and = 0.1, and up to the fth virial coe cient = 0:05. Note that the density region spanned by each binodal cannot go beyond the point where the total packing fraction occupied by the spheres reaches for the dense phase the highest possible value. Since these values are not known, we have drawn all the curves up to the lim iting (unphysical) value = 1. A comparison between these binodals and parallel ones derived using the depletion mechanism [5] indicates the following. For = 0.2, the low-density expansion predicts demixing, whereas there is no uid-uid separation in the eective one-component uid. The qualitative behavior of the binodals for = 0:1 and = 0.05 is, on the other hand, rather sim ilar in both approaches. However, there are two main di erences: 1) the values of 2 for the mixture are much lower than the corresponding ones in the e ective one-component uid; 2) the critical consolute points already lie outside the range where the binodals




FIG. 3: B inodals of asymmetric binary uid mixtures of additive hard spheres in the ( $_1$ -p) plane as obtained from the exact low-density expansions for the same values of the diam eter ratio as considered in Figs. 1 and 2. D ash-dotted line: = 0.05; dashed line: = 0.1; solid line: = 0.2. Filled circles indicate the critical consolute points.

Figure 3 is yet another presentation of the binodals, this time in the ( $_1$  p) plane, with p the pressure. These binodals follow from the low-density expansions by keeping the same number of exact virial coe cients as in Fig. 2. Since no values of the pressure for the coexisting phases have been reported in the elective one-

are predicted in the e ective one-component uid.

component uid in [5], a direct comparison between both approaches is not possible in this case. Nevertheless, the following comments are in order. It is known that a one-component uid with pairwise interactions consisting of a repulsive part and a short-range attraction can only produce in the (1 p) plane a van der W aals-like uiduid separation ending in an upper critical point, the concavity of the binodals pointing downwards. Moreover, it is well established that, by strongly reducing the range of the attractions with respect to that of the repulsions, the usual phase diagram with two stable transitions, namely uid-uid and uid-solid, changes and the uid-uid transition becomes metastable with respect to the uid-solid transition [22]. By a further reduction of the range of the attractions, a stable isostructural solid-

solid transition develops at high densities in the phase diagram [23, 24]. The phase behavior found in Ref. [5] follows indeed this trend. Note that although the zerobody and one-body terms (the volume terms) in the effective one-component description play no role in determ ining the phase equilibria, they are how ever responsible for inverting the concavity of the binodals from downwards to upwards, yielding the same concavity as the one found in the true binary mixture. The importance of the volume terms in the determination of the complete phase diagram should therefore not be ignored [1]. On the other hand, the resulting phase diagram s found in Ref. [5] also indicate that, for the depletion pair potential used in this reference, the small repulsive barrier that follows the attractive potential close to the surface of the large sphere does not qualitatively modify the phase diagram that would result by only considering a purely short-range attractive potential. The predictions for the phase diagram in the e ective one-component uid [5] for = 0:1 (a m etastable uid-uid transition) and for = 0.05 (a m etastable uid-uid transition and a stable solid-solid transition) are indeed at grips with the foregoing rem arks.

It should be clear that due to the fact that only a few exact virial coe cients are available and that the radius of convergence of the virial series in the case of mixtures is not known, de nite conclusions derived from the low-density expansions cannot be drawn. Nevertheless, the observed trends lead to the following considerations. As shown in Fig. 1, as one increases the number of terms in the low-density expansions, both the critical pressure and the critical total packing fraction grow. It is not clear whether this feature will change by including more exact virial coe cients (when available) in the density expansions, but all the evidence so farm akes it unlikely. In any

event, provided the trend obtained with the low-density expansions is a true feature, two possible scenarios arise. One may envisage the convergence of the critical constants to a therm odynam ic state with either a physical or an unphysical critical total packing fraction. Indeed, the term sphysical and unphysical depend of the resulting solid phase at high densities. For example, if the freezing transition corresponds to the partial freezing of the large spheres, i.e. a face-centered cubic lattice form ed by the large spheres while the small spheres remain disordered [19], the close packing fraction of the large spheres <sup>cp</sup> ' 0:74 de nes the boundary between physical and unphysical. In the rst scenario the dem ixing transition would be therm odynam ically metastable with respect to the freezing transition as found in previous studies, while in the second no dem ixing would be present at all. At this stage we have no way to decide which of the two scenarios is correct since, by incorporating up to the flh (sixth) virial coe cient in the exact low-density expansions for = 0:05 (0:1), the critical packing fraction of the big spheres  $_{1}^{c}$  is  $_{1}^{c} = 0.595 (0.557)$ . Concerning this point, a




FIG. 4: Critical total packing fraction  $_{\rm C}$  as a function of the critical reduced pressure  $p_{\rm C}$  as obtained from the truncation of the virial expansion of the BMCSL equation of state for two of the values of the diam eter ratio considered in Fig. 1. Successive points (from left to right) indicate that an additional (approximate) virial coecient has been retained in the truncation, starting with the second. Lines have been drawn to guide the eye. Dash-dotted line and triangles: = 0:05; dashed line and squares: = 0:1.

Concerning this point, a related analysis carried out with the Boubl k-M ansocri-Camahan-Starling-Leland (BMCSL) equation of state [25] (which predicts no deximing) is illustrative. This is shown in Fig. 4. The striking feature to be noted is the excellent agreement of the results obtained with the exact low-density expansion (c.f. Fig. 1) and those obtained with the truncated BMCSL equation of state. By including additional virial coe cients of the BCMSL equation of state it is seen that  $_{\rm C}{}'$   $_{\rm I}^c$  exceeds the close-packing fraction of the large spheres.

In order to understand the dierences between the phase diagram spresented in Fig. 2 using the exact lowdensity expansions and the e ective one-component description, the following considerations should be pointed out. For = 02 both approaches would be equivalent whenever the critical packing fraction of the big spheres resulting from the low-density expansions converges to an unphysical value. As indicated above, for = 0.05 = 0:1 the critical consolute points obtained with a reduced number of exact virial coe cients already lie outside the range where the e ective one-component description locates the binodals. In these cases the e ective one-component description would only provide a qualitative approximation of the true binary mixture if  $^{c}_{1}$  converges to a physical value. O therwise (convergence to an unphysical value) the predictions of both approaches would be completely at odds with each other in this basic issue. All these possibilities can indeed only be tested by including more exact virial coe cients in the density expansions. As a possible source for the dierences found between the exact density expansions and the e ective one-component description we suggest that it may be due to the fact that, in order to determ ine in the latter the phase diagram and to perform the direct simulations [5], the Camahan-Starling equation of state

is used for describing both the big and the small hard spheres. Note that the Percus-Yevick-type singularity of the Camahan-Starling equation of state may induce for each component dierent (through  $_1$  and  $_2$ ) spurious x-dependences similar to those discussed in Ref. 10 in connection with equations of state derived from \rescaled" virial expansions. These dependencies would in turn lead to unreliable predictions on the location of the demixing transition.

Up to here and due to the involved approximations, none of the argum ents and results that we have discussed lead to a neat conclusion concerning the claim ed equivalence of the e ective one-com ponent description vis a vis the true binary m ixture description of highly asym m etric hard spheres. Therefore, new theoretical approaches to deal with this problem should be sought. In this respect, system atic and controlled approximations in the uid regime, may protably be undertaken. Of course these are presently limited by the available virial coe cients. A lso, the role of reliable simulations capable of exploring the region of interest can hardly be overem phasized. Irrespective of the technical di culties that no doubt are involved both in the simulations and in the computation of additional virial coe cients of highly asym metric binary uid mixtures of additive hard spheres, we hope that the present paperm ay also serve to stimulate e orts in this direction.
