# N eutron scattering study of the vibrations in vitreous silica and germ ania

The incoherent approximation for the determ ination of the vibrational density of states of glasses from inelastic neutron or x-ray scattering data is extended to treat the coherent scattering. The m ethod is applied to new room temperature measurements of vitreous silica and germ ania on the therm altim e-of- ight spectrom eter IN 4 at the H igh F lux R eactor in G renoble. The inelastic dynamic structure factor at the boson peak turns out to be reasonably well described in terms of a mixture of rotation and translation of practically undistorted SiD 4 or G eO 4 tetrahedra. The translational component exceeds the expectation of the D ebye model by a factor of two. A possible relation of this excess to the phonon shift and broadening observed in x-ray B rillouin scattering experiments is discussed.

#### I. IN TRODUCTION

There is an extensive quantum mechanical treatment of the scattering from atom s moving in a crystal<sup>1</sup>. The regular atom ic arrangement allows to solve this problem with an accuracy and a theoretical depth which one cannot hope for in the much more complex case of a disordered solid. In a glass, the translation symmetry is lost. In addition, the sample is in an energy landscape with many minima. Fortunately, the relaxational jumps between di erent energy minima of glasses are only seen as quasielastic scattering below an energy transfer of about  $1 \text{ meV}^{2,3}$  (a frequency of 250 G H z); above that frequency, one can reckon with a more or less harm onic vibrational density of states.

But the problem what these vibrations are is by no means solved. Below 1 meV, reasonably well-de ned long-wavelength sound waves can be shown to exist (coexisting with relaxational or tunneling motion), but they become rapidly overdam ped above that frequency. This was rst deduced<sup>4</sup> from the plateau in the therm al conductivity at low temperatures. W ithin the last decade, it has been directly observed for the longitudinal sound waves by x-ray B rillouin scattering<sup>5</sup>. A lso, the density of states exceeds the D ebye expectation markedly at the socalled boson peak, at a frequency where the corresponding crystals still have only well-de ned long-wavelength sound waves.

In this paper, we report them alneutron tim e-of- ight m easurements at room temperature on silica and germania, data taken over a very large momentum transfer range with the new spectrometer IN 4 at the High Flux R eactor at the Institut Laue-Langevin at G renoble. The high quality of the data allows for an evaluation which goes beyond the usual incoherent approxim ation, extending and improving earlierwork<sup>6,7,8,9,10</sup>. One not only gets a vibrational density of states which compares favorably with heat capacity data, but one learns new facts on the details of the atom ic motion, in particular in the low-frequency range at the boson peak.

A fier this introduction, the paper describes an extension of the incoherent approxim ation for the evaluation of coherent inelastic neutron or x-ray data in Section II. Section III presents the tim e-of- ight experiments in silica and germania, their multiple-scattering correction and their normalization to di raction data from the literature. Section IV applies the new method to the data. The discussion of the results and a short sum mary is given in Sections V and VI.

# II. EXTENDING THE INCOHERENT APPROXIMATION

# A. De nitions

The following derivation is formulated in terms of the classical scattering law S (Q;!), where the frequency ! is related to the energy transfer E of the scattering process by E = h! and Q is the momentum transfer. This classical S (Q;!) can be calculated from the measured double di erential cross section

taking ! to be positive in energy gain of the scattered particle, neutron or x-ray photon. Here T is the tem perature,  $k_i$  and  $k_f$  are the wavevector values of incoming and scattered waves, respectively, N is the number of atom s in the beam, is the average scattering cross section of the atom s and is the solid angle. Note that the average scattering cross section is Q-dependent for x-rays; this Q-dependence is determ ined by the atom ic form factors. The de nition of S (Q;!) requires a com – pletely isotropic glass, the usual case. It is also valid for glasses with m ore than one kind of atom, like silica and germ ania.

The above de nition makes no distinction between coherent scattering (the case where the waves scattered from di erent atom s interfere) and incoherent scattering (the case where there is no interference). X-ray scattering is purely coherent; for neutrons, it depends on the nuclei of the scattering atom s. In silicon, germ anium and oxygen atom s, the coherent scattering dom inates. Integrating over all frequencies one obtains S (Q)

If all atoms of the sample scatter only incoherently, S (Q) = 1. If one has only coherent scattering, S (Q)shows a rst sharp di raction peak at about 1.5A, followed by oscillations around 1 which die out at high Q. These peaks relect the short range order of the glass on the atom ic scale. Below the rst sharp di raction peak, S (Q) is due to long-range density and concentration uctuations. Silica and germ ania show a pronounced rst sharp di raction peak.

For the evaluation of coherent scatterers, we will need the de nition of a hypothetical incoherent scattering function  $S_{inc}(Q;!)$ . This is de ned as the scattering function which one would have without interference between di erent atom s, keeping their total cross sections.

#### B. The incoherent approxim ation

To determ ine a vibrational density of states from scattering data, one needs to take the D ebye-W aller factor and the multiphonon scattering into account. An elegant way to do this is to use the interm ediate scattering function

with the back transform

The incoherent approximation assumes that one can describe the scattering function, eq. (1), in terms of an average atom which scatters only incoherently. The tim e-dependent displacement of this average atom from its equilibrium position is assumed to have a Gaussian distribution. From the Bloch identity<sup>1</sup>, one obtains the interm ediate scattering function

where  $\ \ \, (t)$  is the time-dependent mean square displacement of the average atom .

If there are only vibrations, (t) is determined by the vibrational density of states g(!). Their relation can be derived from the one-phonon approximation for the inelastic scattering from our classical isotropic incoherent scatterer<sup>1</sup>

where  $e^{2W}$  is the Debye-W aller factor and  $\overline{M}$  is the average atom ic m ass. C om paring the initial  $Q^2$  rise and using the Fourier transform ation, eq. (3), one nds

Here  $!_{m ax}$  is the upper frequency boundary of the vibrational density of states.

The incoherent scattering is obtained from the Fourier transform of the interm ediate scattering function in time

In this approximation, one accounts not only for the onephonon scattering, but the entire inelastic scattering including the multiphonon term s.

To apply the approximation to measured data, one begins by calculating a st guess to the vibrational density of states, assuming a  $Q^2$ -or  $Q^2e^{2W}$ -dependence of the inelastic scattering. From the density of states, one gets

(t) from eq. (7) and can calculate the Q-dependence of the inelastic scattering. W ith this, one can determ ine a better density of states from the data. U sually, after a few iterations the density of states does no longer change. In the case of a glass consisting of two or m ore elements, one calls this density the generalized vibrational density of states, to emphasize that is is not the true density of states, but its re ection in the scattering, weighted by the cross sections and m asses of the atom s in the sam ple.

As we will see, the incoherent approximation works astonishingly well even for the two coherently scattering glasses silica and germ ania. But it does not provide any information on the vibrational eigenvectors. One needs an extension of the incoherent approximation to do that. Such an extension will be introduced in the following subsection.

#### C. O scillation function $S_{\pm}\left(Q\right.$

The vibrational density of states is a function of the frequency, not of the time. Therefore the extension of

the incoherent approximation must be done in the frequency domain. The vibrational eigenvectors change with changing frequency, so each frequency window has its own coherent dynamic structure factor. The interference between di erent scattering atoms does not change the overall scattering intensity, but leads to oscillations in the dependence on the momentum transfer.

To take this into account, we de ne the oscillation function S  $_{\rm 2}$  (Q ) by

where  $S_{inc}(Q; !)$  is understood to be the scattering function without interference between di erent atom s, but with unchanged total cross sections, as de ned in II.A.

Like S (Q), S! (Q) equals 1 in the incoherent case. It is an extension of S (Q) to describe the coherent oscillations of the scattering at a xed frequency !, both for elastic and inelastic scattering. Though our main interest is in the inelastic part, it is suitable to begin the discussion with the elastic part S<sub>0</sub> (Q) for ! = 0.

As S (Q) relects the pair correlation of the atom s in their instantaneous positions, the elastic oscillation function  $S_0$  (Q) relects the pair correlation of the atom s in their equilibrium positions. In a glass at low temperatures (and even at not so low temperatures), the atom ic displacements are small compared to the interatom ic distances, so  $S_0$  (Q) S (Q). Both functions show the rst sharp di raction peak at about 1.5 A followed by further peaks at higher momentum transfer. At still higher momentum transfer, the peak am plitudes diminish and the functions S (Q) and  $S_0$  (Q) approach the nal value of 1. Below the rst sharp di raction peak, at small momentum transfer,  $S_0$  (Q) mirrors the frozen density and concentration uctuations of the glass, while S (Q) mirrors both static and dynam ic ones.

The inelastic part of the oscillation function  $S_{!}(Q)$  with ! € 0 will depend on the vibrational modes at the given frequency. At small momentum transfer, it shows the Brillouin peak, the scattering from longitudinal sound waves. The interference pattern at highermomentum transfer is not only due to the positional phase factors which determ ine S(Q), but also to the scalar product of momentum transfer and atom ic displacement (see eq. (11)). Thus the inelastic part of  $S_{!}(Q)$  contains inform at higher of the eigenvectors of the vibrational modes at the frequency !.

W ith the help of the oscillation function, the incoherent approximation, eq. (8), transform s into the extended approximation

The approximation allows to t not only a density of states, but a frequency-dependent oscillation function as well. Thus, for coherent scatterers, the introduction of  $S_{\pm}(Q)$  provides not only an enormous reduction of the

deviation between incoherent approximation and experiment, but opens up the possibility to analyze the vibrational eigenvectors<sup>6,8</sup>. If this analysis is successful, one can proceed to calculate the true vibrational density of states, because then one knows the weight of a given m ode in the scattering.

In the harmonic one-phonon approximation, one can express the coherent inelastic scattering<sup>1</sup> from a given normal mode in terms of its eigenvector  $e_j$ , the equilibrium position  $r_j$  and the scattering length  $b_j$  of atom j, (j = 1:N) (the scattering length  $b_j$  is related to the coherent cross section \_ j by \_ j = 4  $b_j^2$ ). W ithin the one-phonon approximation, the oscillation function

where the angular brackets denote an average over all eigenm odes at the frequency !, together with a directional average over the m om entum transfer vector Q. The m ode norm alization factor  $F_{n\, \rm orm}$  is given by

If one is able to nd the properm ode eigenvectors, one can go beyond the determ ination of a generalized vibrational density of states, because the proper norm alization factor contains cross sections and m asses and thus allow s to determ ine the true vibrational density of states. This paper aim s at such a treatm ent for the silica and germ ania m easurem ents described in the next section.




FIG.1:  $\mathbb{N}$  4 spectrum (with standard corrections) from vitreous silica at a scattering angle of 104 degrees, showing the boson peak at both sides of the elastic line.

#### A. Sam ples and tim e-of- ight experim ent

The vitreous silica sample used for the  $\mathbb{N}$  4 experiments was a commercial grade spectrosil disk with a diameter of 50 mm and a thickness of 4.8 mm.

In the case of vitreous germ ania, appropriate am ounts of reagent-grade GeO<sub>2</sub> powder (A kirich 99.99+ %) were m elted in platinum crucibles for about 1 h at ca. 1600 C. T he hom ogeneous and bubble-free m elt was subsequently quenched in water and glassy sam ples of irregular shape were removed from the bottom of the crucible. This preparation technique results in com pletely transparent glasses. Several such pieces were arranged to m im ic the disk shape of the silica sam ple.

The neutron spectra were obtained on the therm al time-of- ight spectrom eter  $\mathbb{N}4$  at the High Flux Reactor of the Institute Laue-Langevin at Grenoble. The m easurements were done in relection geometry, with the sample disk plane inclined at 45 degrees to the incoming beam . W ith a wavelength of incoming neutrons of 1.53 A, one is able to study the momentum transfer range from 1.5 to 7 A<sup>1</sup> with an energy resolution of 1.3 m eV FW HM. Similarly, a wavelength of incoming neutrons of 2.2 A allowed to study the momentum transfer range from 1 to 4.9 A<sup>1</sup> with an energy resolution of 0.8 m eV FW HM.

The momentum transfer range of these measurements is more than a factor of two larger than the one of earlier investigations<sup>6,8</sup> with cold neutrons on the time-of-ight spectrometer IN 6. One of these earlier measurements (vitreous silica at 318 K) was included in the evaluation presented below.

The  $\mathbb{I}N 4$  m easurements were performed at temperatures between 5 and 300 K. The following evaluation, however, is restricted to the 300 K data.

#### B. Corrections

The m easured neutron counts were corrected for the empty container signal. The detector e ciency was corrected for by a m easurement of a vanadium sample (an incoherent scatterer) in the same container. The signal wasmultiplied by  $k_i = k_f$  and an angle-dependent absorption correction was calculated. These four standard corrections were done with the program INX of the Institut Laue-Langevin at G renoble. Fig. 1 shows such a corrected spectrum for silica at the highest scattering angle.

The multiple scattering correction was done assuming an angle-independent multiple scattering contribution. For silica and germ ania, where wide-angle scattering predom inates, this assumption is expected to hold.

To do the correction, one st calculates an average spectrum, weighting each detector with the sine of its scattering angle. This spectrum should be folded with itself to get the spectrum of the twice-scattering processes. However, to treat the elastic line correctly, one has to replace the elastic line by a -function in one of the two spectra which one folds. O therwise the procedure would broaden the elastic line in an unphysical way.




FIG.2: Inelastic signal from 1 to 5 meV for germ ania at 300 K, incoming wavelength 2.2 A, with and without multiple scattering correction.

The question how much of the resulting twicescattering spectrum one should subtract is answered by looking at the momentum transfer dependence in the inelastic part of the spectrum . On a normalized scale, one subtracts a fraction  $s_{m\,u}$ , chosen in such a way that the inelastic intensity extrapolates to zero towards zero momentum transfer. As an example, Fig. 2 shows corrected (with  $s_{m\,u} = 0.1$ ) and uncorrected data for germania at 300 K between 1 and 5 m eV, measured with incoming neutrons of a wavelength of 2.2 A.

The procedure is not exact, because the coherent inelastic scattering at small m om entum transfer is not exactly zero. If the velocity of the incoming neutrons exceeds the longitudinal sound velocity of the glass (the kinematic condition<sup>1</sup> for the visibility of the Brillouin line), one sees the Brillouin scattering. But even if it does not (as in the measurements reported here), there is still a small nonzero coherent inelastic scattering contribution. This, how ever, is small compared to the multiple scattering<sup>11,12</sup>.

# C . Norm alization to S (Q)

In principle, if one does all corrections properly, one should be able to norm alize the m easurem ent to the vanadium signal. In practice, it is easier and m ore accurate to norm alize the tim e-of- ight data of a glass to the S (Q) of a di raction m easurem ent. For vitreous silica, there are two such di raction m easurem ents in the literature<sup>13,14</sup>. They agree very well with each other. For germ ania, there is only one di raction m easurem ent<sup>5</sup>.

To determ ine S (Q) from a time-of-ight dataset, one

integrates the scattering over the time channels of a single detector or a detector group, correcting for the changes in momentum transfer as the energy transfer changes. Here, we corrected with the factor  $Q_{el}^2 = Q^2$ , where  $Q_{el}$  is the momentum transfer at the elastic line and Q is the one at nite energy transfer. The procedure is not exact, but it has the advantage that a bad detector does not corrupt its neighbors.

Fig. 3 (a) shows the result of this norm alization to S(Q) for the two IN 4 m easurements on vitreous silica at room temperature. Also included is an earlier IN 6 m easurement<sup>8</sup>, done with incoming neutrons of a wavelength 4.1 A at 318 K.






FIG.3: (a) Norm alization of IN 4 data at 2.2 A and 1.5 A to the S (Q) of vitreous silica<sup>13,14</sup> (continuous line). An earlier IN 6 m easurem ent<sup>8</sup> at 4.1 A is also included (b) Norm alization of IN 4 data at 2.2 A and 1.5 A to the S (Q) of vitreous germ ania<sup>15</sup> (continuous line).

The same norm alization of the two  $\mathbb{IN} 4$  room tem perature measurements of vitreous germania to di raction data from this substance<sup>15</sup> is shown in Fig. 3 (b). The 1.5 A measurement su ers from problems with the subtraction of the empty container; it consisted of pure aluminum with large crystalline grains.

The comparison to Fig. 3 (a) shows that the second and the third peak in S (Q) shift to lower momentum transfer in germ ania. This is caused by the increased G e-O distance (1.73 A) in germ ania<sup>15</sup> as compared to the SiO distance of 1.6 A in silica<sup>13</sup>. The corner-connected G eO<sub>4</sub>-tetrahedra in germ ania are larger than the SiO<sub>4</sub> ones in silica. Nevertheless, the position of the rst sharp di raction peak is more or less the same in both substances, which shows that the packing of the tetrahedra must be di erent.

The norm alization allows to compare di erent measurements in the same frequency window. Fig. 4 (a) shows the boson peak frequency window from 2 to 6 m eV in vitreous silica for all three sets of data. O ne sees pronounced oscillations around the dashed line (calculated from the incoherent approximation as explained in Section IIIA).G erm ania shows rather sim ilar oscillations in the same window in Fig. 4 (b) (its boson peak is also at

 $4\ {\rm m}\ {\rm eV}$  ). The task of the next section is to extract the inform ation content in these oscillations.




FIG. 5: The developm ent of the inelastic dynam ic structure factor of vitreous silica above the boson peak. The dashed line is the incoherent approxim ation discussed in Section IIIA, the continuous line the extension to coherent scattering in terms s of eq. (15). (a) Energy transfer from 10 to 15 m eV (b) Energy transfer from 20 to 30 m eV (c) Energy transfer from 40 to 60 m eV.

As one goes up in energy transfer, the amplitude of the oscillations decreases gradually. This development is shown for vitreous silica in Fig. 5 (a-c). Above 40 meV, one nds the incoherent approximation to be valid within the experimental error. In vitreous germania, the incoherent approximation is reached even faster, around 30 meV. In both cases, there is no discernible peak shift; within experimental error, the peaks merely fade away with increasing energy transfer.


# IV. EVALUATION

#### A. Incoherent approxim ation

H aving data corrected for multiple scattering and norm alized to S (Q), one can proceed to apply the incoherent approximation described in Section IIB. In this way, one determ ines a generalized vibrational density of states g(E) (we replace the frequency ! by the energy transfer E = h! in this section) without any adaptable parameter.

In both cases, silica and germ ania, the procedure described in section IIB converged to a nalgeneralized vibrational density of states after three iteration steps.

As it turns out, the three results for g(E) of vitreous silica agree fairly wellw ith each other. The boson peak in  $g(E) = E^2$  is slightly lower in the 2.2 A measurement, but this is not due to the oscillations of the inelastic dynamic structure factor. Looking at Fig. 4 (a), one sees that the norm alized intensity itself is slightly lower than in the



two other measurements.

The same good agreement was found for the vibrational densities of states of germania calculated for the IN 4 m easurements at 1.5 and 2.2 A.

# B. Analysis of the inelastic dynam ic structure factor

As the following analysis shows, we have at present no perfect eigenmode t of the dynamic structure factor at the boson peak. Therefore we do the analysis in two steps. We rst t the oscillation function  $S_{oson}$  (Q) at the boson peak in a purely empirical way with ve lorentzians, independent of any motionalm odel, but providing an excellent t. This tform is used to investigate the frequency dependence of the peaks in  $S_{\perp}$  (Q) to higher frequencies. The second step models the atom ic motion at the boson peak in term s of a sum of translation and rotation of undistorted tetrahedra. In this procedure, one has only one t parameter (the translational fraction of the motion). One gets a reasonable rather than a perfect t, but one has a motional model which allows to calculate the true rather than the generalized vibrational density of states.

To go beyond the incoherent approxim ation, we start

by calculating the oscillation function  $S_{\pm}$  (Q ) at the boson peak via

taking (t) from the evaluation in terms of the incoherent approximation described in the previous subsection.  $S_{boson}(Q;!)$  is determined from the measured S(Q;!) via

where  $h!_{m in} = 2 \text{ meV}$  was chosen to exclude any contribution of the elastic line even for the 1.53 A m easurem ent and  $h!_{m ax} = 6 \text{ meV}$  is a frequency well above the two boson peak frequencies of 4 m eV and 3.6 m eV for silica and germ ania, respectively. Fig. 6 (a) shows the result for the three sets of data of silica, Fig. 6 (b) for the two IN 4 m easurem ents of germ ania.

The next step is to quantify the fading-away of the oscillations with increasing frequency. For this, we need a functional expression for  $S_{boson}$  (Q). To get it, we t the data points of Fig. 6 (a) in terms of a sum of ve lorentzians (the continuous line in Fig. 6 (a)). This purely empirical function oscillates around 1 in the



energy transfer E (meV)

m om entum transfer region of the three m easurem ents. O ne can use it to replace the incoherent approximation  $S_{boson}$  (Q) = 1. Fig. 4 (a) shows that it gives a much better agreement with experiment than the incoherent approximation, at least in the frequency region of the boson peak.

As one goes up in frequency, the oscillations of the m easured dynam ic structure factor begin to get weaker, until one reaches again the incoherent approximation at about 40 m eV (see Figs. 5(a) to (c)). One can follow this behaviour quantitatively by thing the inelastic intensities in subsequent frequency windows in terms of the oscillation function

where  $S_{boson}(Q)$  is the ve-lorentzian t of Fig. 4 and  $r_{in\,coh}(E)$  is the energy-dependent fraction of incoherent scattering, going from 0 to 1 as one goes from the boson peak up to higher frequencies (Fig. 7 (a)). Fig. 5 shows that one obtains a good t of the m easurements in this way. So within experimental accuracy, the peaks in the coherent inelastic dynamic structure factor of silica do not shift; they merely fade away to make room for a full validity of the incoherent approximation above 40 meV.

It is interesting to note that this crossover into a validity of the incoherent approxim ation occurs at the D ebye frequency  $!_D$  of vitreous silica. D ebye's strongly oversimpli ed picture describes the whole vibrational density of states in terms of sound waves. The total density of sound waves (norm alized to 1) is




FIG.8: Coupled libration of vecomer-connected SiO  $_4-$  or GeO  $_4-$  tetrahedra  $^6$  .



Here is the density,  $v_1$  is the longitudinal sound velocity and  $v_t$  is the transverse sound velocity. Table I gives the values for vitreous silica and germ ania.

In germ ania, the oscillations of the inelastic dynamic structure factor fade even more quickly with increasing frequency than in silica (Fig. 7 (b)). Again, the validity of the incoherent approximation is reached at about the D ebye frequency.

Having established the frequency dependence of the dynam ic structure factor in both glasses, we proceed to the second step, the understanding of the oscillation function  $S_{boson}$  (Q) at the boson peak in terms of a detailed picture of the atom ic motion.

To nd such an understanding, let us nst recall what one knows about this frequency region, both from the quartz crystal<sup>16,17</sup> and from the silica glass neutron<sup>6,8</sup> and H yperram an<sup>18</sup> studies. One expects a mixture of long-wavelength sound waves and SiD<sub>4</sub>-tetrahedra libration. The oscillation function of the translationalm otion of long-wavelength sound waves<sup>19</sup> is S (Q). The oscillation function S<sub>rot</sub> (Q) of the coupled tetrahedra libration was calculated from the motionalm odel of F ig. 8, using eq. (11) for S<sub>1</sub> (Q) in the one-phonon approximation.



strong second peak a large tetrahedra libration fraction. Fig. 6 (a) shows the best t (continuous line) of the observed  $S_{boson}$  (Q) of silica in terms of a sum of the two oscillation functions. The t is by no means perfect, but supplies a fraction of 0.55 of tetrahedra libration signal

and 0.45 of translation.

a large sound wave fraction in the boson peak modes, a

This is a surprising result. If one estimates the strength of the translational signal on the basis of the Debye sound-wave treatment, one would expect nomore than a translational fraction of 0.2 at the boson peak<sup>6,8</sup>. Sim ilarly, the Hyperram an data<sup>18</sup> require a dominating role of the tetrahedra libration for their understanding. But obviously, the librationalmotion of the corner-connected tetrahedra is accompanied by strong translational shifts.

A similar e ect appears in germania. The t in terms of a sum of the S (Q) of germania and the tetrahedra libration (the line in Fig. 6 (b)) gives an even larger fraction of 0.75 for S (Q). As we will see, the Debye expectation in germania is again a factor of two smaller. We will come back to this point in the discussion.




FIG. 9: Comparison of the translation oscillation function S (Q) (continuous line) with the oscillation function  $S_{\rm rot}$  (Q) (dashed line) of the coupled libration of vecomer-connected SiD<sub>4</sub>-tetrahedra<sup>6</sup> of Fig. 8.

# C . V ibrational density of states in the extended approxim ation

If one knows what kind of vibrationalm odes one deals with, one can calculate the vibrational density of states in the extended approximation, accounting for the cross sections and am plitudes of the atom sparticipating in the modes.

For vitreous silica, we take the signal at the boson peak to consist of 55 % of tetrahedra libration signal and 45 % of S (Q), the result of the best t of the data in Fig. 6 (a). Since the tetrahedra libration is essentially oxygen m otion, we have to correct the num ber of resulting m odes dividing by the enhancement factor for a pure oxygen m otion

where  $_{\circ}$  is the oxygen cross section and M  $_{\circ}$  is the oxygen m ass. and  $\overline{M}$  are the average values of cross section and m ass as de ned in Section II.

The increasing incoherent fraction  $r_{\text{in}\,\text{coh}}$  of  $S_{\,\text{dyn}}$  (Q) in eq. (15) is taken to be an average motion of all atoms, which requires no enhancement factor.

W ith these assumptions, one can determ ine a vibrational density of states from the data using the extended approximation, eq. (10).  $S_{boson}(Q)$  is calculated from the sum of 45 % of S (Q) and 55 % of the tetrahedra libration oscillation function  $S_{rot}(Q)$  of the model in Fig. 8.  $S_{!}(Q)$  is evaluated from eq. (15), taking  $r_{in\,coh}$  to follow the line in Fig. 7.

Fig. 10 (a) shows the vibrational density of states of vitreous silica obtained in this way for the three sets of data, plotted as  $g(E) = E^2$  to emphasize the boson peak at 4 m eV.

For vitreous germ ania, we take the signal at the boson peak to consist of 25 % of tetrahedra libration signal and 75 % of S (Q). A gain, we have to correct the num ber of resulting m odes dividing by the enhancem ent factor for a pure oxygen m otion

The resulting vibrational density of states  $g(E) = E^2$  is shown in Fig. 10 (b).

# V. DISCUSSION

# A. Potential and lim itations of the m ethod

Let us begin the general discussion with a disclaim er: The evaluation method for coherent inelastic neutron or x-ray scattering from glasses proposed in the present paper, which we denote by "extended approximation", is by no means new. Its beginnings can be traced back to the classical paper of C arpenter and Pelizzarri<sup>19</sup> (and even beyond that). In a less form al way, it has been applied earlier, not only to vitreous silica<sup>6,8</sup>, but also to am orphous germ anium <sup>20</sup>, deuterated polybutadiene<sup>21</sup> and boron trioxyde<sup>22</sup>. Our present work m erely form alizes this extended approximation, introducing the concept of the oscillation function S<sub>1</sub> (Q) and giving a recipe for its experimental determination.

The oscillation function  $S_{\perp}(Q)$  contains inform ation on the eigenvector of the vibrational or relaxational modes seen at the frequency !. The inform ation is limited: Even if one knows  $S_{\perp}(Q)$  with high accuracy over a large Q - range, one cannot determ ine the eigenvectors at that frequency. One can only check models of the motion against the measured  $S_{\perp}(Q)$ . In a practical sense, even such a check is restricted to the use of the one-phonon approximation of eq. (11), because it is di cult to calculate the interference oscillations of the coherent multiphonon scattering. Fortunately, the one-phonon approximation holds to rather large momentum transfer at the boson peak, the most interesting target for these studies.

At the boson peak, the analysis is simplied by the scientic question: one wants to know (i) whether the longwavelength sound waves at the boson peak frequency still follow the D ebye expectation (ii) whether there are additional modes, and if there are, what their eigenvector is. The rst of these questions can be attacked, using the fact<sup>19</sup> that the oscillation function  $S_1(Q)$ ) S(Q) for long-wavelength sound waves, no matter whether they are transverse or longitudinal. The second requires a model calculation for whatever mode is expected to be soft in the given system. In our cases silica and germ ania, one expects the coupled libration of corner-connected tetrahedra to be soft, because this is the soft mode of the phase transform ation from to in crystalline quartz<sup>16</sup>.

N ote that this rather stream lined procedure has weak points: (1) since the sound waves interact with the additional modes<sup>23,24</sup>, one needs the S<sub>1</sub> (Q) of the resulting true eigenmodes, in which translation and soft mode eigenvector parts have a nonzero interference term. Therefore their S<sub>1</sub> (Q) might be di erent from a simple sum of the two oscillation functions. (2) At the boson peak, measurements of incoherent scatterers<sup>25,26</sup> reveal sizeable nongaussianity elects. These will tend to distort the experimental S<sub>1</sub> (Q), determined on the basis of the G aussian approximation.

In view of these points, it is not surprising that the agreem ent between the model calculation and the data in F ig. 6 (a) and (b) is not perfect. Nevertheless, the comparison with heat capacity data in the next subsection shows the reliability of the resulting vibrational density of states.

The extended approximation should be particularly useful for the evaluation of wide-angle inelastic x-ray scattering data. Such measurements have been reported<sup>27,28</sup>, but have not been evaluated on a quantitative level. W ith the recipe given here, one could do a quantitative evaluation, provided one has good x-ray di raction measurements. In that case, one even could

do only constant-Q scans (sim pler to measure than the constant-E scans of the two references  $2^{7,28}$ ), relating their intensities by the di raction measurem ent.

# B. Comparison to heat capacity

We want to check the vibrational density of states obtained in the previous section from the extended approximation against earlier results in the literature. The

rst check is against heat capacity data from silica<sup>6</sup> and germ ania<sup>29</sup> between 1 and 20 K. If one plots the heat capacity  $C_p$  as  $C_p=T^3$ , one gets a close correspondence to the plot of g(E)=E<sup>2</sup>, showing the boson peak of silica and germ ania at about 10 K.

In this com parison, the mode eigenvector assignment at the boson peak is checked, because the assumed fraction of tetrahedra libration provides the correction to the number of vibrationalmodes.

Fig. 11 (a) compares measured heat capacity data<sup>6</sup> of vitreous silica to the result of the evaluation of the neutron data in the extended approximation, described in the preceding section. We chose the results from the measurement at 4.1 A, because the heat capacity measurements<sup>6</sup> stem from the same sample. As it turns out, the correction of the enhancement factor of eq. (18) is essential to get good agreement. So the comparison




FIG. 11: Comparison of the heat capacity calculated from the neutron data with and without correction for the enhancement factor of the tetrahedra librational modes (the one without correction is close to the result from the incoherent approximation) to measured data (a) of vitreous silica<sup>6</sup> (b) of vitreous germania<sup>29</sup>.

corroborates the assignment of 55 % pure oxygen signal and 45 % translational signal at the boson peak in vitreous silica.

Sim ilarly, Fig. 11 (b) shows good agreem ent between m easured<sup>29</sup> and calculated heat capacity data in vitreous germ ania. Here, we compare to the 2.2 A m easurement, because it has the better resolution. Again, the correction improves the agreement. However, in this second case the correction is smaller, because according to the t of the m easured dynamic structure factor of Fig. 6 (b) we have only 25 % tetrahedra libration at the boson peak. Again, this conclusion is supported by the heat capacity data.

## C. Comparison to simulation

There is a large number of m olecular-dynamics sim – ulations of vitreous silica in the literature<sup>30,31,32</sup>, most of them done with e ective classical force elds like the BKS potential<sup>23</sup>. The BKS potential reproduces the m easured S (Q), but a recent comparison to an ab initio calculation<sup>34</sup> shows that it fails not only to reproduce the vibrational density of states, but also the m ode eigenvectors.




FIG.12: V ibrational density of states of vitreous silica from an ab initio simulation<sup>34</sup>, from earlier neutron work<sup>7</sup> with 0.6 A and from the present evaluation of the 4.1 A data.

Fig. 12 com pares the vibrational density of states determ ined from the neutron measurement at 4.1 A in the extended approximation with the ab initio calculation<sup>34</sup> and with an earlier neutron determination with very short wavelength at the spallation source at Argonne<sup>7</sup>. Note that the two neutron determinations are com – plementary: the spallation source measurement su ers from an overcorrection at low frequencies, but provides a true picture of the high-frequency density of states. In contrast, the cold neutron measurement is unable to measure above 100 meV, but provides good results at low frequency, as shown by the comparison to the low – temperature heat capacity data in the previous subsec-

tion. B etween 20 and 100 m eV, the two sets of data agree reasonably well with each other.

Note that the ab initio simulation is unable to describe the boson peak region below 10 m eV. Above that region, there is impressive agreement between simulation and neutron experiment. But below 10 m eV, the simulated modes fail to come down to the low frequencies where both neutrons and heat capacity report them to exist. The reason might be either the small size of the simulation cell or its poor equilibration, natural disadvantages of an ab initio simulation.

It is interesting to compare our results to a simulation<sup>24</sup> of dynamic structure factors of a di erent system, soft spheres interacting with a repulsive  $1/r^6$  potential, a model appropriate for metallic glasses. In this case, the oscillation function at the boson peak shows only the peaks of S (Q). The additional modes seem to be a motion along a chain of nearest atom ic neighbors, with an oscillation function which resembles S (Q). This is obviously di erent in silica and germ ania, where the resonant boson peak modes seem to have a distinct tetrahedra rotation component.

# ${\tt D}$ . Sound waves at and above the boson peak

The preceding two subsections demonstrated the ability of the extended approximation to determ ine a reliable vibrational density of states, in particular in the frequency region of the boson peak. This good agreement supports the interpretation of the boson peak modes as a mixture between long-wavelength sound waves and soft modes, in the cases of silica and germania librational modes of cormer-connected tetrahedra.

But the sound-wave fraction determ ined from the dynam ic structure factor is decidedly higher than the expectation on the basis of the sound-wave D ebye m odel. Looking at the boson peak region between 2 and 6 m eV in Fig. 10 (a) and (b) and the dashed line of the D ebye expectation, one would expect no m ore than 20 % sound waves in silica and no m ore than 40 % in germ ania. The t of  $S_{boson}$  (Q) gives about twice as much in both substances. This nding goes beyond earlier cold-neutron work<sup>6,8</sup>, which could not quantify the sound wave fraction at the boson peak.

The e ect is apparently not limited to silica and germania. Earlier decompositions of S (Q;!) at the boson peak window into a Q<sup>2</sup>-and a Q<sup>2</sup>S (Q)-part in deuterated polybutadiene<sup>21</sup> and in vitreous B<sub>2</sub>O<sub>3</sub><sup>22</sup> also observed a larger Q<sup>2</sup>S (Q)-part than expected on the basis of the D ebye m odel.

If the Q<sup>2</sup>S (Q) part is only due to sound waves, this in – plies a dow nw and shift in frequency of the sound wave intensity above the boson peak. For the longitudinal sound waves, such a dow nw and shift, together with a strong broadening, is in fact observed experimentally in x-ray B rillouin scattering<sup>35</sup>. The broadening and the shift increase with the square of the phonon wavevector, i.e. with the square of the nom inal frequency of the phonon.

There is general agreement that the downward shift is not due to a dispersion of the sound velocity, but rather to sound wave scattering. One nds no evidence for any dispersion of either the longitudinal or the transverse sound velocity in tunneling diode<sup>36</sup> or ballistic phononpulse<sup>37</sup> experiments in vitreous silica and other glasses.

Also, there seems to be general agreement that the broadening of the sound waves observed in x-ray Brillouin scattering is not due to a true anharm onic damping of the sound waves, but rather to a deviation of the true eigenvectors from a purely sinusoidal displacement in  $space^{31}$ .

On the other hand, there is a hot debate on the proper description of the x-ray Brillouin data, whether one should use a dam ped harm onic oscillator<sup>35</sup> (DHO) or whether one should take another form <sup>38</sup> which brings no intensity down to the frequency zero. But both form s shift the intensity down to lower frequencies, consistent with our observation of a heightened Q<sup>2</sup>S (Q)-com ponent at the boson peak (heightened with respect to undam ped D ebye phonons).

The low-temperature plateau in the thermal conductivity<sup>4</sup> and the phonon-pulse experiments<sup>37</sup> suggest that the transverse phonons have essentially the same fate as the one observed for the longitudinal phonons in x-ray B rillouin scattering<sup>35,38</sup>.

To test these ideas, we submitted a Debye density of states with a Debye frequency corresponding to an energy




FIG.13: Experim ental density of states, plotted as  $g(E) = E^2$  as in Fig. 10, compared to the simple D ebye expectation (dashed line) and to D ebye sound waves with D H O damping as explained in the text (continuous line) for (a) vitreous silica (b) vitreous germ ania.

transfer of 42 m eV (the value for silica) to a D H O dam ping with the param eters of B enassi et  $a1^{35}$ . The transverse phonons were assumed to have the same dam ping as the longitudinal ones at the same frequency, increasing proportional to the square of the phonon wavevector. The resulting e ective D ebye density of states is shown as the continuous line in Fig. 13 (a). To do the same calculation for germ ania, shown in Fig. 13 (b), we used recent neutron B rillouin m easurem ents<sup>39</sup>. A coording to them, the strong dam ping condition = viq (q phonon wavevector) is reached at the energy transfer 19.3 m eV, a bit less than three quarters of the D ebye frequency. From B enassiet  $a1^{35}$ , the same condition is reached in vitreous silica already at 12 m eV, at about only one quarter of the D ebye frequency.

Fig. 13 shows that the scattering of the sound waves is strong enough to have a non-negligible e ect on their spectral appearance in a scattering experiment. But it also shows that one cannot explain the boson peak in term s of the sound wave scattering alone. This does not depend on the choice of the DHO. If one takes the alternative proposed by the M ontpellier group<sup>38</sup>, one does indeed get a peak, because this alternative shifts the intensity to a nite frequency, not to the frequency zero. But the intensity of the peak remains too small. W hat one really needs is a mechanism which raises the total vibrationalm ean-square displacem ent by nearly a factor of two over the Debye expectation, a mechanism which brings vibrations from higher frequencies down to the boson peak. In vitreous silica and vitreous germ ania, one has the additional advantage that one can identify these additional vibrations by their dynam ic structure factor.

# VI. SUMMARY

W e introduce a form altreatm ent of the coherent inelastic neutron or x-ray wide-angle scattering from glasses, which takes the interference oscillations explicitly into account. This "extended approximation" is an extension of the incoherent approximation. It allows to tanew ly de ned "oscillation function" S<sub>1</sub> (Q) at each frequency !, thus supplying information on the vibrational eigenvectors. The method should be particularly useful for the quantitative evaluation of wide-angle inelastic x-ray scattering measurements.

The application of the method to new roomtemperature thermal neutron time-of- ight measurements of silica and germania not only provides a vibrational density of states in excellent agreement with heat capacity and simulation data, but also allows to quantify for the rst time the ratio of tetrahedra rotation and tetrahedra translation at the boson peak. One nds about twice as much translation as in a simple Debye expectation. This excess is probably connected to the heavy damping of the sound waves at frequencies above the boson peak, observed by x-ray B rillouin scattering.
