Penetration depth, sym m etry breaking, and gap nodes in superconducting PrO s₄Sb₁₂

Transverse- eld m uon spin relaxation rates in single crystals of the heavy-ferm ion superconductor PrOs₄Sb₁₂ (T_c = 1.85 K) are nearly constant in the vortex state for temperatures below $0.5T_c$. This suggests that the superconducting penetration depth (T) is temperature-independent at low temperatures, consistent with a gapped quasiparticle excitation spectrum. In contrast, radiofrequency m easurements yield a stronger temperature dependence of (T), indicative of point nodes in the gap. A similar discrepancy exists in superconducting Sr₂R uO₄ which, like PrOs₄Sb₁₂, breaks tim e-reversal symmetry (TRS) below T_c, but not in a num ber of non-TRS-breaking superconductors.

P hase transitions are always symmetry breaking; the symmetry of the ordered state is less than the full symmetry of the H am iltonian. In all superconductors gauge symmetry is broken and the ground-state wave function acquires a de nite phase. A dditional symmetries are simmultaneously broken in so-called unconventional superconductors. Examples include the point-group symmetry of the lattice, spin rotation symmetry, and time-reversal symmetry (TRS) [1, 2]. TRS is always broken in magnetic transitions but rarely in superconductors. P robably the most direct evidence for TRS breaking is the onset of a spontaneous local magnetic eld in zero applied eld below the superconducting transition temperature T_c ; the local eld reverses its direction under time reversal and thus signals broken TRS.

M uon spin rotation/relaxation (SR) experiments have proved invaluable in characterizing the superconducting state [3]. In the SR technique [4] spin-polarized positive m uons (⁺) are implanted in the sample and precess in the local magnetic eld. This precession is detected using the asymmetry of the ⁺ beta decay (the decay positron is emitted preferentially in the direction of the ⁺ spin). The distribution of ⁺ precession frequencies directly re ects the distribution of magnetic elds in the sample. Reproducible SR evidence for a TRSbreaking local eld has been found in only three superconductors: the heavy-ferm ion system (U,Th)Be₁₃ [5], the transition-m etaloxide Sr₂RuO 4 [6], and the Pr-based heavy-ferm ion com pound PrO s₄Sb₁₂ [7].

TRS breaking in a superconductor may (but need not) be accompanied by breaking of other symmetries [1].

The most accessible consequence of additional symmetry breaking is the presence of point or line nodes (k) = 0 in the superconducting energy gap function (k) on the Ferm i surface. Them all excitations of low -lying states are strongly modiled by gap nodes, and these excitations govern superconducting properties at low tem peratures. The tem perature dependence of the superconducting penetration depth , in particular, depends on details of the gap structure [1, 2]: for a nodeless superconductor

(T) = (T) $(0) / e^{=T}$, which is small at low temperatures, whereas with gap nodes $/ T^n$, n 2, for at least some eld orientations.

PrO s_4 Sb₁₂ is a superconductor ($T_c = 1.85$ K [8]) with a number of extraordinary properties [9]. It is the only known Pr-based heavy-ferm ion superconductor, the Pr³⁺ ground state is nonm agnetic, a novel ordered phase appears at high elds and low tem peratures, there are multiple superconducting phases, and TRS is broken in the superconducting state [7]. Previous SR measurements of in the vortex state of a pow dered sam ple [10] found evidence for a BCS-like activated dependence at low tem peratures, suggesting the absence of gap nodes. But radiofrequency (rf) inductive measurements of the surface penetration depth [11] indicate point nodes in the gap, in disagreement with the SR results.

This Letter reports new SR experiments on oriented $PrOs_4Sb_{12}$ crystals, and compares SR and surface penetration-depth m easurements in $PrOs_4Sb_{12}$ and a number of other superconductors. The discrepancy between these measurements noted above is found in TRS-breaking superconductors but not otherwise, and is therefore correlated with TRS breaking.

In the vortex lattice of a type-II superconductor each vortex possesses a norm al-state-like core surrounded by a shielding supercurrent. These supercurrents give rise to an inhom ogeneous magnetic eld that is periodic in the vortex lattice. The vortex-lattice eld distribution $P_v(B)$ is related to . For a xed density of vortices the rm s width B of $P_v(B)$ decreases with increasing ; in a London superconductor (much longer than the coherence length) B / $1=^2$ when the applied eld H satis es H _{c1} H H _{c2} [12]. Transverse- eld SR (TF-SR) experiments (eld applied transverse to the ⁺ spin) are sensitive probes of this eld distribution [3].

Time-di erential TF - SR experiments were carried out at the M 15 channel at T R IUM F, Vancouver, C anada, on a mosaic of oriented PrOs4Sb12 crystals. The crystals were mounted on a thin GaAs backing, which rapidly depolarizes m uons in transverse eld and m in im izes any spurious signal from muons that do not stop in the SR asymmetry data were taken for temsample. peratures in the range $0.02\{2.5 \text{ K} \text{ and } _{0}\text{H} \text{ between}$ 10 m T and 100 m T applied parallel to the h100i axes of the crystals. The data were tted with the functional form G (t) cos(! t+), where the frequency ! and phase describe the average + precession and the relaxation function G (t) describes the loss of phase coherence due to the distribution of precession frequencies [13]. The relaxation rate associated with G (t) is a measure of the width of this distribution and hence of B [3].

N either of the commonly-used exponential or G aussian functional forms accurately t the asymmetry data in the normal state, due to + coupling to both nuclear and Pr³⁺ spins as discussed below. D ata from both the normal and the superconducting states are well t, how-ever, by either of two slightly more complex functional forms: the \power exponential"

These functions are both phenom enological and have no theoretical motivation. We shall see that the superconducting-state properties obtained from these ts are sim ilar for both functions, which indicates insensitivity to details of the tting function and justi es a posteriori these otherwise arbitrary choices.

Figure 1 (a) shows the tem perature dependence of the relaxation rate and exponent K from power-exponential ts for $_0H = 10 \text{ m T}$ and 100 m T. The relaxation is interm ediate between exponential and G aussian (1 . K < 2). The tem perature dependence of K below T_c indicates that the shape of G (t) is changing with tem – perature, but for tem peratures lower than about 1 K and K are nearly constant for $_0H = 10 \text{ m T}$.




FIG.1: Relaxation rates from TF-SR asymmetry data in PrOs₄Sb₁₂ for applied elds $_0H = 10 \text{ mT}$ (circles) and 100 mT (triangles). (a) Relaxation rates (open symbols) and exponents K (lled symbols) from power-exponential ts [Eq.(1)]. Note that and K have di erent dimensions; they are plotted on the same graph only for convenience. (b) G aussian relaxation rates from damped G aussian ts [Eq.(2)]. The exponential rates have been xed to the norm al-state values [N (10 m T) = 0:095 s¹, W (100 m T) = 0:428 s¹].

Figure 1 (b) gives the temperature dependence of the G aussian rate from damped-G aussian ts. Below T_c the exponential rate W [Eq. (2)] was held xed at the norm al-state value for each eld, so that the temperature dependence of the G aussian rate re ects the e ect of the superconducting state. Som e such procedure is necessitated by the strong statistical correlation between W and in Eq. (2); the time constant and the shape of the function are in uenced by both of these parameters, so that correlations between them can result from small system atic errors. The principal justic cation for this ad hoc

xing of W is the insensitivity of the superconductingstate results to details of the tting function noted above. Statistical correlation is less of a problem in power exponential ts, where and K control the rate and shape, respectively, and are not as strongly correlated.

For damped-G aussian ts the norm al-state G aussian rate is independent of eld [cf. Fig. 1(b)] and of m agnitude consistent with nuclear dipolar broadening. The exponential rate increases with eld and is due to inhom ogeneity in the Pr^{3+} m agnetization. D eterm ination of the vortex-state eld distribution width requires correction for the norm al-state relaxation. For the damped G aussian ts we take the superconducting-state G aussian rate s to be given by $\frac{2}{s} = \frac{2}{n}$, where n is the norm al-state rate [3]. For the power exponential ts the

proper correction procedure is somewhat less clear. We have chosen to use the relation $\frac{K}{s} = \frac{K}{n}$, which interpolates smoothly between the exponential (K = 1) and G aussian (K = 2) limits. The results are sensitive to this choice only for $_{0}H = 100 \text{ mT}$, where $_{n}$ is significant (cf. Fig. 1 (a)].




FIG.2: Tem perature dependence of superconducting-state relaxation rates in PrOs₄Sb₁₂, corrected for norm al-state relaxation (see text). (a) power exponential rates s. (b) dam ped G aussian rates s. Circles: applied eld $_0H = 10 \text{ mT}$. Squares: $_0H = 20 \text{ mT}$. Triangles: $_0H = 100 \text{ mT}$. The curves are guides to the eye.

Figure 2 gives the temperature dependence of the corrected superconducting-state $^+$ relaxation rates for $_{0}H = 10, 20, \text{ and } 100 \text{ mT}$. It can be seen that the

qualitative behavior of the rates is rem arkably independent of the t function. At 10 and 20 mT both $_{\rm s}$ and $_{\rm s}$ are nearly tem perature-independent below 1 K. At the low est tem peratures the rate is eld-independent to within a few percent between 10 mT and 100 mT. In an isotropic superconductor such as cubic PrOs_4Sb_{12} vortex-lattice disorder is expected to increase the low -

eld rate; increasing eld (increasing vortex density) then decreases the rate as intervortex interactions stabilize the lattice [3, 14]. Thus the eld independence of the rate indicates a substantially ordered vortex lattice, in which case the tem perature dependence of the rate is controlled solely by the tem perature dependence of the eld distribution P_v (B). We can also conclude that the eld dependence expected as H ! H_{c1} [15] plays no role.



Now the rm s width $_{\rm s}$ of the best-t Gaussian is not necessarily !, and replacement of ! in Eq. (4) by $_{\rm s}$ is not completely justi ed. Nevertheless $_{\rm s}$ should scale with !, and within its range of validity Eq. (4) should give the correct temperature dependence of $_{\rm SR}$. This is because under these circum stances elects of nonzero

are restricted to the high- eld tail of \mathbb{P} (B), which is not heavily weighted in a Gaussian t (cf. Fig. 1 of Ref. [16]). PrO s₄Sb₁₂ is a strongly type-II superconductor (Ginzburg-Landau = 30 [8, 10]), and this picture should be applicable.

Figure 3 (a) compares $_{surf}(T) = _{surf}(T) _{surf}(0)$, obtained from rf inductance m easurem ents in the M eissner state [11, 17], with $_{SR}(T)$ obtained using $^+$ relaxation rates for $_{0}H = 10 \text{ m T}$ (Fig. 2) in Eq. (4). At low temperatures [18] the di erence $_{surf}(T)$



 $_{\rm SR}$ (T) increases m arkedly with increasing tem perature; this is the discrepancy between the m easurements noted above. It is the same whether $_{\rm s}$ (T) [Fig. 2 (a)] or $_{\rm s}$ (T) [Fig. 2 (b)] is used in Eq. (4); the comparison does not depend on the choice of thing function. Figure 3 (b) gives $_{\rm surf}$ (T) $_{\rm SR}$ (T) for the TRSbreaking superconductor Sr₂RuO₄, using data from the literature [19, 20]. Again there is a discrepancy (as noted previously [21]), which is very similar to that in PrOs₄Sb₁₂. Sm all-angle neutron di raction experiments [22] also found a tem perature-independent vortexlattice eld distribution in SpRuO₄ at low tem peratures.

Figures 3(c){(f) give _{surf}(T) _{SR} (T) from literature data for the heavy-ferm ion com pound CeCoIn₅ [23, 24], the borocarbide YN i_2B_2C [25, 26], and the high- T_c cuprates YBa₂Cu₃O_{6:95} [27, 28] and La1:85 Sr0:15 CuO 4 [29, 30]. None of these superconductors exhibit TRS breaking, and none exhibit the temperature dependence of surf _{SR} seen in Figs. 3(a) and (b). There is a signi cant di erence $_{\rm surf}$ (T) and $_{\rm SR}$ (T) only for the TRSbetw een breaking superconductors PrOs₄Sb₁₂ and Sr₂RuO₄. This is in spite of a wide range of experimental methods and analysis techniques: in Figs. 3(a), (b), (c), and (f) surf was obtained from rfm easurements, in (d) from m agnetization, and in (e) from m icrow ave im pedance; in $_{\rm SR}$ was obtained from Eq. (4), in Figs. 3(a) and (c) (b), (e), and (f) from ts to the expected vortex-state eld distribution, and in (d) from a generalization of Eq. (4) to low and high elds [25].

The origin of this discrepancy and its relation to TRS breaking are not clear. Low - eld low tem perature phase transitions between superconducting states have been reported in both $PrOs_4Sb_{12}$ [31] and Sr_2RuO_4 [32], and m ay be involved in the discrepancy. The TRS-breaking state m ay couple to rf or m icrow ave elds, necessitating a revised interpretation of the surface m easurem ents. A mechanism of this sort, in which subgap chiral surface states a ect the surface penetration depth, has been proposed for $Sr_{2}RuO_{4}$ [33]. A T² power law is found for surface m easurem ents even though the bulk energy spectrum is gapped. The theory requires , how ever, and thus seems inapplicable to $P rO s_4 Sb_{12}$. It has also been noted [34] that surface scattering breaks pairs in an odd-parity superconductor. To our know ledge the surface penetration depth has not been calculated taking this effect into account, but pair breaking would decrease the gap and therefore increase the tem perature dependence of . The discrepancy might be related to a breakdown of the relation B (T) / $1=^2$ due to nonlinear/nonlocal e ects [3, 35], or to the spontaneous magnetic eld in the vortex state [7] (although the measured eld is not large enough to have a signi cant direct e ect on B).

 Sr_2RuO_4 and $PrOs_4Sb_{12}$ are both TRS-breaking superconductors but are otherwise very di erent. Tetragonal Sr_2RuO_4 is an anisotropic transition-m etal-oxide superconductor that is weakly type-II for H k c ($_{ab}$ = 2:3 [21]), whereas cubic $PrOs_4Sb_{12}$ is an isotropic strongly type-II heavy-ferm ion superconductor. The fact that a similar discrepancy between SR and surfacem easurements of (T) is found in such di erent materials, but not in a variety of non-TRS-breaking superconductor.
