Parity e ect and spontaneous currents in superconducting nanorings

A bstract

New physicale ects emerge from an interplay between the electron parity number and persistent currents in superconducting nanorings. An odd electron, being added to the ring, produces a countercurrent which may substantially modify the ground state properties of the system. In superconducting nanorings with an embedded normal metal layer a novel \=\n -junction" state can occur for the odd number of electrons. Changing this number from even to odd yields spontaneous supercurrent in the ground state of such rings without any externally applied magnetic ux. Further peculiar features of the parity electron transport across the weak link.

1. Introduction

It is well established both theoretically and experim entally [1{6}] that them odynam is properties of isolated superconducting system s are sensitive to the parity of the total number of electrons N despite this number may be macroscopically large. The fundamental dierence between superconductors with even and odd N is due to the fact that the number of electrons in the condensate of C coper pairs should necessarily be even. Hence, for odd N at least one electron remains unpaired having an extra energy equal to the super-

conducting gap $\,$. This di erence { hindered by the entropy factor at su ciently high tem peratures { becomes important in the low tem perature limit.

C an the supercurrent be a ected by this parity effect? Recently we have argued [7] that (a) the answer to this question is positive and (b) in superconducting nanorings interrupted by a weak link parity-restricted supercurrent can strongly deviate from one evaluated for the grand canonical ensemble. In this paper we will extend our previous analysis focusing it on superconducting rings with embedded piece of a normal metal (SNS rings). We will consider transparent nanojunctions as well as structures with low transmission of NS-interfaces. In the latter case resonant elects become

im portant leading to substantial modi cations of the physical picture of the parity e ect [7].

2. Parity projection form alism

In the subsequent analysis of parity-restricted persistent currents (PC) in superconducting nanorings we will employ the parity projection formalism [4{6].Recapitulating the key points of this approach we will closely follow Ref. [5]. We will then derive a general formula for the circulating supercurrent in isolated superconducting rings with even/odd number of electrons.

The grand canonical partition function Z (T;) = Tre $\,^{(H~N~)}$ is linked to the canonical one Z (T;N) as

Here and below H is the system Ham iltonian and 1=T. Inverting this relation and dening the canonical partition functions $Z_{\rm e}$ and $Z_{\rm o}$ respectively for even (N $N_{\rm e}$) and odd (N $N_{\rm o}$) ensembles, one gets

are the parity projected grand canonical partition functions. For N 1 it is su cient to evaluate the integral in (2) within the saddle point approximation

Let us emphasize that $_{\rm f}$ is just the standard grand canonical therm odynam ic potential and $_{\rm b}$ represents the corresponding potential linked to the auxiliary partition function Z (T; + i T). This function can be conveniently evaluated by nding the true grand canonical partition function Z (T;), expressing the result as a sum over the Ferm i M atsubara frequencies ! $_{\rm f}$ = 2 T (l+ 1=2) and then substituting the B ose M atsubara frequencies ! $_{\rm b}$ = 2 T 1 (l= 0; 1;:::) instead of ! $_{\rm f}$.

Consider now an isolated superconducting ring pierced by the magnetic ux. Making use of the above expressions one one can easily determine the equilibrium current $I_{e=0}$ circulating inside the ring:

Below we will make use of these equations in order to evaluate PC in superconducting nanorings.

3. Superconducting rings with nanojunctions

31. The m odeland general analysis

Before we turn to concrete calculations let us specify the model for our system. In what follows we will investigate PC in superconducting nanorings with cross section s and perim eter $L = 2 R \cdot Superconducting$ properties of such rings will be described within the (parity projected) mean eld BCS theory. A necessary { though not always su cient { validity condition for this mean eld approach reads N $_{
m r}$ p², s the total number of conducting channels in the ring Nr should remain large. More detailed requirements can be formulated with the aid of the results [10,11]. For generic wires QPS e ects are small provided the param eter s exceeds 10 nm [10{13]. Considering then hom ogeneous rings one can prove [7] that in such rings the e ect of the electron parity number on PC remains small in the parameter $1=N_r$ other hand, in rings with only few number of channels 1 uctuation e ects m ay entirely wipe out




Fig. 1. Superconducting ring with embedded SNS junction of length ${\bf d}$.

the supercurrent thus \mathbf{m} aking the \mathbf{m} ean eld approach obsolete.

The way out is to consider superconducting rings with N $_{\rm r}$ 1 interrupted by a weak link with only few number of conducting channels N. In such systems the mean eld BCS description remains applicable and, on the other hand, the parity elect can be large due to the condition N 1.Quantum point contacts (QPC) or, more generally, SNS junctions (of length d) can be used for practical realization of such weak links. The corresponding structure is depicted in Fig. 1.

In this case the therm odynam ic potential of the system consists of two dierent contributions [14]

In (8) we made use of the fact that the therm odynam ic potentials of the ring depend both on $_{\rm X}$ and 'only via the super uid velocity $v_{\rm S}=(1\text{=}4~{\rm m~R}\,)$ (' $2~_{\rm X}\text{=}~_0)$, in which case one can put 0=0 $_{\rm X}$ = (2e=~c) (0=0'). Here and below $_{\rm 0}$ is the superconducting ux quantum . The left-hand side of Eq. (8) represents the current owing inside the superconducting ring I $^{\rm (r)}$ = c0 $^{\rm (r)}$ 0 $_{\rm X}$ ' (ev_F N $_{\rm r}$ =L) (' $2~_{\rm X}$ = $_0$). This value

should be equal to the current across the weak link which is given by the right-hand side of Eq. (8). Estimating the maximum value of the latter for a single channel contact as $2eT = \sim$, we obtain

In what follows we will consider the most interesting lim it N N r and L L . Due to Eq. (9) in this case the dependence $I_{\text{e=o}}$ (x) is fully determined by the current-phase relation for Q P S which can be found by means of Eq. (6) with $I_{\text{f=b}} = (2\text{ee}) e^{\text{(c)}}_{\text{f=b}} = e^{\text{(c)}}$. We also note that quantum uctuations of 'can easily be suppressed, e.g. by choosing the ring inductance succently small. In accordance with the charge-phase uncertainty relation the number of C ooper pairs passing through the junction should strongly uctuate thereby suppressing charging elects in the contact area.

Let us now directly evaluate the supercurrent in both even and odd ensembles. As it was demonstrated above, it is su cient to nd the currents I $_{\rm f=b}$ along with the dierence of therm odynam is potentials $_{\rm b}$

 $_{\rm bf}$ and combine the results with Eq. (6). The value $\rm I_{f=b}$ can be determ ined by m eans of a general form ula [15]

and $_{\rm bf}$ is evaluated as a sum of the ring and the weak link contributions, $_{\rm bf}=_{\rm bf}^{\rm (r)}+_{\rm bf}^{\rm (w\ 1)}$. The term $_{\rm bf}^{\rm (w\ 1)}$ is found by integrating $I_{\rm f=b}$ (') over the phase ', while the ring contribution $_{\rm bf}^{\rm (r)}$ at low enough T is de ned by the standard expression [2,4,5] $_{\rm bf}^{\rm (r)}$ ' $_{\rm bf}^{\rm (r)}$ is the density of states at the Ferm i level, V = sL is the ring volume and is the superconducting energy gap.

32. Rings with quantum point contacts

Let us rst consider the lim it of short QPC w ith d! 0. In this case one has W $_{i}$ (!) = $(2=T_{i})(1+!^{2}=^{2})$ 1, where T_{i} is the transm ission of the i-th channel. Combining this form ula with Eq. (11), after a simple calculation from Eq. (6) one nds [7]

where $\text{"}_i(') = \frac{p}{1 - T_i \sin^2{('=2)}}$. The term in the square brackets is speci c for canonical ensembles and should be substituted by one for grand canonical ones. For N = 1 and at T = 0 this term reduces to unity for even ensembles and to zero for odd ones. In other words, in the latter case PC will be completely blocked by the odd electron and no current will ow in the system despite the presence of a non-zero external ux threading the ring. In QPC with several conducting channels the current through the most transparent one will be blocked by the odd electron and, hence, the e ect can remain signicant also for QPC with N > 1.

The physics of this blocking e ect was discussed in details in Ref. 7. It is related to a complete cancellation of the contributions to the supercurrent coming from a pair of discrete Andreev levels with energies E (') =

"i('). Indeed, for the even ensemble at T=0 only the lower Andreev level E (') is occupied, while the upper one E (') remains empty. A coordingly, only the lower Andreev level contributes to the supercurrent in this case, and the result coincides with the standard grand canonical expression [16{19}]. In contrast, for the odd ensemble both levels E (') are occupied at T=0 and contribute to the supercurrent in equal measure. These contributions, however, enter with opposite signs and completely canceleach other thus reducing the net supercurrent down to zero. We also note that a similar result was recently obtained in Ref. [20]

It is in portant to emphasize that the above physical picture is based on the assumption that the supercurrent is determined only by the contributions of two discrete Andreev levels E ('). This is the case provided (a) quasiparticle states with energies above do not contribute to the supercurrent and (b) there are no more discrete Andreev levels inside the junction. Both these conditions are met only for symmetric and extremely short QPC with d! 0. In a general case d 60 at least one of these conditions is violated, and no exact compensation of the supercurrent by the odd electron countercurrent is anymore possible. The physics then becomes even more interesting, as it will be demonstrated below.

3.3. Rings with transparent SNS junctions

From now on let us lift the condition d! 0, i.e. consider SN S junctions with a non-zero thickness of the norm alm etal. Since the parity e ect become smore pronounced with increasing transmission of the system, let us rst restrict our analysis to fully transparent SN S junctions. In this case the function W $_{\rm i}$ (!) W (!) is the same for all channels. It reads

At T = 0 the current I_e again coincides with that for the grand canonical ensem bles [21,22]. At the same time for odd ensem bles we observe no blocking e ect anym ore, but rather a non-zero current I_o for any non-zero value of d, cf. Eqs. (15-16). As before, at T = 0 the countercurrent produced by the odd electron exactly compensates the current of the next lower Andreev level. However, the contribution of continuous spectrum (in the case d 0) or of continuous spectrum and all other discrete Andreev levels (in the case d 0) remains uncompensated and is responsible for the non-zero current I_o (15-16).

It is important to emphasize that such a current causes a jump on the current-phase dependence at \prime = 0, and the direction of I_{o} at su ciently small \prime is always opposite to that of I_{e} . This property implies that in the case of odd ensembles the minimum energy (zero

current) state occurs not at '=0, but at some other value of the phase di erence. For instance, for d $_0$ the \saw tooth" current-phase relation is shifted by the value =N and, hence, them inimum Josephson energy (zero current) state is reached at '==N. One concludes that the \=N-junction" state is realized in this case. This non-trivial state has a number of specic features. For instance, in the particular case N = 2 the current-phase relation I_0 (') turns—periodic. In addition, for any N > 1 the ground state of the system '=N

=N is a twofold degenerate one within the interval < ' < . Here we note that a similar behavior is expected for SN S junctions formed by d-wave superconductors [24].

Let us also recall that the —junction state can be realized in SN S structures by driving the electron distribution function in the contact area out of equilibrium [25{27]. Here, in contrast, the situation of a — or —N—junction is achieved in therm odynam ic equilibrium. Despite this drastic di erence, there also exists a certain physical similarity between the e ects discussed here and in Refs. [25{27]: In both cases the electron distribution function in the weak link deviates substantially from the Fermi function. It is this deviation which is responsible for the appearance of the —junction state in both physical situations.




Fig.2.The zero tem perature current-phase relations I_e (') and I_o (') ($~<~\prime~<~$) for N = 1 and di erent values of the param eter y = d =~v $_F$.

The current-phase relations I_e (') and I_o (') for arbitrary values of the parameter y can be computed numerically. Examples are presented in Fig. 2. In the case of odd ensembles one clearly observes the current jump at ' = 0. As it is obvious from Eq. (15), this feature disappears only in the QPC limity! 0.

3.4. Spontaneous currents in the ground state

Perhaps the most interesting property of superconducting rings interrupted by a —junction is the possibility to develop spontaneous supercurrent in the ground state [23]. A lithough this feature is inherent to any type of —junctions, in the case of the standard sinusoidal current-phase relation such spontaneous supercurrents can occur only for su ciently large values of the ring inductance L [23]. In contrast, in the situation studied here the spontaneous current state is realized for any inductance of the ring because of the non-sinusoidal dependence L [28].

In order to dem on strate that let us assum e that no

external ux is applied to our system . Then at T $\,!\,$ 0 the energy of an SN S ring with odd number of electrons can be written in the form

where is the ux related to the circular current owing in the ring. M inim izing this energy with respect to , one easily observes that a non-zero spontaneous current

should ow in the ground state of our system . This is yet one more remarkable consequence of the parity e ect: Just by changing N from even to odd one can induce non-zero PC without any external ux $_{\rm X}$. In the limit of small inductances L $_{\rm 0}$ d=ev_F N { which is easy to reach in the system sunder consideration { the value of I does not depend on the number of channels N and is given by the universal expressions can easily be derived from Eqs. (15-16):




Fig. 3. The spontaneous current am plitude $I_{\rm sp}$ as a function of the parameter $y=d=\sim v_{\rm F}$ at T=0. In the inset, the same function is shown on the log log scale. D ashed lines indicate the asymptotic behavior of $I_{\rm sp}$ (y) in the lim its of small and large v.

For interm ediate values of the param eter y the am plitude of the current $I_{\rm sp}$ can be evaluated num erically. The results are displayed in Fig. 3. In agreem ent with Eq. (19) the spontaneous current $I_{\rm sp}$ increases linearly with d at small d, reaches its maximum value $I_{\rm max}$ 0.4e =~ at d 0 and then decreases with further

increase of d approaching the dependence (20) in the lim it of large d. For typical BCS superconductors this m axim um current can be estimated as $I_{\text{m ax}} = 10 - 100 \, \text{nA}$. Spontaneous currents of such a large magnitude can be directly detected in modern experiments.

3.5. Junctions with resonant transmission

A swe have already emphasized above, thee ects discussed here are mostly pronounced for SNS junctions with few conducting channels N 1. Them ost promising candidates for practical realization of such structures are junctions with N-layers formed by carbon nanotubes or organic molecules. In both these cases it is not always easy to achieve good quality contacts between nanotubes/molecules and superconducting electrodes. In other words, although the electron transport in the N-metal itself can be ballistic, electron scattering at NS-interfaces may be substantial and may signic cantly modify the above results.

At the rst glance, in the limit of small transm ission of NS-interfaces the in uence of the parity e ect on PC should become weak and, hence, can be disregarded. Below we will demonstrate that this conclusion { although correct under certain conditions { does not necessarily apply to nanojunctions for which size quantization of energy levels is an important e ect. This e ect gives rize to resonant transm ission of elec-

trons across the junction and considerably $\ensuremath{\mathtt{m}}$ odi esthe physical situation.

To proceed we will adopt the standard model of an SIN IS junction (\I" stands for the insulating layer) and assume that transmissions of both NS interfaces are much smaller than unity. In this limit electron transport across the junction is mainly due to resonant tunneling through discrete energy levels inside the normal metal. For simplicity we will restrict our analysis to a single channel junction N = 1. If needed, generalization of our analysis to the case N > 1 can be performed in a straightforward manner.

A sbefore, we will make use of the general expression (11) where the function W (!) now takes the form [15]

Here $T_{1;2}$ and $R_{1;2}=1$ $T_{1;2}$ are respectively transmission and rejection coefcients of the two NS interfaces, $=\frac{p}{2+!}\frac{2}{2}$ and $2k_F$ d+ is the phase accumulated by electrons during the motion between the barriers.

In accordance with our assumption below we shall consider the $\lim it T_{1;2}$ 1.Them ost interesting physical situation is realized in the lim it of short SIN IS $_{0}$ \sim_{Ψ} = .U nder the above conditions junction d the size energy level quantization in the norm alm etal becomes an important e ect. In the case of a one dim ensional m etal of length d, the level spacing in the vicinity of the Ferm i energy is ~w=d.Hence, the condition for the short junction regim e can also be represented in the form . Tunneling of electrons into the reservoirs causes a non-zero linewidth of the energy levels which is proportional to $T_{1;2}$.This value ismuch smaller than , hence, the resonances remain well separated. In this situation it su ces to take into account only the closest to the Ferm i energy level inside the norm alm etal.

Let us introduce the energy of the resonant level $_{\rm R}$ by m eans of the relation $\cos(2k_{\rm F}+)$ 1+1=2 $^{\rm R}-^2$, where = \sim y =2d, and the tunneling rates $_{1,2}=\sim=$ $T_{1,2}=\sim$. Expanding the \cosh and \sinh terms in Eq. (21) to the leading order in = and substituting the result in Eq. (11), we obtain




Fig. 4. Andreev levels in a single mode SN S junction with $d=\sim v_F=$: (a) T $_{1,2}=$ 1 and (b) T $_{1,2}$ 1 and = = 0:5. In both cases T = 1.

It is interesting to point out that the expressions dened by Eqs. (22,23) can also be derived from the Anderson model for resonant tunneling through a single impurity center between two superconductors in the limit of zero on-site interaction.

It follows from Eqs. (22, 23) that { although the transparencies of both barriers are low { the total transm ission T and, hence, the Josephson current show sharp peaks provided the Ferm ienergy becomes close to the bound states inside the junction. On the other hand, Eqs. (22, 23) dem onstrate that even in the vicinity of resonances the behavior of the Josephson current as a function of the phase dierence ' and temperature T can substantially deviate from that for transparent SN S junctions.

In order to understand the physical reasons for such a di erence it is instructive to compare the structure

of discrete Andreev levels for ballistic ($T_{1;2} = 1$) SN S junctions with that for SIN IS junctions with T1:2 1, see Fig. 4. The spectrum of an SIN IS system consists only of a single non-degenerate state \mathbf{v}_0 (') in the interval $0 < "_0 < (Fig. 4b)$. As a result, the behavior of "0 (') at sm all ' is sm ooth and the derivative of $"_0$ with respect to 'has no jump at ' = 0. In contrast, in the case of ballistic SNS junctions discrete levels become split at arbitrary small values of the phase ' (Fig. 4a). Hence, the derivative of the lowest Andreev level with respect to ' acquires a jump at ' = 0. As we have already discussed, this feature is crucial for the presence of spontaneous currents in superconducting rings with arbitrary small inductances L and with odd num ber of electrons. Since this feature is absent in the case of SIN IS junctions the spontaneous current in the ground state of the system can only develop at not very sm all ring inductances.

A nalytical expressions for the energy of the subgap state (obtained from the poles of the sum m and in Eq. (22)) and for the parity-dependent currents $I_{\text{e}=\text{o}}$ can be derived in various asymptotic regimes. At a given value of the total transmission T one can distinguish two limiting cases: = 1 and = 1. In the case of a wide resonance = 1, the energy of the subgap state is "0 (') = 1 T sir² ('=2) and $I_{\text{e}=\text{o}}$ are given by the expressions derived for a single mode QPC with an elective transmission T. In the opposite narrow resonance limit = 1 we get

$$r = \frac{r}{(R)^2 + \frac{1}{4} \cdot r} = \frac{q}{1 - r} = \frac{r}{r}$$

The currents $I_{e=o}$ are again given by the expressions abtained for QPC with the substitution of by $(_R)^2+\frac{1}{4}^{-2}$. Note that in both these asymptotic regimes only the discrete spectrum contributes to the currents $I_{e=o}$. Thus, for these regimes the Josephson current will be completely blocked by the odd electron in the limit of low temperatures.




Fig. 5. Zero temperature current-phase relations $I_{e=o}$ (') for T = 0:9, $_1$ = $_2$ = $_0$ and dierent values of the parameter = $_0$.

At interm ediate values of the parameter = the continuous spectrum will contribute to the Josephson current. The current-phase relations $I_{\text{e=o}}$ (') can be easily evaluated numerically for arbitrary parameter values. The results of these calculations { partially represented in Fig. 5 { clearly demonstrate that at succently low temperatures the \ -junction" state should be realized in the case of odd number of electrons. According to our expectations, however, in the case of

resonant S IN IS junctions the current has no jum p at '=0 and the behavior of I_o (') is m ore similar to that of \conventional" -junctions [23].

Let us emphasize again that all the above results for SIN IS junctions with small interface transmissions were derived in the limit of short junctions d $_{0}$. Resonant elects are also important in the opposite limit d $_{0}$ [15]. However, in the latter case even exactly at resonance the Josephson current remains small being proportional to the smallest of the two transmissions T_{1} and T_{2} . Hence, the parity elect in the limit d $_{0}$ will also be small in equal measure. For this reason the case of long junctions with resonant transmission will not be considered here.

4. Conclusions

In this paper we have demonstrated that at succently low temperatures superconducting parity effect may strongly in uence equilibrium persistent currents in isolated superconducting nanorings containing a weak link with few conducting modes. An odd electron, being added to the ring, occupies the lowest available Andreev state and produces a countercurrent circulating inside the ring. For a single channel quantum point contact at T=0 this countercurrent exactly compensates the supercurrent $I_{\rm e}$ produced by all other electrons and, hence, yields complete blocking of PC for any value of the external magnetic ux. In supercon-

ducting nanorings with embedded normal metal the odd electron countercurrent can \overcompensate" $I_{\rm e}$ and a novel \= N -junction" state occurs in the system. Changing the electron parity number from even to odd results in spontaneous supercurrent in the ground state of such rings without any externally applied magnetic ux. This and other novel e ects predicted here can be directly tested in modern experiments. They can also be used for practical realization of superconducting qubits.
