Doping dependence of the superconducting gap in T 1/2 B a2C uO 6+ from heat transport

We present low-tem perature therm al conductivity measurements on the cuprate T  $\lg B$  a $_2$  C uO  $_{6+}$  throughout the overdoped regime. In the T  $_{1}$  0 limit, the thermal conductivity due to d-wave nodal quasiparticles provides a bulk measurement of the superconducting gap, . We not decrease with increasing doping, with a magnitude consistent with spectroscopic measurements (photoemission and tunneling). This argues for a pure and simple d-wave superconducting state in the overdoped region of the phase diagram, which appears to extend into the underdoped regime down to a hole concentration of '0:1 hole/Cu. As hole concentration is decreased, the gap-to-Tc ratio increases, showing that the suppression of the superconducting transition temperature Tc (relative to the gap) begins in the overdoped regime.

O ver the past decade, low tem perature therm al conductivity has emerged as a powerful probe of the low energy quasiparticle excitations in the cuprates. Unlike conventionals—wave superconductors, the nodes in the dwave superconducting order parameter of cuprates lead to a nite quasiparticle density of states at zero energy resulting in \universal" transport in the low tem perature  $\lim it (T ! 0) \cdot ^{1,2}$  By performing measurements in the  $T ! 0 \lim it$ , the complicated physics of quasiparticle transport in these materials is greatly simplied and meaningful quantitative comparisons between mean—eld theories in the self-consistent T-matrix approximation (SCTMA) $^{3,4,5}$  and experiments have been made. $^{6,7,8}$ 

In the mean-eld theory, the low-T thermal conductivity is proportional to the slope of the gap near the =  $j_{!}$  =4. By assuming a gap with a simple d-wave form ( =  $_0 cos(2)$ ), the gap maximum,  $_0$ , can be inferred from = , m aking therm alconductivity a measure of the superconducting gap. This measure is notable for a number of reasons that make it an excellent com plem ent to m ore conventional, spectroscopic m easurem ents of the gap. First, it is a very low energy m easurem ent of the gap, the energy scale being set by tem perature (and impurity bandwidth, ). Second, it m easures the gap near the nodes (in the direction) as opposed to the anti-nodes (,0). Finally, therm alconductivity provides a bulk m easure of the gap, unlike surface sensitive techniques such as photoem ission (ARPES) and tunneling. Together these properties allow one to impose important constraints on the nature of superconductivity in cuprates.

The cuprate T  $\frac{1}{2}$ B  $a_2$ C uO  $_{6+}$  (T  $\frac{1}{2}$ 201) is an ideal material for quantitative investigations of d-wave superconductivity in the cuprates. It is a single-layer mate-

rial with  $T_c^{m \ ax}$  ' 90 K, comparable to the well-studied cuprates B½Ba2CaCu2O<sub>8+</sub> (Bi2212) and YBa2Cu3O<sub>y</sub> (YBCO).By varying the oxygen concentration, the material can be doped from optimal doping far into the overdoped region of the phase diagram. In this region, the metallic state is well-characterised in terms of a single coherent Ferm i surface and there are no indications of competing phases, such as encountered in La2  $_{\rm X}$  SrxCuO4 (LSCO), for example. Moreover, T1-2201 can be prepared with reasonably low levels of disorder because the dopant atoms are interstitial oxygen residing well away from the CuO2 planes, instead of the more obtrusive cation doping located close to the CuO2 planes (as in LSCO, for example).

In this paper, we present low-tem perature therm alconductivity m easurem ents of T 1-2201 as a function of doping, spanning the overdoped region of the phase diagram. Expanding upon previous work on cuprates, 1,2,6,7,8 we analyze our results using the mean-eld SCTMA theory to provide a determ ination of the superconducting gap from thermal conductivity. We nd agreement between therm alconductivity and spectroscopic measurements of the gap, con m ing both the d-wave form of the superconducting gap as well as the validity of the mean-eld description of low-tem perature therm al conductivity in overdoped T12201. We track the gap as a function of doping throughout the overdoped region and nd a gap-0=kB Tc, that increases with decreasing doping, starting with a value close to the weak-coupling BCS value ( = 2.14) at high doping and reaching a value twice as large near optimal doping ( = 5 This shows that the suppression of the onset of coherent superconductivity (or Tc) so characteristic of the underdoped regim e actually begins above optim aldoping.




FIG. 1: (colour online) Therm all conductivity of one T l-2201 sample, measured at two different hole concentrations, as indicated by the respective  $T_{\rm c}$  values, plotted as  $\,$  =T vsT below 1 K. The lines are  $\,$  ts to Eq. 2. A three-fold decrease in  $T_{\rm c}$  corresponds to a six-fold increase in the residual linear term (which is inversely proportional to the superconducting gap, via Eq. 5), hence a two-fold decrease in the gap-to-T\_c ratio with doping.

Five ux-grown single crystals of T  $l_2$ B  $a_2$ C uO  $_{6+}$  are used in this study.9,10 The platelet samples have approxim ate length and width of 0.5 mm in the abplane and thickness 20-65 m along the caxis. The heat current is applied in the ab plane and the magnetic eld along the c-axis. The concentration of holes in the CuO 2 plane, p, is set by tuning the excess oxygen content in the T  $10_2$ layer. Concentrations between optim aldoping and heavily overdoped were achieved by annealing the samples in atm ospheres ranging from vacuum ( $5 ext{ 10}^7$  torr) at 500 C near optimal doping to 50-60 mbar oxygen at 400-480 C for heavily overdoped samples. The value of p for each sample was estimated from the measured  $T_{\rm c}$ (de ned as the tem perature at which the electrical resistivity has fallen to zero), using the well-known empirical form  $u \ln^{11}$

where  $T_c^m$  ax = 90 K is taken as the nominal  $T_c$  of optim ally-doped T 1-2201. The value of  $T_c$  and p for each sample is listed in Table I.

Therm alconductivity, ,wasm easured down to  $50\,\mathrm{m}\,\mathrm{K}$  in a dilution refrigerator using a standard 4-wire steady-state technique described elsewhere. Electrical contacts to the samples were made using evaporated gold pads, which were annealed to improve the contact conductance in the same anneal used to set the oxygen content. Silver wires were then attached to the contact pads using silver paint.




FIG. 2: (colour online) Therm al conductivity of four T 1-2201 sam ples, each with a di erent hole concentration, as indicated by their respective T<sub>c</sub> values, plotted as =T vsT below 1 K . The lines are ts to Eq. 2.

The largest error in the magnitude of , ranging from 15 to 25 % (see Table I), comes from the measurement of sample dimensions for the appropriate geometric factor. In order to eliminate this dominant source of uncertainty when comparing two dierent hole concentrations, one of the samples was measured twice with the same contacts, at two dierent dopings,  $T_{\rm c}=84~{\rm K}$  and 26 K (see data in Fig. 1). This was achieved by rst evaporating gold pads onto the sample and annealing the sample to set the doping, as described above. After measuring the sample, the wires and silverpaint were removed, the sample was reannealed to a dierent doping and subsequently remeasured with the gold pads still in place.

The therm alconductivity measured below 1 K is shown

in Fig. 1 for this sample and in Fig. 2 for four other samples, each at a dierent doping. To extract the electronic contribution to the data are to

where  $_0$ =T (intercept) is the electronic contribution to the total thermal conductivity and the second term (slope) is the phonon contribution,  $_{\rm ph}$ =T = AT. The values of  $_0$ =T from ts to Eq. 2 are listed in Table I, along with the error bars for each sample, estimated from the statistical error in the ts (< 1.5%) and the error in the geometric factor (15 25%). These results can be compared to a previous study on a strongly overdoped T 1-2201 crystal,  $^7$  with  $^7$  c = 15 K, which gave  $^0$ =T = 1.4 m W K  $^2$  cm  $^1$  and an excellent t to Eq. 2.

Note that in these overdoped samples  $_{\rm ph}$  / T $^2$  (over a decade in temperature). This is in contrast to previous reports of the low-tem perature therm al conductivity of cuprates, m easured typically at or below optim aldoping, where  $_{
m ph}$  /  ${
m T}^{\,2:5\,\,3}$ , consistent with phonons being scattered from the boundaries of the sample. 1,2,6,8,12,13 In overdoped T 1-2201, with its higher carrier concentration, we attribute the T $^2$  dependence of  $_{\rm ph}$  to dom in ant electron-phonon scattering, known to yield ph / T2 at low T in a metal. 14 Sm ith has shown that this is indeed the theoretically expected dependence of phonon transport in a d-wave superconductor, 15 in the range 0.1 -1.0 K.We emphasize that the main results of this paper, which stem from the doping dependence of  $_0$ =T, are una ected by alternative methods to t ph, such as a power-law with adjustable power (=T = a + bT).

The T-linear electronic contribution to is due to transport from d-wave nodal quasiparticles in the lim it of  $k_B$  T 0, where is the impurity band width. \(^1,4,5\) In this lim it, the residual linear term in the thermal conductivity is universal, in the sense that it is independent of scattering rate, and given by \(^5\)

where n is the number of CuO  $_2$  planes per unit cell (= 2 for T  $\vdash$ 2201) and c is the c-axis lattice constant (= 23.2 A for T  $\vdash$ 2201). The ratio  $v_F = v$  is the ratio of quasiparticle velocities normal and tangential to the Ferm isurface at the node, respectively given by the Ferm i velocity in the (0,0) - (;) direction,  $v_F$ , and

proportional to the slope of the gap at the node. Note that, unique amongst transport properties,  $_0$ =T was shown to be robust against both Ferm i liquid and vertex corrections.




FIG. 3: (colour online) Upper panel: The gap m axim um,  $_{0}$ , vs hole concentration, p, derived from thermal conductivity m easurem ents on T 1-2201 (circles) and Y B C O (square; R efs. 8 and 16). The solid (red) circles denote the sam e T 1-2201 sam ple m easured at two di erent doping levels, as discussed in the text. Spectroscopic m easurem ents of the gap from ARPES on T 1-2201 (red down-triangle; Refs. 17 and 9) and YBCO (blue down triangle; Ref. 18) and SIS tunneling on Bi-2212 (black up-triangles; Ref. 19) are also shown. The dashed line gives the BCS doping dependence of the gap based on the measured  $T_c$ , namely  $0 = k_B T_c$ , using a strong-coupling value of = 3 and  $T_c$  (p) from Eq.1. Lower panel: The gap-to- $T_c$ ratio,  $_0=k_B$   $T_c$ , vsp, for T 1-2201 from therm alconductivity data. The solid (red) line is a tthrough the two data points (full red circles) obtained on a single sample, for which the relative uncertainty is m in im al ( 3%), given the xed geom etric factor. The dashed (red) lines on either side re ect the uncertainty on the absolute value ( 17 %; see Table I). The horizontal (black) dashed line is the weak-coupling d-wave BCS prediction, namely  $_0$ = $k_B$   $T_c$  = 2.14. $^{20}$ 

The above form alism , however, is only valid in the lim it  $k_B\,T_{0}$ . Before proceeding, it is in portant to determ inew hether this criterion is indeed satisfed for our samples, particularly since  $_0$  decreases with increasing doping and eventually goes to zero at the superconductor/m etal phase transition.  $^{21}$  In the Appendix, we pro-

vide two independent and consistent estimates of for each sample which show that in all cases  $=k_B T > 10$  (for T < 1 K) and  $= _0 < 0.16$ , validating the use of Eq.3 for our T  $\downarrow$ -2201 sam ples.

The signi cance of Eq. 3 is that it provides a reliable way to measure the gap from a rather straightforward measurement of the thermal conductivity. Indeed, through Eqs. 3 and 4, the slope of the gap at the node,  $= j_{\text{hode}}\text{, is in mediately obtained from }_{0}\text{-T, provided }v_{\text{F}}\text{ and }k_{\text{F}}\text{ are known.}^{6,8}\text{ Making the assumption that has the standard d x² y² form () = <math>_{0}\cos(2)$ , Eq. 3 can be rewritten (for  $v_{\text{F}}$  v) as

0=T can thus be related in a straightforward fashion to the gap maximum, 0, by making use of the fact that v<sub>F</sub> and k<sub>F</sub> at the nodes are approximately doping independent. ARPES measurements $^{22}$  have shown  $v_F$  to be independent of both doping and material and to have a value  $v_F = 2.7 10^{\circ} 20\%$  cm/s. M easurem ents of the Ferm i surface by ARPES in LSCO  $^{23}$  , B i-2212  $^{24}$  and T l-2201  $^{17}$  , show  $\,k_F\,$  to have a value  $\,$  0.7 A  $^1\,$  along the nodal direction (0,0) - ( , ), essentially independent of m aterial or doping ( $k_F$  only has signicant doping dependence along (0,0) - (0, )). In overdoped T 1-2201, this value of k was nicely con med by bulk sensitive angular m agneto-resistance oscillation (AMRO) m easurem ents. 25 The values of obtained for our ve T1-2201 samples from Eq.5 are listed in Table I, and plotted vsp in the top panel of Fig. 3. Also shown is the value of  $_0$  for an ultra-pure overdoped YBCO crystal, 8,16 obtained in the sameway (with  $_0$ =T = 0.16 mW K  $^2$  cm  $^1$ ) { it is in excellent quantitative agreem ent with the T 1-2201 data.

0 decreases with increasing doping and follows the doping dependence of the gap m easured by spectroscopic probes such as tunneling  $^{19,26}$  and ARPES  $^{27}$ . In Figure 3 we also plot the doping dependence of  $_0$  in B i-2212 m easured using SIS tunneling 19 and nd good quantitative agreem ent with  $_0$  m easured by therm alconductivity,  $^{28}$ sim ilar to previous work on optimally doped Bi-2212.6 Comparing directly to measurements on T1-2201, recent ARPES m easurem ents give 0' 12 5 m eV and  $_0$  ' 24 9 m eV in a sam ples with  $T_c = 30 \text{ K}$  and 74 K respectively $^{9,17}$  which is also in favorable agreem entwith therm al conductivity. (  $_0$  here is taken as the average of two commonly used measures of o; the peak position and the leading-edge midpoint, which are 17 meV (33 m eV) and 8 m eV (15 m eV), respectively, for  $T_c = 30 \text{ K}$ (74 K).)

The agreem entbetween the di erent measures of has important in plications. First, it provides further compelling evidence for coherent nodal quasiparticle excitations that are correctly described by mean-eld d-wave quasiparticle theory throughout the overdoped region of the phase diagram. Secondly, the fact that the gap derived from thermal conductivity (i.e. from low-energy

nodal quasiparticles) agrees well with the gap maximum derived from tunneling or ARPES (determ ined from antinodal quasiparticles at higher energies) suggests that the gap structure (as a function of angle) is not very di erent from the simple d-wave gap assumed in our analysis (  $_0\cos(2)$ ). This places limits on any sub-dominant order param eter that may exist in the bulk. Subdom inant order param eters that result in a fully gapped nodal region (such as is or id) are limited to having a magnitude much less than the impurity bandwidth  $^{29}$  which is estimated to be on the order of  $_0$ =10 in our T 1-2201 sam ples (see Appendix). An even more stringent restriction is provided by the YBCO measurements, where, in crystals of the highest quality, can be orders of magnitude smaller than in Tl-2201.8,16 These conclusions are in agreem ent with the phase-sensitive tricrystal experim ents, which show  $d_{x^2-y^2}$  sym m etry of the order param eter and no signature of a subdom inant im aginary contribution to the superconducting order parameter away from optimal doping. On ote that a reals component and a reals component to the state of the sta is allow ed.)

The gap-to- $T_{\rm c}$  ratio, =  $_{0}$ =k $_{\rm B}$   $T_{\rm c}$ , is plotted vs p in Figure 3. is seen to decrease with increasing doping from a strong-coupling BCS value of = 5-6 near optimal doping towards the weak-coupling value of = 2:14 at high doping. This trend is made compelling by comparing measurements on the same as ample at two dierent dopings (solid red circles), for which the relative uncertainty is small. Indeed for sample a (see Table I), drops by a factor 1.9 (from 5.6 to 3.0) when the doping is increased from p = 0:19 ( $T_{\rm c}$  = 84 K) to p = 0:25 ( $T_{\rm c}$  = 26 K).

Having established how the superconducting gap grows with decreasing doping in the overdoped regime of the phase diagram, it is is natural to ask how it continues to evolve below optimal doping, into the enigmatic underdoped regim e. Heat transport m easurem ents on YBCO have shown that  $_0$ =T decreases monotonically, at least down to p' 0:1.8,32,33 Based on Eq. 5, this was interpreted in terms of a gap that keeps on rising as p is reduced. Note, however, that recent measurements of the in-plane resistivity in the (eld-induced) normal state of YBCO reveal a \m etal-insulator" crossover at p  $^{\prime}$  0:09.  $^{34}$  One should not expect the standard BCS analysis (leading to Eq. 3) to apply below that crossover. (The same situation was encountered in LSCO, 8 setting in at a considerably higher doping since the \m etalinsulator" crossover in that system is at p' 0.17.35) The crossover to a non-m etallic norm alstate m ay account for the qualitative change observed in the behaviour of  $_0$ =T when p is reduced to 5-6%, where it becomes independent of both doping and magnetic eld. This overall evolution of 0=T vsp in YBCO is corroborated by recent ARPES measurements on Bi-2212, which show the gap near the nodes to have comparable magnitude and to rise with decreasing puntil p' 0:08, and then fall abruptly.37

In conclusion, we have measured the doping depen-

dence of the low-tem perature therm al conductivity in the overdoped cuprate T 1-2201. A nalyzing the magnitude of 0=T using mean-eld theory, we show quantitative agreem ent between the slope of the gap at the nodes from thermal conductivity and spectroscopic measurements of the gap maximum at the anti-nodes in overdoped cuprates. These measurements provide further con m ation of the applicability of m ean-eld SCTMA transport theory in the cuprates, and more generally the basic description of overdoped cuprates as d-w ave superconductors. As a function of reduced doping, the gapto- $T_c$  ratio increases by nearly a factor 2 from p = 0.25to p = 0:19. This reveals that the strong suppression of phase coherence (or Tc) characteristic of the underdoped regime, presum ably caused by a combination of pair-breaking and phase uctuations, in fact begins in the overdoped region, at least as high as p' 02, perhaps higher.

## APPENDIX A: ESTIMATES OF THE IMPURITY BANDW IDTH

In this Appendix we estim ate the impurity bandwidth, , using two approaches: from the normal state transport and from the magnetic eld dependence of  $_0 =\! T$  in the superconducting state. Both approaches yield similar values of which in all samples satisfy the two criteria for the validity of a `universal" limit analysis, namely  $_0$  and T

## 1. From normal state transport

First, we estimate from the normal state quasiparticle scattering rate,  $_{\mbox{\scriptsize N}}$  . Because the norm al state of our samples could not be reached with the magnetic eld available in our lab (15 T), we turn to a previous study<sup>7</sup> on a crystal with a similar quality but signicantly lower  $T_c$  (higher doping), namely (15 K). In that crystal, N was estimated from N = T to be 0.52 m eV. $^{7}$ U sing this value as representative of  $_{\rm N}$  in our sam ples, we can estimate an upper bound on via the relation  $0.63^{r}$   $_{N}$   $_{0}$ , valid in the unitarity limit (which for a given value of  $_{
m N}$  ). These yields the largest estim ates are listed in Table  $\Pi$ , based on the 0 values of Table I. One can see that  $=k_B T > 13$  for T < 1 K and =  $_{0}$  ' 0:1 in all cases, m ore precisely ranging from 0.07 to 0.16. When is not negligible, there is a known correction to Eq. 3 (and Eq. 5), which for = 0 ' 0:1 is about 20%, 39 i.e. the clean-lim it gap value is 20% larger than estimated using Eq. 5. An error of this magnitude has little in pact on the conclusions of this article.

## 2. From the magnetic eld dependence of $_{0}\text{=}T$

As a crosscheck, we can also make use of the magnetic eld dependence of the thermal conductivity in the T! 0 lim it to estimate in our samples. Unlike the zeroeld thermal conductivity, which is independent of , the eld dependence of the thermal conductivity is dependent upon the quasiparticle scattering rate.  $^{40,41}$  In a d-wave superconductor  $_0$ =T increases with an applied magnetic eld due to the Volovik e ect.  $^{42}$  and in optimally doped cuprates  $^{13,41,43}$  the thermal conductivity is well described by semi-classical calculations of the eld dependence of  $_0$ =T based on the Volovik e ect.  $^{40,44}$ 




FIG. 4: (colour online) Therm all conductivity in an applied eld (H ==c) for the T l=2201 sample with  $T_c=76~\rm K$ , plotted as =T vs T.  $_0$ =T increases by a factor of 3 in an applied eld of 11.5 T. The lines are ts to Eq. 2. Inset: The in-eld electronic therm all conductivity  $_0$  (H)=T norm alized to the zero-eld value  $_0$  (0)=T as a function of magnetic eld in a T l=2201 sample with  $T_c=89~\rm K$  (not used in the main study). The solid line is a t to the semi-classical model (Eq. A1), which yields  $=_0$  of 0:1 (see text).

Note that aside from , Eq.A1 is only dependent upon known constants. As such, we can estimate from a single parameter t to the eld dependence of  $_{\rm 0}$ =T at H  $_{\rm C2}$ .

In Figure 4, we show =T vs T for the T l-2201 sam ple with  $T_c=76\,\mathrm{K}$ , in H = 0 T and 11.5 T.W e see that  $_0$ =T is enhanced by a factor 3 or so. Similar eld-induced enhancements of  $_0$ =T are observed in all sam ples, by a factor which varies from 2 to 4.46 In the inset, we show  $_0$  (H)=T (normalized to  $_0$  (0)=T) vs H in a separate T l-2201 sam ple ( $T_c=89\,\mathrm{K}$ ).47 Eq.A1 provides a reasonable t (solid line) to the data, giving  $\overline{H}=3:36T^{1=2}$ ,

which results in = 3.8 m eV, so that  $= _0$  ′ 0.1. This is similar in magnitude to our above estimate from normal state transport, providing a non-trivial validation for both methods of estimating.

W e conclude that within possible corrections on the order of 20% or so, it is legitim ate to use Eqs. 3 and 5 to extract an estimate of  $_{0}$  from a measurement of  $_{0}$ =T in the T l-2201 sam ples considered here.
