## A nalytical Current Form ula for Strongly Coupled Quantum Dot with A rbitrary Electron-Electron Interaction

A n analytical expression for the current through a single level quantum dot for arbitrary strength of the on-site electron-electron interaction is derived beyond standard m ean-eld theory. By describing the localised states in terms of m any-body operators, the employed diagram m atic technique for strong coupling enables inclusion of electron correlation e ects into the description of the local dynam ics, which provides transport properties that are consistent with recent experimental data.

Electron transport through few electron islands is strongly in uenced by electron correlations between its atom ic like states. A variety of correlation e ects, including K ondo e ect [1] and resonant current peaks [2], have been observed. For low conductance of the tunnel junctions one can employ "orthodox theory" [3], which treats the tunnelling in lowest order perturbation theory (golden rule). In the strong coupling regime, however, this theory collapse since then the transport is not dom inated by sequential tunnelling. W hile e ects of coherent tunnelling have been extensively studied [4], the question of a general description which includes correlation e ects and is valid both for strong and weak coupling regim es rem ains open. In this Letter, an analytical form ula for the current through a single level quantum dot (QD) is derived for arbitrary on-site Coulomb repulsion, beyond standard mean-eld theory (e.g. beyond self-consistent Hartree-Fock, or Hubbard I, approxim ation (HIA) [5, 6, 7]). This form ula include local correlation e ects which provide the well known renorm alisation of the localised level [7, 8, 9].

The present derivation concerns single level QDs, here described by the Anderson m odel [10], e.g.

where  $c_k^{\gamma}$  (k) creates (annihilates) an electron in the left (L) or right (R) lead at the energy "k and spin = ";#, whereas X <sup>pq</sup> = jpihqj jpi; jpi = jDi; j i; jZi j "#i, is a Hubbard operator [5], where  $h^p$  X<sup>pp</sup> is the population operator for the state at the energy  $E_p$ . Here, the local state energies are  $E_0 = 0$ , E = ", and  $E_2 = "_" +$ " $_{\#} + U$ , where " is the localised single electron energy, whereas U is the on-site C oulom b repulsion. The last term in Eq. (1) models the tunnelling, with rate  $v_k$ , between the leads and QD. The factor h jd jZi (";# = 1) accounts for the selection rule between the singly and doubly occupied states (hOjd j i = 1), and is the opposite spin of  $\ .$ 

U sing the description of the Anderson model in terms of H ubbard operators is motivated because this enables the use of a diagram matic technique which i) provides an expansion of the QD GF in the strong coupling regime [11], ii) yields the logarithm ic renorm alisation of the localised level [12], and iii) can be employed for a direct transform ation of the on-site properties into corresponding non-equilibrium quantities [13, 14]

The stationary current through the system can be calculated from the general expression Eq. (19) in Ref. [15], with the matrix  $^{L=R}$  (given later) describing the coupling between the left/right lead and the QD, and the retarded/advanced/lesser matrix GF G  $^{r=a=<}$  for the localQD properties.

The components of the GF are de ned by [11, 12, 13, 14] G<sub>ab</sub> (t;t<sup>0</sup>) = ( i)hTSX<sup>a</sup> (t)X<sup>b</sup> (t<sup>0</sup>)i=hTSi, where a;b denote Ferm i like (single electron) transitions whereas a;b denote the conjugate transitions. The action S = exp (  $i_{t_0}^{t_0}$  i H<sup>0</sup>(t)dt), 1= =  $k_B T$ , [11, 12, 13, 14, 16] contains time dependent disturbance source elds U (t), used for the generation of a diagram matic expansion of the GF in term<sub>P</sub>s of functional derivatives. Here, H<sup>0</sup>(t) = U<sub>0</sub>(t)h<sup>0</sup> +  $_{0} U_{0}$  (t)X  $^{\circ} + U_{2}$ (t)h<sup>2</sup>. Physical quantities are accquired from the GF as U (t) ! 0.

In the present system, there are four possible single electron transitions, e.g.  $X^{0}$  and  $X^{2}$ , which yields a 4 m atrix equation for the GF.Follow ing the derivation in Refs. [12, 13], one nds that the general structure of the equation of m otion for the matrix GF is given by

where I is the identity,  $^{0} = \text{diagf} \stackrel{0}{}_{"0}; \stackrel{0}{}_{\#0}; \stackrel{0}{}_{2\#}^{0}; \stackrel{0}{}_{2"}^{0}g$ (diagonal matrix) contains the bare transition energies  $^{0}_{0} = E \quad E_{0}$  and  $\stackrel{0}{}_{2}^{0} = E_{2} \quad E$ . The interaction between the leads and the QD is given by

where  $V = \text{diag} f V_*; V_{\#} g$  and  $V^0 = _z V$  ( $_z$  is the zpomponent of the Pauli spin vector), with V (t; t^0) =  $_{k^2 L;R} j v_k j^2 g_k$  (t; t<sup>0</sup>). Here,  $g_k$  (t; t<sup>0</sup>) is the GF for the conduction electrons in the leads, satisfying the equation (i@=@t  $\frac{v}{k}$ ) $g_k$  (t; t<sup>0</sup>) = (t  $\frac{v}{k}$ ).

In Eq. (2) the end-factor P (t), which arise due to the non-com m utative algebra of H ubbard operators, carries the spectral weights of the components of the matrix GF. In the considered system  $P = diagfP_1; P_2g_1$ where  $P_n$ ; n = 1; 2, them selves are 2 2 m atrices given by  $P_1 = fP_0 \circ_0 g \circ fhT fX^0 ; X^{\circ_0} gi_U g \circ$ and  $P_2 = fP_{22} \circ g \circ fhT fX^2; X^2 \circ gi_U g \circ (sub$ script U signifying the source elds dependence of the averages). In the present case  $P_0$   $_0$ ;  $P_{22}$  = 0. The non-commutativity of the Hubbard operators also gives rise to the operator R (t) [11, 12, 13], here given by  $R = diagfR_1; R_2g$ , where  $R_1(t) =$  $fR_0 \circ_0 (t)g \circ f \circ = U_0 (t) + = U \circ (t)g \circ and$  $R_2(t) = fR_{22} \circ (t)g \circ f \circ = U_2(t) + = U \circ (t)g \circ$ that is, functionaldi erentiation operators which operate on the GFG with respect to the auxiliary source elds U (t). The matrix U = diagfU<sub>1</sub>; U<sub>2</sub>g, where U<sub>1</sub>(t) = fU ∘(t)  $_{0}U_{0}$  (t)g  $_{0}$  and  $U_{2}$  (t) = f  $_{0}U_{2}$  (t) U º (t)g º.

The structure of the equation of motion, Eq. (2), suggests that G  $(t;t^0) = D(t;t^0)P(t^0)$ , where D  $(t;t^0)$  is the boator [11] carrying the local on-site properties of the GF, e.g. the position and width of the localized level. Here, uctuations of the spectral weights are neglected, hence, P is treated as a constant with respect to the source elds U (t). Therefore, varying the GF with respect to the source elds generates G = (D)P, and since the locator satis es the matrix property  $DD^{-1} = I = D^{-1}D$  one nds that  $D = D(D^{-1})D$ , hence  $G = D(D^{-1})G$ . Thus, it is necessary to study the locator and its inverse.

In general, the equation of motion for the locator appear very similar to Eq. (2), that is, replacing G by D and removing P in the rst term on the right hand side of Eq. (2). In addition, the structure of the resulting equation of motion for D suggests that the inverted locator D  $^{1}$  can be written

whereas the bare locator  $d(t;t^0)$  satisfies the equation  $[id=dtI \quad ^0 \quad U(t)]d(t;t^0) = (t \quad ^0)I$ . For the present derivation, the dressed inverted locator in  $\$  G  $\$  =  $\$ 

D (D<sup>1</sup>)G is replaced by its corresponding bare quantity, e.g.  $G = D (d^1)G$ , meaning that the diagram – matic expansion term inate after the rst functional differentiation, the so-called loop correction [11, 12, 13]. This will then generate the renormalisation of the localised level, as is shown below. However, continuing the functional di erentiation to higher orders generate higher order diagram s that account for additionalm anybody correlation e ects [11, 13], for instance contributions from the K ondo e ect.

D ue to the non-commutativity of the matrices in Eq. (2) it is now preferable to study the scalar equations. The interaction matrix V goes una ected by the functional derivatives, since here the source elds are only applied to the localised QD states. Noticing that, for instance,  $R_0 \sim_0 (t^+) d^{-1} (t;t^0) = (t^-) R_0 \sim_0 (t^+) U (t)$ , one nds that the only non-vanishing contributions are

where  $D_{ab}^{r}$  (!) is the retarded form of the corresponding locator, and  $f_{L=R}$  (!) = f (!  $_{L=R}$ ) is the Ferm i function at the chem ical potential  $_{L=R}$  for the left/right lead. The renorm alisation due to the loop correction and its e ects on the transport properties is discussed elsewhere [12, 13, 14].

The form al structure of the equation for the QD GF, e.g. Dyson equation, gives by a direct application of the Langreth rules for analytical continuation [17] the retarded/advanced and lesser counterparts of the GF as

Here g is the GF for the QD in the atom ic limit, whereas the components of V < (!) are given by V < (!) =  $i[f_L(!)]^{L} + f_R(!)^{R}$ ; =  $^{L} + ^{R}$  and  $^{L=R} = 2Im_{k2L=R} j_{y_k} j g_k^{r}$  (!). The retarded/advanced and lesser GFs can now be inserted into the general expression for the current, Eq. (19) in R ef. [15], where the trace is taken over the 4 d matrices. It is then straightforw ard to show that

where  $P_0 = P_0_0$  and  $P_2 = P_{22}$ , and  $V^r = V^r(!)$ . Hence, the current becomes

It should be emphasised that the derivation of Eq. (7) is valid for arbitrary couplings  $^{L=R}$ , not only  $^{L} = ^{R}$ .

Here, the end-factors pare given by  $P_0 = Im [G_0^{<}(!_R) G_2^{>}(!) G_{P_0}^{>}(!)]d! = (2)$  and  $P_2 = Im [G_0^{<}(!) G_2^{>}(!) + G_{0}^{<}(!)]d! = (2)$ , which leads to the boundary condition  $P_0 + P_2 = tr Im G^{r}(!)d! = 1$  [18] by the requirement that the integrated total local density of states is unity [11, 14]. Hence, Eqs. (3) and (4), along with of the end-factors, lead to a set of equations subject to self-consistent calculations, for each value of the bias voltage. This, then provide an accurate eld dependence of the transport properties of the system. Replacing  $^{L} = ^{R}$  by and  $f_{L} = ^{L} = f_{R} = ^{R}$  by  $f_{L} = ^{L} + f_{R} = ^{R}$  in Eq. (5), one easily show s charge and current conservation of the presented result, e.g.  $(= (CP_0 + P_2) = 0$ .

Now, since the occupation number  $h i = h + h^2 i = P_2$ , it follows that  $P_0 = 1$  hn i. Hence, removing the renorm alisation energies in Eq. (6), reduces the GF to the standard mean-eld result, e.g. the HIA [6].

The atom ic lim it of Eq. (6) is trivial since this lim it is the starting point of the expansion of the QD GF. However, it is worth to notice that  $_0$ ;  $_2$  ! 0 as  $v_k$  ! 0, c.f. Eq. (3). Further, in the lim it of no on-site C oulom b interaction, e.g. U ! 0, the renormalisation energies  $_0 + _2$  ! 0 [19], giving G<sup>r</sup> (!) = (! "\_0 V^r) <sup>1</sup>, i.e. the result from the exactly solvable Fano-A nderson m odel [10, 20]. Inserting this expression into the current, Eq. (7), yields the well-known result for the single resonant level [15, 21]. Finally, in the limit of strong on-site Coulomb repulsion, e.g. U ! 1, Eq. (6) becomes  $G^{r}(!) = P_{0} = (! _{0} P_{0} V^{r})$ , where  $_{0} = {}^{0}_{0} + {}_{0}$  and (at T = 0 K)

since  $_{0}$ ;  $_{2}$  are nite for all U. This GF was derived in Ref. [12] and is consistent with the result in Ref. [8]. By removing the loop correction  $_{0}$ , this GF reduces to the result in Ref. [7]. Also in this case the current becomes particularly simple, e.g.

The di erence between this expression and the one for the single resonant level is that the end-factor  $P_0$  makes sure that the localised level is at most occupied by one electron, and that the transition energy is appropriately renorm alised due to the strong electron correlations.

In the remainder of this Letter, the di erence in the transport properties of the HIA and the loop correction in the non-magnetic case, is addressed. Therefore, let = , and let = 0 be the equilibrium chemical potential. In general, the renormalisation of the transition energies tends to increase the elective C oulomb repulsion, e.g.  $U = {0 \atop 2} + {2 \atop 0} {0 \atop 0} > U$  since  ${0 \atop 2} {0 \atop 0} = U$  and  ${0 \atop 0} {0 \atop 2}$ . However, for U = 1 and U = 1, this does not cause any dramatic deviation between the two approximations in the resulting transport properties.




FIG.1: (C obur online). C alculated transport characteristics of the single levelQD.a) D i erential conductance calculated in the HIA (dotted) and with the loop correction (solid) (the sm all ripples in the solid line is due to that dJ=dV is the numerical derivative of the calculated current). Inset: T he current in the voltage interval between the conductance peaks. b) O ccupation numbers N<sub>0</sub> (dotted), N (N = N  $_{\#}$ ) (solid), and N<sub>2</sub> (dashed) in the HIA (faint) and with the loop correction (bold). Here, f"<sub>0</sub>;U;k<sub>B</sub> T g= = f1;0:5;0:02g.

In contrast, by tuning the system into the regime  $1 < {}^{0}{}_{0} = < {}^{0}{}_{2} = (or {}^{0}{}_{0} = < {}^{0}{}_{2} = < 1)$  and  $0.5 \cdot U = 1$ , for low tem peratures, one nds that the current resulting from the HIA is weakly peaked for bias voltages such that either of the chemical potentials  $L_{R}$ lies between the two transition energies, see inset of Fig. 1 a) (dotted). Consequently, there will be a region of a clear negative di erential conductance (NDC) between the two conductance peaks corresponding to the transition energies  $_0$  and  $_2$  , Fig. 1 a) (dotted). This resonant peak is, however, not consistent with recent experim ental data on single-level QDs, for example see Ref. [22]. In the approximation with the loop correction (solid), on the other hand, the di erential conductance is positive in the whole bias voltage interval, in agreem ent with experiments. The current then shows a plateau, as expected when the one-particle state is resonant while the two-particle state is not.

The di erence of the two solutions can be understood as follows. The renormalisation of the transition energies yields  $_0 \quad {}^0_0$  and  $_2 \quad {}^0_2$ . Hence, the state j i begins to populate at lower bias voltages, Fig. 1 b) (bold

solid), than in the H IA, whereas the state 1/2 i rem ains unoccupied for higher voltages (bold dashed). Therefore, the population in the one-particle state is able to saturate for bias voltages such that the two-particle state rem ains unoccupied. In the HIA, on the other hand, the one- and two-particle states compete about the available population, since the transition energies lie closer to one another, which leads to an overpopulation of the one-particle state, Fig. 1 b) (faint solid). In general, a high population number in the one-particle state in com bination with a signi cant reduction in the population num ber of the empty state ji, tends to reduce the tunnelling probability of the one-particle state [13]. Hence, the overpopulation in j i a ects the transport properties of the system such that the current decreases. For larger bias voltages, how ever, the population in the one-particle state returns to its norm al saturation value leading to an increasing current.

In conclusion, an analytical form ula for the current through a single level Q D for arbitrary on-site C oulom b repulsion and couplings to the leads, was derived beyond standard m ean-eld theory (H IA) using a diagram m atic expansion of the Q D G F in the strong coupling regime. The result rem oves the region of N D C, found in the H IA, in agreem ent with recent experim ental data.
