## Pt steps decorated by 3d nanow ires calculated via an order-N m ethod

W e present the m agnetization energy and m agnetic m om ents of 3d m onow ires aligned along the step edges of Pt (533) and (322) vicinal substrates. W e em ploy an electronic structure m ethod which scales linearly with the size of the system. This allows us to treat with ease both ferrom agnetic and antiferrom agnetic solutions, and in principle the m ethod should allow for the evaluation of m ore com plex system s, such as wires deposited on rough step edges. W e ind that Co, Fe, and M n are alm ost perfect H eisenberg system s, with alm ost no change in the m om ent between antiferrom agnetic and ferrom agnetic solutions. A large polarisation of the Pt substrate is also observed. Our results are in close agreem ent with recent experimental results obtained for the case of a Com onow ire. A s expected the trend is for the late d series to be stabalised by ferrom agnetic long range order and the m iddle of the d series by antiferrom agnetic order. Since our m ethod is only locally self consistent we discuss as some length the convergence of the results with respect to the size of the region which is treated self-consistently.

#### I. IN TRODUCTION

P hysics on the nanoscale has developed enorm ously in the last decade and the construction of a wide variety of nanoscale system s has become possible. This usually proceeds through either an atom by atom manipulation using STM, or by growth on a substrate favorable to the form ation of the desired nanostructure. Stand out am ongst the latter category of experiments has been the production of parallelm onoatom ic chains aligned along the step edges of a Pt vicinal substrate<sup>1</sup>. Vicinal substrates, created by the controlled miscut of the crystal o a high symmetry plane, present an ordered array of step edges and thus form an ideal tem plate for the grow th ofm onoatom ic wires.

One of the fundam ental issues which arises in the context of nanophysics is how very well known phenom ena such as magnetism are altered in systems of reduced dimensionality. A variation in the magnetic properties of the 3d and 4d transition m etals as a function of dim ensionality and substrate type has been observed on severaloccasions<sup>2,3,4,5,6,7,8,9</sup>, where the system s investigated have ranged from zero-dim ensional adatom s, m onow ires, and monolayers. The picture that has emerged from these investigations is that elements which in the bulk situation are non-magnetic may develop large magnetic m om ents in the nanoscale. M ore precisely it has been observed that the peak of the moment-valence plot shifts to low er valence as the dim ensionality is reduced. How ever, the early prediction of the magnetism of two dimensional m onolayers of 4d m etals was not realized in m any cases. This was due to the sensitivity of the magnetism to structural defects and relaxation, these tending to reduce the magnetic moment from that of the ideal structure. On the other hand the recent investigation of the magnetic

nature of the 3d m etal C o deposited in one-dimensional chains on the Pt(997) surface<sup>1</sup> showed a dram atically enhanced spin and orbitalm om ent.

From the theoretical point of view one of the problem s with the study of low dimensional systems is that the reduction in symmetry and the corresponding increase in system size mean that the calculations can become quite dem anding. This is simply due to that fact that m ost of the theoretical approaches scale as N  $^3$ , with N the number of inequivalent sites. A lternative ab initio techniques with more favorable scaling do exist how ever. In particular, Bellini et al.<sup>7</sup> have determ ined the magnetic structure of 4d m onoatom ic row s on A g vicinal surfaces, using an ab inito method that scaled as order N with the number of substrate layers. However the scaling with the num ber of inequivalent wire atom srem ained N $^3$ . This, as the authors noted, m eant that calculations involving inequivalent wire atoms (needed for the calculation of antiferrom agnetic wire con gurations) became again very dem anding. On the other hand, E isenbach et al, have recently deployed a genuine ab inito order N method in the study of Fem onow ires embedded in a Cu m atrix. U sing this approach they were able to determ ine the magnetic structure of the Few ire.

Ab inito order N m ethods clearly hold a lot of prom ise for the investigation of system s on the nanoscale. W ith the ability to calculate system s of several hundred atom s one can consider, for example, m agnetic clusters either embedded within the bulk of another m aterial or deposited on a substrate. However, the favorable scaling of order N m ethods comes at a certain price of accuracy. This is due, in the case of the m ethod deployed by E isenbach et al. and to the related m ethod used by us in this work, to their being only locally self consistent. H ence, it is necessary to establish that the m agnitudes of quantities one is interested in are within the scope of the m ethod.

In this work we investigate the magnetic properties of 3d nanow ires deposited on the step edges of a Pt vicinal surface. We consider both ferrom agnetic (FM) as well as anti-ferrom agnetic (AFM) magnetic con gurations, and establish the accuracy of the method for the relevant magnetization energies. A lthough the calculations we perform here do not have spin-orbit (SO) coupling this will not be important for the determ ination of energy differences between FM and AFM magnetic con gurations, which will be order the order of mRy and hence orders of magnitude bigger than the magnetic anisotropy from the SO interaction.

### II. VICINCAL GEOMETRY AND SUPERCELL

A vicinal surface is one created by m iscutting away from a high symmetry plane. These surfaces neccessarily display a periodic array of steps aligned along some specic direction, separated by terraces of the high symmetry plane the surface was m iscut from . We will consider here a surface m iscut o the high symmetry (111) plane. In this case there are two possible vicinal surfaces with steps that have either (100) or (111) m icrofacets. These two families of surfaces are described by the M iller indices (p + 1; p = 1; p = 1) and (p = 2; p; p) respectively with p being the number of atom ic rows in the terraces separating steps.

The template that we use for depositing the 3d m onow ires on will in this study be the (p+1;p 1;p 1) vicinals, and we consider surfaces with 2 atom wide and 4 atom wide terraces. A susual we replac the sem i-in nite geometry with that of a supercell which is then periodically repeated in space. This leaves us with a slab with two surfaces, one of which we will decorate with a m onow ire. It is important that these slabs should not interact and also that the two surfaces should not interact across the slab. Here we accomplish this by separating the slabs which are 8 (111) layers in thickness by 7 (111) vacuum layers. This leads to supercells of 25 atom s and 55 atoms for the (311) and (533) vicinals respectively. In order to consider the possibility of anti-ferrom agnetic solutions of the m onow ire we sim ply double the supercell. in the wire direction, leading to supercells of 50 and 110 atom s.

### III. THE ORDER N LOCALLY SELF CONSISTENT GREEN'S FUNCTION METHOD

The Locally Self-consistent G reen's Function m ethod  $(LSGF)^{10}$  is based on an approach whereby a supercellof N sites is divided into N separate local interaction zones (LIZ) each of M sites. The motive for this construction is the observation that that the properties of the central site in each LIZ will approach those that would be found

by a full solution of the supercellas M ! 1. This is very similar to the Locally Self-consistent Multiple Scattering (LSM S) method used by Eisenbach et. al in their work on Fe wires embedded in Cu<sup>11</sup>. Essentially, the only difference between the two approaches is that in the LSM S method each LIZ is embedded within a free electron gas whilst in the LSG F method one embedded the LIZ into some judiciously chosen e ective medium.

Form ally this is achieved by writing a D yson equation for the central site of each L  $\rm IZ$

By solving this equation for every site in the supercell one nds the diagonal elem ent of G reen's function m atrix  $g_{R,R}$  for all sites, and from this set one can construct the e ective m edium G reen's function  $g_{R,R} \circ$ . This process is then iterated to self-consistency being rst initiated by some suitable guess. One must note that although the full G reen's function m atrix  $g_{R,R} \circ$  will not correspond to that of the supercell under consideration, provided M is large enough, the site diagonal element will. Since it is the only the site diagonal elements that are required to determ ine the local density of states for each site one m ay extract reliable inform ation on charge density, one electron energy, and total energy of the supercell from this m ethod.

The e ective medium plays only the role of a boundary condition for the LIZ, but convergence with LIZ size will be strongly a ected by this choice<sup>10</sup>. In the case of a highly inhom ogeneous structure one way to proceed is by making the e ective medium more complicated (for exam ple by allowing for inequivalent e ective atom s), how ever in the case of a vicinal surface this is not practical. (Since the num ber of inequivalent vicinal layers is equal to the number of sites in the supercell.) We therefore proceed by the use of the simplest single site e ective medium construction. The criteria that such an e ective medium should sattisfy in such a case is that the "effective atom "most resembles the maximum number of sites. W ith only one type of e ective medium site this is clearly not possible in the case of seperate vacuum and m etal regions in the supercell. A way that suggests itself is to sattisfy the two natural lim its by having an e ective vacuum atom and an e ective metal atom. Near the interface region the size LIZ will need to be large to elim inate the error at the central site, but away from the interface region the e ective m edium will com e to resem ble more and more closely the real material and hence the error with the same size of the LIZ is smaller.

For simplicity we choose here a single site e ective medium constructed from all metal sites via the average t-m atrix approach. The rational behind this can be seen by considering the LIZ around an atom in the surface. The error committed for vacuum sites in the LIZ should be less important, as the density of states there is anyway sm all, while the error for the m etal sites will be less for not having a spurious vacuum term in the effective m edium, and indeed should vanish in those sites which no longer feel the perturbation of the surface.

O ne m ust emphasize that there is no direct scattering between distant sites in this m ethod. Beyond the LIZ boundary the e ective m edium is single site and contains only inform ation related to the underlying lattice and no inform ation w hatever about the geom etry of the vicinal surface. Hence quantum e ects due entirely to such direct scattering processes with be lost. This may be of im portance when considering, for example, step-step interactions.

### IV. COMPUTATIONALDETAILS

The method deployed here was a real space technique based on the K orringa-K ohn-R ostoker G reen's function scheme in the atom ic sphere approximation. The basis consisted of s, p, and d orbitals, and corrections to the spherical charge density were included up to  $l_{max} = 4$ . The calculations were performed in the Local Density Approximation (LDA) with the Perdew, Burke, and E mzerhofparam eterization of the results of C eperly and A kler. The integration of the G reen's function was taken in the complex plane with 16 energy points on a semi-circular contour. The lattice parameter for Pt was taken to be the theoretical LDA value.

## V. CONVERGENCE OF TOTAL ENERGY AND MAGNETIC MOMENT W ITH LIZ

The success of the LSGF method as a genuine order-N m ethod for arbitrary structures depends of course on how quickly is the convergence with respect to the LIZ size. By construction the rate of convergence of the supercell will depend solely on the convergence of the individual LIZ's. This in turn depends on how well the e ective medium corresponds to the system at hand. A consequence of this is that the convergence of the total energy should become worse linearly with increasing N. In Table I are shown the total energies for the supercell consisting of a Comonowire deposited on Pt (533). From this one m ay conclude that a LIZ of 55 atom s is enough to capture the energetics of this system . In Table II are shown the wire and substrate m agnetic m om ents and m agnetization energies. The convergence is better for the wire than for the substrate quantities. For the moments this can be understood as due to the fact the the 3d m onow ire will be a very good localm om ent system whereas the Pt substrate is of more itinerant character. The more localised the magnetic moment the better it is expected to converge in real space.

Finally we show in Fig. 3 the convergence of the quantity  $E_{FM} - E_{AFM}$  for all the 3d m onow ires from V to N i deposited on a Pt (311) substrate. 

gence is with L IZ is su cient that one can state clearly which solution is preferable for each wire.

# VI. MAGNETIC MOMENTSAND MAGNETIZATION ENERGIES

W e now turn to the trends of wire m om ent and energetics versus the d band lling. In Fig. 1 we show the wire, substrate, and vacuum m om ents for the elem ents V to N i, T i and Sc being found to display no m agnetic solutions for the m onow ire geom etry considered here. A swas

FIG.3: Convergence with LIZ of the di erence  $E_{FM} - E_{AFM}$  for 3d m onow ires on Pt (311) substrate.




found by B lugel<sup>3</sup> in the case ofm onolayers of 3d elem ents we nd stable FM and AFM solutions for all monow ires. This indicates again that the monow ire form s a good local moment system and particularly so for the M n, Fe, and C o wires where the moments of the FM and AFM con gurations are almost identical.

The total moment of the Pt substrate on the other hand is sensitive to the magnetic con guration of the monowire, and changes from around 1  $_{\rm B}$  to almost zero when the wire con guration changes from FM to AFM. One can note that the substrate moment associated with




the FM monowire has a node between Cr and Mn, so that only for V and Cr does the substrate couple antiferrom agnetically to the FM monowire. The large polarization of the substrate associated with the FM conquration is to be expected considering work on 3d im purities in Pd and Pt where a large polarization cloud of several B was observed experim entally and theoretically. This being due to the fact that bulk Pt is near a magnetic instability. In Fig. 2 we show the total magnetic moment of each principle layer of the (533) and (311) vicinals, the decay of the moment is fairly slow and one can observe that nearly all layers of the Pt slab have become polarised. On the other hand, the absence of a signi cant polarization of the substrate for the AFM m onow ire con guration indicates that the m agnetic coupling is strongly ferrom agnetic for the Pt vicinal surface. The magnetic moment associated with the vacuum sites is seen to be largest earlier in the d series, which is expected due to the larger spatial extent of the d orbitals for the early 3d transition m etals.

W e note that the values found here for the Co wire spin moment and associated substrate moments are in close agreement with the very similar vicinal studied experimentally by G am bardella<sup>1</sup> et. al.

The quantity  $E = E_{FM}$   $E_{AFM}$  is expected to pos-

sess two nodes across the d series and in Fig. 4 it can be seen that the second of these nodes occurs between M n and Fe, whereas the rst would likely be seen between Ti and V if the Timonowire was magnetic. Thus we nd that the V, Cr, and M n m onow ires prefer and AFM structure whereas Fe, Co, and Nimonowire prefer the FM structure. Turning now to the site projected energies one can see that the contribution to E from the vacuum and substrate sites is rather large away from the middle of the d-series. The origin of the importance of this term s lies in the very di erent polarization of the surrounding depending of the magnetic con guration of the wire. This might be expected to cause complications for approaches based on extracting e ective interactions for a Heisenberg model via the force theorem . In this case one does perturbation theory on a particular magnetic structure, and thus would be unable to take account of the change in energy coming from the change in polarization of the environm ent.

### VII. CONCLUSIONS

We have studied monowire of 3d elements deposited on Pt (311) and (533) vicinal surfaces using a real space order N method, and have investigated the convergence of various quantities as a function of the LIZ size. We demonstrate that the method is suitable for a quantitative determ ination of the magnetization energies of the monowires, although the calculation of step-step interactions would appear to be at the limit of what the method can achieve. Nevertheless, there are many interesting magnetic structures, such as magnetic vicinals, which could be calculated with this approach.
