# Random Aharonov-Bohm vortices and some funny families of integrals

#### Abstract

A review of the random magnetic impurity model, introduced in the context of the Quantum Hall effect, is presented. It models an electron moving in a plane and coupled to random Aharonov-Bohm vortices carrying a fraction of the flux quantum. Recent results on its perturbative expansion are given. In particular, some funny families of integrals show up to be related to the Riemann (3) and (2).


## 1 Introduction :

The single Aharonov Bohm (A-B) flux line (infinitely thin and impenetrable vortex) piercing the plane at a given point was considered in a seminal paper in 1959 A more complex system consists of several A-B lines piercing the plane at different points A simplification arises when the locations of the punctures are random : consider the Random Magnetic Impurity model introduced in the context of the Integer Quantum Hall Effect. It consists of an electron coupled to a Poissonian distribution of A-B lines (the so-called magnetic impurities) having a mean density and carrying a fraction of the electron flux quantum o. Periodicity ( $2[0 ; 1]$ ) and symmetry considerations (no priviledged orientation to the plane) allow to take $2[0 ; 1=2]$. The Poissonian disorder defines the infinitesimal probability $\mathrm{dP}\left(\mathbb{N} ; \Psi_{1}^{0} ; \Psi_{2}^{0} ;::: ; \varkappa_{N}^{0}\right)$ of finding $N$ impurities at position $\mathscr{x}_{1}^{0} ; \mathscr{x}_{2}^{0} ;::: ; \mathscr{\Psi}_{N}^{0}$

where is the mean impurity density : in the thermodynamic limit $\mathrm{N} ; \mathrm{V}$ ! 1 ( V the area of the plane), $\quad=\langle\mathrm{N}\rangle=\mathrm{V}$.

[^0]The model has two parameters, and . Periodicity ! + 1 and symmetry around $=1=2$ in the spectrum imply that the density of states and the partition function are invariant under ! 1 , thus depend in fact on and (1 ).

It has been shown via path integral random walk simulations that, when ! 0, the average density of states of the electron narrows down to the Landau density of states for the average magnetic field $\langle B\rangle=\quad$ o with broadened Landau levels (weak disorder). On the contrary, when ! $1=2$, the density of states has no Landau level oscillations and rather exhibits a Lifschitz tail at the bottom of the spectrum (strong disorder).

In the path integral formulation, the average partition function rewrites as an average over C, the set of closed Brownian curves of a given length $t$ (the inverse temperature)

where $S_{n}$ is the arithmetic area of the $n$-winding sector (i.e. the sector wounded around n times by the path) of a given path in $\mathrm{fCg}\left(\mathrm{Z}_{\mathrm{o}}\right.$ is the free partition function). It amounts to say that the Poissonian A-B lines couple to the $S_{n}$ 's, a different (intermediate) situation from the single A-B line, which couples to the angle spanned by the path around it, and from the homogeneous magnetic field, which couples to the algebraic area enclosed by the path. The average partition function rewrites as

Since $S_{n}$ scales like $t$-in fact $<S_{n}>=t=\left(2 n^{2}\right)$, even more, for $n$ sufficiently large, $n^{2} S_{n}!<n^{2} S_{n}>=t=(2)$, the variables $S$ and $A$ are indeed tindependent.

In fact, very little is known on the joint distribution function $P(S ; A)$ :

The partition function of the mean magnetic field $\mathrm{hB} i=$ 。 is reproduced as a power series in $(P)^{n}$ (mean field approximation where the local magnetic field $B(x)=\quad \underset{i=1}{N} \quad\left(x x_{i}^{0}\right)$ is replaced by its mean value). Perturbative corrections ${ }^{n}{ }^{m} ; m>n$ to the mean magnetic field expansion originate from disorder: in the 1-impurity case the correction is known $\left\langle\mathrm{Z}_{1}\right\rangle=\mathrm{Z}_{0}+\quad(\quad 1)=2$; in the 2-impurity case one encounters non trivial Feynman diagrams at order ${ }^{2}{ }^{4}$, i.e. an electron interacting with 2 impurities 4 times, at order ${ }^{2}{ }^{6}$, i.e. an electron interacting with 2 impurities 6 times, etc...

With these perturbative Feynman rules at hand, one can proceed with the perturbative expansion of the average partition function. The first non trivial diagram occurs at order ${ }^{2}{ }^{4}$. Denoting the temperature differences as $a=12 ; b=2 \quad 3 ; c=3 \quad 4 ; d=+4 \quad 1$, the momentum integration yields an integral over the temperatures

Indeed, integration by part (this exercice is left to the interested reader, use $\frac{d I_{0}(u)}{d u}=I_{1}(u)$ and $\left.\frac{d\left(u I_{1}(u)\right)}{d u}=u I_{0}(u)\right)$ gives $\quad$ that

$$
\begin{align*}
& p_{n+2}^{0}(000) \\
& p_{n+2}^{1}(111)
\end{align*}=\frac{1}{2^{5}(n+4)} \begin{array}{cccc}
(n+4)^{2}(5 n+14) & 3(n+4)^{2}(n+6) & (n+2)(n)(5 n+26) & p_{n}^{0}(000)  \tag{10}\\
p_{n}^{1}(111)
\end{array}
$$

and that all other integrals are given in terms of $p_{n}^{0}(000)$ and $p_{n}^{1}(111)$. For example

$$
\begin{aligned}
2^{5}(n+3)(n+4) p_{n+2}^{0}(011)= & +8(n+2)^{2}(n+4)^{2} p_{n}^{0}(011) \\
& (n+4)^{2}\left(3 n^{2}+15 n+14\right) p_{n}^{0}(000) \\
& +\quad n(n+2)\left(3 n^{2}+27 n+58\right) p_{n}^{1}(111)
\end{aligned}
$$

[^1]Amusingly enough, the recurrence is identical to up to n ! $n+2$ and to the off-diagonal global sign, the origin of which being easily tractable to the sign difference in the differentiation relations between $I_{0}$ and $I_{1}$ on the one hand, and $K_{0}$ and $K_{1}$ on the other hand.

Setting as above $\mathrm{n}=2 \mathrm{k} ; \mathrm{k} \quad 0$ and redifining

$$
\begin{aligned}
& q_{k}^{0}(0)=\frac{p_{2 k}^{0}(000)}{(2(k+1))!} \\
& q_{k}^{1}(1)=\frac{p_{2 k}^{1}(111)}{(2(k+1))!}
\end{aligned}
$$

the recurrence becomes

$$
\begin{aligned}
& q_{k+1}^{0}(0) \\
& q_{k+1}^{1}(1)
\end{aligned}=\frac{1}{2^{4}(2 k+3)} \begin{array}{rrc}
(5 k+7) & 3 k(k+1)^{2}=(k+2)^{2} & q_{k}^{0}(0) \\
3(k+3) & k(k+1)(5 k+13)=(k+2)^{2} & q_{k}^{1}(1)
\end{array}
$$

with again the eigenvalues $1=4$ and $1=(16)$ for the asymptotic matrix. The initial conditions are (by direct computation)

$$
\begin{gathered}
q_{0}^{0}(0)=\sim^{\sim}(2) \\
q_{0}^{1}(0)=\frac{1}{8}+3^{\sim}(2)
\end{gathered}
$$

where $\sim(2)=3 \quad(2)=2$.
To conclude a few remarks can be made: -in both recurrences, the building blocks, $\sim(2)=3(2)=2$ and $\sim(3)=$ 7 (3) =2, are not pure (n)'s, but rather (21) (n)'s. This indicates that one deals with alternated Euler sums,

$$
a(n)=x_{p=1}^{X^{n}} \frac{(1)^{p}}{p^{n}}
$$

or

$$
\sim(n)=\frac{(n)+{ }_{a}(n)}{2}=\frac{2^{n} \quad 1}{2^{n}}(n)
$$

-it has been impossible so far to generalize to (4); (5); :: in terms of simple integrals on the product of modified Bessel functions ${ }^{2}$. May be one should look at double nested integrals as indicated by computation at order ${ }^{2}{ }^{6}$.

[^2]is not simply given in terms of 's.
