G lobal phase diagram s of binary dipolar uid m ixtures

We apply a modiled mean-eld density functional theory to determ ine the phase behavior of binary mixtures of Stockmayer uids whose spherical constituents interact according to Lennard-Jones (LJ) pair potentials with embedded pointlike dipole moments. On the basis of systematic numerical calculations we construct the global phase diagrams of these systems in the three-dimensional thermodynamic space of temperature, pressure, and chemical potential dierence of the two components. The vapor-liquid, isotropic liquid (isotropic liquid, isotropic liquid (ferromagnetic liquid, and ferromagnetic liquid (ferromagnetic liquid rst-order phase separations are investigated. The loci of the second-order isotropic uid (ferromagnetic uid transition are calculated from Landau theory. Liquid-vapor and liquid-liquid critical lines, tricritical lines, triple lines, and lines of critical end points of the binary Stockmayermixtures are also determined. We discuss how the topology of the phase diagrams change upon varying the strengths of the two dipole moments of the two species as well as their sizes.

I. INTRODUCTION

There are various classes of uids whose structural and them odynam ical properties are strongly in uenced by the presence of either magnetic or electric dipolar interactions between their constituents: polar molecular liquids, dipolar liquid crystals, ferro uids, and magneto—or electrorheological uids. These systems respond to external electric or magnetic elds and some may even exhibit long-ranged spontaneous orientational order in the liquid phases. The strongly anisotropic and long-ranged character of the dipolar forces causes particular diculties for the theoretical description of these systems. By using simulations, integral equation theories, density functional theories, and phenomenological approaches signicant progress has been achieved in understanding one-component dipolar uids (see, e.g., Refs. [1] and [2] and references therein) albeit several aspects remain still under debate [3].

If isotropic phases of dipolar uids form interfaces (such as liquid-vapor or uid-wall interfaces) the broken translational invariance gives rise to interesting local orientational order tied to the interface [4, 5, 6, 7, 8]. Recently such orientational pro les have becom e experim entally accessible through ellipsom etry [9, 10, 11, 12]. In these experim ents the orientational order at (critical) liquid-liquid [9, 10] and at (noncritical) uid-vapor [11, 12] interfaces of several binary mixtures of polar (A) and nonpolar (B) components have been studied. In particular the growing spatial extension of orientational order normal to the interface and proportional to the bulk correlation length upon approaching the continuous demixing transition of A-rich and B-rich phases in the bulk has been analysed. These data have been discussed in terms of universal scaling functions. Various forms of their shape have been proposed [9, 10], including the occurrence of a surface correlation length di erent from the bulk correlation length [11, 12]. These surprising interpretations lack system atic theoretical analyses, which are particularly important because the ellipsom etry data provide only indirect access to orientational proles so that theoretical guidance is required. It is our goal to provide such system atic theoretical studies for the aforem entioned interfacial phenom ena near continuous demixing and to extend them to wetting phenomena. As a necessary rst step the present work aims at providing an overview of the global phase behavior of polar binary liquid mixtures. This is an indispensable prerequisite for studying the interfacial properties in a second step. Moreover, in view of the numerous interesting features even of bulk properties of dipolar uids [1, 2, 3], the analysis of dipolar mixtures is also important in its own right.

A lready some time ago there was an interesting rst step towards the understanding of interfacial properties of dipolar liquid mixtures. In a combined experimental and theoretical study the liquid-vapor surface tensions of two

polar binary liquid m ixtures have been studied for various temperatures and as function of composition [13]. Using density functional theory (DFT) also relative adsorption as well as concentration and orientational proles have been calculated [13]. By resorting to an improved DFT it is our intention to expand the above analysis towards focusing on liquid-liquid demixing transitions, the formation of phases with long-ranged orientational order, critical phenomena, and wetting phenomena and thus reaching out to the aforementioned more recent experimental studies.

There is a sizeable body of theoretical research available which is devoted to the study of bulk properties of polar liquid m ixtures. This encom passes M onte C ario simulations [14, 15, 16, 17, 18, 19, 20, 21, 22, 23], molecular dynamics simulations [16, 24, 25, 26, 27, 28, 29], integral equations [30, 31, 32, 33], cluster aggregation models [34, 35, 36, 37, 38], construction of equations of state [39], them odynamic perturbation theory [40, 41, 42, 43], structure formation in external elds [44], and van der W aals and Ising uids [45]. There are few theoretical studies concerning the structure formation of dipolar mixtures at interfaces such as DFT and M onte C arlo studies at charged walls [46, 47] and integral equation approaches for dipolar mixtures in random connect geometries [48, 49]. Beyond the aforementioned study in Ref. [13] the structure of dipolar mixtures at interfaces between uid phases has been investigated by M onte C arlo simulations of the liquid-liquid benzene-water interface [50] and by molecular dynamics simulations [51] and lattice-gas models [52] of the liquid-vapor interface of water-methanolmixtures. In the context of this body of research the present study is focused on obtaining global phase diagrams using an appropriate version of DFT which opens the possibility for interfacial studies later on.

M odels for dipolar uids have to capture three basic features of the pair potentials between the uid particles: short-ranged repulsion (which in general is anisotropic re-ecting molecular shapes), long-ranged attractive dispersion forces (containing an omnipresent isotropic contribution r^6 at large distances r between the particles plus higher order anisotropic terms), and the dipolar interaction r^3 .

As long as one is not aim ing for a quantitative description of a specic system but for general phenomena and trends the so-called Stockmayer model has turned out to be rather useful (see Refs. [1] and [2] and references therein). It considers spherical particles interacting with Lennard-Jones (LJ) potentials plus pointlike permanent dipoles at the center. Such binary systems are characterized by three them odynamic parameters (temperature T and two chemical potentials $_{\rm A}$ and $_{\rm B}$ for the two species A and B), three LJ interaction energy parameters $_{\rm ij}$ (i; j = A;B), three LJ molecular diameter parameters $_{\rm ij}$, and two dipole moments m $_{\rm A}$ and m $_{\rm B}$. A fiter choosing an energy scale for $k_{\rm B}$ T = $^{\rm 1}$ and the $_{\rm i}$ among the $_{\rm ij}$ and a length scale for the number densities among the $_{\rm ij}$ one is left with a six-dimensional interaction parameter space. By using DFT we analyze the three-dimensional (T;p;) phase diagrams (where p is the pressure of the system and = $_{\rm B}$ $_{\rm A}$) as they change along certain paths within suitable subspaces of this interaction parameter space.

This Stockm ayer model provides an approximate model for dipolar molecular uids as well as an elective model for ferrouids with the solvent degrees of freedom taken into account via elective interaction energies $_{ij}$. Ferrouids are often polydisperse [21, 53]. In this respect the study of binary Stockmayermodels provides also insight into the elects of polydispersity for ferrouids in the special case of bimodal distributions of their sizes or of their magnetic moments.

Whereas one-component uids with simple, radially symmetric pair potentials give rise to only two uid phases, i.e., liquid and vapor, binary uids exhibit typically three uid phases: vapor, A-rich liquid, and B-rich liquid. The latter two emerge via phase segregation from a homogeneous liquid upon lowering the temperature. There is a line of critical points (with high temperatures) limiting a two-dimensional sheet of rst-order liquid-vapor phase transitions, a line of critical points (at intermediate temperatures) limiting a two-dimensional sheet of rst-order demixing transitions into A-rich and B-rich liquid, and a triple line of phase coexistence between all three uid phases formed as the intersection of the two aforementioned sheets; at high temperatures the triple line ends at a critical end point where the line of critical demixing points meets the sheet of liquid-vapor coexistence (see, e.g., Ref. [54] and references therein). At low temperatures freezing sets in such that there the triple line ends in a tetra point where the vapor phase, A-rich liquid, B-rich liquid, and the solid phase coexist. (For the topology of this phase diagram see Ref. [55].) In the present study we focus on su ciently high temperatures so that freezing is not of concern. (For freezing in one-component dipolar uids see Ref. [2] and references therein. For quasicrystalline order and glasslike structure formation in two-dimensional binary dipolar systems see Refs. [56, 57, 58].) The introduction of dipole moments shifts these phase boundaries and may even give rise to the formation of new liquid phases with spontaneous long-ranged orientational order.

In a recent series of papers [59, 60, 61] Range and K lapp have also extended the modi ed mean-eld density functional theory to study the phase behavior of binary dipolar mixtures. There they have focused on the investigation of the isotropic uid { ferrom agnetic uid phase separations. Studying dipolar hard sphere mixtures (and brie y mentioning binary Stockmayer uid mixtures in Ref. [60]) they have found that the isotropic uid { ferrom agnetic uid phase transitions are shifted towards higher densities as compared with the corresponding one-component dipolar uids. These general trends are in agreement with our ndings for the corresponding phase transitions in binary Stockmayer uid mixtures. However, there are important dierences to the case of dipolar hard sphere systems,

because due to the additional presence of isotropic dispersion forces Stockm ayer uids exhibit also a vapor phase, which is indispensable for studying the interfacial properties mentioned at the beginning of the Introduction. These dispersion forces modify also the other phase transitions. Therefore in the following we explore the wider phase behavior of binary Stockm ayer uid mixtures. In Sec. II we formulate the DFT for Stockm ayer uid mixtures. Our results are presented in Sec. III and sum marized and discussed in Sec. IV.

II. DENSITY FUNCTIONAL THEORY FOR STOCKMAYER FLUID MIXTURES

A. M icroscopic m odel

We study binary Stockm ayer uids which consist of spherically symmetric particles interacting via Lennard-Jones (LJ) potentials with parameters $_{ij}$ and $_{ij}$ (i; j = A; B):

In the following for the unlike LJ size parameter we assume $_{ij} = (_{ii} + _{jj})=2$. In addition there is the dipolar interaction due to point dipoles embedded at the centers of spheres of diameter $_{ii}$:

where particle 1 (2) of type i (j) is located at r_1 (r_2) and carries a dipole moment of strength m_i (m_j) with an orientation given by the unit vector m_1 (!1) (m_2 (!2)) with polar angles !1 = (1;1) (!2 = (2;2)); $r_{12} = r_1 - r_2$ is the dierence vector between the centers of the particle i and the particle j with $r_{12} = jr_{12}$ jand (r) is the Heaviside step function. Thus the total pair potential is given by

In order to apply density functional theory, following Barker and Henderson [62] this interaction potential is decomposed into a short-ranged repulsive reference part

This decomposition allows one to choose a suitable reference system (a hard sphere system with temperature dependent diameters) for which reliable approximations for the free energy are known. The excess part w_{ij}^{exc} (r_{12} ; ! 1; ! 2) is treated perturbatively in a suitable way (see below).

B. Modied mean-eld density functional theory

Our analysis is based on the following grand canonical variational functional, which is the binary extension of the one component functional used in Refs. [63] and [64]:

where V , T , and $_{i}$ denote the volume of the uid, its temperature, and the chemical potential of the ith component, respectively, $= 1 = (k_B T)$ with the Boltzmann constant k_B , $_{i} = N_{i} = V$ is the number density of the species i taken to be spatially constant for the present bulk study. $_{i}(!)$ is the orientational probability density distribution (i.e., $_{i}(!) = _{i}(!)$) with $_{i}(!) = 1$ is the number density of particles of type i with orientation!). The rst term in Eq. (6) is the free energy density of the reference system due to M ansooriet al. [65]:

For $_{AA} = _{BB}$ Eq. (7) reduces to the Camahan-Starling formula. In Eq. (6) the second contribution to the grand canonical functional takes into account the loss of entropy if the orientational distributions of the particles are not isotropic. For the interaction contribution due to the long-ranged part of the pair potential between the spherical particles with embedded point dipoles we adopt

Following Refs. [63, 64] in order to calculate the spatial integrals in Eq. (10) we consider a nite volume V which has the shape of a prolate rotational ellipsoid with aspect ratio k (k-1). The M ayer functions can be expressed in terms of the rotational invariants $a_{1,1,2}$ (for the denition of these functions see, e.g., Ref. [64]) so that the corresponding integrals yield

These results show that the knowledge of the functions $u_{ij}^{(l)}$ (T) is necessary to obtain the coe cients $i^{(l)}$ of the orientational distribution functions (Eq.(25)) and to obtain the dierent therm odynamic functions (Eqs. (26-28)).

In computing these functions we use the same approximations as in Ref. [64], i.e., we expand the Mayer functions in Eq. (16) for small dipole moments m_i which allows us to perform the angular integrations analytically. As in Ref. [64] we have determined the expansion coe cients up to 0 (m 8). This gives a satisfactory accuracy for reduced dipole moments $m_i^2 = m_i = \frac{1}{AA} \frac{3}{AA}$. 2 [64]. The omission of the higher order terms implies a truncation in the sum mations at l=4 in all equations which contain such a sum mation over l. The corresponding coe cients $u_{ij}^{(l)}(T)$

C. Phase equilibria and phase diagram s

The phase diagram s at a given tem perature T follow from requiring the equality of the chem ical potentials of both components and of the pressure for the densities i and i characterizing the coexisting phases I and II:

The functions $_{i}^{(I)}$ (x) and $_{i}^{(II)}$ (x) (i = A;B) denote the corresponding equilibrium orientational distributions obtained from Eqs. (25) and (22). As mentioned in the Introduction we consider four kinds of two-phase equilibria: isotropic liquid { isotropic vapor, isotropic A-rich liquid { isotropic B-rich liquid, isotropic liquid { ferrom agnetic liquid, and ferrom agnetic A-rich liquid { ferrom agnetic B-rich liquid. For binary uids G ibbs' phase rule allows for three-phase coexistence lines and four-phase (tetra) coexistence points in the therm odynam ic space (T;p;). For isotropic phases the corresponding equations for the chem ical potentials and the pressure are simpler because for them $_{i}$ (x) = 1=2 (i.e., $_{i}$ (0) = 1=2 and $_{i}$ 0 if 1 1).

In order to locate the surface of critical points separating the isotropic and the ferrom agnetic liquid phases by second-order phase transitions, similar as in Ref. [64] we expand the orientation dependent ideal gas contributions to the interaction part $_{\rm int}$ of the grand canonical functional for small deviations from isotropy, i.e., for small $_{\rm i}^{(1)}$. Using the results for the one component dipolar uid with l=1 the leading orientation dependent contribution to the grand canonical potential turns out as

where $_{ij}$ is the K ronecker delta symbol. Obviously, for given , A, and B the isotropic conguration minimizes the grand canonical functional if the quadratic form dened by Eq. (36) is positive denite. Provided $_{A}u_{AA}^{(1)} + 2 = (3) > 0$, this quadratic form is positive denite if and only if its determinant is positive [66]. For all the cases studied it turns out that this inequality is satistical. Thus the zero of the determinant denes the surface which separates the isotropic liquid phase from the ferromagnetic liquid phase:

In the one-component limit Eq. (37) reduces to the equation for the critical line given in Ref. [64].

III. RESULTS AND DISCUSSION

In the following we shall use reduced quantities: $T^? = k_B T = _{AA}$ as reduced temperature, $^? = (_A + _B)_{AA}^3$ as reduced total density, $x_i = _{i} = (_A + _B)$ as the concentration of species i, $p^? = p_{AA}^3 = _{AA}^3$ as reduced pressure, $_i^? = (_i k_B T \ln (_i^3 = _{AA}^3)) = _{AA}^3$ as the reduced chemical potential of species i, and $m_i^? = m_i = _{AA}^3 = _{AA}^3$ as the reduced dipole moments. For our numerical analysis we consider the following choices for the Lennard-Jones potential parameters: $_{BB} = _{AA} = 0.95$, $_{AB} = _{AA} = 0.75$, and $_{AA} = _{BB} = _{AB}$. The case $_{AA} \in _{BB}$ will be discussed in Subsec. III C. The bulk phase diagrams of the binary dipolar uid mixtures are calculated in the them odynamic space spanned by temperature T, pressure p, and the difference of the chemical potentials $= _{B} = _{A}$ of the two components. In order to obtain the phase boundaries in this space for xed T the corresponding phase equilibrium equations (Eq. (35)) have to be solved simultaneously under the constraint

The pressure p follows from Eq. (28).

A. B inary m ixtures of particles with equal size and equal dipole m om ent

As a rst step we have determ ined the phase diagram s of non-polar binary Lennard-Jones uid mixtures (m $_{\rm R}^2$ = 0) for the aforementioned parameters. Based on our systematic calculations in the thermodynamic space (T;p;) these phase diagrams take on shapes as shown schematically in Fig. 1(a). S_1 and S_2 are sheets of rst-order phase transitions separating the vapor phase from the uid phase and the A-rich liquid phase from the B-rich liquid phase, respectively. These sheets are bounded by lines L_1 and L_2 , respectively, of second-order phase transitions marking the onset of liquid-vapor separation (L_1) and demixing (L_2) upon lowering the temperature. The intersection of S_1 and S_2 forms the triple line TL of three-phase coexistence ending at the critical end point CEP where L_2 hits S_1 . This type of phase diagrams corresponds to type II in the classication scheme of phase diagrams of binary uid mixtures given by Scott and van K onynenburg [67, 68]. For the non-polar binary uid mixture Fig. 2 presents our numerical results for the pressure-temperature (Fig. 2(a)) and the density-temperature (Fig. 2(b)) phase diagrams for $\frac{1}{2} = 0.3$. At low temperatures (T < $\frac{1}{2}$) the A-rich liquid coexists with the vapor. At the triple point temperature $\frac{1}{2}$ = 1.003 three phases coexist: vapor, B-rich liquid, and A-rich liquid. Above $\frac{1}{2}$ up to the liquid-vapor critical temperature ($\frac{1}{2}$) = 1.153) there is coexistence between the vapor and the B-rich liquid and between the A-rich liquid and the B-rich liquid. In the temperature range $\frac{1}{2}$ 0 < T < $\frac{1}{2}$ 1 with $\frac{1}{2}$ 2 there is only coexistence between the A-rich liquid and the B-rich liquid and the B-rich liquid.

Figure 1 (b) shows the schem atic phase diagram of the binary liquid m ixture with the same LJ param eters but with m $_{\rm A}^2$ = m $_{\rm B}^2$ = 1. The occurrence of a ferrom agnetic phase gives rise to the appearance of the sheet S $_3$ which separates the isotropic liquid at high tem peratures from the ferrom agnetic liquid at low tem peratures. The nature of this sheet S $_3$ di ers from that of S $_1$ and S $_2$ in that S $_3$ is the locus of second-order phase transitions. In the them odynam is space (T;p;) the surface S $_3$ is given by the simultaneous solution of Eqs. (37) and (38). (With the knowledge of A, B, and T Eq. (28) gives the corresponding pressure p, using the fact that on S $_3$ in the ferrom agnetically critical liquid phase coexists with the isotropic vapor phase. The other line M $_2$ of critical end points is given by the intersection of the sheets S $_2$ and S $_3$. The sheet S $_3$ divides the triple line into two parts. The upper part describes isotropic vapor { isotropic B-rich liquid { isotropic A-rich liquid three-phase coexistence, while the low erpart describes an isotropic vapor { ferrom agnetic B-rich liquid { ferrom agnetic A-rich liquid coexistence. B oth critical lines L $_1$ and L $_2$ are in the isotropic part of the them odynam is space (T;p;). Figure 3 shows the corresponding results of our




FIG. 1: Schem atic bulk phase diagram s of binary Stockm ayer uid m ixtures in the therm odynam ic space of temperature T, pressure p, and chem ical potential di erence = B A of the two components for various equal dipole m om ents. The phase diagram in (a) represents a non-polar (m $_{A}^{?}$ = m $_{B}^{?}$ = 0) binary uid m ixture which exhibits three phases: vapor, A-rich liquid, and B-rich liquid. They are separated by sheets S_1 and S_2 of rst-order phase transitions, delim ited by lines L_1 and L_2 , respectively, of second-order phase transitions. S_1 and S_2 intersect along the triple line TL which ends at the critical end point CEP. The phase diagram in (b) represents a dipolar ($m_A^2 = m_B^2 = 1$) binary uid mixture for which a third sheet S3 (hatched) appears, which separates the isotropic liquid from the ferrom agnetic liquid. S3 is a sheet of second-order phase transitions. The intersection of the sheets S_1 and S_3 form sa line M_1 of critical end points. The intersection of the sheets S_2 and S_3 form s another line M 2 of critical end points. Upon increasing the dipole m om ents (m $_A^2$ = m $_B^2$ = 1.5) in (c) the sheet S_3 has been raised above L1 and has merged with S1 into the sheet S1 [S3 with a tricritical line (TC-line), which separates the rst-order transition (lower part of the sheet) from the second-order transition (hatched upper part). The isotropic liquid-vapor transitions are reduced to two winglike surfaces, which are connected to the sheet S_1 [S_3 along the triple lines TL₁ and TL₁. These triple lines end in critical end points $C \to P_1$ and $C \to P_1^0$. The liquid-vapor critical lines L_1 and L_1^0 are the upper edges of the wings. Upon a further increase of the dipole moments (m $_{

num erical calculations for a binary Stockm ayer—uid m ixture with dipole m oments m $_A^2$ = m $_B^2$ = 1 for $_A^2$ = 0.3. The intersection of the plane— $_A^2$ = 0.3 with the sheet S_3 yields the critical (dotted) line in Fig. 3 (a). Its intersection with the rst-order coexistence curve between vapor and ferrom agnetic A—rich liquid is the critical end point CEP with T_{CEP}^2 = 1.082, p_{CEP}^2 = 0.03, and p_{CEP}^2 = 0.74 at p_{CEP}^2 = 0.3. Below T_{CEP}^2 the isotropic vapor phase coexists with the ferrom agnetic A—rich liquid. The critical line of second—order phase transitions divides the A—rich liquid into an isotropic A—rich liquid phase and into a ferrom agnetic A—rich liquid phase. In the tem perature range T_{CEP}^2 < T < T_{tr}^2 with T_{tr}^2 = 1.12 the isotropic vapor coexists with an isotropic A—rich liquid phase. Above the triple point tem perature there is also coexistence between the isotropic B—rich liquid and the isotropic A—rich liquid. This rst—order phase transition ends in the critical tem perature $T_c^{(ll)}$ = 1.404. The critical tem perature of the isotropic vapor { isotropic B—rich liquid coexistence is $T_c^{(lv)}$ = 1.296.

Upon increasing the dipole moments the phase diagram shown in Fig. 1(b) changes in two respects. First, the sheet S_3 is raised due to the strengthening of orientational ordering. Second, close to the line M $_1$ the character of the ferrom agnetic – isotropic phase transition on S_3 becomes rst-order such that a line of tricritical points (TC) emerges




FIG. 2: Phase diagrams of a non-polar ($m_{A}^{2} = m_{B}^{2} = 0$) binary Lennard-Jones uid mixture in the pressure-tem perature (a) and density-tem perature (b) plane for $^{?} = 0.3$; $_{BB} = _{AA} = 0.95$, $_{AB} = _{AB} = 0.75$, $_{AA} = _{BB} = _{AB}$. T_{tr} , $T_{c}^{(lv)}$, and $T_{c}^{(lll)}$ denote the triple, liquid-vapor critical, and liquid-liquid critical tem perature, respectively. In (a) all lines are lines of rst-order phase transitions. The vapor phase occurs only at very low pressure. In (b) the full curves enclose two-phase regions. The dashed line indicates three-phase coexistence. Below the triple point tem perature the vapor coexists with the A-rich liquid. Between T_{tr} and $T_{c}^{(lv)}$ there are three possible phases: the vapor, the isotropic B-rich liquid, and the A-rich liquid. Between $T_{c}^{(lv)}$ and $T_{c}^{(lll)}$ there is only B-rich liquid (A-rich liquid coexistence. At high densities the system freezes. The corresponding solid phases are not shown because they are not accessible by the present theory.




FIG. 3: Phase diagram s of a binary Stockm ayer uid m ixture for m $_{\rm R}^2$ = m $_{\rm B}^2$ = 1 in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm R}^2$ = 0:3. The LJ param eters are the same as in Fig. 2. The dotted line denotes a line of second-order phase transitions. It ends at a critical end point (CEP) where the ferrom agnetically critical liquid coexists with the non-critical vapor. The critical line divides the A-rich liquid region into an isotropic and ferrom agnetic part. For more details see the caption of Fig. 2.

from M $_1$ and separates the sheet S $_3$ into a continuous part (back part at high p and hatched) and a rst-order part (front part at lower p and unhatched). This implies that M $_1$ turns into a triple line T L $_1^2$. Upon further increase of m $_A$ and m $_B$ this sheet S $_3$, divided by the T C -line, raises nally above the line L $_2$. Moreover the upper part of S $_1$, i.e., above T L $_1^2$ disintegrates into a left and right part leaving a gap between them . This means that T L $_1^2$ is split into T L $_1$ and T L $_1^0$ and L $_1$ into L $_1$ and L $_1^0$ in F ig. 1(c). This also generates two critical end points C E P $_1$ and C E P $_1^0$ which are raised above C E P . Figure 1(c), corresponding to m $_1^2$ = m $_1^2$ = 1.5, displays this latter structure with S $_1$ [S $_2$ denoting the sheet which emerged from the lower part of S $_1$ in Fig. 1(b) and S $_2$ whereas the winglike structures in F ig. 1(c) are the rem nants of the upper part of S $_1$ in F ig. 1(b). They are connected to the sheet S $_1$ [S $_2$ along the triple lines T L $_1$ and T L $_1^0$ and bounded by the liquid-vapor critical lines L $_1$ and L $_1^0$. The isotropic vapor { isotropic uid { ferrom agnetic liquid triple lines T L $_1$ and T L $_1^0$ end in critical end points C E P $_1$ and C E P $_1^0$. S $_2$ and S $_1$ [S $_3$




FIG. 4: Projections onto a plane p=const of the triple lines and of the liquid-vapor critical lines of a binary Stockm ayer—uid mixtures with $m_A^2 = m_B^2 = 1.5$; the LJ parameters are the same as in Figs. 2 and 3. In accordance with Fig. 1(c) along TL there is isotropic vapor { A-rich ferrom agnetic liquid { B-rich ferrom agnetic liquid three phase coexistence. This triple line ends at a critical end point (CEP). Both TL1 and TL1 describe isotropic vapor { isotropic uid { ferrom agnetic uid three-phase coexistence. These two triple lines end at critical end points CEP1 and CEP1. The dashed lines L1 and L1 represent the projections of the liquid-vapor critical lines delim iting the upper end of the wings shown in Fig. 1(c). Note that as in Fig. 1 increases towards the left.




FIG. 5: Phase diagrams of a binary Stockmayer uid mixture for $m_A^2 = m_B^2 = 1.5$ (compare Fig. 1(c)) in the pressure-temperature (a) and density-temperature (b) plane for $m_A^2 = 4$; the LJ parameters are the same as in Figs. 2-4. Below the triple point temperature T_{tr} the isotropic vapor coexists with the ferrom agnetic liquid. Between T_{tr} and $T_c^{(lv)}$ there are three possible phases: the isotropic vapor, the isotropic liquid, and the ferrom agnetic liquid. The rst-order phase transition between the isotropic uid and ferrom agnetic liquid turns into a second-order phase transition at the tricritical temperature T_{trc} . Above the tricritical temperature the dotted line represents the corresponding line of critical points. For the value of the chemical potential difference $m_c^2 = 4$ there is no A-rich liquid { B-rich liquid phase separation (i.e., the plane $m_c^2 = 4$ does not intersect the sheet S_2 ; see Figs. 1 and 4). For more details see the caption of Fig. 2.

intersect along the triple line TL which ends at the critical end point CEP.

Figure 4 shows the corresponding results for the projections of the triple lines and of the liquid-vapor critical lines of a binary Stockm ayer—uid m ixture with dipole m oments m $_{\rm A}^2$ = m $_{\rm B}^2$ = 1.5 onto a plane p = const. The triple line TL describes the isotropic vapor { ferrom agnetic A—rich liquid { ferrom agnetic B—rich liquid three-phase coexistence with the critical end point tem perature $T_{\rm CEP}^2$ = 1.614. The triple lines TL 1 and TL 1 associated with the two winglike surfaces (see Fig. 1(c)) describe the isotropic vapor { isotropic—uid { ferrom agnetic A—rich liquid and isotropic vapor { isotropic—uid { ferrom agnetic B—rich liquid three-phase coexistences with the critical end point tem peratures $T_{\rm CEP}^2$ = 1.764 and $T_{\rm CEP}^2$ = 1.747.

Figure 5 presents our num erical results for a binary Stockm ayer uid m ixture with dipole m om ents $m_{\lambda}^2 = m_{R}^2 = 1.5$




FIG. 6: Phase diagrams of a binary Stockm ayer—uid m ixture with m $_{\rm A}^2$ = m $_{\rm B}^2$ = 1.5 (compare Fig. 1(c)) in the pressure-tem perature (a) and density-tem perature (b) plane for— 2 = 0.4; the LJ parameters are the same as in Figs. 2-5. For this choice of—, below the isotropic vapor { ferrom agnetic A -rich liquid { ferrom agnetic B -rich liquid triple point tem perature T $_{\rm tr}$ the isotropic vapor coexists with the ferrom agnetic A -rich liquid. Between $_{\rm tr}$ and $_{\rm C}^{(11)}$ there are three possible phases: the isotropic vapor, the ferrom agnetic B -rich liquid, and the ferrom agnetic A -rich liquid. In (b) the two-phase region of A -rich and B -rich liquid coexistence ending at $_{\rm Tc}^{(11)}$ is rather narrow. Between $_{\rm Tc}^{(11)}$ and the tricritical tem perature $_{\rm trc}$ the isotropic vapor coexists with the B -rich ferrom agnetic liquid. A bove the tricritical tem perature $_{\rm trc}$ the transitions between the isotropic and ferrom agnetic—uid are continuous and their loci are given by the dotted critical line. The dash-dotted line in (b) indicates the therm odynam ically unstable isotropic liquid { vapor coexistence.




FIG. 7: Phase diagrams of a binary Stockm ayer—uid mixture with $m_A^2 = m_B^2 = 2$ (compare Fig. 1(d)) in the pressure-tem perature (a) and density-tem perature (b) plane for $m_A^2 = 0.5$; the LJ parameters are the same as in Figs. 2-6. Below the triple tem perature $T_{\rm tr}$ the isotropic vapor coexists with a ferrom agnetic A-rich liquid. The vapor phase occurs at such small values of p and—that it is not visible on the scales shown in (a) and (b). Within the very narrow tem perature range $T_{\rm tr} < T < T_c^{(11)}$ there are three possible phases: the isotropic vapor, the ferrom agnetic B-rich liquid, and the ferrom agnetic A-rich liquid. Above the ferrom agnetic B-rich liquid (ferrom agnetic A-rich liquid critical tem perature $T_c^{(11)}$ there is only coexistence between the isotropic—uid and the B-rich ferrom agnetic liquid. Above the tricritical tem perature $T_{\rm tr}$ these phase transition are continuous forming the dotted critical line.

for $^?=4$. For this choice of at the triple point T $_{\rm tr}$ the following three phases coexist: vapor, isotropic uid, and ferrom agnetic liquid. At low tem peratures T < T $_{\rm tr}$ with T $_{\rm tr}^?=1:768$ the ferrom agnetic liquid coexists with the isotropic vapor. Above the triple point tem perature, two isotropic uids coexist at low and moderate densities, becoming identical above the liquid-vapor critical temperature T $_{\rm c}^{\rm (lv)?}=1:788$. (The corresponding critical pressure and density are $p_{\rm c}^{\rm (lv)?}=0:185$ and $p_{\rm c}^{\rm (lv)?}=0:286$, respectively.) At higher densities, the isotropic liquid and magnetic liquid are separated by a rest-order phase transition which becomes second order above the tricritical temperature

 $T_{\rm trc}^2=1.954$. (The corresponding tricritical pressure and density are $p_{\rm trc}^2=0.964$ and $\frac{2}{\rm trc}=0.579$, respectively.) The critical line of second-order phase transitions divides the liquid range into an isotropic liquid phase and into a ferrom agnetic liquid phase. At this value of the chem ical potential dierence there is no A-rich liquid $\{B-rich \ liquid \ dem \ ixing \ phase \ separation.$

Figure 6 shows our num erical results for a binary Stockm ayer—uid mixture with dipole moments m $_{\rm A}^2$ = m $_{\rm B}^2$ = 1.5 for— 2 = 0.4. At the triple point tem perature $T_{\rm tr}$ the coexisting phases are: vapor, ferrom agnetic B—rich liquid, and ferrom agnetic A—rich liquid. At low tem peratures $T < T_{\rm tr}$ with $T_{\rm tr}^2$ = 1.512 the isotropic vapor phase coexists with the ferrom agnetic A—rich liquid. Above the triple point tem perature, an isotropic vapor coexists with a ferrom agnetic B—rich liquid and a ferrom agnetic B—rich liquid coexists with a ferrom agnetic A—rich liquid. The two ferrom agnetic liquid phases become identical beyond the liquid—liquid critical point $T_{\rm c}^{\rm (II)}$ with $T_{\rm c}^{\rm (III)}$? = 1.694. (The corresponding critical pressure and density are $p_{\rm c}^{\rm (III)}$? = 16.83 and $p_{\rm c}^{\rm (III)}$? = 1.17, respectively, at $p_{\rm c}^{\rm (III)}$? = 0.4.) Above the ferrom agnetic A—rich liquid (ferrom agnetic B—rich liquid critical tem perature $p_{\rm c}^{\rm (III)}$? the isotropic liquid and ferrom agnetic B—rich liquid are separated by a rst-order transition which turns second order above the tricritical tem perature $p_{\rm crit}^2$ = 1.918. (The corresponding tricritical pressure and density are $p_{\rm crit}^2$ = 0.994 and $p_{\rm crit}^2$ = 0.568, respectively, at $p_{\rm crit}^2$ = 0.4.) At tem peratures $p_{\rm crit}^2$ 0 and $p_{\rm crit}^2$ 1 are peratures $p_{\rm crit}^2$ 2 and $p_{\rm crit}^2$ 3 and $p_{\rm crit}^2$ 4 are peratures $p_{\rm crit}^2$ 4 and $p_{\rm crit}^2$ 5 and $p_{\rm crit}^2$ 6 and $p_{\rm crit}^2$ 6 and $p_{\rm crit}^2$ 7 and $p_{\rm crit}^2$ 8 are peratures $p_{\rm crit}^2$ 9 and $p_{\rm c$

Fig. 1(d) shows that by further increasing the dipole m oments (m $_{\rm A}^{\, 2}$ = m $_{\rm B}^{\, 2}$ = 2) the winglike surfaces associated with the isotropic liquid { isotropic vapor transition disappear and only the two sheets S_2 and S_1 [S_3 remain. A coordingly there is only one triple line TL, which describes the isotropic vapor, ferrom agnetic A-rich liquid, and ferrom agnetic B-rich liquid three-phase coexistence and which ends at the critical end point CEP where L_2 hits S_1 [S_3 . Since the sheet S_2 bounded by L_2 lies beneath the sheet S_1 [S_3 all rst-order liquid-liquid phase separations involve ferrom agnetic phases.

Figure 7 shows our num erical results for a binary Stockm ayer—uid m ixture with dipole m oments m $_{\rm A}^2$ = m $_{\rm B}^2$ = 2 for— $_{\rm C}^2$ = 0.5. The topology of Fig. 7 is the same as in Fig. 6, only the num erical values for the triple, critical, and tricritical points are di-erent. Below the triple point temperature $T_{\rm tr}^2$ = 1.961 (with $p_{\rm tr}^2$ = 0.002 at— $_{\rm C}^2$ = 0.5) an isotropic vapor coexists with a ferrom agnetic A-rich liquid. The ferrom agnetic liquid-liquid critical point is given by $T_{\rm c}^{(11)^2}$ = 1.98, $p_{\rm c}^{(11)^2}$ = 7.59, and $p_{\rm c}^{(11)^2}$ = 1.2, while the tricritical point is given by $p_{\rm trc}^2$ = 3.17, $p_{\rm trc}^2$ = 2.06, and $p_{\rm trc}^2$ = 0.528.

B. Binary liquid mixtures of non-polar and polar particles of equal size

In this subsection we present our results for phase diagrams of non-polar (m $_{\rm A}^{?}$ = 0) { polar (m $_{\rm B}^{?}$ § 0) binary m ixtures. The corresponding schematic phase diagrams are shown in Fig. 8. In order to provide a convenient visual com parison Fig. 8 (a) shows again as a reference case the schematic phase diagram of a non-polar binary Lennard-Jones uid m ixture (m $_A$? = m $_B$? = 0) with the parameter set $_{BB}$ = $_{AA}$ = 0:95, $_{AB}$ = $_{AA}$ = 0:75 and $_{AA}$ = $_{BB}$ = $_{AB}$. Figure 8 (b) shows the schematic phase diagram of the binary liquid mixture with the same LJ parameters but with $m_A^2 = 0$ and $m_R^2 = 1$. Similar to Fig. 1(b) the occurrence of a ferrom agnetic phase gives rise to the appearance of the sheet S3 of second-order phase transitions which separates the isotropic liquid phase from the ferrom agnetic liquid phase. The ferrom agnetic phase appears only in the B-rich liquid phase and at low temperatures while the A -rich liquid phase remains isotropic even at low temperatures. This behavior re ects the polar (B) and non-polar (A) character of m olecules. In accordance with this asymmetry the sheet S_3 is tilted, ends at S_2 and thus does not cut through the sheet S_2 . This leads to the line M $_2$ of critical end points. The intersection of S_3 and S_1 form s another line M₁ of critical end points. The triple line (TL) is given by the intersection of S₁ and S₂. The line M₁ of critical end points divides the triple line into two parts. The upper part of the triple line describes isotropic vapor (isotropic B-rich liquid { isotropic A-rich liquid three-phase coexistence as in the case of symmetric dipolar mixtures with dipole m om ents m $_{\rm A}^2$ = m $_{\rm B}^2$ = 1 (see Fig. 1(b)). The lower part of the triple line describes isotropic vapor { ferrom agnetic B-rich liquid (isotropic A-rich liquid coexistence.

Figure 9 shows our numerical indings for a binary Stockmayer uid mixture with dipole moments m $_{\rm A}^2=0$ and m $_{\rm B}^2=1$ for $_{\rm C}^2=0.27$. Figure 9(a) demonstrates that for this value of the chemical potential difference the plane $_{\rm C}^2=0.27$ cuts through the upper part of the triple line TL in Fig. 8(b) so that the corresponding triple point $_{\rm C}^2=0.101$.




FIG. 8: Schem atic bulk phase diagram s of binary Stockm ayer—uid m ixtures in the therm odynam ic space of temperature T, pressure p, and chem ical potential difference—= $_B$ $_A$ of the non-polar ($m_A^2 = 0$) and polar ($m_B^2 \neq 0$) components. For reference purposes the phase diagram in (a) represents the same non-polar ($m_A^2 = m_B^2 = 0$) binary—uid m ixture as in Fig.1 (a). The phase diagram in (b) represents a non-polar (dipolar ($m_A^2 = 0$, $m_B^2 = 1$) binary—uid m ixture for which in comparison with (a) a third sheet S_3 —(hatched) appears, which separates the B-rich isotropic liquid from the B-rich ferrom agnetic liquid. S_3 is a sheet of second-order phase transitions. M_1 and M_2 represent lines of critical end points at the intersection of S_3 with S_1 and S_2 , respectively. In (a)-(d) the A-rich liquid is always isotropic. Upon increasing the dipole moment of the component $M_A^2 = 0$, $M_B^2 = 1.5$) in (c) the tilted sheet $M_A^2 = 0$, M_A^2

The intersection of the plane $_{\rm C}^2=0.27$ with the line M $_{\rm C}$ in Fig. 8(b) gives the critical end point CEP where an isotropic vapor coexists with a ferrom agnetically critical B-rich liquid. The them odynamic parameters of this critical end point CEP are given by $_{\rm CEP}^2=0.107$, $_{\rm CEP}^2=0.043$, and $_{\rm CEP}^2=0.74$, respectively, for $_{\rm CEP}^2=0.27$. Below the temperature $_{\rm CEP}^2$ the isotropic vapor phase coexists with the ferrom agnetic B-rich liquid phase. Between the temperatures $_{\rm CEP}^2$ and $_{\rm CEP}^2$ two phases coexist: the isotropic vapor and the B-rich isotropic liquid. Above $_{\rm Tt}^2$ up to the liquid-vapor

critical tem perature ($T_c^{(lv)}$? = 1:19) coexistence is possible between the vapor and the A-rich isotropic liquid phase and between the A-rich isotropic liquid and the B-rich isotropic liquid. In the tem perature range $T_c^{(lv)} < T < T_c^{(ll)}$ with $T_c^{(ll)}$? = 1:23 coexistence is possible only between the isotropic A-rich and B-rich liquid phases. (The corresponding critical densities are $c_c^{(lv)}$? = 0:31 and $c_c^{(ll)}$? = 0:55, respectively.)

Figure 10 shows our numerical results for a binary Stockmayer—uid mixture with dipole moments $m_{\hat{A}}^2 = 0$ and $m_{\hat{B}}^2 = 1$ for $m_{\hat{B}}^2 = 0.54$. The critical pressure and density of liquid-vapor coexistence are $m_{tr}^2 = 0.122$ and $m_{tr}^2 = 0.285$, respectively. The A-rich isotropic liquid { B-rich ferrom agnetic liquid phase coexistence extends to higher temperatures. The corresponding liquid-liquid critical point is not attainable at physically relevant—uid densities. (A thigh densities the system freezes, but the corresponding solid phases are not captured within the framework of the present theory.)




FIG. 9: Phase diagrams of a non-polar { polar (m $_{\rm A}^2$ = 0, m $_{\rm B}^2$ = 1) binary Stockmayer uid mixture (compare Fig. 8(b)) in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm CEP}^2$ = 0.27. The LJ parameters are the same as in Fig. 2. Below the critical end point (CEP) tem perature $T_{\rm CEP}^2$ the isotropic vapor coexists with the B-rich ferrom agnetic liquid. Between $T_{\rm CEP}^2$ and $T_{\rm tr}^2$ the isotropic vapor coexists with the B-rich isotropic liquid. Between $T_{\rm c}^2$ and $T_{\rm c}^2$ there are three possible phases: the vapor, the A-rich isotropic liquid, and the B-rich isotropic liquid. Between $T_{\rm c}^2$ and $T_{\rm c}^2$ and $T_{\rm c}^2$ only A-rich isotropic liquid (B-rich isotropic liquid) and the B-rich denotes a line of second-order ferrom agnetic phase transitions. It ends at a critical end point CEP.




FIG. 10: Phase diagram s of a binary Stockm ayer uid m ixture for m $_{\rm A}^{?}=0$ and m $_{\rm B}^{?}=1$ (com pare Fig. 8(b)) in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm C}^{?}=0.54$; the LJ param eters are the same as in Fig. 2. Below the triple point tem perature $T_{\rm tr}$ the isotropic vapor coexists with the B-rich ferrom agnetic liquid. Between $T_{\rm tr}$ and $T_{\rm c}^{\rm (lv)}$ there are three possible phases: the vapor, the A-rich isotropic liquid, and the B-rich ferrom agnetic liquid. The A-rich isotropic liquid (B-rich ferrom agnetic liquid coexistence does not end in a critical point within the range of uid densities.

Upon increasing the dipole moment of component B the phase diagram shown in Fig. 8 (b) changes considerably. First, the sheet S_3 moves up due to the strengthening of the dipolar interaction. Like in the case of symmetrical dipolar mixtures (m $_A^2$ = m $_B^2$ = 1.5, see Fig. 1 (c)) close to the line M $_1$ the ferrom agnetic-isotropic phase transition on the sheet S_3 becomes rst order. This means that a line TC of tricritical points emerges from M $_1$ and separates the sheet S_3 into a continuous part and a rst-order part. In turn this implies that M $_1$ turns into a triple line TL 2 . In the next step due to the rise of the sheet S_3 (divided by the TC-line) the line M $_2$ rises, too, and merges with the line L $_2$ so that S_3 and S_2 form a single sheet S_2 [S_3 . Upon a further increase of m $_B$ the upper part of S_1 disintegrates into a left and a right part leaving a gap between them , where S_1 merges with S_2 [S_3 form ing the surface S_1 [S_2 [S_3 . The rem nants of the upper part of the sheet S_1 appear as asymm etrically winglike structures, where the triple lines TL $_1$ and TL $_1^0$ stem from the triple line TL $_2^2$ which has split while the split line L $_1$ generates the liquid-vapor critical lines L $_1$ and L $_1^0$ (see Fig. 8 (c)). The intersections of the corresponding triple and critical lines give two critical end points




FIG. 11: Phase diagrams of a binary Stockmayer uid mixture for $m_A^2 = 0$ and $m_B^2 = 1.5$ (compare Fig. 8(c)) in the pressure-tem perature (a) and density-tem perature (b) plane for $m_A^2 = 1$; the LJ parameters are the same as in Fig. 2. Below the tricritical tem perature $T_{\rm trc}$ the B-rich isotropic uid coexists with the B-rich ferrom agnetic uid. This rst-order phase transition turns into a second-order phase transition at the tricritical tem perature $T_{\rm trc}$. A bove $T_{\rm trc}$ the dotted line represents the line of second-order phase transitions.




FIG. 12: Phase diagrams of a binary Stockm ayer uid mixture for $m_{\tilde{A}}^2=0$ and $m_{\tilde{B}}^2=1.5$ (compare Fig. 8 (c)) in the pressure-tem perature (a) and density-tem perature (b) plane for $m_{\tilde{A}}^2=0$; the LJ parameters are the same as in Fig. 2. At this value of the chemical potential dierence only the A-rich isotropic liquid can coexist along a line of rst-order phase transitions with the B-rich ferrom agnetic liquid. The liquid-liquid coexistence does not end in a critical point within the range of physically relevant uid densities.

CEP₁ and CEP₁. Figure 8 (c) corresponds to m $_{A}^{?}$ = 0 and m $_{B}^{?}$ = 1:5 and displays this nalstructure with S₁[S₂[S₃ denoting the surface which has emerged from the sheets S₁, S₂, and S₃ (shown in Fig. 8 (b)) upon the increase of the dipole moment m_B.

Figure 11 shows our numerical results for a binary Stockmayer uid mixture with dipole moments $m_{\hat{A}}^2 = 0$ and $m_{\hat{B}}^2 = 1.5$ for $\hat{A}^2 = 1$. For this value of \hat{A}^2 the gure displays a vertical intersection of the phase diagram shown in Fig. 8 (c) between the two critical end points CEP₁ and CEP₁ and close to CEP₁. At low temperatures the B-rich isotropic uid and the B-rich ferrom agnetic uid are separated by a rst-order phase transition which becomes second order above the tricritical temperature $T_{\text{trc}}^2 = 2.03$. (The tricritical pressure and density are $p_{\text{trc}}^2 = 1.82$ and $p_{\text{trc}}^2 = 0.65$, respectively.) The dotted critical line corresponds to a cut through the second-order part of the surface $S_1[S_2[S_3]]$.

Figure 12 shows our numerical notings for a binary Stockmayer widn ixture with dipole moments $m_A^2 = 0$ and $m_B^2 = 1.5$ for $m_A^2 = 0$. This gure displays a vertical cut through the phase diagram in Fig. 8 (c) between CEP₁ and CEP₁ but close to the critical end point CEP₁. 


FIG. 13: Phase diagram s of a binary Stockm ayer uid mixture for $m_{R}^{2} = 0$ and $m_{B}^{2} = 1.5$ (com pare Fig. 8 (c)) in the pressure-tem perature (a) and density-tem perature (b) plane for $m_{B}^{2} = 0$; the LJ parameters are the same as in Fig. 2. Below the triple point tem perature T_{tr} the isotropic vapor coexists with the B-rich ferrom agnetic liquid. Between T_{tr} and $T_{c}^{(lv)}$ there are three possible phases: the vapor, the A-rich isotropic liquid, and the B-rich ferrom agnetic liquid. The A-rich isotropic liquid $T_{c}^{(lv)}$ be a prich ferrom agnetic liquid coexistence does not end in a critical point within the range of physically relevant uid densities.

uid are not separated by a dem ixing transition; in Fig. 8 (c) both are in front of S_1 [S_2 [S_3 . The liquid-liquid critical point lies outside the physically relevant uid densities.

Figure 8 (d) shows that by further increasing the dipole moment of the component B (m $_{\rm A}^2$ = 0, m $_{\rm B}^2$ = 2) the winglike structure on the left hand side in Fig. 8 (c), which is associated with the B-rich isotropic liquid { vapor transitions, disappears so that there remain only the two sheets S_1 [S_2 [S_3 and the wing on the right hand side associated with the A-rich isotropic liquid { vapor transitions. A coordingly there is only one triple line TL_1^0 , which describes the isotropic vapor { A-rich isotropic liquid { B-rich ferrom agnetic liquid three-phase coexistence. It ends at the critical end point CEP_1^0 where L_1^0 hits the surface S_1 [S_2 [S_3 . Since the topology of the phase diagram in Fig. 8 (d) is the same as that of Fig. 8 (c) (only the left winglike surface in Fig. 8 (c) is missing), the topologies of dierent cuts at given them ical potentials are in agreement with the topologies of the phase diagrams in Figs. 11-13. Therefore we refrain from presenting our detailed numerical results for Stockmayer mixtures with dipole moments m_A^2 = 0 and m_B^2 = 2.

C. Binary liquid mixtures of polar particles of dierent size

In this subsection we present phase diagram s of binary Stockm ayer liquid m ixtures of polar particles (m $_{A}^{?}$ f m $_{B}^{?}$) of di erent size. Since in the Stockm ayer interaction potential the size parameters appear in the LJ contribution to the potential, we rst study the e ect of varying the ratio $_{BB} = _{AA}$ on the phase diagram s of binary LJ uid m ixtures (m $_{A}^{?} = m_{B}^{?} = 0$) while keeping the energy parameters of the LJ potential xed.




FIG. 14: Projections of the vapor { A-rich isotropic liquid { B-rich isotropic liquid triple line TL (see Fig. 1) of binary Lennnard-Jones uid mixtures ($m_A^2 = m_B^2 = 0$) onto a plane p = const for $p_B = p_A = 0.95$, $p_A = p_A = 0.95$, and various size ratios $p_B = p_A = 0.95$. The triple lines end at different critical end points (CEPs, see Fig. 1). Note that as in Figs. 1 and 4 increases towards the left.

Figure 14 shows the projections of the triple lines of binary LJ uid mixtures with dierent particle size ratios onto a plane p = const. These triple lines describe the vapor { A-rich isotropic liquid { B-rich isotropic liquid three-phase coexistence. The curves show that the sheet S_2 , which separates the A-rich and B-rich liquid phases (see Fig. 1(a)) is increasingly tilted upon increasing the size ratio $B_B = A_A$. The critical end point temperature increases and the chemical potential dierence C_{EP} at the end point turns more negative, i.e., it is shifted towards the region of uid rich in the small particles. This means that for large size ratios three phase coexistence occurs for a wider range




FIG. 15: Phase diagram s of the binary Lennard-Jones uid mixtures in the pressure-tem perature (a) and density tem perature (b) plane for dierent size ratios $_{B\,B}=_{A\,A}$ and $^{?}$. The LJ energy parameters are the same as in Fig. 14. In (a) all liquid-vapor coexistence curves separate the vapor phase from the B-rich isotropic liquid phase. The liquid-liquid coexistence curves separate the B-rich isotropic liquid phase from the A-rich isotropic liquid phase. In (b) the full, dashed-dotted, and dotted curves enclose two-phase regions whereas the dashed lines indicate three-phase coexistence. The line code in (b) corresponds to that in (a) with the same choices of the size ratio $_{B\,B}=_{A\,A}$ and $^{?}$.

of therm odynam ic param eters.

We now turn to binary Stockmayer uid mixtures whose components have dierent dipole moments and particle




FIG. 16: Schem atic bulk phase diagrams of binary Stockmayer uid mixtures in the thermodynamic space of temperature T, pressure p, and chem ical potential di erence = B A for various dipole m om ents and size param eters. The phase diagram in (a) represents a binary dipolar uid mixture with the parameters $m_A^2 = 0.75$, $m_B^2 = 1.5$, and $m_B = m_A = 1$. The topology of this phase diagram is the same as that of a non-polar { dipolar binary uid mixture with the parameters $m_{\tilde{h}}^2 = 0$, m $_{\rm B}^{?}=1.5$, and $_{\rm B\,B}=_{\rm A\,A}=1$ (com pare Fig. 8(c)). Upon increasing the size of the component B such that $_{\rm B\,B}=_{\rm A\,A}=2^{1-3}$ (m_A = 0.75, m_B = 1.5) one obtains the phase diagram shown in (c) in which the sheet S₃ appears again, which separates the B-rich isotropic liquid from the B-rich ferrom agnetic liquid. The topology of this phase diagram is the same as that of non-polar { dipolar binary uid m ixture with the param eters m $_{\rm B}^2$ = 0, m $_{\rm B}^2$ = 1, and $_{\rm BB}$ = $_{\rm AA}$ = 1 (com pare Fig. 8(b)). The phase diagram in (b) represents a binary dipolar uid mixture with the parameters m $_{A}^{2} = 1$, m $_{B}^{2} = 2$, and $_{BB} = _{AA} = 1$. The topology of this phase diagram is similar to the topology of the phase diagram of non-polar { dipolar binary uid mixture with the param eters $m_{B}^{2} = 0$, $m_{B}^{2} = 2$, and $m_{B} = m_{A} = 1$ (com pare Fig. 8(c)), with the di erence that at the bottom of the wing like structure attached to the surface $S_1[S_2[S_3]$ an A-rich ferrom agnetic liquid phase appears. In this phase diagram a new sheet of second-order phase transition S_3^0 appears, which separates the A-rich isotropic liquid from the A-rich ferrom agnetic liquid. The intersection of the winglike surface and the sheet S_3^0 forms a line M $_1$ of critical end points. The intersection of the sheets $S_1[S_2[S_3]$ and S_3^0 form s another line M $_2$ of critical end points. Upon increasing the size of the component B so that $_{BB} = _{AA} = 2^{1=3}$ (m $_{A}^{?} = 1$, m $_{B}^{?} = 2$) one obtains the phase diagram shown in (d) where a winglike surface of rst-order phase transitions appears on the left part of the surface S_1 [S_2 [S_3 . This winglike surface separates the vapor phase from the B-rich isotropic liquid phase.

sizes. This model gives a reasonable description of bidisperse ferrom agnetic uids and as such provides also a rst approximation of actual polydisperse ferrocolloids. For these uids the magnetic dipole moments of the particles are proportional to the particle volume, i.e., m_i / $\frac{3}{3i}$, i=A; B. In the following we restrict our study to binary Stockmayer uid mixtures with dipole moment ratio $m_B^2 = m_A^2 = 2$, which implies the size ratio $_{BB} = _{AA} = 2^{1-3}$. This motivates our choice of the size ratio used for the above study of the phase behavior of the binary LJ uid mixtures. For the dipole moment ratio $m_B^2 = m_A^2 = 2$ in the following we compare the phase diagrams of binary Stockmayer uid mixtures composed of particles with either equalor dierent sizes. The corresponding schematic phase diagrams are shown in Fig. 16. Figure 16 (a) displays the schematic phase diagrams of a binary Stockmayer uid mixture with dipole moments $m_A^2 = 0.75$, $m_B^2 = 1.5$, and with particle size ratio $_{BB} = _{AA} = 1$; the LJ energy parameters are the same as in Fig. 14. The topology of this phase diagram is the same as that of shown in Fig. 8 (c). This fact is not surprising because in both cases $m_B^2 = 1.5$ and the increase of m_A^2 from $m_A^2 = 0$ to $m_A^2 = 0.75$ causes only a small change in the dipolar interaction energy relative to the LJ interaction energy.




FIG. 17: Phase diagram s of a binary Stockm ayer uid m ixture for dipole m oments $m_A^2 = 0.75$ and $m_B^2 = 1.5$, and with size ratio $_{B\,B} = _{A\,A} = 1$ in the pressure-tem perature (a) and density-tem perature (b) plane for $_B^2 = 6$ (compare Fig. 16(a)). The LJ energy parameters are the same as in Fig. 14. Below the triple point temperature T_{tr} the isotropic vapor coexists with the B-rich ferrom agnetic liquid. Between T_{tr} and $T_c^{(lv)}$ there are three phases: the vapor, the A-rich isotropic liquid, and the B-rich ferrom agnetic liquid. The A-rich isotropic liquid { B-rich ferrom agnetic liquid coexistence does not end in a critical point within the range of uid densities.




FIG. 18: Phase diagram s of a binary Stockm ayer uid m ixture for dipole m oments m $_{\rm A}^2$ = 0:75 and m $_{\rm B}^2$ = 1.5, and with size ratio $_{\rm B\,B}$ = $_{\rm A\,A}$ = 2^{1-3} in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm B\,B}^2$ = 1:36 (com pare Fig. 16 (c)). The LJ energy parameters are the same as in Fig. 14. Below the triple point tem perature the vapor coexists with the A-rich isotropic liquid. Between $T_{\rm c}$ and $T_{\rm c}^{(11)}$ there are three phases: the vapor, the B-rich isotropic liquid, and the A-rich isotropic liquid. Between $T_{\rm c}^{(11)}$ and $T_{\rm c}^{(10)}$ there is only vapor { B-rich isotropic liquid coexistence.

Figure 17 shows our num erical results for this binary Stockm ayer—uid mixture with dipole moments m $_A^2 = 0.75$ and m $_B^2 = 1.5$, and with particle size ratio— $_{BB} = _{AA} = 1$ for—? = 6. Figure 17 (a) demonstrates that the plane ? = 6 cuts through the wing attached to the right hand side of the surface S_1 [S_2 [S_3 in Fig. 16 (a). In accordance with the aforementioned topological similarity the phase diagrams shown in Fig. 17 dier from those shown in Fig. 13 only quantitatively. In Fig. 17 the liquid-vapor critical point is given by $T_c^{(lv)} = 1.384$, $p_c^{(lv)} = 0.138$, and $p_c^{(lv)} = 0.277$. The corresponding triple point temperature and pressure are $p_c^2 = 0.277$, respectively. For the same dipole moments ($p_c^2 = 0.75$) and $p_d^2 = 0.75$ and $p_d^2 = 0$




FIG. 19: Phase diagrams of a binary Stockm ayer—uid mixture with dipole moments m $_{\rm A}^{\,2}=1$ and m $_{\rm B}^{\,2}=2$, and size ratio $_{\rm B\,B}=_{\rm A\,A}=1$ in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm C}^{\,2}=5.5$ (com pare Fig. 16 (b)). The LJ energy parameters are the same as in Fig. 14. Below the tricritical temperature $T_{\rm trc}$ the B-rich isotropic—uid coexists with the B-rich ferrom agnetic—uid. This rst-order phase transition turns into a second-order phase transition at the tricritical temperature $T_{\rm trc}$. Above $T_{\rm trc}$ the dotted line represents a line of second-order phase transitions.




FIG. 20: Phase diagram s of binary Stockm ayer—uid m ixture for dipole m oments m $_{\rm A}^{?}=1$ and m $_{\rm B}^{?}=2$, and with size ratio $_{\rm B\,B}=_{\rm A\,A}=2^{1-3}$ in the pressure-tem perature (a) and density-tem perature (b) plane for $_{\rm C}^{?}=5.5$ (compare Fig. 16(d)). The LJ energy parameters are the same as in Fig. 14. Below the triple point tem perature $T_{\rm tr}$ the isotropic vapor coexists with the B-rich ferrom agnetic liquid. Between $T_{\rm tr}$ and $T_{\rm c}^{(lv)}$ there are three phases: the isotropic vapor, the B-rich isotropic liquid, and the B-rich ferrom agnetic liquid. The line of rst-order phase transition between the B-rich isotropic uid and B-rich ferrom agnetic liquid turns into a line of second-order phase transition (dotted line) at the tricritical tem perature $T_{\rm trc}$.

insu cient to lead to the form ation of an A-rich ferrom agnetic liquid phase, so that for negative values of phase remains isotropic, as in the case of non-polar { polar mixtures (see Fig. 8 (b)).

Figure 18 shows our numerical indings for a binary Stockmayer uid mixture with dipole moments m $_{\rm A}^{?}=0.75$ and m $_{\rm B}^{?}=1.5$, and with particle size ratio $_{\rm B\,B}=_{\rm A\,A}=2^{1-3}$ for $_{\rm C}^{?}=1.36$. Increasing the dipole m oments from m $_{A}^{?}=0.75$ and m $_{B}^{?}=1.5$ to m $_{A}^{?}=1$ and m $_{B}^{?}=2$ at a xed particle size ratio $_{BB}=_{AA}=1$ the phase diagram shown in Fig. 16(a) changes considerably leading to the phase diagram displayed in Fig. 16(b). This increase of the dipole moments causes the disappearance of the winglike structure attached to

the left part of the surface $S_1[S_2[S_3]$ (see Fig. 16(b)), which is associated with the B-rich isotropic liquid { vapor transitions. M oreover the winglike structure attached to the right part of the surface $S_1[S_2[S_3]]$ also changes due to the appearance of the sheet S_3^0 . This sheet separates the A-rich isotropic liquid at high tem peratures from the A-rich ferrom agnetic liquid at low tem peratures. S_3^0 is the locus of second-order phase transitions and is the rem nant of the sheet S_3 (see Fig. 1(b)), which together with S_1 and S_2 has formed the surface $S_1[S_2[S_3]]$.

Figure 19 displays our numerical results for a binary Stockmayer uid mixture with dipole moments $m_A^2 = 1$, $m_B^2 = 2$, and with particle size ratio $_{BB} = _{AA} = 1$ for $_{AA}^2 = 55$. For this value of $_{AA}^2$ the gure shows a vertical slice through the left part of the surface $S_1[S_2[S_3]$ in the phase diagram displayed in Fig. 16(b). The topology of these phase diagrams is the same as those of shown in Fig. 11. The tricritical point is given by $T_{trc}^2 = 328$, $p_{trc}^2 = 2538$, and $\frac{2}{trc} = 0.565$.

Increasing the particle size ratio from $_{B\,B}=_{A\,A}=1$ to $_{B\,B}=_{A\,A}=2^{1-3}$ for xed dipole moments $m_A^?=1$ and $m_B^?=2$, the phase diagram shown in Fig. 16(b) transforms into that shown in Fig. 16(d). Upon the increase of the particle size ratio on the left part of the surface $S_1[S_2[S_3]$ in Fig. 16(d) a winglike structure appears, which is associated with B-rich isotropic liquid { vapor phase transitions. Through a similar topological change, the phase diagram shown in Fig. 8(d) transforms into the phase diagram shown in Fig. 8(c) upon a decrease of the dipole moment $m_B^?$ from $m_B^?=1.5$ to $m_B^?=1.5$

Figure 20 displays our numerical results for a binary Stockmayer uid mixture with dipole moments m $_{\rm A}^2=1$, m $_{\rm B}^2=2$, and with a particle size ratio $_{\rm B\,B}=_{\rm A\,A}=2$ for $_{\rm C}^2=5.5$. For this choice of $_{\rm C}^2$ Fig. 20 (a) represents a vertical slice through the left part of the surface $S_1[S_2[S_3]$ in the phase diagram shown in Fig. 16 (d) where the attached winglike structure appears again. The corresponding liquid-vapor critical point, the tricritical point, and the triple point are given by $T_{\rm C}^2=1.71$, $p_{\rm C}^2=0.09$, $p_{\rm C}^2=0.142$, $p_{\rm tr}^2=1.77$, $p_{\rm trc}^2=0.37$, $p_{\rm trc}^2=0.37$, and $p_{\rm tr}^2=1.64$, $p_{\rm tr}^2=0.065$, respectively. The topology of the phase diagram s shown in Fig. 20 is the same as of those of shown in Fig. 5.

IV. SUMMARY

In the present study of the phase behavior of binary Stockm ayer (Eqs. (1)-(3)) uid m ixtures the following main results have been obtained:

- (1) We have extended the one-component version of the modi ed mean-eld density functional theory to that of binary Stockm ayer uid mixtures of particles A and B with dierent dipole moments, sizes, and Lennard-Jones interaction energies. In particular, we have focused on the explicit formulation of the grand canonical functional, the equilibrium pressure p, and the chemical potentials $_{\rm A}$ and $_{\rm B}$ of the two components [see Subsec. II B and Eqs. (26)-(28)].
- (2) This system exhibits 6 distinct uid phases: isotropic vapor, isotropic uid, A-rich isotropic liquid, A-rich ferrom agnetic liquid, B-rich isotropic liquid, and B-rich ferrom agnetic liquid. At a given temperature T the rst-order phase transitions between them follow from the equalities of the chemical potentials and of the pressure between the coexisting phases [see Subsec. II C and Eq. (35)]. The loci of the second-order phase transitions between isotropic and ferrom agnetic uids can be determined analytically from a suitable Landau theory [see Subsec. II C and Eq. (37)].
- (3) In the therm odynam ic param eter space (T;p; = BA) we have constructed the schem atic phase diagram s of binary uid mixtures of particles with equal size and equal dipole moment (see Fig. 1). We have discussed the topological changes of these phase diagram s due to an increase of the particle dipole m om ents. The various shapes of the three-dim ensional schem atic phase diagram s are supported by num erically calculated cuts through them , which are two-dim ensional phase diagrams at xed chemical potential dierences. For dipole moments m $_{\rm A}$ = m $_{\rm B}$ = 0 Fig. 2 shows a cut through the phase coexistence surfaces (Fig. 1 (a)) of rst-order liquid-vapor and A-rich liquid { B-rich liquid phase transitions of Lennard-Jones $\,$ uid $\,$ m ixtures which are characterized by energy parameters $\,$ $_{AA}$, $_{BB}$, $_{AB}$ and diam eters $_{AA}$, $_{BB}$, $_{AB}$ = ($_{AA}$ + $_{BB}$)=2. For reduced dipole moments m $_{A}$ = m $_{B}$ = 1 with $m_i^2 = m_i^2 - MAAAA$, i = A;B, Fig. 3 displays a cut through the phase coexistence surfaces (Fig. 1 (b)) describing the vapor-liquid, the vapor { A -rich ferrom agnetic liquid, and the A -rich isotropic liquid { B -rich isotropic liquid phase transitions of binary Stockm ayer uid mixtures. For increased dipole moments $m_{\tilde{h}}^2 = m_{\tilde{h}}^2 = 1.5$ the corresponding schem atic phase diagram is shown in Fig. 1 (c). In this case Fig. 4 shows the projections of the triple lines and critical lines onto a plane p = const. The vapor-liquid, vapor { ferrom agnetic uid, isotropic uid { ferrom agnetic uid, and the A-rich ferrom agnetic liquid { B-rich ferrom agnetic liquid phase boundaries for dipole m om ents m $_A^2$ = m $_B^2$ = 1:5 are shown in Figs. 5 and 6. A further increase of the dipole moments to $m_A^? = m_B^? = 2$ leads to the schematic phase diagram shown in Fig. 1(d). A cut at $^? = const$ through those coexistence surfaces is shown in Fig. 7, describing the isotropic uid { ferrom agnetic uid and the A-rich ferrom agnetic liquid { B-rich ferrom agnetic liquid phase transitions.

- (4) We have also constructed the schem atic phase diagram s of binary uid mixtures of non-polar and various polar particles of equal size (see Fig. 8) and have discussed the topological changes of these phase diagram s due to an increase of the dipole moment of the polar component B. For dipole moments $m_A^2 = 0$ and $m_B^2 = 1$ Fig. 9 shows a cut through the schematic phase diagram (Fig. 8(b)) describing the vapor-liquid, the A-rich isotropic liquid (B-rich isotropic liquid, and the vapor (ferrom agnetic liquid phase coexistences. Figure 10 displays another cut at $m_A^2 = 0$ const through the phase diagram in Fig. 8(b) indicating the possibility of A-rich isotropic liquid (B-rich ferrom agnetic liquid coexistence besides the vapor-liquid one. Upon increasing the dipole moment of the polar component B from $m_B^2 = 1$ to $m_B^2 = 1$:5 the topology of the corresponding phase diagram shown in Fig. 8(b) changes to that shown in Fig. 8(c) which includes dierent types of phase coexistences: B-rich isotropic uid (B-rich ferrom agnetic uid coexistence (see Fig. 11), A-rich isotropic uid (B-rich ferrom agnetic uid coexistence (see Fig. 12), and vapor (A-rich isotropic liquid coexistence together with A-rich isotropic liquid (B-rich ferrom agnetic liquid coexistence (see Fig. 12), and vapor (See Fig. 13). A further increase of the dipole moment to $m_B^2 = 2$ leads to the phase diagram shown in Fig. 8(d).
- (5) We have studied the dependence of phase diagrams of binary Stockmayer liquid mixtures on the size ratio $_{BB} = _{AA}$ $2^{1=3}$ the phase diagram sofbinary Lennard-Jones liquid m ixtures $_{B\,B}=_{A\,A}$. We have found that for 1 $(m_A^2 = m_B^2 = 0)$ do not exhibit any topological change with increasing size ratio. For $m_A^2 = m_B^2 = 0$ Figs. 14 and 15 dem onstrate that with increasing particle size ratio only the therm odynam ical param eter ranges of vapor-liquid and liquid-liquid coexistence are changed. In Fig. 16 the schematic phase diagrams of binary Stockmayer liquid m ixtures with particle size ratios $_{BB} = _{AA} = 1$ and $_{BB} = _{AA} = 2^{1=3}$ and for the dipole moment ratio m $_{B}^{?} = m_{A}^{?} = 2$ are shown. Such binary mixtures with dipole moment and particle size ratios dierent from 1 can be considered as a rst approximation of polydisperse ferrouids. The topological change of the phase diagram of binary Stockmayer liquid m ixtures with dipole moments $m_{A}^{2} = 0.75$ and $m_{B}^{2} = 1.5$ due to the increase of the size ratio from $m_{B} = m_{A} = 1$ to $_{BB} = _{AA} = 2^{1-3}$ is displayed in Figs. 16(a) and 16(c). Corresponding slices through these phase diagram s for ? = const have been calculated (see Figs. 17 and 18). Figure 17 shows vapor (A-rich isotropic liquid and A-rich isotropic liquid { B-rich ferrom agnetic liquid coexistence, while Fig. 18 displays vapor { B-rich isotropic liquid and B-rich isotropic liquid { A-rich isotropic liquid coexistence. For dipole m om ents $m_{\tilde{A}}^2 = 1$ and $m_{\tilde{B}}^2 = 2$ Figs. 16(b) and 16(d) show another type of topological change in the phase diagrams of binary Stockmayer liquid mixtures due to the increase of the size ratio from $_{B\,B}=_{A\,A}=1$ to $_{B\,B}=_{A\,A}=2^{1=3}$. The corresponding slices through these phase diagram s for ? = const have been calculated (see Figs. 19 and 20). Figure 20 shows that with increasing size ratio vapor-liquid coexistence em erges besides the coexistence of B-rich isotropic uid and B-rich ferrom agnetic uid (Fig. 19).
