# Vortex-chain phases in layered superconductors

Layered superconductors in tilted magnetic eld have a very rich spectrum of vortex lattice con gurations. In the presence of in-plane magnetic eld, a small c-axis eld penetrates in the form of isolated vortex chains. The structure of a single chain is mainly determ ined by the ratio of the London [] and Josephson  $[_J]$  lengths,  $= = _J$ . At large the chain is composed of tilted vortices [tilted chains] and at small it consists of a crossing array of Josephson vortices and pancake stacks [crossing chains]. We studied the chain structures at interm ediate 's and found two types of behavior. (I) In the range 0:4. 0.5 a c-axis eld rst penetrates in the form of pancake-stack chains located on Josephson vortices. Due to attractive coupling between deform ed stacks, their density jumps from zero to a nite value. With further increase of the c-axis eld the chain structure sm oothly evolves into m odulated tilted vortices and then transform s via a secondorder phase transition, into the tilted straight vortices. (II) In the range 0.5 . . 0:65 a c-axis eld rst penetrates in the form of kinks creating kinked tilted vortices. W ith increasing the c-axis eld this structure is replaced via a rst-order phase transition by the strongly deform ed crossing chain. This transition is accompanied by a large jump of pancake density. Further evolution of the chain structure is similar to the higher anisotropy scenario: it smoothly transforms back into the tilted straight vortices.

# I. IN TRODUCTION

Layered superconductors have an am azingly rich phase diagram in tilted magnetic eld. In the presence of the in-plane eld, pancake vortices generated by the c-axis eld<sup>1,2</sup> can form a very large num ber of di erent lattice con gurations. Possible structures include the kinked lattice,<sup>3,4,5,6</sup>, tilted vortex chains<sup>7</sup>, and crossing lattices com posed of sublattices of Josephson vortices (JV s) and pancake-vortex stacks.4,8 In addition to hom ogeneous lattices, phase-separated states may also exist such as dense pancake-stack chains sitting on JV s and dilute lattice in between<sup>8,9,10,11</sup> or coexisting lattices with di erent orientations.<sup>12</sup> E ven though considerable progress in this eld has been made in the last decade, the satisfactory understanding of the phase diagram has not been achieved yet. All these phases probably do realize in different materials and experimental conditions. However nding ground states in tilted eld occurs to be a challenging theoretical task and it is even more di cult to prove experim entally that a particular lattice con guration does realize som ewhere in the phase diagram .

The main source of richness of lattice structures in tilted eld is the existence of two very di erent kinds of interactions between pancake vortices in di erent layers: magnetic and Josephson interactions. The key parameter, which determines the relative strength of these two interaction and plays a major role in selecting the lattice structures, is the ratio of the two fundamental lengths, the in-plane London penetration depth, ab, and Josephson length  $_{\rm J}$  = s, with being the anisotropy parameter and s being the interlayer spacing, = =  $_{\rm J}$ . O ne can distinguish two limiting cases which we refer to as \extrem ely anisotropic" case, < 0:4, and \model model.




FIG.1: Crossing (left) and tilted (right) vortex chains. Upper pictures show three-dimensional views and lower pictures show the structures of isolated chains.

erately anisotropic" case > 0:7. Note that in our term inology even  $\mbox{m}$  oderately anisotropic" superconductors may have very large anisotropy factor, 1. Am ong known atom ically layered superconductors, only  $B_{12}Sr_2CaCu_2O_x$  (BSCCO) and related compounds may belong to the  $\mbox{extrem ely anisotropic"}$  fam ily. Even in this compound the parameter is not smaller than

0.25 and increases with temperature so that BSCCO typically becomes \m oderately anisotropic" in the vicinity of transition temperature.

In a wide range of the in-plane elds (10-200 G) and at very small c-axis elds (up to 1-2 G) the pancake stacks in layered superconductors within a wide range of an isotropies are arranged in chains, see F ig. 1. An isolated chain is a two-dimensional array of pancake vortices oriented perpendicular to the layers. At some what higher c-axis elds the chains are surrounded by the stripes of

regular vortex lattice.<sup>9,10</sup> The internal structure of an isolated chain depends on the ratio and it is relatively simple in two limiting cases. At large the chain is com posed of tilted pancake stacks (tilted chain, right colum n in Fig. 1) and at small it consists of crossing array of Josephson vortices and pancake stacks (crossing chains, left column in Fig. 1). A very nontrivial and intriguing problem is how one structure transforms into another in the region of intermediate . We address this problem in this paper. We analytically and num erically com puted ground-state con gurations in the isolated vortex chain and found a surprisingly rich behavior. We found two types of phase transitions. The rst phase transition typically takes place for the interm ediate separations between pancake stacks  $a, a = \begin{bmatrix} 1 \\ 2 \end{bmatrix}_J$ , and rather wide range of the ratio , 0:4 . . 0:65. For these 's the ground state is given by the crossing chain in a wide range of the pancake separations a. However, due to attractive coupling between deform ed pancake stacks<sup>13</sup>, the equilibrium separation can not exceed some maximum value, which depends on the in-plane eld and and it is typically of the order of several J. W ith decreasing the pancake separation a, the crossing chain becom es strongly deform ed and sm oothly transform s into the modulated tilted vortices which then transform via a second-order phase transition into the tilted straight vortices. We calculated analytically the energies of two lim iting chain con gurations and checked that num erics reproduces them . Comparing these energies, we locate the transitional region in the phase space, where stronglydeform ed chains are realized.

A nother phase transition is realized at very sm all densities of pancake vortices and only when exceeds a certain critical value 0:5 (exact criterion depends on the in-plane magnetic eld). In this case a small c-axis eld penetrates in the form of kinks. The kinked vortex lines form ing tilted chains are com posed of pieces of Josephson vortices separated by kinks.<sup>3,4,5</sup> If the kink energy is only slightly smaller then the energy per pancake in a straight pancake stack then at very small concentration of kinks, typically at a  $[20 \quad 30]_{\rm J}$ , the kinked chains are replaced with strongly deform ed crossing chains via a rst-order phase transition. Due to the opposite signs of interactions (kinks repeland deform ed pancake stacks attract each other) this transition is accompanied by a very large jum p in the pancake density. W ith further decrease of pancake separation the chain sm oothly transform s back to the tilted chain as it was described in the previous paragraph.

Based on num erical exploration of the chain con gurations, we construct the chain phase diagram s for di erent ratios . A s follow s from the above description, there are two types of phase diagram s in the region of interm ediate 's.

In the range 0:4. . 0:5 a sm all c-axis eld rst penetrates in the form of pancake-stack chains located on Josephson vortices. Due to attractive coupling between deform ed stacks, their density jumps from zero to a nite value. W ith further increase of the caxis eld the chain structure rst evolves into the modulated tilted vortices, which then transform s via a second-order phase transition, into the tilted straight vortices.

In the range 0.5 . . 0:65 a small c axis eld rst penetrates in the form of kinks creating kinked tilted vortices. W ith increasing the c-axis eld this structure is replaced via a rst-order phase transition by the chain of pancake stacks, which are typically strongly deform ed. This transition is accom panied by a large jum p of pancake density. Further evolution of the chain structure is identical to the smaller scenario: the structure rst transform s into m odulated tilted vortices and then, via a second-order phase transition, into tilted straight vortices.

Note that the exact transition between the two types of behavior depends also on the in-plane eld. As interaction with the Josephson vortices reduces the energy of the pancake stacks, the larger in-plane eld favors the rst scenario.

U sing num erical code developed for studying the chain structures, we also investigated stability of an isolated crossing con guration of the Josephson vortex and pancake stack. We found that the crossing con guration becom es unstable at 0:69. Above this value the magnetic coupling is not capable to maintain stable con guration and the Josephson vortex tears the stack apart. Nevertheless, the obtained stability range occurs to be signi cantly broader than it was estimated from simple considerations in Ref. 21. The reason is that the strongly-deformed crossing con quration signi cantly modies the Josephson vortex which reduces forces pulling pancakes apart. W e found that the crossing energy increases sm oothly up to instability point. Perturbative calculation<sup>8</sup> gives accurate results for the crossing con guration and its energy up to 0:35.

Recently, the vortex chains in BSCCO at sm all concentrations of pancakes have been studied by the scanning Hall probe m icroscopy by Grigorenko et al.<sup>14</sup> They observed that at very sm all concentration of the pancakes the chains are magnetically hom ogeneous and separate pancake stacks are not resolved. When the external eld exceeds som e critical value of the order of several 0 ersted, crystallites of the pancake stacks are suddenly formed along the chain and the ux density in the crystallites approximately ten times higher then the ux density in the hom ogeneous chains. Our calculations provide consistent interpretation for these observations. The magnetically hom ogeneous chains are interpreted as kinked/tilted chains and form ation of crystallites can be attributed to the low-density [kinked lines]-[crossing chains] rst-order phase transition (such interpretation has been proposed by Dodgson<sup>15</sup>). The observed large density jump also com es out from the theory.

The evolution of the mixed chain+ lattice state with

increasing temperature has been studied recently by Lorentz m icroscopy.<sup>16</sup> It was observed that the pancake stacks located in chains sm ear along the chain direction above some eld-dependent temperature while the pancake stacks outside chains still rem ain well-de ned. The continuous low -density phase transition from crossing to tilted chain found and discussed in this paper provides a very natural interpretation for this observation.

The paper is organized as follows. In Section II we review general expressions for the chain energy. In Section III we perform analytical calculations of the chain energy for the two limiting cases: crossing and tilted chain. In the next section IV, com paring energies for the two lim iting con gurations, we estimate location of the transition region. In section V we review attractive interaction between deform ed pancake stacks located on Josephson vortices<sup>13</sup> and derive general form ulas for determ ination of the maximum equilibrium separation between the pancake stacks and the boundaries of stability region with respect to density uctuations. Section VI contains the main results of the paper on numerical exploration of the the phase diagram . A fter discussion of num erical im plem entation of the model, we explore stability of the isolated crossing con guration. In the next two subsections we consider two di erent phase transitions between the tilted and crossing chains and two types of phase diagram swhich are realized in the region of interm ediate parameter .

#### II. ENERGY FUNCTIONAL

O ur calculations are based on the Law rence-D oniach free-energy functional in the London approximation, which depends on the in-plane phases  $_n$  (r) and vector-potentialA (r)

The ratio of the two energy scales determ ines the most important length scale of the problem, the Josephson length,  $J = s = J = E_J$ . We use the London gauge, divA = 0. W e m ainly address the situation when magnetic B inside the superconductor is xed. The c component of the eld determ ines the concentration of the pancake vortices n<sub>v</sub>  $B_z = 0$  inside one layer. The in-plane phases n have singularities at the positions of pancake vortices R<sub>n;i</sub> inside the layers,

Logarithm ic divergencies in the vicinity of pancakevortex cores have to be cut at the coherence length ab. A useful approach for superconductors with weak Josephson coupling is to split the phase and vector-potential into the vortex and regular contributions, n = vn + rnand  $A = A_v + A_r$ . The vortex contributions minim ize the energy for xed positions of pancake vortices at  $E_J = 0$  and give magnetic interaction energy for the pancake vortices. One can express this part of energy via the vortex coordinates R  $_{n;i}$ . In general, the regular contributions m ay include phases and vector-potentials of the Josephson vortices. The total energy naturally splits into the regular part  $F_r$ , the energy of magnetic interactions between pancakes  $F_{\mbox{\scriptsize M}}$  , and the Josephson energy F<sub>J</sub>, which couples the regular and vortex degrees of freedom,

where  $E_1(u) = \begin{bmatrix} R_1 \\ u \end{bmatrix}$  (exp(v)=v) dv is the integral exponent ( $E_1(u) = \begin{bmatrix} hu + u at u \\ R^2 + (ns)^2 \end{bmatrix}$ , and L is a cuto length. The regular and vortex degrees of freedom s are coupled only via the Josephson energy in which n is the total phase composed of vortex and regular contributions.

The discrete layer structure has strongest in uence on the cores of tilted and Josephson vortices. Interaction contributions to the total energy usually can be computed within continuous approximation which describes the layered superconductor as a three-dimensional anisotropic material. This approximation amounts to replacement of summation in the layer index n in Eqs. (4), (5), and (6) with integration in the continuous variable z = ns and expansion of cosine in Eq. (6). In the continuous approximation one can derive a very useful general result for the energy (1) (see Ref. 17)

As we will use this form ula only for evaluation of interaction energies between vortex lines, we have to subtract from it the logarithm ically diverging single-vortex term s.

In this paper we focus on the structure of an isolated vortex chain with period a in x direction and period c = N s in z direction corresponding to the tilting angle of vortices with respect to the caxis with tan = a=c (see Fig. 1). The vertical period is  $2_{0} = (53 \text{ B}_{x}).$ xed by the in-plane eld  $B_x$ , c 500 and this period is approximately For BSCCO equal to 20 layers at  $B_x$ 50G.We consider the case and in-plane distances much smaller than c. С For this particular problem the general energy given by Eqs. (3), (4), (5), and (6) can be signi cantly simplied using several approximations: (i) we can neglect screening of regular phase and z-axis vector-potential; (ii)we consider only one-dimensional displacements of pancake rows along the chain,  $R_{n:i} = (ai + u_n; 0; ns);$ (iii)we subtract the energy of straight pancake stacks,  $(B_x = 0)$ "<sub>PS</sub> with "<sub>PS</sub>  $"_0$  (ln + 0:5), allowing us to elim inate logarithm ically diverging pancake-core contributions; (iv)we drop the trivial magnetic energy term  $B_x^2=8$  which plays no role in selection between di erent chain phases. W e will use the chain energy per unit area,  $B_x^2 = (8)$  ( $B_z = 0$ )"<sub>PS</sub>) with V being the Ε Ç;(F=V total system volume. With the above assumptions this energy can be represented as

 $c_y = {}_0 = cB_x$  c is the in-plane distance between chains, and  $L_z$  is the total system length in z direction.

The energy (9) contains a long-range suppression of the Josephson energy accumulated from distances c  $y = c_y$ , that is identical in all chain phases and it is convenient to separate this term too. The averaged z-axis phase gradient induced by the Josephson vortex lattice is given by

This part of energy weakly depends on  $c_y$  and does not diverge for  $c_y$  ! 1. The result (11) is valid for chains separated by distance  $c_y$  smaller than  $_c$ . Similar calculation can be made for isolated chain separated from other chains by distance larger than  $_c$ . In this situation the integral over y converges on distance  $_c$  instead of  $c_y$  leading to result  $E_{J-LR} = E_J = c=sN^2$ . We will use this result in the analytical calculations of the isolated chain energy.

In calculation of magnetic coupling energy one has to take into account periodic conditions for pancake displacements,  $u_{n+N} = u_n$ . In addition, if one selects z axis origin at the center of the Josephson vortex then symmetry also requires  $u_n = u_h$ . G round state of the vortex chain is determined by the minimum of energy (9) with respect to pancake displacements and regular phase distribution. Two simple limiting cases in Fig. 1 correspond to (i)  $u_n$  a for the crossing-chain con guration and (ii)  $u_n = a(1 (n 1=2)=N)=2$  for the tilted-chain con guration.

## III. ANALYTICAL CALCULATIONS OF CHAIN ENERGIES

In this section we compute energy of an isolated vortex chain with period a in x direction and period c = N s

in z direction. In general, there are two approaches to compute energies of vortex con gurations. U sing distribution of phase and vector potential, the total energy can be obtained directly from the Law rence-D oniach functional by integration of the local energy. This approach is always used in num erical computations. A nalytically, it is more convenient to calculate the total energy by summing up energy of isolated vortices and vortex interactions. A nalytic estimates for energy contributions are possible in two limiting cases of weakly deformed crossing chain and chain consisting of tilted vortices (see F ig. 1). C om parison of these energies gives an approximate range of parameters where one of these competing congurations is energetically preferable. In contrast to the num erical part, we consider isolated chain separated from

other chains by distance  $c_y$  c. For comparison with num erical calculations, it will be necessary to extract the local part of energy which is not sensitive to the long-range behavior.

#### A. Crossing chains

Energy of crossing-lattices chain per unit area is given by sum of pancake-stack (E  $_{\rm PS}$ ), Josephson-vortex (E  $_{\rm JV}$ ) and crossing energies (E $\,$ ) term s,

Both pancake and JV terms are composed of singlevortex and interaction contribution,  $E_{PS} = E_{PS}^{s} + E_{PS}^{i}$ ,  $E_{JV} = E_{JV}^{s} + E_{JV}^{i}$ .

W e start with evaluating pancake stack energies. C ontribution from energies of individual stacks to the energy per unit length is given by

The JV interaction energy can be evaluated in the same way as the pancake-stack interaction energy (16) and in the limit c it is given by

T herefore, the total energy of the JV array, E  $_{\rm JV}$  = E  $_{\rm JV}^{\rm s}$  + E  $_{\rm JV}^{\rm i}$  , can be written as

with  $C_{JV} = 1.54$  ln 4 +  $_{E}$  0.41. The st term in this formula is the long-range Josephson energy,  $E_{J LR}$ .

This term is identical in all chain phases and does not determ ine selection between them. This form ula is valid for an isolated chain and it is di errent from the long-range Josephson energy of the dense JV lattice,  $c_y < c_r$ , given by Eq. (11). Note that at not very large tilt angles, . 1, the Josephson tilt energy is roughly <sup>2</sup> sm aller than the magnetic tilt energy. Two terms become comparable at very large tilt angles, . In several papers<sup>17</sup> the energy of a tilted line in anisotropic three-dimensional superconductor has been calculated. This calculation is based on the London energy expression (8) employing elliptic cut o in k-integration  $k_k^2 + k_z^2 = {}^2 < {}_{ab}^2$  to treat the vortex core. Strictly speaking, this approximation does not describe layered superconductors in which  ${}_c < s$ . Nevertheless, in the region < it leads to the result similar to Eq. (22) with some what di erent magnetic part and di erent expression under logarithm in the Josephson part.

b. Region = tan > (kinked lines). In the region tan > the vortex lines have the kink structure, i.e., they are composed of kinks separated by JV pieces.

The interaction energy between neighboring kinks in the kinked line decays as  $1=L^2$  up to  $L < {}_c$  leading to relatively large interaction contribution to the total energy. The kink interaction energy is computed in details

in the Appendix A. In the region L <sub>c</sub> the dom inant interaction term in the energy of single line is given by

Note that the values of the num erical constants  $C_{\,\nu}\,$  and  $C_{\,k}\,$  depend on the core structure at sm all distances r from its center, which evolves with temperature decrease. However, as this structure is exactly the sam e for the pancake vortex and kink, the di erence  $C_k$   $C_v$  is not sensitive to behavior at sm all distances and rem ains the same down to low tem peratures. C riterion ln  $(1 = _c) + C_{kv} = 0$  (corresponding to c 0:44) separates the kink and pancake-stack penetration regimes of a small c-axis eld for large N (som ew hat larger value  $_{\rm c}$ 0:5 has been given in Ref. 6). This critical value increases with decrease of N due to the crossing energies in the crossing chains. Penetration of the c-axis eld in the presence on the in-plane eld is frequently referred to as a lock-in transition.

#### 2. Interaction energy of tilted vortices.

The interaction energy between tilted lines is not in uenced much by the layered structure and it can be com puted within the London approximation. In Appendix B we derive a general analytical form ula for the interaction energy of tilted chain,  $E_{TV}^{i}$ ,

# IV. LOCATION OF TRANSITIONAL REGIONS IN THE PHASE SPACE

To nd out whether the crossing or tilted chain is realized for given values of the parameters a, c, and , we have to compare the energies of these states. Naively, one m ay think that intersection of the energy curves for the two states would correspond to a rst-order phase transition between these states. However, as we will see from numerical simulations, in the region = tan < another scenario is realized. Typically, strongly deformed intermediate chain con gurations develop in the transitional region providing a smooth transition between the two limiting con gurations. Therefore, a simple energy comparison gives only an approximate location of the transitional region separating the two con gurations.

In the region = = a=N  $_{\rm J}$  1 comparison of (20) and (30) gives the following criterion for the transitional region

O ne can observe that the main competition takes place between the loss of the magnetic coupling energy for the tilted chain (rst term) and strong suppression of the Josephson energy by JVs for the crossing chain (second term). Solution of this equation provides the boundary which can be written in the reduced form  $a = _JN f(N;)$  with f(N;) = 1, i.e., the boundary shape in the plane  $a = _J-N$  depends only on the param – eter .

In contrast to Eq. (33), which gives only an approximate location of the broad transitional region, this equation indeed describes a very strong rst-order phase transition.

# V. ATTRACTION BETW EEN DEFORMED PANCAKE STACKSAND TILTED VORTICES. MAXIMUM EQUILIBRIUM SEPARATION

A peculiar property of the crossing chain is an attractive interaction between the deform ed pancake stacks at large distances.<sup>13</sup> As a consequence, when the magnetic eld is tilted from the layer direction, the density of the pancake stacks located on the Josephson vortices jumps from zero to a nite value. This means the existence of a maximum equilibrium separation  $a_m$  between pancake stacks, i.e., chains with a >  $a_m$  are not realized in equilibrium. Note that the tilted vortices also attract each otherw ithin some range of angles and distances<sup>7</sup> m eaning that tilted chains also have this property in som e range of param eters.

A simple analytical formula for the attraction energy between the deformed pancake stacks can be derived for very anisotropic superconductors  $_J$  in the range R  $_J$ .<sup>13</sup> In this limit short-range pancake displacements  $u_n$  from the aligned positions in the two neighboring stacks produce a dipole-like contribution to the interaction energy per unit length between these stacks

This term has to be combined with the usual repulsive interaction between straight stacks  $U_{10}(R) = 2"_0K_0(R=) 2"_0^P - 2R \exp((R=))$ . Minimum of the total interaction energy,  $U_{10}(R) + U_1(R)$ , gives an estimate for the maximum equilibrium separation  $a_m^{-13}$ ,  $a_m = \ln(C^{-2} = u^2)$  and this result is valid until  $a_m < J$ . Because in BSCCO J is only 2 3 times larger than , this simple form ula is not practical for this compound. We will see that  $a_m$  in BSCCO is usually larger than J.

O ne can obtain a useful general recipe for determination of the maximum equilibrium separation between the pancake stacks directly from the chain energy per unit area E, without splitting it into the single-vortex and interaction parts. We consider situation when the in-plane component of the magnetic eld is much larger than the low ercritical eld in this direction so that the inplane magnetic induction practically coincides with the in-plane external magnetic eld. The c component of the external eld, H z, determ ines the elective chemical potential for density of pancake stacks,  $= _0H_z = (4)$ . With xed chemical potential, the chain therm odynamic potential per unit area depends on pancake linear density n as

W hen the main contribution to the total interaction energy is coming from the nearest-neighbor interaction,  $a_m$  coincides with the position of the m inimum in the pair interaction potential.

In principle, nonequilibrium structures with a  $> a_m$  can be prepared by applying external stretching forces at the chain edges. However, the chain can be stretched only up to a certain critical value of separation. Above this value the system becomes unstable with respect to density uctuations leading to form ation of high-density chain clusters. The stability criterion of the chain is given by

In numerical calculations we assume for simplicity periodic boundary condition in y direction with period  $c_y$ . Physically, this corresponds to rectangular arrangement of both Josephson vortices and pancake stacks. Even

though such arrangement does not give the true ground state, it does not in uence much the structure of an individual chain, that is the focus of this paper. Due to symmetry properties, it is su cient to not the phase distribution  $_{n}(x;y)$  within domain 0 < x < a,  $0 < y < c_{y}=2$ , 1 n  $N_{1} = N = 2$  with the following boundary conditions for the total phase

Sim ilar decomposition was m adde for the m agnetic interaction energy in Eq. (41).

We explored chain phase structures by numerically solving Eqs. (46) with respect to the pancake row displacement  $v_n$  and regular phase distribution  $_{r,n}$  for different values of the parameters a, N =  $2N_1$ , and . Numerical computations were performed on two Linux workstations with 2G H z AM D A thlon processors and on the nodes of the Argonne computing cluster \Jazz" (350 nodes, each with 2.4 G H z Pentium X eon processor). In the following sections we review the results of these calculations.

#### B. Stability of crossing con guration

The fundam ental property of the crossing-chain state is the structure of the crossing con guration of Josephson vortex and pancake stack. In-plane currents of the Josephson vortex displace the pancakes in the opposite directions above and below central layers. Equilibrium displacements are the result of a balance between the pulling forces of the Josephson vortex, which try to tear the pancake stack apart, and magnetic coupling, which tries to keep the stack aligned. The structure of the crossing con guration can be calculated analytically in the  $_{\rm J}$ <sup>8,19</sup> leading to the reregime of high an isotropy sult (18) for the crossing energy and to the maximum dis- $22^{2} = [_{J} \ln (2_{J} = )]$ . This calculation placem ent  $u_1$ is based on (i) quadratic approximation for the magnetic tilt energy and (ii) assumption that the JV in-plane currents are not in uenced much by pancake displacem ents. The rst assumption breaks down when  $u_1$  approaches and the second one breaks dow n when  $u_1$  becom e com parable with J. Thism eans that the both approxim ations break down as approaches J.

Pancake displacements  $v_n$  have symmetry properties  $v_{n+N} = v_n$  and  $v_{1-n} = v_n$ . This allows us to reduce in nite m summation in Eq. (46b) to summation over half of the unit cell 1 m  $N_L$ ,

The stability of the crossing con guration has been addressed recently by D odgson<sup>21</sup> using the full magnetic coupling energy but without taking into account modi – cation of the Josephson vortex by pancake displacements. The latter can not be easily computed analytically. This calculation suggested that the crossing con guration becomes unstable at  $=_J$  1=2.86 0.35. This estimate seems to be in contradiction with the recent decoration experiments<sup>22</sup> where the isolated pancake stacks sitting on the Josephson vortices have been observed in the strongly overdoped BSCCO with the ratio signi – cantly larger than this value.




FIG. 2: (a) The dependence of the maximum pancake displacement in the crossing (de ned in the inset) on the ratio  $= = _J$  for di erent periods a in x direction. Plot shows that crossing becomes unstable near = 0.69. Inset shows crossing con guration near instability point. (b) The dependence of crossing energy on the ratio . For com parison sm all calculation is shown in both plots.

To resolve this contradiction and nd an accurate stability criterion we studied numerically evolution of the isolated crossing con guration with increasing ratio . For this purpose we used the code, which calculates the chain structure in Fig. 1, for large values of the periods a and N =  $2N_1$ . Figure 2a shows the dependence of the maximum pancake displacement on the ratio for N = 20 and di erent values of a. One can see that the crossing con guration becomes unstable near

0:69, which signi cantly exceeds a simple estimate in Ref. 21. The main reason for the extended stability range is that the pancake displacem ents signi cantly modify the structure of the Josephson vortex. This reduces forces which pull the pancake stacks away and com pensates for reduced m agnetic coupling restoring forces at large u. Finite-size e ect is only noticeable in vicinity of the instability. The small- calculation correctly predicts the maximum displacement up to 0:35 and underestimates it at larger . Figure 2b shows the dependence of crossing energy . It dem onstrates a rather regular behavior alm ost up to the instability point. Sim ilar to the maximum displacement, the small- calculation gives an accurate estim ate for up to 0:35.For higher an absolute value of exceeds the analytical

estimate.

# C. Typicalphase diagram within the range 0.4. 0.5: Phase transition from crossing to tilted chains with decreasing pancake separation




FIG. 3: Main pbt shows the dependence of the maximum displacement (de ned in the inset) divided by pancake separation on the parameters for N = 14 and a = 1.52 J. The chain structures are illustrated at marked points. In the con guration pictures circles show positions of the pancake vortices and horizontal lines mark locations of the Josephson vortices. One can see that the system evolves from weakly deformed chain ( = 0.25) via strongly deformed chain ( = 0.4) to modulated tilted chain ( = 0.46). The last structure transforms via a second-order phase transition at = 0.48 into tilted straight vortices.

At the rst stage we studied the evolution of chain structures with increasing  $=_{\rm J}$  for xed periods a and N . A s increases with the tem perature and Jis approxim ately tem perature-independent, increase of corresponds to increase of the tem perature in real system s except that our calculations do not take into account therm al uctuations. For sm all values of a and N we found that the chain structure evolves sm oothly. An example of such evolution is presented in Fig. 3 for N = 14 and a = 1.52 J. The main plot shows the dependence of the maximum pancake displacement from the straight-stack position  $u_{m ax}=a$  (de ned in the inset) on the parameter . We will use this ratio to characterize the chain structure throughout the paper. It changes from zero for straight stacks to (1 1=N)=2 for tilted chains. At small a weakly deform ed crossing con guration is always realized (see the structure at = 0.25). The pancake displacements grow with increasing and the chain evolves into strongly corrugated con gurations such as con guration for = 0.4 in Fig. 3. W ith further

increase of , this structure smoothly transforms into modulated tilted lines (see the structure for = 0.46). Finally, the last structure transforms via a second-order phase transition into the straight tilted lines. For param – eters used in Fig. 3 this occurs at = 0.48. The plateau in the dependence  $u_{m \ ax}$  () above this value of corresponds to the maximum displacement (1 1=N)=2 in the tilted chain.




FIG. 4: (a) The dependence of the local part of energy of the chain con guration on the ratio for N = 10 and a =3:4 J. For comparison, we also show analytical estimates for the crossing and tilted chain con guration. (b) Phase diagram in the plane [pancake separation a]-[ratio ] for the xed separation between JV s, N = 10. The solid line show s computed transition into the tilted chain state. The dashed line show s location of the transitional region where the energy of the crossing con guration is equal to the energy of the tilted con guration.

To compare num erical and analytical calculations we plot in Fig. 4a the num erically com puted -dependence of the local energy (42) together with analytical estim ates (43) for N = 10 and a = 3:4 J. One can see that the analytical estim ates accurately reproduce num erical results for the weakly deform ed crossing chain at < 0.35and for the tilted chain at > 0:5. How ever, in between the num erical study predicts interm ediate con gurations with energies smaller than the energies of the both lim iting con gurations. As a result, a naively expected rstorder phase transition is replaced by a continuous transition occurring at signi cantly larger . This behavior is quite general. We observed it within the broad range of the periods, 6 . N . 20, 2 .  $a=_J$  . 5 and the ratios 0:4 . . 0:6. In Fig. 4b we compare location of the phase transition into the tilted-chain state in the a - plane for N = 10 with location of the transitional region de ned by Eq. (33). The com puted transition line is always displaced from the estimated boundary in the direction of larger . The transitional region just marks the location of the interm ediate strongly deform ed chain con gurations. The observed continuous phase transition indicates that tilted lines become unstable with decrease of . It is known that an isolated vortex line in anisotropic superconductors is unstable within some range of tilt angles.<sup>24,25</sup> W e have to note that the stability criterion of a chain is not identical to the stability criterion of an isolated vortex line and requires separate study. At large values of a a continuous transition is replaced by a rst-order phase transition. However, as it was discussed in Sec. V, due to the attractive interaction between the pancake stacks, large separations may not realize in equilibrium because a is expected to jump from in nity to the maximum equilibrium separation am .




FIG.5: The dependence of the excess pancake energy per stack in units of " $_0$ , U, on the separation between pancakes a for = 0.5 and di erent N. The position of m inimum of this energy corresponds to the maximum equilibrium separation  $a_m$  (m arked for N = 8 plot).

To nd location of am in the phase space, we calculated the evolution of chain structures with changing a for xed and N. These calculations, of course, reproduce the chain structures and location of the transition line of the previous calculation. Following recipe of Sec. V, we calculated the a-dependence of the excess pancake energy per unit stack, U (a) a(E  $E_{VV}$ ), and nd am from the minimum location of this energy. Figure 5 shows an example of these dependencies for = 0.5and di erent N. Increasing U (a) at  $a > a_m$  implies attractive interaction between stacks at large separations. We can see that for = 0.5 the separation  $a_m$  weakly depends on N and lies in between 2  $_{\rm J}$  and 3  $_{\rm J}$ . Note that the N -dependence of the limiting value of U (a) at a! 1 re ects contribution from the crossing energy of

an isolated pancake stack with the JV array.




FIG.6: Chain phase diagrams in the plane  $a= _J$  N for two values of the ratio , 0.4 and 0.5. The solid line indicate phase transition into the tilted-chain phase. The dotted line shows the maximum equilibrium separation  $a_m$ . The dashed line shows crossover \reconnection" line at which the maximum displacement exceeds a=4 and weakly deformed crossing con guration crosses over into the strongly corrugated conguration. For = 0.5 we also show  $a_m$  for the tilted-chain phase analytically calculated from Eq. (39).

In Fig. 6 we present the chain phase diagram s in the a-N -plane for two values of , 0:4 and 0:5. Solid lines show the phase transition into the tilted-chain state (the dependence  $a_t (N)$ . One can see that at larger N the transition takes place at sm aller a. W ith increasing this line m oves higherm eaning that the tilted-chain state occupies larger area in the phase space. At large a weakly deform ed chain con gurations are realized, sim ilar to ones shown in Fig. 3 for = 0.25. With decreasing a the chain con guration crosses over into a strongly corrugated state. To mark location of this crossoverwe show in the phase diagram s by dashed lines the pancake separation at which the maximum pancake displacement um ax reaches a=4 (plot ar (N)). This crossover can be viewed as \reconnection" of pancake stack segments. Dotted lines show locations of  $a_m$  . We see that  $a_m$  (N ) line crosses

the transition line meaning that at small N  $a_m$  falls into the tilted-chain region and at large N it falls into the crossing-chains region. For = 0.5 we also show the analytical estim ate for  $a_m$  for the tilted chain calculated from Eq. (39). One can see that it agrees very well with num erical calculations. For = 0.5 and N 8 the transition is of the rst order. How ever, the pancake separation at the transition lies above  $a_m$  m eaning that it does not correspond to the ground state.

The obtained phase diagram s in ply that at sm all tilting angle of the eld with respect to the c axis (corresponding to sm all a) the tilted chains have lower energy than the crossing chains. This is sim ilar to the situation at higher elds, in the dense lattice, where the crossinglattices state also is expected to transform into the sim ple tilted lattice at sm all tilting angle of the eld.<sup>8</sup>

At higher values of the ratio a new qualitative feature emerges in the phase diagram. W hen exceeds the characteristic value, a small c-axis eld penetrates superconductor in the form of kinks form ing kinked vortex lines (lock-in transition, see e.g., Refs. 3,4,5). The critical value of is determined by combination of num erical constants in the pancake-stack and kink energies and it is given by  $_{c} = \exp C_{kv}$ , where the constant  $C_{kv}$ is de ned after Eq. (26). To nd the value of  $_{\rm c}$ , we calculated in Appendix A the energy of tilted chains at very large pancake separations a, which allowed us to extract the energy of an isolated kink. This calculation gives C<sub>kv</sub> 0:81 corresponding to 0:44. It is in portant to note that the critical value of increases with decrease of N, due to the increasing contribution of the crossing energies to the total energy of crossing chain. Very interesting behavior is expected when is only slightly larger than c. The competing chain states have very di erent interactions: deform ed stacks attract and kinks repeleach other. M oreover, at the sam e value of the c-axism agnetic induction,  $B_z$ , the kink separation is much smaller than the stack separation and the absolute value of the kink interaction energy is much larger than the interaction energy between deform ed stacks. As a consequence, with increasing  $B_z$  the total energy of the kinked lines rapidly exceeds the total energy of the crossing chain and the system experiences a rst-order phase transition into the crossing-chain state. Due to the attractive interaction between the pancake stacks, the pancake/kink separation at which the energy curves cross does not give the equilibrium separation for the crossing chain and the stack separation jum ps at the transition to a value slightly smaller than the maximum equilibrium separation  $a_m$  . This means that the phase transition is accompanied by jump of pancake density and magnetic induction,  $B_{z}$ .




FIG. 7: The dependence of the excess pancake energy per stack on pancake separation a for N = 16 and = 0.6. The two branches correspond to the two di erent starting states at large a, crossing chain and kinked lines. One can see that the kinked lines have lower energy at very large a, a > 14.81. C rossing chain sm oothly transform s back into tilted chain with decrease of a. The transform ation is completed at a second-order phase transition point at  $a_t = 2.5$  J. Chain con gurations at four points m arked by arrows are shown below. The evolution of chain con guration along this energy curve is also illustrated by an anim ation.<sup>26</sup>

This behavior was con med by numerical calculations. Figure 7 shows a plot of the dependence of the pancake energy U on the pancake separation for N = 16= 0:6. This dependence has two branches, correand sponding to the two di erent starting states at large a, crossing chain and kinked lines. This branches cross at a = 14.8 J and the the kinked vortex lines have sm aller energy at larger a. The variations of U at large a occur due to the interaction energy and one can see that the kink interaction energy is much larger than the interaction energy of the deform ed stack in the crossing chain. With further decrease of a, the crossing chain sm oothly transform s into the tilted chain, as it was described in the previous Section. The second-order phase transition for these param eters takes place at a 2:5 ј som ew hat sm aller than the maximum equilibrium separation am 3:44 J.

The pancake separation (or pancake density) in the




FIG. 8: The density dependence of the pancake part of the therm odynam ic potential per unit area, E n (in units of  $_0 = _J$ ) at di erent chem ical potentials corresponding to di erent values of the m agnetic eld strength for N = 14 and = 0.6. K inks in the curves separate regions of tilted/kinked lines (low n) and crossing chains (high n). The equilibrium density in units of  $1 = _J$  is given by the global m inim um of this energy. O ne can see that at 0.152 the system experiences a rst-order phase transition with very large density jum p.

chain can not be directly xed in experiment. Instead, the magnetic eld strength, H<sub>z</sub>, xes the chemical potential H, H =  $_{0}$ H<sub>z</sub>=(4), and the equilibrium density is determined by the global minimum of the thermodynamic potential G (n) = E (n) H n. To nd evolution of density with increasing chemical potential, we plot in Fig. 8 the density dependencies of the reduced therm odynamic potential, E n for di erent and representative parameters N = 14 and = 0.6. As the energy of isolated stacks is subtracted in E, the dimensionless chemical potential is shifted with respect to its bare value and it is related to the magnetic eld strength as

where  $H_{cl}$  is the lower critical eld for H kc. We nd that for selected parameters the transition takes place at = t = 0.152. At < t the global minimum falls into the region of kinked lines and at > t it jumps into the region of crossing chain. Note that the density

value, at which the energy curves cross (kinks in the lines near n = 0:1 in Fig. 8), is always larger than the lower density from which the jump to the high-density state takes place. At the transition, the density jumps almost ten times, from 0:037= $_{\rm J}$  to 0:315= $_{\rm J}$ .

The num erically obtained phase diagram in the N-a = 0.6 is shown in the upper panel of F ig. plane for 9. The plots in the lower left panel, the therm odynam ic potential at the transition point and the maximum displacem ent versus a= J, illustrate de nitions of di erent lines in the phase diagram . The lines 1 and  $1^0$  show the lim iting pancake separations at the rst-order transition between which the jump takes place. When the chemical potential is xed by external conditions, the area between these lines is bypassed in equilibrium. At large N the jump takes place from the kinked-lines state into the strongly corrugated con guration. This con guration transforms into the tilted chain with further decrease of a via continuous transition shown by the line 2<sup>0</sup>. Below N = 14 only tilted chains realize, but the density jump still exists. The upper separation grows approximately proportional to N while the lower separation slow ly decreases with N and lies slightly below the maximum equilibrium separation am shown by dotted line. This means that the relative density jum p increases with N . The line 2 shows the position of the crossing of the energy curves for the two states.

It is also instructive to exam ine the phase diagram for xed c-axis period N, in the a- plane. As increases with temperature, this diagram to some extent describes the temperature evolution of the chain structure. Figure 10 shows such diagram for N = 14. One can see that the phase transition line is reentrant, within some range of the tilted chains are realized both for sm all




FIG.9: The upper plot shows the phase diagram in the N-a plane for = 0:6. The left plot in the lower plat illustrates meanings of the phase lines using the plot of the therm odynam ic potential E n vs a= J at the transition point (main plot) and the maximum displacement u divided by lattice spacing a vs a = J (inset). The lines 1 and  $1^{\circ}$  correspond to the two lim iting pancake separations at the transition point between which the jump occurs. The line 2 indicates crossing of the energy curves for the kinked and crossing chain. The line 2° shows the position of a continuous transition into the tilted chain (illustrated by the inset in the lower panel). Dotted line slightly above 1<sup>0</sup>-line shows the position of the maximum equilibrium separation am . W e also show the crossover line a = J = N above which well-de ned kinks appear. The right plot in the low er part show s blow up of the phase diagram above the  $2^0$  line.

and large a. Above some critical value of (0:66 for N = 14) only straight tilted lines exist in whole range of a. This maximum value increases with N . For somewhat smaller values of , there is narrow range of a where the chains become slightly modulated. This is illustrated in the plot of the maximum displacement u for = 0.63in the right panel of Fig. 11. The maximum equilibrium separation line  $a_m$  ( ) term in a tes at certain value of , above which the dependence U (a) becomes monotonic. We also show in this diagram the stability boundaries extracted from the in ection points in the U (a) dependencies (see criterion (38) and related discussion). O rigin of such phase diagram can be better understood by studying the dependencies U (a) at di erent shown in the left panel of Fig. 11.0 ne can see that the rst-order transition vanishes above certain value of and the dependence U (a) becom es monotonic close to this value of . On the other hand, even after becoming monotonic, this dependence still has two in ection points bounding




FIG.10: Phase diagram in a- plane for N = 14. Solid noseshaped line shows the phase transition into the tilted-chain state. Dashed line shows location of the maximum equilibrium separation, which term inates at some point. We also show by dotted line location of the stability boundaries obtained from in ection points of the dependencies U (a) (see criterion (38)).




FIG.11: Left panel: The dependencies of the excess pancake energy per stack U on separation a for N = 14 and di erent values of .W ith increasing the rst-order transition from tilted to crossing chain vanishes and the crossing chain do not realize at all. A lso the dependence U (a) become s monotonic which corresponds to term ination of  $a_{\rm m}$  () line in Fig.10. Right panel: The dependence of the relative maximum displacement u on separation a for N = 14 and = 0.63. The maximum value of u, corresponding to tilted chains, is given by (1 1=14)=2 0.464. One can see that there is a range of a where the chains become only slightly modulated.

unstable region in som e range of a. Existence of such unstable region m eans that the pancake-density jum p with increasing the c-axis external eld persists in the region where only tilted chains exist. This jum p is closely related (but not identical) with the jum p of the tilt angle of the vortex line at the lower critical eld with increasing tilt angle of the external eld.<sup>27,28</sup>

The vortex chains in BSCCO at sm all concentrations of pancakes have been studied by the scanning H all probe m icroscopy in Ref. 14. It was found that at very sm all concentration of pancakes the chains are m agnetically hom ogeneous and separate pancake stacks are not resolved. W hen the external eld exceeds certain critical value, crystallites of the pancake stacks are suddenly form ed along the chains and the ux density in crystallites approximately ten times higher then the ux density in homogeneous chains. The [kinked lines]-[crossing chains] rst-order phase transition provides a very natural ex-

planation for this observations.

#### VII. CONCLUSIONS

In conclusion, we investigated num erically and analytically the phase diagram of an isolated vortex chain in layered superconductors. In the region where Josephson and m agnetic coupling are approxim ately equal, we found a very rich behavior. The crossing chains typically transform into tilted chains with decreasing pancake separation via form ation of interm ediate strongly deform ed congurations and a continuous phase transition. W hen the relative strength of the Josephson coupling exceeds som e typical value, the phase diagram becom es reentrant. At a very small c-axis eld, tilted chains are realized in which the vortex lines have the kinked structure. W ith increasing c-axis eld these low-density tilted chains transform via a rst-order phase transition into strongly-deform ed crossing chains. This transition is accompanied by a large jump of the pancake-vortex density. With further increase of the eld these crossing chains transform s back into the tilted chains via a second-order transition.

An important feature of real BSCCO which is not taken into account in this paper is the thermal vortex uctuations. We expect that uctuations will not change qualitatively the described behavior, especially the strong rst-order phase transition, but may signi cantly change locations of the phase transitions in the phase space.

Finally, we brie y overview the relevant eld scales. In the range of studied JV separations, N, from 10 to  $20_{\rm p}$  and for = 500, the in-plane eld,  $B_{\rm x}$  =  $2_{0}$  = ( $\overline{3}$  s<sup>2</sup>N<sup>2</sup>), varies in the range from 200 to 50 G auss and the in-plane separation between Josephson vortices,  $c_{\rm y}$  = ( $\overline{3}$ =2) sN, varies from 6.75 to 13.5 m. The

typical density jump for N = 16 and = 6 in Fig. 9 corresponds to jump if the average c-axis induction,  $B_z = 0=ac_y$ , from 0.12 to 1.2 G auss. Such jump is usually di cult to notice in the globalm agnetization measurements. Therefore, a rich spectrum of transform ations discussed in this paper takes place in the range of very smallc-axism agnetic induction, not exceeding few gauss. Taking a typical value for BSCCO at 80K, as 0.4 m, we estimate for the same parameters that the maximum c-axis eld in the chain center,  $B_{z0} = 0=a$ , jumps from 3.3 G auss to 33 G auss.

# APPENDIX A: KINK INTERACTION ENERGY OF A SINGLE LINE

W e com pute the kink interaction energy within London approxim ation. As the main contribution to this energy com es from the regions away from the JV and kink cores, one can expect that the London approach gives a very good approxim ation of the interaction energy. Shape of the kinked line is given by

From the general form ula (8) we obtain the total energy of the kinked line in London approximation

To separate the kink interaction energy one has subtract from this expression the energies of Josephson vortices,  $\mathbf{I}_{JV}^{L}$ , and kinks,  $\mathbf{I}_{kink}^{L}$ , in London approximation. Integration over X, X<sup>0</sup>, and  $k_x$  leads to the following expression for the total kink contribution to energy,  $\mathbf{I}_{k}^{L} = \mathbf{I}_{k1}$ .

# APPENDIX B:DERIVATION OF THE IN TERACTION ENERGY OF TILTED VORTICES.

The interaction potential between two straight tilted vortices per unit length along c-axis separated by distance R in the tilt direction (x axis) is given by




FIG.12: Left panel shows plot of the pancake part of the chain energy per unit area in units " $_0$ =  $_J$ , E, vs pancake density n at very small n. Slope of this energy at n ! 0 determ ines the energy of an isolated kink and the num erical constant C<sub>kv</sub>. Calculations were made for two sets of parameters, (N = 10; = 0.52) and (N = 14; = 0.6), and for two system sizes for each set. Right picture illustrates the num erically calculated kink structure. A rrows show in-plane currents and gray level plot codes distribution of the cosine of phase di erence between the neighboring layers (dark area below corresponds to the Josephson vortex.)

# APPENDIX C:ENERGY OF ISOLATED KINK

To nd the energy of an isolated kink, we calculated energy of tilted lines in the regim e when kink separation L = a=N signi cantly exceeds the Josephson length. Numerically, this is a challenging task because the kink interaction energy decays slow by with increasing L meaning that one has to go to very large values of a. To maintain su cient accuracy, one has to use large number of grid points in x direction. As follows from Eq. (32), the pancake part of energy vanishes linearly at small kink concentrations n. In reduced units, we de ne this energy as  $E = (J = "_0) (E_{TV} = E_{PV}^s = E_{JV})$  and from Eq. (32) we have

P lots of this energy are shown in Fig. 12 for two sets of parameters, (N = 10; = 0.52) and (N = 14; = 0.6). From linear ts at small n we obtain estimates  $C_{kv}$ 

0:192  $\ln(1=0.52)$  0:846 for the rst set and  $\mathcal{G}_{vv}$ 0:296  $\ln(1=0.6)$  0:807 for the second set. If we use the last constant, corresponding to the larger system size, we obtain the estimate  $C_k$  0:31 for the constant in the kink energy within G inzburg-Landau theory (24). This is somewhat smaller than the value 0:17 reported in Ref. 6. The di erence is most probably due to nitesize e ects.
