# Survival of a D i using Particle in a Transverse Flow Field

We consider a particle di using in the y-direction, dy=dt = (t) where (t) is G aussian white noise, and subject to a transverse ow eld in the x-direction, dx=dt = f(y), where x 0 and x = 0 is an absorbing boundary. We discuss the time-dependence of the survival probability of the particle for a class of functions f(y) that are positive in some regions of space and negative in others.

I. IN TRODUCTION

In a recent paper [1] we considered a class of stochastic processes de ned by the equations

where (t) is Gaussian white noise with mean zero and correlatorh (t) ( $t^{0}$ ) i = 2D (t  $t^{0}$ ). Equations (1) and (2) represent a particle which di uses (perform s a random walk) in the y-direction but is subject to a determ inistic drift in the x-direction with a y-dependent drift velocity. We consider the case where there is an absorbing boundary at x = 0, and we are interested in the survival probability of the particle. Two previously studied models are the cases f(y) = y and f(y) = sgn(y). The form er is equivalent to the random acceleration process, x = (t), while the latter is the windy cli ' model introduced by Redner and Krapivsky [2]. For both these m odels, the survival probability of the particle decays as t  $^{1-4}$  for large time t, and it has been argued [1,2] that this is a generic result for odd functions f (y). It should be noted that, in general, such problem s are highly nontrivial and exact solutions are available in only a small num ber of cases.

In ref. [1], we raised the question of how the survival probability decays when the function f (y) is not an odd function. We considered a class of models where f (y) =  $v_+ y$  for y > 0, and f (y) = v ( y) for y < 0. Here the drift takes the particle away from the absorbing boundary for y > 0, and towards it for y < 0, but not in a symmetrical way: the function f (y) is odd only when  $v_+ = v$ . Using an extension of a technique developed by Burkhardt [3] in connection with the random acceleration process, we showed that the survival probability decays ast for large t, where the exponent (the persistence exponent') is nontrivial and given by

where = 1 = (2 + ). This reduces to = 1 = 4 for  $v_{+} = v$ but lies in the range 0 < < 1 = 2 in general. When  $v_+>v$ , the drift away from the boundary is weakly dom inant. The decay of the survival probability still has a power law form, but  $<1{=}4$ , while the converse occurs for  $v_+<v$ : the drift toward the boundary is weakly dom inant and  $>1{=}4$ . The fact that 1=2 is an upper bound for  $%1{=}1{=}2$  is clear when one recalls that the probability that the particle stays in the region y>0 (and therefore never encounters the drift towards the absorbing boundary) decays as t $^{1{=}2}$  [4,5].

It is worth emphasising that the process de ned by Eqs. (1) and (2) is non-G aussian except when f (y) is linear. Eq. (3) is a rare example of an exactly calculable persistence exponent for a non-G aussian process.

In [1] we speculated about the behavior of the system when the function f (y) is described by di erent exponents, \_ + and \_, for y > 0 and y < 0 respectively. We argued that for \_ + > the drift away from the boundary is strongly dom inant, leading to a non-zero survival probability at in nite time (i.e. = 0), while for \_ + < the drift tow ands the boundary is strongly dom - inant and obtains its maximum value of 1=2.

In the present work we obtain some exact result pertinent to the latter question. Looking at the case  $_+$  >

, we show explicitly that the survival probability approaches a non-zero value at in nite time and we obtain a closed-form expression for this value.

In the second part of the paper we revisit the issue of whether the decay exponent takes the value 1=4 for all odd functions f (y), as has been assumed up to now. W e consider m odels w here the ow eld takes a periodic, banded form with f(y) taking the values  $v_+$  and v in alternate bands of width b+, b respectively. W e dem onstrate num erically that for the case  $b_{+} = b$  and  $v_{+} = v$ which, with appropriate cloice of the y = 0 axis, represents an odd function, = 1=2, not 1=4 and we argue that = 1=2 whenever there is no net drift, i.e. when  $v_{+} b_{+} = v b$ . In these cases we argue that an elective di usion in the x-direction, resulting from the stochastic movem ent between the alternating bands, dom inates over the drift and naturally accounts for the exponent 1=2. We obtain an analytical result in the lim it b ! 0, v ! 1, with b v held xed and equal to  $b_t v_t$ , and we verify that = 1=2 in this case.

The model we consider initially is dened by Eqs. (1) and (2), with the function f(y) given by

We work in the regime  $_{+} > _{-}$ , where we expect a non-zero survival probability. The probability, Q (x;y) that the particle survives to in nite time satis es the backward Fokker-Planck equation (BFPE) D( $_{yy}Q$  + f(y)( $_{x}Q$  = 0. In the present context it is convenient to work instead with the killing probability', P = 1 Q, which obviously satis es the same equation,

but with di erent boundary conditions. The boundary conditions on P (x;y) are

the last of these following from the fact that, for an initial condition with x = 0 and y < 0, the ow immediately takes the particle on to the absorbing boundary.

Inserting the form (4) for f(y) in (5), the equation can be solved separately in each regime by separation of variables. Im posing the boundary conditions (6) and (7) the result takes the form (setting D = 1 for convenience)

J (z) is a Bessel function and K (z) a modied Bessel function.

Eqs. (9) and (10) contain the three undeterm ined functions a (k), b(k) and c(k). The last two can be expressed in term s of a (k) by in posing suitable continuity conditions at y = 0. From the BFPE, Eq. (5), it follow that both P (x;y) and  $e_yP$  (x;y) are continuous at y = 0. Im posing these conditions gives the relations

Finally, a(k) is determined by the boundary condition (8). This gives

In principle, Eqs. (12), (13) and (16) completely determ ine the functions a(k), b(k) and c(k). In practice, how – ever, we have been unable to extract these functions explicitly. We can, how ever, determ ine the small-k form s. These are su cient to demonstrate our main claim s.

To determ ine the small k behavior of a (k) we consider Eq. (16) in the lim it y ! 1, since the integral is dom - inated by small values of k in that lim it. We make the ansatz

Then the small-k forms of b(k) and c(k) are xed by equations (12) and (13). Since  $_{+} < , b(k)$  c(k)for k ! 0, so the rst term, involving b(k), in Eq. (16) dominates for large negative y, and the term involving c(k) is negligible. In this lim it, therefore, Eq. (16) reads

Evaluating the integral xes the values of the exponent a and the amplitude A in Eq. (17):

Inserting the small-k results for a(k), b(k) and c(k) in Eqs. (9) and (10) determ ines P (x;y) in the entire regime where x or y (or both) are large. Especially simple is the lim it of large x at y = 0, where one obtains

for x ! 1 . This result dem onstrates that there is a nonzero in nite-time survival probability provided > + , i.e. + > . The spatial decay exponent, + , should have (we feel) a simple physical derivation, but so far it has eluded us. In the remaining part of this paper we consider the case where f (y) is a periodic function of y, with period 2b. In particular, we consider the case

for all integers n. This function f (y) is odd, but we shall show that the survival probability decays asym ptotically as t  $^{1\!-\!2}$ .




FIG.1. Double logarithm ic plot of the survival probability Q against time t for a range of band widths b. The data show, after a short-time transient, an initial t <sup>1=4</sup> decay crossing over to a t <sup>1=2</sup> decay at later times. The dashed lines with slopes 1=4 and 1=2 are guides to the eye.

We rst present, in Figure 1, the result of a numerical simulation for di erent values of the width, b, of the alternating bands. In each case the particle is initially located at x = 0, on the interface between two bands. To avoid immediate absorption, the rst step is taken into the band with positive velocity. For early times, t  $b^2=D$ , the particle explores the two bands either side of the initial position and the decay exponent 1=4, appropriate to in nitely wide bands is obtained. At time t  $b^2=D$ , how ever, where the particle starts to explore many bands, there is a clear crossover from the initial t  $^{1=4}$  decay to an asymptotic t  $^{1=2}$  decay.

To understand these results, we rst recall the use of the Sparre Anderson theorem [6] to demonstrate that = 1=4 for odd functions f(y). First suppose that f(y) > 0 for y > 0 and f(y) < 0 for y < 0. We focus on crossings of the x-axis and regard the steps between crossings as the elementary steps of a one-dimensional random walk on the x-axis. The steps are clearly (i) independent, and (ii) drawn from a symmetric distribution. The Sparre Anderson theorem states that the probability that the process has not crossed the absorbing boundary at x = 0 after N steps decays as  $Q_N = N^{1=2}$  for large N. Since the number of crossings in time t scales as  $N = t^{1=2}$ , this implies Q (t) t  $1^{1=4}$ .

Let us exam ine this argument more carefully. It's validity clearly requires that a crossing of the absorbing boundary at x = 0 can occur at most once between two consecutive crossings of the x-axis. This will always be the case if f(y) takes only one sign for y > 0 and the other sign for y < 0. In the periodic case, however, f(y) takes both signs for y > 0 and both signs for y < 0. The process can therefore cross the absorbing boundary, from x > 0 to x < 0, and cross back again without crossing the x-axis. Such absorption process will be missed in a description which focuses only on crossings of the x-axis. Such a description will typically underestim ate the value of (it gives a lower bound on ).

A better way of looking at this problem is as follows. The probability Q(x;y;t) that the particle survives until timet, given that it started at (x; y), is periodic with period 2b. In particular, the partial derivative  $Q_v Q$  vanishes by symmetry at the center of any band. It therefore sufces to solve the problem in the region b=2V b=2, 0, which de nes a sem i-in nite strip, with boundary х conditions Q (0;y;t) = 0,  $Q_yQ(x; b=2;t) = 0$ . The ow velocity is v in the upper part of the strip (y > 0) and v in the lower part. This strip problem has been discussed by Redner and K rapivsky [2], who argue as follows. The typical time between crossings of the center line, y = 0, is b=D. The typical distance travelled, in the xdirection, in this time is  $1 \quad v\dot{B} = D$ . The two cases x 1 and x l, where x is the initial displacement of the particle, have to be analysed separately. The following discussion is based on reference [2].

# A.The regime x l

The crossings of the x-axis de ne a symmetric onedimensional random walk with step length land time step . The elective di usion constant for motion in the x-direction is, therefore, D<sub>k</sub>  $\hat{f} = \hat{\forall} b^2 = D$ . The survival probability for this random walk is given by the well-known result [4]

Note that the y-dependence is not determ ined by this argument. It is intuitively clear, however, that the result is insensitive to y at large x.

C om paring this result with F igure 1, we note that the amplitude of the t  $^{1=2}$  behaviour in the late-time regime increases with increasing b in F igure 1, whereas Eq. (23) predicts a decreasing amplitude with increasing b. The data, however, were obtained with the initial x equal to

zero (with x = v after one time step). To make meaningful comparisons with the data, therefore, we need to analyse the opposite regime x 1.

#### B.The regime x 1

For x l, one can argue as follows. At short times, t , the behaviour will be the same as for strips of in nite width, Q (t)  $(x=vt)^{1=4}$  [2]. At later times, this result will be modiled by a function of t= , Q (t) =  $(x=vt)^{1=4} f (D t=b^2)$ . For t =  $b^2=D$ , there should be a crossover to the t<sup>1=2</sup> decay calculated above, since if the particle survives for time , it will typically reach a distance x v = 1. The scaling function f (z) therefore behaves as z<sup>1=2</sup> for large z, giving




FIG.2. Double logarithm ic plot of the survival probability Q against time t plotted in the scaling form  $t^{1=4}Q$  against  $t=b^2$ . The dashed line with slopes 1=4 is a guide to the eye.

The two results Eqs. (23) and (24) m atch, as required, at x  $l = vb^2=D$ , where both reduce to Q b=Dt. The scaling form Q (t)  $t^{1=4}f(Dt=b^2)$  is tested in Figure 2, where  $t^{1=4}Q$  is plotted against  $t=b^2$  on a double logarithm ic plot. A fler the initial transients, there is a good collapse of the data onto a scaling curve, in which an initial slope of zero gives way, att'  $b^2$ , to a nall slope of 1=4, corresponding to the regimes Q (t)  $t^{1=4}$  and Q (t)  $t^{1=2}$  respectively.




FIG.3. Double logarithm ic plot of the survival probability Q against time t for the band m odel, for dierent types of absorbing boundary. The dashed lines with slope 1=4, 1=3and 1=2 are guides to the eye. In order of increasing steepness, the corresponding data refer to absorbing boundaries given by (i) the negative y-axis, (ii) the negative y-axis and the negative x-axis and (iii) the whole y-axis. Least squares ts to the data give slopes -0.254, -0.333 and -0.501 respectively, consistent with the predicted values.

We can interpret the asymptotic result Q  $t^{1=2}$  as follows. If we coarse grain in the y-direction, the average determ inistic drift is zero, and the nom inally subdom inant di usive motion in the x-direction [2], with di usion constant D<sub>k</sub>, plays an important role. The elective coarse-grained dynam ics corresponds to anisotropic twodimensional di usion. If the absorbing boundary is the whole y-axis, di usion in the y-direction is irrelevant (except for its role in inducing di usion in the x-direction) and the standard one-dimensional result for the survival probability, Eq. (23), is obtained. One can now discuss, how ever, other types of absorbing boundary. First we consider absorption on the half-line x = 0, y < 0. Numerical simulations, presented in Figure 3, suggest = 1=4for this case, while for absorption on the two half lines x = 0, y < 0 and y = 0, x < 0, which de ne an absorbing wedge of angle =2, the data suggest (for x > 0 initially) = 1=3.

These seem ingly mysterious exponents are readily understood in the context of the underlying an isotropic twodim ensional di usion process. For isotropic di usion inside a wedge of opening angle, with absorbing boundaries on the edges of the wedge, the survival probability is known to decay as a power law, Q (t) t , with = =2 [7,4]. The absorbing boundary on the half-line x = 0, y < 0 corresponds to opening angle = 2, giving = 1=4, while the absorbing boundary on the two half-lines x = 0, y < 0 and y = 0, x < 0 corresponds to = 3 =2, giving = 1=3. A lthough the e ective diffusion process is here an isotropic, it can be transform ed into an isotropic process by rescaling the x or y variable. Since this rescaling does not change the geom etry of the two absorbing boundaries considered, the results = 1=4and 1=3 respectively are not changed.

It is straightforw and to apply the sam e general reasoning to the band m odel w here the positive-and negativeow bands are inequivalent. Consider a model where bands of width  $b_{+}$  and  $f(y) = v_{+}$  alternate with bands of width b and f(y) = v. For the special cases where  $b_{+}v_{+} = b v$  there will be no macroscopic ow, and a coarse-grained description will lead to an anisotropic diusion model as before, with the same values of , e.g. = 1=2 if the whole y-axis is absorbing (indeed, = 1=2 will hold for any periodic f (y) with zero m ean). b v > 0, the coarse-grained model has a If b<sub>+</sub> v<sub>+</sub> mean ow away from the absorbing boundary, and the in nite-time survival probability is non-zero, while for bv < 0 the mean ow is towards the boundary b+ v+ and the survival probability decays exponentially with time. In the following subsection we provide an exact solution for the case  $b_t v_t = b v$ , in the lim it b ! 0, v ! 1, with u = b v held xed.

## C.A solvable m odel

The model we study is dened by a periodic function f(y), with period b, given by

with f(y+b) = f(y) for ally. The marginal case of interest, corresponding to no net ow, is given by u = bv. It is convenient, in the rst instance, to compute the killing probability P (x;y;t). The periodicity in plies that we need only consider the regime b=2 y b=2, with the boundary conditions  $@_yP(x;b=2;t) = @_yP(x; b=2;t) =$ 0. The function P obeys the BFPE

Taking the Laplace transform with respect to time, and exploiting the initial condition P(x;y;0) = 1 for all x > 0, gives

where  $P(x;y;s) = \frac{R_1}{0} dt exp(st)P(x;y;t)$ . The general solution satisfying the given boundary conditions at y = b=2 is (setting D = 1 for convenience)

for  $y \in 0$ . Imposing the discontinuity in  $\mathbb{Q}_y \mathbb{P}$  at y = 0 implied by Eq. (27),  $\mathbb{Q}_y \mathbb{P}(x; 0+;s)$   $\mathbb{Q}_y \mathbb{P}(x; 0;s) = u\mathbb{Q}_x \mathbb{P}(x; 0;s)$  for all x > 0 and all s, leads to the condition

Eq. (29) shows that only a single value of k is possible for each s. Specialising to the marginal case u = bv, this equation simpli es to

The large-time behavior is governed by the small-s solution of Eq. (31): '  $(3b^2s=4)_p^{1=4}$ . Inserting this into Eq. (30) gives, for small s, k ' 2' 3s=bv and ' kv + s '  $(3s)^{1=4}$  2=b. Putting these results into Eq. (28) gives

The amplitude a(s) is xed by the boundary condition, P (0;0;t) = 1 for all t, which gives F'(0;0;s) = 1=sand  $a(s) = fs \cosh[(3s)^{1=4}] = b=2$ ]g<sup>-1</sup> for smalls. Since Q (x;y;t) = 1 P (x;y;t), we have Q'(x;y;s) = 1=s F'(x;y;s). The small-s result for F' determ ines the larget form of Q (x;y;t) as

for jyj b=2. This result con m s, for this special case, the result Q (t) t<sup>1=2</sup> obtained above using general heuristic arguments for the case where there is no net ow. Note that Eq. (33) has the same form as Eq. (23), and that this form holds for all values of x=1, where  $l = vb^2=D$ , i.e. there is no analogue, in this model, of Eq. (24) for x l. This is because in the present model there is no regime in which the system s resembles a twoband model.

## IV.DISCUSSION AND SUMMARY

In this paper we have obtained further results on the rst-passage properties of a particle di using in the y-direction and subject to a determ inistic drift velocity, f (y), in the x-direction, with an absorbing boundary at x = 0.

In the rst part of the paper we considered the case where  $f(y) / y^+$  for y > 0 and f(y) / jyj for y < 0. We con rm ed the conjecture proposed in [1] that the larger power is 'strongly dom inating' (in contrast to the weakly dom inating' behaviour obtained when the exponents  $_{+}$  and are equal but the amplitudes are di erent [1]). We showed explicitly that for  $_{+}$  > the survival probability approaches a non-zero limiting value, and we obtained an expression for this value.

In the second part of the paper we considered the case where f (y) has a banded periodic form, with alternating bands of equal and opposite drift velocity. We presented numerical data, supported by a heuristic argument, to show that the asymptotic persistence exponent is = 1=2in this case, and obtained a generalisation for dierent forms of absorbing boundary. We argued that the result generalises to any model where the coarse-grained ow eld vanishes, and exemplied this result through a soluble model. PG 's work was supported by EPSRC .
