# Q uantum logical states and operators for Josephson-like system s

#### Abstract

W e give a form alalgebraic description of Josephson-type quantum dynam ical system s, ie., H am iltonian system s with a cos\#-like potential term . The tw o-boson H eisenberg algebra plays for such system sthe role that the $h$ (1) algebra does for the harm on ic oscillator. A single Josephson junction is selected as a representative of Josephson system s. W e construct both logical states (oodew ords) and logical (gate) operators in the superconductive regim e. The codew ords are the even and odd coherent states of the two-boson algebra: they are shift-resistant and robust, due to squeezing. The logical operators acting on the qubit codew ords are expressed in term sof operators in the enveloping of the two-boson algebra. Such a schem e appears to be relevant for quantum inform ation applications.

## I. INTRODUCTION

The term Josephson system $s^{\prime}$ denotes here all quantum system $s$, whose H am iltonian is characterized by a nonlinear cos\# potential term, regardless of the speci c details of their experim ental realization. In the eld of quantum inform ation this broad de nition encom passes physical system sw hich are considered good candidates for the actual im plem entation



In this Letterw e dealw ith Josephison system sfrom an algebraic point ofview. T he outline of our approach is as follow s: we perform, w ith respect to system $s w$ ith cos\# potential, a theoretical analysis closely analogous to the well-known Fock space description of system s w ith a quadratic potential, as it is carried out through the algebraic theory of the harm onic oscillator. M ore de nitely, we show that the tw o-boson H eisenberg algebra, which is a special case ofm ulti-boson algebra [1] $h(1)$ algebra does for the harm onic oscillator. T his is done starting from the exact expression oflooth the nonlinear H am iltonian and its energy eigenvalues in term s of characteristic energy param eters: the ensuing Fock space structure is proved to be given by the direct sum of even and odd subspaces.

W e then prove that this very algebra is relevant also forquantum com puting applications. Indeed it allow s for the construction of shift-resistant, squeezed logical states (codew ords) and the corresponding logical (gate) operators. M oreover such codew ords and gates appear to be natural for the realization of quantum error-correcting codes and in quantum search problem s.

Finally, the squeezing properties of the codew ords are obtained connecting the displace$m$ ent' and $m$ om entum ' variables describing the system $w$ ith the creation and annihilation operators of the two-boson algebra. This bridges our representation $w$ th the continuous variables quantum com putation schem e.

Since we describe fully nonlinear H am iltonian system $s$ in algebraic term $s$, any Josephson system would $t$ our theoretical schem e. H ere, for de niteness, we consider a single low-capacitance Josephson junction circuit, whose quantum dynam ics is govemed by the

In this context, in the quadratic kinetic part of equation (1ָ-1) $\mathrm{E}_{\mathrm{C}}=(2 \mathrm{e})^{2}=2\left(\mathrm{C}_{J}+\mathrm{C}_{\mathrm{g}}\right)$ is the electrostatic energy of the junction, $e^{\prime} C_{J}$ and $C_{g}$ being electron charge, junction and gate capacitance, respectively; $\hat{N}$ is the operator corresponding to the num ber $N$ of excess C ooper pairs between the superconductive islands, $\mathrm{n}_{\mathrm{g}}=\mathrm{C}_{\mathrm{g}} \mathrm{V}_{\mathrm{g}}=(2 \mathrm{e})$, which plays the role of an extemal charge' $[\underline{[1]} \overline{-1}]$, is the polarization charge (in units of 2e) induced by the gate voltage source $V_{g}$. Whereas in the periodic potential term $\mathrm{E}_{J}$ is usually referred to as the Josephson coupling energy and the phase operator \# corresponds to the phase di erence between the condensate wavefunctions of the islands. $\hat{N}$ and $\hat{\#}$ are canonically conjugated operators, i.e., $[\hat{\#} ; \hat{N}]=$ i.

Two di erent regim es for the junction can be identi ed, depending on the ratio = $\mathrm{E}_{J}=\mathrm{E}_{\mathrm{C}}$. In the charge regin $\mathrm{e} \quad 1\left(\mathrm{E}_{\mathrm{C}} \quad \mathrm{E}_{J}\right)$, the charge num ber operator $\hat{N}$ is shanp while, due to the uncertainty principle, the phase operator \# is undeterm ined. On the other hand, in the superconductive regim $e, \quad 1\left(E_{J} \quad E_{C}\right)$, the uctuations of $\hat{N}$ are so large that the phase operator $\hat{\#}$ is assum ed to be the good quantum number.

## II. ENERGY SPECTRUM AND TW OBOSON ALGEBRA

W ith reference to the superconductive regim e we rst prove that the energy spectrum of the Ham iltonian (İI) is given by an appropriate perturbative expansion and that the corresponding diagonalization of the H am iltonian is obtained in quite a natural way in a suitable Fock space by resorting to the algebra oftw o-boson operators. In equation $(\underline{\mathbf{2}})$ the potentialenergy is periodic of period 2 and B loch's theorem (which is the physicists' version of the $F$ loquet theorem līiol) im plies that its general solution can be
 are here determ ined by the periodicity condition ofthe physicalwave function, $k$ (\# + 2 ) = k (\#). The gauge transform ation and B loch's theorem show that such periodicity condition implies $r_{k}+n_{g} 2 Z$.

For large $Q$ the eigenvalues $E_{k}$ can therefore be calculated from $E_{k}=\left(E_{C}=4\right) a(k ; Q)+$ $\mathrm{E}_{\mathrm{J}}$, where only a( $\mathrm{k} ; \mathrm{Q}$ ) is kept, since in the asym ptotic regin e, as mentioned above, the tw o eigenvalue branches $\mathrm{a}(\mathrm{k} ; Q)$ and $\mathrm{b}(\mathrm{k}+1 ; Q)$ coincide; indeed the asym ptotic expansion

It is worth $m$ entioning that our diagonalization procedure, here explicitly carried out for large values of $Q$, can be applied also for $m$ all values of $Q$ : working again in the phase representation, one should only m odify the de nition of the perturbative param eter
(e.g., $\quad \doteq 2$ ) and utilize the appropriate series expansion of the $M$ athieu eigenvalues, e.g., the single form ula reported in [2]in], which holds once m ore for non integral values of the characteristic exponent.

We prove now that $H$ am iltonian $H_{J}^{0}$ can be diagonalized over a suitable Fock space
 that the diagonalized $H$ am iltonian should distinguish the parity of the eigenvalue index $k$.

A natural pathway to diagonalization is then provided by the two-boson H eisenberg algebra generated by operators $\mathrm{A}_{2}$ and $\mathrm{A}_{2}$, designed in such a way as to annihilate and

The experim ental realization of such operators cannot therefore be done resorting sim ply to dow $n$-conversion, because $A{ }_{2}^{y} \in a^{y^{2}}$, but requires the intensity-dependent m odulation of the amplitude described by $\mathrm{F}_{2}(\mathrm{~A})$. Indeed, equation $(\underset{-1}{5})$ de nes the two-boson realization of $h(1)$ and not of su $(1 ; 1)$, as $f a^{2} ; \mathrm{a}^{\mathrm{y}^{2}}$; $\hat{\mathrm{n}} \mathrm{g}$ would do. N otice that the bosonic excitations
 original dynam ical variables $\hat{N}$, $\hat{\#}$, are nonlinear quantum soliton-like ob jects, unrelated to the physical particles (C ooper pairs in the Josephson junction case, created and annihilated by $\mathrm{b}^{\mathrm{y}} ; \mathrm{b}$, where $\mathrm{b}^{\mathrm{y}} \mathrm{b} \mathrm{b}=\hat{\mathrm{N}}$ ) designed to fully account the states' parity.

W e em phasize that the expansion in , reported here only to the rst order for the sake of sim plicity, can be readily extended to any order, in no case being the algebraic structure a ected by the order at which the perturbative expansion is truncated.

## III. CODEW ORDSAND GATE OPERATORS

W e can now use the conservation of the num ber states parity to encode a qubit in the in nite-dim ensional system described by the H am iltonian ( $\overline{\text { (6) }}$ ). T The qubit codew ords are de ned as the odd and even coherent states of the two-boson algebra. To this aim, we start from the highest weight vector of such algebra, j! i = cos' j0i+ isin' jli.  they are clearly invariant under the action of $Z^{2}$ and $X^{2}$ : therefore they generate the code basis described in [2] $\left.{ }_{2}^{-1}\right]$ for the qubit, though here the nonlinearity of the H am iltonian is fully taken into account.

W e em phasize that the standard approaches utilized to im plem ent a qubit using either
 e ective two-level system by properly tuning the extemal control param eters. H ow ever it is well-known that two-level system s are not the only possible choice to perform quantum com putation. For instance it has been show $n$ that $m$ ulti-level system $s$ allow for the realization ofquantum error-correcting codes in which the state of a qubit is protected by encoding it in a higher-dim ensional quantum system [2] $\overline{2} \overline{-1}]$ and are of interest to solve database search


In this context our theoreticalapproach suggests that any Josephson system (for exam ple, the Josephson junction in superconductive regim e) can be regarded as a system to encode quantum inform ation in $N$ (num erable in nite-dim ensional qubit) rather than in $Z_{2}$ (binary qubit). A ctually codew ords ( $(\underset{1}{ })$ correspond to an e ectively two-dim ensional quantum system em bedded in the in nite-dim ensional H ibert space of the system.
IV. SQUEEZING

W e now show that the above codew ords are squeezed $w$ ith respect to the physical variables of the system, which means that the above encoding can be carried out, in principle, in quite a robust way. T he form alism we utilize show s that the schem e proposed is an e ective im plem entation of a full edge quantum computation over continuous variables [ַַּind. To this aim, we notice that an expansion in term $s$ of two-boson operators can be obtained also for $\hat{\#}$ and $\hat{N}$, by resorting to the dynam ical quantum algebra (w ith identity) generated by the dim ensionless operators $x ; p ; H$, related to the junction dynam ical variables. Such an algebra is $[\underline{[3 \overline{4}} \overline{-1}]$ the deform ation of the universal enveloping algebra of $h(1)$, w ith deform ation param eter $q=\exp (\dot{I} v), w=(2=)^{\frac{1}{4}}=4^{p}-$. The requirem ent of parity conservation, $m$ anifest in equation (1] $\overline{1})$, according to which only $a^{2}$ and not $a$ is provided by $M_{F}$, shows that the form al structure one is passing through in this construction is indeed the non-com pact algebra $s u(1 ; 1)$ : in $F_{\text {even }}$ and $F_{\text {odd }}, M_{F}$ is a (non-linear) invertible $m$ ap of $D^{\prime}{ }^{\prime}$ ) $\operatorname{su}(1 ; 1)$, with $=\frac{1}{4} ; \frac{3}{4}$, into $h(1)$. The $W$ eyl ideal of $h(1)$, generated by $a ; a^{y} ; I$, in this picture would further require the (intertw ining) m ap between $\mathrm{F}_{\text {even }}$ and $\mathrm{F}_{\text {odd }}$. It is again to be em phasized that the com plexity of the whole schem e is attributable to the fact that $a^{2} \in A_{2}$.

It is also worth mentioning that upon inverting expansions ( $(\overline{1} \overline{2})$ and ( $(\overline{1} \overline{3})$ in $)$ the two-boson operators $A_{2}, A_{2}^{y}$ could be expressed in term $s$ of the physical operators $\hat{N}, \hat{\#}$, thus realizing the necessary link between the structure of the two-boson algebra and directly m easurable quantities. This im plies that one could in principle explicitly construct $U$ in term $s$ of the two-boson algebra generators and hence the physical states $\mathrm{U}^{1}$ jni, jni 2 F .

Squeezing in \# and $\hat{N}$ produced by the codew ords $j$ i can be better described in term $s$ of $x$ and $p$, since $\hat{N} \hat{\#}=p x$ and $x$ and $p$ are readily expressed in term $s$ of tw o-boson operators from equations $(\underline{1} \overline{2})-(\overline{1} \overline{4})$. The relevant variances $w$ th respect to both $j$ i prove then to be ${ }^{\mathbf{1}} \mathbf{5} 51$

In equations ( $\overline{1} \overline{\bar{\sigma}})$ ) the num erical factor in square brackets is real and positive 8 . If the squeezing condition is de ned by the requirem ent that the variance of $x$ or $p$ be smaller than its coherent state value, then, to the rst order in , we have squeezing with respect to p as $(\mathrm{p})^{2}<\frac{1}{2}$; besides $(\mathrm{x})^{2}(\mathrm{p})^{2}=(\hat{\#})^{2}\left(\hat{N^{\prime}}\right)^{2}=\frac{1}{4}$. O ne can expect squeezing for codew ords $j$ i at higher orders in to depend on the value of '[
V. CONCLUSIONS

W e form ulated a theoretical, algebraic approach to Josephson system s , w ith full consideration of their nonlinear potential term . The two-boson H eisenberg algebra proved to be the appropriate algebraic tool fram ew ork for such class of system $s$, in analogy to what h(1) algebra is for system $\mathrm{s} w$ th quadratic potential.

As far as quantum com puting is concemed, we constructed codewords, de ned as the norm alized xed-parity even and odd coherent states of the tw o-boson algebra, and proved that such states are squeezed. W e gave also the explicit construction of the logicaloperators realizing the required action on the codew ords; such operators belong to the enveloping algebra of the tw o-boson algebra.

W hile our analysis was carried out with respect to the exam ple of a Josephson junction in superconductive regim e, we em phasize that the results here reported apply equally well to any Josephson system .
