Ab initio study of m irages and m agnetic interactions in quantum corrals

The state of the art ab initio calculations of quantum m images, the spin-polarization of surface-state electrons and the exchange interaction between m agnetic adatom s in Cu and Co corrals on Cu (111) are presented. We nd that the spin-polarization of the surface-state electrons caused by m agnetic adatom s can be projected to a rem ote location and can be strongly enhanced in corrals com pared to an open surface. Our studies give a clear evidence that quantum corrals could perm it to tailor the exchange interaction between m agnetic adatom s at large separations. The spin-polarization of surface-state electrons at the empty focus in the Co corral used in the experimental setup of M anoharan et al., (N ature 403, 512 (2000)) is revealed.

As the physical size of a system approaches atom ic dimensions, quantum e ects are known to play a significant role. One of the most striking illustrations of the quantum behavior in atom ic-scale nanostructures is the observation of the electronic con nem ent of surface-state electrons in the Fe corral constructed in an atom -by-atom fashion on a copper (111) surface [1]. The structures which con ne the electrons on surfaces can be built using the manipulation into the required geometry of individual adsorbed atom s by the scanning tunneling m icroscope (STM) [2]. A ltering the size and shape of arti cial structures, one could a ect their quantum states. The controllable modi cation of quantum states could perm it to manipulate individual spins, their dynam ics, interactions, and could be of a great in portance for the developm ent of quantum nano-devices.

Recent rem arkable experim ents of M anoharan et al. [3] have shown that the electronic structure of adatom s can be projected to a rem ote location exploiting quantum con nem ent of electronic states in an engineered nanostructures. Placing an atom of magnetic cobalt at one focus of the elliptical corral constructed from several dozen cobalt atom s on Cu(111) caused the K ondo m irage to appear at the empty focus. Results of this fascinating experiment have been explained by Fiete et al., [4] using the scattering theory. They have dem onstrated that the m irage at the empty focus of the elliptical corral is the result of resonant scattering of electrons from the magnetic adatom and scattering from the adatom s of the walls of the corral. There have also been several in portant theoretical studies related to quantum corrals and the m irage experiments [5-9].

A lthough above mentioned works have provided an appealing picture of quantum mirages and interactions in quantum corrals, a full understanding of the behavior of surface-state electrons in man-made nanostructures and their response to magnetic adatom s requires a rstprinciple calculations. Such studies would be of fundamental interest for our understanding of magnetism at the atom ic scale, and could establish a basis for the controllable manipulation of quantum states in atom ic-scale nanostructures. O byiously, the challenge would be to tailor the interaction between single spins.

In this Letterwe present a fully ab initio study of quantum mirages, the spin-polarization and the exchange interaction between m agnetic adatom s in corrals. W e concentrate on 3d adatom s in elliptical C u and C o corrals on Cu(111). We demonstrate that the interaction of magnetic adatoms with the con ned surface-state electrons of corrals leads to signi cant changes in electronic and m agnetic states of corrals, and could produce a m irage at a rem ote location. We show that the spin-polarization of surface-state electrons caused by magnetic adatoms placed in the corral focus is projected to an empty focus. Strong enhancement of the spin-polarization in corrals com pared to an open C u (111) surface is found. O ur study presents a clear evidence that the long-range exchange interaction between magnetic adatoms is strongly a ected by con ned electronic states of corrals. The possibility of tailoring the exchange interaction by modifying the corral geom etry is dem onstrated. The spin-polarization of the electron gas in the empty focus of the Co corral used in the experimental setup of M anoharan et al. [3] is revealed.


A datom s and corrals destroy the two-dim ensional (2D) periodicity of the ideal surface. Heller et al. [10] have shown in their studies of 'quantum stadium' that the multiple-scattering approach is physically motivated to treat the electronic states of an arbitrary corralgeom etry and arbitrary placed adatom s in 2D system s. Therefore, we believe that an ab initio method based on the multiple scattering theory is well suited for calculations of m agnetic adatom s in quantum corrals. O ur approach is based on the density functional theory (DFT) and multiplescattering approach using the Korringa-Kohn-Rostoker (KKR) G reen's function method for adatoms and clusters on surfaces [11]. A though the DFT does not account for properties of dynam ical origin like the K ondo e ect, it is an accurate method to determ ine static quantities [12]. Therefore, our calculations are related to electronic and magnetic properties of quantum corrals above the K ondo tem perature.

The Green's function of the corral (with or without adatom s) is calculated in a real space representation.

where $G_{LL_0}^{nn_0^{\circ}}(E)$ is the energy-dependent structural G reen's function matrix and $G_{LL_0^{\circ}}(E)$ the corresponding matrix for the ideal surface; $t_L^n(E)$ describes the di erence in the scattering properties at site n induced by the existence of the corral and adatom s [13, 14] T he atom ic structure of the substrate is taken into account in calculations [15].




FIG.1: (color) a: The LDOS at the corral focus; b: Q uantum interference patterns inside and outside of the corral. The elliptical Cu corral with sem i-axis a= 25 A, and eccentricity " = 0:5 on Cu (111) is presented; the distance between nearest Cu atom s in the corral walls is equal to the nearest neighbor separation on the Cu (111) surface. The LDOS of an open Cu (111) surface is shown by the dashed line

First, we consider the elliptical C u corral on C u (111) (Fig.1). The quantum interference between the electron



ing the quantum con nement. The spatial distribution of the LDOS at the Ferm i energy is presented in Figlb. The standing wave patterns outside and inside the corral are caused by the quantum interference of surface-state electrons scattered by atom s of the corral wall. The oscillations of the LDOS outside the corral at distances larger than 8 A are well described by the period of about 15 A which is close to half of the Ferm i wavelength of surface-states electrons on Cu (111) [17].

the LDOS exhibits a series of resonant peaks indicat-

If a magnetic adatom is placed at the focus of the corral, the resonance scattering of the surface-state electrons by the adatom and the corral walls leads to striking changes in the LDOS. As an example, we show in Fig2 our calculations for Co adatom. Strong changes in the LDOS near E_F in the empty focus are resolved (see Fig2a.). Comparing this LDOS with the one for

waves traveling towards the Cu atom s form ing the corral walland the backscattered ones leads to the con nem ent of the surface state electrons inside the corral [16]. The energy resolved local density of states (LDOS) at one of the corral's foci is presented in Fig.1a. It is seen that

em pty corral (Fig.1a), it is evidently that resonances act as waveguides for the projection of the electronic structure of the magnetic adatom to an empty focus [3]. The change in the LDOS (close to the E_F) at the empty focus clearly demonstrates the mirage e ect (Fig.2b). To the best of our know ledge, the above result is the rst fully ab initio con rm ation of the projection of electronic structure of the magnetic adatom to a remote location.




FIG.3: (color) Enhancement of the spin-polarization at the empty focus of the Cu corral. The magnetic Co adatom is placed at the right focus. a: The spin-polarization is determined as: (N - N #)/(N + N #), where N and N #) are the LDOS for majority and minority electrons respectively. The spin-polarization around the Co adatom on the open Cu (111) surface is shown by dashed line; b: N # and N " are determined by the di erence between LDOS at the energy E₁ between the corral with the Co adatom and the single Co adatom on the open Cu (111).

A nother very important consequence of the quantum con nem ent in the corral concerns the spin-polarization of the 2D electron gas. We place them agnetic Co adatom at the focus of the Cu corral and calculate the energyresolved spin-polarization at the empty focus. Results shown in Fig.3a reveals strong enhancement of the spinpolarization in the empty focus of the corral compared to that around Co adatom on an open Cu (111) surface. Our calculations clearly demonstrate that the spin-

polarization of surface-state electrons at the empty focus is very close to that near the magnetic adatom (Fig 2b). In other words, the spin-polarization is projected to the second focus by the quantum states of the corral. We emphasize that the corral walls are non-magnetic and therefore, the spin-polarization at the second focus is only caused by the spin-dependent scattering of the surfacestate electrons by the magnetic adatom. This result is the example of a possible 'magnetic information transfer' on metal surfaces. Recently, a theory of magnetic mirages based on the Anderson model has been proposed by Hallberg et al. [6]. Our ab initio studies are in line with this theory and unambiguously prove that tailoring the spin-polarization of 2D electron gas could be achieved in articial atom ic structures by exploiting the quantum con nement of surface-state electrons.

The above results suggest that there could be a significant impact of the quantum con nement in corrals on the interaction between magnetic adatom s.

To give a clear evidence that quantum corrals can be used for controlled m odi cation of magnetic interactions, we perform ab initio calculations for the exchange interaction between 3d adatoms inside the Cu corral. For large interatom ic separations the exchange interaction energies are very small (m eV and eV). Therefore, there is the problem of subtracting huge total energy values to obtain the resulting sm all interaction energies. How ever, it has been proved that applying the force theorem and using the single-particle energies, instead of total energies, one can resolve very sm all interaction energies at large atom ic distances with high accuracy [18].




FIG.4: (color) a: The exchange interaction between m agnetic adatom s inside the Cu corrals of di erent eccentricities; the distance between foci is xed, The exchange interaction on an open Cu (111) is presented by the black line.

We have calculated the exchange interaction between 3d adatoms in the Cu corral on Cu (111) for di erent adatom -adatom separations. In the absence of the corral, i.e. for an open surface, the exchange interaction between m agnetic adatoms is dom inated by the surfacestate electrons, and itsm agnitude decays as $1=d^2$ (d is the adatom -adatom separation) [19]. However, the quantum corral drastically in uences on the interaction between m agnetic adatoms. This is well seen in Fig.4 where our calculations for 3d adatom s placed in the corral foci are presented.

In order to dem onstrate the e ect of the corral geom etry on the exchange interaction, we show our calculations for the Cu corrals of di erent eccentricities. These striking results reveal that the exchange interaction in the corral is strongly enhanced compared to an open surface, and can switch from the ferrom agnetic coupling to the antiferrom agnetic one by modifying the corral geom etry. We believe that these calculations provide the clearest evidence of tailoring the magnetic interactions between adatoms at large distances by constructing appropriate corrals [20]. Note that recent results of Lazarovits et al., have also indicate that the geom etry of corralsm ay a ect their electronic and magnetic states [21].




FIG. 5: (color) The LDOS at the Ferm i energy on the Co adatom and the Co atom s of the corral walls are shown. The spin-polarization of surface-state electrons inside the Co corral is presented in color: N # and N " are determ ined by the di erence between LDOS near the Ferm i energy (+ 10 m eV) of the Co corral with the Co adatom, the empty Co corral and the single Co adatom on the open Cu (111). M irage in the empty focus is marked by the red arrow. The geom etrical parameters of the corral are the same as in the experimental setup of ref.3, i.e., sem i-axis a= 71.3 A, and eccentricity " = 0.5.

Finally, we apply our method for calculations of the spin-polarization in the Co corralused in the experim ental setup of M anoharan et al., [3]. A net spin-polarization of the electron gas in the Co corralwas suggested in this work as the possible reason for the quantum mirage in an empty focus. First, we have found the LDOS for the minority and majority electrons inside the Co corralwith the Co adatom placed in the corral focus. Calculations have been perform ed for energies close to the Ferm ienergy (E_F + 10m eV). Then, we have repeated the calculations for an empty Co corral. In fact, the di erence between the two calculations presents the e ect of the Co adatom on the spin-polarization of the electron gas inside the corral. However, the spin-polarization in the empty focus is found to be signi cantly smaller than the spin-polarization on the Co adatom . Therefore, to make a clear presentation of the magnetic mirage, i.e., enhanced spin-polarization at the empty focus, the spinpolarization of the single Co adatom on an open Cu (111) surface has been rem oved from the image shown in Fig.5. The oscillations of the spin-polarization are well seen in

Fig.5. The enhancement of the spin-polarization in an

empty focus is revealed.

In sum mary, we have presented the rst ab initio studies of quantum mirages and the magnetic interactions in quantum corrals. While we have used a particular system s, Cu and Co corrals on Cu (111) to illustrate several e ects of the quantum con nement of surface-state electrons, the main conclusions of our work are independent of the speci c system s. It is generally true that the spin-polarization of surface electrons caused by magnetic adatom s can be projected to a rem ote location by quantum states of corrals, and the exchange interaction between magnetic atom s can be manipulated at large distances. Our work opens up new possibilities for experim ental and theoretical studies of magnetic properties in engineered atom ic nanostructures.

- [13] The local spin density approximation (LSDA) and the generalized gradient approximation (GGA) give essentially the same results for corrals.
- [14] O ur calculations have proved that only a limited number of atom snear the corral wall and near the adatom splaced inside the corral contribute to $t_{\rm L}^{\rm L}$ (E) in eq.1. Therefore, even very large corrals can be calculated fully ab initio using our approach. We have found that self-consistent and non-self-consistent calculations give essentially the same results for the LDOS, the spin-polarization and the interaction energies, provided that the self-consistent potentials of single adatom s on Cu (111) are used in the non-self-consistent calculations. The e ect of bulk electronic states on the scattering of the surface electrons is taken into account in our approach.

- [20] We have found that changes of the eccentricity in uence on the position of the resonances in the LDOS close to the E $_{\rm F}\,$ in the corral. These resonances form the projection medium for the long-range interaction between spins

(see also ref.3), therefore m odifying their positions near the E $_{\rm F}\,$ one can tailor the exchange interaction between m agnetic adatom s.
