## Topological order and the decon nem ent transition in the (2+1) dim ensional com pact A belian H iggs m odel

W e study an Abelian compact gauge theory m inim ally coupled to bosonic matter with charge q, which may undergo a connement factor nement transition in (2+1)D. The transition is analyzed using a nonlocal order parameter W, which is related to large W ilson boops for fractional charges. W e map the model to a dual representation with no gauge eld but only a global q-state clock symmetry and show that W correspond to the domain wall energy of that model. W is also directly connected to the concept of topological order. W e exploit these facts in M onte C arlo simulations to study the detailed nature of the deconnect transition.

I. IN TRODUCTION

The appearance of excitations with fractional quantum numbers in strongly correlated systems has received much interest in recent years.<sup>1,2,3,4,5,6,7,8,9,10</sup> The splintering of the electron into a neutral spinon and a charged spinless holon, and the resulting spin-charge separation, was proposed early after the discovery of the superconducting high-T<sub>c</sub> cuprates as a route to explain the non-Ferm i liquid behavior observed in these systems. The fractionally charged Laughlin quasi-particles in the fractional quantum hall e ect is another fam ous example. W hile spin-charge separation is well established in one dim ensional electron gases, the occurrence in higher dim ensions remains poorly understood. U sually, the fractionalization in dimensions larger than one, is imagined to occur via a con nem ent-decon nem ent transition of an e ective low energy gauge theory description of the system .<sup>11,12</sup> A number of such gauge theories have been proposed for the underdoped cuprates, including U (1),<sup>1,2,3,4,5,6,7,8,13,14</sup> SU (2),<sup>9</sup> and Z<sub>2</sub><sup>10</sup>-gauge theories. In addition, the possibility of fractionalized phases in m odels containing only bosons has been proposed.<sup>15</sup> The fractionalized phases are not ordered in a conventional sense, which breaks any obvious symmetries of the system. Instead they are characterized by a special kind of order called topological order.<sup>16</sup> Topological order is robust against local perturbations and furtherm ore leads to a ground state degeneracy. It has been proposed that this topologically protected degeneracy could serve as a building block for qubits in a quantum com puter.<sup>17,18</sup> A n important prediction is that in nite sized systems the degeneracy is lifted due to tunneling processes, leading e <sup>L=</sup> .<sup>16</sup> to a splitting

In this paper we study the relation between topological order and decon nement in one of the sim plest models displaying topological order | the compact A belian H iggs model. It should be noted that a realistic theory of the high-T<sub>c</sub> cuprates would require also the inclusion of gapless nodal quasiparticles, which are here neglected.<sup>19,20,21,22,23</sup> W e thus consider a (2+1)D com -

pact U (1) gauge theory m in im ally coupled to a charge-q bosonic matter eld, with an Euclidean action

where r and  $A_r$  are compact phases 2 [0;2) living on the sites and links of a 3D simple cubic lattice, respectively.  $B_r =$  $r A_r$  is the dual eld strength, with the lattice di erence operators de ned by  $r f_r = \overline{r} f_{r+e} = f_{r+e}$  $f_r$ . The pure gauge theory in absence of matter is always con ning in (2+1)D, due to the proliferation of instantons.<sup>24</sup> (In (3+1)D a decon ned Coulomb phase is also possible.)<sup>24</sup> Partly because of this much attention has focused on Z2-gauge theories,  $^{10}$  which do allow a con nem ent-decon nem ent transition in (2+1)D. A Iternatively, when the U (1) model is coupled to a matter eld which does not belong to the fundamental representation (i.e., when the charge q of the boson diers from unity in Eq. (1)), a phase transition is possible.<sup>25</sup> This could happen, e.g., if the bosonic eld describes the pairing of spinons.<sup>5,26</sup> Indeed, the U (1) gauge theory coupled to a charge 2 boson is equivalent to a  $\mathbb{Z}_2$ -gauge theory in the limit  $J \ ! \ 1$  . In such a system, the fractionalized phase would then correspond to a phase where the spinon-pairs breaks up into separate free excitations. M ore generally, the model with gauge charge q reduces to a Z<sub>q</sub>-gauge theory in the lim it J! 1. In the opposite limit g! 0, the gauge eld uctuations freeze out and a 3D X Y model (with a global U (1) symmetry) results. One may ask how the transition interpolates between these two extremes with increasing screening length =  $1 = Jgq^2$ . The naive expectation would be that the ! 1 transition would represent an unstable xed point and that any nite value of would ow to zero upon renorm alization, giving a transition in the  $Z_{\alpha}$  universality class. In this case the 3D X Y point at

! 1 would be an isolated point in the phase diagram. Recently, large scale M onte C arlo simulations of the (2+1)D compact U (1) Higgs model were performed by Sudb et al.<sup>27</sup> and Sm iseth et al.<sup>28</sup> for several values of the charge q > 1. The results of these indicated that the phase diagram m ight be surprisingly complicated, with continuously varying critical exponents along the transition line between the  $Z_q$  and 3D X Y values. This would imply that the transition line for intermediate might be described by a line of xed points. These interesting results were obtained from a nite size scaling analysis of the third moment of the action, which is a purely therm odynam ic observable. A lthough their method seems to work very well, it would be desirable to have a clear order parameter which distinguishes the con ning and decon ning phases, especially in light of their surprising results.

In this paper we employ a nonlocal order parameter W , previously introduced in Ref29, which provides a direct probe of the conning properties of the theory. We show that this order parameter can be mapped via a duality transformation to the domain wall energy of a  $Z_q$  clock model, and present an indepth discussion of its relation to topological order, including many of the details left out in Ref29. We obtain the nite size scaling properties of W , discuss its relation to the splitting of the nearly degenerate ground states, and the energy gap to vortex excitations in the deconned phase. Finally, we use it in M onte C arbo simulations to study the detailed nature of the deconnement transition of the model, and compare with the earlier results mentioned above.

The paper is organized as follows. In Sec. IIA we reform ulate the theory in terms of its topological defects, which are vortices and instantons, and discusshow W can distinguish the di erent phases. Going over to another dual form ulation a model with a global q-state clock sym m etry (and no gauge elds) obtains, and W translates into the dom ain wall energy of that model, or equivalently the energy cost for twisting the boundary conditions by 2 =q, see Sec. IIB-IIC. In Sec. IID, we discuss the relation to topological order, adding details and generalizations of the ideas discussed in R ef 29. In Sec. III we describe M onte C arb simulations of the (2+1)D com pact H iggs model carried out in the bop-gas representation of ux lines and m onopoles. O ur results and conclusions are discussed in Sec. IV and V.

# II. DUALITY TRANSFORMATIONS, WILSON LOOPS AND TOPOLOGICAL ORDER

In order to transform Eq. (1) to alternative representations it is convenient to instead study the V illain version of the model, which allow the action to be transform ed to dual representations exactly, without further approxim ations, while retaining the important physics. In the V illain approximation the action is

where  $n_{\rm r}~$  and  $k_{\rm r}~$  are dum m y integers to be sum m ed over. The sum m ation over  $k_{\rm r}~$  has the e ect of m ak-

ing the energy cost of putting an integer multiple of q ux quanta  $_0 = 2$  =q through a plaquette of the lattice vanish. The net e ect of this is the proliferation of D irac strings, which leads to the appearance of m agnetic m onopoles of charge q  $_0 (= 2)$ .

A standard set of transform ations<sup>25,30</sup> allows Eq. (2) to be rewritten in terms of ux lines and monopoles, interacting via the action

Here m  $_{\rm r}$  2 Z<sup>3</sup> is the vorticity on the links and N  $_{\rm r}$  2 Z is the monopole charge,<sup>36</sup> and K = (2)<sup>2</sup>J. The ux lines are constrained to start or end on the monopoles only in quanta of q, i.e., r m<sub>r</sub> = qN  $_{\rm r}$ . The ux lines and monopoles interact through a screened coulomb interaction, de nedpby its Fourier transform  $V_k^{-1} = \frac{2}{k} + \frac{2}{r}$ , where  $2 = \frac{2}{k}$ , and  $k = 2 \sin(k = 2)$ , i.e.,

which for large distances is a screened coulom b interaction V (r) = e<sup>r=</sup> =4 r with a screening length given by <sup>2</sup> = K g=  $^2_0$  = Jgq<sup>2</sup>. In the lim it ! 0 the interaction reduces to an onsite interaction V<sub>r</sub> = <sup>2</sup> r, and the action becomes




FIG.1: (Color online) Possible phases of the system. To the left the topological ordered, decon ned phase, where vortices cost much energy. To the right the percolating vortex tangle in the con ned phase. The large W ilson loop W surrounds the shaded area as indicated in the gures.

The constraint r m = qN means that a + ()monopole has precisely q outgoing (incoming) ux lines. For q > 1 one may then envisage two distinct phases of the system . Either the monopoles mostly pair up in neutral pairs, where the q outgoing ux lines of the plus charge all end at the m inus charge of the pair, as illustrated in Fig. 1(a). This phase will be realized in the lim it of large K, where the ux lines cost a lot of energy. As discussed in the next section, this magnetically conning phase corresponds to decon ned fractional electric charges. The other possibility is that the outgoing ux lines mostly end on di erent monopoles, form ing a large connected tangle of ux lines and m onopoles, which percolate through the whole system, as in Fig. 1 (b). Recent simulations<sup>31</sup> support this interpretation. A transition between these two geom etrically di erent phases is expected at som e critical value of the coupling K  $_{\rm c}\,$  (or  $g_{\rm c})$  . This picture can be made more precise by studying the W ilson loop for fractional charges.

#### A. W ilson loops

The presence of percolating ux lines in the system can be detected by counting the number of ux lines crossing a given surface S that form a cross-section of the system,

see Fig. 1. We assume here periodic boundary conditions for the vorticity m in all directions, i.e., the system has the topology of a 3-torus. This corresponds to allowing twists in the boundary conditions for A in Eq. (1) or (2).<sup>29</sup> Let the winding number M be the number of such ux line crossings (counted with signs) for a cross-section perpendicular to the -direction, i.e.,

(For notational convenience we use a continuum form ulation here.) The precise location of the surface does not m atter. In the paired phase this number will be an integerm ultiple of q, whereas in the percolating phase it can be any integer. It turns out that precisely this property is captured by a large W ilson bop for fractionally charged test particles,

where the loop C encircles the surface S . The expression in the exponent,

equals 2 =qtimes the winding number M , and the W ilson bop for a bop with this special geometry is thus given by

This becomes one in the paired phase where M is an integer multiple of q Fig.1(a)]. In the percolating phase Fig. 1(b)] no particular value of the winding number M will be favored, making the W approach zero with increasing system size. Note that it is the global topological structure of the ux line tangle that determines the value of W, while sm all scale entanglement is unim – portant.

A W ilson loop decaying with an area law, W (C) exp( cL<sup>2</sup>) implies a linearly con ning attraction between static fractional charges, while a perimeter law, W (C) exp(cL), means that such charges would be decon ned. Note that the behavior of the charges is opposite of the monopoles: The charges are decon ned when the monopoles form pairs and con ned when the pairs break up. Remember that the charge of the bosons in the original model is q, so the W ilson loop for charge-q test particles would include a factor q in the exponent, making W equal to 1 exactly in both phases. For fractional charges, how ever, it changes from unity to an area  $\exp(cL^2)$ , when going through the transition law Wĩ (deep in the con ned phase one nds c = q=2). Another way to say this is that the charge-g dynam ic m atter cannot screen out the fractionally charged test particles.

The absence of a perimeter law for W in the deconned phase is a consequence of the special geometry of a loop which covers a whole cross-section of the system, and in some sense has no perimeter due to the periodic boundary conditions. This makes our order parameter W di erent from ordinary W ilson loops, and is a big advantage since it makes it easier to analyze its scaling behavior as discussed in Sec. IIC. For a nite sized bop in a much larger system the W ilson bop would follow a perimeter law rather than approach unity in the deconned phase. This is due to con gurations where part of the ux connecting a monopole-antim onopole pairwould pass through the bop and part outside the bop. In the paired phase this can happen only very close to the bop itself, hence giving rise to a perimeter law. In the next two sections we describe the relation of the W ilson bop order parameter W to the dom ain wall energy in a dual clock-symmetric model.

#### ${\tt B}$ . M apping to a m odel with clock sym m etry

W e w illnow m ap Eq. (3) to a dualm odelw ith a q-state clock symmetry. The idea is to start from the action

where the constraint r = qN is implemented via a Lagrange multiplier , and then integrate out the ux lines and m onopoles to get an elective action for . We decouple the vortex-vortex and m onopole-m onopole interactions with the help of two auxiliary elds, a and , to get

As announced this model has only a global q-state clock symmetry and contains no gauge elds and only short range interactions. Rewriting it in Fourier space gives

which clearly has a q-state clock symmetry. For small  $^2$  it is legitimate to replace the continuous variable  $_r$  by a discrete one  $_r$  2  $k_r = q$  leading to

which is just the familiar q-state clock model. Equation (16) is exact in the limit  $\phantom{0}$ ! 0, where the well known duality between Z $_{\rm q}$ -gauge theory and the q-state clock model is regained. Equation (13) remains valid for arbitrary .

Note that for fundamental matter, when q = 1, Eq. (13) essentially describes an XY model in a nite external magnetic eld, which does not have a phase transition; this agrees with Ref. 5.

#### C. Domain wallenergy

We now proceed to show that the domain wall energy in the q-state clock symmetric model, Eq. (13), corresponds precisely to the large W ilson loop W in the original compact gauge theory. Consider a nite sized system with side length L and periodic boundary conditions. A domain wall can be forced into the system by changing the boundary conditions such that (r + Le) = (r) + , = 2 k = q. The domain wallenergy is de ned as the free energy cost F for introducing such a twist. It is convenient to make a change of variables in the twisted system to get back to periodic boundary conditions by setting (r) = (r) +(r), where (r) = conobeys periodic boundary conditions, and stant except across a surface S occupying a cross section of the system perpendicular to the direction , where (r) jumps discontinuously by 2 k=q. We can then

evaluate the dom ain wall energy as

where the average h i is taken with respect to the unperturbed system, and S = S[+] S[]. Going back to the ux line representation Eq. (10) we have

where S is the surface at which is discontinuous and  $\hat{n}_r$  is the surface normal at lattice site r. Because  $_r$  is an integer multiple of 2 =q only the rst term on the right hand side contribute when exponentiated. The resulting form ula is more transparent when written in the continuum,

This is nothing but the large W ilson bop W for a test particle with fractional charge k. Thus the domain wall energy of the dualm odel is related to W by

In the (dual) ordered phase this will be proportional to the surface area,  $F = L^{d-1} = L^2$ , consistent with an area law for the W ilson loop W = exp(cL<sup>2</sup>). In the disordered phase, creating a dom ain wallcosts no energy and F = 0 with system size. Precisely at a critical point F = 0 with system size. Precisely at a critical point F = 0 with system we expect the nite size scaling relation

to hold, where =  $(K^{1} K_{c}^{1})=K_{c}^{1}$  is the tuning parameter of the transition and the correlation length exponent.




FIG.3: The large W ilson loop order parameter W as function of coupling constant, for dierent values of the screening length . Upper left: W vs  $g = \frac{2}{0}$  for = 0. Upper right, lower left, and lower right: W vs  $J^{-1}$  for = 0.5, 1, 2, respectively. The critical point is where the curves for dierent system sizes cross. Note that only system sizes much larger than scale well (solid lines), sm aller sizes (dashed lines) su ers from nite size corrections.

From simulation data the critical point can thus be located by plotting F (or equivalently W) vs the tuning parameter for di erent system sizes and observing the point where the di erent curves cross. W e will show examples of this below in Fig. 3.

#### D. Topological order

O ne characteristic feature of system s displaying topological order is a ground state degeneracy which depends on the topology of the space on which the model is dened. A further prediction is that for nite sized systems the exact degeneracy will be lifted due to tunneling events, leading to a ground state splitting exp (L=)<sup>16</sup> In Ref. 29 it was shown that there is a close relationship between the lifting of the ground state degeneracy and the largeW ilson loop W discussed above. Here we give more details on this relation and discuss the generalization to topologies other than the torus.

To simplify the discussion we consider state case q = 2 on a torus, with W in the space-time plane. In order to study ground state properties of the system we have to consider an isotropic system s with size L L

and take the lim it where the length of the tim e dimension goes to in nity. In the in nite system size lim it the degenerate ground states may be characterized by having an even or odd number of ux quanta  $_0$  through the holes of the torus, giving a degeneracy of  $2^2 = 4$  since a torus has two holes.<sup>32</sup> The general case of arbitrary q

on a manifold with genus g (i.e., which has g handles and 2g holes) naturally leads to  $q^{2g}$  degenerate ground states. For nite system size the degeneracy will be lifted by vortex tunneling processes, in which a vortex tunnels around a nontrivial path on the torus as illustrated in Fig. 2. In the decon ned phase such processes are exponentially suppressed and the system is topologically ordered. In the con nem ent phase, how ever, the vortices condense, and the tunneling is no longer negligible even in the therm odynam ic lim it. Let us concentrate on just one of the two holes of a torus for now. We will denote the quantum mechanical states with an even or odd number of ux quanta through the hole by jDi and jLi, respectively.

The space-time con gurations of vortex lines and monopoles that contribute to the partition function splits into di erent topological sectors, depending on whether the winding number M de ned in (6) is even or odd, i.e.,  $Z = Z_{even} + Z_{odd}$ . Our W ilson loop W (for q = 2) can be written in term s of these as

Q uantum mechanically the con gurations in the even sector contribute to the diagonalmatrix elements

The tunneling lifts the degeneracy and m ixes the di erent ux states. The H am iltonian restricted to the (alm ost) degenerate ground state H ilbert space is

which has energy eigenvalues  $E = E_0$  and eigenstates  $j i = (j)i \quad jli = 2$ . The ground state splitting can be related to W by the following equality, valid for ! 1:

as found in Ref29. In the decon ned phase W = 1 in the therm odynam ic lim it and we must have = 0 for !1, i.e., an exact degeneracy. For nite L the splitting can be evaluated directly deep in the decon nem ent phase, where the ux lines cost much energy and are very dilute. The dom inating con gurations which have to be taken into account then are those with n straight tunneling trajectories across the system with action S Ln. This gives

where is the line tension and there are L places to put the tunneling trajectory. In this lim it W will thus be given by W exp 2 Le <sup>L</sup> . Precisely such an exponential form of the ground state splitting has been argued for by W en.<sup>33</sup> Approaching the phase transition the ux line will no longer be straight and interaction e ects between di erent ux lines must be taken into account, making it much more di cult to estimate the ground state splitting. However, matching to the scaling form Eq.(21) for W suggests that W = exp 2 L = <sup>2</sup>e <sup>L=</sup> , so that

where j j is the correlation length. This should hold for L & on the decon ned side of the transition. Indeed, we will verify in the next sections that this form is in agreement with the data from numerical simulations. In the con nement phase an area law W e<sup>c L</sup> for the W ilson bop translates into a splitting L that grows with system size.

The arguments given above naturally generalize to manifolds of arbitrary genus g and charge q. There are 2g nontrivial bops around which vortex tunneling can take place. Each such tunneling event changes the ux through the corresponding hole by one ux quantum  $_{0}\cdot_{E}$  In the in nite system size limit the  $q^{2g}$  ux states  $f = f_{1}if_{2}i:::f_{2g}i$ , where  $f_{i} 2 Z_{q}$  is the number of ux quanta through hole i (m od q), are degenerate ground states. A way from the transition one may, to a very good approximation, neglect higher order tunneling processes and only consider those which tunnel single ux quanta. Denoting those tunneling matrix elements by  $T_i$  the energy levels become  $E_k = E_0 \qquad i T_i 2 \cos(2 k_i = q)$ , i.e., the contributions from individual tunneling processes are just added together.

#### E. Vortex gap

An important property of the ordered phase is that vortex excitations are gapped. This gap can be related to the large W ilson loop oriented norm al to the time direction W . Returning to the q = 2 case the vortex gap is

#### III. MONTE CARLO ALGORITHM

W e use M onte C arb sim ulations to obtain quantitative results for the m odel and the nonlocal order parameter W . The simulations are performed in the loop-gas representation, Eq. (3), of ux lines and m onopoles, and we focus on the cases q = 2 and q = 3. W e use simple cubic lattices with periodic boundary conditions for the vortices and m onopoles, corresponding to uctuating twist boundary conditions in the phase representation.<sup>29</sup>

In the simulation we must update both the ux lines and the monopoles. In order to calculate W it is necessary to include global moves that change the winding numbers M and thus the topology of the vortex conguration. In a conventional M etropolis algorithm the acceptance ratio for such moves become es exponentially small with increased lattice size. To overcome this we use a worm cluster M onte C arlo algorithm  $.^{34,35}$  T his algorithm is described for on-site interactions in R ef. 34, but is straightforward to adapt to longer range interactions.

To construct a worm one starts at a random lattice site  $s_1$  in space-time. A vortex segment is then created in direction to a new lattice site  $s_2$ . The direction is chosen with the probability

where S is the change in the action S for creating a vortex segment in direction . A new direction and lattice site are then chosen from  $s_2$ . These steps are repeated until the worm of vortex segments form a closed loop. To ensure detailed balance, the nal worm is accepted with the probability P = m in [1;N (now orm)=N (w orm)], where N = A at the initial site, before and after the creation of the loop. O c-casionally the loop constructed this way winds around the system , leading to the desired changes in the winding number M .

The model allows magnetic monopoles in addition to the ux lines. The monopoles are updated using a standard M etropolis scheme, with trial moves consisting of the insertion of a nearest neighbor pair of oppositely charged monopoles connected by q ux quanta on the link between them. These moves are then accepted with probability min(1;exp(S)). The creation of a plus monopole on top of a minus monopole (or vice versa) leads to their annihilation so that the procedure described includes creation, destruction, as well as motion of monopoles.

It is straightforward to show that the algorithm described above, combining both the worm updates of the ux lines and the M etropolis monopole moves, fulls both ergodicity and detailed balance, and respects the constraint r = qN. The W ilson loop order parameter W in direction is calculated in the simulations as hoos(2 M =q)i where M is the number of vortex lines crossing a plane, perpendicular to direction , of the system.




FIG.4: Phase diagram of the model with q = 2. Circles indicate the points which have been simulated. The parameters have been rescaled in order to t the phase diagram into the gure, so that J ! 1 occur at the upper side and g ! 0 at the right side. The phase diagram connects the 3D X Y point at g = 0 and the  $Z_2$  transition at strong coupling J ! 1. The decon ned phase is topologically ordered.

#### IV. RESULTS

For q = 2 we have made simulations for constant = 0;0:5;1:0;2:0, varying J (or g in the = 0 case) in each simulation. The results for W are shown in Fig. 3. Below the transition W goes to one with increasing system size. This is the decon nement phase. Above the transition, in the con nem ent phase, it goes to zero. Precisely at the transition W should be independent of system size according to the scaling form ula Eq. (21). The gures clearly show how W for system sizes much larger than cross at a given  $J_c$ . However, it is also apparent that for large values of there are strong corrections to scaling which in uence the smaller sizes. This is not surprising since the interaction Eq. (4) looks screened only at distances much larger than . It is important to have this in m ind during the nite size scaling analysis below. The phase diagram determ ined from the simulations is shown in Fig. 4.




FIG.5: A rea law and perim eter law demonstrated for ! 0, for a W ilson loop W (C) which covers a quarter of a cross section of the system and therefore has a nite perim eter and area. D ashed and solid lines are exact area and perim eter law s, inserted for com parison.

A s discussed W di ers from an ordinary W ilson bop in that it does not follow a perim eter law in the decon ned phase. In order to dem onstrate both area and perim eter law, we use a W ilson bop that covers one quarter of the system. This con guration is less suitable to locate  $J_c$ , but dem onstrates the area and perim eter laws nicely in Fig. 5.

We also simulate the model with q = 3 to show that W works also for larger values of q. The result for W is shown in Fig.7 for = 0. For q = 3 the model has a rst order transition when = 0,<sup>28</sup> and hence we expect no scaling of W. This is consistent with our M C data, since we nd no good crossing. Instead the transition becomes sharper with increasing system size and it is conceivable that a discontinuity develops in the therm odynam ic lim it.

W e now turn to the nite size scaling relation given in Eq.(21), and the correlation length exponent , for q = 2. W ith an appropriate choice of the data for di erent sizes should collapse onto a single scaling function. This is achieved by m inim izing




FIG.6: Finite size scaling plot of the W order parameter for = 0.5 (left) with = 0.64 and = 1 (right) with = 0.62.  $J_c^{-1}$  is determined from Fig.3 to 1.25 and 2.29, respectively. The inset shows thing error as a function of .

where  $x = (J^1 J_c^1)L^{1=}$  and W is the mean value of  $W_L$ . We calculate and  $J_c$  by making a multiparameter minimization of Eq. (37). Figure 6 shows two of the resulting data collapses. In doing this minimization it is important to make use only of system sizes large enough that corrections to scaling are negligible, hence we include only those sizes for which well de ned crossings were found above. We get = 0:633 0:007, 0:64 0:015, 0:62 0:03, 0:6 0:15, for = 0;0:5;1;2, respectively. W ithin error-bars the data for all values of that we have tested are consistent with the expected

0:63 of the 3D Ising model, which is the dual of the Z $_2$  gauge theory, i.e., the limiting case obtained for

! 0. This is in sharp contrast to the continuously varying exponents found by Sudb et al.<sup>27</sup> and Sm iseth et al.<sup>28</sup> Their results were obtained from studies of the third m om ent of the action and show ed substantial deviations from the 3D Ising value for & 0.5. The parameter values used in these papers overlap to large extent with the present ones, although there is a slight shift in the location of the phase diagram resulting from our use of the V illain m odel [Eq. (2), or equivalently (3)] instead of the cosine version Eq. (1). This is not expected to change the critical exponents, how ever.

Finally, we may also use W to calculate two quantities which are characteristic of topological order, namely the gap to vortex excitations  $E_v$ , and the splitting of the nearly degenerate ground states on a torus. Figure 8 shows  $E_v$  calculated using Eq. (34) as a function of =, where j j. The data nicely follows the scaling relation proposed in Eq. (35) in the decon ned phase, with 10.

The relation between W and in Eq. (27) allows the ground state splitting to be explicitly calculated using the M onte C arb data. An example of this is shown in F ig. 9, where the exponential dependence on system size obtained in Eq. (30) is clearly seen in the decon nem ent phase (solid line), while an area law (dashed line) is found in the con nem ent phase. For further examples and discussion of this aspect see R ef. 29.



In sum m ary, we have studied a com pact U (1) gauge theory coupled to bosonic matter with gauge charge qusing duality arguments and M onte C arlo simulations. The connement{deconnement transition is analyzed using a nonlocal order parameter W, which is related to large W ilson bops with the bop covering a whole cross section of the system, and which directly probes the conning properties of the theory. The model can be mapped to a dual model with a global q-state clock symmetry, and W corresponds to the domain wall energy of that model, which suggests a scaling behavior according to Eq. (21). W e conm this using M onte C arlo simulations and study the details of the deconnement transition over a range of parameters. Our results for the critical exponent support a transition in the 3D Ising universality class for




FIG.7:  $W vsg = \frac{2}{0}$  for a model with q = 3 and = 0. Note that this model has a rst order transition and no scaling behavior is expected.




FIG.8: The energy gap to vortex excitations as a function of tem perature in the decon ned phase, for q = 2 and = 0.




FIG.9: The scaling combination 2  $^{2}$ =L plotted against L= for q = 2, = 1. In the topologically ordered deconnement phase the data follows the exponential dependence given in Eq. (30), as indicated by the solid line. The dashed line indicates the area law obeyed in the connement phase.

all values of tested. In particular, we do not see any trace of continuously varying critical exponents found in Refs. 27,28 using a di erent order param eter. There are, however, strong crossover e ects in the vicinity of the 3D X Y transition at ! 1, which make an accurate determ ination of the exponents tricky in this lim it. The decon ned phase is topologically ordered with gapped <sup>1</sup>, which can be vortex excitations, with a gap  $E_v$ related to W for a spatial loop. The ground state degeneracy characteristic of topological order is lifted in nite sized system swith a gap 2 which is simply related to W for a space-time loop.<sup>29</sup> This establishes a m relationship between topological order and decon nement and allows explicit calculations of the ground state energy splitting in the topologically ordered phase of the theory. W e expect the m ethods developed here to be useful for quantitative studies of topological order in other system s aswell.

### APPENDIX A:GROUND STATE SPLITTING FOR GENERAL GAND q

In this appendix we give a detailed derivation of the relation between the ground state splitting and W´ form odels with gauge charge q on m anifolds with arbitrary genus g. The congurations contributing to the partition function can be split into separate topological sectors depending on the ux  $_{0}m_{i}$  passing through  $g_{i}$  space-time cross section surrounding hole i.
