Universality in Phase Transitions for Ultracold Ferm ionic Atoms

We describe the gas of ultracold ferm ionic atom s by a functional integral for atom and molecule elds. The crossover from Bose-E instein condensation (BEC) to BCS-type super uidity shows universal features in terms of a concentration parameter for the ratio between scattering length and average interatom ic distance. We discuss the relevance of the Yukawa coupling between atoms and molecules, establish an exact narrow resonance limit and show that renormalized quantities are independent of the Yukawa coupling for the broad resonance, BCS and BEC limits. Within our functional integral formalism we compute the atom scattering in vacuum and the molecular binding energy. This connects the universal concentration parameter to the magnetic eld of a given experiment. Beyond mean eld theory we include the uctuations of the molecule eld and the renormalization e ects for the atom -molecule coupling. We not excellent agreement with the observed fraction of bare molecules in ⁶Li and qualitative agreement with the condensate fraction in ⁶Li and ⁴⁰K. In addition to the phase diagram and condensate fraction we compute the correlation length for molecules, the in-medium scattering length for molecules and atoms and the sound velocity.

I. IN TRODUCTION

U ltracold fem ionic atom s are developing into exciting experimental laboratories for the understanding of complex many body quantum physics. Collective phenomena as the phase transition to low temperature superuidity can be investigated with controlled microscopic physics. Recent experimental progress [1, 2, 3, 4, 5] in the crossover region between a Bose-E instein condensate (BEC) [6, 7] of molecules and the condensation of correlated atom pairs similar to BCS-superconductivity [8, 9] reveals the universality of the condensation phenom enon, as anticipated theoretically [10, 11, 12, 13, 14, 15].

At rst sight the understanding of the crossover region in presence of a Feshbach resonance seems to depend on com plex atom ic and molecular physics and therefore on m any param eters. The crucial role of m olecular bound states involves the detailed know ledge of binding or resonance energies as well as atom ic scattering am plitudes in presence of a hom ogeneous magnetic eld B. In particular, one needs the e ective coupling between the bound state and the atom s, usually encoded in the matrix elem ent of the H am iltonian between \bound and open channels" in the space of two-atom states. The many body physics depends in addition on the tem perature and density of the therm odynam ic equilibrium state. Furtherm ore, the experim ental observations are in uenced by the geometry of the trap which is used for the con nement of the atom gas.

In this paper we underline the universal aspects of the equilibrium state of ultracold ferm ionic atoms. In the lim it of a hom ogeneous situation we argue that \m acro-

scopic" observables can be expressed in terms of only three dimensionless parameters:

(1) The \concentration" c describes the ratio between the in-medium scattering length and the average distance between two unbound atom sorm olecules. For sm allneqative c the m olecular resonance becom es unim portant the gas is approxim ated by ferm ionic atom swith a sm all pointlike interaction. The phase transition to super uidity is of the BCS type and we will call this region in param eter space (jcj 1, c < 0) the \BCS regime". In contrast, for sm all positive c the phase transition and the low tem perature physics is well described by a gas of bosonic molecules. This lim it will be denoted by \BEC regime" it shows the phenom enon of Bose-E instein condensation very similar to a gas of bosonic atoms. The perhaps most interesting region is the \crossover regim e" between the BCS and BEC regimes for large cor c^{1} j. 1. All three regim es are continuously connected as c¹ is varied from large negative to large positive values. For low enough tem perature T a transition to a super uid state with condensation of atom pairs orm olecules occurs for all c. The critical tem perature T_c for the phase transition to superuidity clearly shows (cf. g. 1) the universal character of the crossover.

(2) The details of the crossover physics depends on a dimensionless Yukawa or Feshbach coupling ${\rm \ensuremath{\check{}}}$ which describes the interaction between atom s and molecules. This coupling depends on the density ${\rm \ensuremath{\check{}}}$ / n $^{1=6}$. In the \narrow resonance regime" of small ${\rm \ensuremath{\check{}}}$ the precise value of the coupling is not important for the location of the phase transition. A universal \narrow resonance limit" ${\rm \ensuremath{I}}$ () exists for the \symmetric phase" for T T_c . For this limit we nd a nontrivial exact solution of the many body problem which is described by a suitably adapted mean eld theory. Small deviations from this universal limit lead for many (but not all) quantities to a controlled expansion for small ${\rm \ensuremath{I}}$. For the \broad resonance

regime" with large \tilde{h} the precise value of \tilde{h} does not a ect the observables that are connected to renorm alized elds and parameters. In fact, for large \tilde{h} strong renorm alization e ects lead to a new form of universality for large couplings as observed previously in relativistic system s with a strong boson-ferm ion \Yukawa coupling" [16]. Our general universality hypothesis ¹ states states that the \m acroscopic quantities" can be expressed in term s of only two couplings c and \tilde{h} .

(3) The third parameter is nally the temperature in units of the Ferm i energy, $\Upsilon = T = {}_{\rm F}$, ${}_{\rm F} = k_{\rm F}^2 = 2M$, $k_{\rm F} = (3\ ^2n)^{1=3}$ (with M the mass of the atom s). Using the parameters c, $\tilde{\rm N}$ and Υ we obtain results for dimensionless ratios and couplings for arbitrary densities n. For a given c and Υ the only implicit dependence on n arises via the weak dependence $\tilde{\rm N}$ / n $^{1=6}$ and drops out in the limits of lenhanced universality" for broad and narrow resonances and the BEC or BEC regimes.

N o further details of the \mbox{m} icrophysics" are needed for the m acroscopic quantities. In this sense the description becom es universal. In the language of quantum eld theory the parameters c and \mbox{h} describe relevant couplings for the long distance physics.

At this point we may emphasize that the universal aspects discussed here are not related to the \universal critical behavior" near a second order phase transition. For example, the divergence of the correlation length for T ! T_c is governed by a universal critical exponent – this has not yet been computed very accurately here. The discussion of universality in the present paper rather concentrates on the parameters which are of relevance and concerns \non-universal quantities" in the sense of critical phenomena.

O ur results are based on a system atic formulation of the interacting many body system in terms of a functional integral. A detailed derivation and discussion of this form alism, together with an extension to the inhom ogeneous situation of a trap, can be found in [18]. We carefully address the issue of renormalization or, more precisely, the relation between m icroscopic parameters" and m acroscopic observables". Expressed in terms of our renormalized parameters c, \tilde{N} and T' all bop integrals are ultraviolet convergent such that the actual value of the physicalm icroscopic cuto scale plays no role. A lso the mass of the atom s drops out.

As one of the important advantages of our functional integral form ulation we can compute both the \physics in the vacuum " and the atom gas at nonvanishing density and temperature in the same fram ework. The vacuum physics corresponds to appropriate low density limits and concerns properties of two-atom systems like the cross section and molecular binding energy. These quantities are directly accessible to experiment. Combining the experimental information about the two-atom system with knowledge of the density (k_F) we can relate the parameters c and \tilde{N} to measurable quantities. In particular, the concentration c is related to the magnetic eld, or, more precisely, to its \detuning" $B = B = B_0$ from the vacuum Feshbach resonance at B_0 .

The functional integral treats the ferm ionic uctuations of unbound atom s and the bosonic uctuations of the molecule or di-atom eld on equal footing. It is therefore an ideal starting point for the inclusion of the molecule uctuations. These uctuations are important for the quantitative understanding of the phase transition for a broad Feshbach resonance. For a large dim ensionless Yukawa coupling ñ the renormalization e ects are crucial. In fact, the importance of the molecule uctuations is directly related to the size of \tilde{h} – for \tilde{h} ! 0 a nontrivial exact \narrow resonance lim it" can be established where the molecule uctuations can be neglected and mean eld theory becom esvalid. The present experim ents in ⁶Li and ⁴⁰K probe, how ever, broad resonances with large h for which the inclusion of the bosonic uctuations cannot be neglected.

We present a rst computation of the correlation length for the molecule eld. It turns out to be larger than the average distance between two atoms for a rather broad range of temperature above T_c , indicating the importance of collective e ects. We also compute the ective scattering length for molecule-molecule scattering. Again, it turns out to be large in the crossover region. Furtherm ore, we compute the sound velocity in the super uid phase.

O ur functional integral approach perm its a uni ed view of many previously obtained results. In fact, various other methods have already revealed many aspects of the results of our investigation. Strinati et. al. propose a purely ferm ionic description of the crossover problem based on a physically motivated choice of diagram s in the fram e of the operator form alism [19, 20, 21, 22, 23]. A ssum ing that the chem ical potential satis es =T ! 1 in the BEC lim it, they can show by explicit calculation [22] the appearance of a \molecular" and a condensate particle density in the BEC lim it. A sim ilar approxim ation schem e is advocated in [24].

O ther approaches form ulate the problem m icroscopically in terms of a Yukawa theory for a coupled system of ferm ionic unbound atoms and bosonic m olecules [25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36]. In part, this ism otivated by a functional integral [26, 33, 34]. Approaches of this type are well suited for dealing with nonlocal interactions. Another route of achieving this task is followed in [37, 38]. A comparison of purely ferm ionic vs. bosonized approach has recently been perform ed [39]. W orking with them icroscopic param eters appropriate for 40 K, alm ost no di erence is found between the two ap-

proaches. This is consistent with our investigation, classifying 40 K in the broad resonance regime where the two approaches become indeed equivalent.

A system atic study relating on the two body level the param eters of the m icroscopic Y ukaw a theory to binding energies and two-atom cross sections in vacuum includes the UV-renorm alization [33, 34, 35, 36]. The investigations of Feshbach resonances (see [36] for K) reveals clear tendency that the Y ukaw a coupling extracted \naively" from scattering properties is much too large in order to account for the large condensate fraction $_{\rm C}$ advocated by observation, in particular for ⁶Liused by m any experimental groups [3, 4, 40, 41, 42]. This has triggered recent work on an elective Y ukaw a coupling and its m om entum and energy dependence [36, 43, 44].

The plan of the paper is as follows. In sect. II we brie y discuss the form al ingredients of our functional integral form alism. It is based on the elective action to be computed for our two-channelm odel of the crossover system . A more extensive description of these issues can be found in [18]. In sect. III we state our notion of universality more precisely. The aspects we consider differ from those analyzed by other authors, e.g. [17]. We state universality here in a general eld theoretical context, where for given external param eters n and T only two relevant renorm alized couplings describe the system, nam ely c and ñ . In sect. IV we brie y address enhanced universality in various lim its. These lim its are discussed in more detail in sect. V III when the necessary form al fram ew ork has been provided.

In sect. V we turn to the important di erence between bare (microscopic) and dressed molecules (or \macroscopic" diatom bound states). We compute the renormalization consant Z that relates the bare and dressed molecule elds. Sect. VI turns to the elective potential for the molecule eld. Here we state our approximation scheme beyond mean eld theory.

In sect. V II we compute the correlation length for the molecule uctuations. It diverges at the critical temperature and remains large for a rather wide range, typically as long as T is smaller than $1.5T_{\rm c}$. A large correlation length is a clear sign for collective e ects. We also compute the in-medium scattering length for molecules and the sound velocity in the superfuid phase.

In sects. IX, X we relate the universal couplings c, \hbar to the parameters of Feshbach resonances, in particular the detuning of the magnetic eld B B_0 and the response of the level splitting to variations of the magnetic eld, . Our functional integral form alism enables us to com – pute directly the observable quantities of the two-atom system, like the molecular binding energy $_{\rm M}$ or the scattering cross section between the unbound atom s. This is achieved in an appropriate lim it where both the tem perature T and the density n vanish as shown in sect. IX. Sect. X establishes a direct link between the universal concentration parameter c and the magnetic eld B and determ ines the Y ukawa coupling \hbar .

In sect. XI we turn to our results for the crossover

phase diagram for particular Feshbach resonances explored by recent experim ents. We rst address the fraction of bare molecules $_{\rm B}$ that has been measured by laser excitations to a higher level [5]. We nd excellent agreem ent with the observations in a range covering ve orders of magnitude for $_{\rm B}$ on both sides of the Feshbach resonance (cf. g. 3). The condensate fraction _c relates to dressed m olecules. Here we nd qualitative agreem ent with the experiments in 40 K [2] and 6 Li [3], whereas a quantitative com parison would need a more detailed relation between the experimental observable and $_{\rm C}$. In sect. XII we present our conclusions. Four appendices dealwith the renorm alization e ects for the Yukawa coupling (A), the detailed form of the gap equation (B), the dispersion relation for the molecules in vacuum (C) and the atom scattering in vacuum (D).

II. EFFECTIVE ACTION

The ultracold gas of ferm ionic atom s in the vicinity of a Feshbach resonance can be idealized by two stable atom ic states denoted by a two component spinor . (For the example of ⁶Li these states may be associated with the two lowest hyper ne states jli, j2i.) The molecular state responsible for the Feshbach resonance can be treated as a complex bosonic eld ^. In our approximation this boson is stable for negative binding energy and can decay into a pair of ferm ionic atom s for positive binding energy. O ur functional integral form alism is based on the euclidean m icroscopic action

This is a simple model for fermions with Yukawa coupling to a scalar eld ^ and a pointlike \background " interaction (or \four-ferm ion vertex") . The parameter plays the role of an e ective chem ical potential². The di erent prefactor for the coupling between and the atom s resp. molecules accounts for the fact that the molecules have atom number two. Similarly, their mass is twice the atom mass such that they have a nonrelativistic kinetic energy p^2 =4M . Further motivation and details of our functional integral approach can be found in [18]. Our units are ~ = c = k_B = 1.

The bare parameters , h and have to be xed by appropriate observable \renorm alized" parameters. The

quadratic term n involves the \bare" binding energy () which typically depends on the magnetic eld. The Yukawa coupling h accounts for the coupling between the single atom s and molecules, = , $_{12} = 1$. For h ! 0 the molecular states decouple, giving rise to a nontrivial exact \narrow resonance lim it", cf. sect. V IIIA.

For a therm odynam ic equilibrium situation the partition function is represented as a functional integral with weight factor e $^{\rm S}$, with S the Euclidean action

Here Z_B is defined as a functional of the source term j (x) and we will set j = 0 at the end of the computations.

O ur Yukawa type theory (1) is equivalent to a purely ferm ionic model. For this purpose we perform the G aussian functional integration over the ^ eld. Expressed only in terms of ferm ions our model contains now a four-ferm ion interaction with a momentum dependent coupling $(Q_1;Q_2;Q_3;Q_4)$. The interaction has the explicit form $(Q_4 = Q_1 + Q_2 - Q_3)$ [26]

In the pointlike lim it the momentum dependence can be neglected and eq. (3) is replaced by the \local interaction approximation"

Later we will argue that the pointlike lim it can be established by h ! 1 , $/h^2$ (with the UV renormalized version of , cf. [18] and sect. IIIA). This settles the connection between broad Feshbach resonances and the pointlike lim it, for which a purely ferm ionic description as discussed by Strinati et al. [19, 20, 21, 22, 23] is appropriate.

The action S_B (1) has a global U (1) symmetry. This is plies the conservation of the particle number N =

In the second line, we have expressed the disconnected correlation function h^{$^}$ iby the connected G reen's function h^{$^}$ i_c and the expectation value h^{$^}$ i. These terms</sup></sup></sup>

can be interpreted [18] as density contributions from open channel atoms ($n_F = h^y$ i) and closed channel atoms in uncondensed molecules ($n_M = h^{-1}i_c$) as well as a contribution from closed channel atoms in the condensate ($n_C = 2h^-$ ih^-i). We emphasize that eq. (5) is no \ad hoc" assumption -it directly follows from the microscopic form ulation of the functional integral.

For a hom ogeneous setting the condensate is constant, $h^(x)i = 0$. It can be related [18] to the expectation value of a composite diatom operator

This demonstrates directly that our form ulation in terms of a path integralm akes no di erence between a \conden-sate of molecules" and a \condensate of atom pairs" h^T i-they are simply related by a multiplicative constant. Hence, the universality of the condensation phenom enon itself - the fact that we do not need to specify a precise microscopic mechanism as e.g. the formation of C coper pairs - is particularly visible.

The eld equations which determ ine $_0$ and n can be computed from the elective action [;], which depends on and the expectation value = h^{i} . As usual, it obtains by a Legendre transform, eliminating the source j (x) in favor of (x),

For hom ogeneous ; , it is appropriate to consider the e ective potential U = (T = V). To one loop order it is composed of a classical piece and a uctuation contribution,

In our case, the classical contribution reads

The one loop contribution is composed of a piece from ferm ion $(U_1^{(F)})$ and boson $(U_1^{(B)})$ uctuations. The explicit expression for the one loop part depends on the detailed approximation. It will be discussed in sect. V I, while we will rst display some general features and results of our approach.

The hom ogeneous eld equations read [18]

The condensation of atom spairs or molecules is signalled by a non-vanishing expectation value $h^{i} = _{0}$, given by the location of the minimum of U. The associated spontaneous breaking of the global continuous sym metry of phase rotations of and $^{\circ}$ (related to the conservation of the number of atom s) induces a massless G oldstone boson. This is the origin of super uidity.

A. Additive Renorm alization

The m icroscopic action (1) depends explicitly on three parameters , h , . A fourth parameter is introduced in plicitly by the ultraviolet cuto for the momentum integration in the uctuation e ects. (Besides this, the results will depend on the therm odynamic variables T and $- \sec [18]$ for the relation between the e ective chemical potential and the chemical potential .) The renorm alization procedure eliminates the cuto dependence and trades these \bare" parameters for renorm alized ones which can subsequently be related to observables of the concrete atom ic system (cf. sect. X).

It turns out that it is su cient to perform the ultraviolet renorm alization in two instances: The rst one concerns the connected correlation functions (density contributions) h ^y i and h ^ i_c. Carefully relating these eld expectation values to their counterparts in the operator form alism shows that the divergences / ³ are due to a zero point shift of the density [18]. In our setting the contributions of the ferm ionic uctuations are cancelled by the bosonic (m olecule) uctuations and no renorm alization is necessary in this respect. The second divergence for ! 1 is associated to the bare detuning . It can be absorbed by using the renorm alized detuning

This prescription corresponds to a renorm alization of the e ective atom interaction strength (4) [18].

Expressed in terms of and h the elective potential becomes very insensitive to the m icroscopic physics, i.e. the value of the cuto .W it hout much loss of accuracy we can take the limit ! 1 for the computation of U.

B. D im ension less P aram eters

The action (1) still involves the atom mass M which is much larger than all other characteristic mass scales. By the choice of appropriate units the nonrelativistic physics becomes independent of M. We therefore introduce a \Ferm im om entum " $k_{\rm F}$ and a \Ferm i energy" $_{\rm F}$ = $k_{\rm F}^2$ =2M. The inverse of the Ferm i mom entum should be associated with the most important characteristic length scale in our problem. Roughly speaking, it corresponds to the average distance d between two unbound atom s or molecules. Nevertheless, the precise value of $k_{\rm F}$ is not relevant – it just sets the units and we could take a ducial value $k_{\rm F}$ = 1eV. For a hom ogenous situation it is convenient, however, to de ne $k_{\rm F}$ by the density,

This yields the scaling form of the action

A coordingly, all quantities derived from the partition function can be brought to a scaling form and can only depend on the dimensionless parameters (~ = ~ + $\hbar^2 = (4^{-2}k_{\rm F})$)

This scaling form shows a rst in portant aspect of universality. All computations can be performed at a ducial $k_{\rm F}$ = 1eV. Contact to a concrete physical situation is only made at the end by rescaling the results by using the value of $k_{\rm F}$ appropriate to the density of a given experiment. In our approximation for a hom ogeneous situation all dimensionless physical observables can be expressed in terms of the dimensionless variables ~, ${\rm \tilde{n}}$, ~ and T'! The scale is then introduced by n.

The parameters in the action (14) are microscopic param eters ~ ; h̃ ; ; ~ ; . Sim ilar to the renorm alization of ~ also the couplings \tilde{h} and ~ will be a ected by renorm alization e ects. For a comparison with experim ent we have to relate the \bare couplings" \tilde{h} ; , ^ to renorm alized couplings, as for example the coupling ñ :0 which appears in the molecular binding energy in vacuum of the scattering of two isolated atoms 3 . We will argue below that in terms of the macroscopic relevant param eters only two param eters rem ain which can be associated to the renorm alized couplings ~ and \Tilde{h} . The macroscopic value of ~ becomes computable as a partial xed point in terms of ~ and ${\tt \tilde{n}}$, at least su ciently close to the resonance and for su ciently large $\ensuremath{\tilde{\mathbf{h}}}$. Furtherm ore, for the broad resonance lim it of a pointlike interaction we may absorb ~ by a Fierz transform ation into a rede nition of \tilde{h}^2 such that (4) remains invariant, i.e. $h^2 ! h^2$ (witth j2 j). In sect. X we will relate \sim and \tilde{n} to the parameters of experiments with gases of ${}^{6}Li$ and ${}^{40}K$.

C. Concentration

The space of model parameters and them odynamic variables for the crossover problem is spanned by ~; \hbar^2 and T. How ever, it turns out that another set of parameters, c; \hbar^2 and T, describes the system more e ciently, revealing further aspects of universality more clearly. Using the relation between a four-fermion coupling and a scattering length a ,

we de ne an e ective in-medium resonant scattering length a or, in the scaling form,

W e will refer to c as \concentration". Indeed, with the inverse Ferm i momentum setting the scale for the average interparticle spacing d, the concentration c is a measure for the ratio between scattering length a and average distance, c / a=d. It is therefore of no suprise that in the case c¹ < 1, where the scattering length exceeds the typical interatom ic distance, m any-body effects play an essential role. Note that through this inmedium scattering length depends on the density. It will, in general, di er from the \reduced scattering length" $a_R = a(=0)$, which is de ned by

For broad Feshbach resonances the concentration is related to the full scattering length a (B) by c = a (B) $k_{\rm F}$ (cf. sect. X). Here the dependence of a (B) = $a_{\rm res}$ (B) + $a_{\rm bg}$ on the magnetic eld B involves both a resonant piece $a_{\rm res}$ (B) that diverges at the Feshbach resonance B ! B₀, and an approximately B – independent background scattering length $a_{\rm bg}$.

The impact of the choice of variables c^1 ; \hbar^2 ; Γ is twofold. First, it absorbs a good deal of the \hbar - dependence in the nal results. In the language of critical phenomena, the dimensionless temperature Γ and the inverse concentration c^1 are relevant parameters, whereas \hbar is marginal. A more system atic discussion of the role of \hbar will be given in the next section. Second, the choice of c or a relates our form ulation based on partial bosonization more closely to an interacting ferm ion system, where the elective scattering length a is obviously a crucial parameter.

For a small concentration jcj the gas is dilute in the sense that scattering can be treated as a perturbation. In this range mean eld theory is expected to work reasonably well. On the other hand, for large jcj the scattering length exceeds the average distance between two atoms and collective e ects play a crucial role.




FIG.1: Crossover phase diagram. The dependence of the critical temperature $T_c = T_c = F$ on the inverse concentration $c^{-1} = (ak_F)^{-1}$ is shown for the broad resonance lim it $\hbar + 1$ (solid and short-dashed line) and for the narrow resonance lim it $\hbar + 0$ (dashed-dotted line). We also indicate the standard BEC (dashed horizontal line) and BCS (dashed rising line) lim its which do not depend on the choice of the Y ukaw a coupling. For the broad resonance lim it we plot two di erent approximations.

In sum m ary we have now an elective low energy formulation where neither M nor enter anym ore. Everything is expressed in term sofk_F and three dimensionless parameters, namely c, T and ${\tt \tilde{h}}$.

IV. ENHANCED UNIVERSALITY

Enhanced universality occurs in situations where one of the two parameters c; \hbar becomes irrelevant (or xed). This concerns the limits of narrow and broad Feshbach resonances (\narrow resonance limit", \hbar ! 0 and \broad resonance limit", \hbar ! 1), the BCS and BEC regimes, c ! 0, and the scaling limit, c ! 1. For a given T the crossover for narrow and broad Feshbach resonances can be described by a single parameter c¹. Results for the BCS, BEC and scaling limit can only depend on \hbar and become parameter free for narrow or broad resonances.

We can qualitatively discuss the lim its ofenhanced universality taking the phase diagram in g. 1 as an example. The values of c¹ and ñ determ ine the phase diagram completely, i.e. the critical temperature depends only on these two parameters, $T_c = T_c (c^1; \tilde{n})$. We display the critical temperature T_c as a function of c¹ and compare the lim its ñ ! 0 (dashed) and ñ ! 1 (two approximations, solid and short dashed). (The underlying approximation schemes are discussed in sect. VI.) For intermediate values of \tilde{n} , a monotonic change between the two lim its is found, cf. also g. 2. Though the impact of the marginal parameter \tilde{n} is moderate, the precise value of \tilde{n} in uences the details of the crossover

and will be in portant for precision estimates for concrete physical systems, in particular when narrow erresonances than those presently investigated in $^{6}Lior^{40}K$ will be explored.

Fig. 1 clearly reveals an \hbar -independent approach to the limiting BCS and BEC regimes: for jc¹ j! 1, \hbar becomes an irrelevant parameter and the system can be described in terms of the concentration only. For com parison, we have also plotted the extrapolated standard BCS (dashed, rising line) and BEC (dashed, horizontal line) results.

The narrow resonance lim it corresponds to an exact solution of the many-body problem . It requires h ! 0 and additionally a vanishing four-ferm ion background interaction, but is free of further approxim ations. The broad resonance limit, instead, corresponds to a strongly interacting eld theory, whose approximate solution still involves quantitative uncertainties, in particular close to the critical tem perature (cf. sect. VI). This is re ected by the two critical lines obtained in di erent approxim ations in the broad resonance limit. The di erence between the solid line and the short dashed line gives an idea of the remaining uncertainty in the treatment of the molecule uctuations. For the solid line our result at the resonance $T_c = 0.292$ is in agreement with the theoretical value obtained in [45, 46] and compatible with the m easurements reported in [46] $T_c = 0.31$ 0.04. Including the molecule uctuations in the gap equation (short dashed line) yields $T_c(c^1 = 0) = 0.255$. The maximum of T_c (c¹) has a similar value for both approximations.

We nd a new form of crossover from the narrow to broad resonance lim it in dependence on the Yukawa or Feshbach coupling ñ. This is shown in g. 2, where we plot T_c (g. 2 (a)) as a function of \tilde{h} for $c^1 = 0$. (The curves for other values of large jej are sim ilar.) One clearly sees a sm ooth interpolation between the regimes. W ithin the broad resonance regime the precise value of \tilde{n} is not relevant for T_c or, m ore generally, for all quantities not involving explicitly the m icroscopic constituents (bare elds"). Renormalization e ects for ñ even as large as a factor of ten do not matter. In contrast, in the \crossover regin e" of interm ediate h 10 the physical results depend on the value of ñ . Now renorm alization e ects must be taken into account carefully for a reliable computation. Furthermore, we will learn in sect. V that observations related to \m icroscopic observables" like the fraction of closed channel atom s (or m icroscopic molecules) can depend strongly on h even in the broad resonance regime. We also show in g.2 (b) the gradient coe cient A for $T = T_{c}$, $c^{1} = 0$ - this quantity will be de ned in the next section.

M ore details on the di erent lim its of enhanced universality will be given in sect. V III after the discussion of the necessary form alism in the next sections.




FIG.2: Enhanced universality for large and small \hbar . For c 1 = 0 we plot the dependence on \hbar of (a) the dimensionless critical temperature T_c and (b) the gradient coe cient A for T = T_c (cf. sect. V). For small \hbar < 1, a stable universal narrow resonance limit is approached. For large \hbar we nd a very pronounced insensitivity of T_c and A to the precise value of \hbar – note that we plot on a logarithm ic scale. The \crossover" regime interpolates smoothly between the universal limits.

V. DRESSED AND BARE MOLECULES: THE WAVE FUNCTION RENORMALIZATION Z

For an understanding of the crossover problem, it is crucial to distinguish bare and dressed molecules [47, 48]. In our interpretation, the bare or \closed channel" molecules are associated to a true nonlocality in the microscopic interaction (3). Their overall role for the therm odynam ics should be subdom inant for broad resonances or alm ost pointlike microscopic interactions. The dressed molecules can instead be elective degrees of freedom, generated dynamically by uctuation elects. They correspond to a renormalized bosonic eld.

A. Derivative Expansion

For a hom ogeneous situations or weakly varying trap potentials a derivative expansion of the e ective action becomes appropriate (with ~= h^{^{2}i} = k_{_{\rm F}}^{^{3=2}} in presence of sources j)

The elective potential can be decomposed into a classical contribution $\mathfrak{a}^{(C1)}$, a contribution from the ferm ion uctuations $\mathfrak{a}_1^{(F)}$ and a contribution from the molecule uctuations $\mathfrak{a}_1^{(B)}$,

The -dependence of the di erent pieces is closely related to the di erent contributions to the total density of atom s [18]. Indeed, the pressure of the system obeys $p(T) = (U_0(;T) = U_0(;T) = U_0(=T=0))$, where $U_0()$ denotes the value of the elective potential at its minimum (with respect to). A therm odynam ic relation associates the particle density with the derivative of p with respect to the chemical potential.

B. Contributions to the atom density

The wave function renorm alization Z plays a crucial role for the precise understanding of the di erent contributions to the total atom density, from condensed or uncondensed atom s, molecules or unbound atom s, open channel and closed channel atom s. For example, the number density of uncondensed dressed molecules $n_{\rm M}$ can be computed from the propagator for the renorm alized eld . It is related to the ~ -derivative of $\alpha_1^{({\rm B}\)}$ [18] evaluated at xed (not xed c 1 !)




FIG.3: Fraction of closed channelm olecules $_{\rm B}$ = $_{\rm C}$ + $_{\rm M}$, compared to experimental values [5], for T = 0 and k_F = 0:493eV \triangleq 250nK. On the BEC side, we nd that our results are quite insensitive to the precise choice of k_F. The strongly interacting region c¹ < 1 is indicated by vertical lines, where the center line denotes the position of the resonance. For B > B₀ the solid and long dashed-dotted lines re ect the uncertainty from the \Fierz am biguity" discussed in app. D. For B < B₀ the dashed line om its the renorm alization e ects discussed in sect. X and app. A.

Now $_{M}$ counts the fraction of closed channel atom s (not in the condensate) as de ned by the m icroscopic m olecular Feshbach state. For large Z the num ber of dressed m olecules n_{M} can be substantial even if the num ber of m icroscopic m olecules n_{M} is negligibly sm all. O f course, in this case the dressed m olecules are dom inantly com – posed of open channel atom s and not of closed channel m olecules.

Similarly, the condensate fraction $_{\rm C}$ = $n_{\rm C}$ = n m easures the fraction of atom s in the condensate

C. Computation of ${\tt Z}$

The wave function renormalization Z can be com puted from the dependence of the molecule propagator on the (real) frequency [18]. We include in this paper only the contribution from ferm ion uctuations. In this section we employ the relation [18]

The lim it T ! 0; ! 0 is infrared divergent. This divergence is cured by a nonzero momentum q in the propagator: For T = = 0 the correction / $h^2 (q^2)^{1=2}$ diverges only for q^2 ! 0. In the vacuum the physics of the \dressed m olecules" has therefore to be handled with care. W e will see in sect. IX that the case ! 0 applies to a situation where the m olecules correspond to an unstable resonant state with positive binding energy. In contrast, stable m olecules correspond to a nonzero negative value of without infrared divergence in Z . Furtherm ore, for nonzero density a condensate occurs for T = 0 and Z is regularized by the nonvanishing value of r in eq. (29).

D. Renorm alized Yukawa coupling

We observe that for large h the wave function renormalization diverges Z / \tilde{h}^2 . We will not that the total fraction of dressed molecules $_{\rm B} = _{\rm M} + _{\rm C}$ is a quantity of the order one in the crossover region. We conclude that in the broad resonance lim it the total num ber of bare molecules $_{\rm B} = _{\rm M} + _{\rm C} = _{\rm B} = Z / \tilde{\rm h}^2$ becomes negligibly small. As argued in sect. IV the m icroscopic m olecules can be om itted for the therm odynam ics and the broad resonance lim it is well described by a pointlike interaction for the ferm ionic atom s. Nevertheless, the renorm alized bosonic eld remains a very useful concept. We will see that in the lim it \tilde{h} ! 1 the appropriately renormalized couplings remain nite and become therefore independent of the precise value of \tilde{h} . This holds, in particular, for the renorm alized Yukawa coupling ⁵

The fact that these quantities are electively \hbar -independent has a simple but important implication regarding the renormalization elects for \hbar itself: Even if the actual value of \hbar is changed by, say, an order of magnitude, this will not a lect these parameters. A ll quantities that can be expressed in terms of the renormalized couplings become very insensitive to the value of \hbar , as seen in g.2.

⁴ The appropriate choice of the Yukawa coupling ñ relating r and ~ is a subtle issue. E. Bosonic quasiparticles

We have computed the gradient coe cient A in [18]. In g. 2 (b) we have displayed the renorm alized gradient coe cient A at the resonance, c¹ = 0. It switches from 0.5 for small h to a value close to one for large h . On the other hand, deep in the BEC limit we nd A = 0.5 both for small and large h . Indeed, the BEC limit is well described by pointlike bosonic quasiparticles, even if the microscopicm olecules become irrelevant for h ! 1. The limit

turns out to be twice the number of dressed molecules (including the ones in the condensate) according to the standard Bogoliubov form ula. (Form ore details, we refer to [18]. A similar result has been obtained by Strinatiet al. in a purely ferm ionic setting [20, 22].) In the BEC limit all quantities that can be expressed in terms of the renorm alized couplings can equally well be described by a simple model involving only bosonic elective degrees of freedom. This holds both for the case where microscopic molecules dominate and for the case of a purely pointlike interaction for fermionic atom swithout microscopic molecules. In this case an elective bosonic theory boses memory of its microscopic origin.

F. Fraction of m icroscopic m olecules

O ur calculations relate the \m acroscopic observables" and the renorm alized param eters to the m icrophysical interactions. In view of the large universality for the experim entally tested broad resonances one m ay wonder if these calculations can be checked experim entally or if only universal relations will rem ain at the end. A rst possible check of the detailed relation between the m icrophysics and m acrophysics concerns the relation of the universal concentration param eter c with the detailed experim ental setting, in particular its dependence on the m agnetic eld B. This will be discussed in sect. X. A second access is provided by tests that directly observe \m icroscopic quantities" as, for exam ple, the fraction of m icroscopic m olecules.

Indeed, even for a broad Feshbach resonance the microscopicm olecules exist and one can measure their num - ber. The laser probe in the experiment by Partridge et al. [5] triggers resonant transitions from closed channel microscopic molecules to open channel atoms. It therefore directly couples to the total number of microscopic

molecules h^ ^i. The quantity Z in [5] can be idential with the fraction of bare molecules

W e have computed this quantity as a function of c^{1} and relate c¹ to the magnetic eld in sect. X. The result is shown in g. 3. The comparison with the experimental values is very good. Since $_{M}$ + $_{C}$ is of the order one the dom inant e ect actually checks our com putations of Z $\,$. O by iously, $_{\rm B}$ depends explicitly on the Yukawa coupling, $_{\rm B}$ / ${\rm \tilde{h}}^2$, in distinction to the universal quantities for a broad Feshbach resonance. For T = 0 and n = 0 the Yukawa coupling $\tilde{h}_{;0}$ can be extracted from properties of single atom s and m olecules (cf. sect. X) and one $\text{ nds for }^{6}\text{Lih}_{;0}^{(\text{Li})}$ = 610 (k $_{\rm F}$ = 1eV). However, even for T = 0 (as appropriate for the experim ent [5]) the renorm alization e ects induce an e ective dependence of \tilde{n} on c^1 as shown in app. A. Om itting these e ects gives substantial disagreem ent with the measured values, as shown by the dashed curve in g.3 for $B < B_0$. We consider g. 3 as an important quantitative check of our m ethod 6 that we will describe in m ore detail below .

VI. EFFECTIVE POTENTIAL

In our approximation all relevant information is contained in the various contributions to the elective potential $\mathfrak{a}^{(\operatorname{Cl})};\mathfrak{a}_1^{(\mathrm{F})};\mathfrak{a}_1^{(\mathrm{B})}$ and in A ;Z . These quantities depend on T;~;c¹ and ñ where ~ can be xed by the rst equation (10)

we see that for xed c the explicit dependence of $\alpha(\mathbf{r})$ on \tilde{h} enters only through the contribution from the molecule uctuations $\alpha_1^{(B)}$. The presence of a substantial $_{\rm M}$ on the BEC side reduces $_{\rm F;0}$ and therefore changes the value of ~. This e ect is already su cient to produce a crossover from the BCS to the BEC regime. We therefore need an estimate of $_{\rm M}$.

where SYM and SSB denote the symmetric and superuid (spontaneously symmetry-broken) phases. W ithout loss of generality we also choose $_0$ real such that $_1$ corresponds to the \radialm ode" and $_2$ to the \G oldstone m ode". In the approximation (21) this yields [18]




FIG.4: Temperature dependence of the bosonic mass term m² for c¹ = 0; ħ ! 1. The vanishing of the mass term m² is approached continuously (solid line). We also plot the separate contributions from \m ean eld" (classical plus fermions, dashed) and boson uctuations (dashed-dotted). For T > T_c the latter become unimportant away from the phase transition.

and we note the appearance of the M atsubara frequencies in the o diagonal entries. Here we use a form ulation that can be used in both the norm al (SYM) and the super uid (SSB) phase. We will specialize to these cases in the following subsections. The mass matrix

In the super uid phase ($_0 \notin 0$; $_0 \notin 0$) one infers m² = 0. Therefore the mass matrix (47) has a zero eigenvalue and $_2$ can be identieed with the massless Goldstone boson. The presence of a \massless mode" with in nite correlation length is the central ingredient for super uidity. For the symmetric phase the two eigenvalues of (m²)_{ab} are equal since $_0 = 0$.

In principle, the inverse propagator (46) involves a momentum dependent vertex (q). Including the molecule uctuations (q) vanishes for q = 0. As advocated in [18] we take this di culty into account by using in the density equation (43) only the fermionic contribution $! {}^{(F)} = (2^2 \alpha_1^{(F)} = (2^2 j_0)$. To reduce the error connected to this approximation one may either com – pute the momentum dependence of the four-boson ver-




FIG.5: M olecular correlation length $\widetilde{}_{\rm M}$ as a function of the reduced temperature (T $~T_{\rm c})=T_{\rm c}$. We consider three regimes: crossover (c 1 = 0, solid), BCS (c 1 = 1:5, dashed), BEC (c 1 = 1:5, dashed-dotted) and the broad resonance limit $\tilde{\rm h}$! 1.

tex or, perhaps more promising, use functional renorm alization group methods [52, 53, 54]. The approximation $= {}^{(F)}$ is, of course, consistent with our \intermediate approximation" where the eld equation for neglects the bosonic uctuation contributions.

A more consistent inclusion of the molecule uctuations also takes them into account in the eld equation for , modifying also the second equation (40). We need to evaluate the bosonic mass term

W hile $\mathfrak{a}_1^{(F)}$ is given by eq. (27) we still need to determ ine $(\mathfrak{a}_1^{(F)})=0$. For this purpose we compute the lowest order \gap" or Schwinger-D yson equation for the molecule propagator. In the context of a perturbation expansion the gap equation amounts to a self-consistent resum mation of a series of diagram sinvolving bosonic uctuations beyond the G aussian (one loop) level. The explicit form of the gap equations for the norm aland super uid phases as well as the phase boundary is displayed in app. B. D etails of their derivation and limitations of validity can be found in [18].

VII. CORRELATION LENGTH AND SCATTER ING LENGTH FOR MOLECULES

In the symmetric phase the static e ective molecule propagator reads (for zero M atsubara frequency)




FIG. 6: E ective potential in the crossover region, $T=0:33; {\rm I}$ 1 . The solid line expresses the quartic coupling in term s of the renorm alized m olecule scattering length obtained with $a_M \ k_F = = = (4 \)$. The short dashed line neglects the molecule uctuations and shows $a_M^{(F)} k_F = {}^{(F)} = (4 \)$. Large renorm alization e ects are observed in the crossover regine. In the BEC limit, the bosons are only weakly interacting. In addition, we plot the renorm alized m ass term for the molecule eld m 2 (dashed-dotted) and the renorm alized gradient coe cient A (long dashed).

We approximate here A as a constant. The Fourier transform of G decays for large distances r exponentially

(M ore precisely, $_{M}^{2}$ corresponds to the location of the pole of the propagator for negative q^{2} and therefore A should be evaluated at the location of the pole instead of $q^{2} = 0$ as approximated here.) At the critical temperature T_{c} the correlation length diverges since m = 0.

In the super uid phase the propagators for the radial and G oldstone m odes di er. The correlation length for the G oldstone uctuations $(_2)$ is in nite according to eq. (49). In the \radial direction" $(_1)$ the e ective mass term for the uctuations around them inim um reads $2 = _0$. It vanishes (at zero m om entum) since our approxim ation based on Schwinger-D yson equations [18] yields = 0 for the deep infrared value of the m olecule coupling. Hence we obtain in our approxim ation a diverging correlation length for the radialm ode. N evertheless, the

pole is actually not located at $q^2 = 0$ -using a momentum dependent (q^2) in m² or taking this e ect into account in the form of A (q^2) would be a better approximation. In this paper we will not discuss further the e ects that render the radial correlation length nite for T < T_c.

The dimensionless molecular correlation length in the symmetric phase

For the computation of A we refer to [18]. We plot the renorm alized boson mass, displayed in curly brackets in eq. (55), in g. 4. Additionally, we indicate the separate contributions from ferm ion (dashed) and boson uctuations (dashed-dotted). Boson uctuations are important close to the critical temperature.

The condition ${\textstyle\bigwedge_M}^2 = 0$ de nes the critical temperature where the molecule correlation length diverges. Fig. 5 displays ${\textstyle\bigwedge_M}$ in the BEC, crossover and BCS regime. We observe that the molecular correlation length remains larger than the average distance between atoms or molecules $k_F^{\ 1}$ even rather far away from the critical temperature. This feature is quite independent of the BEC, BCS and crossover regime. It indicates the importance of collective phenom ena.

For \tilde{M} 1 the correlation length exceeds by far the average distance between two atoms. We do not expect the loop expansion to remain accurate in this limit. This is the typical range for the universal critical behavior near a second order phase transition which is known to be poorly described by MFT or a loop expansion. A proper renormalization group framework is needed for \tilde{M} 1. In contrast, for \tilde{M} 1 the molecules are essentially uncorrelated.

Let us de ne an e ective molecule scattering length a_M for the dressed molecules in analogy to eq. (16) (with \classical" boson mass 2M for composite particles)

A second possible criterion for the validity of the loop expansion is the smallness of the molecular self interaction

. Typically, a one loop expression becomes questionable for $a_{M} \ k_{F} \qquad 1.$

We plot $a_M k_F$ and $a_M^{(F)} k_F$ in g. 6 as a function of c¹ and in g. 7 as a function of temperature. Both plots are for the broad resonance limit. While $a_M^{(F)} k_F$ grows large near T_c the \full" molecule scattering length $a_M k_F$ goes to zero. The reader should be warned, how ever, that for T ! T_c the momentum dependence of (q) becomes crucial - for T = T_c one has (q) / q^2 such that vanishes only for q = 0. At T_c the interaction between the dressed molecules cannot be approximated by a pointlike interaction.

Finally, we comment on the ratio of ferm ionic and molecular scattering length in the two-body limit. The




FIG.7: Scattering length form olecules $a_M k_F$ as a function of the reduced temperature (T T_c)= T_c in the crossover regime (c¹ = 0; ħ ! 1; T_c = 0;255). Boson uctuations renorm alize the bosonic scattering length down to zero in the vicinity of the critical temperature. This may be compared to the increase of the ferm ion uctuation induced part $a_M^{(F)} k_F$.

diagram m atic approach of [19] yields $a_M = a = 0.75$. In [55], the ratio was extracted from an analysis of the quantum m echanical four-body problem in the BEC lim it, establishing the result $a_M = a = 0.6$. This was reproduced in a Q uantum M onte C arb simulation in [51].

We discuss a procedure to project on the low density lim it in sect. IX. For the ferm ionic contribution to the molecular scattering length, this yields in the BEC regime

This is the Born approximation. In the low density limit, the one-loop expression for the bosonic uctuations reduces a_M but is plagued by infrared divergences similar to the ones encountered above in the super uid phase. A resolution of this issue is expected from the consideration for the momentum dependence of the couplings or from the use of functional renormalization group equations.

As a last application of our form alism we compute the speed of sound as extracted from the low energy dispersion relation $! = v_m$ jgj [18]. In the dimensionless form ulation $v_s = 2M v_s = k_F$ it takes the form

For the broad resonance $\lim it$ the result is plotted at T = 0 throughout the crossover in g.8.

VIII. LIM ITS OF ENHANCED UN IVERSALITY

In this section we discuss in more detail the status of the di erent lim its of enhanced universality presented in sect. IV .




FIG. 8: D in ensionless speed of sound $v_{\rm s}$ for the molecules at $\underline{T}=0$. In the extreme BEC regime it approaches $v_{\rm s}$! 2' $\overline{c=(3)}$. This limit (plotted dashed) is obtained by neglecting the contribution from the boson density in the equation of state.

A. Exact N arrow R esonance L im it

A nontrivial exact limit exists for which \hbar ! 0 and ~ ! 0 while c and T are kept xed. It applies to the symmetric phase including the location of the critical line. This exact limit remains valid for arbitrary concentration c, even if the scattering length a is arbitrarily large. A s we have discussed before, the molecules and fermionic atom s decouple in the limit \hbar ! 0 such that the G aussian (one loop) approximation becomes exact. N evertheless, our limit can describe the full BCS-BEC crossover as visible from g. 1. In practice, the applicability of this limit corresponds to a narrow resonance, much narrower than the ones currently investigated for lithium or potassium.

We learn from eq. (17) that our lim it corresponds to $2 / h^2 ! 0$. Due to the simultaneous vanishing of 2 and hour lim it is not the trivial lim it of a mixture of a noninteracting atom gas plus a noninteracting molecule gas. Nevertheless, we will see that in the narrow resonance lim it an appropriate mean eld theory becomes exact and can describe the high temperature phase including the approach to the critical temperature of the phase transition. (This mean eld theory di ers from standard BCS mean eld theory results, cf. g. 1.) The existence of this lim it guarantees that mean eld theory remains valid as long as h remains small, say h < 1. This is con rm ed in g. 2.

In order to establish the exact results for this limit we rst perform in eq. (2) the functional integral for the fermions . For = 0 this can be done exactly. The G aussian integralyields an interm ediate action S [^] depending only on ^, with

Let us discuss the properties of S $[\hat{}]$ in the lim it $\tilde{h} ! 0$. The e ective potential w in S corresponds to the mean eld potential and we note that w =r=(8 c(~)) + $\mathfrak{a}_1^{(F)}$ (r;~) depends on the gap parameter $\mathbf{r} = \tilde{h}^2 \stackrel{\sim}{\sim} \stackrel{\sim}{\sim}$ but not explicitly on ñ (For the explicit mean eld form ulae cf. sect. V, eq. (27), and app. B.) The loop correction to the inverse boson propagator P (Q) vanishes for \tilde{h} ! 0 due to the overall factor \tilde{h}^2 . In consequence, the inverse bosonic propagator for ^ is precisely given by the classical part P $^{(C1)} = 2 \text{ in T} + q^2 = 4M +$ 2. This is the inverse propagator for free bosons with mass 2M . All terms in S [^] with more than two powers of ^ also involve powers of h̃ and therefore vanish in our lim it. In consequence, the functional integral for ^ becom es G aussian in the lim it $\hbar = 0$ and we can solve the functional integral (59) exactly. In our lim it it should be evaluated for = =2. In this lim it the num ber density of m icroscopic molecules n_M therefore corresponds to the density of free nonrelativistic bosons of m ass 2M with vanishing chem ical potential (48), as given by the canonical partition function.

In the narrow resonance lim it the mean eld approxin ation for the e ective potential becomes exact. This yields exact estim ates for the critical tem perature and all quantities of the symmetric phase for T T_c . In contrast, the low tem perature phase has only a partially meaningfullim it for ñ ! 0. For nonzero r the bare condensate fraction $c = 6^{2} r = h^{2}$ (cf. sect. V I) diverges. The constraint _c 1 then implies that r has to vanish $/ h^2$. In summary, the limit h ! 0 corresponds to a universal phase diagram in the narrow resonance lim it, as given by the lowest curve in q. 1. For small h this universal curve is smoothly approached (q. 2). All corrections to the \narrow resonance universality" are proportional to the dimensionless quantity \hbar^2 . Obviously, for h ! 0 all exact results depend only on the param eters c and T, whereby every point in the (c;T)-plane may be realized by di erent combinations of a (or), n (or) and T.

At this point a comment on the interpretation of the narrow resonance limit is in order. The choice of the classical values for the coe cients in the boson propagator on the microscopic level corresponds to an intrinsically non-local situation. Their actual values are found by simple physical considerations, i.e. A = 1=4M as the gradient coe cient for bosons of mass 2M and chemical potential

2 for particle num ber two. How ever, for realistic narrow Feshbach resonances additional physical features, as a nonvanishing , may become important.

B. Broad Resonance lim it

The broad resonance $\lim it$ obtains for $\hbar ! 1$ while keeping c xed. We will see that it corresponds to a model for ferm ionic atoms with local interaction and without explicit m olecule degrees of freedom. For \tilde{N} ! 1 all quantities depend only on c and T. The broad resonance lim it therefore shows a particularly high degree of universality. For xed c and nite ~ the lim it \tilde{N} ! 1 is accompanied by ~ ! 1 according to eq. (17)

This relation is independent of ~. For nite ~ the inmedium scattering length a coincides with the reduced scattering length a_R (18). Going back to the original de nition of the action for the functional integral (2) the broad resonance limit corresponds to the double limit j j! 1, h ! 1. In this limit, the \classical" terms s $\tilde{r} \ \tilde{r} \ and \ \hat{e} \ become subdom inant and can be ne$ glected. In the fermionic language (3) our model therefore reduces to a purely local four-ferm ion interaction.Our partially bosonized description has to match thepurely ferm ionic description with a pointlike interactionterm. In otherwords, all physical results can only dependon the elective coupling (cf. 4)

Any individual dependence on h, or (at xed) can only be an artefact of an insu cient approximation and can therefore be used to test the validity of various approximation or truncation schemes.

As the scale set by h drops out in this limit, we can express the crossover in terms of a single parameter, the inverse dimensionless scattering length c¹. In the super uid phase we can use for the order parameter the squared dimensionless fermionic mass gap $r = \hbar^2 \sim \sim$. These are precisely the generic parameters used in a purely fermionic description. They characterize the system uniquely in the strict limit $\hbar + 1$, but also remain very e cient for $\hbar - 1$. Corrections will be 0 (\hbar^2) or less.

The system s currently investigated experimentally are ^{6}Li and ^{40}K . Both range in the broad resonance regime, as can be seen from g. 2 and discussed in sect. X. This clearly motivates the theoretical investigation of this regime.

In contrast to the narrow resonance limit (ñ ! 0, ! 0) the broad resonance limit cannot be solved exactly. It still corresponds to an interacting ferm ion m odel, as discussed in detail by Strinati et al. [19, 20, 21, 22, 23]. Nevertheless, it allows us to make a detailed m atching with a purely ferm ionic description and to compare all physical results directly by computing the concentration c in both approaches. Furtherm ore, the broad resonance limit can be used as a starting point for a system atic investigation of corrections beyond a local four-ferm ion interaction.

0 ur present calculations in the broad resonance limit still involve quantitative uncertainties related to our approximation scheme. This diers from the exactly solvable narrow resonance limit. On the other hand, due to the \loss ofmem ory" concerning the details of the microscopic interaction vertex (3), this limit has a higher degree of robustness as compared to the narrow resonance limit, where the details of the microscopic interactions must be known.

Finally, we would like to point out that a further \crossover problem ", i.e. the crossover from small to large K, emerges from the above discussion. We leave this exciting eld, physically describing the crossover from nonlocal to pointlike interactions, for future work. Our interpretation of the narrow and broad resonance limits is con med in the numerical study [37] com paring di erent types of interaction potentials.

C. BCS and BEC regimes

The BCS and BEC regimes correspond to the limits $c \mid 0$ and $c \mid 0_+$. In the limit of small jcj the marginal parameter \tilde{n} turns irrelevant. Formally, this can be seen form the microscopic four-ferm ion vertex (3): In these limits, the absolute value of j 2 jbecomes large compared to the momentum dependent terms. Indeed, the temperature and momentum dependent terms in the denominator of eq. (3) are typically of the order $F = k_F^2 = (2M)$ whereas j 2 j $F \tilde{n}^2 = jcj$. For $jcj \mid 0$ the interaction becomes therefore electively pointlike for any given nonzero value of \tilde{n}^2 . In consequence, the results can only depend on or c, but not on \tilde{n} separately.

Though an intuitively expected result, this kind of universality is interesting from a conceptual point of view. It is associated to a boss of memory concerning eld degrees of freedom : On the BCS side, the molecules could have been om itted, and the BCS picture of a weakly interacting Ferm i gas exhibiting the form ation of Cooper pairs becomes valid. On the BEC side, we end up with an elective theory for the \dressed" molecules. They behave exactly like weakly interacting pointlike fundamental bosons (more details will be presented in the next section), whereas atom degrees of freedom are completely negligible for the macroscopic features.

The reason for this behavior can be seen directly from the functional integral (2) and the m icroscopic action (1): Introducing the variables c^1 and $n = h^{(h)}$ in $h^{(h)}$ is $i = h^{(h)}$ r), which is an exhaustive set to describe these limits, we observe the following: For $c^1 ! 1$ (BCS limit), the classical contribution to Qr=Qr (38) acts as a large positive m ass term / c¹ for the bosons, and the correlation functions associated to " are heavily suppressed. On the other hand, for $c^1 + 1$ (BEC lim it), the solution of the crossover problem in plies for the e ective 1 , and chemicalpotential ~ ! constitutes a m ass term for the ferm ions, sim ilarly suppressing their propagation. Though the interaction between ferm ions and bosons remains strong through n T y , the overall role

of one of the two di erent degrees of freedom becomes unim portant in the two respective limits.

It is instructive to discuss the BEC lim it from a som ewhat dierent form alperspective. Let us consider the model de ned by S_B (14) and take the lim it ~ ! 1. The negative e ective chem ical potential acts as an inframed cuto 7, $\sim = k^2$, both for the ferm ion and boson propagator. We may now integrate out the ferm ions. In the limit k ! 1 the contribution from the ferm ion uctuations to the elective action $S[\hat{}]$ (similar to eq. (59) discussed for the narrow resonance lim it) vanishes. Thus S reduces to the action for free bosonic molecules, R._^ (@ S = 1 4~=2 + ~ $2\sim)^{\hat{}}$. This free theory is easily solved and exhibits the standard BEC for $T < T_c$.

M ore in detail, we observe for $\mathfrak{B}_1^{(F)}$ (27) that both and diverge for k ! 1 , resulting in

Both Z and A take their classical values for $k \ ! \ 1$.

In consequence, the lim it $\sim ! 1$ is exactly solved. Physically, this describes, how ever, only the very extrem e BEC lim it. Still, for large but nite \sim we recover an e ective bosonic theory that can be solved by by perturbative m ethods.

D. Scaling lim it

A further interesting form of universality was pointed out by Ho [17] in the lim it c¹ ! 0⁹. It is argued that if the scattering length drops out, then the density (or $k_{\rm F}$) remains the only relevant scale (besides T), and the therm odynamics of the system should be governed by simple scaling laws.

In this form the argument is not complete since it assumes in addition a strictly pointlike interaction. Deviations from the pointlike structure, as releated in the Feshbach coupling h , introduce new scales and therefore new dimensionless parameters as ${\tt \tilde{h}}$. This is clearly seen by the ${\tt \tilde{h}}$ dependence of the quantities ${\tt T}_c$ and A (e ective gradient coe cient for the dressed bosons) in g. 2, which indeed refers to the resonance c 1 = 0. For example, a given h corresponds to a particular density $k_F^{(cr)}$ for the crossover from a broad to a narrow resonance. (W e may de ne $k_F^{(cr)}$ by the condition ${\tt \tilde{h}}$ (h ; $k_F^{(cr)}$) = 10.) In this sense the scaling limit does not exhibit com plete universality since it depends on an additional parameter.

N evertheless, for a broad resonance the actual value of \tilde{h} is irrelevant for the dressed quantities (as long as we are in a range of k_F su ciently away from k $_F^{(\rm cr)}$). Thus Ho's argument becomes valid in the double limit 10 c 1 ! 0; \tilde{h} ! 1 : For dressed quantities all dimensionless numbers and ratios can be predicted completely independently of the microphysical details of the system !

O ur results for a broad Feshbach resonance extend this argum ent also away from the location of the resonance. U niversality holds not only for one particular value of B at the Feshbach resonance. For arbitrary B in the whole crossover region a single param eter c¹ describes all relevant m acroscopic properties of the dressed quantities. The concrete m icrophysics of a system is only needed to relate c to B, i.e. it is only re ected in one function c(B) which varies from one system to another.

IX. LOW DENSITY LIM ITS

So far we have developed a rather complete picture of the phase diagram for ultracold ferm ionic atoms in term s of the parameters c and \tilde{h} . In order to make contact with experiment we should relate these param eters to observable quantities. In particular, we will see how the concentration c is related to the magnetic eld. One of the great goals for ultracold atom gases is the realization of systems with well controlled m icroscopic param eters. This is a central advantage as com pared to solids or liquids for which usually the precise m icroscopic physics is only poorly known. In order to achieve this goal the \m icrophysical parameters" should be xed by the properties of the individual atom s and m olecules, e.g. by scattering in the vacuum or by the determ ination of binding energies. The m icroscopic param eters are then a matter of atom ic orm olecular physics and do not involve collective e ects of m any atom s or m olecules.

O ur functional integral approach relates the microscopic parameters to \mbox{m} acroscopic observables". It can be used for arbitrary values of the density and temper-

ature. In particular, it can be employed for the computation of properties of excitations in the vacuum at zero density and temperature. Within one formalism we can therefore not only compute the properties of many-body systems, but also the scattering behavior of individual atoms orm olecules in the vacuum. This enables us to relate ourm icroscopic parameters (appearing in the action) to observables in atom ic orm olecular physics. What is needed for this purpose is a computation of binding energies and scattering cross sections in the lim it T ! 0, n ! 0. This will be done in the present and next section.

We are interested in the lim it where the density goes to zero while T = T = F is kept xed at some value $T > T_c$. Of course, then also T goes to zero, but we do not have to bother with condensation phenomena or critical phenomena (for T su ciently larger than T_c). In the lim it n ! 0; k_F ! 0 also the concentration c vanishes. A ctually, we have to consider two lim its jcj ! 0 separately, one for positive and the other for negative c. For positive c the low density lim it corresponds to a gas of molecules, while for negative c one obtains a gas of non-interacting ferm ionic atom s. If the scattering length ism uch sm aller than the average distance between two atom s or molecules, the properties of the dilute gas are directly related to the physics of individual atom s or molecules.

A. Atom and molecule phase

The \fermion gas lim it" or \atom phase" (negative c) is realized for positive or negative scattering length a_R . In this case the molecular binding energy is positive such that the excitation of \molecule resonances" requires energy. Since for xed T and k_F ! 0 the tem – perature becomes very low, $T = T_F$, the excited states become strongly suppressed and can be neglected. In this lim it one nds ~ ! 1 and therefore ! $_F$! 0 and a ! a_R . At xed and h the concentration vanishes $c = a_R \, k_F$! 0. Therefore the interaction e ects are small. In particular, T_c vanishes in the lim it c ! 0, cf. g. 1. Finally, the wave function renorm alization Z diverges / $h^2 = q^2$ for a vanishing momentum q^2 ! 0 in the propagator.

For a negative molecular binding energy or <0 the low density and low temperature state becomes a molecule gas. Now the number density of the ferm ionic atoms is suppressed since for zero momentum their energy is higher as compared to the molecules. We will show that this \molecule phase" is characterized by a nonzero negative value of $\$.

Here $\frac{(U_1)^{(F)}}{(P)}$ (= 0) and $\frac{(U_1)^{(B)}}{(P)}$ (= 0) have to be evaluated for = A. We arrive at the important conclusion that for < 0 the vacuum or zero density limit does not correspond to a vanishing elective chemical potential but rather to negative A < 0.

W e will see below that ($@U_1=@$)(= 0) does not vanish for $_A < 0$, n ! 0, T ! 0. Therefore away from the resonance a($_A$) remains nite for k_F ! 0 and the concentration parameter c vanishes in the low density limit. This is consistent with a noninteracting gas of molecules. It is not surprising that one encounters the B ose-E instein condensation of free bosons as the tem perature is low ered below T_c .

In the molecule phase the nonzero $_{\rm A} < 0$ adapts the additive constant in the energy such that the molecular energy level is a zero. In consequence, $_{\rm A}$ appears as a positive energy (gap or mass term) in the propagator of the ferm ionic atom s. As it should be this suppresses the relative number of ferm ionic atom s in the limit T ! 0 and we end with a dilute gas of molecules. The two low density limits (with $\stackrel{6}{\leftarrow}$ 0) therefore both correspond to the limit of vanishing concentration jcj ! 0. Positive and negative c correspond to pure gases of molecules or ferm ionic atom s, respectively.

B. Binding energy

In the molecule phase $_{\rm A}$ has a simple interpretation in terms of the molecular binding energy in vacuum , $_{\rm M}$,

In the low density limit the interactions become negligible and $n_{\rm F;0}$ should reduce to the density of the free gas of atom s with mass M . However, even for zero momentum the energy of a single atom does not vanish - it is rather given by half the binding energy that is necessary for the dissociation of a molecule. This corresponds precisely to eq. (71), provided we identify $_{\rm M}$ = 2 $_{\rm A}$. We conclude that the binding energy is not simply given by (which is de ned for = 0 and in the absence of molecule uctuations) but rather obeys

W e recover the well known universal result for the scattering length a ($_{\rm A}$) [33, 34] provided a can be identi ed with the physical scattering length a. (75) becomes subdom inant, in plying a quadratic behavior $_{\rm M}$ / ². In contrast, far away from threshold the binding energy equals the mean eld binding energy, $_{\rm M}$ = . For broad resonances, the linear regime will only be approached far away from the resonance when $\frac{1}{2}$ (2M)³⁼²h²=(16).

to address in more detail the question of continuity as the magnetic eld switches between the two situations. In fact, we may view this qualitative change as a \phase transition" in vacuum as a function of B. The corresponding \order parameter" is the value of at T = 0. For $B > B_0$ the \atom phase" is characterized by = 0 and the mass term $m^2 = QU = Q$ (= 0; = 0) is positive, corresponding to M > 0. The \m olecule phase" for $B < B_0$ shows a nonvanishing order parameter = A. Now the mass term vanishes, $m^2 = 0$, whereas the atom s experience a type of gap j_A j_A The binding energy is negative, M < 0. We nd a continuous (\second order") transition where A approaches zero as B approaches B_0 . In this case one has $M(B_0) = 0$ and $m^2(B_0) = 0$ for B approaching B_0 either from above or below. (As a logical alternative, a discontinuous st order transition would correspond to a discontinuous jump of $A = B_0$. Then also M may jump and not be equal to zero at B₀.) As common for second order phase transitions we nd a non-analytic behavior at the transition point $B = B_0$.

X. PARAMETERSASA FUNCTION OF MAGNETIC FIELD

So farwe have described the universal crossover physics in terms of two parameters c and \hbar . For comparison with experiment these parameters have to be related to to the microphysical properties of a given atom ic system and to the external magnetic eld B. More precisely, the three parameters in the microscopic action (1), ; h; and ; have to be known as functions of B and the e ective UV cuto . The dependence on can be elim – inated by trading and h; for appropriately renormalized quantities (B) and h; o connected to the atom ic physics of individual atom s, i.e. evaluated for vanishing density and tem perature. Furtherm ore, can be replaced by the reduced scattering length

The question arises how the background scattering is properly incorporated. In principle, not only the exchange of the dressed molecules contributes to the scattering, but also a residual atom interaction in vacuum which is parameterized by the elective coupling $_{i0}$. In the broad resonance limit our results are consistent with a minor role of $_{i0}$ in the molecule phase and we will neglect it.

Indeed, we will see below how the background scattering is incorporated into a ($_{\rm A}$) for the molecule phase, such that we can associate a ($_{\rm A}$) with the observed scattering length, including the background term

This relation is quite satisfactory. Indeed, in the broad resonance lim it the interaction is essentially pointlike, both for aby and ares. Physical results can therefore only depend on $a = a_{res} + a_{bq}$. This holds independently of the precise value of ; . Indeed, by a Fierz transform ation we can shift the interaction from ; to the contribution from molecule exchange $h^2 =$ and vice versa [18]. Since for pointlike interactions the Fierz transform ations are exact identities the physical results should only depend on the sum h^2 ; =(2_A) ; and not on the value of an individual piece like ; . In terms of the renorm alized quantities the results can then only depend on a and not on a_{res} and a_{bq} separately. This feature is precisely realized by the relation (94): all results depend only on the concentration c, and this is in turn is given by the total scattering length a, independent of a decomposition into a_{res} and a_{bq} .

Based in the above argument we will use the simple relation (94) also for $B > B_0$. Within our approximations this implies that we associate $a_R = a_{res} + a_{bg}$ for $B > B_0$ which amounts to B - dependent $h^2_{\ ;0}(B)$. In fact, our approximation does not resolve the Fierz ambiguity for $B > B_0$. In app. D we discuss in detail the scattering of atom s in vacuum. There we comment on the issue of the Fierz am biguity m ore extensively.

In summary, the dependence of c $^{1}\,$ on B $\,$ obeys the nonlinear relation

For ⁶Li this produces the strong increase of the bare molecule fraction on the low eld side of the resonance as seen in g. 3. We note that for negative a_{bg} (as for ⁶Li) the scattering length reaches zero at some value of B in the BEC regime, B B₀ = $= a_{bg}^{1}$ (M) $^{1=2}$. At this point c vanishes. For B below B₀ the system belongs to the weakly coupled BCS regime. The transition between the BCS and BEC regimes in the weak coupling limit can therefore be realized by experiment. For ⁶Li one nds = 300G, for ⁴⁰K one has = 7:8G.

B. Yukawa coupling

The discussion of the relevant range for our second param eter, the dimensionless Yukawa coupling \hbar , is more

A way from the resonance, however, we have to take into account two renorm alization e ects which appear in the order $a_{bg}=a_{res}$. First, the ratio $(h_{;0}^{(m)}=h_{;0})^2$ yields a B dependent factor $(1 \quad a_{bg}=a)^2$ (with a a(A)). Second, the \renorm alization of the detuning" by the shift ! 2_A induces an additional B - dependence by a factor = (2_A) = a_{res} =a. Eq. (101) yields

and we conclude that a is indeed given by a_{res} (B) + a_{bg} . We observe that a_{bg} is related here to the microscopic \background atom interaction" via the renorm alization of $h_{;0}$ discussed in the appendix A. Thus eq. (102) gives a microphysical explanation for the nonlinear B – dependence of a.

This issue is di erent for the atom phase where the B -dependent renorm alization e ects for h ;0 and are absent. In this case a = a_R (B) only re ects the resonant contribution to the scattering if we keep h^2 ;0 independent of B. The background contribution has then to be accounted for by the direct coupling ;0. A lternatively, we may absorb ; into the molecule exchange contribution by a Fierz transform ation, including an e ective B -dependence of h^2 ;0 for B > B₀. Then a_R has to re ect the full dependence on B, including the background scattering. If ;0 can be neglected this requires $a_R = a$ (B) and leads to the relation (94).

The determ ination of $_{\rm M}$ = 2 $_{\rm A}$ amounts to the condition

The bosonic uctuation contribution vanishes for T ! 0 and $({\rm U_1}^{(\rm F)}){=}0$ r only depends on , but not on h or . This is the reason why the behavior for B ! B_0 can be used to determ ine c and the ratio (96), but not ħ separately. In principle, independent experimental information on ħ ;0 can be gained from measurements of the binding energy outside the resonance. Indeed, for $_{\rm M}$ < 0 the general relation between $_{\rm M}$ and reads

M easurement of $_{\rm M}$ (B) over a wide enough range allows for the extraction of both ${\rm h}^2{}_{;0}$ and independently. Far away from the resonance one has j = j 1 such that $_{\rm M}$ = . From this range we extract the B -dependence of , ${\rm e}_{\rm M}$ = ${\rm e}{\rm B}$ = ${\rm e}$ = ${\rm e}{\rm B}$ = . On the other hand, close to the resonance the opposite limit j = j 1 applies. Then $_{\rm M}$ = 2 =(2) involves the concentration c, and, using = (B B₀), one can extract h ;₀ from = 2 =(2 M). A lternatively, one may extract (B) and h ;₀ (B) from a detailed investigation of the atom scattering near the resonance, as discussed in app. D.

C. General relation between c^1 and B

In subsect. A we have related the mean eld scattering length a_R in vacuum with the detuning magnetic eld B B_0 . This can be used directly for establishing the relation between the concentration c and B B_0 for nonzero T and n, using the de nition (17)

We observe that the dimensionless Yukawa coupling \tilde{h} appears in eq. (106). It is related to $h_{;0}$ by eq. (A 6) in app. A. For practical calculations we use the relation (108) between ~ and B B_0 .

In the broad resonance lim it for large values of \tilde{h}^2 of the same order of magnitude as the vacuum values (98) the term s \tilde{h}^2 in eq. (106) can be neglected if j-j is not too large. This yields the simple expression

W e recall, how ever, that this form ula should not be used far in the BEC regim e where ~ takes large negative values which diverge in the vacuum lim it. Form oderate or sm all values of \hbar the term / ~ in eq. (106) should always be included.

XI. DRESSED AND BARE MOLECULES: COMPARISON TO EXPERIMENTS

A. Bare molecules

The fraction of closed channel molecules is given by $_{B} = _{M} + _{C}$. It has been measured by a laser probe that induces a transition to an excited molecular level - the quantity Z in [5] equals $_{B}$. Indeed, the laser probe couples directly to the total number of \bare molecules" h^ ^i f_{B}. Importantly, we have seen in sect. V and VI that this quantity involves the Yukawa ñ coupling explicitly, cf. eq. (39). In g. 3 we com pare our results with the measured value for Li, using




FIG.9: Contributions $_{\rm C}$; $_{\rm M}$ to the fraction of closed channel molecules $_{\rm B}$ = $_{\rm C}$ + $_{\rm M}$. We plot the result for 6 Li (fi $_{;0}$ = 610) for T = 0. The condensed part dom inates $_{\rm B}$ in the BEC regime, while in the vicinity of the resonance, the contributions are comparable. The dashed line for $_{\rm C}$ om its for c 1 > 0 the background contribution to a and re ects the F ierz am biguity.

T = 0, $k_{\rm F}$ = 0:493eV \doteq 250nK. The solid line uses c = $k_{\rm F}$ ($a_{\rm res}$ (B) + $a_{\rm bg}$) (93) for the whole range of B. The agreement with the measured value is very convincing. In order to give and idea of the Fierz am biguity for B > B_0 we also display by the long-dashed line the result of the choice c = $k_{\rm F}$ $a_{\rm res}$ (B). For B < B_0 the Fierz am biguity is removed by the renormalization e ects as discussed in sect. X B. W e emphasize that the inclusion of the renormalization (A12) for the Yukawa coupling is crucial. Om itting this e ect (dashed line) for B < B_0 in g. 3 results in a clear discrepancy from the observations su ciently far away from the resonance.

At this place we may give a few more details of our computation of $_{\rm B}$,

We use the Yukawa coupling as de ned in (A 6) in the place where it appears explicitly. All other quantities are taken from the solution of the equations determ ining the crossover problem in the super uid phase, eqs. (B 9,B 11). The form ulae for $_{\rm C}$,

relates the closed channel condensate fraction to the super uid order parameter $_0$. In that sense Partrigde et al. indirectly measure the super uid order parameter! From $_{\rm C}$ we can infer $_{\rm B}$ = $_{\rm C}$ (1 + $_{\rm M}$ = $_{\rm C}$) by extracting the ratio $_{\rm M}$ = $_{\rm C}$ from g. 9. In the BEC limit $_{\rm M}$ = $_{\rm C}$ become snegligible, while at resonance (c 1 = 0) we nd $_{\rm M}$ = $_{\rm C}$ = 1:89.

Let us brie y comment on the density dependence of our result. This is particularly simple in our dimensionless formulation. Since r_0 is taken from the solution of the crossover problem it does not depend on k_F if c is kept xed. However, in order to nd the right dimensionless value $\tilde{h} = 2M h = k_F^{1=2}$, k_F must be inserted. For xed c this yields $_C / k_F$. The ratio $_M = _C$ depends also on c. The dependence of $_B$ on c introduces an additional density dependence of $_B$ if the scattering length a is kept xed. (Only for xed ak_F one always has $_B / k_F$ in the broad resonance lim it.)

In the scaling lim it c¹ = 0 the value r_0 and the ratio $_M = _C$ are independent of k_F if we assume the broad resonance lim it \tilde{h} ! 1 . In this lim it we thus can conm the simple scaling law at resonance advocated by Ho [17], $_B / k_F$. A sim ilar result has been obtained by Levin et al. [48], though neglecting the contribution $_M$ which is of the same order of m agnitude at the resonance, cf. g. 9.

In the BEC lim it $_{M} = _{C}$ becomes negligible. Furthermore, since $r_0 / c^1 / k_F^{-1}$, one nds that $_{B}$ becomes independent of k_F . Note that this result is only valid for k_F which respect the BEC regime condition, $c^1 = (ak_F)^{-1} > 1 \text{ or } k_F < a^{-1}$.

In the deep BCS regime $c^1 = jak_F j^1$ 1, we also nd numerically that $_M = _C$ 1. Using the standard BCS result relating the super uid order parameter at T = 0 and c^1 , our scaling form yields $_B$ / $k_F \exp(=(ak_F))$. Again, in order to stay in the desired regime, k_F must be restricted to values k_F jaj^1 . In sum, we nd the following scaling behaviors with k_F

B. D ressed M olecules

The condensate fraction measured in [2, 3] qualitatively refers to the condensation of \dressed m olecules" or diatom states. At the present stage, however, the precise relation between the measured observables and the condensate fraction $_{\rm C}$ has not yet been established with su cient quantitative accuracy. As argued in sect. V, $_{\rm C}$ is given by the expectation value of the renorm alized eld

In g. 10 we plot our result for the condensate fraction of dressed molecules at zero temperature as a function of magnetic eld, for both the ⁶Li (g. 10 (a)) and the 40 K system (g. 10 (b)). Unlike the condensate fraction of bare molecules, the contribution from the dressed condensate is an O (1) quantity.

We nd qualitative agreement with the observations [2, 3] whereas for a quantitative comparison one would




FIG.10: Condensate fraction $_{\rm C}$ and total fraction of dressed molecules $_{\rm B}$ = $_{\rm M}$ + $_{\rm C}$ at T = 0, for 6 Li (a) and 40 K (b). Due to the nonlinear relation of c 1 and B $_{\rm B_{0}}$ which is particularly strong for 6 Li due to the large background scattering value, the curves are twisted compared to the (c 1) plots. We adjust $k_{\rm F}$ to the values found in [2] ($k_{\rm F}$ = 1:50eV $\stackrel{\circ}{=}$ (2500a_B) 1) and [3] ($k_{\rm F}$ = 1:39eV $\stackrel{\circ}{=}$ (2700a_B) 1). The dashed line re ects the Fierz ambiguity as in gs. 3,9.

need a more accurate relation between the measured observables and the condensate fraction $_{\rm C}$ as de ned in our setting. First, the scales of the magnetic edd B for which $_{\rm C}$ decreases from rather large values to small values m atch the scales found in the experiments. This is another con m ation of our universal relation between B, the particle density (or $k_{\rm F}$) and the quantities c 1 ; $\ddot{\rm n}$. We nd that in the BEC limit, the condensate fraction approaches 1 very slow ly. The observed condensate depletion is the e ect of the interaction between the dressed m olecules, as expected for a weakly interacting B ogoliubov gas.

An interesting quantity is the value of the condensate fraction at the location of the resonance, $B = B_0$. For T = 0 we nd a universal value ${}^0_C = {}_C (T = c^1 = 0) = 0.30$, which therefore should apply both ¹⁵ for ⁶Li

and ${}^{40}K$. In order to judge the reliability of this universal result we may consider the relation

which involves the renorm alized Yukawa coupling $h^2 = h^2 = Z$. In the broad resonance lim it and for T = 0 the value $r_0^0 = r_0$ ($T = c^1 = 0$) = 0.28 is universal. The size of $_{c}^{0}$ is therefore determ ined by h^2 , $_{c}^{0} = 16.85h^2$. In the same lim it we nd from eq. (29)

where $\sim^0 = \sim (T = c^1 = 0) = 0.50$. This yields h² = 0.018, $^0_C = 0.30$ as seen in g. 10. Away from the resonance both r_0 and \sim depend on c. In g. 11 we show h² as a function of c¹ for T = 0.

In the broad resonance lim it the value of the renormalized Yukawa coupling only depends on c^1 and T. This universal value h^2 (c¹;T) is rem in iscent of the existence of a partial infrared xed point as som e suitable infrared cuto scale is low ered. The value of h at the xed point typically depends on c^{1} and T, but otherwise the memory of the initial conditions of the ow (e.g. h ;) is lost. It is also plausible that also \sim is governed by some xed point. If this picture is true, the precise location of the xed point may change as the approximation method is improved, for example by taking the molecule uctuations into account for the computation of Z and the renormalization e ects for \tilde{h}^2 . Nevertheless, if both the ${}^{6}Li$ and the ${}^{40}K$ system are within the range of attraction of the xed point, the value of $_{\rm C}$ for $T = c^{1} = 0$ must be the same! Inversely, if the observations should establish di erent values of $\frac{0}{C}$ this would imply that either no such xed point exists or that one of the systems is not yet close enough to the xed point. Only in this case the system could keep additional m em ory of the m icroscopic Yukawa coupling (e.g. h ;0) or the background scattering length aby such that could depend on these parameters. Our ndings so far, how ever, strongly suggest the universal behavior predicting for broad resonances a universal curve $_{\rm C}$ (c 1) for T = 0.

X II. CONCLUSIONS

The theoretical description of the crossover problem for ultracold ferm ionic atom s can be split into two steps.




FIG.11: Renorm alized Yukawa coupling $h^2\,$ as a function of c $^1\,$ at zero tem perature in the broad resonance lim it.

First, the computation of universal properties in term s of the two relevant dimensionless couplings c and \tilde{h} . Second, the relation of c and \tilde{h} to the particular parameters of a given Feshbach resonance as the detuning of the magnetic eld B B₀. B oth steps can be performed within a common setting of non-relativistic quantum eld theory, described here in term s of a functional integral.

The rst step can be done for all densities and tem peratures and for arbitrary Feshbach resonances that can be approximated by our system of one open and one closed channel. It reveals the universal aspects since all observables are expressed in terms of only three parameters c, \hbar , T. For broad Feshbach resonances (large \hbar) the universality is further enhanced. The renorm alized quantities relating to the \m acroscopic" properties of dressed m olecules and atom sonly involve a renorm alized Yukawa coupling h that takes a \ xed point" value h (c; T) that is computable in term s of c and T. The \dressed quantities" therefore depend only on c and T. In consequence, for T = 0 or $T = T_c$ they turn to functions depending only on the concentration c. Furtherm ore, in the scaling lim it at resonance (jcj! 1) the renorm alized observables depend only on T and take predictable universal values for T = 0 or $T = T_c$.

As a particular aspect of universality we nd perfect equivalence between a purely fermionic description of the crossover problem and a model that uses explicit bosonic degrees of freedom corresponding to the m icroscopic m olecules in the closed channel of the Feshbach problem. The m icroscopic m olecules are a convenient tool to take into account the non-locality of the e ective ferm ion-interaction induced by the m olecule exchange. This nonlocality is relevant for narrow and interm ediate Feshbach resonances. For broad Feshbach resonances, how ever, the nonlocality becom es subleading as far as the properties of the dressed atom s and m olecules are concerned. The broad resonance lim it h ! 1 precisely corresponds to a pointlike m icroscopic ferm ion-interaction. A s it should be, only one dimensionless parameter (be-

sides T) characterizes the system , namely the scattering length a appearing in the dimensionless concentration $c=\,ak_{\rm F}$.

For a test of our universality hypothesis we have computed several macroscopic observables as functions of c;ñ;T. This concerns the fraction of microscopic molecules in the atom gas $_{\rm B}$, the condensate fraction $_{\rm C}$ and the fraction of uncondensed dressed molecules $_{\rm M}$. We also compute the correlation length for the molecules $_{\rm M}$ as wellas their scattering length in medium $a_{\rm M}$. The low momentum excitations in the super uid phase are described by a Bogoliubov theory for dressed molecules even if the microscopic molecules play no role. We have computed the corresponding sound velocity $v_{\rm M}$. All these quantities may be experimentally tested.

For these tests we need the second step, the relation of c, h and T to the physical properties of experiments with a given Feshbach resonance at a given density n and tem perature T. Here T = T = F only involves T and n, $_{\rm F}$ = $k_{\rm F}^2$ =(2M), n = $k_{\rm F}^3$ =(3 2). In order to relate c and ñ to observables in the two atom system (at zero density and tem perature) we com pute the molecular binding energy $_{M}$ and the cross section for the atom -atom scattering (s) as functions of c and ${\tt \tilde{h}}$. (Here s denotes the m om entum of the scattering atom s.) This is achieved by simply taking in our formalism the limit n ! 0;T ! 0. Comparing $_{\rm M}$ (c; $\tilde{\rm h}$); (s; c; $\tilde{\rm h}$) to the measured values as functions of the magnetic eld, $_{\rm M}$ (B); (s; B), we can extract c(B) and h (B). In particular, for the broad resonance lim it c (B) is simply related to the scattering length a(B) describing a pointlike interaction, $c(B) = a(B)k_F$. For a broad Feshbach resonance and \dressed quantities" the only experimental input needed is therefore a (B). Only for \bare quantities" (as the fraction of m icroscopic m olecules) one needs, in addition, the determ ination of ñ.

The broad resonance lim it leads to striking predictions that challenge experim ent. For example, the condensate fraction _c should take the same value at resonance, $B = B_0$, for all broad Feshbach resonances. (Here B_0 corresponds to a vanishing binding energy in vacuum, $_{\rm M}$ (B₀) = 0). For T ! 0 or T ! T_c this should hold for arbitrary density, whereas more generally c depends on T = F and therefore on n in a universal way. In our approximation we nd $_{\rm C} = 0.3$ for T = 0 but the precise value could change som ew hat for im proved approxim ations. If both the broad resonances for ^{6}Li and ^{40}K are well described by the broad resonance lim it the experiments [2, 3] should nd the same _c ! W hile the present experiments seem to indicate a substantially higher condensate fraction for $^{\rm 6}{\rm Li}\,as$ compared to $^{40}{\rm K}$, it remains to be seen if this tendency remains once the detailed relation between the observables in both experiments and $_{\rm C}$ is established.

The broad resonance $\lim it$ poses the challenge of a strongly interacting quantum eld theory. Several issues wait for an improved treatment. The understanding of the renormalization ow for h and ~ should reveal the

existence of an infrared stable (partial) xed point and should allow to judge if both ⁶Li and ⁴⁰K are within the range of attraction of this xed point. Indeed, the universal value of $_{\rm C}$ (c¹ = T = 0) requires that for both systems the value of h^2 is su ciently close to the xed point value. The functional renorm alization group [52, 53, 54] seems to be an appropriate method to address these questions. This should also include the e ect of molecule uctuations in the renormalization ow of h; Z and A as well as the computation of the missing corrections to the wave function renorm alization and gradient term for the ferm ionic atom s, Z and A . A nother issue that is not yet settled in a satisfactory way in the present treatm ent concerns the behavior in the super uid phase for T ! T_c and the universal critical behavior in the vicinity of T_c. These issues are mainly related to the running of the molecule interaction

D espite the present shortcom ings we hope that our functional integral approach opens the way for a system – atic quantitative understanding of the relation between m easured m icrophysical parameters and m acroscopic collective phenom ena for ultracold ferm ionic atom s.

APPENDIX A:RENORMALIZATION OF FESHBACH COUPLING

So far we have not been very precise about the meaning of the Yukawa coupling h . Just as it has to be renorm alized, this time with multiplicative renorm alization. In the action (1) appears the m icroscopic Yukawa coupling h; (and similar for ;). In the vacuum (T = 0; n = 0) one can measure the Yukawa coupling by scattering experim ents of single atom s. This involves a UV - renorm alized coupling corresponding to the e ective molecule - atom vertex at low momentum. We will use the vacuum value in the atom phase, h ;0, in order to de ne a UV - renorm alized Yukawa coupling. Finally, in an atom gas at arbitrary T;n the relation between the gap and o involves a renorm alized Yukawa coupling h (T;). Corresponding dim ension less quantities are denoted ñ ; ;ñ ;0;ñ (T;). The quantity ñ (T;) typically appears in the ferm ion loop through the gap r and we use the shorthand \tilde{h} . A ctually, the situation is even more complex since a momentum dependent ñ (q) appears in the mom entum integrals of the Schwinger-Dyson equations. W e will neglect this in a sim pli ed treatm ent.

W e estimate the UV-renormalization e ects for the Yukawa or Feshbach coupling by the use of an appropriate Schwinger-Dyson equation shown in g. 12. This






FIG. 12: G raphical representation of the Schwinger-D yson equation for the Yukawa or Feshbach coupling. Ferm ions are represented by solid, molecules by dashed lines. The vacuum value of the Yukawa coupling, h $_{;0}$, is signalled by the sm all blob, the full quantity h by the fat shaded blob. The vacuum value of the background scattering vertex enters as a sm all square.






FIG.13: Scattering with tree exchange of a molecule.

This would result in the relation (D7) also for a in the atom phase. The B - dependence of a or c therefore depends on the splitting of the m icroscopic interaction into the two pieces ; and $h^2 = .$ Since all our results depend only on c the B -dependence of the observables is now a ected by an unphysical \Fierz am biguity" [60]. This is clearly a shortcom ing of the approxim ation, in particular of our neglection of the molecule uctuations for the computation of Z and the renormalization e ects for h . The uncertainty arising from the Fierz ambiguity is relected by the two curves in q. 3, where the solid line re ects the choice (D 7) whereas the long-dashed line corresponds to eq. (D10). Presum ably the solid line re ects better the true answer since at the end all macroscopic results can only depend on the combination $a_{res} + a_{bq}$. Close to the resonance the Fierz am biguity becom es irrelevant since jaba j can be neglected as com pared to jares j.

C bese to the resonance the scattering at zero m om entum provides the same information on the relation between c and B as the binding energy $_{\rm M}$ (B) in the vicinity of B₀. Indeed, the dependence of the resonant scattering length $a_{\rm res}$ or the cross section on the magnetic eld involves the same combination of parameters. The resonant scattering length $a_{\rm res} = (M_{\rm o})^{1=2}$ (B₀ $_{\rm B}$)¹ involves , just as the binding energy (82) in the \m olecule phase" for $_{\rm M}$ < 0. From the experimental parameterization of the scattering length

This does not involve the Yukawa coupling. Experim ental comparison of $_{\rm M}$ (B) and a (B) on the respective sides of the Feshbach resonance therefore amounts to a test of the computation of the vacuum properties.

For a realistic scattering of atom s we have to take into account them om entum dependence of the atom s and the nonvanishing decay width . From app. C we infer (for $q^2 = 0$ and $! = s_M$ ($_M$))

Independent experimental information on h can be gained from scattering in a momentum range where the pointlike limit does not apply anymore. In particular, the peak height of the resonance at s = M depends ¹⁹ on h,

The value $\tilde{h}_{;0}^{res}$ extracted from resonant scattering (D 17) will again be a renormalized coupling in vacuum, but now evaluated for the particular resonance frequency. It is therefore conceivable that it di ers from $\tilde{h}_{;0}$, eq. (98). We note that the cross section remains nite for

On the other hand, the atom phase is characterized by Z = 1 and (s) given by eq. (D13). While P (s) jis the same, the phase of $_{\rm eff}$ (s) jumps between the molecule and the atom phase. This is a typical shortcoming of our approximation where the molecule uctuations are neglected in the computation of Z and . In particular, the molecule uctuations will provide for an imaginary part of $_{\rm eff}$ (s) also for the molecule phase.

O ur functional integral approach reproduces several results obtained previously by quantum mechanical two channel computations in the vicinity of the Feshbach resonance. The uctuation correction to the mean eld binding energy coincides exactly with the result from a quantum mechanical coupled two-channel approach [61]. The estimate for the Yukawa coupling given in [35] coincides with our \vacuum coupling " \tilde{h}_{j0} (96).
