Bosonic Resonating Valence Bond wave function for doped M ott insulators

W e propose a class of ground states for doped M ott insulators in the electron second quantization representation. They are obtained from a bosonic resonating valence bond (RVB) theory of the t J m odel. At half lling, the ground state describes spin correlations of the S=1/2 H eisenberg m odel. very accurately. Its spin degrees of freedom are characterized by RVB pairing of spins, the size of which decreases continuously as holes are doped into the system . Charge degrees of freedom emerge upon doping and are described by twisted holes in the RVB background. We show that the twisted holes exhibit an o diagonal long range order (ODLRO) in the pseudogap ground state, which has а nite pairing amplitude, but is short of phase coherence. Unpaired spins in such a pseudogap ground state behave as free vortices, preventing superconducting phase coherence. The existence of nodal quasiparticles is also ensured by such a hidden ODLRO in the ground state, which is non Ferm i liquid-like in the absence of superconducting phase coherence. Two distinct types of spin excitations can also be constructed. The superconducting instability of the pseudogap ground state is discussed and a d-wave superconducting ground state is obtained. This class of pseudogap and superconducting ground states uni es antiferrom agnetism, pseudogap, superconductivity, and M ott physics into a new state of m atter.

I. IN TRODUCTION

An important question posed by the study of high temperature superconductors is whether the superconducting ground state of doped M ott insulators can be described by a BCS-like wave function. A d-wave BCS wave function and/or its derivatives have been widely used in the phenom enology of high temperature superconductors, partly because electron pairing, as evidenced by 2e ux quantization and sim ilar experimental results, is observed in the cuprate superconductors. However, owing to the e ect of strong on-site C oulom b repulsion between the electrons, superconductivity in these system sm ay be quite di erent. W hereas in a conventional BCS superconductor, screening and retardation e ects serve to m inimize the role of C oulom b interaction, the role of the latter becom es crucial in a doped M ott insulator where the charge degrees of freedom are partially frozen by the severity of the C oulom b interaction. Strong arguments have been presented in the literature that a high tem perature superconductor evolves from a M ott insulator doped by holes, and consequently the ground state can be very di erent from a conventional BCS state¹.

A simple step towards incorporating M ott physics into a BCS description was suggested many years $ago^{1/2}$. This involves a projection (out of the H ilbert space) of doubly occupied sites in a d-wave BCS state³. In this approach, the charge degrees of freedom on a lattice site i, are partially frozen by a Gutzwiller operator (1 $n_{i^{*}}n_{i^{\#}}$). At half

lling, only spin degrees of freedom survive, and the wave function describes a M ott insulating state. This class of wave functions has achieved some success in the phenom enology of the cuprate superconductors^{4,5,6}. A recent paper argues the case further⁷. However, the treatment of low energy spin degrees of freedom in this description is not satisfactory. Experimentally, strong antiferrom agnetic (AF) correlations have been observed for the Cu spins, but projected d-wave BCS states cannot account correctly for such correlations. Since we opine that spin correlations are intim ately related to superconductivity in a doped M ott insulator, we are motivated to seek an alternate description in which the spin degrees of freedom can be treated m ore accurately and system atically.

In this paper, we propose a new class of ground states based on a microscopic treatment of the t J model. These ground state wave functions are di erent from the projected BCS wave functions, and possess the following properties: (i) the spin degrees of freedom can fully restore the AF long range order (AFLRO) as well as low-lying spin wave excitations at half lling, and evolve into a spin liquid with strong short-range AF correlations at low doping; (ii) the no double occupancy constraint is always satis ed for any doping, and is incorporated self-consistently instead of being enforced by a \brute-force" projection; (iii) there is an inherent d-wave superconducting instability at nite doping. Thus, these wave functions o era uni ed description of antiferrom agnetism and superconductivity in a doped M ott insulator.

To motivate the form of the ground state wave function, let us rst consider the ground state of the undoped M ott insulator on a square lattice. It is well known that the dynam ics of the low energy degrees of freedom in this case are described by the S = 1=2 H eisenberg H am iltonian. W hile the exact ground state of this model is not known, a com parison with num erical results shows that the best variational state, j₀i, is given by⁸

The ground state (1) is defined to be the bosonic RVB state of the insulator⁸. Here, (ij) stands for a singlet spin pairing between opposite sublattice sites i and j, and W (ij), the positive weight factor associated with it. The motivation for such a construction is to ensure that the ground state satis es the so-called M arshall sign rule⁹. M arshall showed that the ground state of the S = 1=2 H eisenberg H am iltonian on a square lattice satis es the condition, sgn [$_0(_{1; 2}; ...; _N)$] = ($_1p^{(_{1; 2}; ...; _N)}$. Here, P ($_1;_2; ...; _N$) denotes, say, the number of down spins on sublattice A for the spin con guration j₁; ₂; ...; _N i. Then, the matrix elements of the H eisenberg H am iltonian are negative and the ground state energy assumes the form of a sum over negative term s¹⁰. Since each singlet bond (ij) satis es the M arshall sign, it follows that the wave function of (1), which is given by $_0 / _{(ij)} (1)^{i}W$ (i j) [here i(j) stands for up (down) spin sites and h(i j) = 0 if ij 2 the same sublattice sites], always satis es this criterion.




FIG.1: (a) The ground state picks up a sequence of signs, (1) (+1) (+1) :::, known as a phase string, during an operation as a hole moves through a closed path and back to the origin with the displaced spin con gurations being restored. This integrable phase string e ect has been shown to be a general consequence of the t $J \mod d^{1}$. (b) The + or sign in a phase string is determined by the exchange of the hole with an " or # spin on the path, which can be viewed as an entanglem ent between the hole and a spin, illustrated by two entangled loops as both the hole and a displaced spin should return to their origins after the operation.

The ground state (1) describes both short-range and long-range AF correlations very accurately as the best variational wave function for the insulator. It is then reasonable to expect that any putative RVB state, away from half

ling, evolves from (1). With this in mind, we ask how the wave function (1) is modiled in the presence of holes. As discussed above, singlet pairing is characterized in the wave function (1) by the Marshall sign. It can be shown that the Marshall sign would be still obeyed if doped holes remain static. Then, from the form of (1), one may easily see that the nearest-neighbor (nn) hopping of holes, which displaces spins as back ow, generally leads to disordering of the Marshall sign (1)[°]. Consequently, a hole moving along a closed path picks up a generalized Berry's phase, which was rst identied by one of us and co-authors¹¹. This e ect, described (and called) as a phase string is illustrated in Fig. 1 (a). It is a singular e ect and cannot be repaired by low energy (transverse) spin excitations¹¹.

It follows that a bare hole created in the RVB background (1) cannot possibly describe a low energy state, and must be dressed by the nonlocal phase string e ect. Since the phase string e ect describes a mutual entanglement between spin and charge degrees of freedom illustrated in Fig. 1(b), the RVB background must also respond nonlocally. One may thus sum is that low energy charge degrees of freedom are created by $e_i = e_i e^{-i}$, instead of by the bare e_i , where $e^{i^{n}}$ is a nonlocal operator describing the phase string e ect. We call a hole that is created by e_i a twisted hole, and as will be shown in this paper, such a twisted hole is a bosonic object whose kinetic energy is optimized in the (m odi ed) RVB background. We shall obtain a ground state of the following form

where Z (1) describes the wave function of the twisted hole e_1 , and $N_h^{"} + N_h^{\#} = N_h$ is the total number of holes. The modi ed RVB vacuum RVBi has the same structure as j₀ i at half-lling, except that the RVB pairing am plitudes, W_{ij} 's, become complex and change continuously with doping, which can be determined self-consistently as we shall show.

The ground state (2) is one of the central results of this paper. It generalizes the wave function (1) written down by Liang et al., to the doped case. We will derive (2) from a microscopic treatment of the t J model, based on a reform ulation of the model in the so-called phase string representation.

The wave function (2) di ers from the Gutzwiller projected BCS wave functions in a fundamental way. Spin correlations with various length scales energe self-consistently as a function of doping in RVBi and their interplay with the charge degrees of freedom is incorporated through the nonlocal phase string operator e^{i^} in c_i. We will nd that the ground state (2) describes both an AF insulator (at zero doping) and a pseudogap phase with short range AF correlations (at nite doping) in which two distinct kinds of spin excitations energe. We will identify a hidden OD LRO in this pseudogap ground state which ensures a nite pairing am plitude and nodal ferm ionic quasiparticles. A lthough superconducting phase coherence of this state is prevented by the presence of free spins which behave like vortices, there exists an inherent superconducting instability at nite doping, which can naturally give rise to d-wave superconductivity.

The outline of the paper follows. In Section II, we reform ulate the t J model using the phase string representation. This is an exact reform ulation and allows us to sort out the e ects of hole motion in an AF background discussed earlier. A singular gauge transform ation autom atically ensures that the single occupancy constraint is satis ed. A brief review of this form alism and in portant physical consequences will be discussed in Section II. In Section III, we obtain the ground state within a mean eld theory, and in Section IV we transform the ground state wave function back to the electron representation, thus com pleting the derivation of the wave function (2). A discussion of the properties predicted by (2) follows and nally a superconducting ground state is obtained. The nal section is devoted to a general discussion about the region of validity (in the phase diagram) of this approach, as well as the questions that this study raises. In Appendix A, some detailed derivations of the mean eld theory in the phase string representation are presented. In Appendix B, we discuss brie y, an e ective theory of spin and charge degrees of freedom that are coupled by the phase string. In Appendix C, we show that the ground state obeys time reversal and spin rotational symmetries.

II. PHASE STRING FORM ULATION AND PHYSICAL IM PLICATIONS

In this section, we reform ulate the t J m odel using the phase string representation¹¹. This representation, like the slave-particle representations used in the literature^{12,13}, is an exact reform ulation. However, the phase string form ulation has a distinct advantage over these other schemes, in the following sense. The most singular e ects encapsulated in the t J model are sorted out by a unitary transform ation, and all nontrivial phases present in the original model now occur as topological gauge elds. W ithout these gauge elds, the model becomes trivial, i.e., free of sign problems, which is the case in one dimension, or in the particular case of half lling in two dimensions. The central issue in two dimensions is then how to handle these topological gauge elds at nite doping. It turns out that they are well controlled, at least for sm all doping.

A. Phase string representation

The most singular e ect of the hole moving in an AF background is the phase string e ect. This leads to a competition between hopping and superexchange processes. Since it is most singular at length scales of a lattice constant (as Z_2 signs), it is crucial to track this e ect explicitly, before constructing any e ective theory. As shown by W eng et al., this can be achieved starting from a slave-ferm ion representation and by performing a unitary transform ation of the basis states¹¹. In this procedure, the electron operator is decomposed into

where holon h_i^y and spinon b_i operators are both bosonic elds, satisfying the constraint

The phase factor e^{i_i} in Eq. (3) is de ned by

Here, n_1^b and n_1^h are spinon and holon number operators respectively, at site 1; and i (1) Im ln ($z = z_1$); where $z_1 = x_1 + iy_1$ is a complex coordinate on the lattice.

It is easily veri ed that the ferm ionic statistics of c_i is autom atically ensured by $e^{i \int_{1}^{string}}$; besides ensuring ferm ionic statistics, the string operator also incorporates the singular e ects of hole motion in the RVB background, as will be discussed later. The factor ()^{N̂ h} guarantees anticom mutation relations between opposite spins. The factor ()ⁱ = 1 in (5) is added for convenience, and incorporates the M arshall sign into the decom position (3) of the electron in terms of the holon and spinon operators, which m ay be regarded as a bosonization scheme for the electron moving in an RVB background. The same bosonization decom position can be also obtained from the slave-boson representation^{14,15}.

B. Thet J model in the phase string representation

Rewriting the t J model using the electron decomposition (3), we get $H_{tJ} = H_t + H_J$; where the hopping term

The RVB pair operator \hat{i}_{j} in H_J is dened by

The unique feature in this form alism is the emergence of three phases (link elds): A_{ij}^{s} , ${}_{ij}^{0}$, and A_{ij}^{h} ; de ned on the nn links. W ithout these, there should be no nontrivial sign problem in H_{tJ} , because h and b are both bosonic elds. The m atrix elements of H_{tJ} would then be real and negative-de nite in the occupation number representation of h and b. Consequently, the ground state expanded in term softhese bosonic elds will have real and positive coe cients. Therefore, any nontrivial signs (phases) of the t J m odel arise solely from these three link elds, de ned by

It is easy to see that the H am iltonian H $_{t}$ J is invariant under U (1) U (1) gauge transform ations:

Thus A_{ij}^{s} and A_{ij}^{h} are gauge elds, seen by holons and spinons respectively, as the latter carry their gauge charges according to (15) and (16). But they are not conventional U (1) gauge elds, as they must satisfy the topological constraints: ${}_{c}A_{ij}^{s} = {}_{l2c}n_{l''}^{h}$ $n_{l\#}^{b}$ and ${}_{c}A_{ij}^{h} = {}_{l2c}n_{l}^{h}$ according to (12) and (14), respectively. Here the subscript c denotes an arbitrary closed loop such that the uxes enclosed, ${}_{c}A_{ij}^{s}$ and ${}_{c}A_{ij}^{h}$, are determined by the number of spinons and holons respectively, inside the loop c; viz. A_{ij}^{s} and A_{ij}^{h} are not independent gauge elds with their own dynam ics. Rather they are directly connected to matter elds as a pair of mutual C hem-Sim ons gauge elds¹⁶. The term \mutual" refers to the fact that A_{ij}^{s} describes quantized uxoids attached to spinons in H_J. The phase ${}_{ij}^{0}$ describes a uniform and constant ux with a strength per plaquette: ${}_{2}$ ${}_{ij}^{0} = {}_{2}$

In the case of the one dimensional model, $A_{ij}^s = {0 \atop ij} = A_{ij}^h = 0$: Thus there is no sign problem in the phase-string representation of the t J model. It implies that the H am iltonian can be treated within a mean eld framework, which indeed results in a correct Luttinger-liquid solution for the large-U H ubbard model¹¹. In two dimensions, these nn link phases can no longer be \gauged away". They compose a mutual gauge structure which completely determines the essential sign problem of the t J model. These gauge elds are generally well controlled in the regimes of our interest: ${0 \atop ij}$ is a non-dynamic phase describing a constant ux per plaquette; A_{ij}^s is canceled when spinons are RVB paired at low-temperature phases; A_{ij}^h remains weak at small doping – it vanishes at half lling, where there is no sign problem in the H am iltonian. Therefore, these gauge elds in the phase string representation are presumably well tractable in low doping and low temperature regimes. This is one of the main advantages of the phase string representation over other approaches.

Finally, it is in portant to note that the phase string representation is de ned in a H ilbert space where the total S^z is an eigen operator. The total numbers of " and # spinons are conserved individually, such that the topological gauge eld A^s_{ij} behaves smoothly as de ned in (12), depicting ctitious uxoids bound to spinons. (Non-conserved S^z would result in non-conserved + and uxoids in A^s_{ij}). Dierent S^z states are connected by the spin ip operators, de ned in the phase string representation as

(a factor (1)^{\hat{V}_h} has been dropped for simplicity) and $S_i = (S_i^+)^y$, and $S_i^z = b_i^y b_i$. These de nitions follow from (3). The nonlocal phase $\frac{h}{i}$ in (17) plays a crucial role in restoring the spin rotational symmetry.

C. No double occupancy constraint

Since the t J m odel is a projective H am iltonian, the no double occupancy constraint is a central issue. It im poses a severe restriction on the H ilbert space

which ensures that the system is a M ott insulator at half lling and a doped M ott insulator away from half lling. In conventional slave particle decompositions, the constraint reduces to a single occupancy constraint like (4), and is still di cult to treat. Typically, the constraint is relaxed at the level of mean eld theory, and restoring its e ect beyond the mean eld theory (say, by a gauge theory) is a very challenging problem. In contrast, the phase string representation outlined in the previous subsection provides a new way to handle the constraint.

A wavefunction e in the electron c-operator representation is de ned in a quantum state as

where the vacuum jDi is chosen to be led by holons. The sign factor $(1)^{N_A}$ in (21) can be identied with the M arshall sign, and N_A denotes the total number of "spins in sublattice A. Here and henceforth, we will always use i to specify an "spin, ja # spin, and l, a holon, where the subscripts u, d, and h label the sequences of the "spins, # spins, and holons, respectively.

Now, the decom position (3) of the electron operator c_i , relates the wave functions written in the two representations:

in which k and m run through all lattice sites, such that C is a constant.

C orrespondingly, the wave functions in the electron and phase string representations are related by

which holds generally for the t J m odel.

Note that the above expression for K has been obtained strictly under the no double occupancy constraint. But if the constraint is relaxed in (23), while still treating C as a constant, then one nds K = 0 for double occupancies when any two particles (spinons and/or holons) occupy the same site; viz., K de ned in (23) autom atically enforces the constraint (4) through the Jastrow-like factors. Therefore, as far as $_{e}$ is concerned, the no double occupancy constraint in $_{b}$ or $_{b}=C$ is no longer in portant, since K in (24) naturally plays the role of a projection operator.

Clearly, an exact $_{b}$ would satisfy the single occupancy constraint (4). But, the point is that an approximate $_{b}$ determined without the constraint does not a ect $_{e}$, owing to K. It means that in the phase string representation the constraint (4) is indeed \unimportant", which may be understood in the following way. In the phase string representation, the e ect of K in the original $_{e}$, is transformed into the topological gauge elds; A_{ij}^{s} and A_{ij}^{h} ; in the H am iltonians, (9) and (10), which describe spinons and holons as mutual vortices, as perceived by each other

(cf. the discussion in the previous subsection). This clearly implies a mutual repulsion between two species, since a spinon cannot stay at the center of its vortex (which is a holon), and vice versa. Thus the constraint that a holon and a spinon cannot occupy the same site is now rejected in the interactions present in the new Ham iltonian, and the condition (4) is not needed as an extra condition to enforce. Note that the constraint (4) also requires the hard core conditions among the holons or spinons them selves. But since both holon and spinon elds are bosonic elds, local hard core exclusions usually do not involve the sign change of the wave function. Hence, in the phase string representation, the local constraint (4) is neither crucial nor singular, as far as low energy physics is concerned.

D. Phase string e ect: A singular doping e ect

In this subsection, we point out that the other in portant e ect, i.e., the phase string e ect, is also explicitly built into this representation via K.

Let us rst rewrite K (23) in a more compact form,

It is easily seen that the Jastrow-like factors in J enforce the single occupancy constraint discussed previously: J vanishes if two spins (or holes) occupy the same site, or if a hole and a spin occupy the same site. The factor J also explicitly captures the ferm ionic statistics of electrons.

Now let us focus on the additional factor G in K, which is asymmetric with regard to " and # spins: it only involves an " spin complex coordinate z_{i_u} and a holon coordinate z_{i_h} . Suppose that the holon is taken along a closed loop shown in Fig. 1. The K factor will generally acquire a nontrivial phase through G. In the following we exam ine this.

For a spinon inside or outside the loop, there will be no net contribution to G as the acquired phase is either 2 or 0 under such an operation. So any nontrivial contribution is solely from spinons occupying lattice sites on the holon's loop-path. At each step of hopping, the holon under consideration will have to switch positions with a spinon occupying a nn site on the loop, obeying the no double occupancy constraint. Then G picks up a minus sign from the Jastrow factor in G every time when the holon and an "spinon are exchanged. Thus, if one changes the holon's coordinate continuously through the loop without encountering other holons, G will acquire a sequence of signs,

where N_{loop} denotes the number of "spinons exchanged with the holon during the above thought experiment. (Note that the spinons displaced by holon hopping during the operation should all be restored to the original conguration by pure spin ips in terms of the superexchange H_J, and this does not generate any further signs in G).

Therefore, the electron wave function $_{e}$, acquires a sign factor (which can also be thought of as a Berry phase) through G:

This factor (for the closed loop) is just the phase string shown in Fig. 1, where $_{\rm m}$ denotes the index of spins on the loop exchanged with a holon, under the thought experiment of moving the holon around a closed path (note that a closed loop on a bipartite lattice always involves an even number of nn links). Equation (29) shows that the singular hopping e ect is explicitly incorporated in $_{\rm e}$ through K, in the phase string form ulation of the t $_{\rm J}$ m odel.

To conclude this section, the two singular e ects in the t J m odel, viz., the single occupancy constraint and the phase string e ect, are explicitly represented by the factor K, (23). Consequently the ground state wave function in the phase string representation, $_{b}$; is presumably no longer singular, justifying a mean eld theory.

III. CONSTRUCTION OF THE GROUND STATE IN PHASE STRING REPRESENTATION

A mean eld theory (bosonic RVB theory) based on the phase string representation of the t J model was constructed in an earlier paper¹⁷, and we will follow a similar route here in dealing with the spin degrees of freedom. However, an important distinction in this work is the way the charge degrees of freedom are incorporated, in order to better facilitate and optim ize the kinetic energy of the holes, as well as to construct a state in which the no double occupancy constraint is strictly enforced. As shown in Sec. IV, this construction directly results in a pseudogap ground state characterized by a nite pairing amplitude and the emergence of nodal quasiparticles. The ground state has an inherent superconducting instability which occurs, when phase coherence is realized.

A . Spin degrees of freedom and bosonic RVB order parameter

Let us begin by considering the superexchange term H_J , which is expressed in term s of an RVB pair operator \hat{i}_{j} in (10). Note that \hat{i}_{j} is invariant under the gauge transform ation (16). It is then natural to de ne the bosonic RVB order parameter by

for nn sites, i and j. This RVB order parameter is di erent from the RVB order parameter introduced by Anderson and collaborators^{1,2}: $\frac{1}{D}$ involves the charge degrees of freedom through the gauge eld, A_{ij}^{h} , and is gauge invariant under (16). Note that b_{i}^{y} bj 0 in this theory, and ^s is the sole order parameter. At half lling, $A_{ij}^{h} = 0$ in \sum_{ij}^{n} , and ^s reduces to the well known Schwinger-boson mean eld order parameter \sum_{ij}^{P} B_{ij} bj i¹³ [in our de nition bj di ers from the conventional Schwinger boson representation by a sign factor (\sum_{ij}^{j}). The mean eld solution describes both long and short range AF correlations of the H eisenberg m odel quite well, as will be discussed below. Thus, the bosonic RVB theory we present is ensured to yield good results at half lling, and provides a natural generalization away from half lling.

We now show how the spin degrees of freedom are treated within the bosonic RVB theory. The superexchange Ham iltonian is rewritten as

where $J_s = J_s = 2$, and s is assumed to be real and positive. The Lagrangian multiplier is introduced to implement the single occupancy constraint (4) on the average. We reemphasize that H_s is not a mean eld Ham iltonian in the conventional sense. Spinons are coupled to a gauge eld A_{ij}^h , related to the charge degrees of freedom, and the Ham iltonian is invariant under the internal gauge transformation (16). So H_s is still a gauge model, describing low energy, long wavelength spin uctuations, underpinned by the bosonic RVB order parameter (30). The link eld A_{ij}^h de ned in (14) describes holons as uxoids perceived by spinons in (31). In the ground state, A_{ij}^h will be treated as a constant eld, as though the holons are Bose condensed (which condition will be determined self consistently, when we discuss the charge degrees of freedom), with




FIG.2: Schem atic phase diagram of the b-RVB mean eld theory: The bosonic RVB order parameter ^s underpins a pseudogap phase at $T < T_0$, in which the AF state, spontaneous vortex phase (a low-T pseudogap state), as well as the superconducting instability occur at low temperatures, separated by som e critical dopings, x_c and x_{RVB} , respectively.

which is antiferrom agnetic in nature [i.e., in the resulting bosonic RVB theory, $hS_1 = \xi > 0 (< 0)$, if i and j belong to the same (opposite) sublattice]. Therefore, ^s 6 0 generally characterizes a regime with short range AF correlations, present in a wide range of temperature in the t J m odel at low doping (e.g., J=k 1;500 K in the zero-doping lim it). Fig. 2 sketches a phase diagram in which ^s or short-range AF correlations controls the high-energy, short-distance correlations in a low-doping regime (< x_{RVB})¹⁷. Such a spin singlet-pairing regime, characterized by ^s 6 0, de nes the \pseudogap" regime of the bosonic RVB state, with a characteristic temperature T₀, as illustrated in Fig. 2.

In the following two subsections, we further exam ine the spin correlations at half-lling and nite doping within this bosonic RVB description.

1. Antiferrom agnetism at half-lling

At half lling, the bosonic RVB ground state $\Re VBi = P_G \Re VBi_{MF}$, which satis as the no-double-occupancy constraint (P_G denotes the G utzw iller projection operator), can be explicitly written as

where each site is occupied only by one spinon, with $f_s g_1$; 2; N being partitioned into RVB pairs connected by the RVB amplitudes, W_{ij}. Here each RVB pair is denoted by (ij), where i(j) refers to the position of an " (#) spin, as before. The sum mation runs over all possible RVB pairing partitions. The holon annihilation operators in (40) are introduced since the spinon vacuum jDi is de ned as a state where every site is occupied by a holon, for later convenience.

 $\Re VBi$ given in (40) is equivalent to the class of variational wave functions (cf Eq.(1)) proposed by Liang, D oucot, and Anderson (LDA)⁸. The RVB amplitudes can be determined from the bosonic mean eld theory outlined above. At half lling, $A_{ij}^{h} = 0$, and the mean eld H am iltonian (31) reduces to the Schwinger-boson mean eld H am iltonian.




FIG.3: The RVB amplitudes, \mathbf{j}_{ijj} obtained from the b-RVB theory for three dimensions of the result for half lling.

In this case, the RVB am plitude W_{ij} / $j_{ij}j^3$, for $j_{ij}j = a$ (a being the lattice constant), as shown in the inset of Fig.3. We use the loop-gas method employed by LDA to determ ine the nn spin correlation (which also decides the ground state energy of the H eisenberg m odel), as well as the staggered m agnetization, m. The maximum sample size is 64 64. We obtained hS_i $j_{i_{nn}} = 0.3344$ (2)J, and a staggered m agnetization, m = 0.296 (2). These results are essentially the same as the best variational result obtained by LDA, and also compare extrem ely well with exact num erical results⁸, hS_i $j_{i_{nn}} = 0.3346$, and m = 0.31.

Therefore, at half lling, the insulating state RVB i correctly reproduces both short range and long range AF correlations of the H eisenberg m odel. A FLRO appears naturally in the long wavelength lim it, with a correct m agnitude of m agnetization; short range spin correlations are also well described as evidenced by the excellent agreem ent of our results with the ground state energy obtained from num erical studies.

2. Spin liquid at nite doping

At nite doping, the RVB amplitudes W $_{ij}$, determined by (31) and (37) decay exponentially for large spatial separations,

as shown in Fig. 3. Correspondingly, AFLRO disappears and a nite length scale, , for equal time spin correlations emerges; viz., a featureless RVB spin liquid with short range correlations evolves continuously from an AF ordered state at half lling (! 1).

Spin excitations can be created by the action of a spin raising/low ering operator on the spin liquid RVBi in (40). In the bosonic mean eld theory, spin excitations are described by the spinon RVB Ham illonian, (31). The results from mean eld theory have been reported elsewhere^{17,18}, and we brie y summarize the results below. At sm all doping, the spin excitations evolve (from the gapless magnon mode at half lling) into a sharp resonance at low energies,

with a characteristic energy scale, E_g / J , around the momentum (;): The spectral weight of this excitation is proportional to , while its width in the momentum space is proportional to ¹, which follows from (41). The evolution of the gapless m agnon mode at half lling into a resonant mode at nite energies relects the phase string e ect on the spin degrees of freedom, through the elect of the gauge led, A_{ij}^h .

B. Charge degrees of freedom : optim izing the kinetic energy of doped holes

At nite doping, the mean eld state $RVB i_{MF}$ describes a condensate of RVB spinon pairs, and does not involve the charge degrees of freedom (holons) explicitly; i.e., the distribution of holons is independent of the positions of spinons. Since the single occupancy constraint is no longer crucial in the bosonic RVB theory, it is tempting to posit a mean eld ground state

where ji_h describes the holon condensate. This approach, adopted in a previous work¹⁷, may be justiled for a long wavelength, low energy theory as the local constraint is not crucial in the phase-string form alism¹⁹. However, to obtain the ground state wavefunction, it is desirable to employ a construction where the single occupancy constraint is satis ed exactly; viz., a method that treats spin back ow elects more carefully, which is also important for facilitating and optimizing the kinetic energy of doped holes. In the following, we show how this can be done dilerently.

First, we project out all double occupancies in $\Re VBi_{MF}$, and de ne $\Re VBi$ as given in (40), where each site is occupied only by one spinon, as if the system were at half lling. However, the RVB am plitudes, W_{ij} , will be determined by the bosonic RVB mean eld theory of H_s at a xed hole concentration.

Next, for every doped holon at site 1, a spinon at the same site 1 is annihilated, by the action of $h_1^y b_1$ on $\Re VBi$, i.e.,

such that the constraint is autom atically satis ed. As discussed below, the construction (44) optim izes the kinetic energy of the holon-spinon composite, $h_1^y b_1$, by maxim izing the overlap between the RVB con gurations before and after hopping. Clearly, the behavior of the spinon b_1 characterizes the spinon back ow accompanying the motion of the holon in the RVB background.




FIG.4: Ratio of the e ective hopping integral $\frac{t_h}{t}$ obtained from (49).

Note that ^s 1 at small, one hast t in terms of (51). So the holes acquire a good \bare" hopping integral in the bosonic RVB background since the singular frustrations due to the phase string e ect are gauged away in the phase string formalism [one would get a minus sign in the second (RVB) term in (51) in the original slave-ferm ion representation]. The residual frustrations of the phase string e ect are represented by the phase eld $^{0}_{ij}$ and A^{h}_{ij} in the eigen equation (49) which determ ines the renorm alized hopping integral t_{h} . The latter is reduced from t as shown in Fig. 4 num erically. In Appendix B, we brie y discuss how to go beyond the above mean-eld construction in an e ective m odel description, which is essentially the same as obtained in R ef.17.

IV. PSEUDOGAP AND SUPERCONDUCTING GROUND STATES IN ELECTRON REPRESENTATION

So far, we discussed the reform ulation of the t J m odel using the phase string representation, where the singular e ects arising from the constraint on occupancy and the phase string, are sorted out explicitly. This allowed us to develop an approximate theory in the above section. In this section, we will rewrite our results in terms of the underlying electronic degrees of freedom, and discuss the physical consequences and im plications.

A. The ground state (45) in electron representation

It is straightforward to reexpress the ground state (45) in terms of the electron operators based on (3)

Note that $\Re VBi$ is always half-lled, involving spins on the whole lattice which satisfy the no double occupancy constraint. Here each spin con guration $f_{sg} = _{1;2;N}$ is weighted by $_{RVB}$ in a way that spins are all paired

up with the RVB am plitudes, ($1^{j}W_{ij}$: The latter depend upon doping as determined by the mean eld theory described in the previous section (see Fig. 3). The summation in _{RVB} runs over all possible pairing partitions for each conguration f_sg.

The ground state j_{G} i, reduces to $\Re VB$ i at half-lling, where it describes the antiferrom agnetism extrem ely well as discussed in Sec. III A1. Upon doping, $\Re VB$ i may be regarded as an insulating RVB vacuum. From (54), we see that each doped hole is \twisted" into a bosonic object c, via the nonlocal phase operator \hat{i}_{i} , in order to optimize its kinetic energy in such an RVB vacuum. The form of the state j_{G} i suggests a generalized \spin-charge separation"; viz., the bosonic holes created by c, move freely in the background $\Re VB$ i; they carry the charge while the vacuum is described by the pairing of neutral spins (spinons). These two degrees of freedom are indeed decoupled in the meaneld sense. But this is di erent from the typical spin-charge separation because the twisted holes are accompanied by

spins. Indeed, annihilating a spinon at the site l in the RVB vacuum by e_1 will always create an unpaired spinon within a scale where the spins were originally RVB paired (with no free spinons). So the state j_G i is composed

both of RVB paired spinons and twisted holes as the holon-spinon pairs as in (57) below. Since the spins at the hole sites I's in the vacuum <code>RVBi</code> are automatically annihilated by c_1 's, the no double occupancy constraint is exactly in posed in j _G i at nite doping. As shown in Appendix C1, the ground state retains time reversal symmetry, which may not be obvious from the form of j _G i. It also respects global spin rotational symmetry under the approximation that the twisted holes are perfectly Bose condensed, as discussed in Appendix C2.

The structure of j_{G} i in the doped case boks rather simple in terms of the twisted holes moving on the RVB vacuum. But it would bok more complicated when written in terms of the c-operators in (54) because i_{i} is highly nontrivial. Physically, the phase string i_{i} can be regarded as the nonlocal phase shift induced by doped holes. In the one dimensional case, where it is responsible for the Luttinger liquid behavior, the phase string can be identied precisely with the phase shift obtained from the Bethe ansatz solution for the large-U Hubbard model¹¹. In the two dimensional case, the role of the phase string operator i_{i} may be seen more clearly in the wavefunction form discussed in Sec. II, i.e., (24). Below we rewrite the wavefunction (54) in terms of the underlying electrons.

Starting from the wavefunction $_{\rm b}$, corresponding to the ground state (45) in the basis of (21), and using the relation between the wavefunctions in the two basis sets (24), we get,

In (54), a given spin-hole con guration, fi₁g, fj₁g and fl_hg, is partitioned into pairs, denoted by (ij) (the sites, i and j, are occupied by an up and a down spin, respectively), $(l_1 j_1)$ (sites l_1 and j_1 are occupied by a hole and a down spin, respectively), $(l_1 j_1)$ (two sites, i_1 and l_1^0 , are occupied by an up spin and a hole, respectively), and (ll⁰) (a pair of holes).




FIG.5: Pairing among spins (full circles) and holes (open circles) are illustrated by the connection of lines. Two sets of bonds (solid and dashed lines) represent two di erent resonating pairing patterns, form ing a loop covering of the lattice for a given spin-hole con guration.

Fig. 5 shows two possible partitions for a given spin-hole con guration, and the sum mation in (57) runs over all possible partitions. Thus, the wavefunction (57) shows that the phase string operator $\hat{l_1}$ leads to the generalized Jastrow-type factor K de ned in (25). The remaining part of the wavefunction is bosonic, describing RVB pairing of spins, pairing between spins and holes as well as between holes.

B. Hidden ODLRO in the ground state: A pseudogap state

The properties of the RVB vacuum RVBiw ere discussed in Sec. IIIA. In the following we shall focus on the charge degrees of freedom in j_Gi.

words, it does not have a direct correspondence to a physical observable. Such a hidden ODLRO characterizes how doped charges (holes) are collectively reorganized and behave in the RVB background, RVBi. As the consequences, the ground state and excited states will exhibit some very unique novel properties. This will be the subject of our discussion below.

1. Pairing am plitude

We rst show that the hidden ODLRO in j $_{\rm G}$ i will result in a nite pairing amplitude between electrons in the singlet channel.

Therefore the ground state (54) indeed possesses a nite pairing amplitude as a direct consequence of the hidden ODLRO in j_G i, which is proportional to the doping concentration for small doping. Note that a nite pairing amplitude exists only in the singlet channel. It is easily shown that the mean value of the pairing amplitude in the triplet channel vanishes identically [in this case, an additional sign appears inside the sum mation of (60)].

However, superconducting phase coherence is generally absent. The phase part of the pair operator (59) involves $_{i}^{s}$ which is defined in (6) and is closely related to the spin degrees of freedom. More precisely, each unpaired spin contributes to a free 2 vortex via $_{i}^{s}$ in the pair operator (59). As will be discussed in subsection C, the presence of free spins in the ground state j _G i prevents phase coherence in (59). Nevertheless, $_{ij}^{0} \in 0$ in (59) is a meaningful de nition and description of a low temperature pseudogap ground state, called the spontaneous vortex phase²¹. In this phase, each unpaired neutral spin (spinon) always carries a 2 supercurrent vortex, known as a spinon-vortex²². We postpone further discussion of the spinon-vortices to Sec. IV C.

2. Ferm ionic nodal quasiparticles

In the following, we construct a quasiparticle excitation based on the ground state j_{G} i. In particular, we show that the existence of nodes in the excitation spectrum is ensured by the hidden OD LRO.

(see Sec. IV C), then $c_{k_0}^{y}$ j_G $i_{N_e - 1}$ would have a nite overlap with j_G i_{N_e} ; namely, the quasiparticle spectrum has four nodes at momenta, k_0 's, that approach $\frac{1}{2}$; $\frac{1}{2}$ in the limit of zero doping. Similar momentum structure can be identied in c_k j_G i_{N_e+1} . A true d-wave-like quasiparticle state in the superconducting state can be constructed as a linear combination of c_k^{y} j_G i and c_k j_G i, which should be in nitesimally close to the ground state j_G i_{N_e} at the four nodal points, k_0 's.

However, as discussed in Sec. IV C, the phase factor $e^{\frac{j}{2}}$ precludes phase coherence, and therefore the quasiparticle state $c_i^y j_G i_{N_{e-1}}$ actually has a vanishing overlap with the ground state $j_G i_{N_e}$ because of such a phase factor. Thus, the low-lying ferm ionic quasiparticles near the four nodes, k_0 's, have a vanishing spectral weight $Z_k = j_e h_G j_K^y j_G i_{N_{e-1}} j = 0$; viz., the non-superconducting (pseudogap) ground state $j_G i$ is a non-Ferm i-liquid in nature. Long lived quasiparticle excitations are expected to emerge only when superconducting phase coherence is realized in (74).

We emphasize that the nodal structure of quasiparticles results from the ODLRO of the bosonic twisted holes, in which the phase string factor e i^{i} , re ecting the ferm ionic nature of the electron operator, determ ines the momentum positions of four nodes. Finally we note that in the previous elective phase string theory in terms of holons and spinons (see Appendix B), a similar d-wave quasiparticle excitation can be obtained as the consequence of form ing the holon-spinon bound pairs by considering residual interactions beyond the elective model²⁰.

3. Two types of spin excitations

The hidden ODLRO in (54) is not only responsible for the existence of a nite pairing amplitude as well as d-wave like nodal quasiparticle excitations, it also predicts the presence of a new type of low -lying spin excitations which are quite distinctive as compared to the previously discussed spin excitations created in the RVB background RVB i (Sec. III A):

The latter may be called Type I spin excitations, which can be created by acting a spin operator, say, S_i^+ , directly onto the insulating spin liquid RVB i, without involving the hole condensate in (54). Obviously, this type of spin excitations is the only elementary excitation at half-lling, where it reduces to a conventional spin wave in the long-wavelength limit as discussed in Sec. III A. At small doping, the majority of spins still remain RVB paired, characterized by ${}^{s} \in 0$ in RVB i: Thus, this kind of spin excitation will naturally persist into the pseudogap regime,

where a spin gap will be opened up in its low-energy spectrum as the spin-spin correlations are short-ranged (here W_{ij} becomes exponential decay with the distance ji jj; see Fig. 3). In fact, as mentioned in Sec. IIIA, the corresponding low-lying excitation reduces to a sharp resonance-like mode in the pseudogap regime, with a characteristic energy scale E_g J around the momentum (;). Remnant spin wave like dispersion is still present at high energies⁸, which disappears when the temperature reaches T_0 as shown in Fig. 2 where the short-range RVB pairing vanishes nally.

Now let us discuss a new type (Type II) of S = 1 excitation which is associated with the twisted holes and may be regarded as composed of a pair of quasiparticle and quasihole, instead of a pair of neutral spinons in $\Re VBi$. To create a Type II spin excitation by, say, S_i^+ ; a pair of quasiparticles will be created and annihilated in j_Gi, which involves a spin ip in the \hole condensate" part in (54).

The term on the right-hand side (rhs) has the same origin as the quasiparticles around nodal points discussed previously. On the other hand, the dynamics of (77) is mainly decided by the vortices in $e^{i \frac{h}{i}}$ which is in turn determined by the charge density. To leading order approximation, no superexchange interaction in the spin degrees of freedom in uences (77). If one neglects the uctuation in $e^{i \frac{h}{i}}$; the term on the rhs of (76) would have a nite overlap with j_{G} i at the incommensuratem on enta Q, which implies a zero mode or the presence of an incommensurate AFLRO. But the true long-range order will be prevented by the density uctuations, because any small uctuation in the charge density will be accumulated in the phase factor $e^{i \frac{h}{i}}$ in a su ciently long time and distance; which in turn will result in a slow- uctuating incommensurate AF ordering above j_{G} i, instead of a true static incommensurate AFLRO. This low-lying spin uctuation can provide an alternative explanation, without invoking a dynamic stripe picture, of low-energy results in neutron scattering experiments on the cuprate superconductors.

Therefore, Type II spin excitations in (76) are quite distinct from Type I in nature. As a direct consequence of the hidden ODLRO, they are absent at half-lling [the weight of this term is proportional to the density of the charge condensate, from (76)]. One should thus properly distinguish these two in a neutron scattering measurement, as a unique prediction of this theory.

C. Superconducting phase coherence

As described above, the hidden ODLRO in j_G i leads to a nonzero pairing amplitude. But it does not necessarily imply superconductivity. Consider the action of the superconducting pairing operator on the N_e electron ground

state. The resulting state has an overlap with N_e 2 electron ground state, determ ined by using (59) and (63), as follows:

1. Spinon vortices

We noted earlier that each isolated (S = 1=2) spin in j_G in eans the creation of a 2 vortex in the phase of the superconducting order parameter $^{SC}_{ij}$, via $^{s}_{i}$, according to (80). Thus, each spin automatically carries a phase or supercurrent vortex, called a spinon-vortex, in the state described by j_G i. This was rst identied in previous work based on the elective theory^{21,22}.

The 2 vortices centered at " and # spins in RVB i are paired as vortex-antivortex pairs, since the underlying spins are always paired in the singlet RVB vacuum. Then, one has

This is in analogy with the two-dimensional XY model below the Kosterlitz-Thouless transition where vortexantivortex pairs are bound together. In our case, vortices and antivortices are associated with " and # spins, respectively. The condition that $S^{z} = 0$ in the singlet background, $\Re VBi$, is equivalent to the charge neutrality condition in the XY model. Since " and # spins are RVB pairs with a nite range at nite doping [see (42)], the cancellation in $\frac{1}{2}$ $\stackrel{s}{i} + \stackrel{s}{j}$ is ensured at large distances. Thus, we see that the spin RVB pairing in $\Re VBi$ is very essential for phase coherence to occur. Note that this condition fails in the AF phase, where ! 1, or beyond the doping concentration x_{RVB} where the RVB pairing disappears.

However, the existence of free spins, associated with doped holes created by c_1 , will imply the presence of free vortices in j_G i. To see this, following (54) and (82), one can write

Therefore the ground state j_G i is not a true superconducting ground state due to the lack of phase coherence, although it possesses a pairing amplitude as well as (incoherent) nodal quasiparticles. It is characterized by the presence of unpaired spinon-vortices as a direct consequence of the hidden ODLRO in j_G i. Nontrivial Nemst e ect contributed by such unpaired spinon-vortices has been investigated based on the elective phase string theory elsewhere²¹.

2. Superconducting ground state

The superconducting instability will take place when those unpaired spins associated with twisted holes also become RVB paired. It reduces the superexchange energy when those back ow spins form the RVB pairs, and most importantly it removes the logarithm ic-divergent energy associated with free vortices as vortices antivortices are paired up at low temperature. Consequently the phase ${}^{h}_{i}$ is cancelled out in (83) and the true phase coherence (81) of the superconducting order parameter can be nally established.

C orresponding to the pairing of those free spins associated with twisted holes, the twisted holes them selves are also e ectively paired and the ground state should evolve from (54) into the following form

Equation (88) also implies the restoration of the coherent ferm ionic quasiparticle excitations in the superconducting state.

V. SUMMARY AND DISCUSSION

In this paper, we obtained and analyzed the ground state of a pseudogap phase (or spontaneous vortex phase) for a doped M ott insulator, starting from a generalized mean eld treatment of the t J m odel in the phase string representation. In this representation, the most singular e ects of doping, viz., the no double occupancy constraint, and the phase string e ect arising from the disordering of the M arshall sign, are sorted out through a system atic procedure. A ll nontrivial phases in the phase string representation are characterized by a topological gauge structure, which turns out to be well controlled in the regime of interest (low doping). The physical picture of the ground

state that em erges, is that of an underlying RVB vacuum (a spin liquid insulator) which makes the doped holes be twisted into bosonic objects, thereby gaining kinetic energy. The ground state retains time reversal and spin rotational symmetries, and has a simple form (54) in the electron second-quantization representation.

At half lling, the ground state describes an AF M ott insulator, and provides a very accurate description of both long and short range spin correlations of the Heisenberg model. At nite doping, the spin degrees of freedom are described by an RVB spin liquid (55); the mean RVB pair size (42) reduces continuously as doping increases. Charge degrees of freedom emerge at nite doping, with a hidden ODLRO (58). This leads to a nite (electron) pairing am plitude, which characterizes the pseudogap structure of the ground state. The hidden ODLRO in the charge sector is also found to be the underlying reason for the four nodes in the quasiparticle excitation spectrum, but the ground state is non-Ferm i-liquid like in the absence of phase coherence. It is more appropriate to call the pseudogap ground state as a spontaneous vortex phase, since free S = 1=2 spins that act like vortices prevent superconducting phase coherence in this state.

Two types of low-lying spin excitations above the pseudogap ground state were identied. One is composed of neutral spinons and has a resonance-like feature around (,). It reduces to the conventional gapless spin wave at half-lling. The other type of spin excitation exists only in the doped regime and describes a slow ly uctuating incommensurate AF ordering. It provides an alternative explanation of the neutron scattering experiments without invoking a charge stripe scenario.

Superconducting phase coherence is established by an instability which causes RVB pairing of the free spins associated with the twisted holes. The ensuing ground state (84), is non-BCS-like in many aspects. The properties of the superconducting ground state (84), especially those involving non-BCS-like features, are very interesting problem s to pursue further.

The class of wavefunctions discussed in this paper provides a united description of Mott physics, antiferrom agnetism, pseudogap physics, and d-wave superconductivity within a single fram ework. There are many basic distinctions between this ground state and BCS-like wave functions. An important distinction is the independence of the spin excitations from the quasiparticles. The presence of the pairing am plitude and spontaneous vortices associated with spin excitations is another unique feature and is independent of superconducting phase coherence. Furtherm ore, generalized Jastrow-like factors K in (23) that appear in the ground state wave function, are incom patible with the (Slater) determ inantal wave functions of the BCS theory. Therefore, the pseudogap and superconducting ground states obtained in this work represent and describe a new state of matter.

Given that the state (54) undergoes a superconducting instability with phase coherence at low tem perature, we may discuss further in plications for the global phase diagram. Clearly, the phase coherence condition (82) fails in the spin ordered phase, when the spatial separation of the RVB pair, ! 1; indeed, at half lling, the RVB am plitude W_{ij} shows a power law decay at ji jj! 1, without a nite length scale, as discussed in Sec. III A. In this AF phase, phase coherence in (82) due to the tight binding of vortices and antivortices in \sum_{i}^{S} is disrupted. In general, such a spin ordered phase will persist into nite doping at su ciently low hole concentration, x_c^{-26} . The condition of phase coherence is not satis ed also when the RVB pairing between spins in $\frac{1}{2}$ NB i is continuously reduced to zero, at su ciently large doping x RVB. In this case, the underlying rigidity for binding of vortices and antivortices in the ground state is also destroyed and the superconductivity should be suppressed beyond x_{RVB} . How the ground state wavefunction system atically evolves with the doping concentration and the possible existence of quantum critical points at, say, x_c and x_{RVB} , is an in portant subject for further investigation.

F inally, the results presented in this paper can be used as a starting point to pursue several interesting questions, and we indicate a few possible directions here: (i) The pseudogap (spontaneous vortex phase) ground state is inherently unstable to superconductivity as the result of pairing of the twisted holes. Nonetheless, the pseudogap ground state can still be regarded as a true ground state, for instance, when strong magnetic elds are applied to destroy the RVB pairing of the low -lying spins associated with the back ow of holes. The study of this state in the presence of strong magnetic elds is thus experimentally relevant. (ii) It will be very useful to develop a numerical scheme based on the wavefunction (57) for a variational study. At half-lling, we used the wavefunction to compute the ground-state energy, magnetization, and equaltime spin-spin correlations by employing the loop gas method. As pointed out, this gave us accurate results. However, away from half lling, the RVB amplitude W ij is no longer a real function and bop products generate a ctitious ux proportional to doping concentration [cf. (C28)]. This leads to a sign problem and further work is necessary to overcom e this barrier. Havilio and Auerbach studied correlations in doped antiferrom agnets using a combination of num ericalm ethods and the Gutzwiller approxim ation for a di erent class of RVB wave functions²⁸. A similar study of the wave function proposed in this paper should yield interesting results. (iii) Finally, we note that the form of the wave function (24) follows from very general consequences of a hole moving in an RVB background, since the disordering of the Marshall sign, i.e., the phase string e ect, occurs in systems even without AF long range order. Thus the phase string representation and the bosonic RVB mean eld theory can be used to study models such as the doped quantum dimer model, where the spin background is known to be RVB paired.

The essence of this approximation is that for a dilute concentration of holes, the hole-hole correlation induced by the background spin RVB pairing can be neglected, since the average separation between holes sets the upper bound for the size of the RVB pair wave function. >From (A 6) we see that t has two contributions: the rst term, proportional to (1)=2; is the probability that the hole hops between nn sites, in a background of uncorrelated spins; the second term, proportional to $j \stackrel{s}{j}$; is the enhancement from RVB assisted hopping - the initial state (before hole hopping) and the nal state have a non vanishing overlap ow ing to the RVB pairing in the spin background. Finally, we note that the eigen values of (A 8) would form a H ofstadter spectrum, if the gauge eld A $_{ij}^{h}$ were treated at a mean eld level, as a uniform ux (32). However, the density of the back ow spinons is tied to that of the holons and so the uctuations in A $_{ij}^{h}$ due to uctuations in the holon density are self consistently related to the density uctuations of the spinon back ow. Thus, (A 8) resembles an anyon (sem ion) system in the bosonic representation with a spin index²⁷. The mean eld approximation is usually no longer valid in determining its excitation spectrum. This is a nontrivial issue. Nevertheless, since we shall be only interested in its ground state, which is a condensate with a uniform density distribution, all we need to know is that there is a renormalized constant t_h for the elective holon hopping term, estimated as the maximal eigen-value at the mean-eld level in (A.8). The wave packet Z (i) is determined as a linear combination of the wave packets of a cyclotron radius $a_c = a_{i}^{-1}$ in accord with (32) and is made maximally uniform in space, in order to accommodate the condensation of the holes.

APPENDIX B:EFFECTIVE THEORY

In the bosonic RVB mean eld theory, the holon many-body wave function $'_{\rm h}$ has been assumed to satisfy the ideal Bose condensation condition (48) at T = 0. As we noted in the paper, two e ects are om itted in (48), viz., the hard core correlation among holons and the uctuations of the link eld A $_{\rm ij}^{\rm s}$. The latter e ect should become important when excited spinons are present. Furtherm ore, $'_{\rm h}$ will also become nontrivial in the presence of an external electrom agnetic eld.

Such an e ective H am illionian has been derived earlier¹⁷, and is the basic low energy e ective m odel for the doping and tem perature regimes underpinned by the bosonic RVB order parameter ${}^{s} \in 0$ in the phase diagram of Fig. 2.

We remark that H_{string} in (B2) is obtained under the assumption that the spinon back ow accompanying the hopping of the holons only provides a renormalized hopping integral t_h . Here t_h is determined at the mean eld level,

as the m in in a leigen value of (49). However, in principle, the internal excitations of the spinon back ow can e ectively reduce t_h according to (49) and thus increase the kinetic energy of H_{string}. This should be taken into account when the high energy part of the charge degrees of freedom are studied. Finally, we point out that the holon and its spinon back ow is actually bound together, as previously show n^{20} by including the residual interactions of the t J m odel beyond the elective H am iltonian. Such a twisted hole as a bound holon-spinon pair emerges naturally in the present wavefunction approach given in the main text.
